(57) **CLAIM**

The ornamental design for a vehicle tire, as shown and described.

DESCRIPTION

1. Vehicle tire

1.1 is an enlarged partial front view of the vehicle tire showing my new design;

1.2 is a front perspective view thereof;


1.3 is a front side elevation view thereof;

1.4 is a top side elevation view thereof;


1.5 is a left elevation view thereof; and

1.6 is a right elevation view thereof.






