(57) **CLAIM**

The ornamental design for a tire, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a tire generally from the front and a first side of the tire;
 FIG. 2 is a front view thereof;
 FIG. 3 is a side view of the first side thereof (the second side view is the same as the first side view);
 FIG. 4 is an enlarged, partial perspective view taken generally from the front and the first side taken from FIG. 1 thereof;
 FIG. 5 is an enlarged, partial front view taken along Line 5-5 of FIG. 2 thereof; and,
 FIG. 6 is an enlarged, partial side view of the first side taken from FIG. 3 thereof.

The broken lines and the region between the broken lines defining the ground engaging surface between the tire buttresses, and the broken lines and the region between the broken lines defining the inner bead and the first or second sidewall depict subject matter that forms no part of the claimed tire design, and are included for the purpose of illustrating the full tire. Likewise, the tire interior forms no part of the claim. The tread pattern is understood to repeat throughout the circumference of the tire.

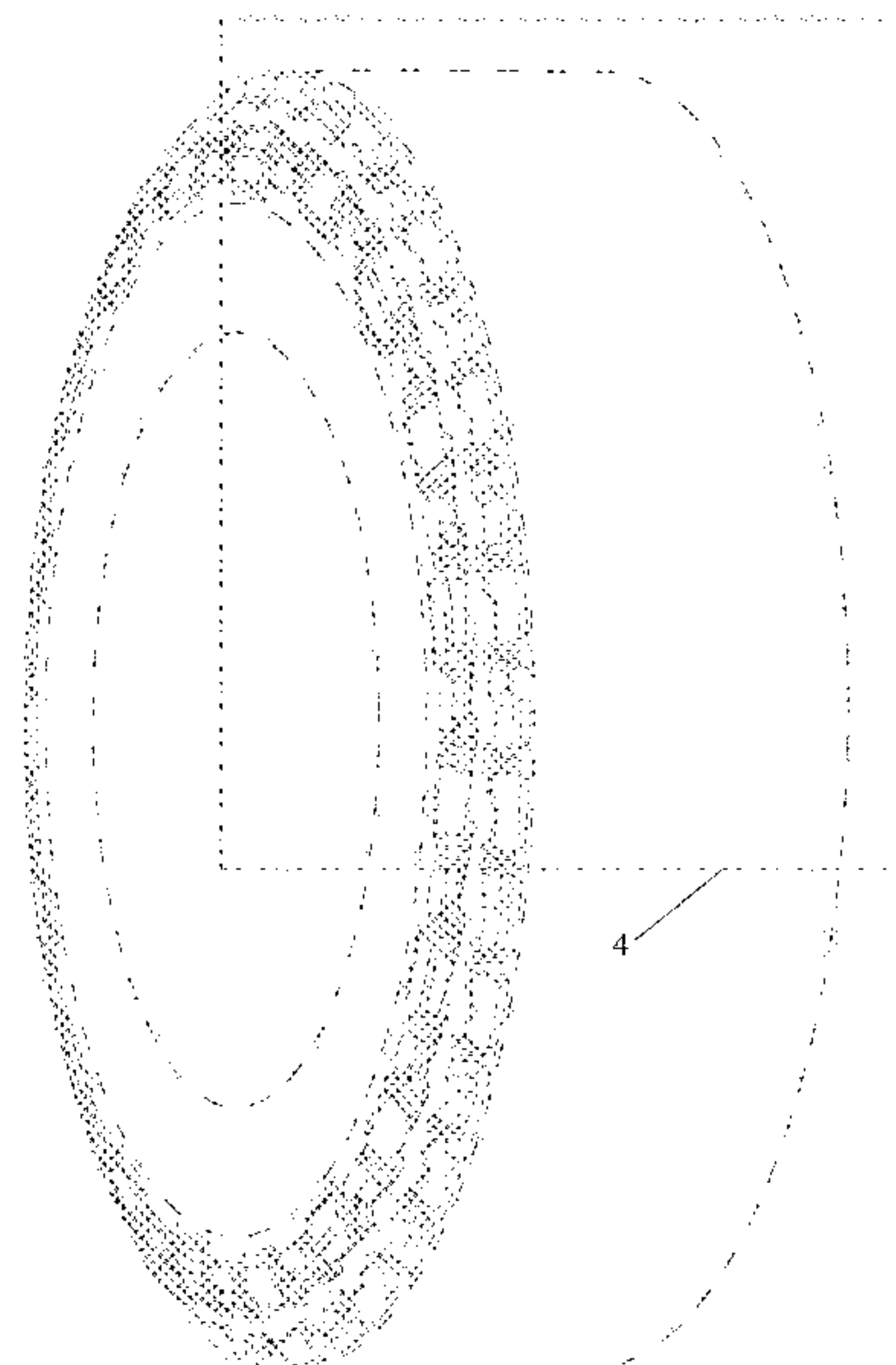
The dashed broken lines indicating an enlargement portion of the design form no part of the claimed design.

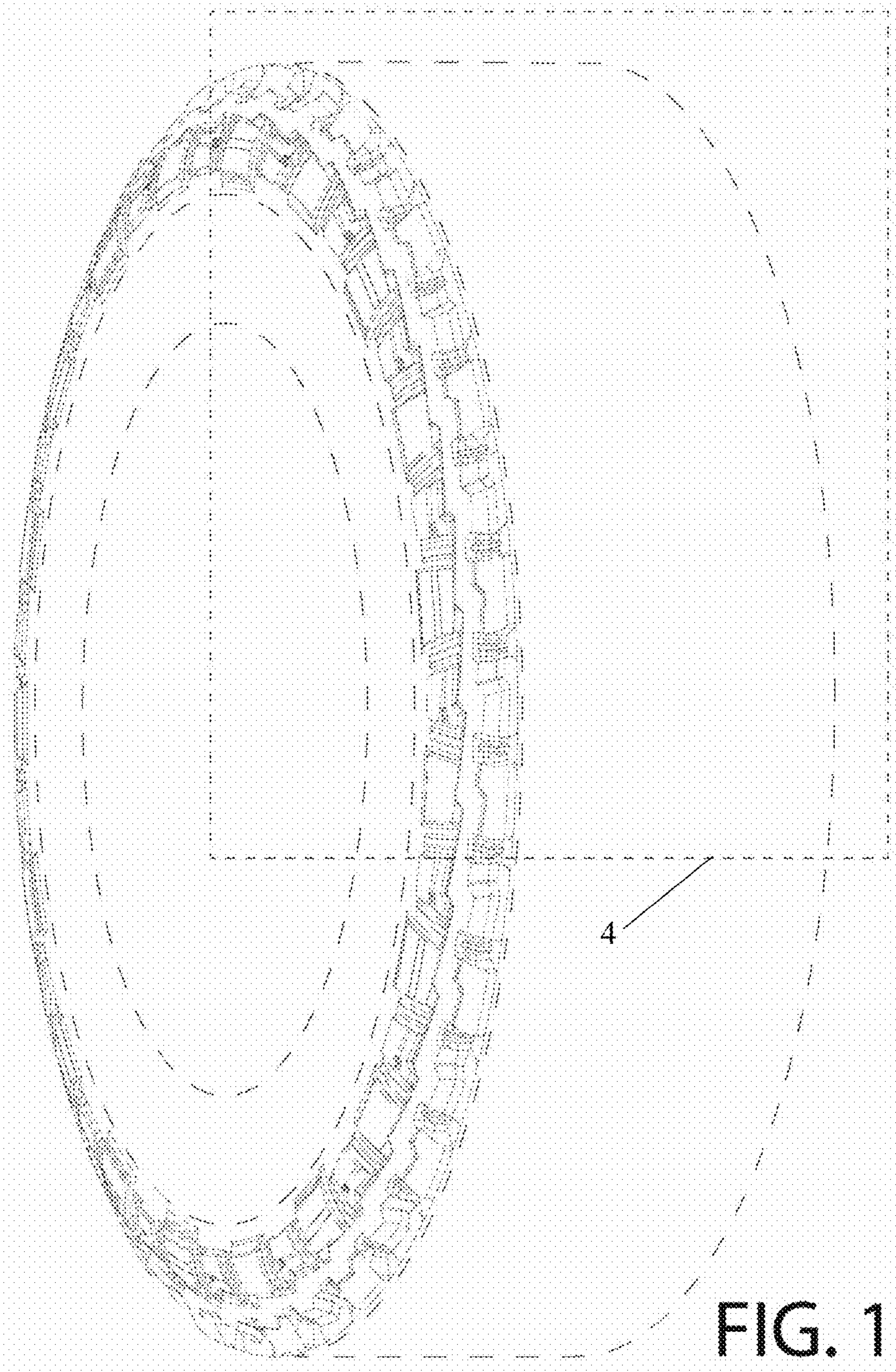
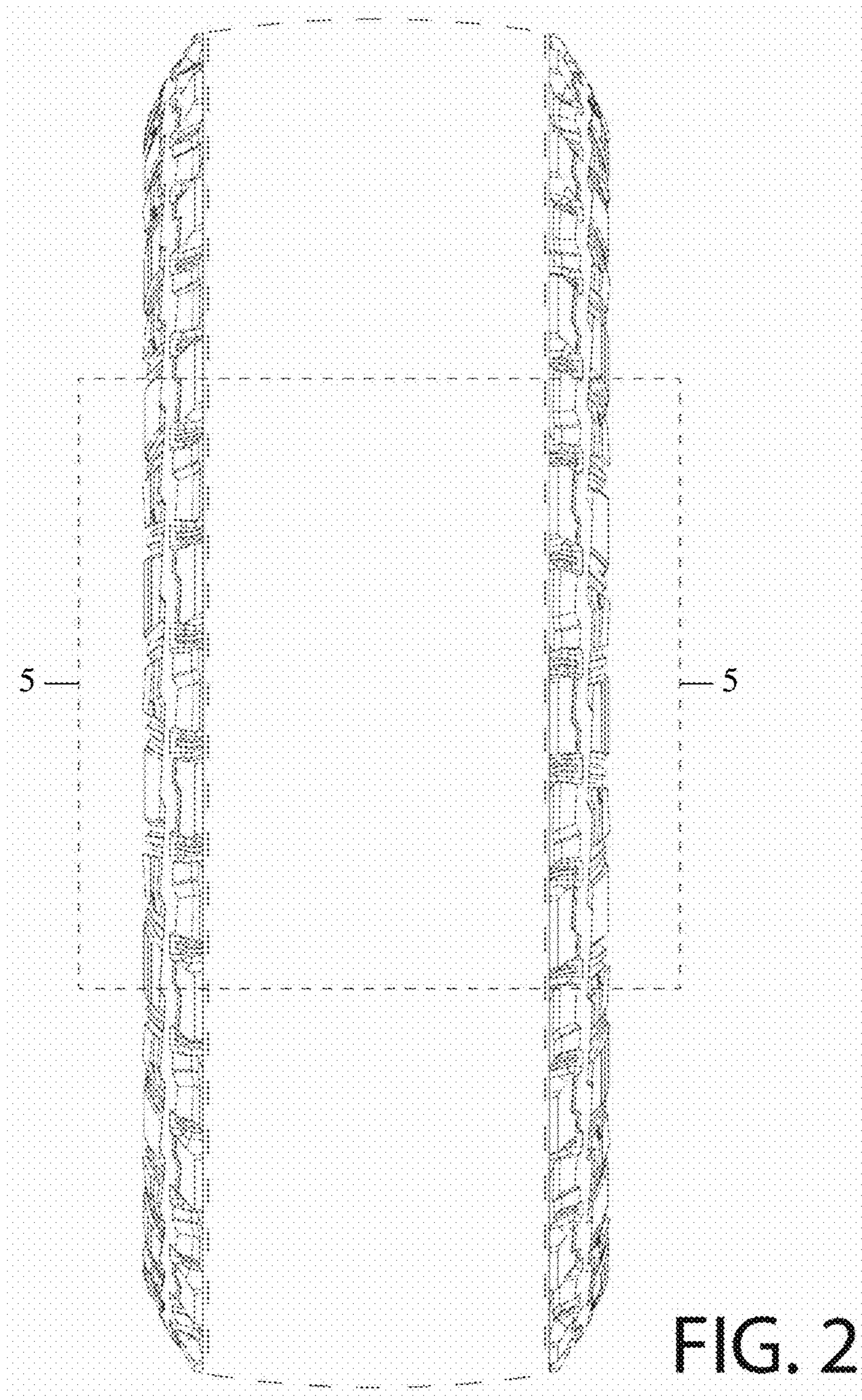

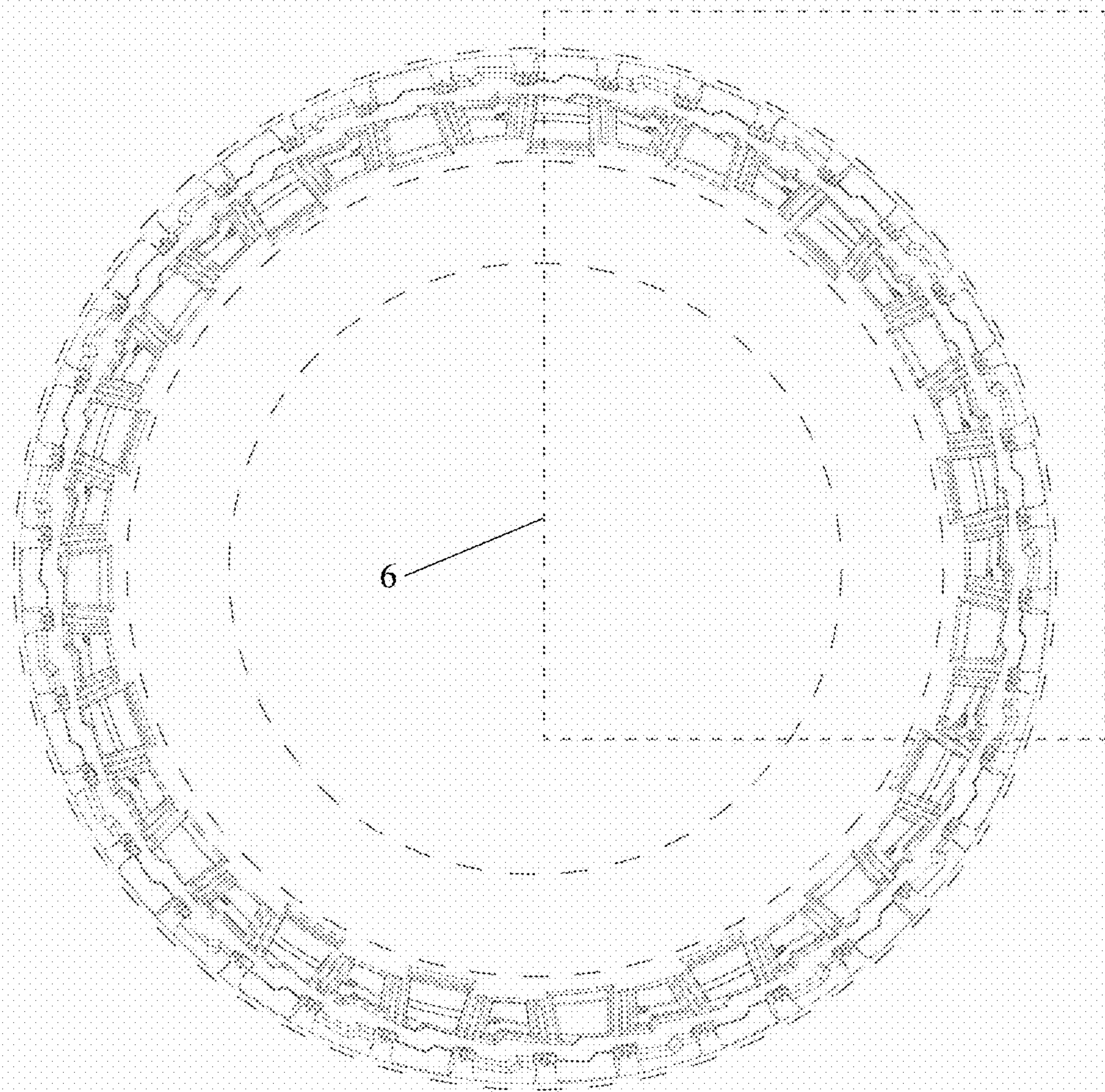

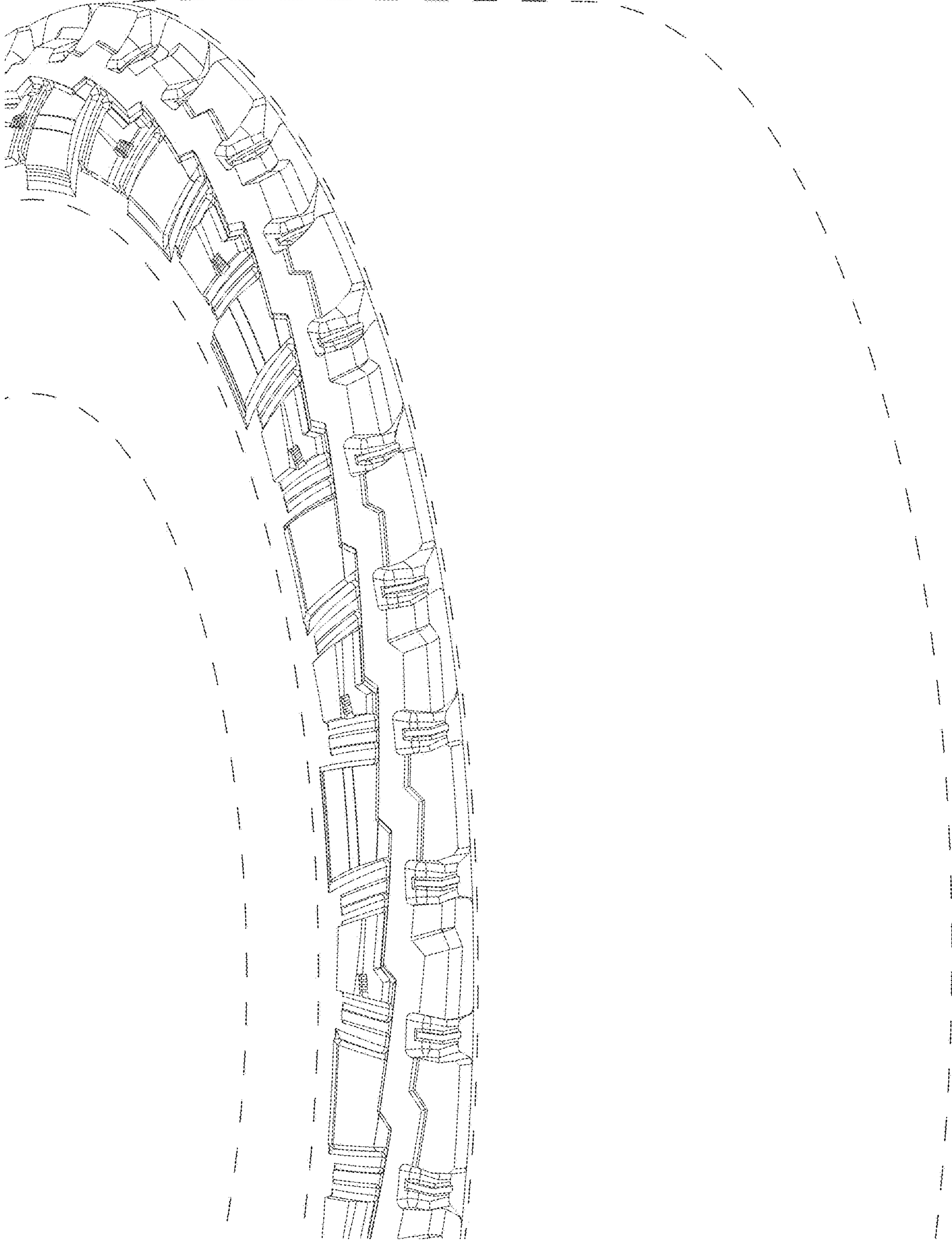

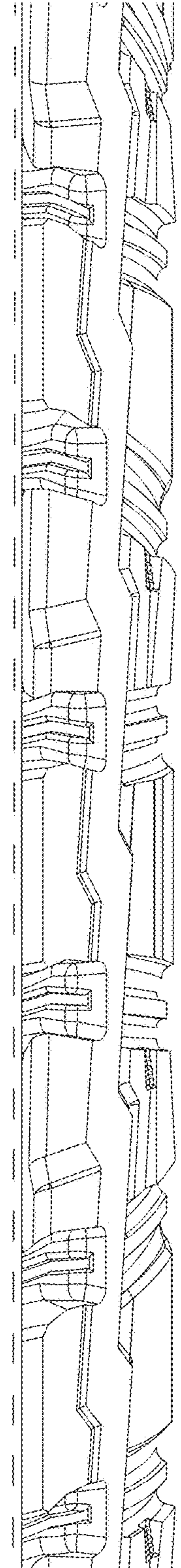
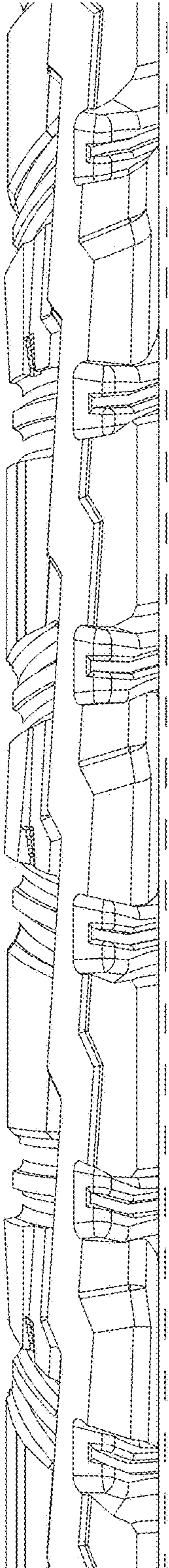

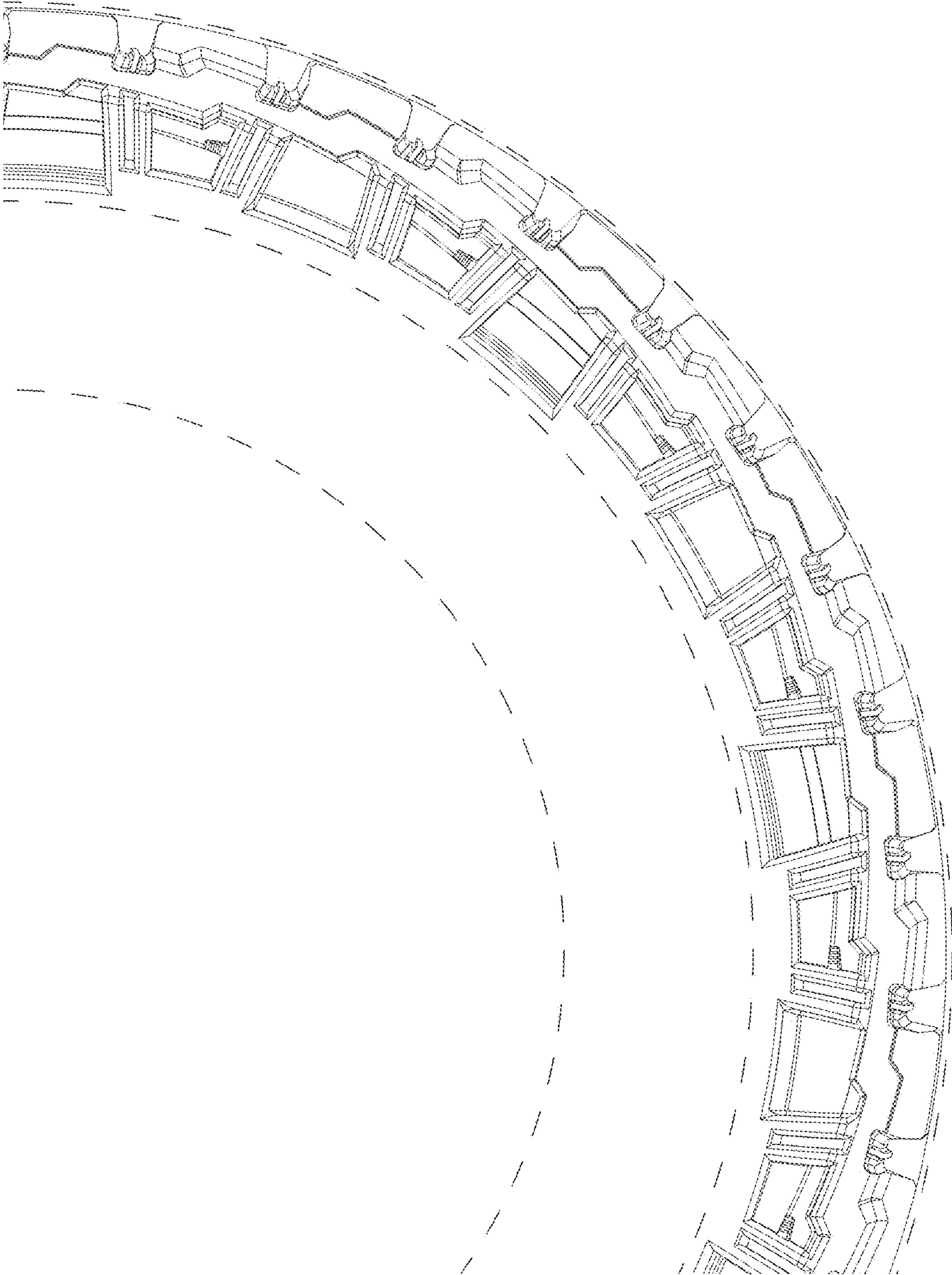
