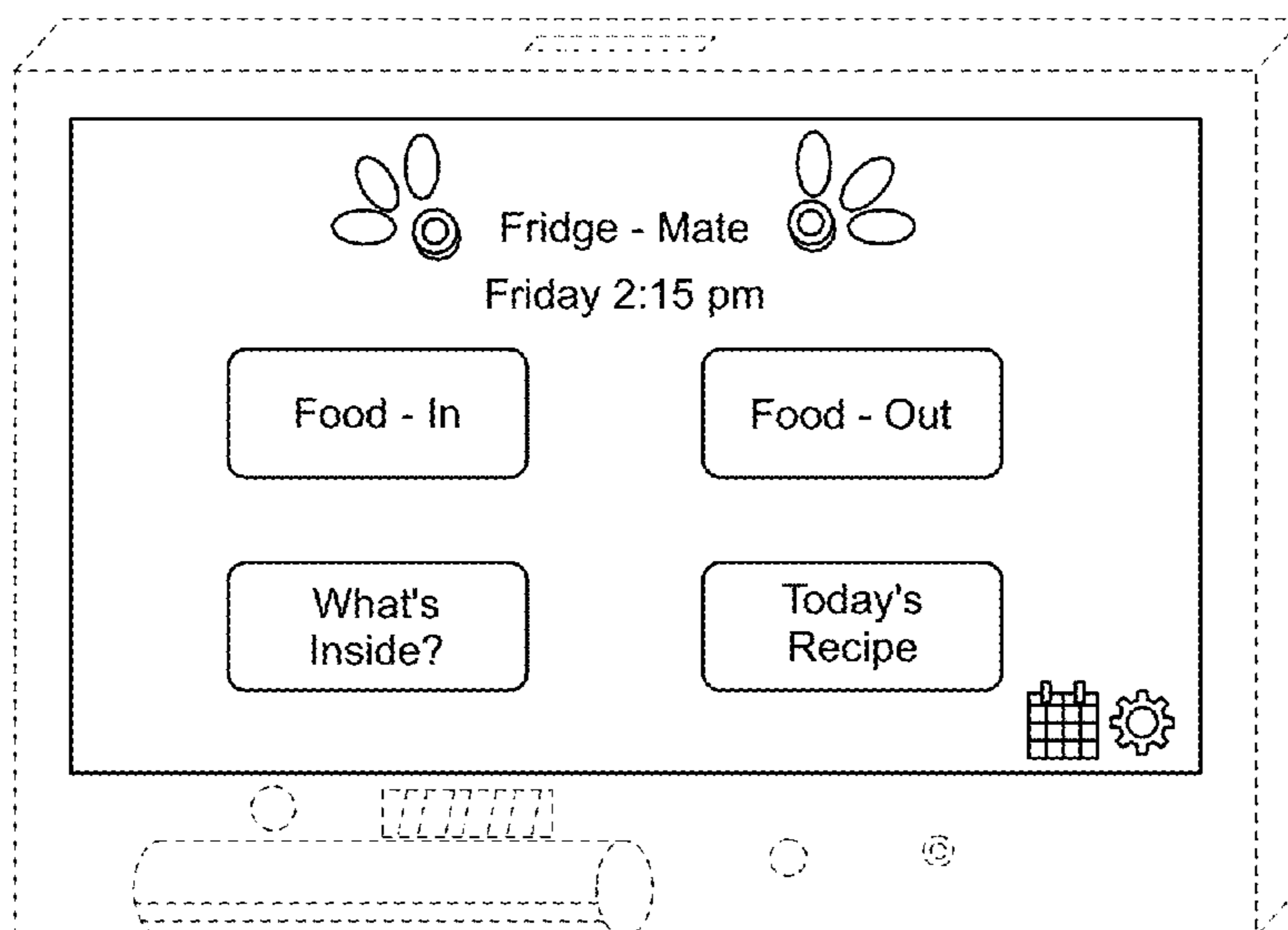
The ornamental design for an electronic device with graphical user interface, as shown and described.
