(57) **CLAIM**

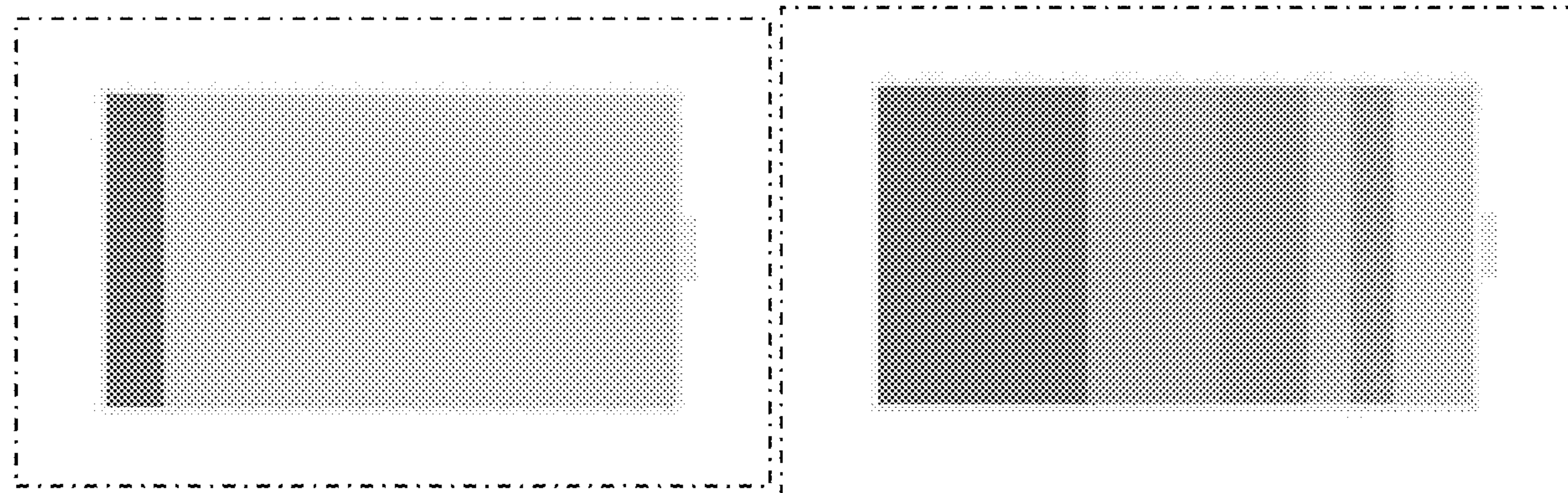
The ornamental design for a display screen or portion thereof with animated graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is the first image in a sequence of a first embodiment of a display screen with animated user interface showing our new design;

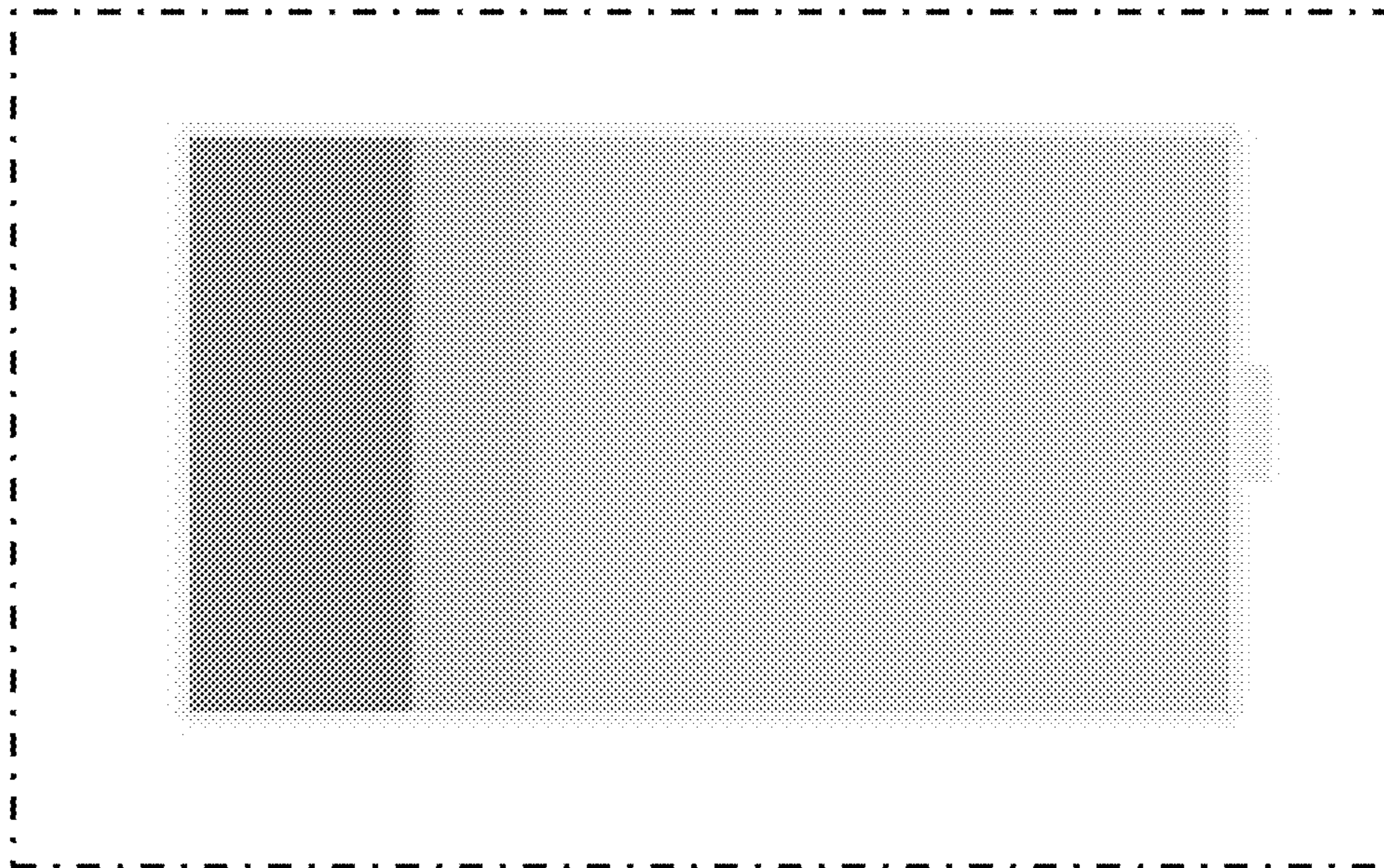

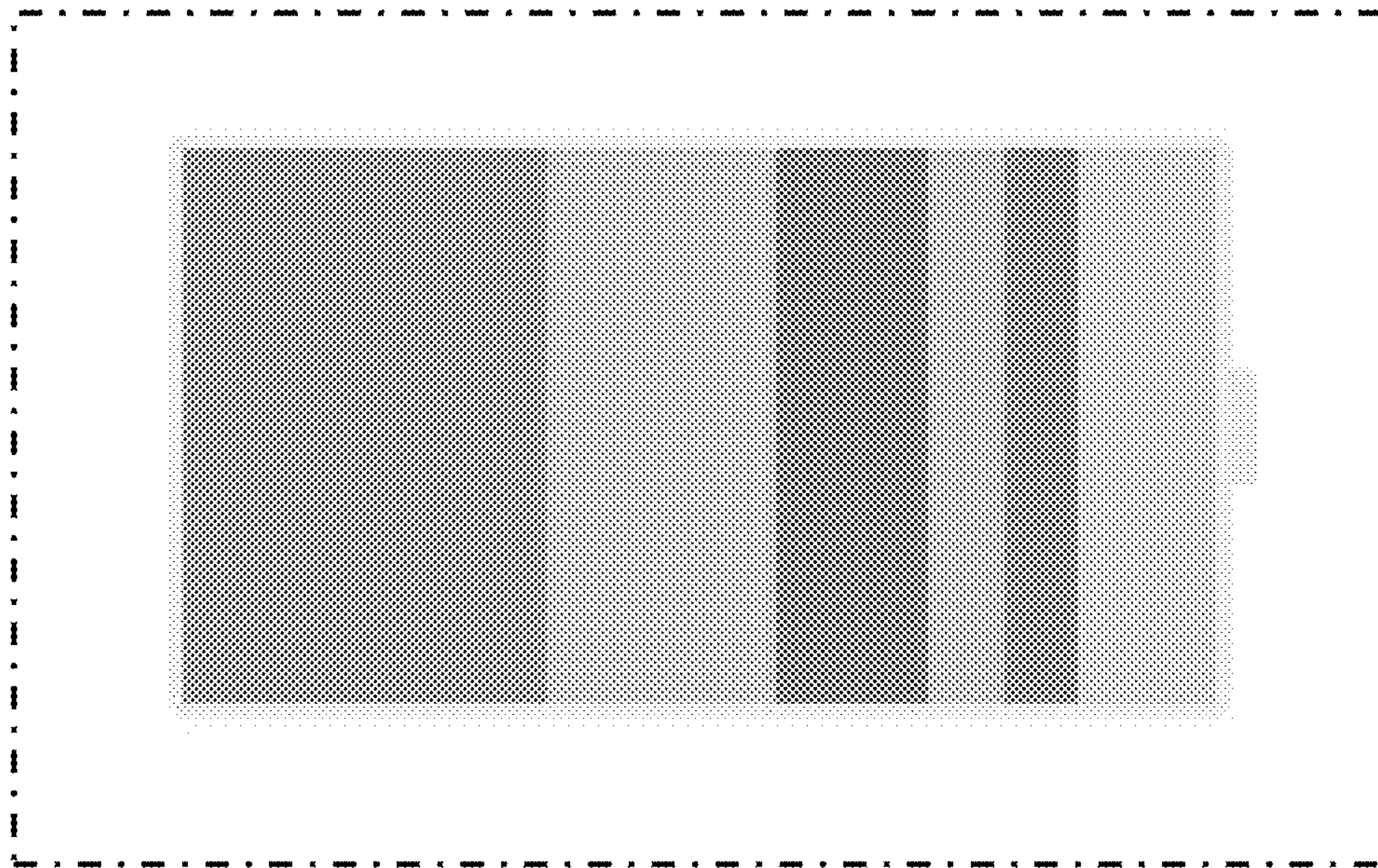

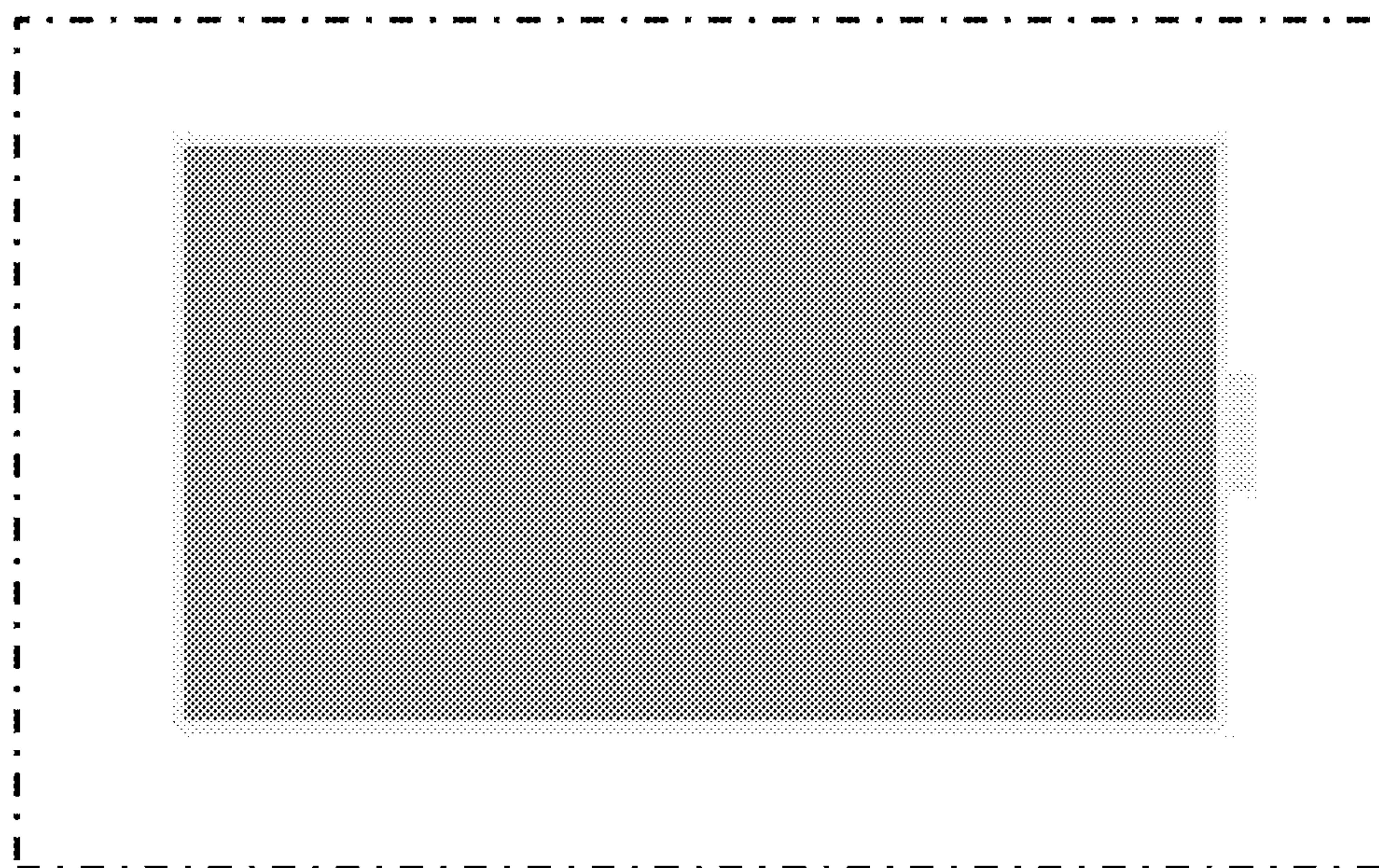

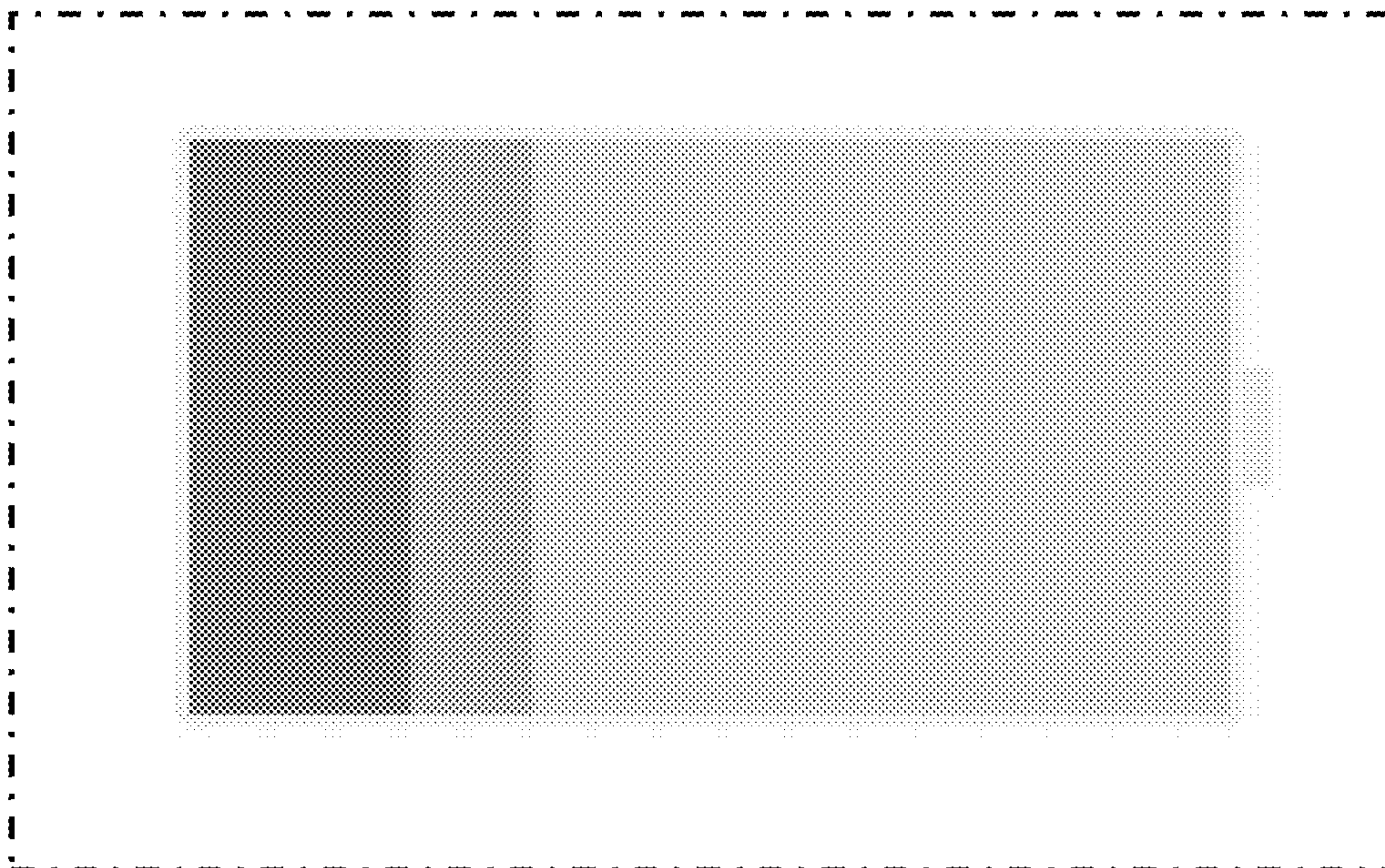

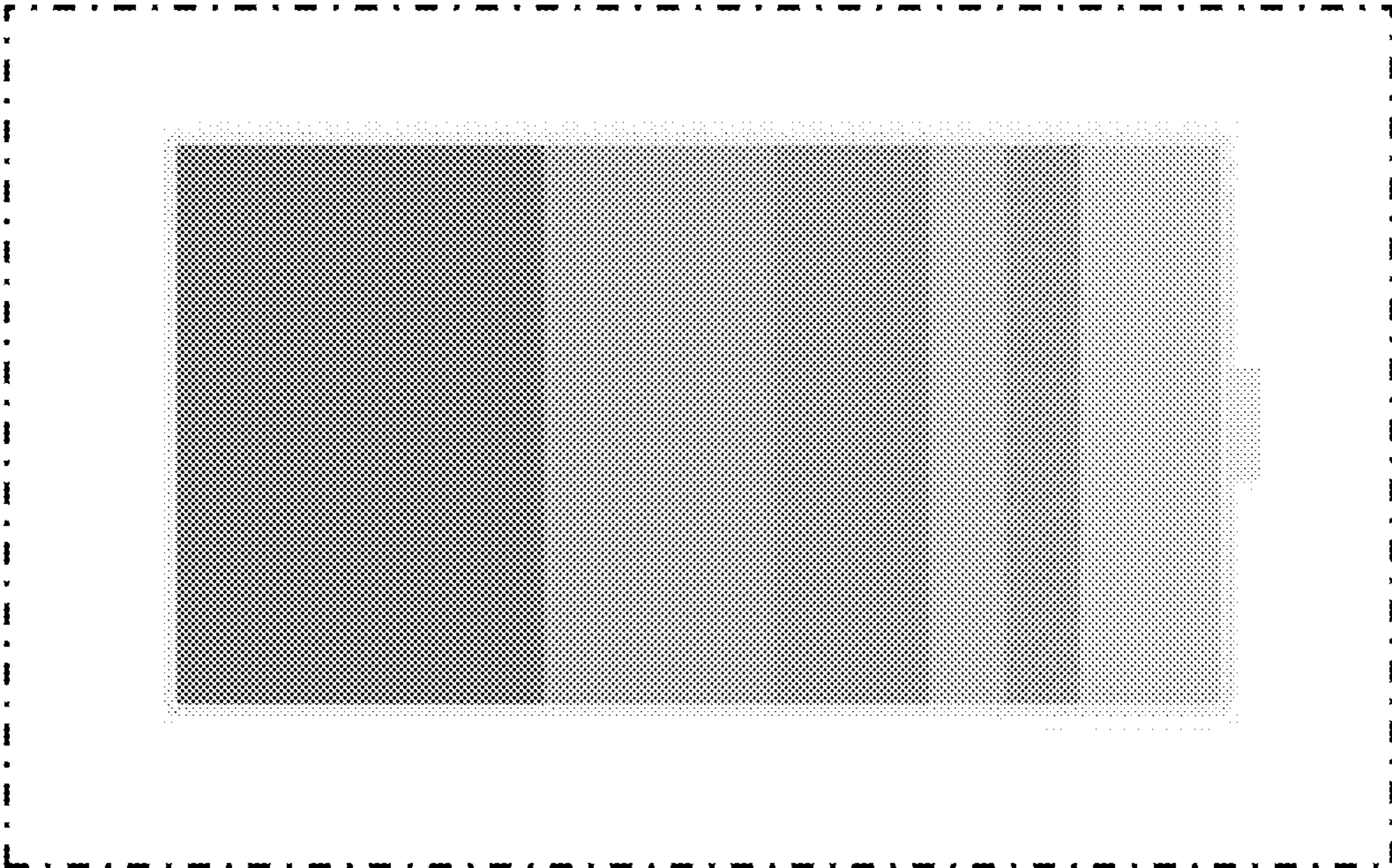

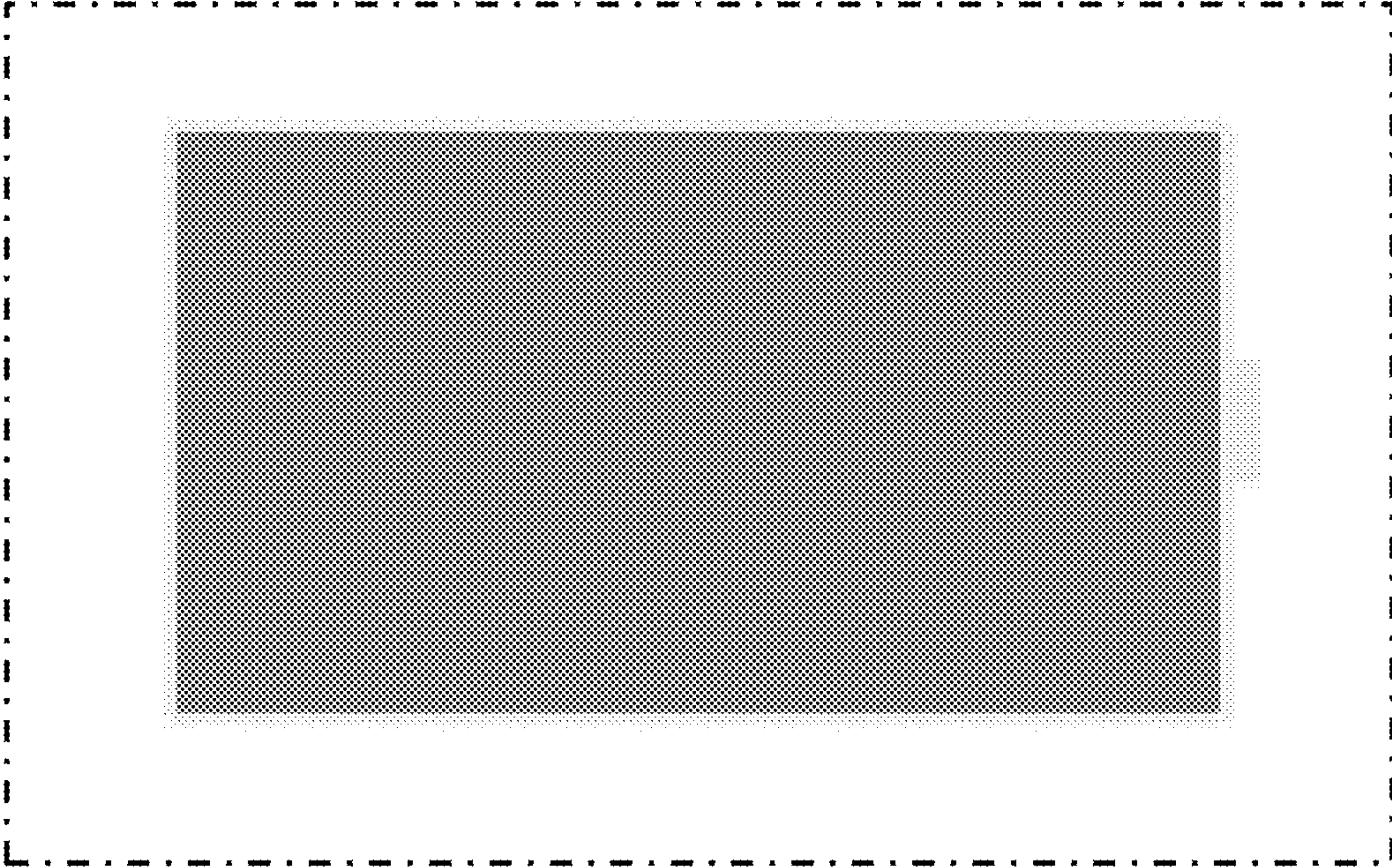
