FIG. 4 is a front view of a fourth embodiment of a display screen with graphical user interface showing our new design.

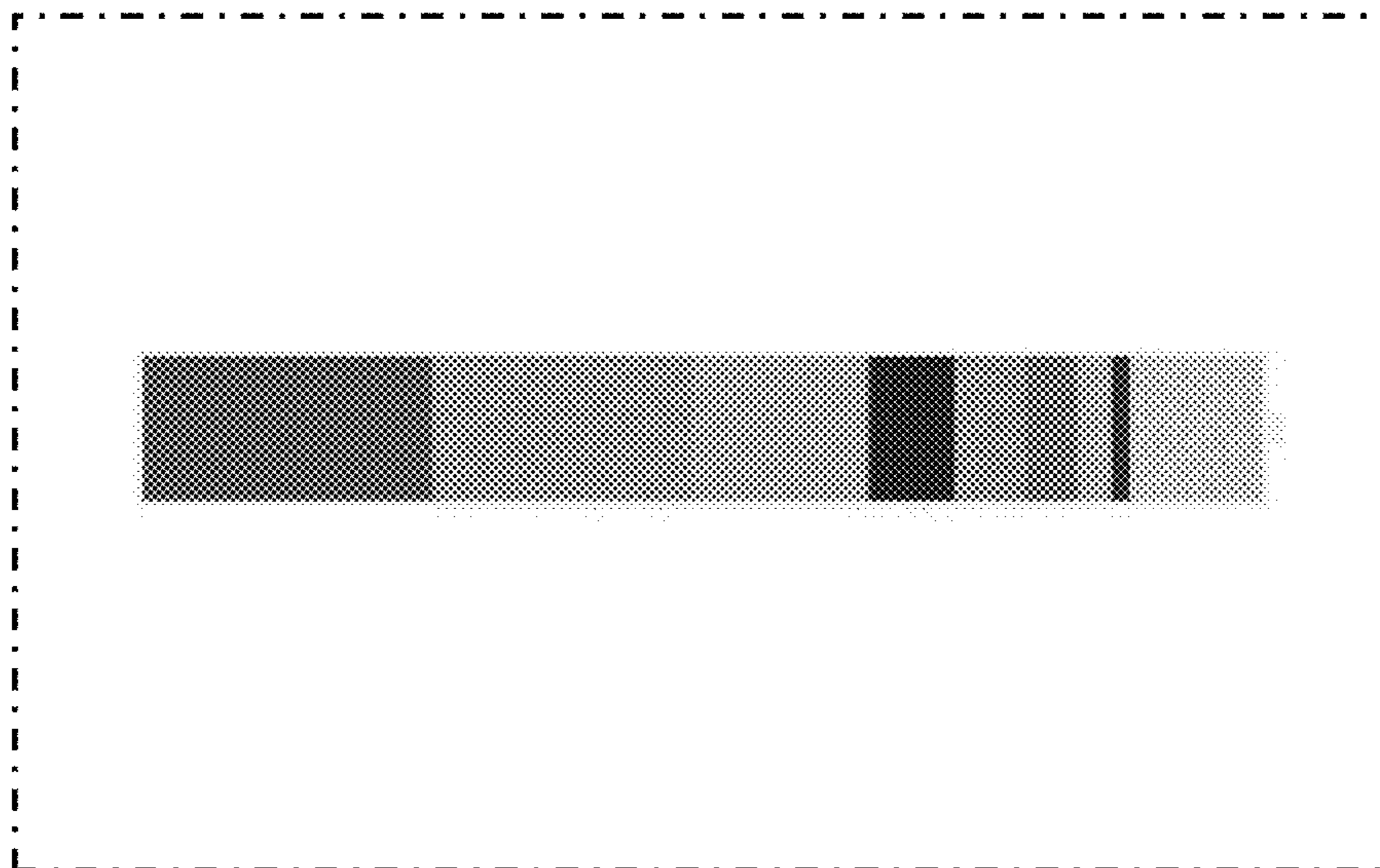

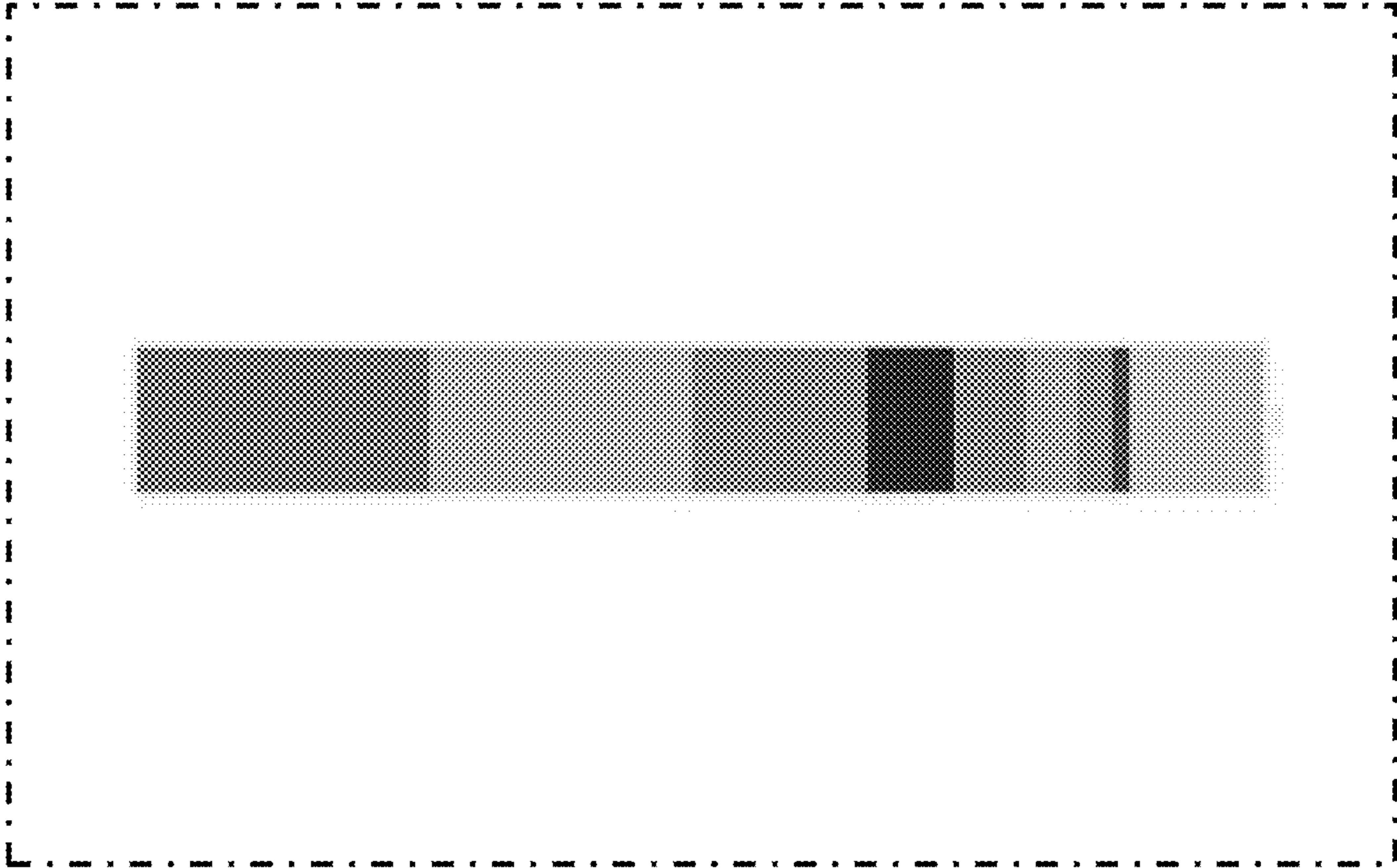

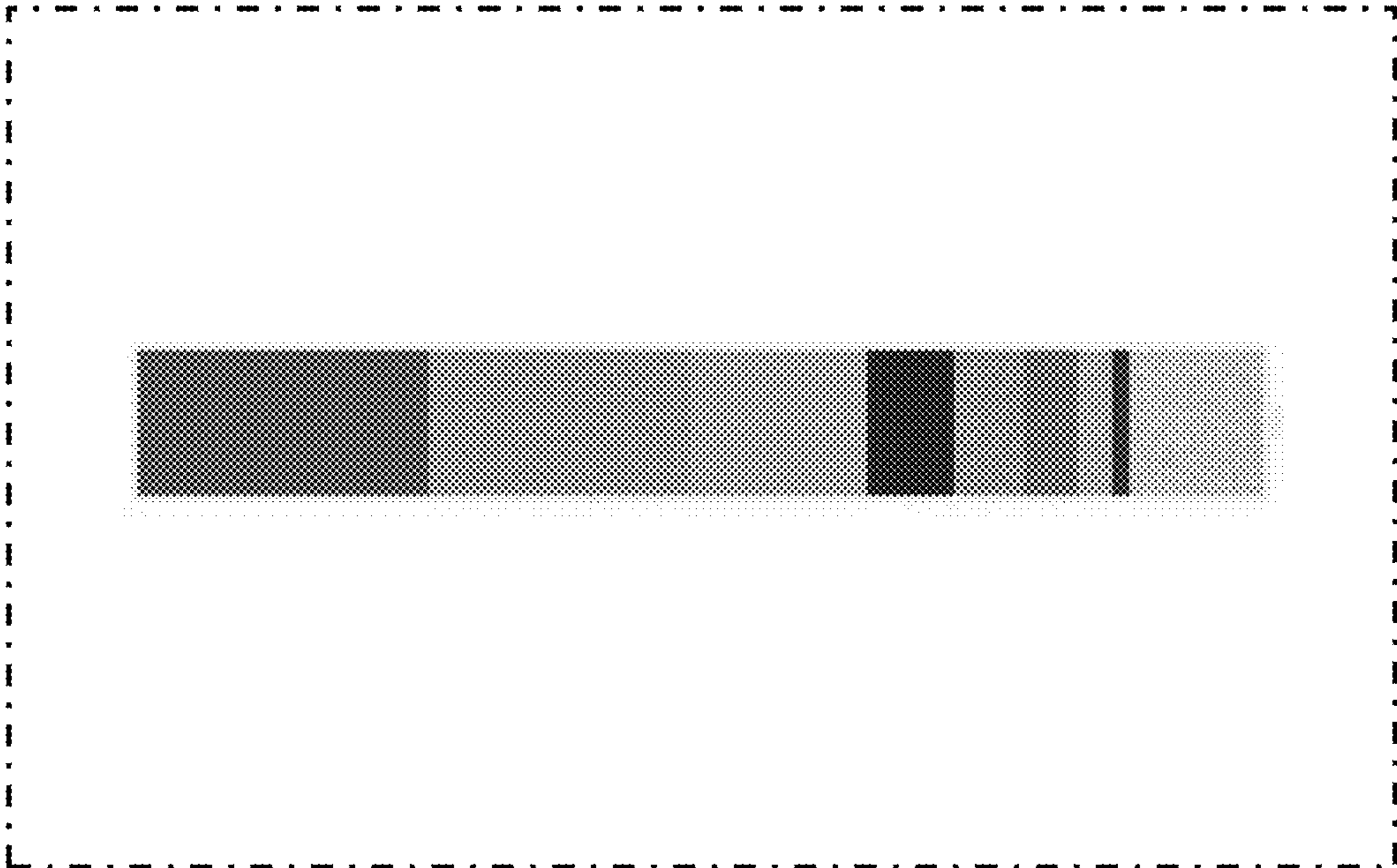

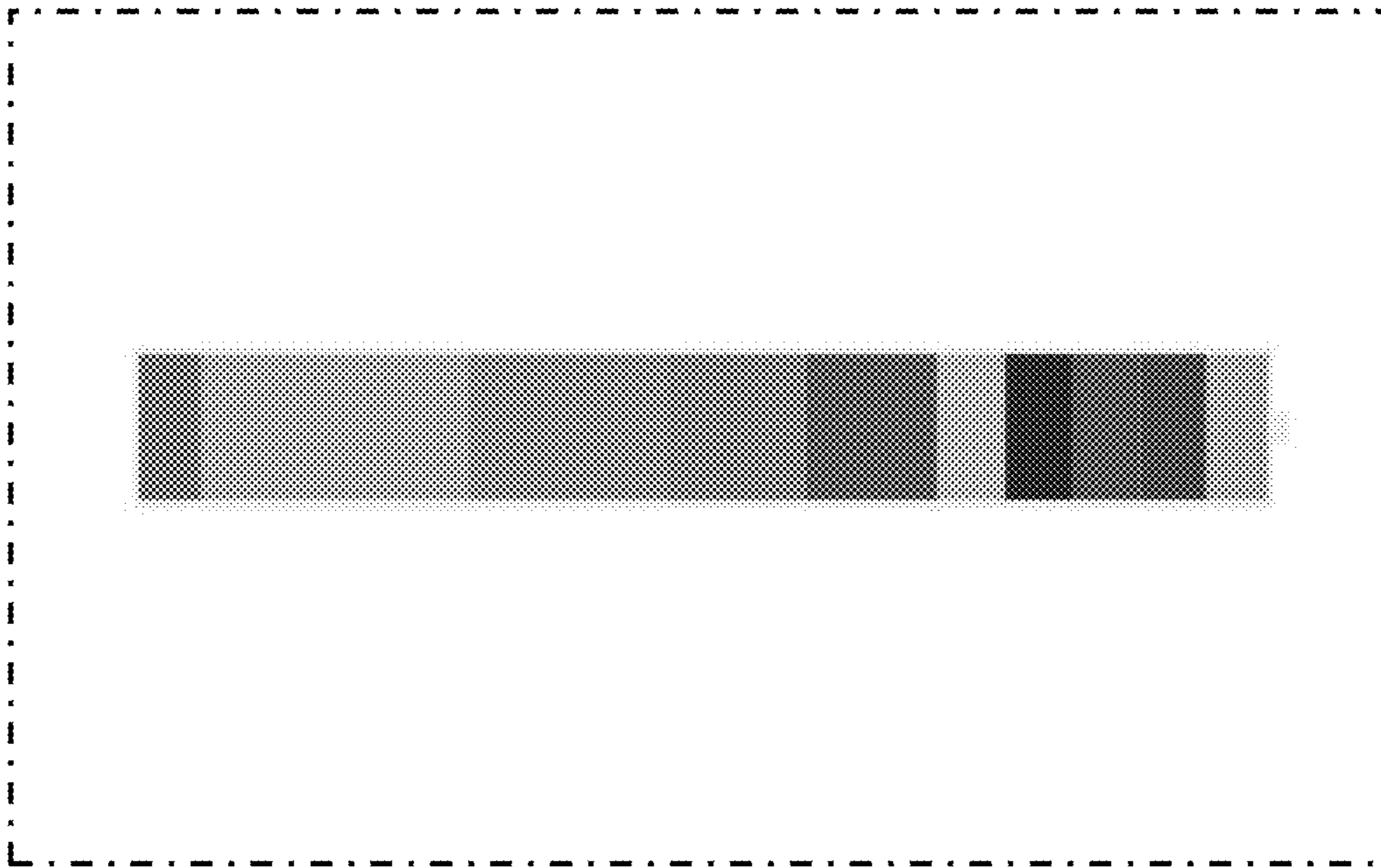

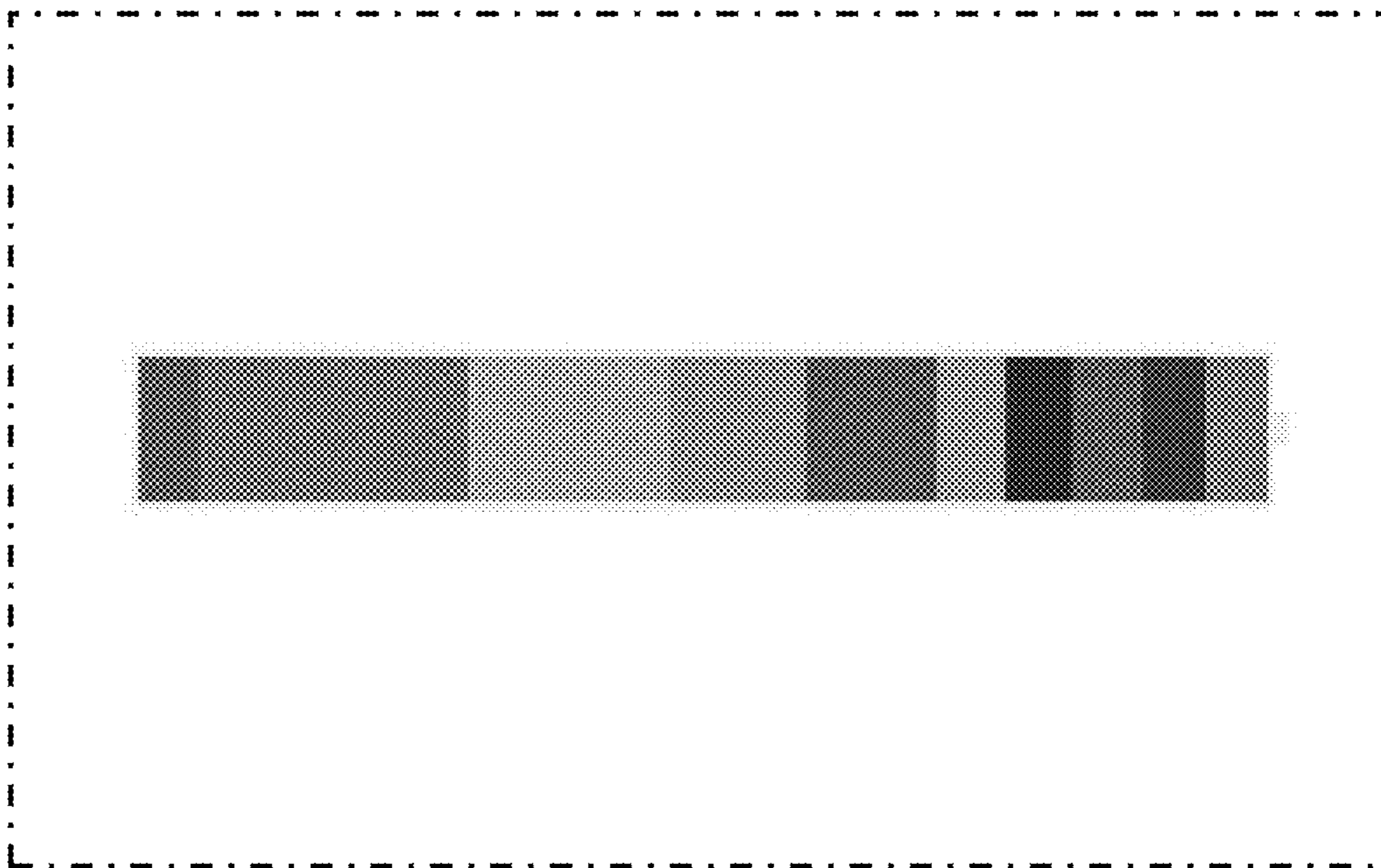
