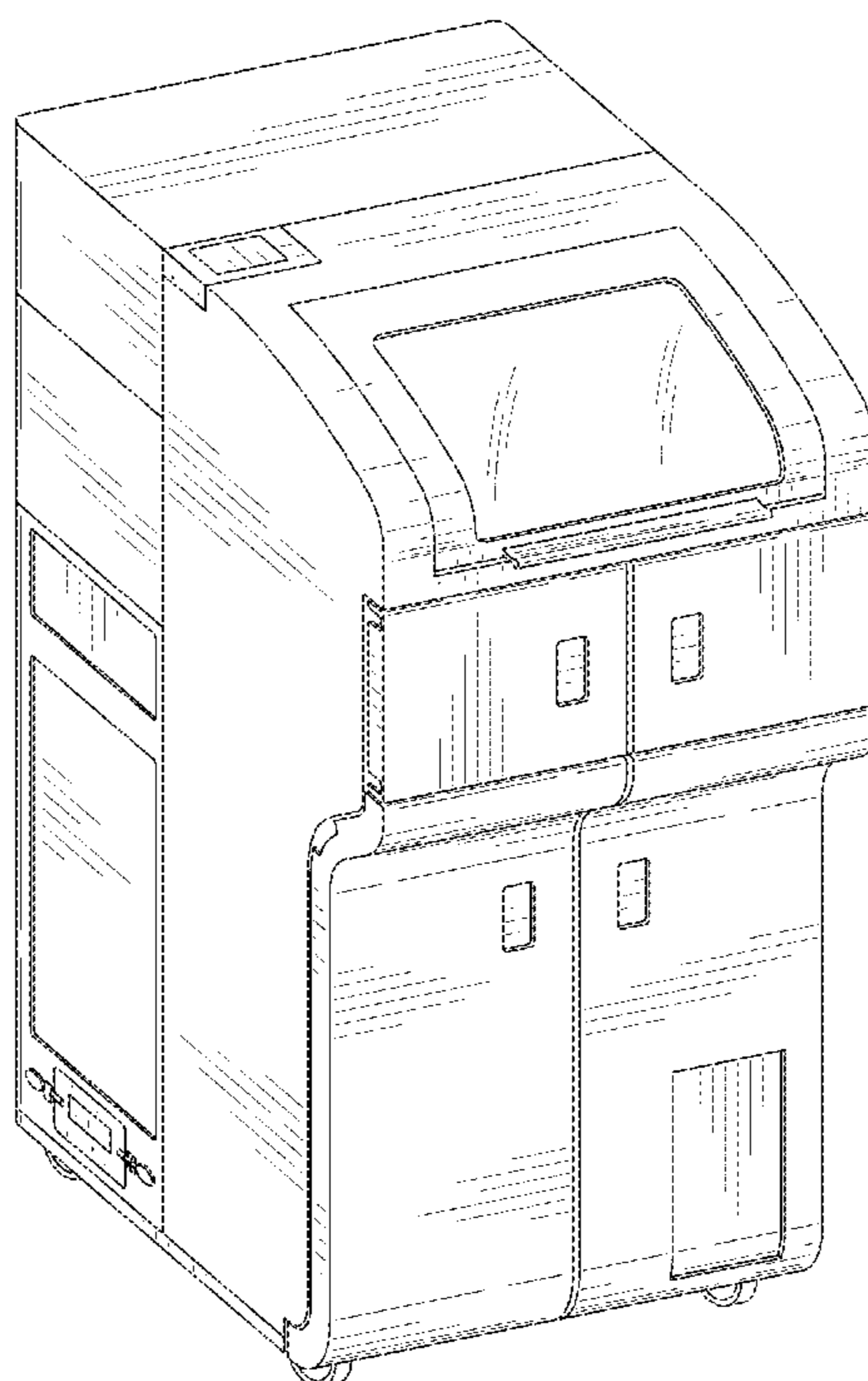
The ornamental design for a shotblasting apparatus, as shown and described.

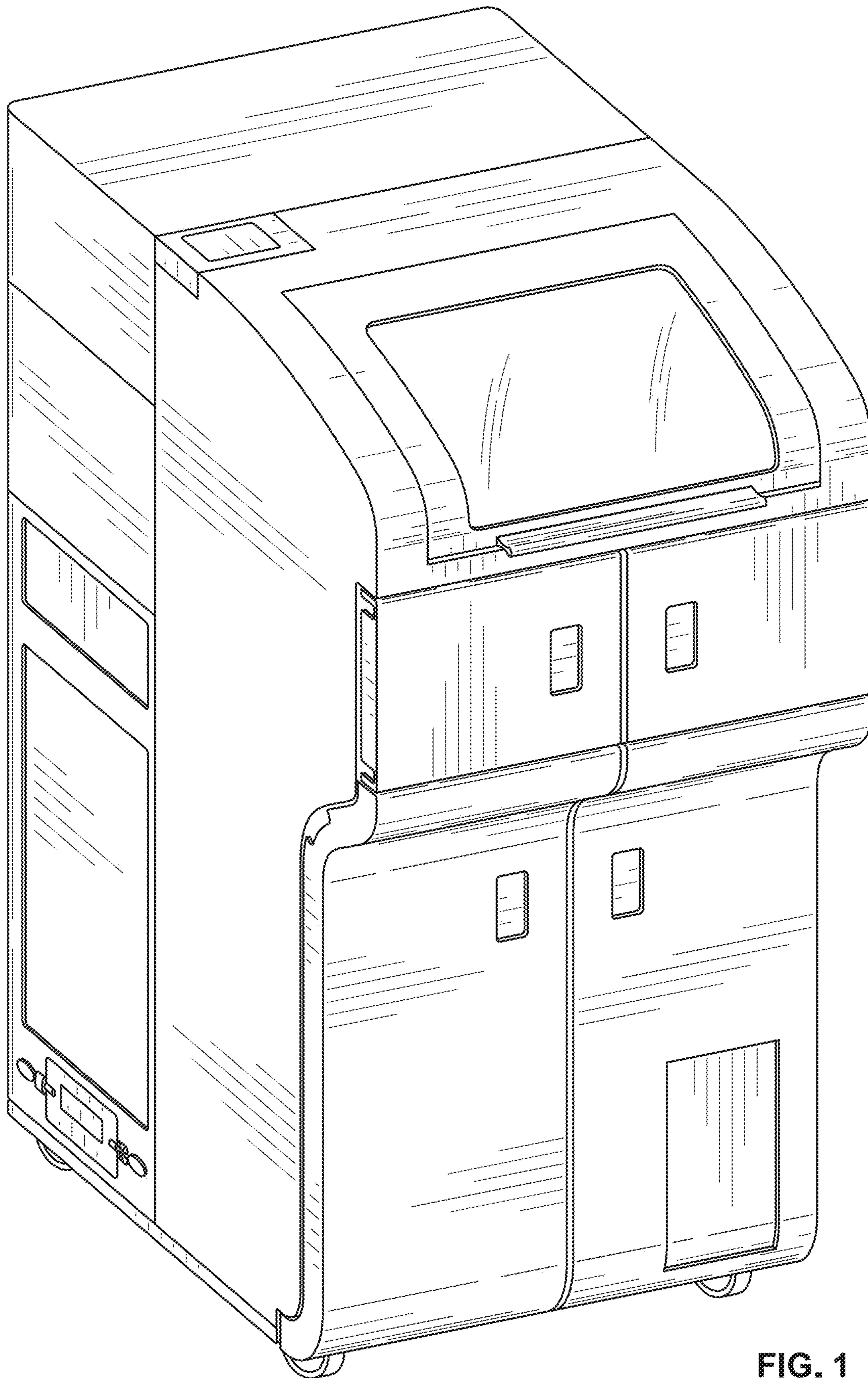

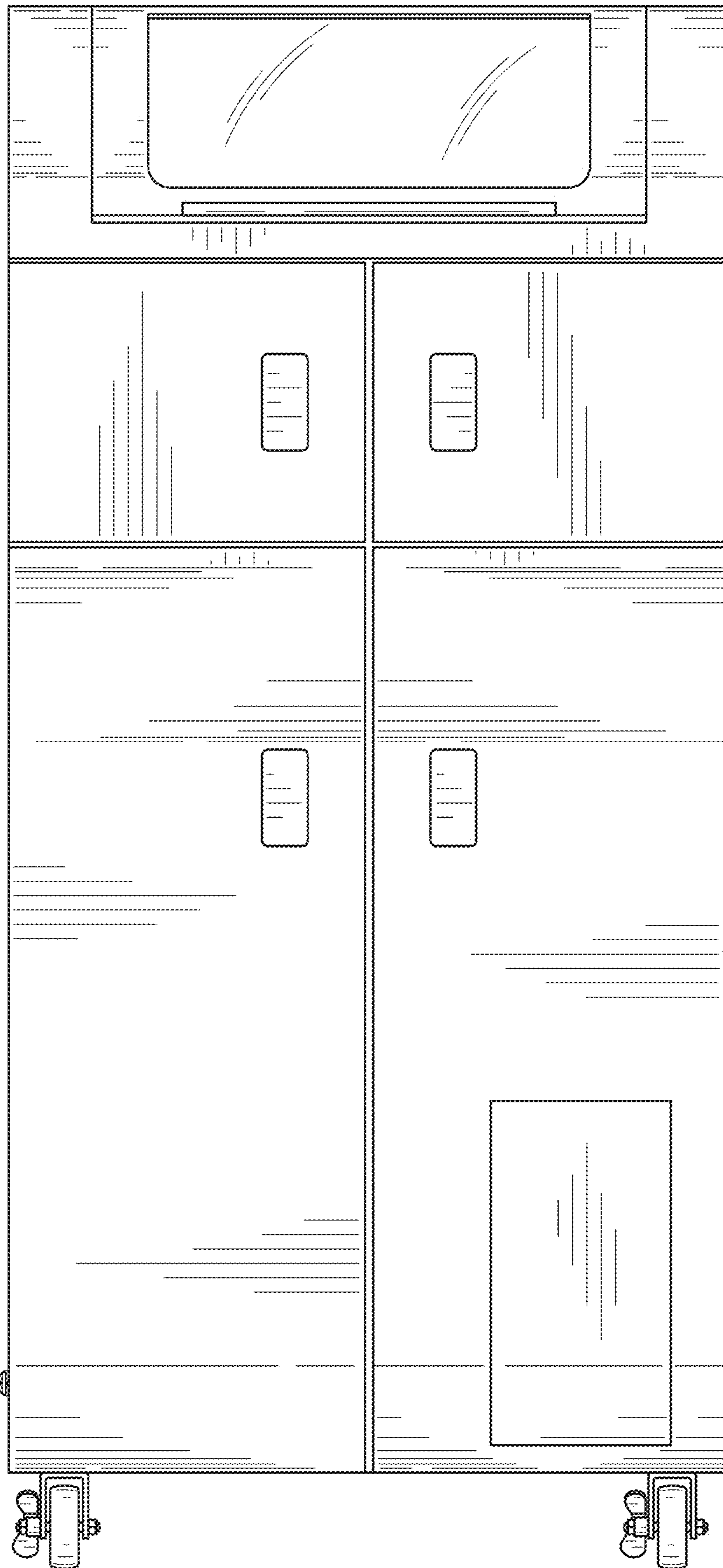

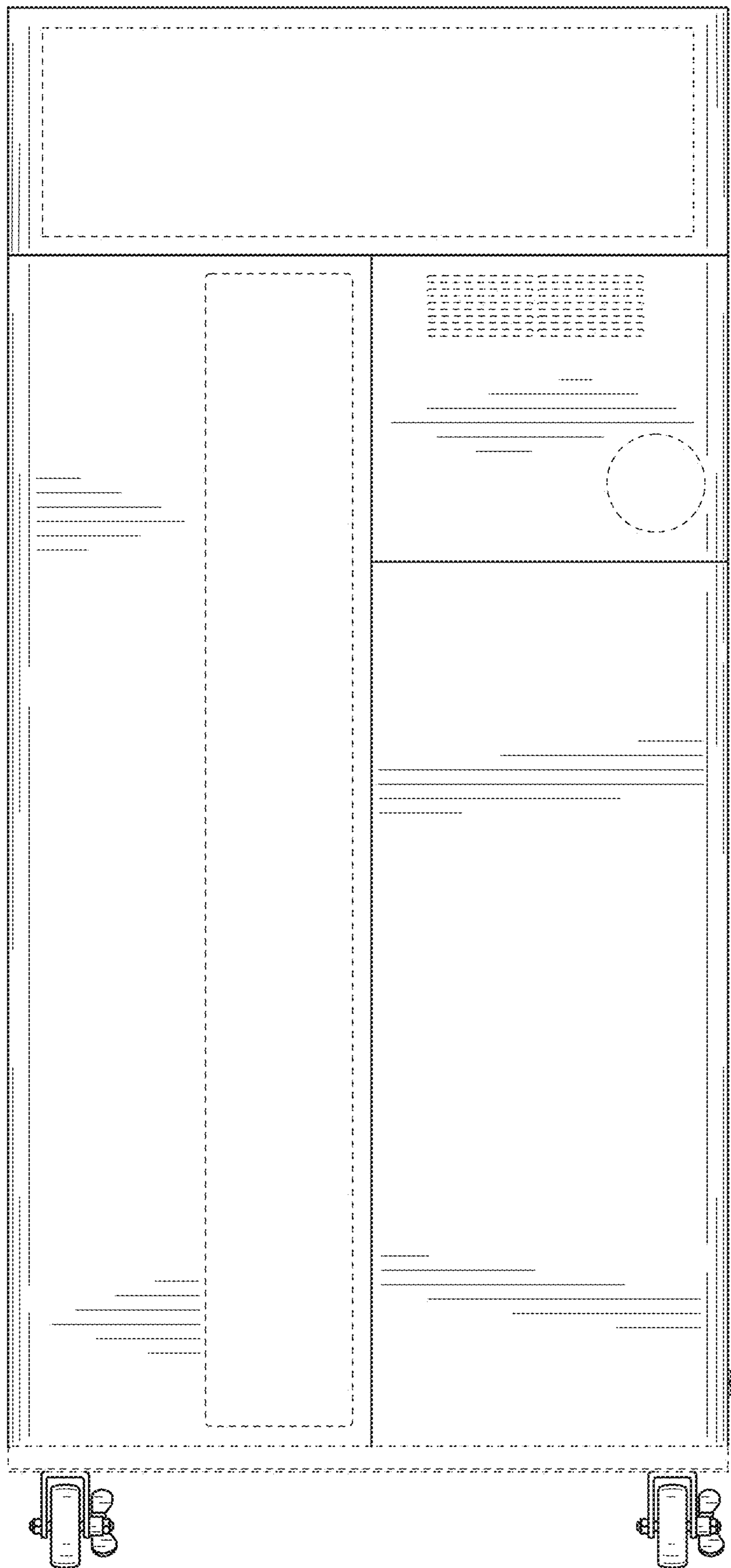

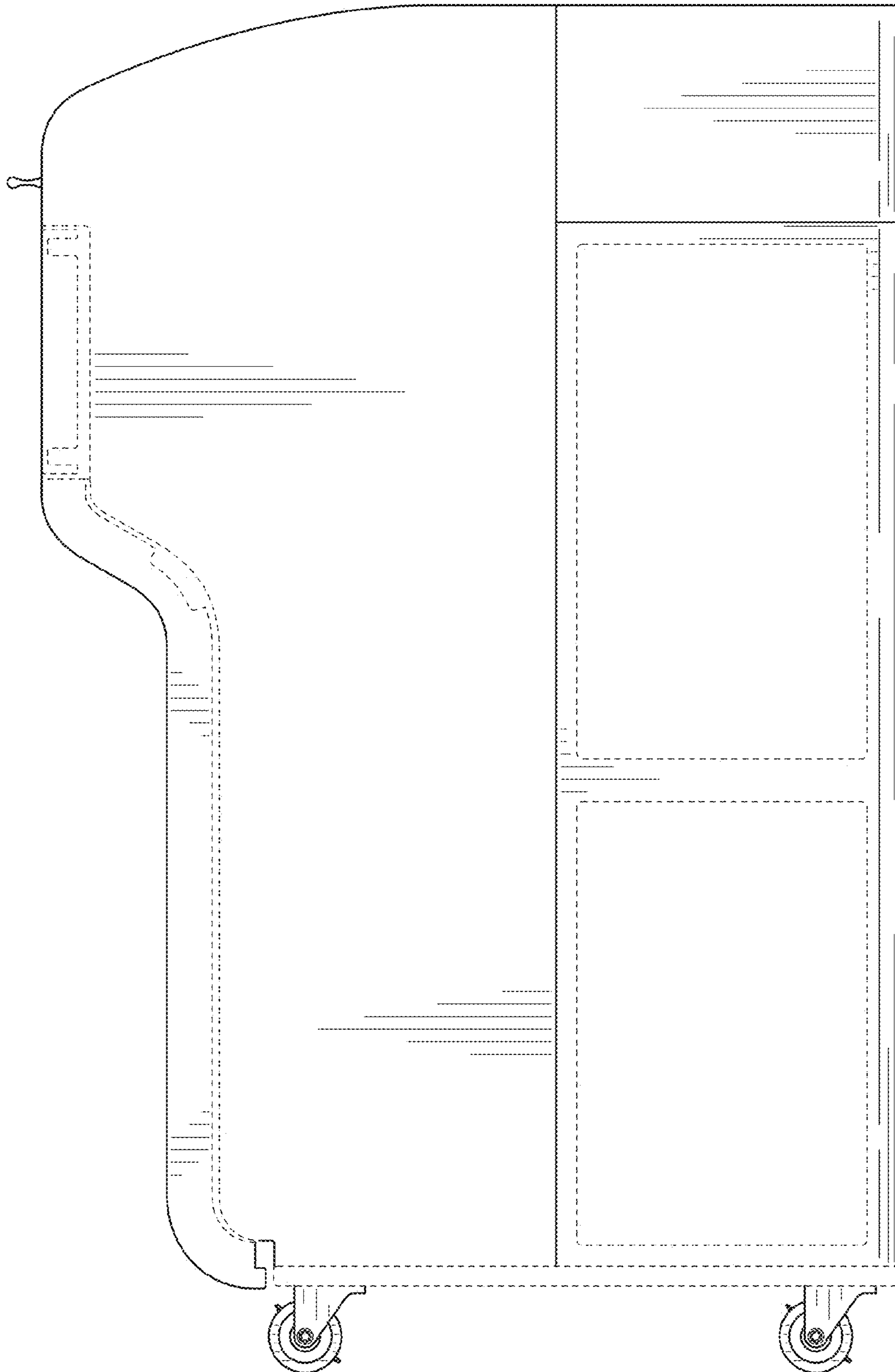

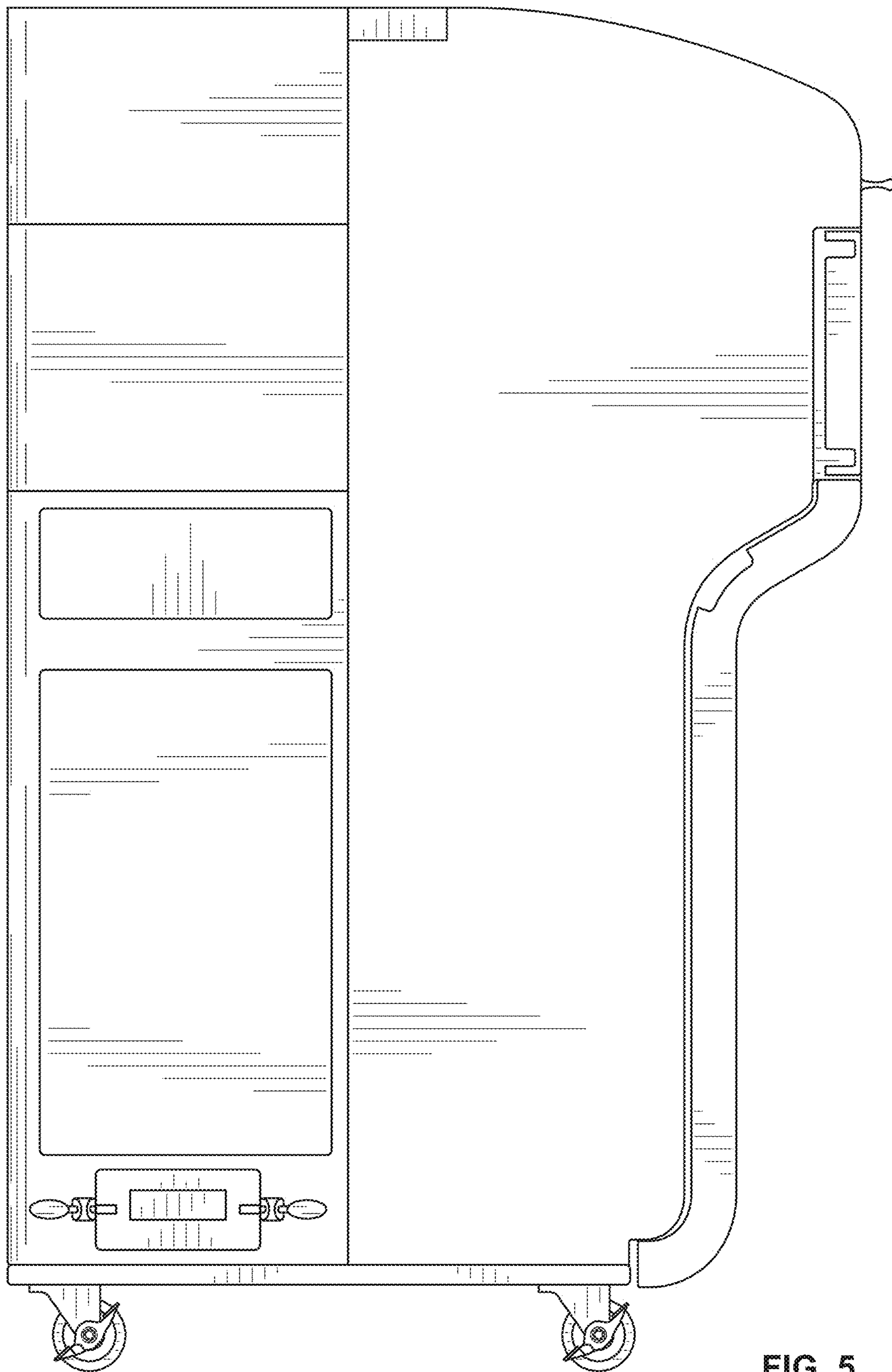

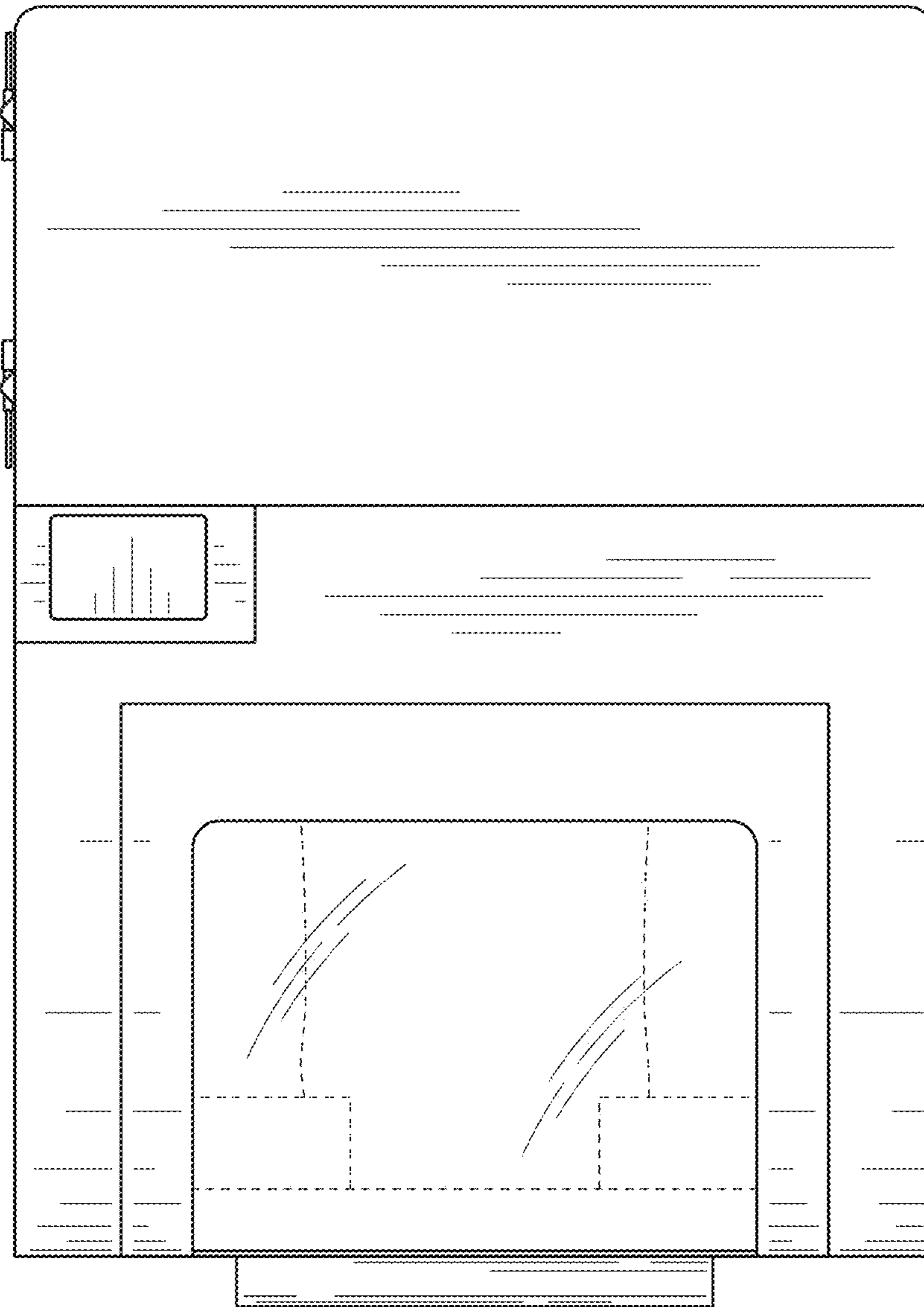

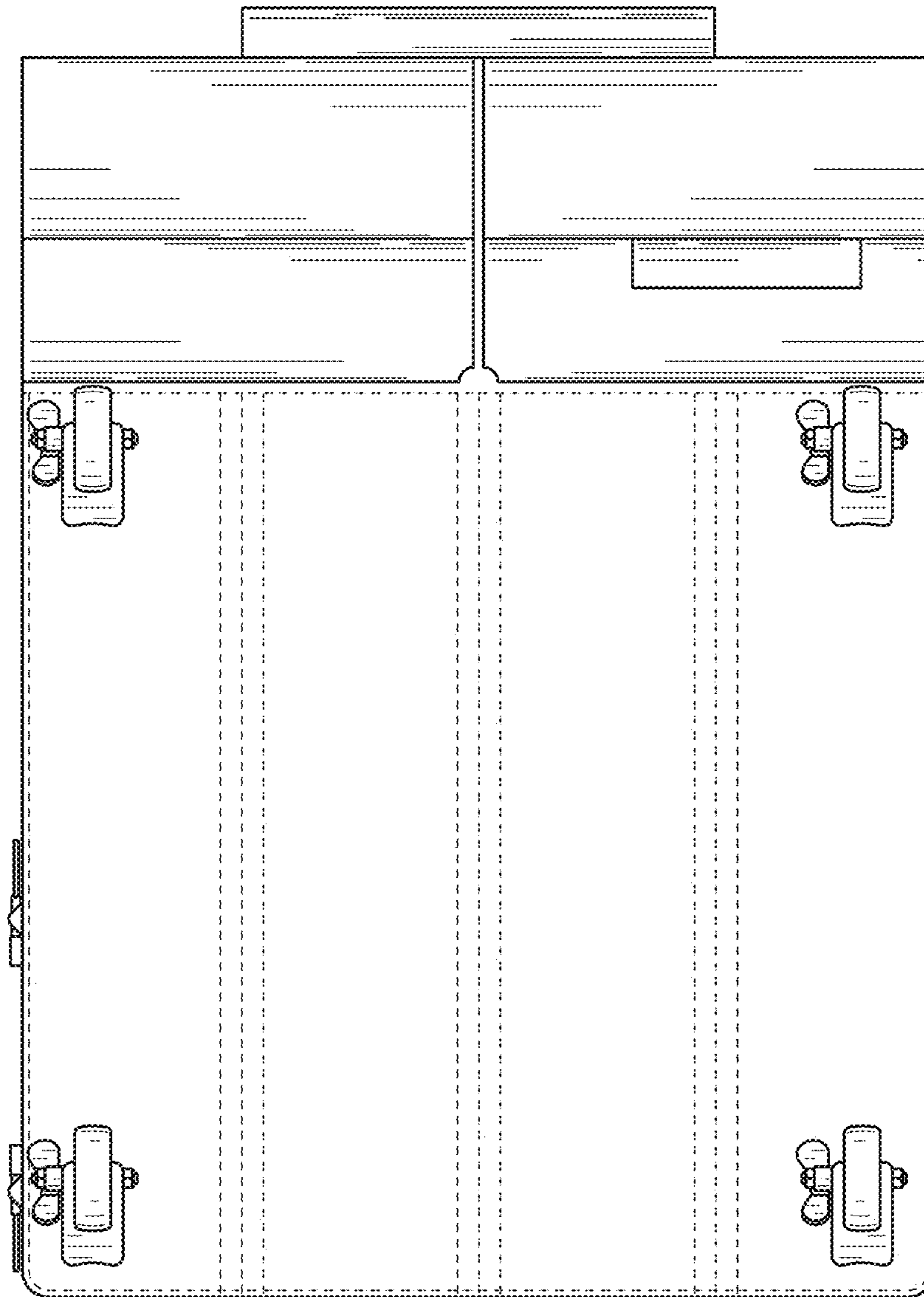

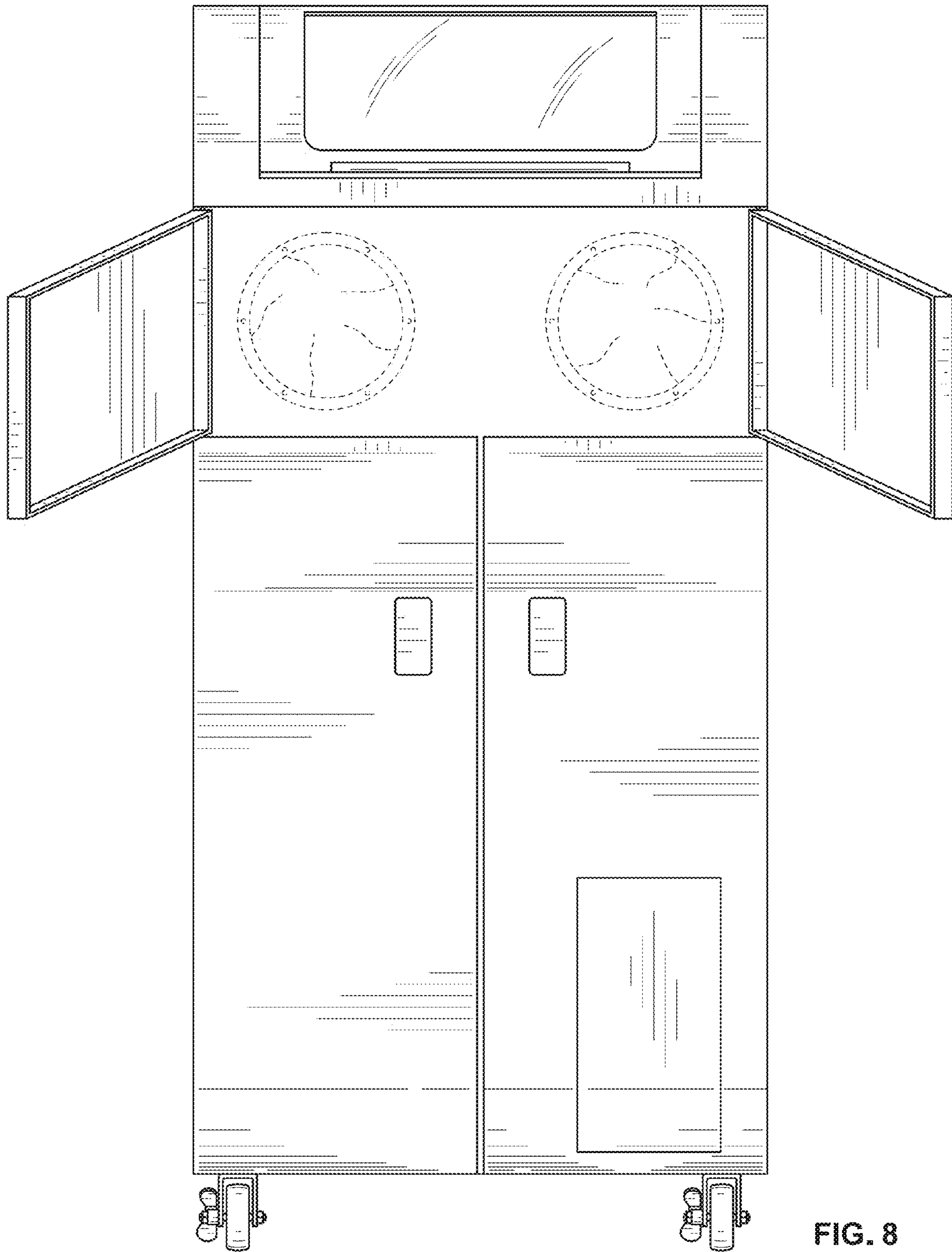
