(57) **CLAIM**

I claim the ornamental design for a set of bags for billiards-type bag toss game, as shown and described.

**DESCRIPTION**

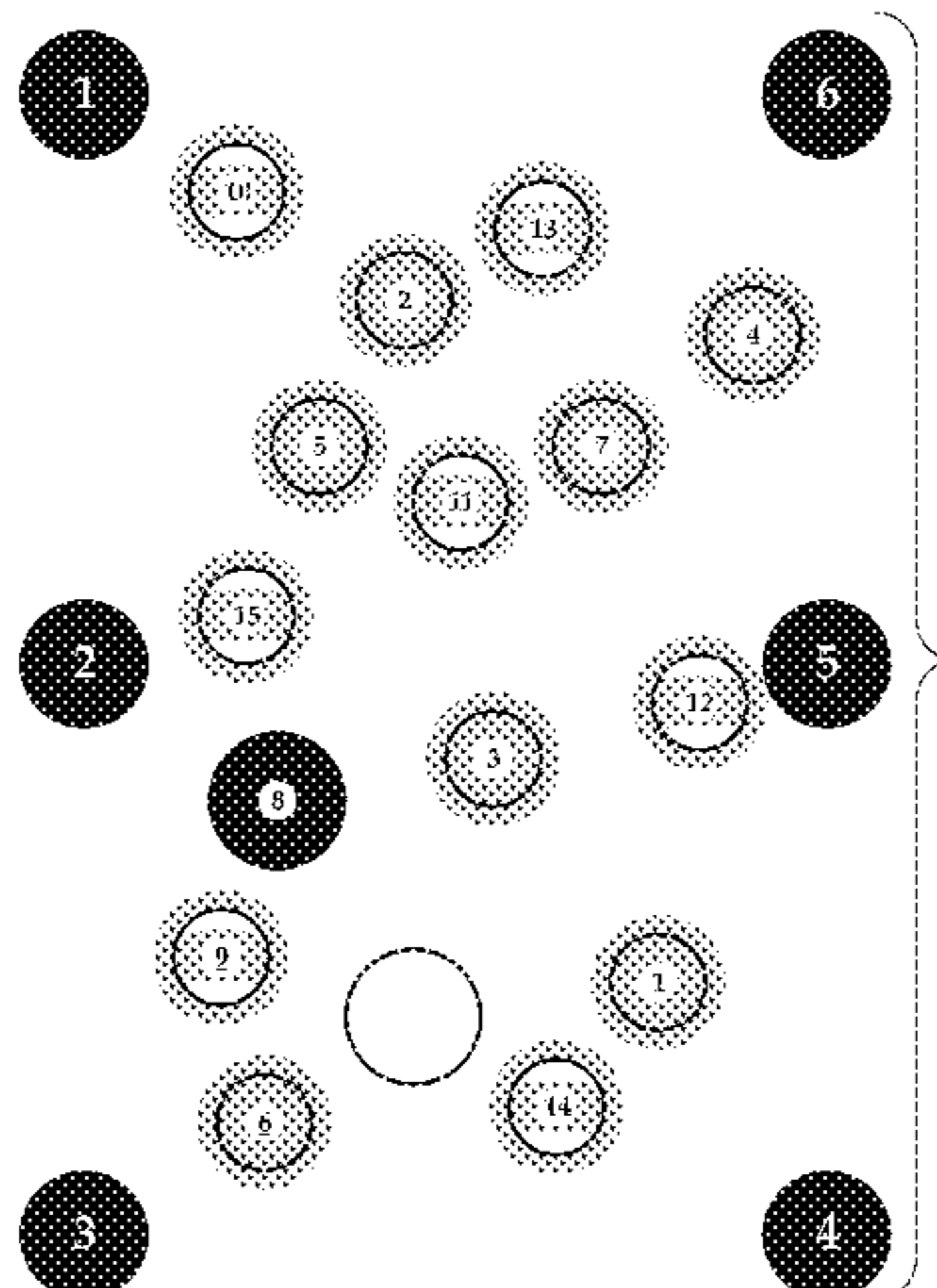


FIG. 27 is a bottom/side perspective detail view of game piece #1 bag, game piece #2-#7 bags each having an identical bottom/side perspective view;

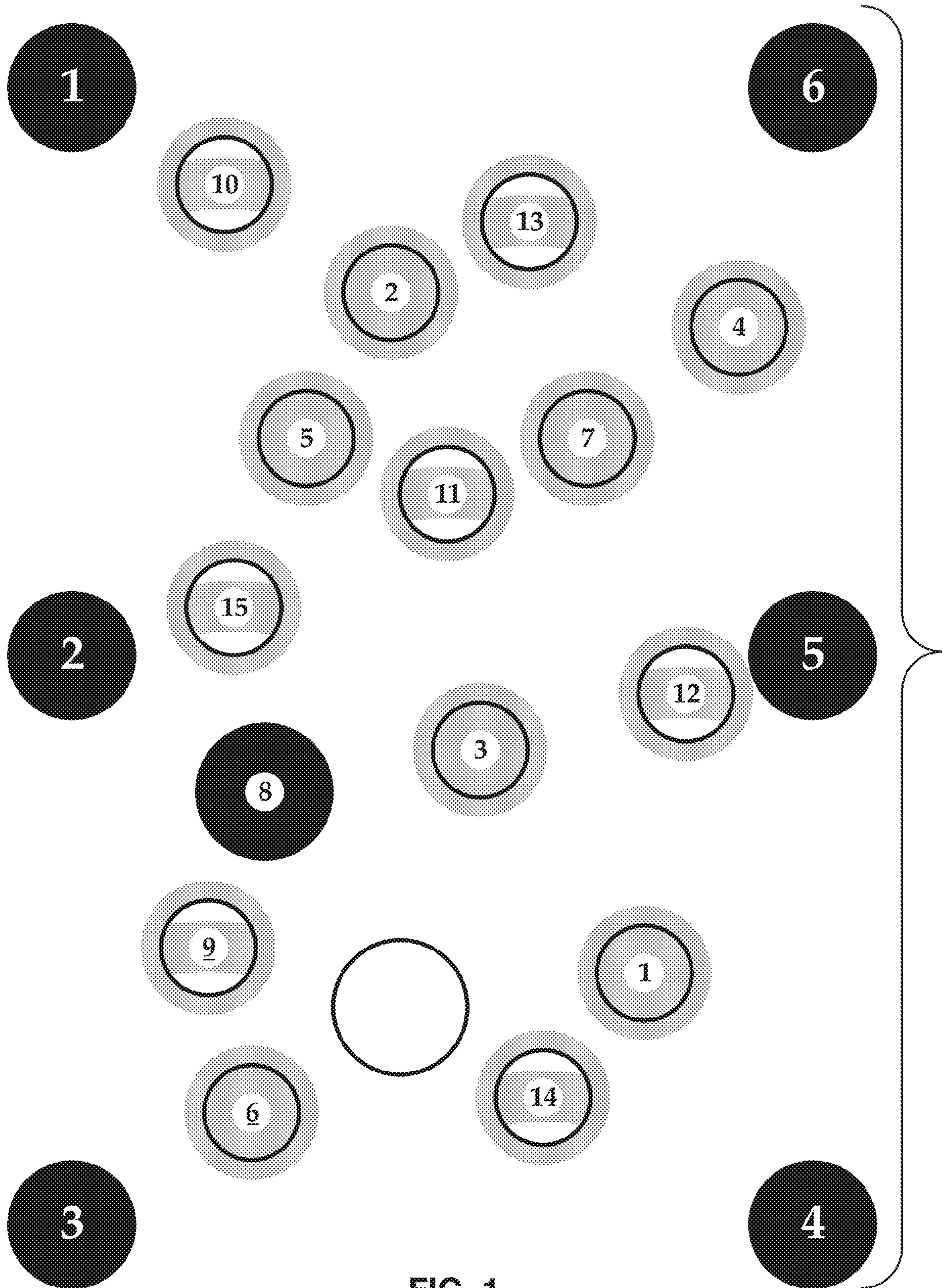

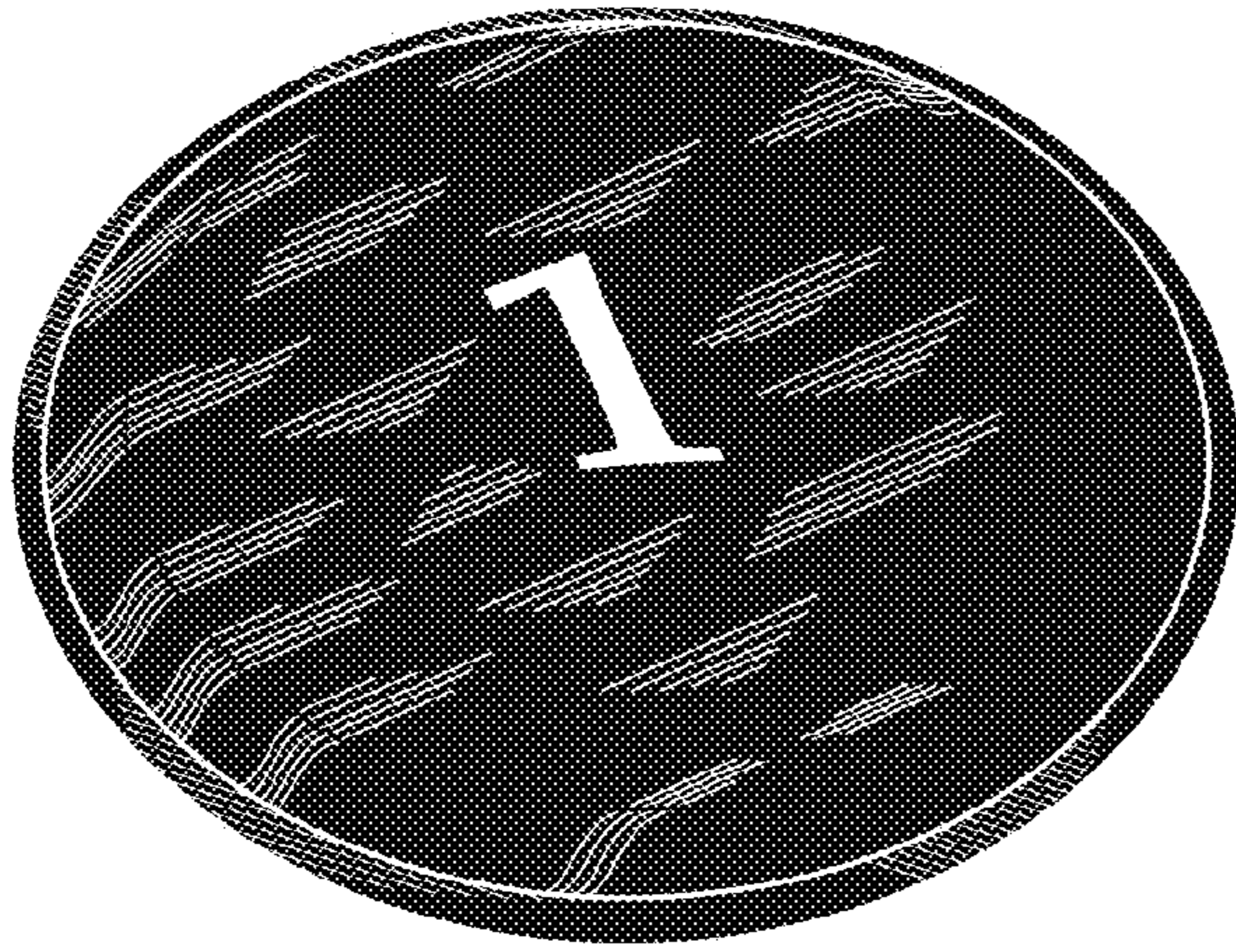

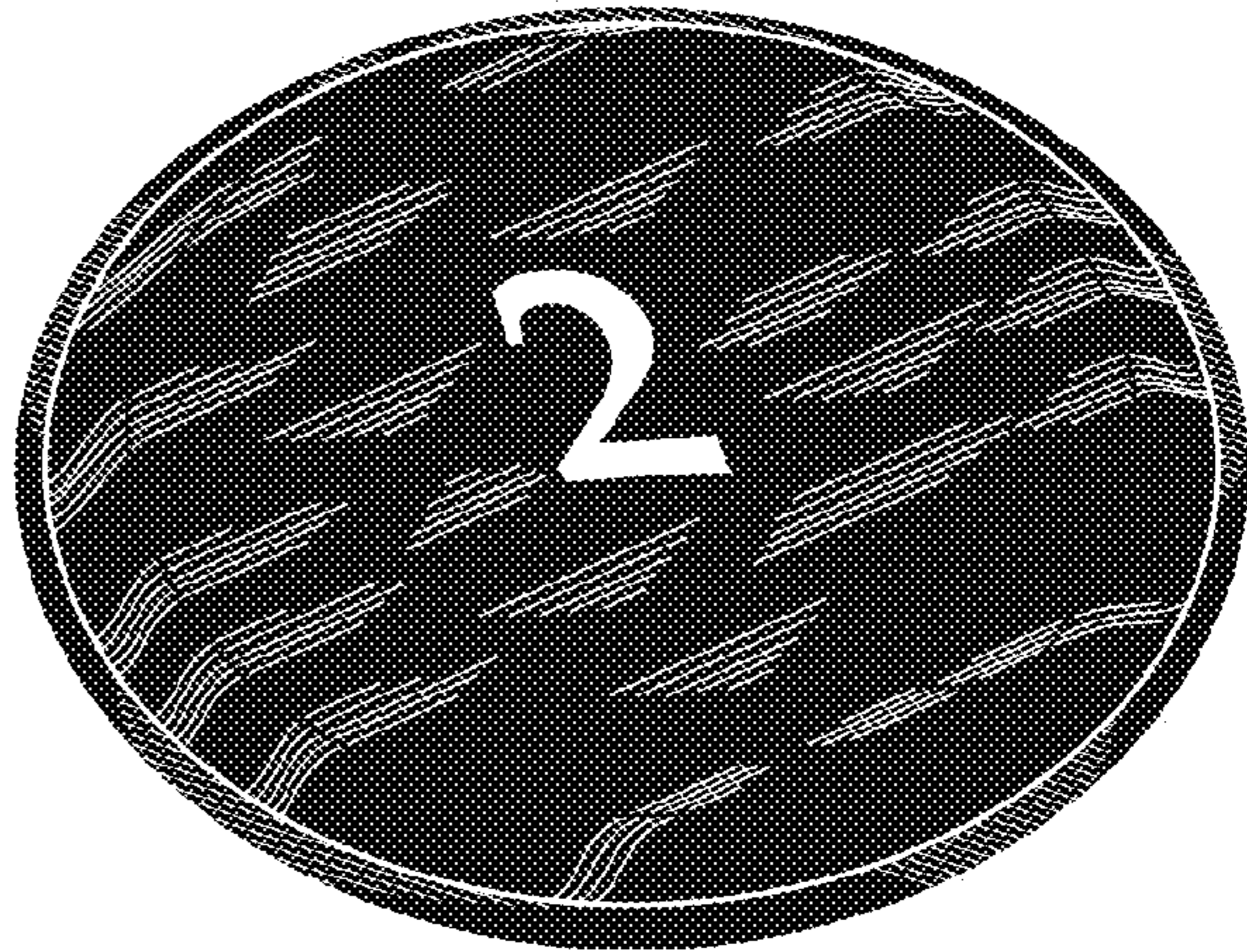

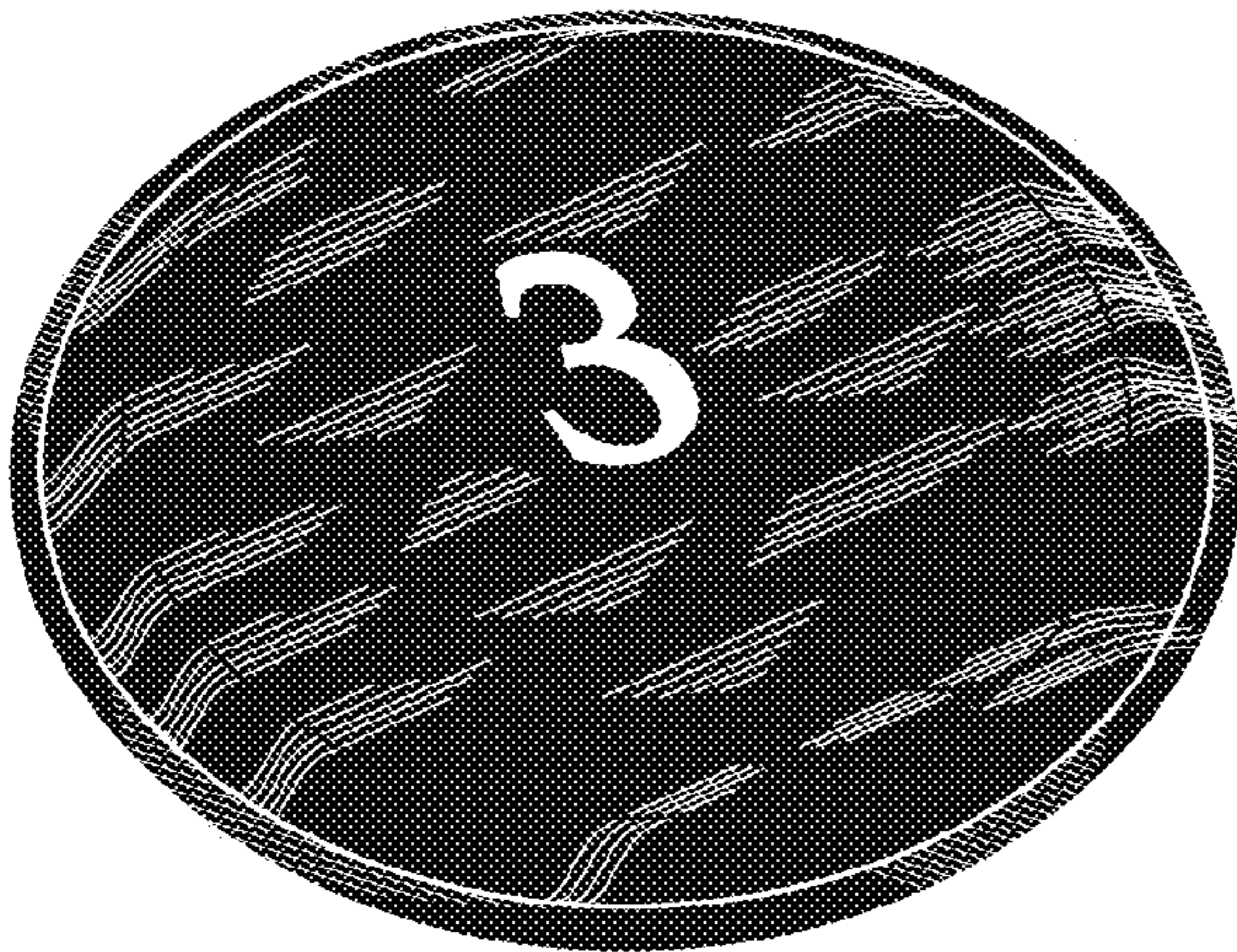

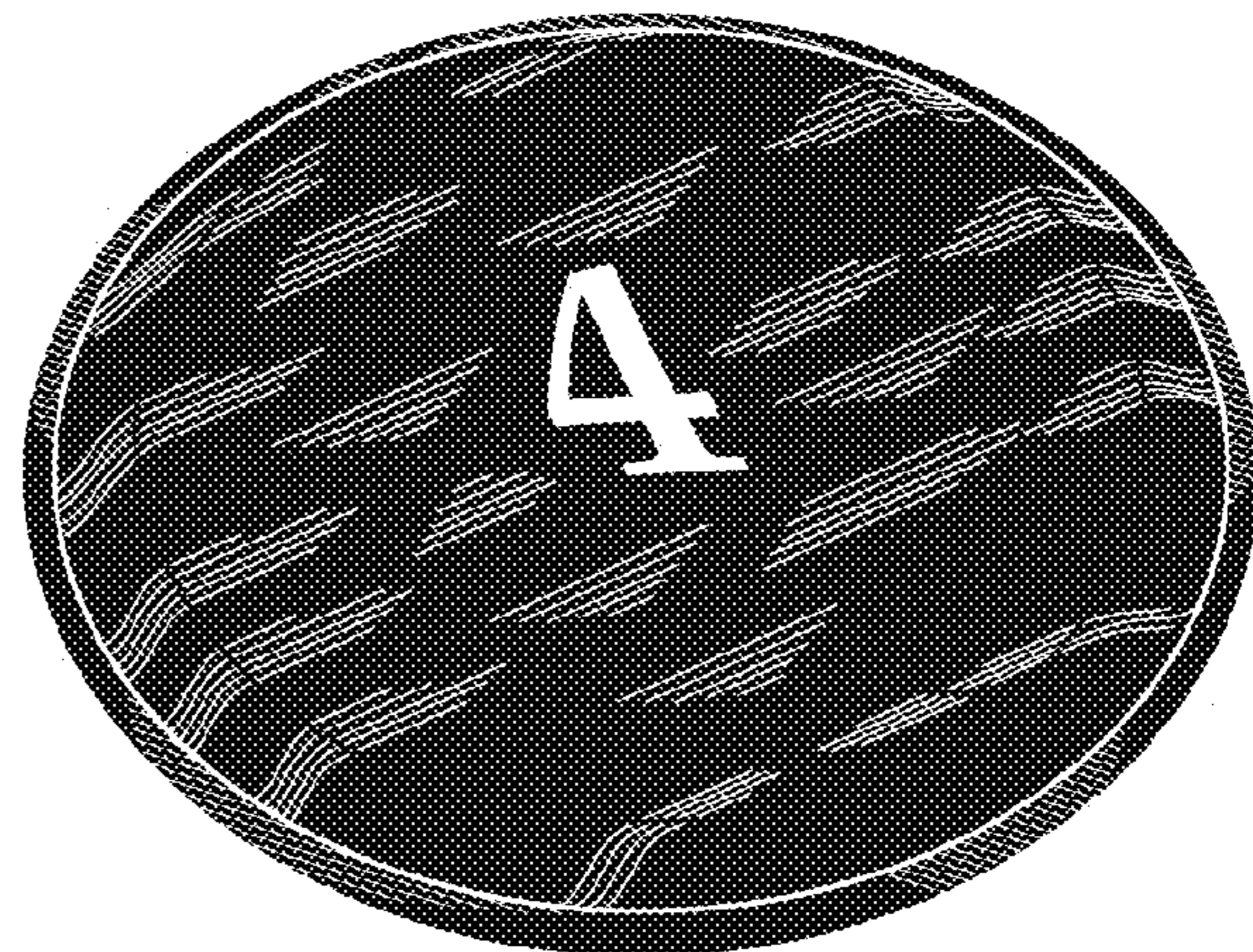

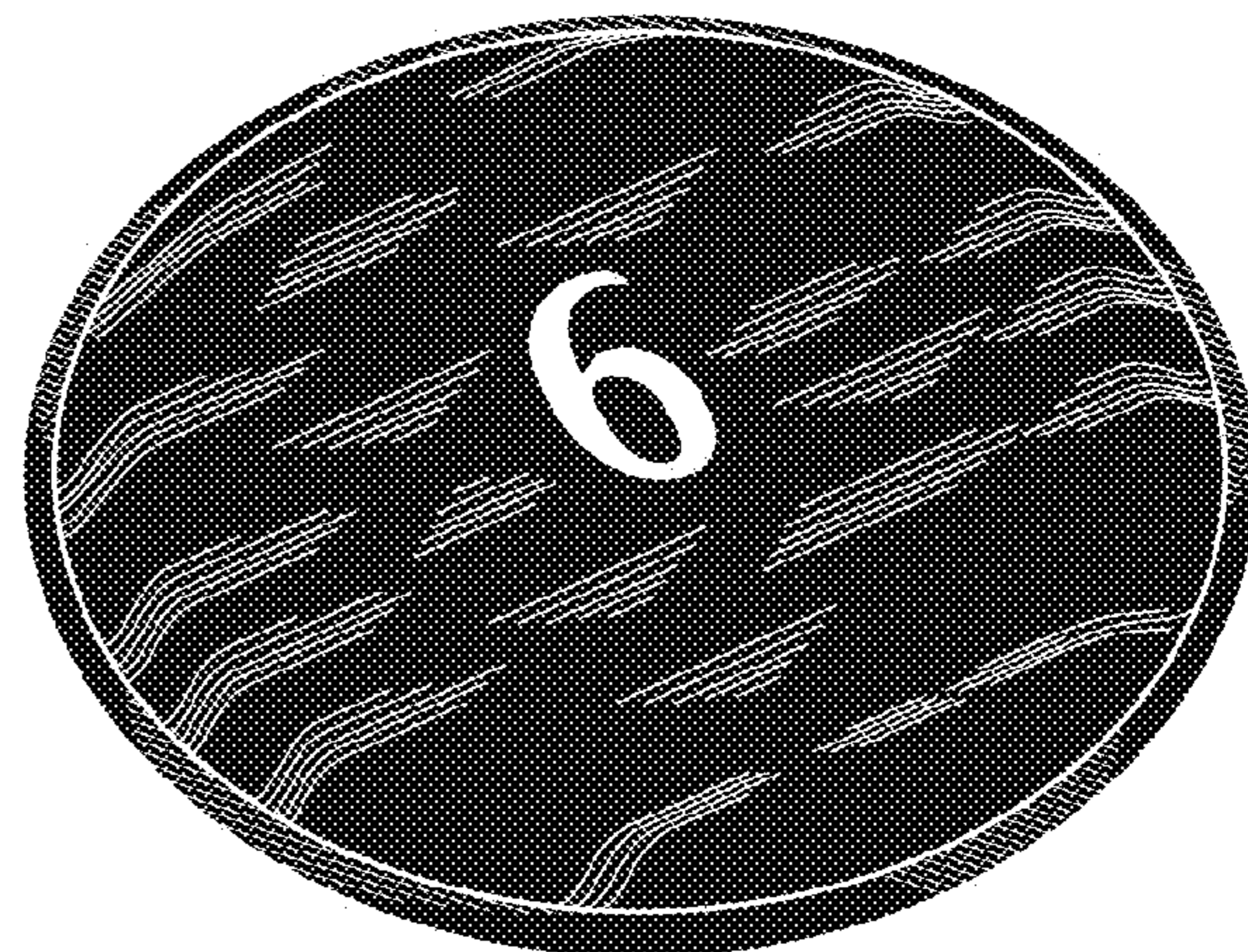

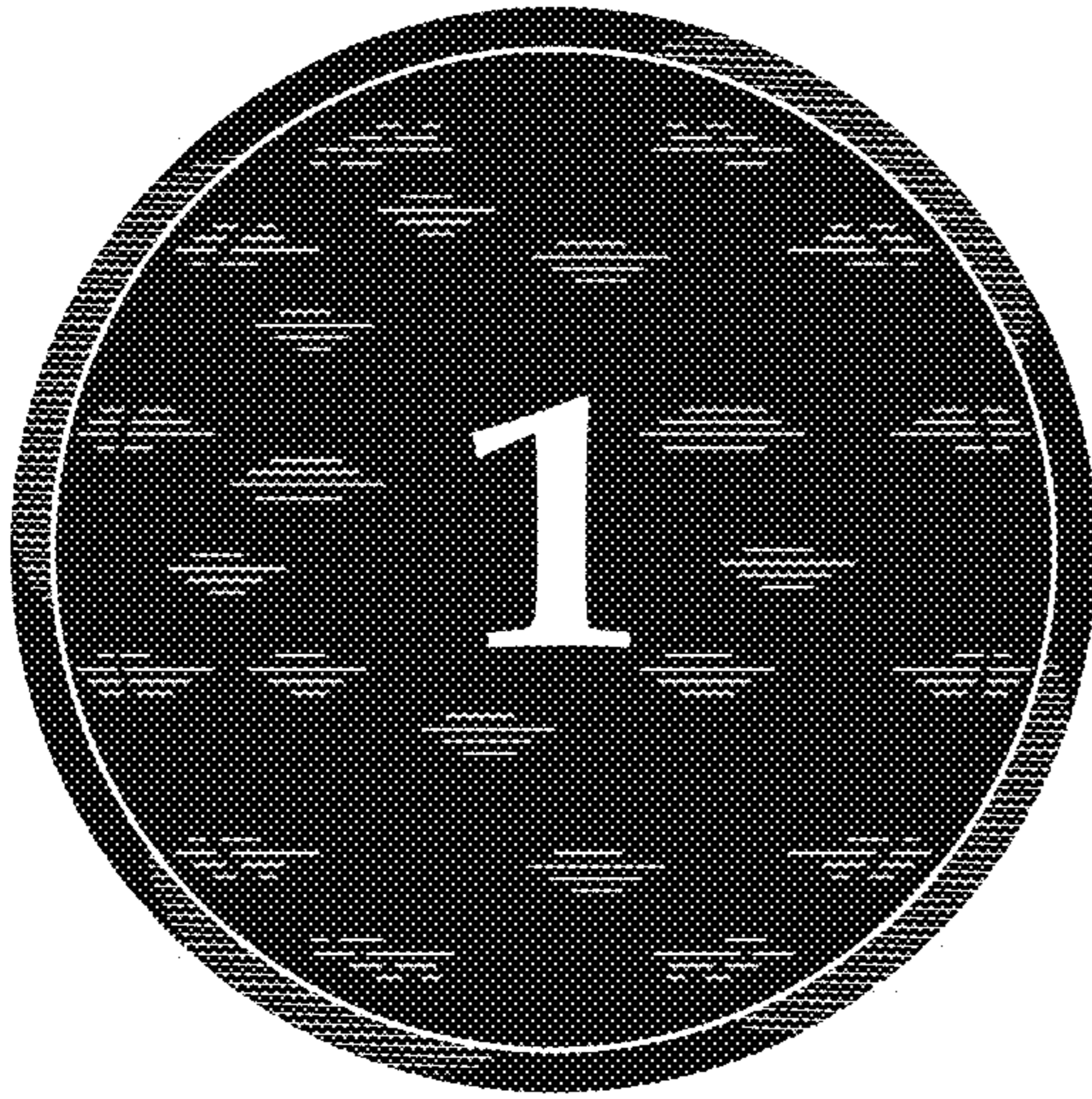

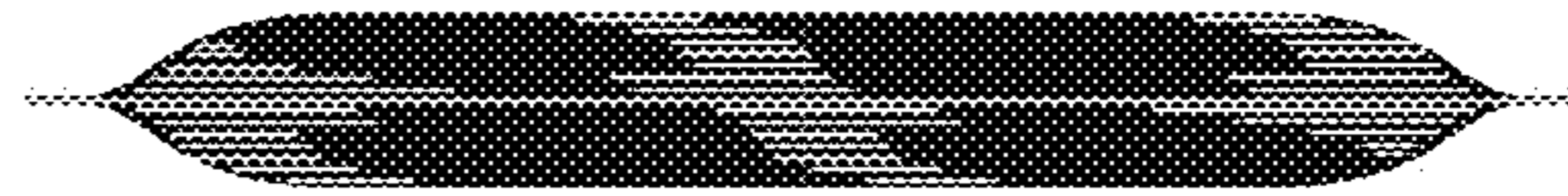

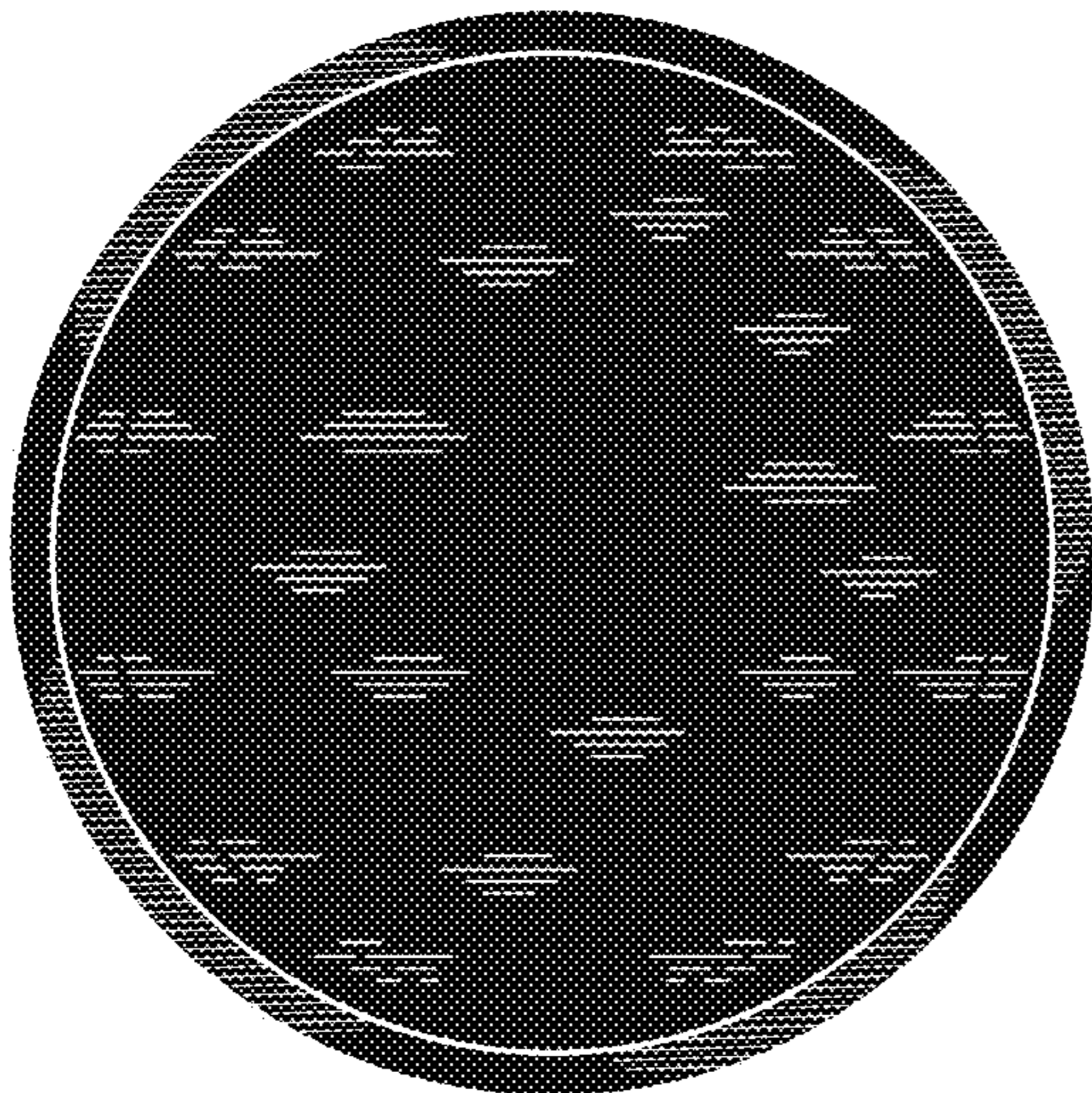

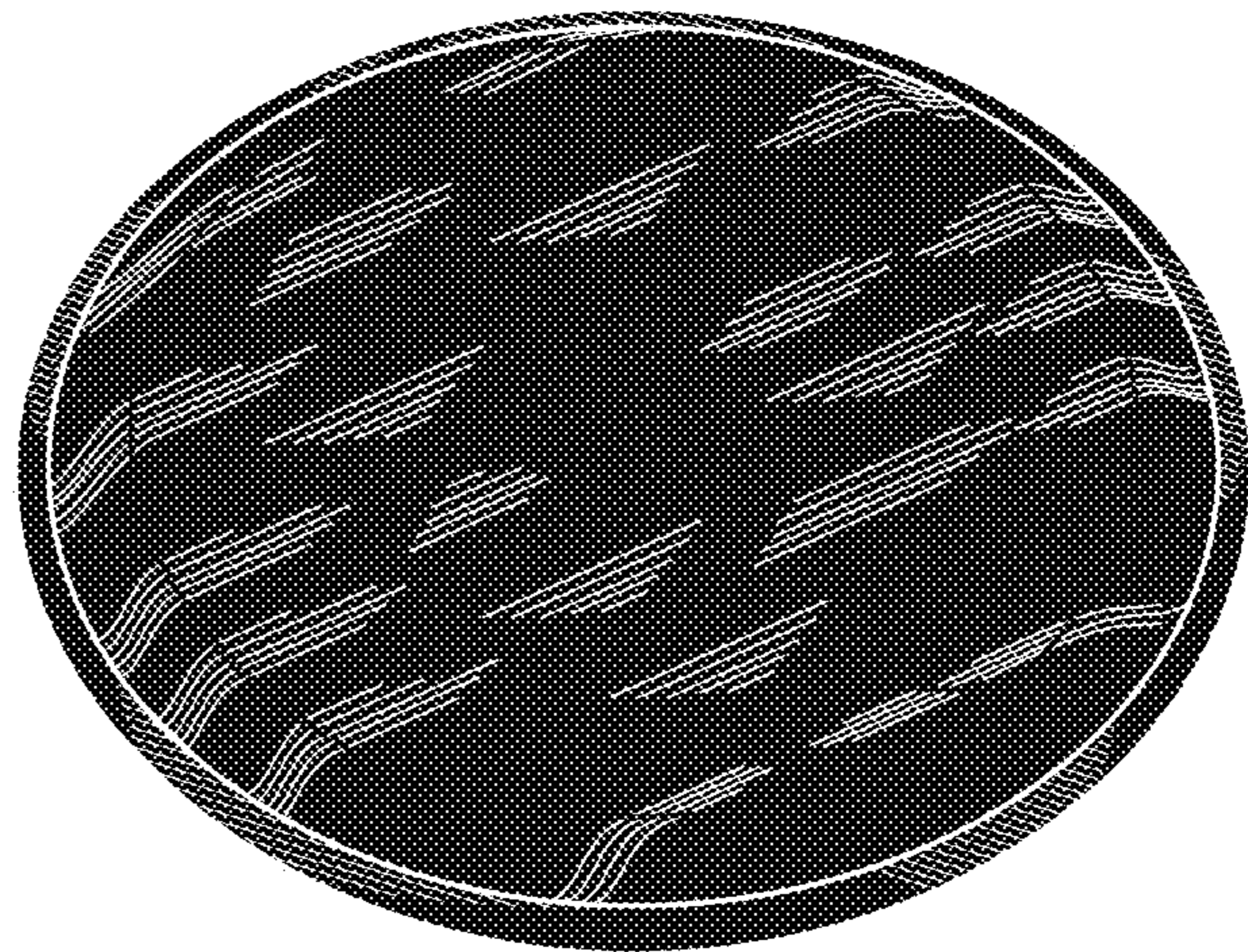

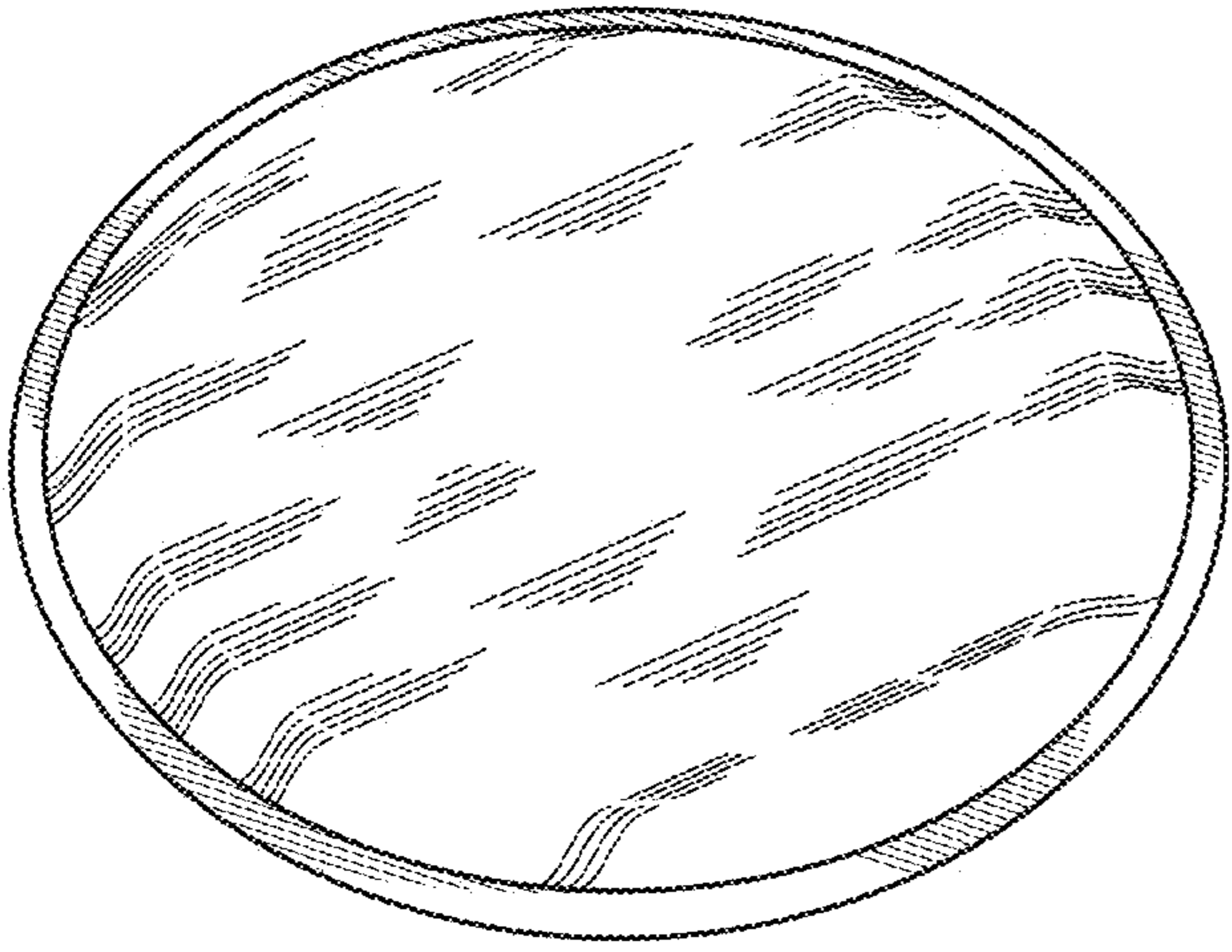

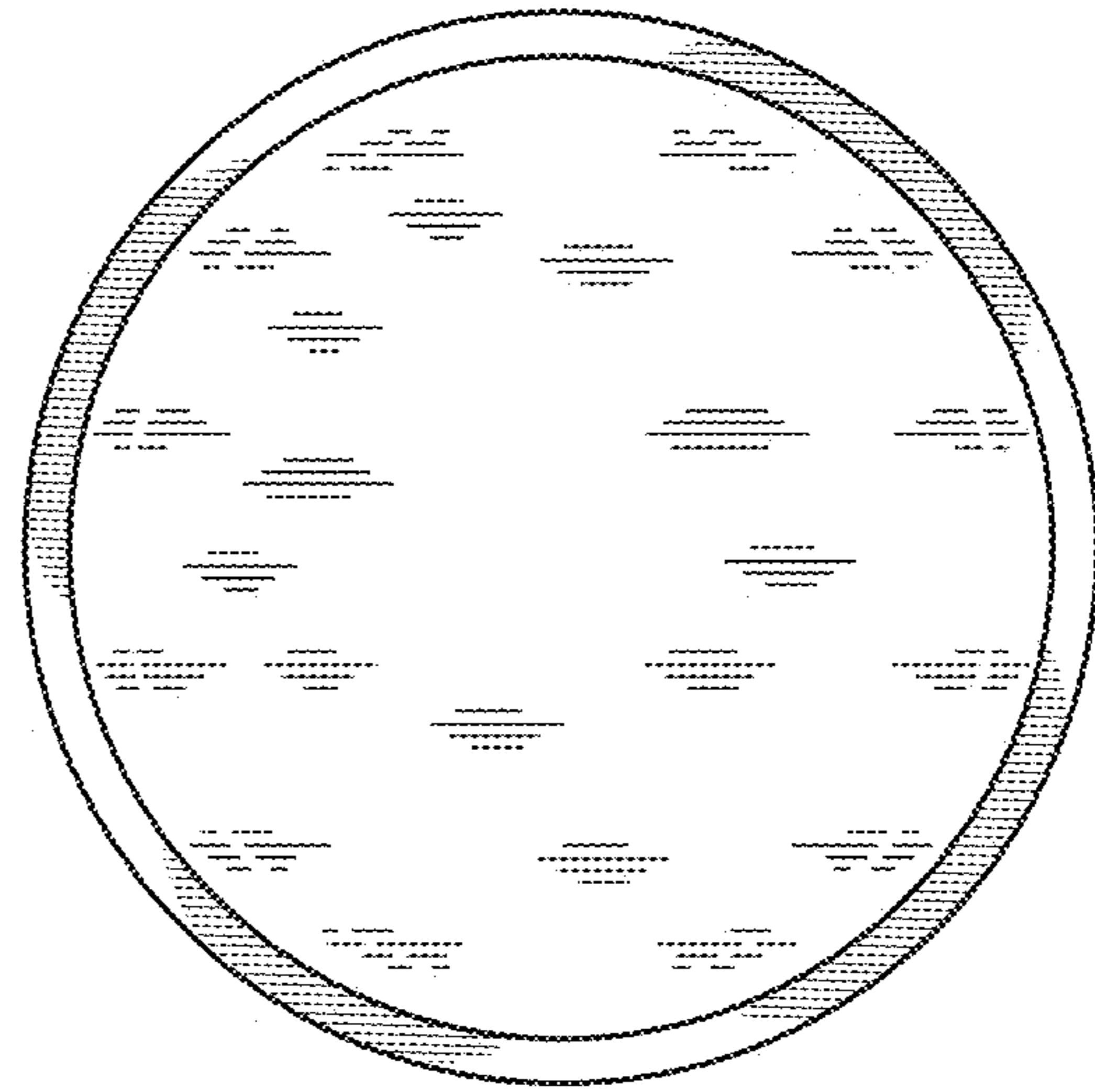

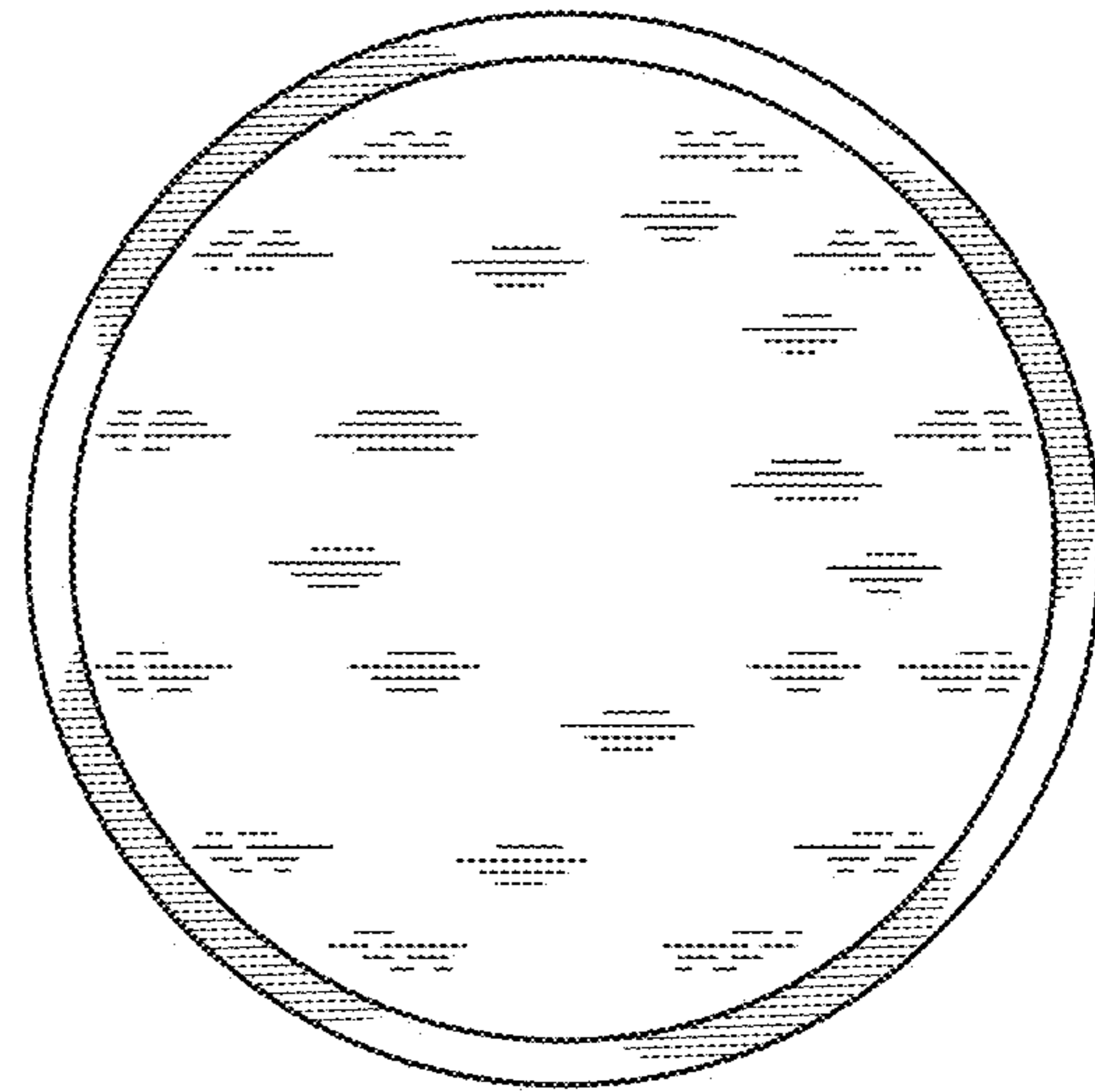

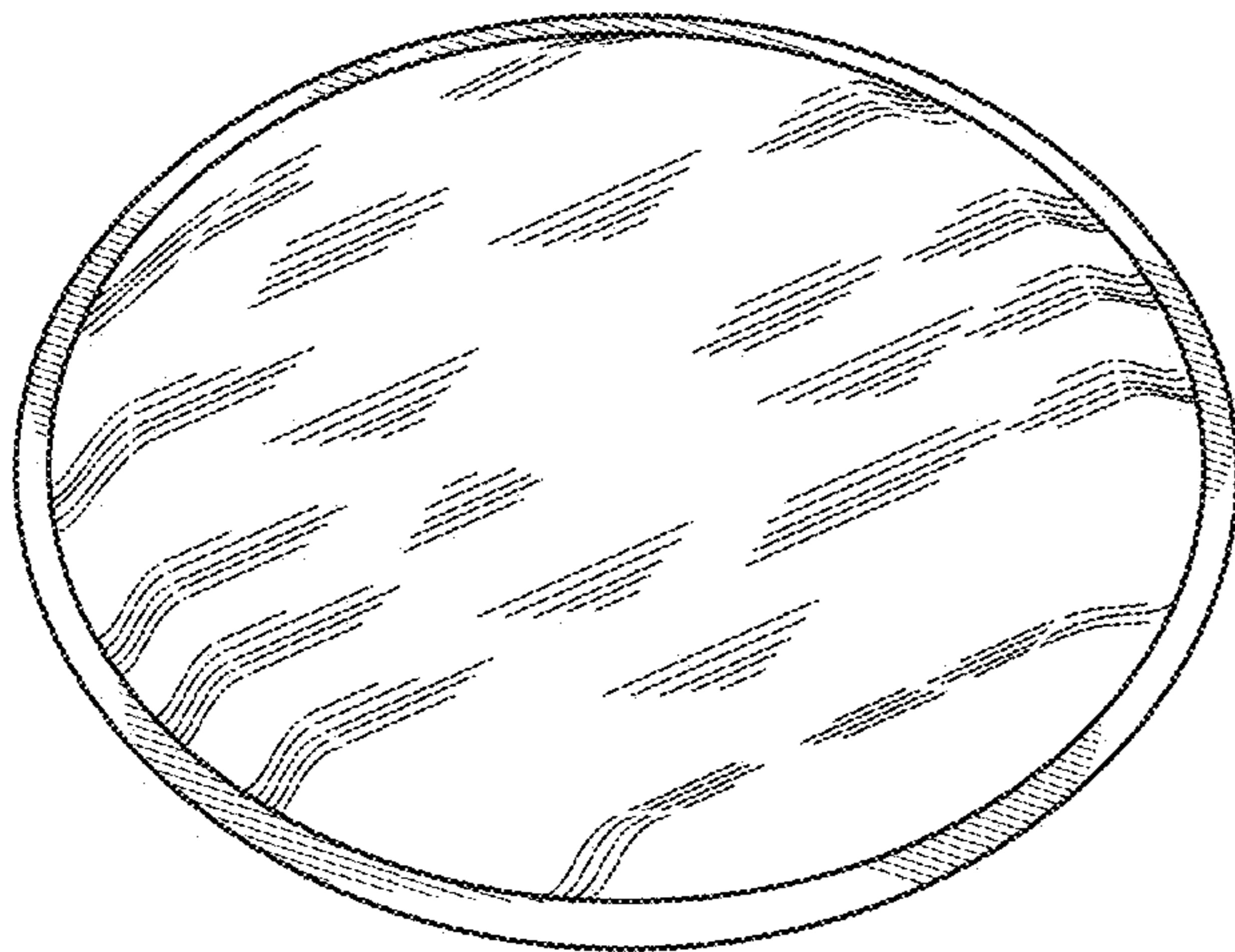

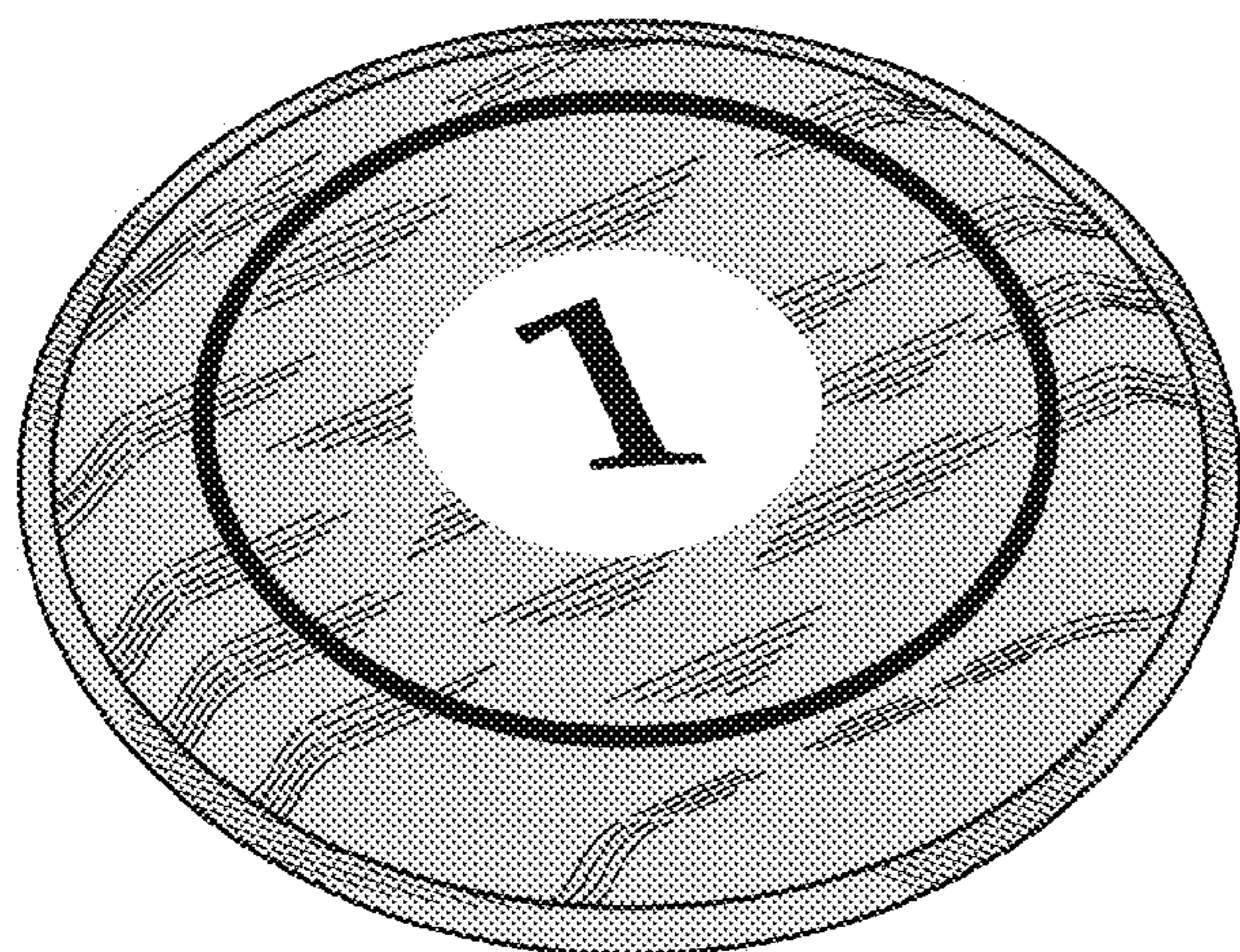

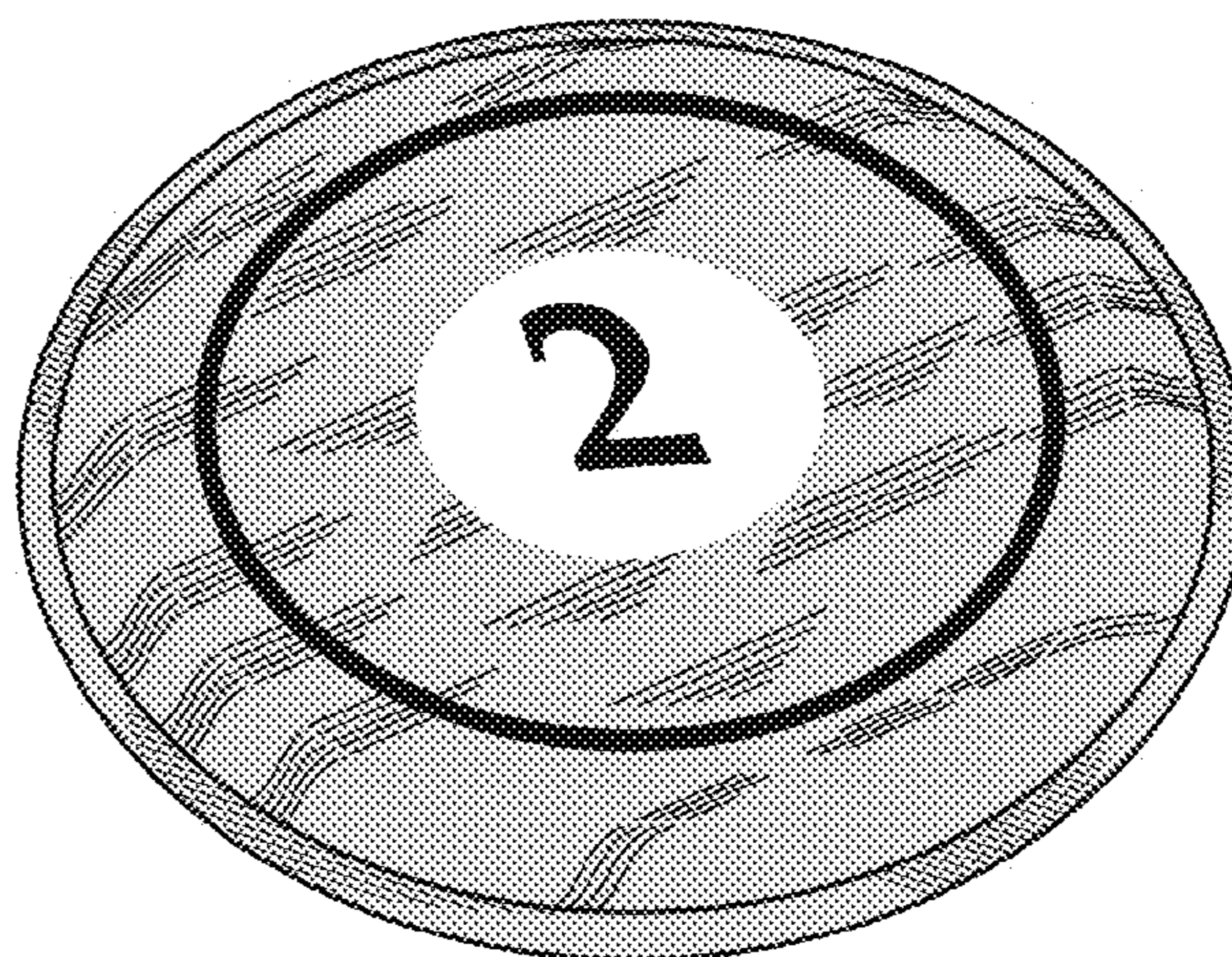

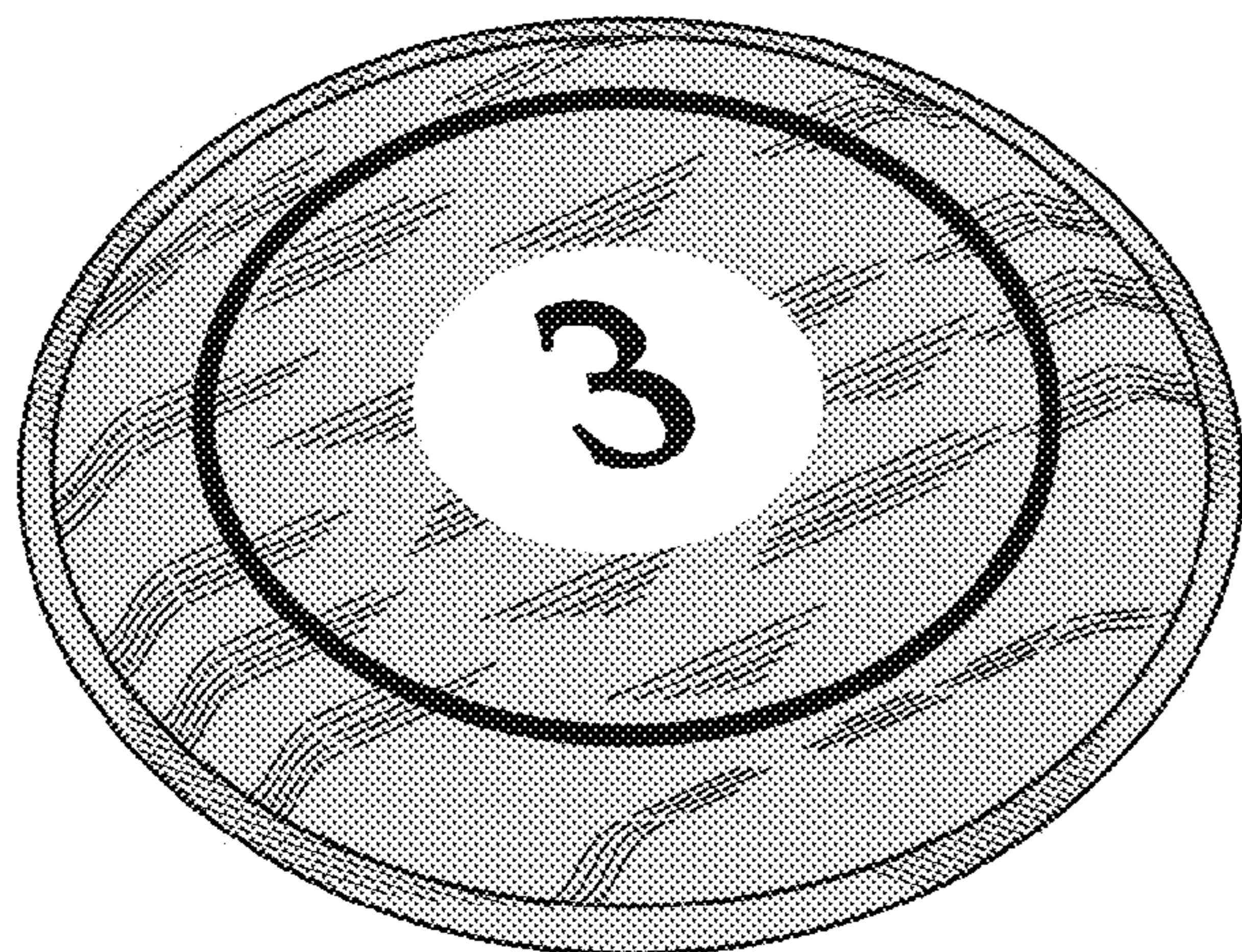

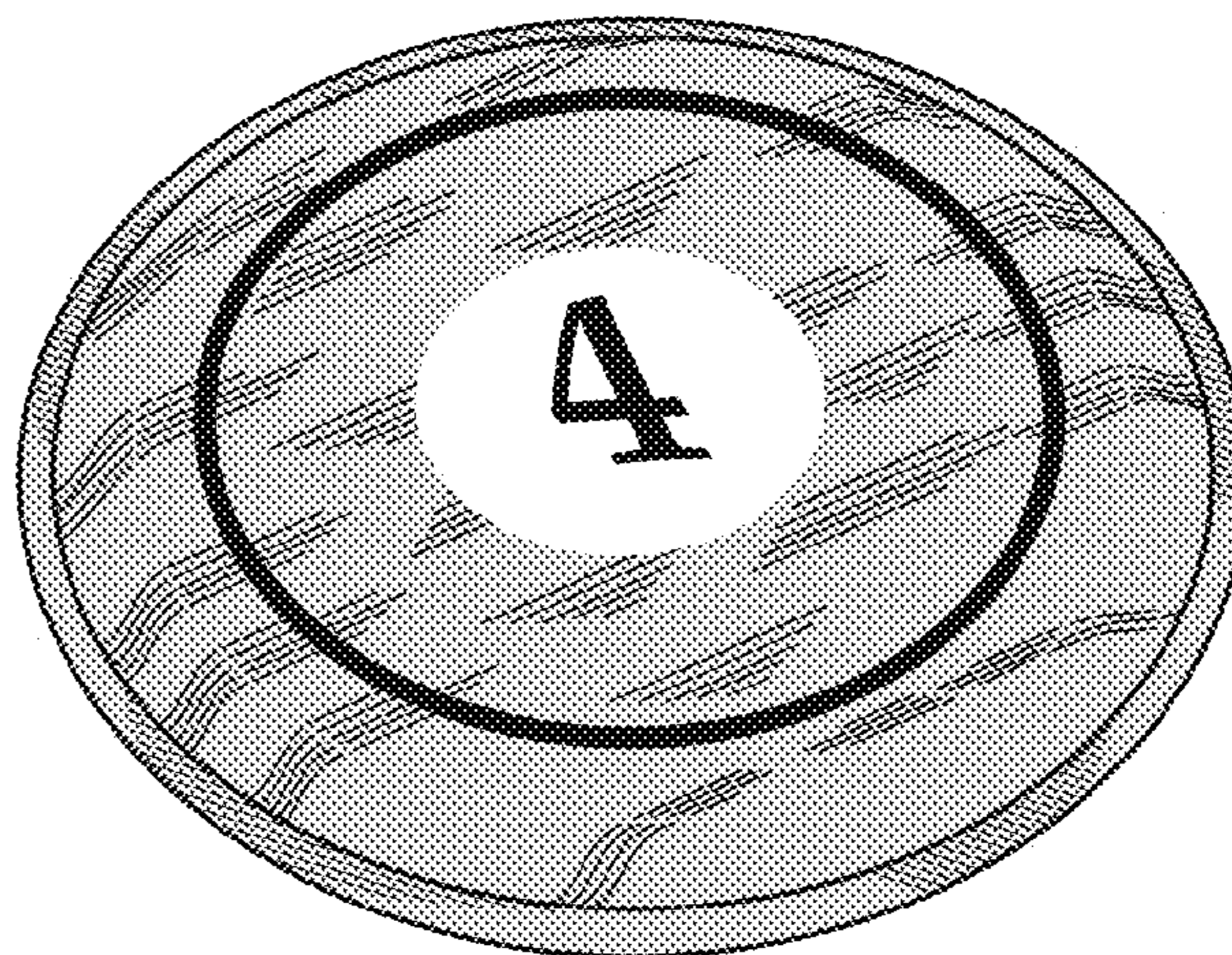

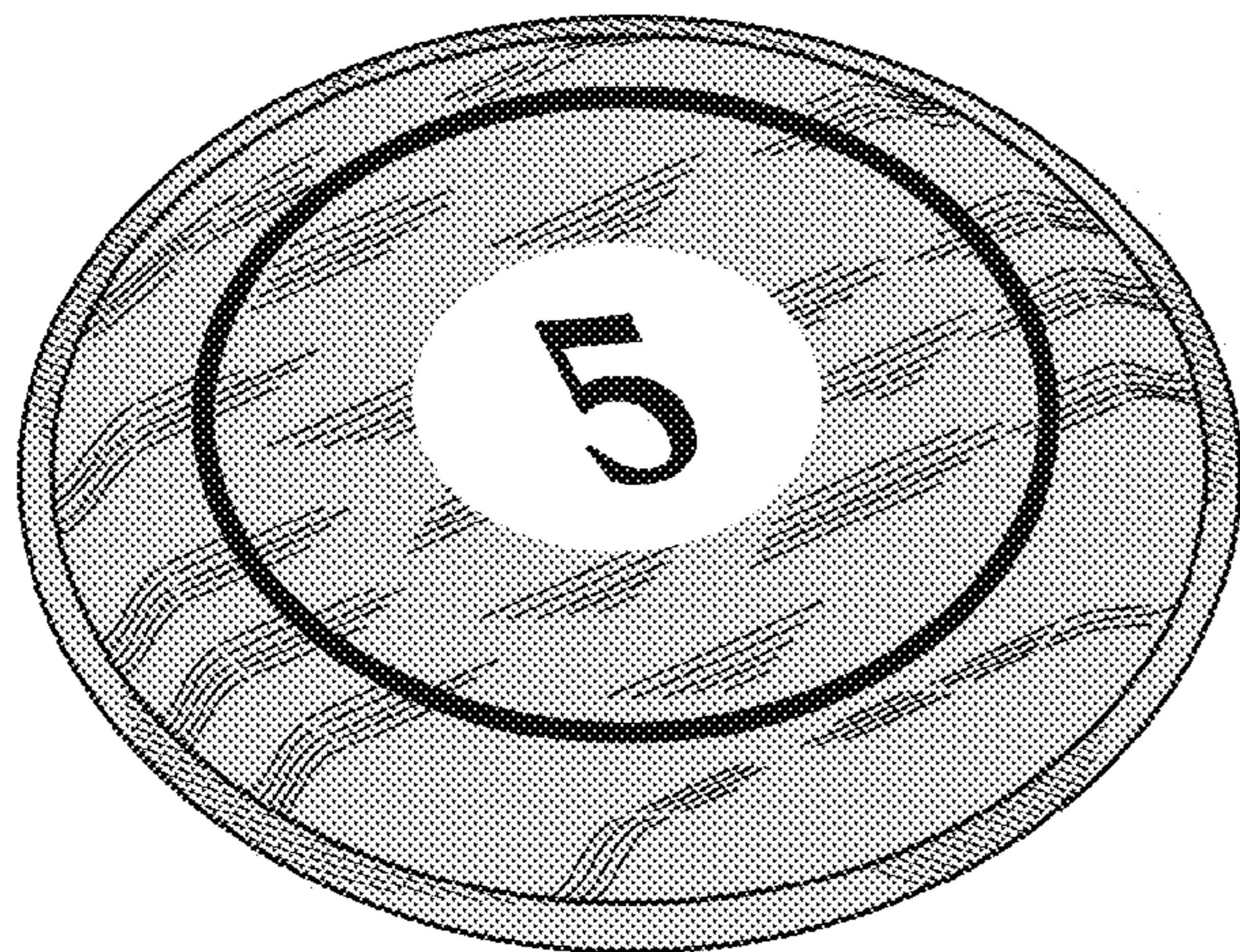

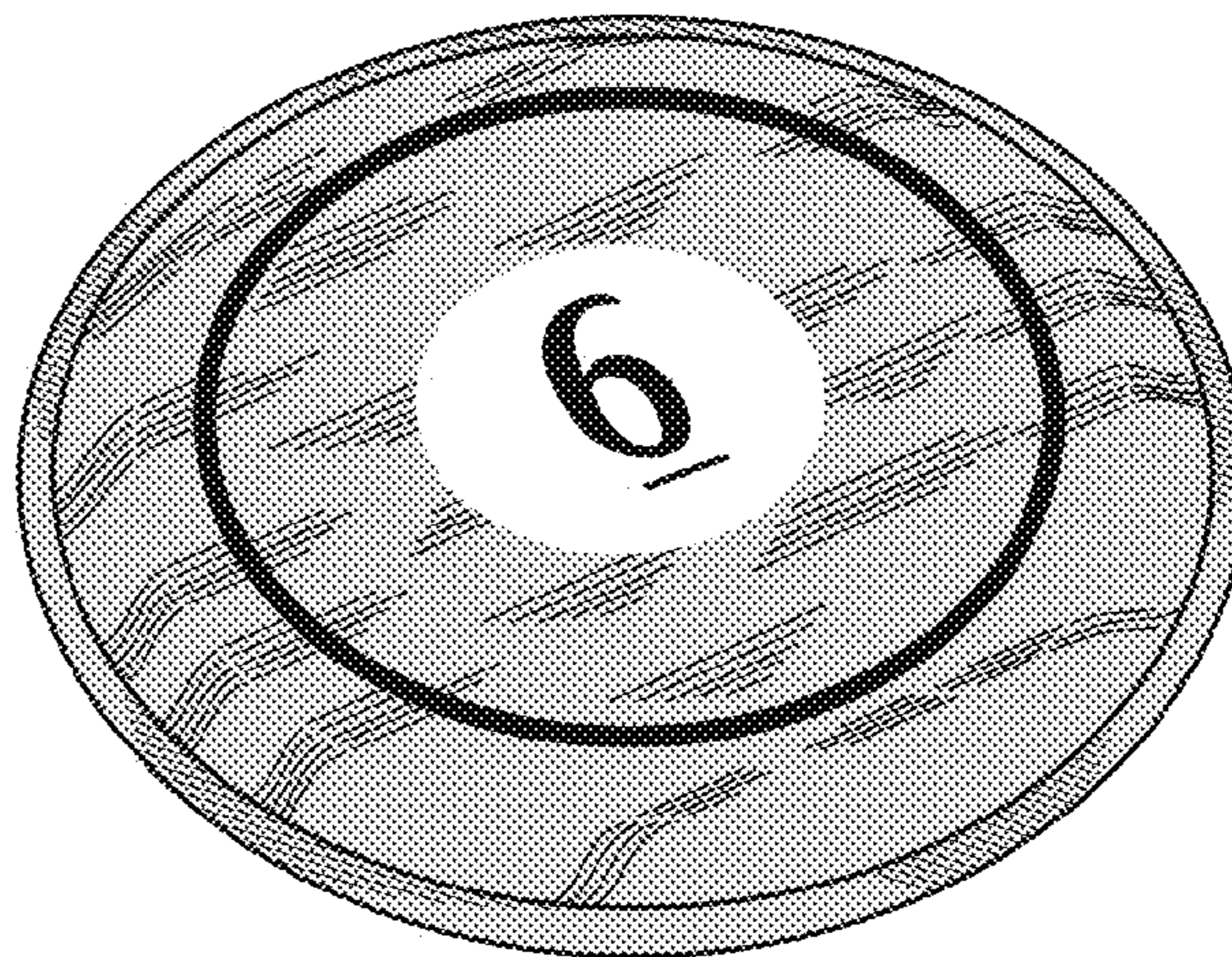

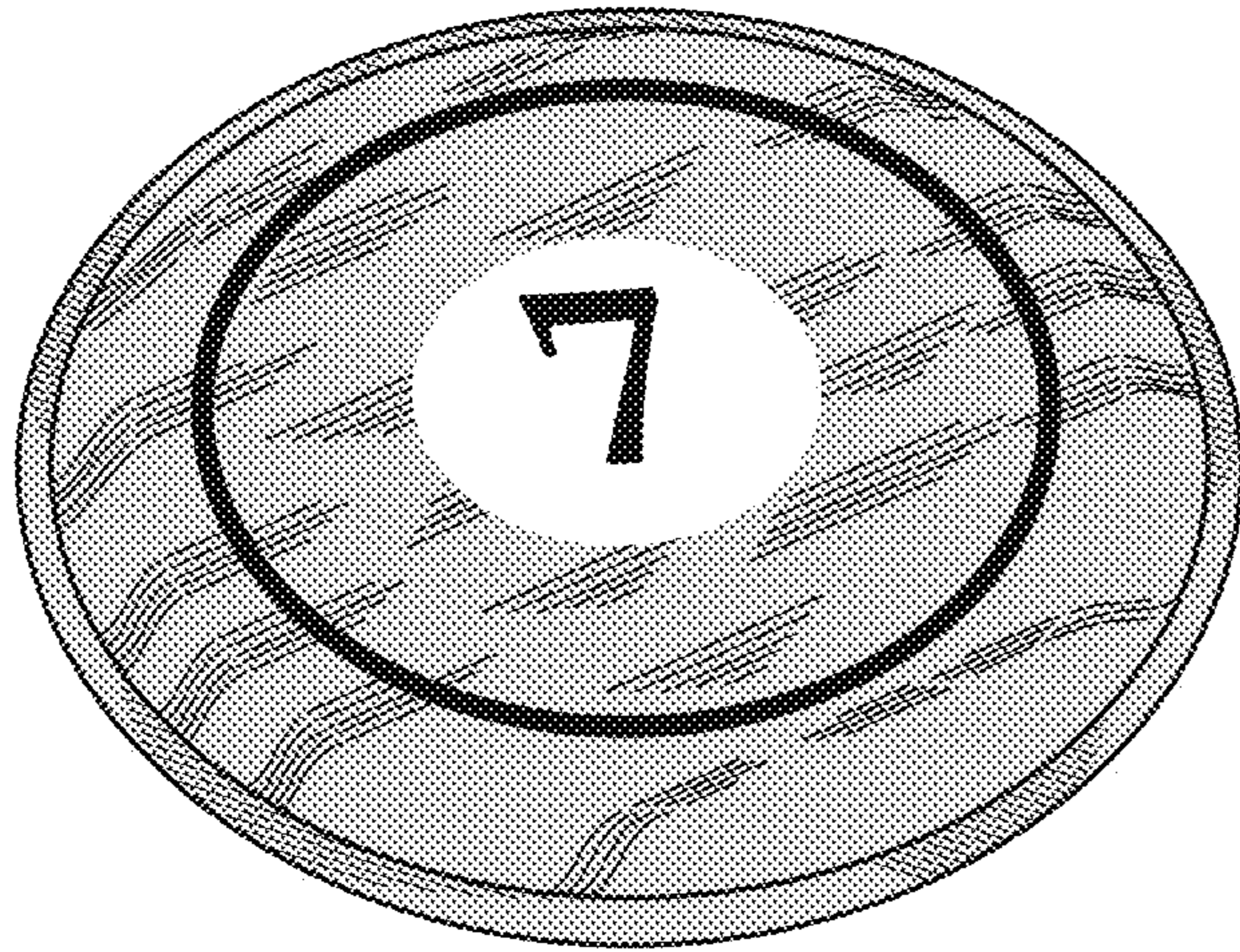

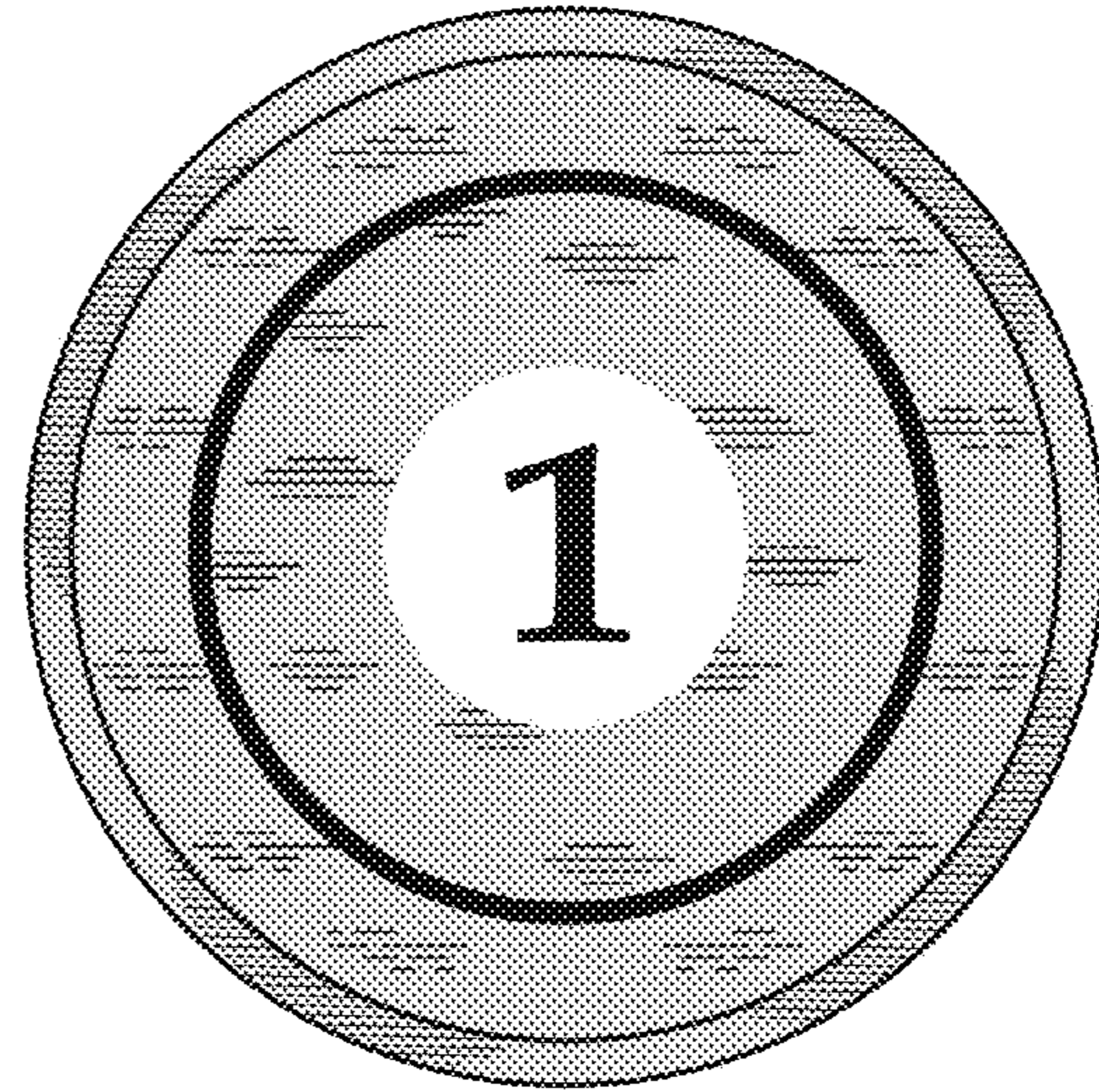

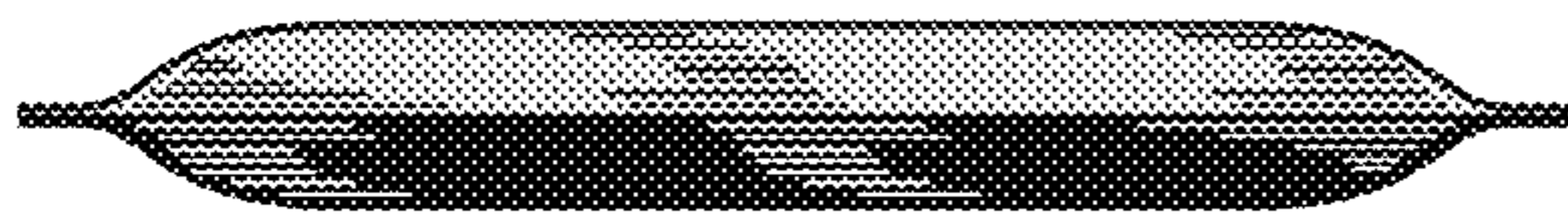

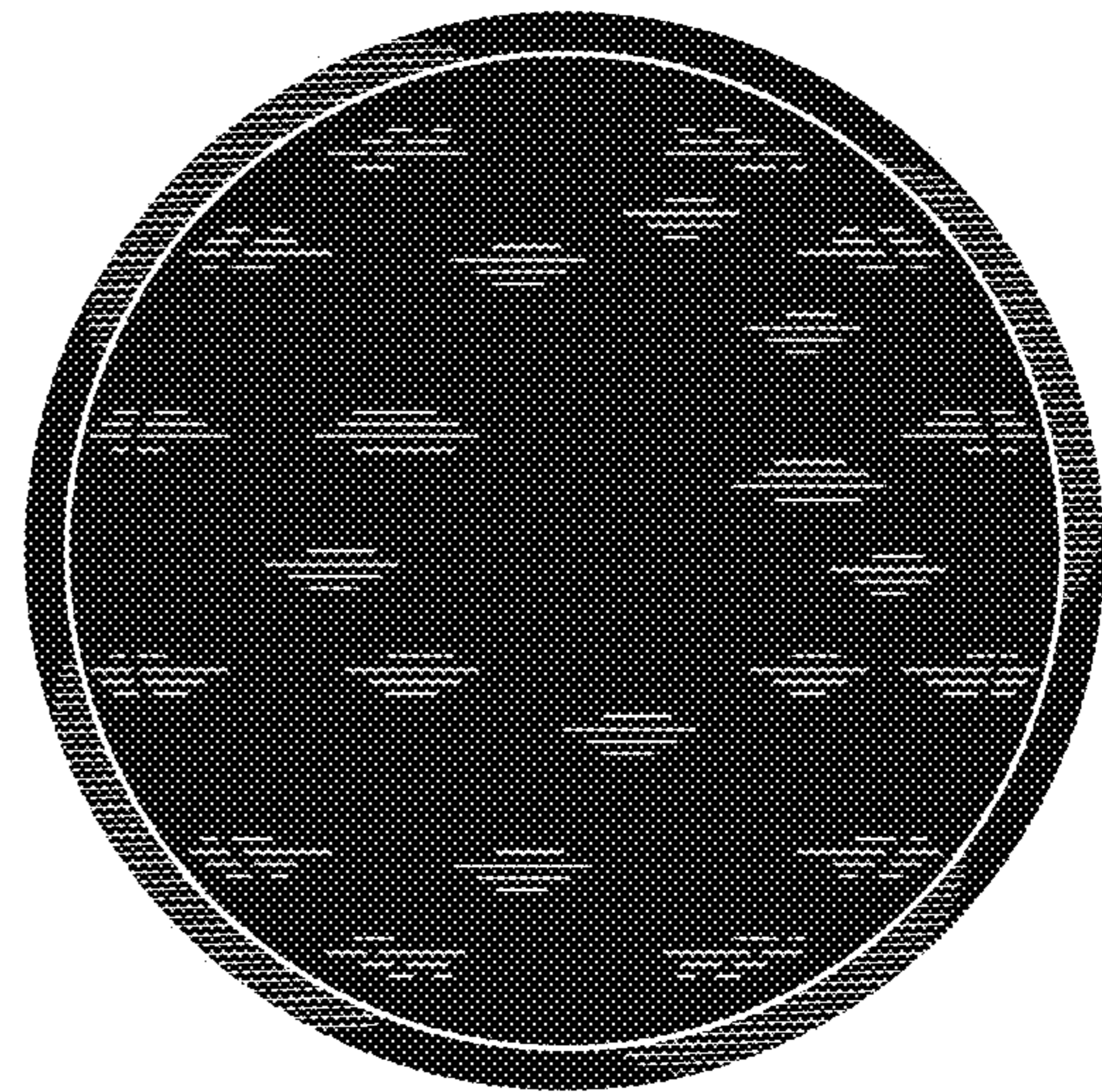

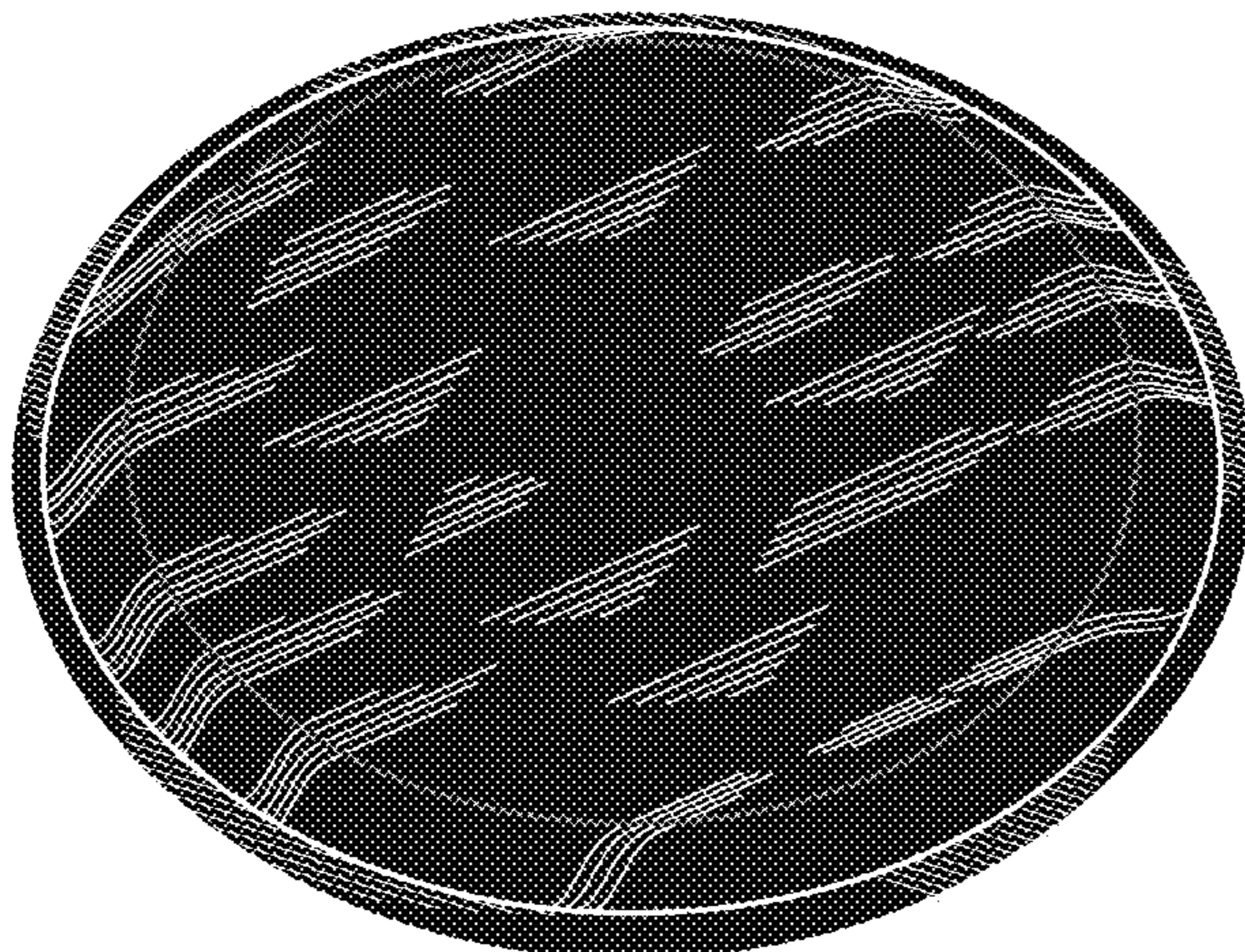

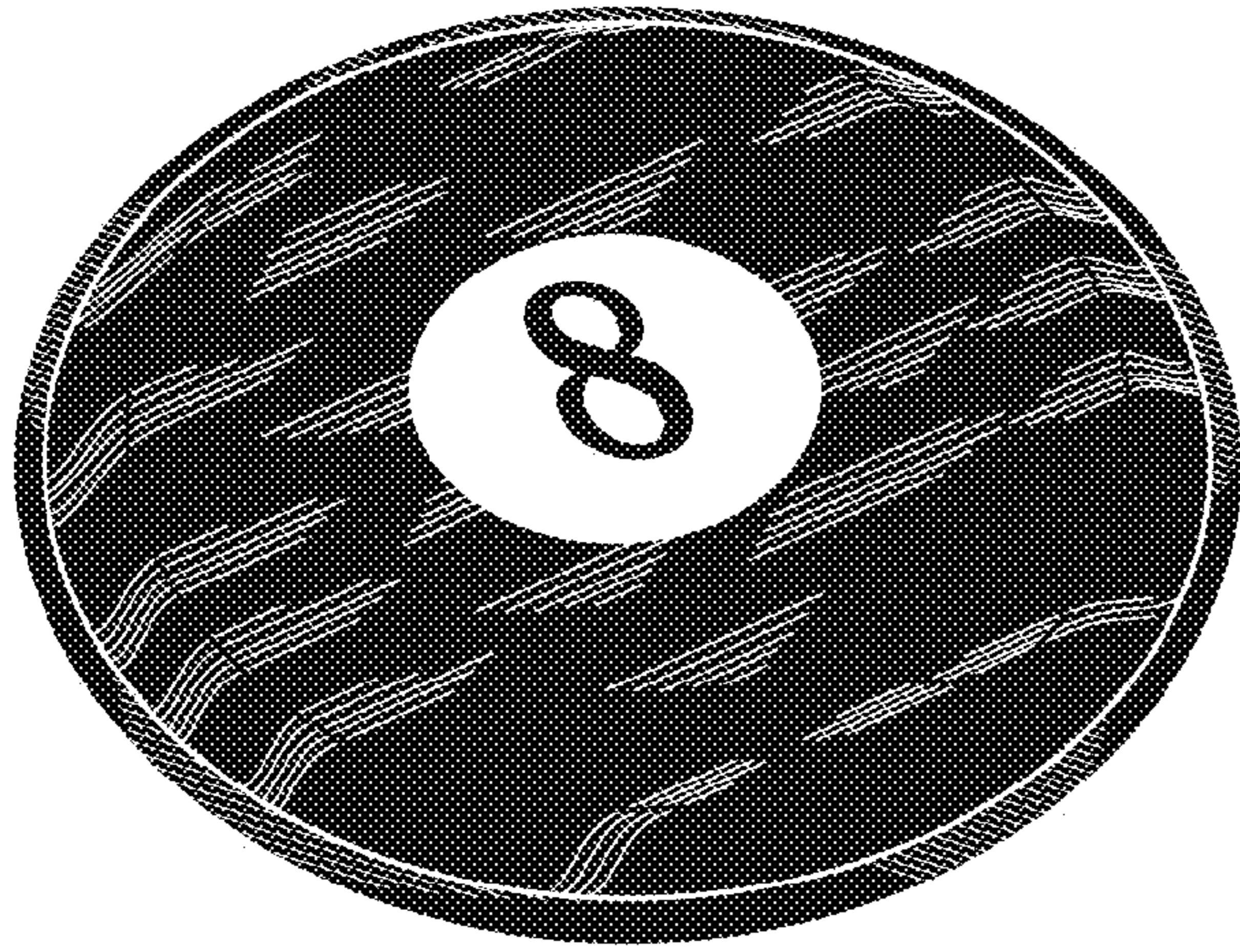

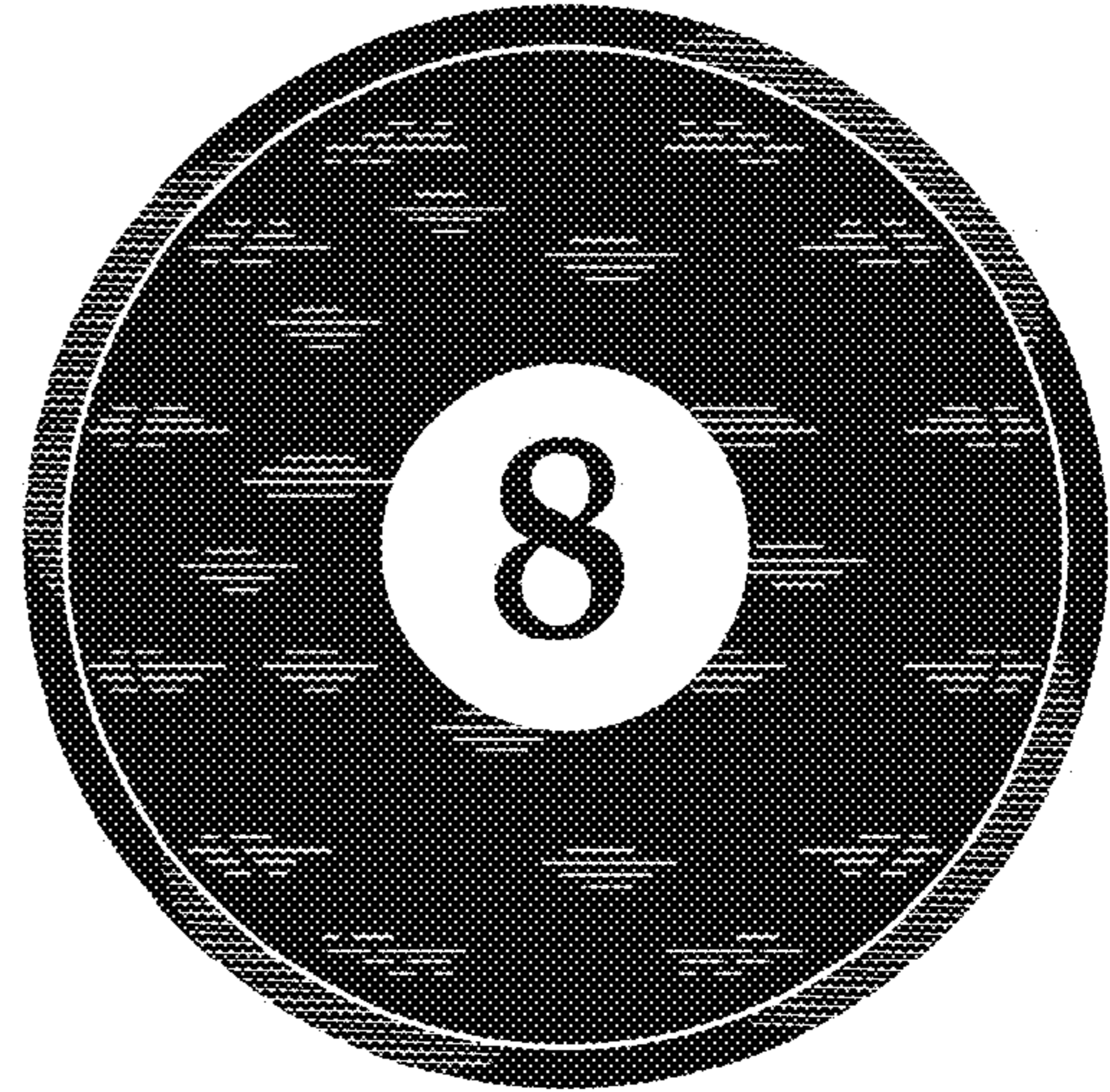

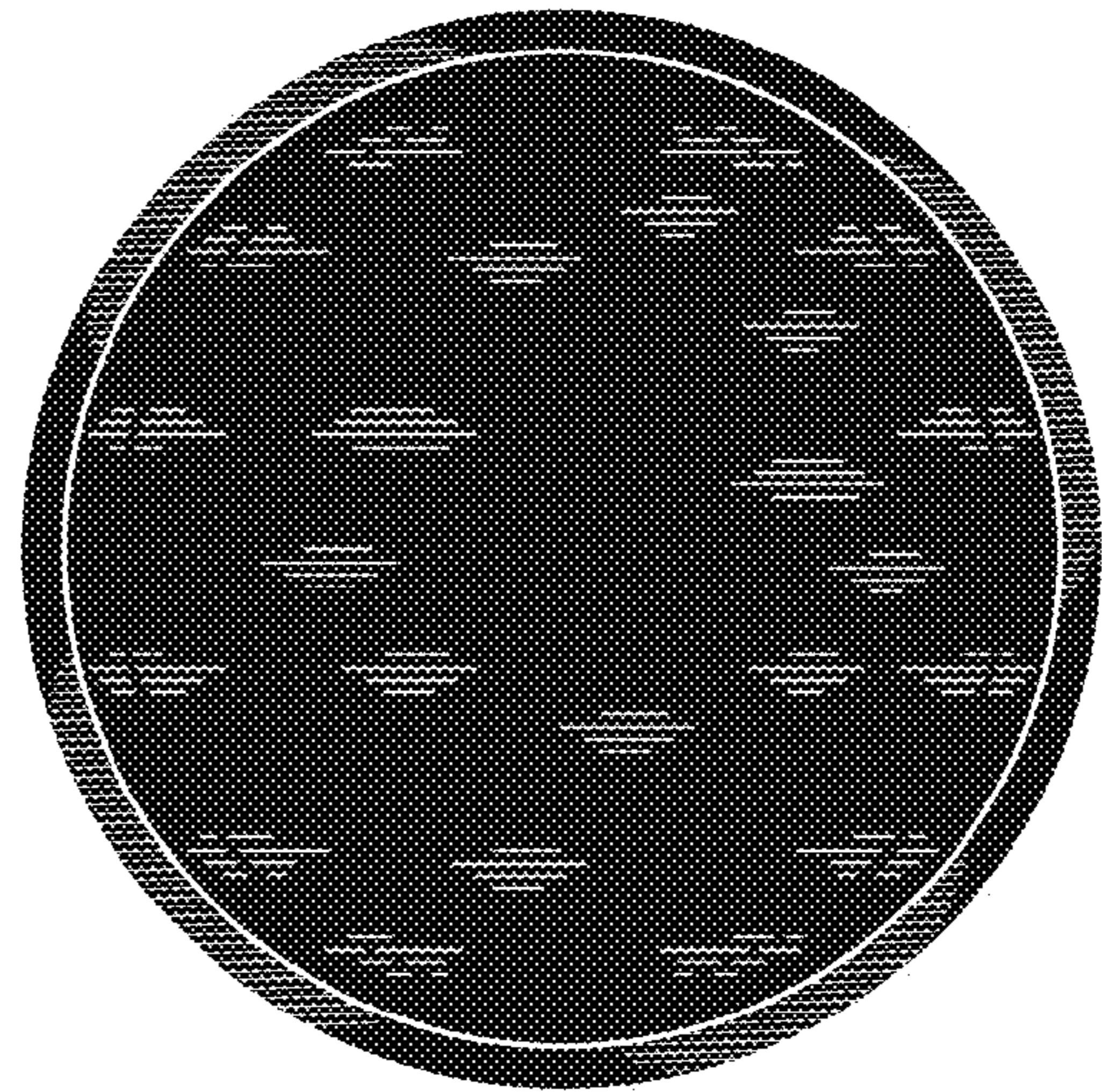

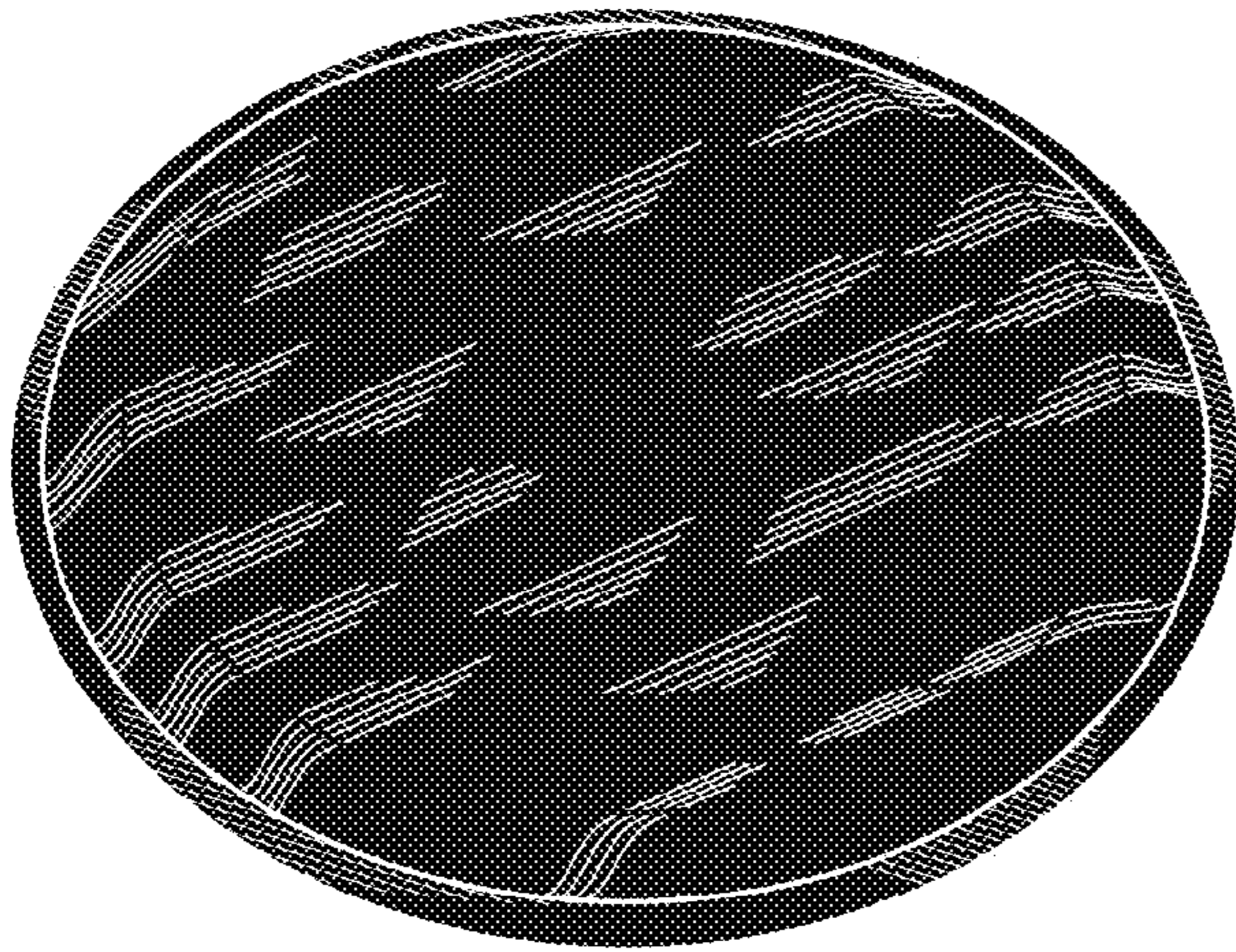

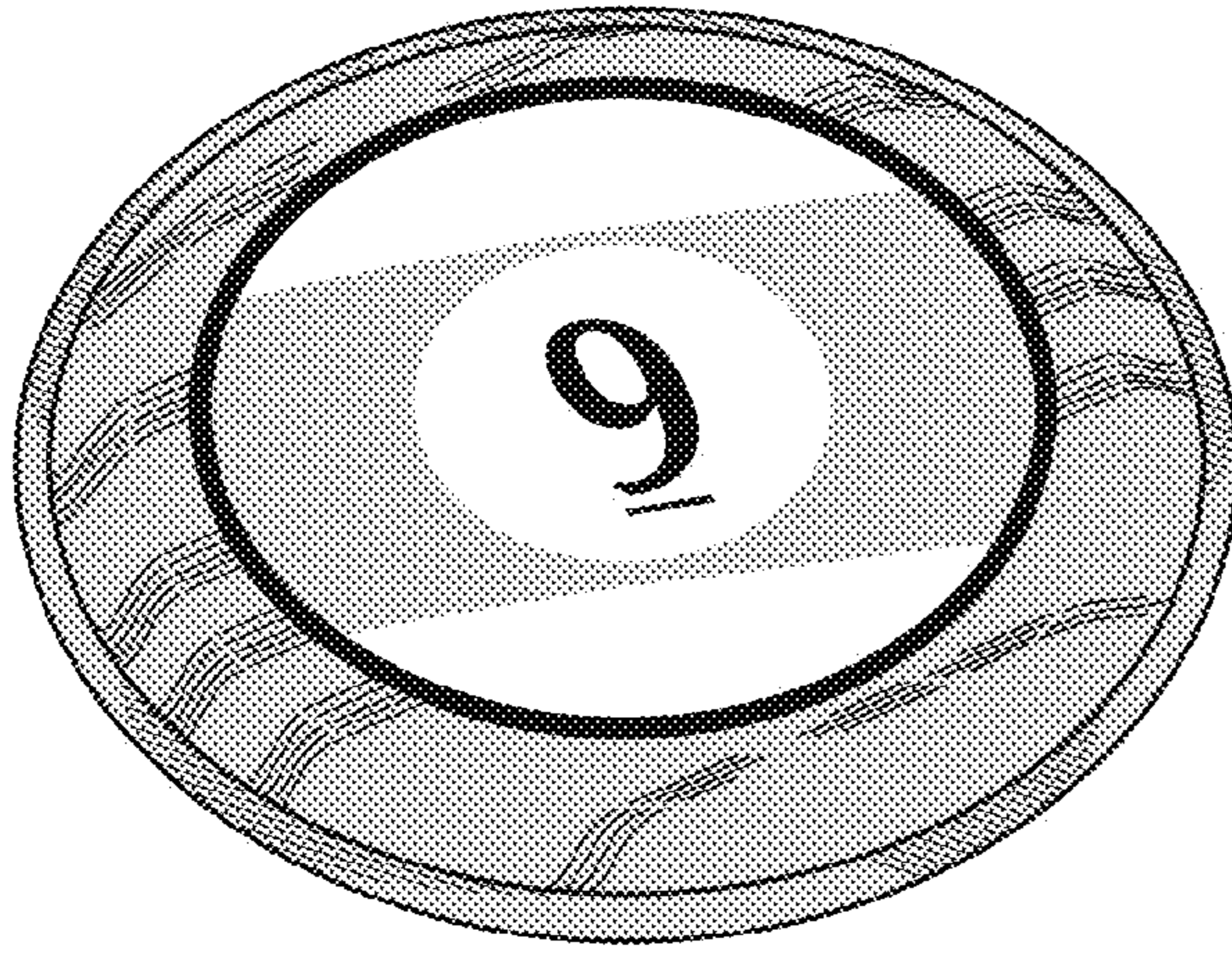

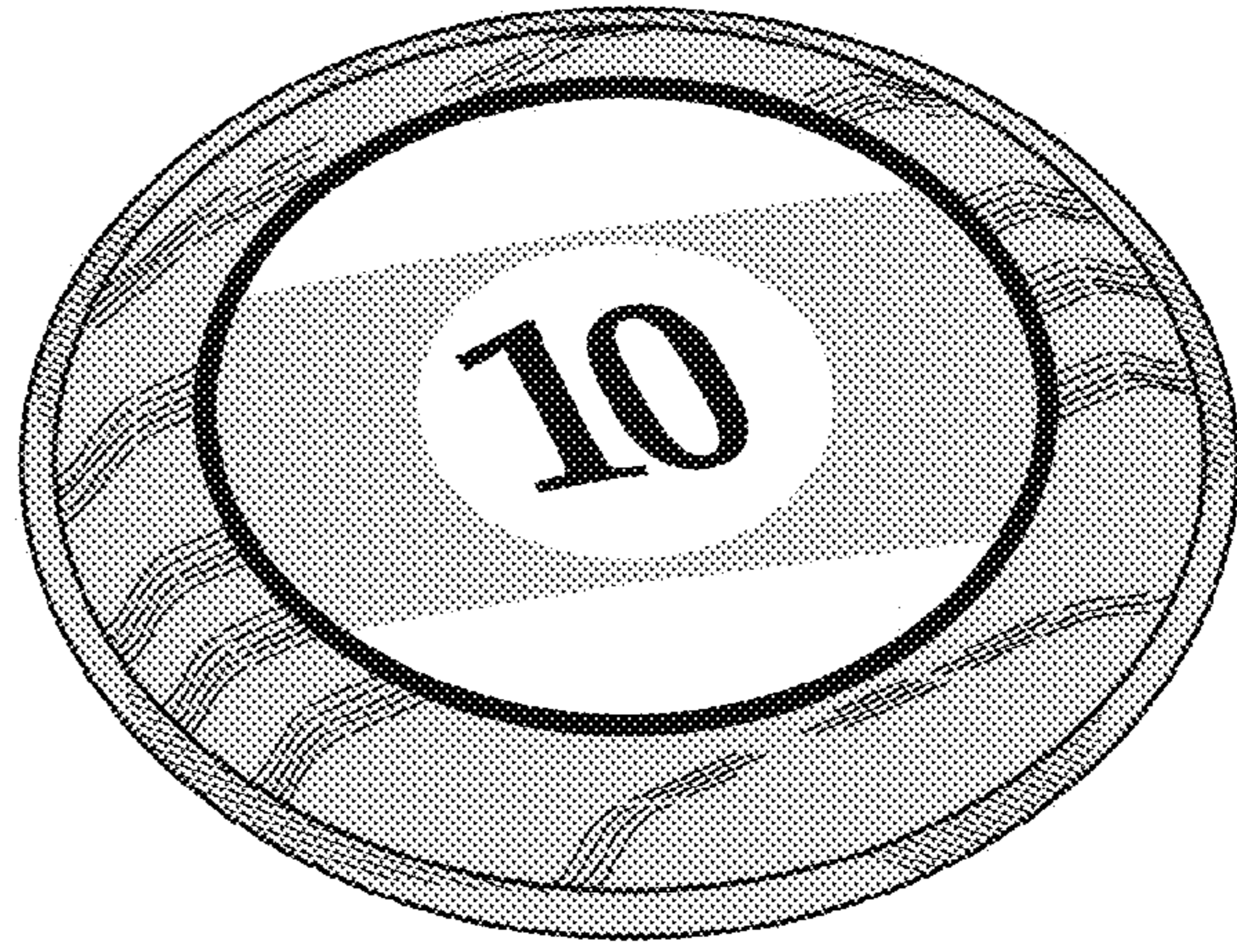

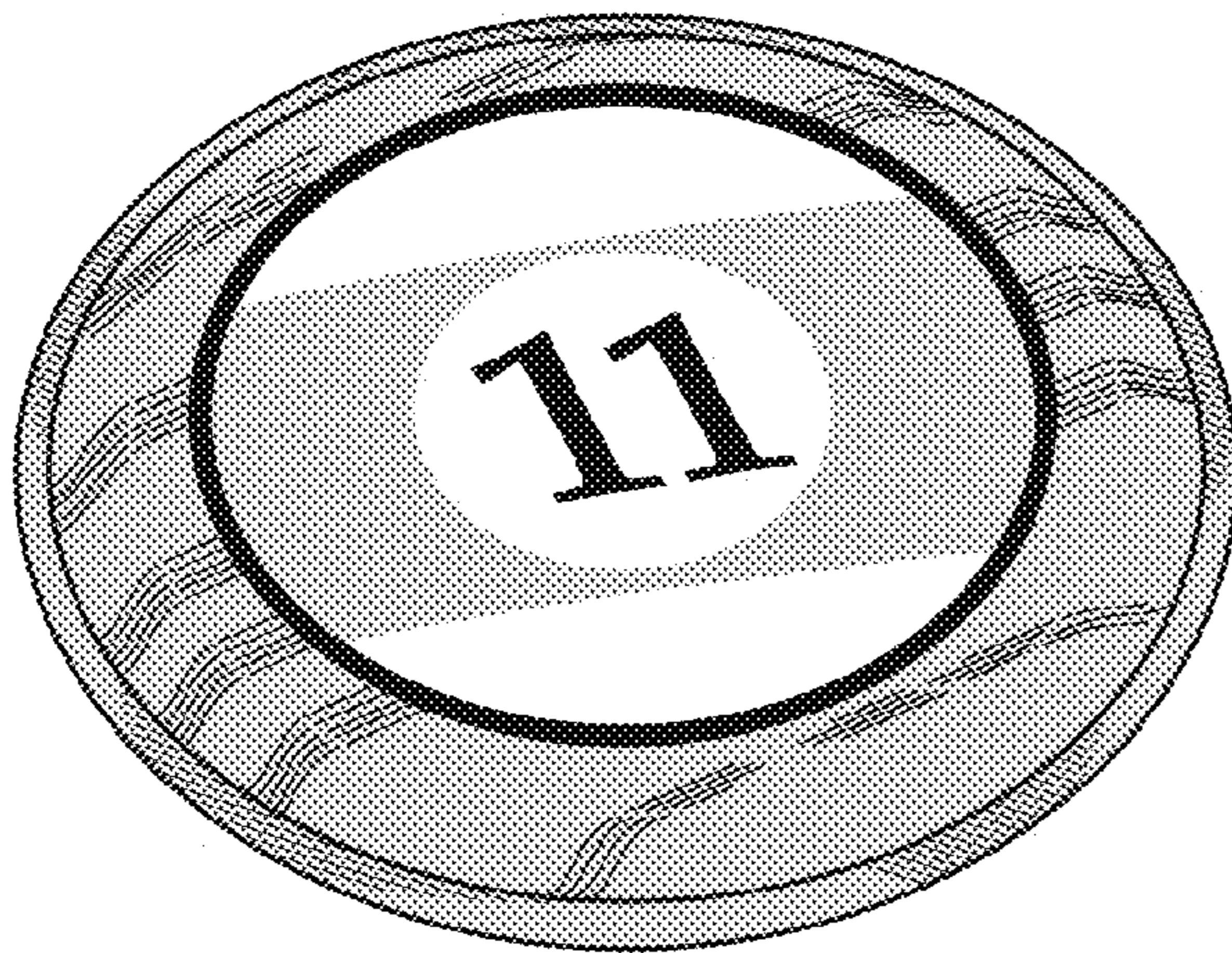

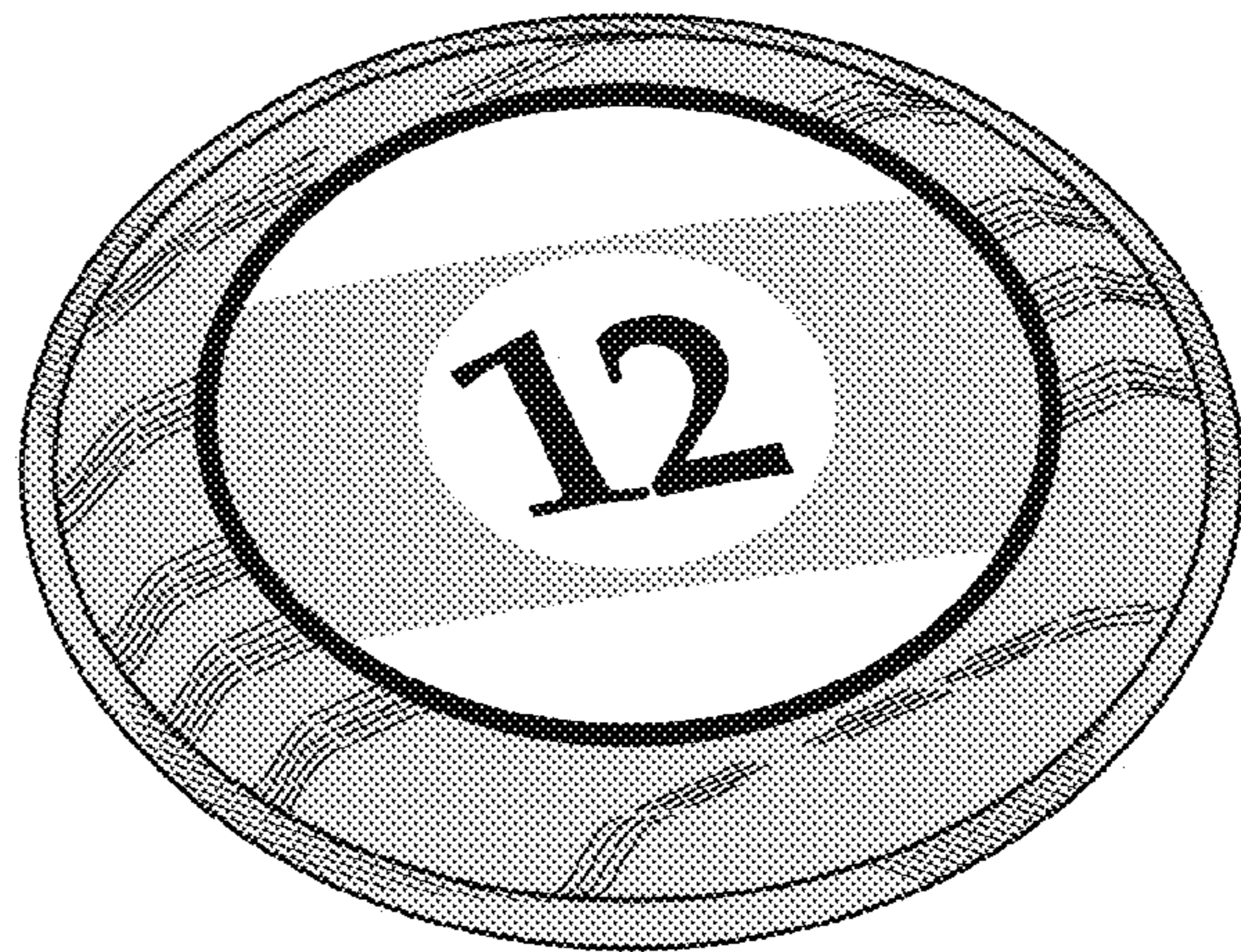

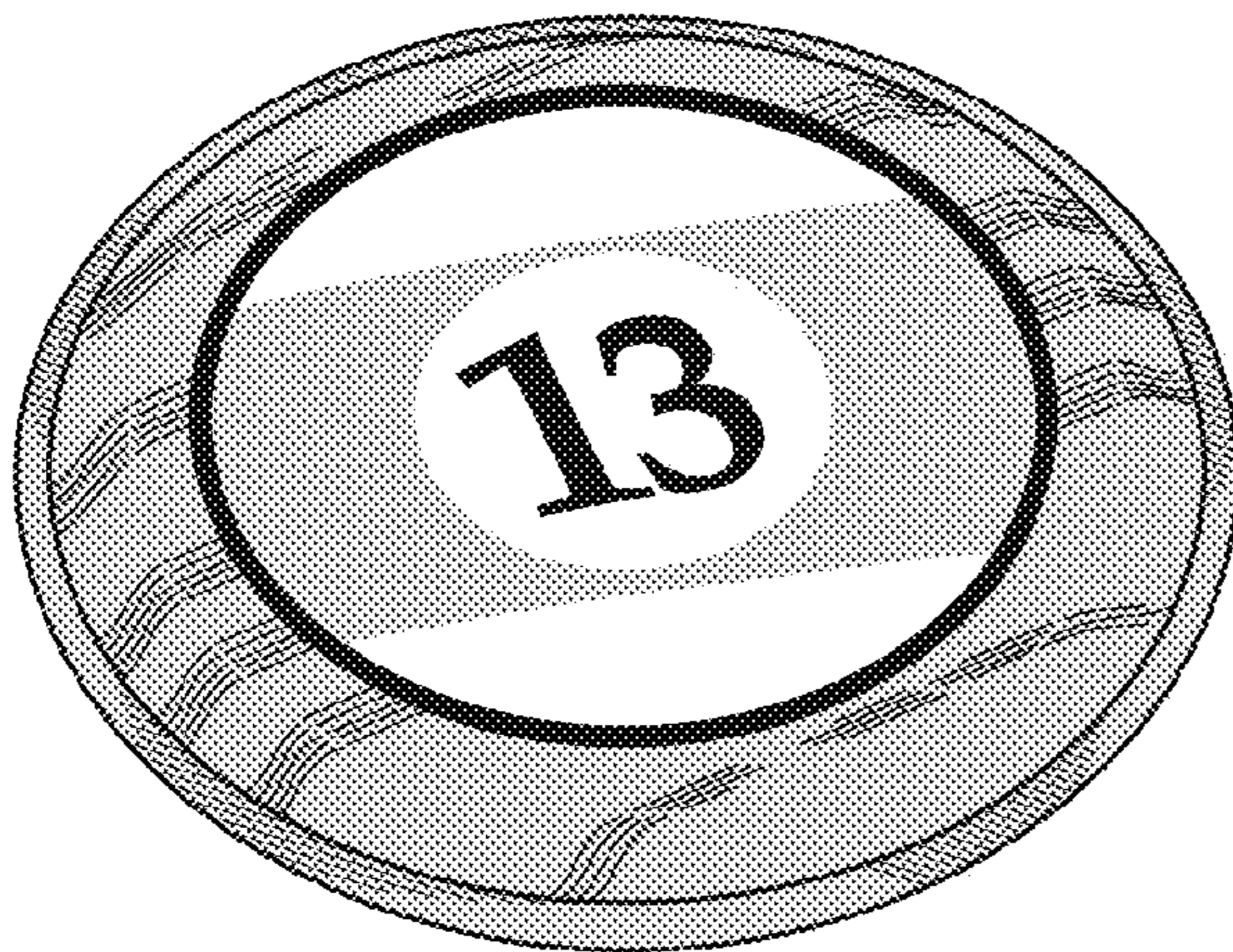

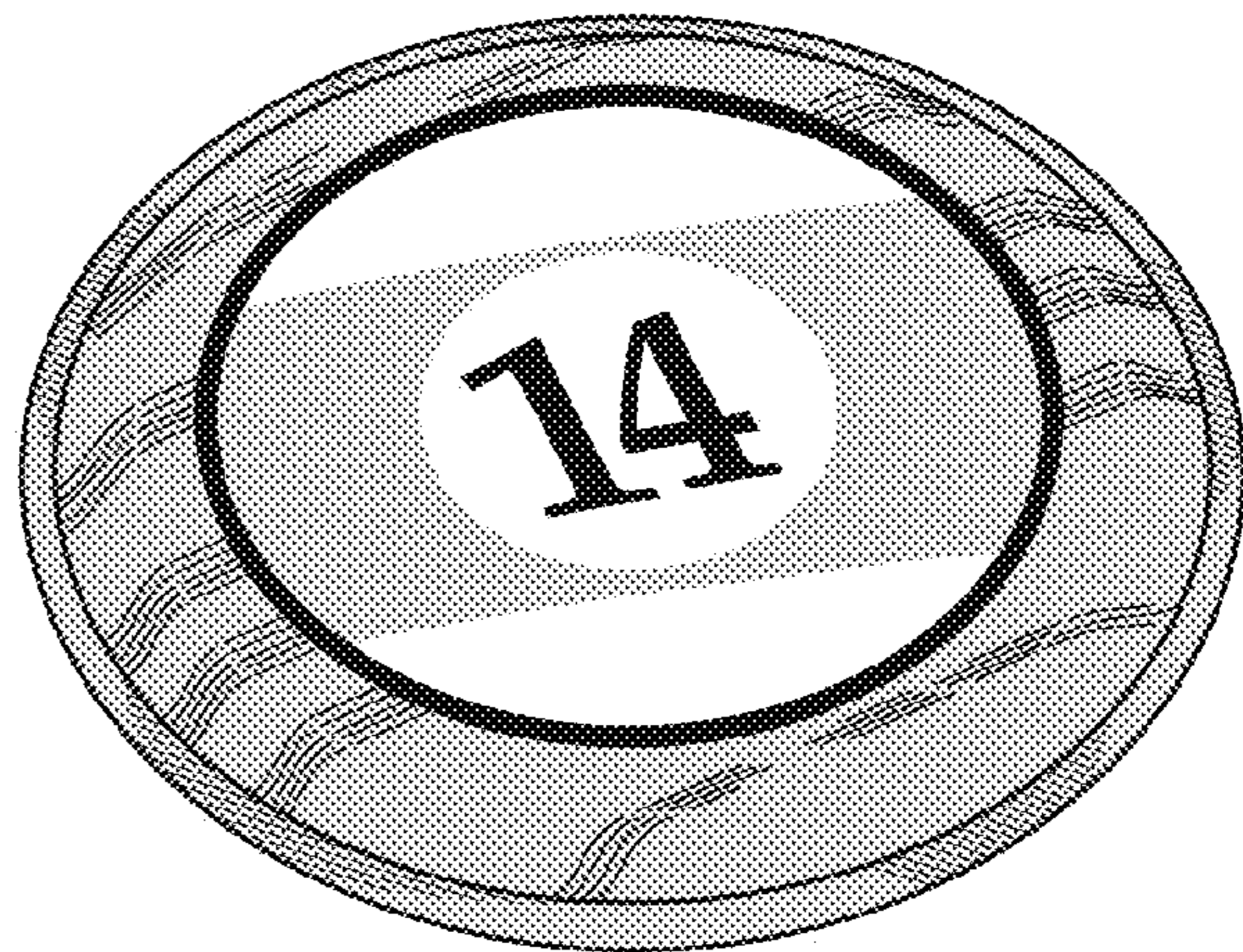

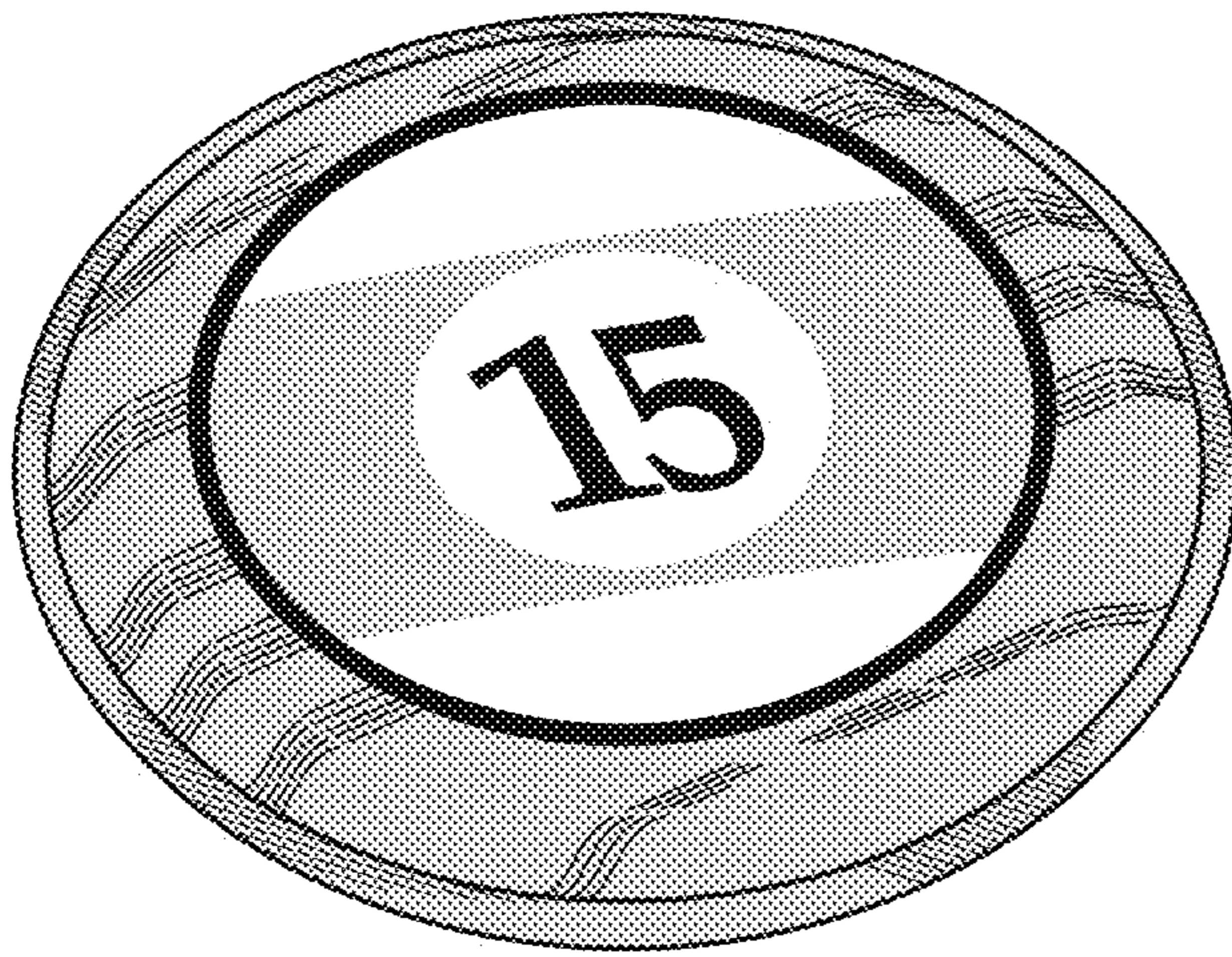

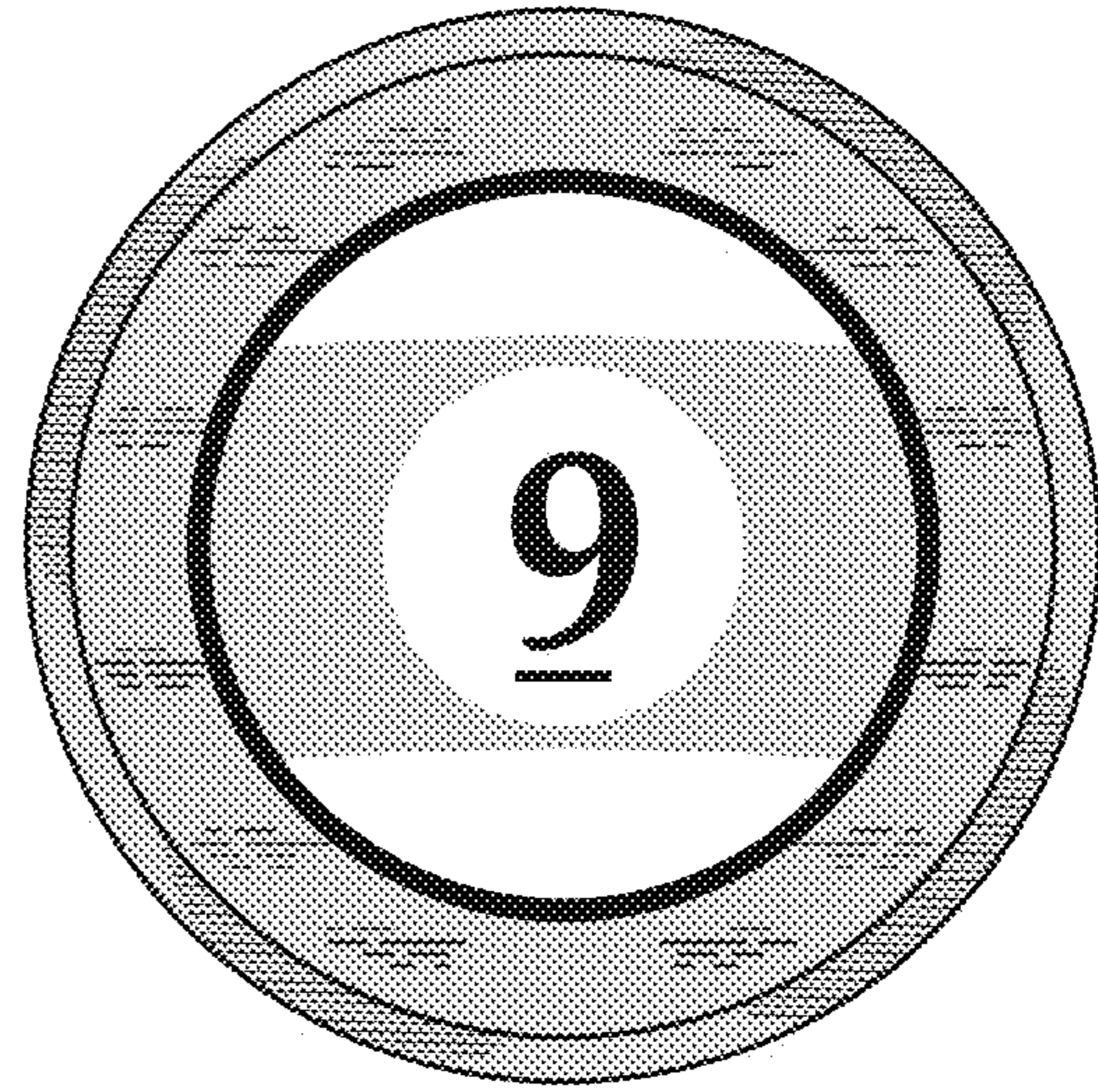

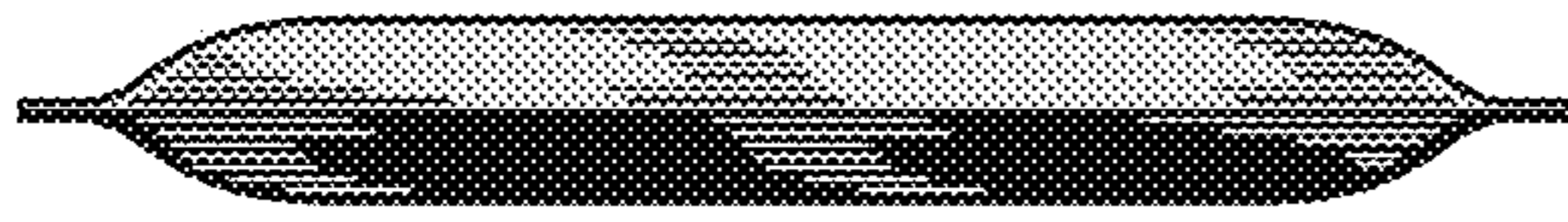

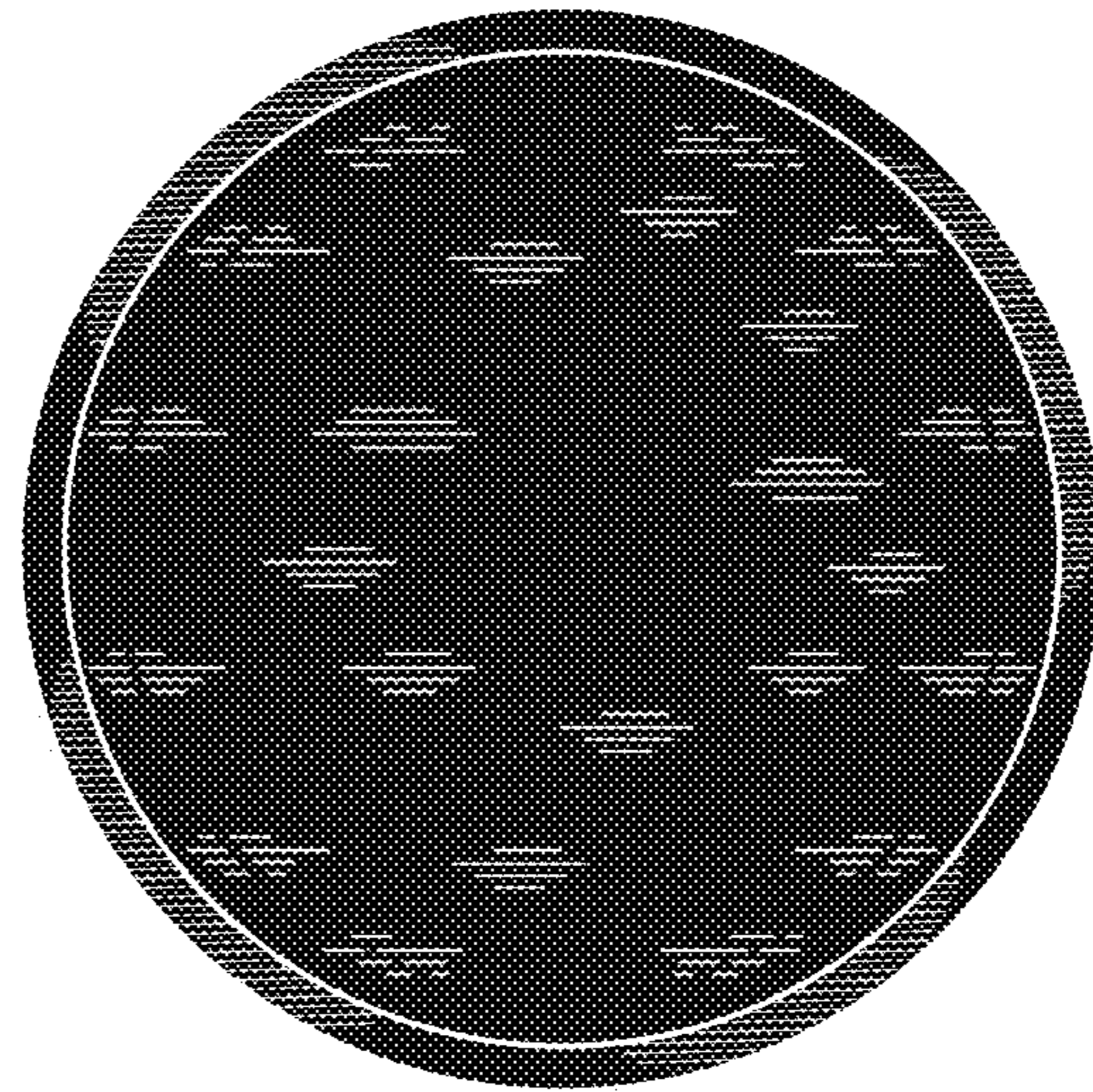

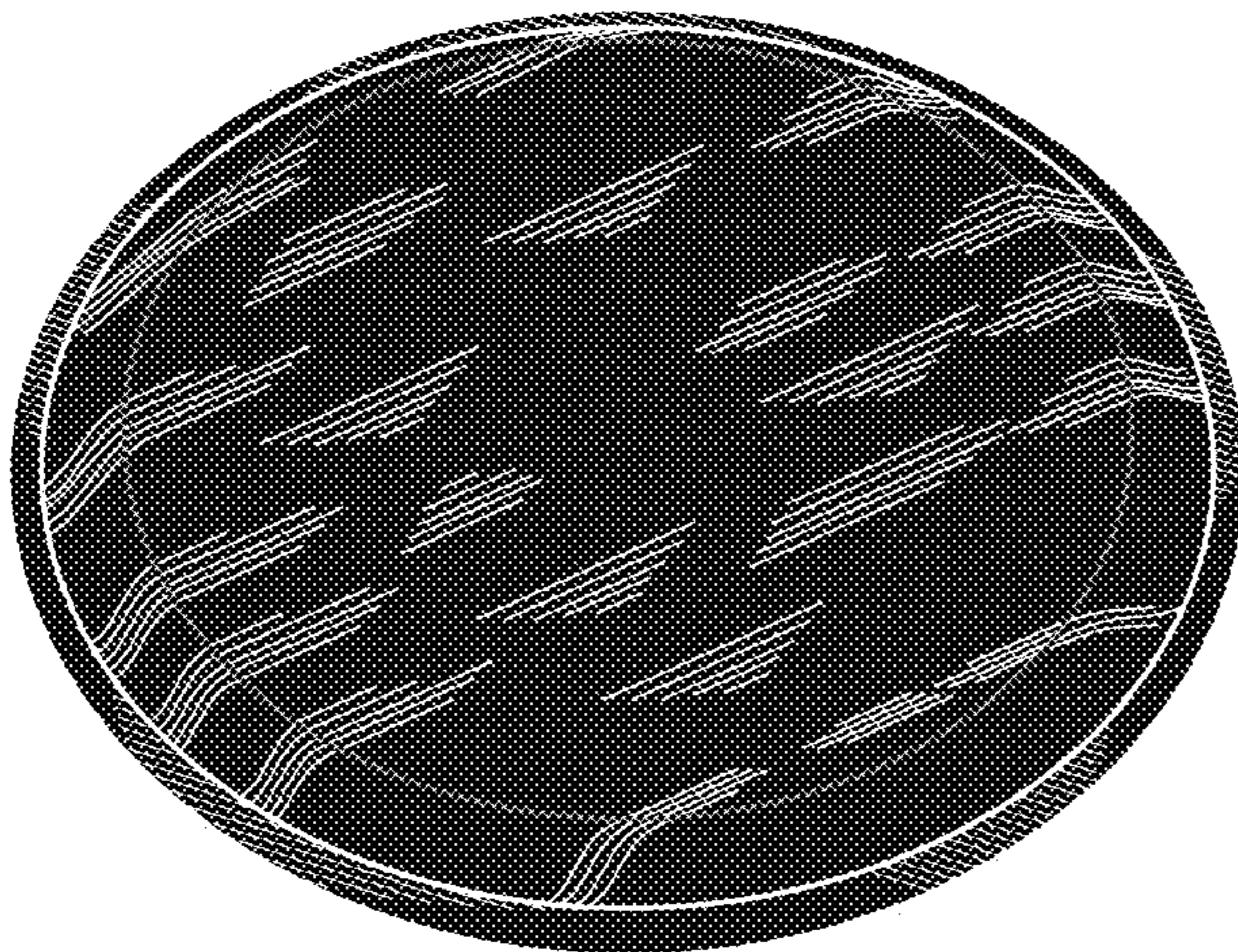
