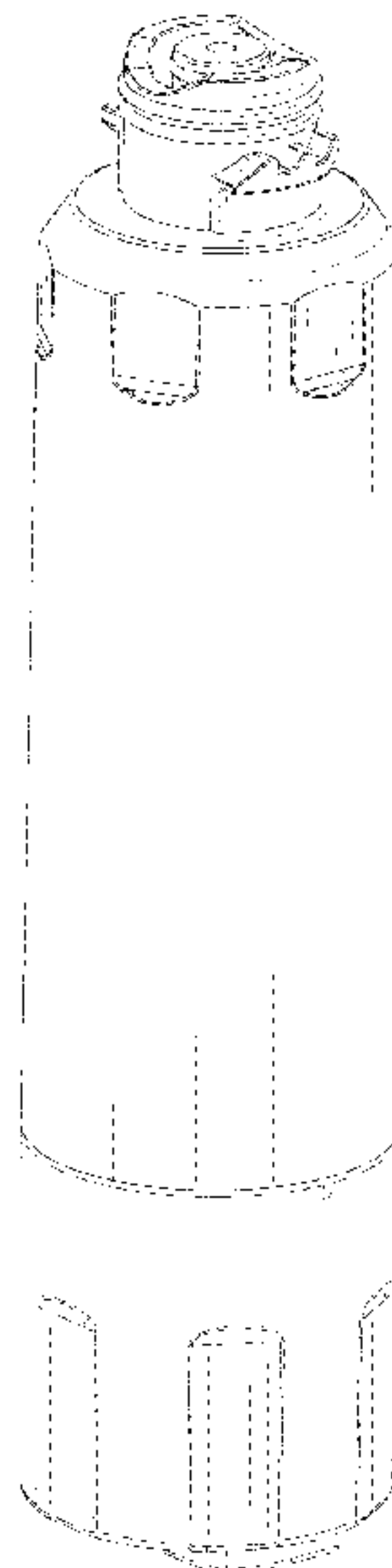
(57) **CLAIM**

The ornamental design for a filter element, as shown and described.

DESCRIPTION

FIG. 1 is a front top perspective view of a filter element showing my new design;
FIG. 2 is a left bottom perspective view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a left side view thereof;
FIG. 6 is a right side view thereof;
FIG. 7 is a top plan view thereof;
FIG. 8 is a bottom plan view thereof; and,
FIG. 9 is an enlarged view of portion 9 shown in FIG. 7.
The broken lines shown in the drawings depict portions of the filter element that form no part of the claimed design. The broken lines surrounding the detail areas and partial views form no part of the claimed design.
The oblique shading lines in the drawings are included to denote the reflective quality of surface planes on the filter element.

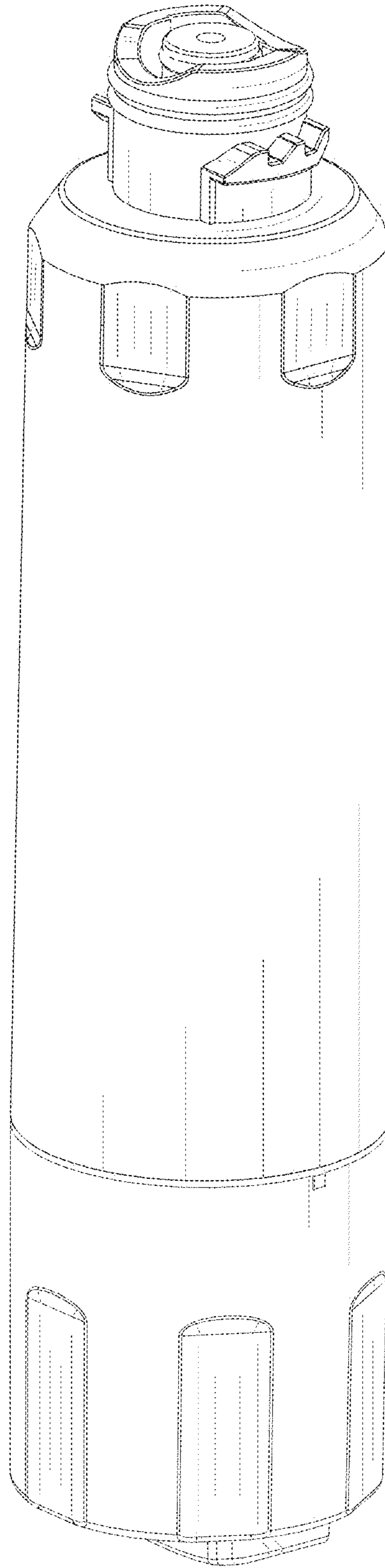

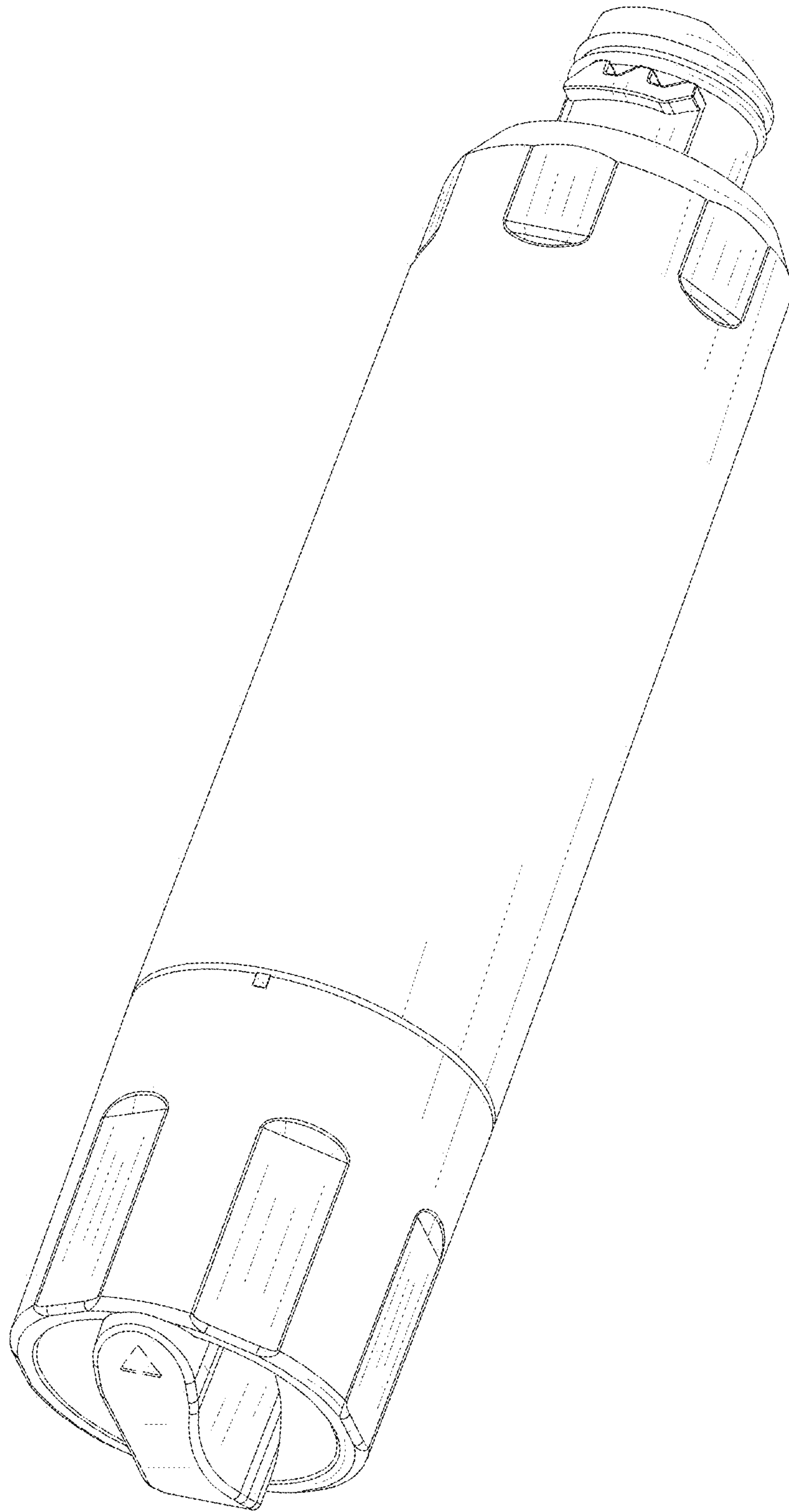

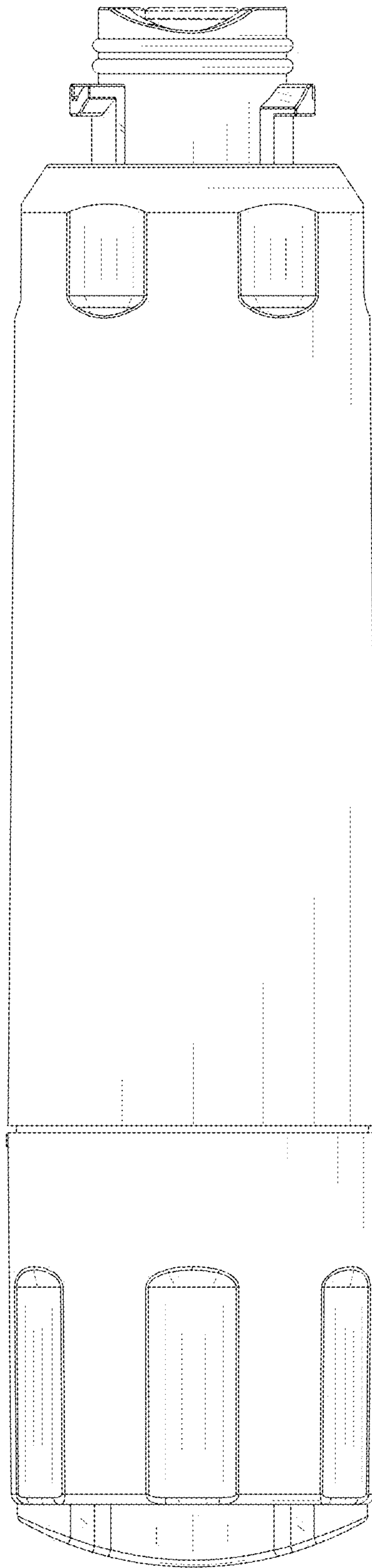

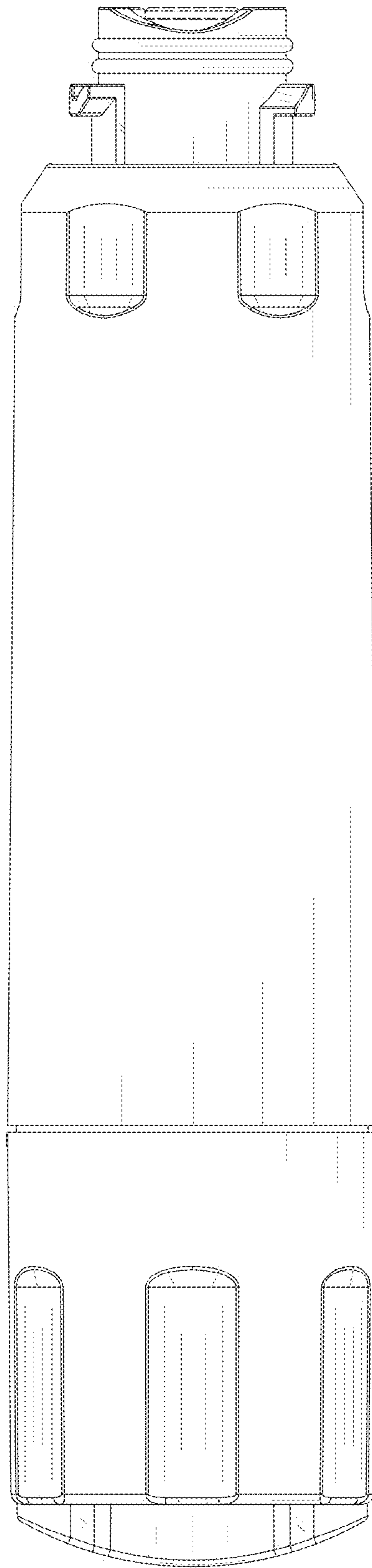

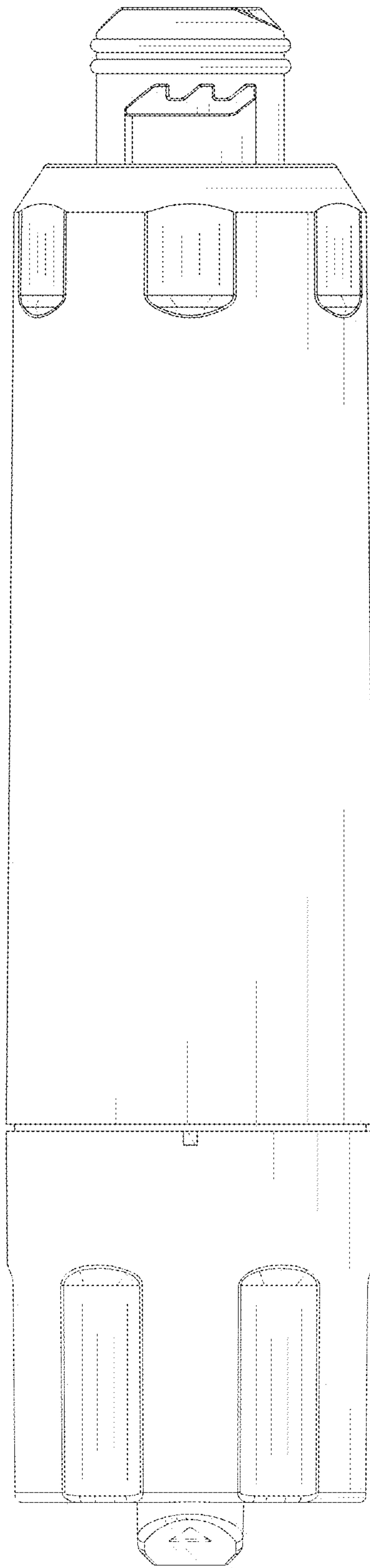

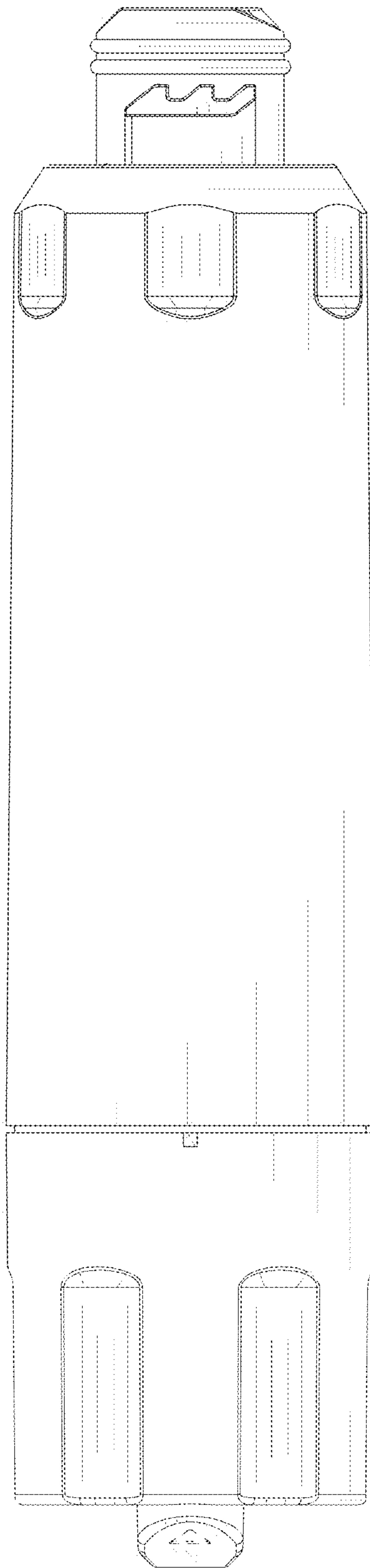

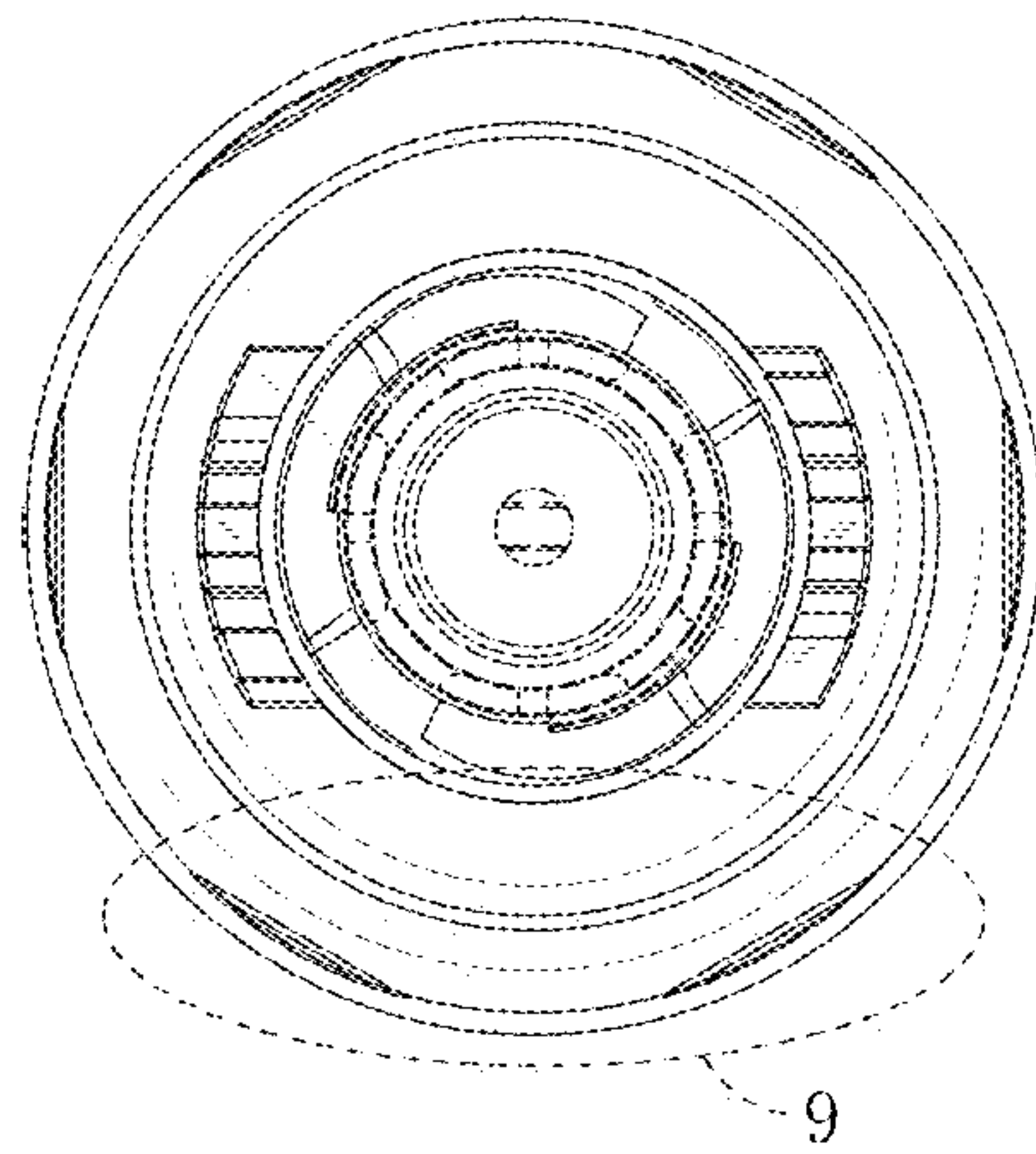

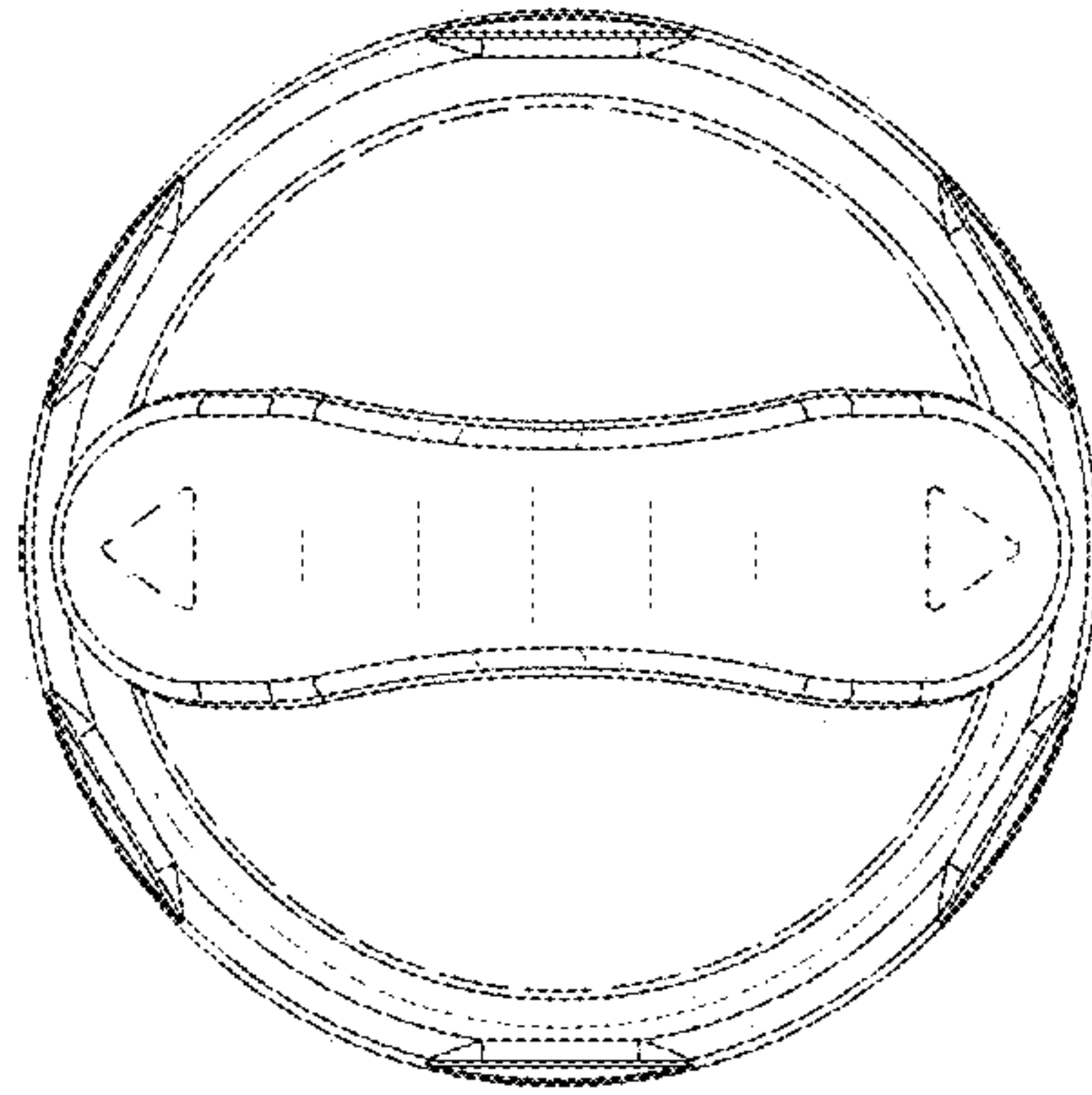

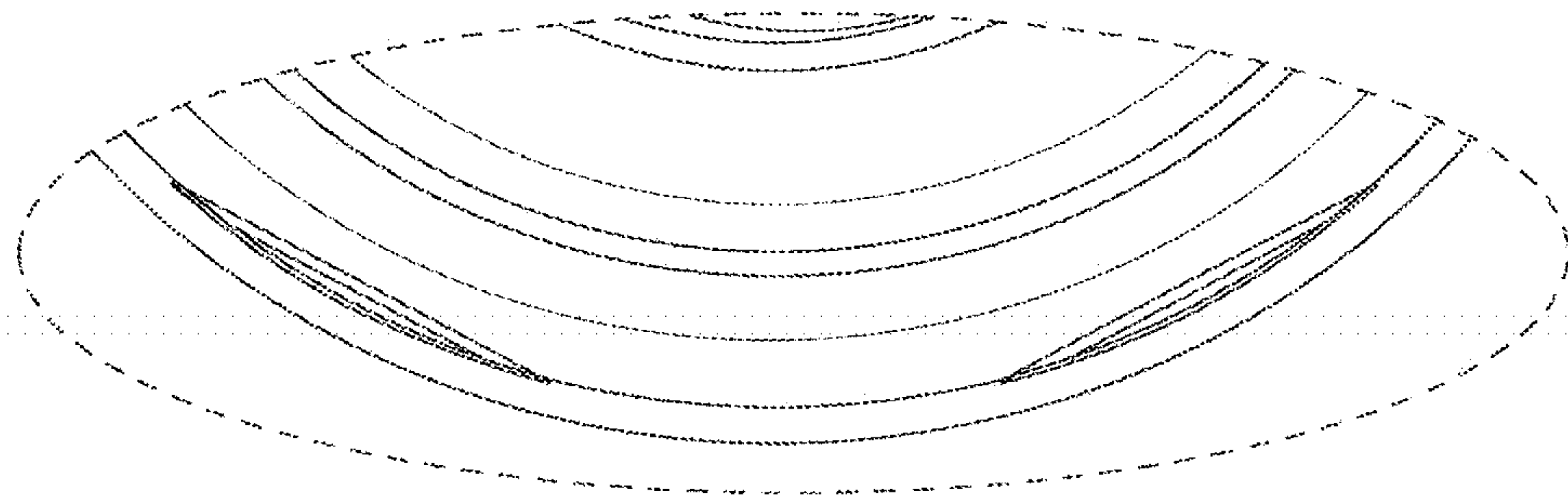
