(57) **CLAIM**

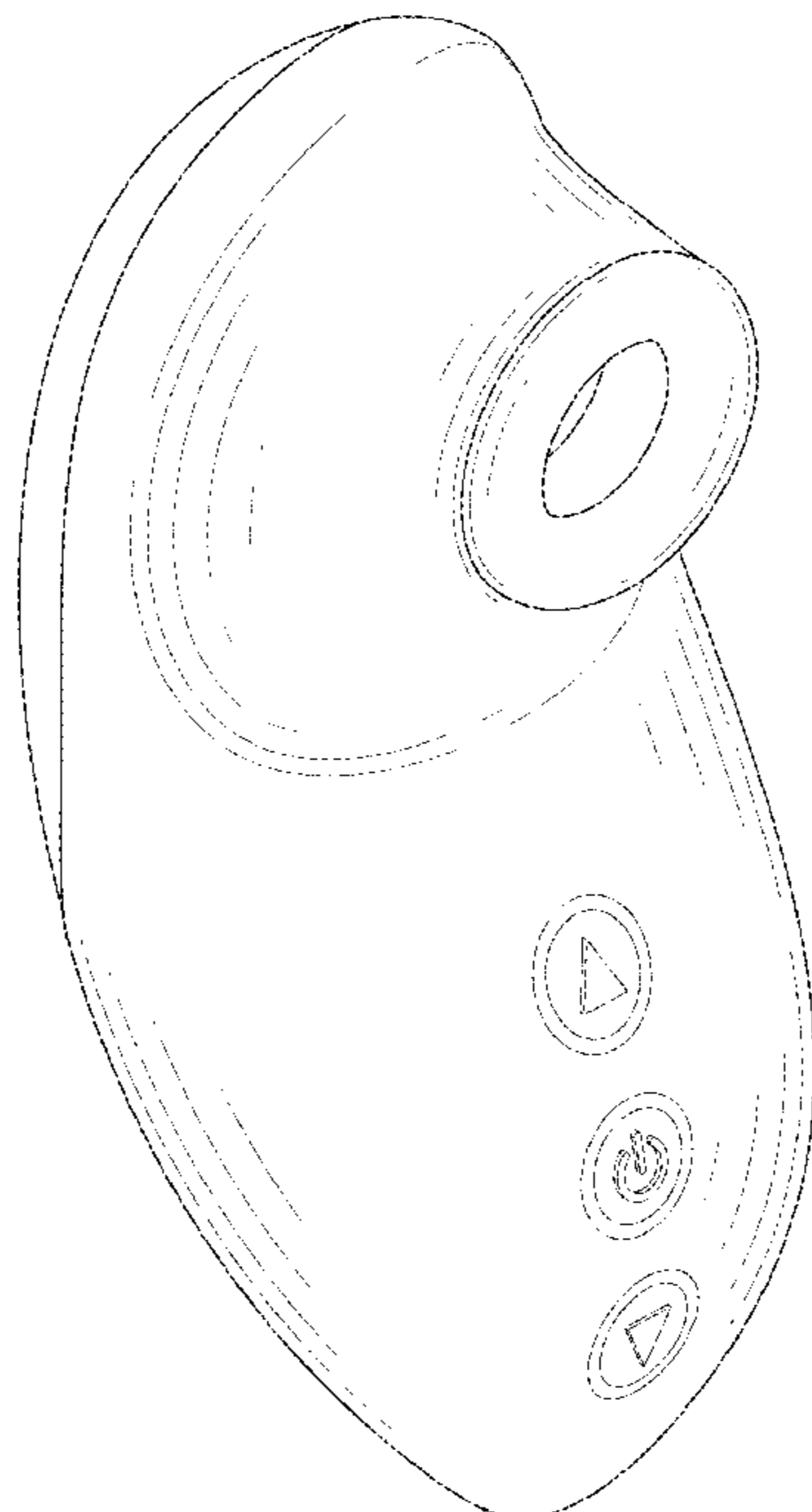
The ornamental design for a sex toy vibrator, as shown and described.

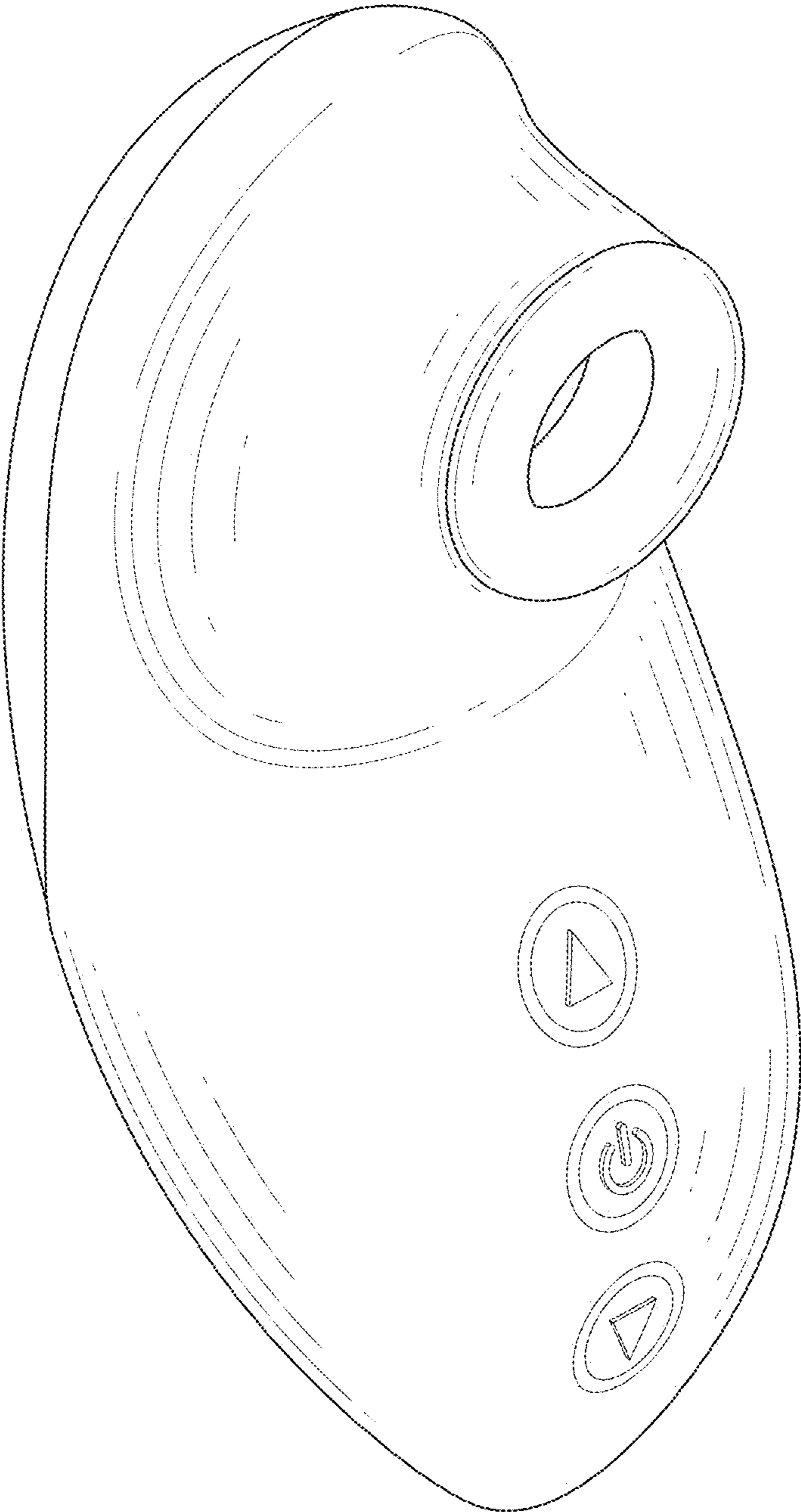

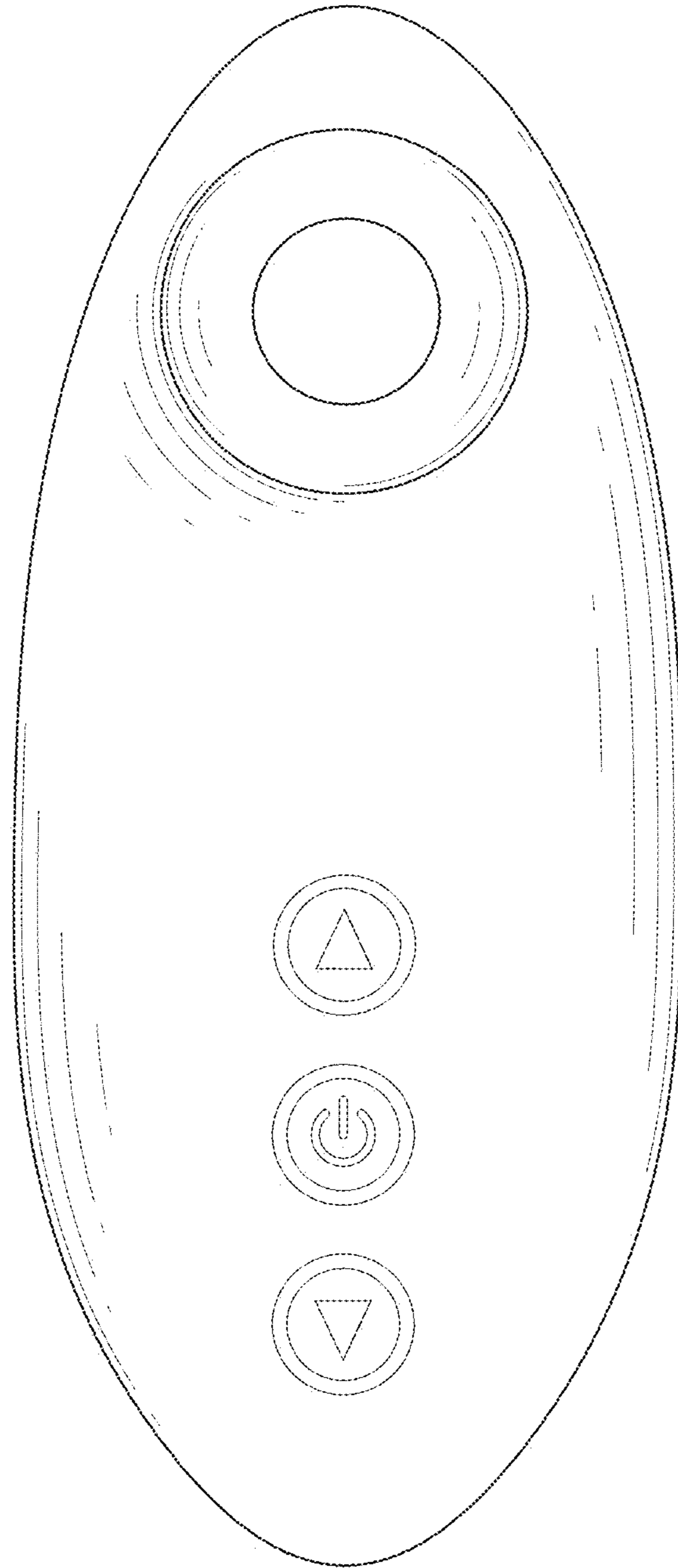

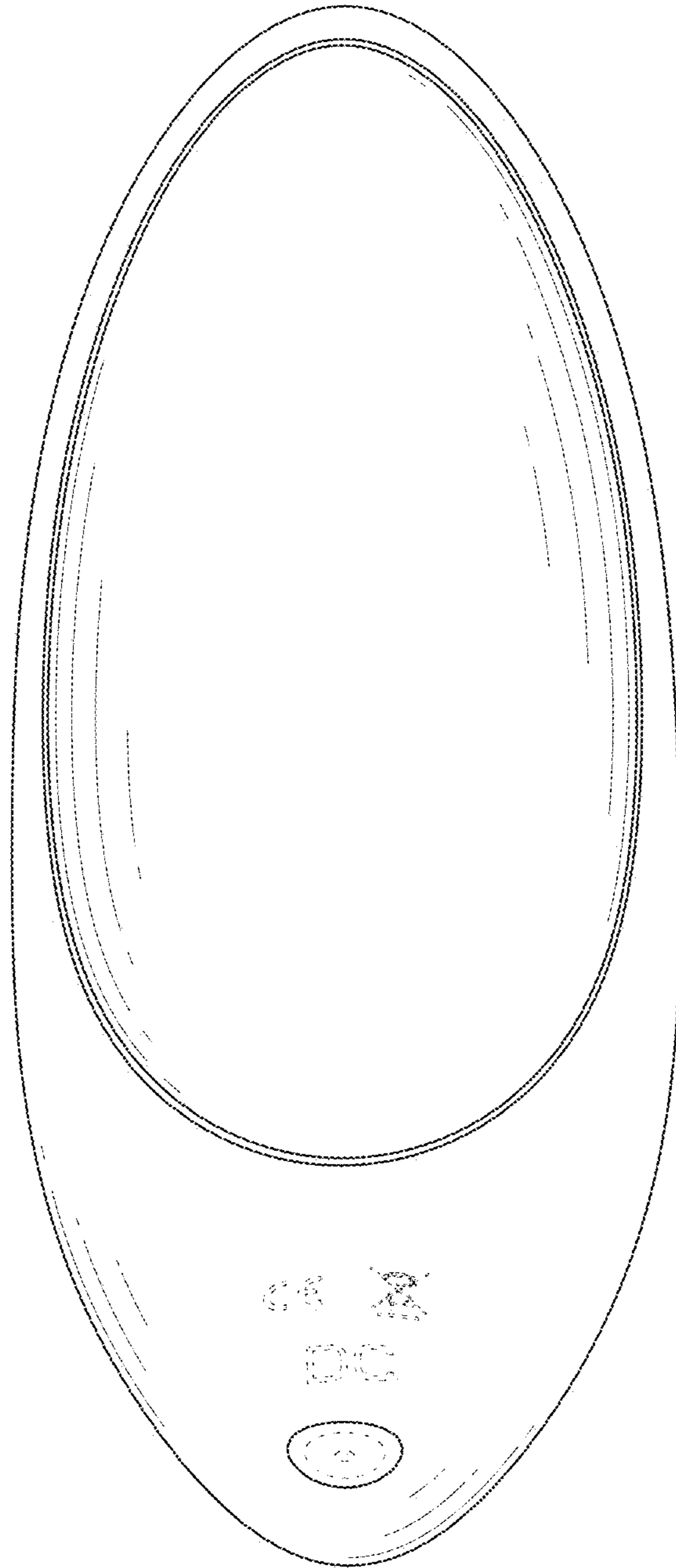

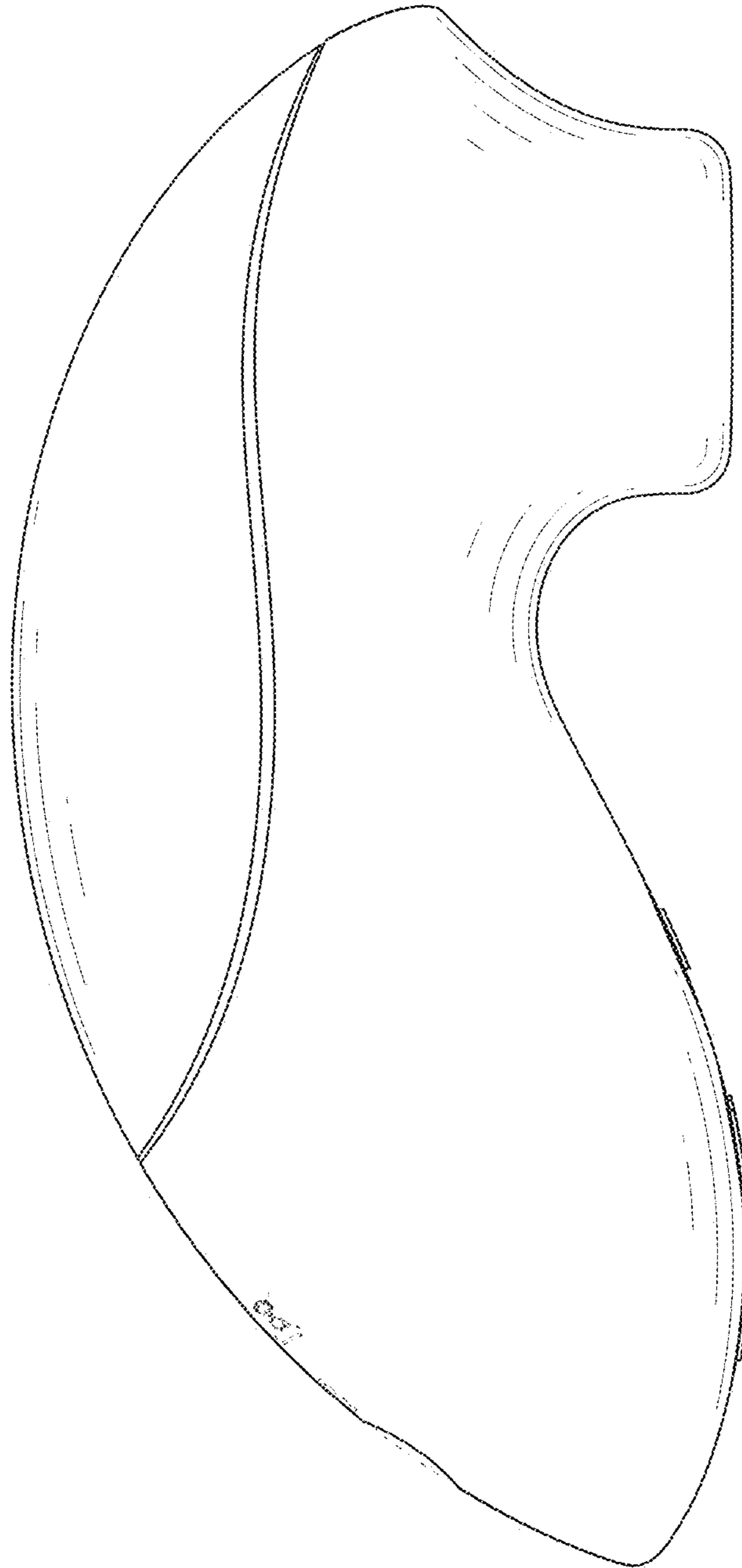

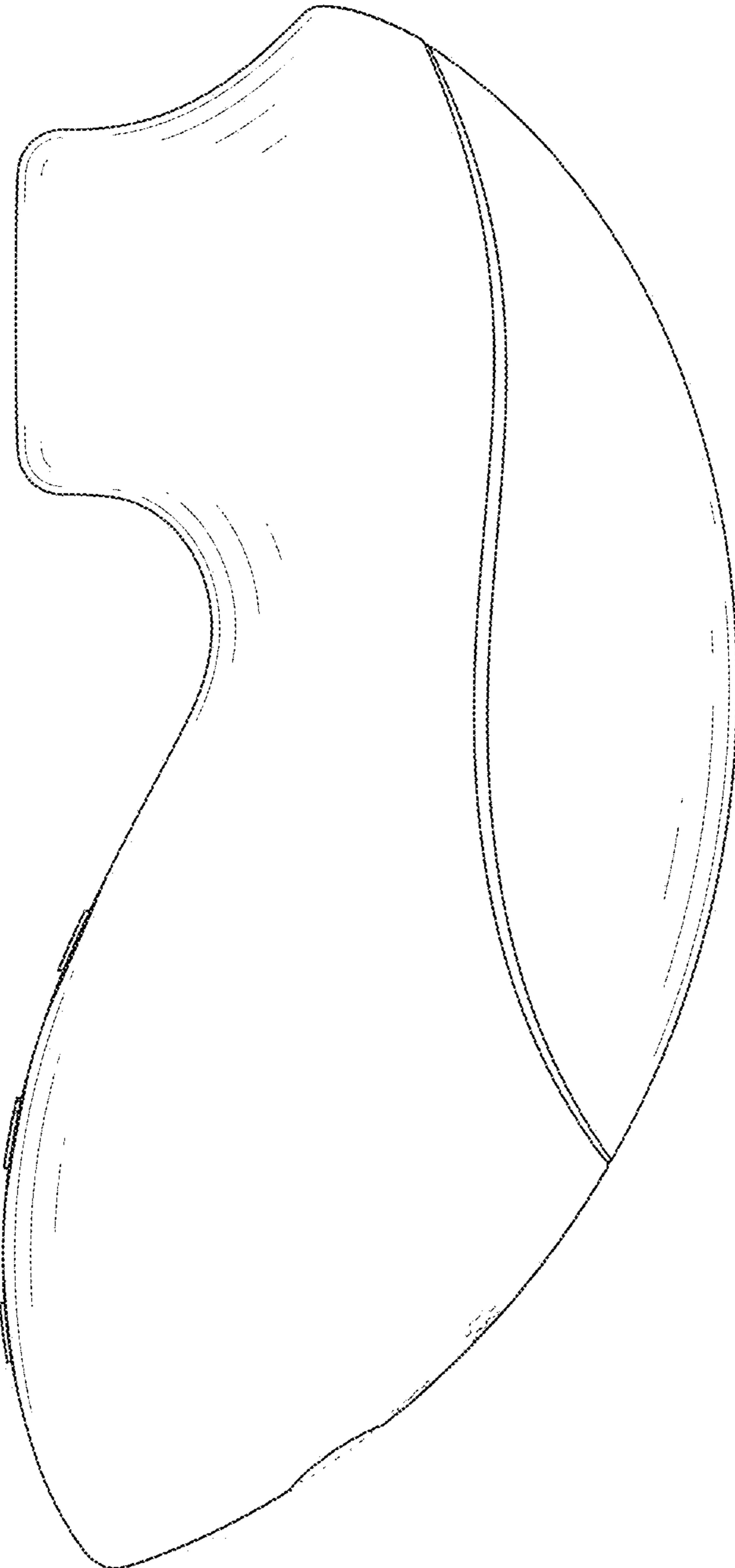

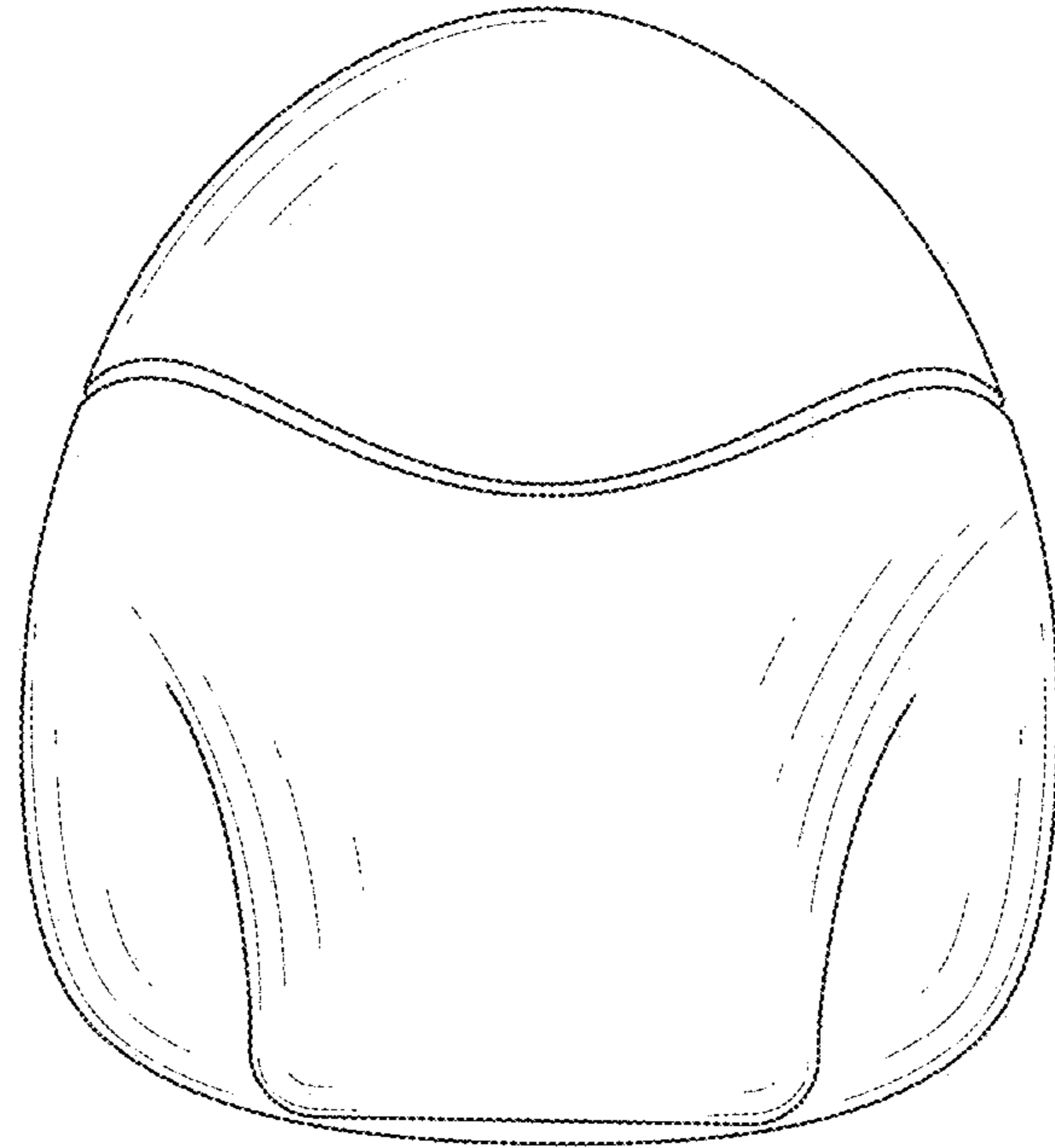

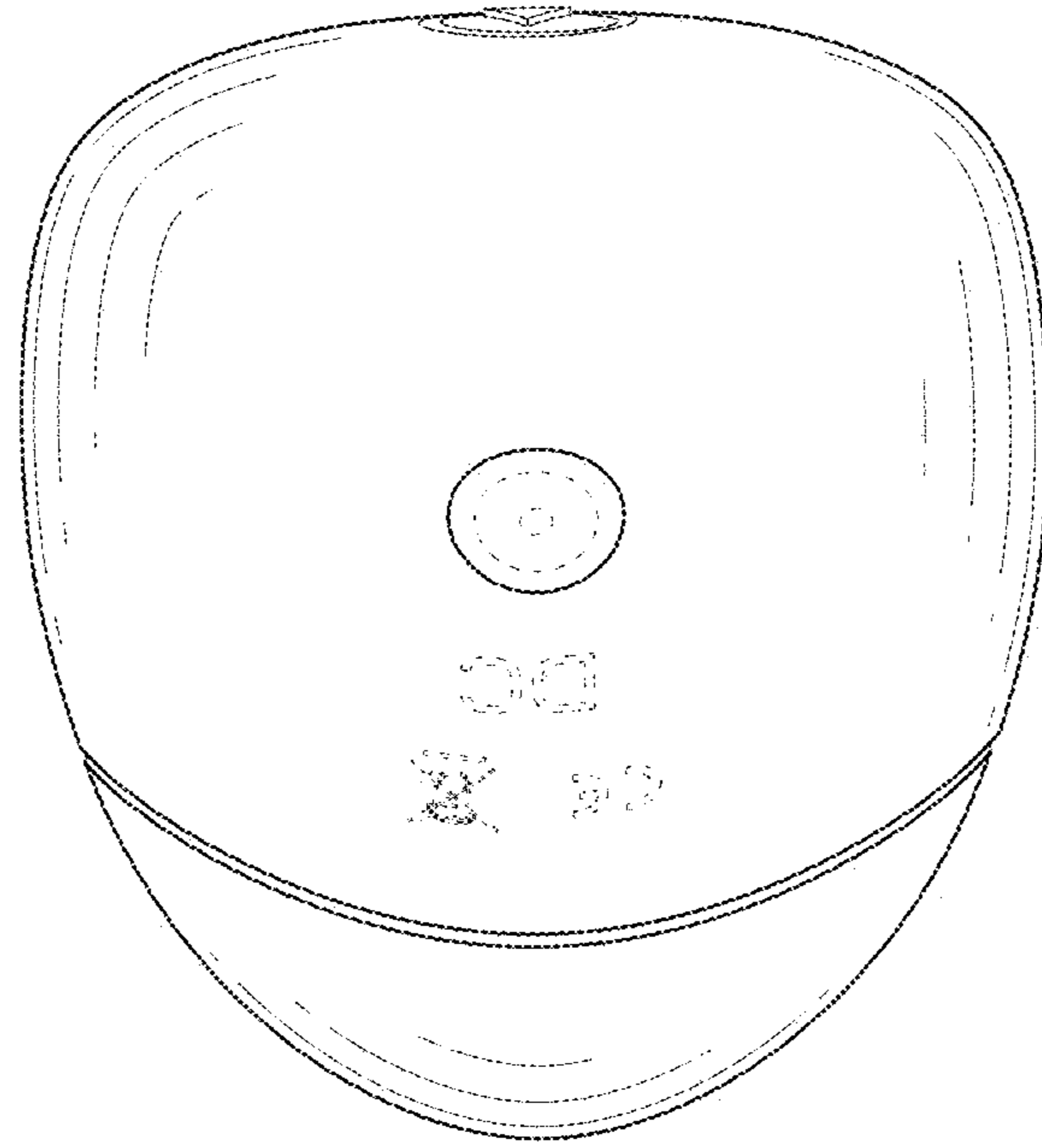
