DESCRIPTION

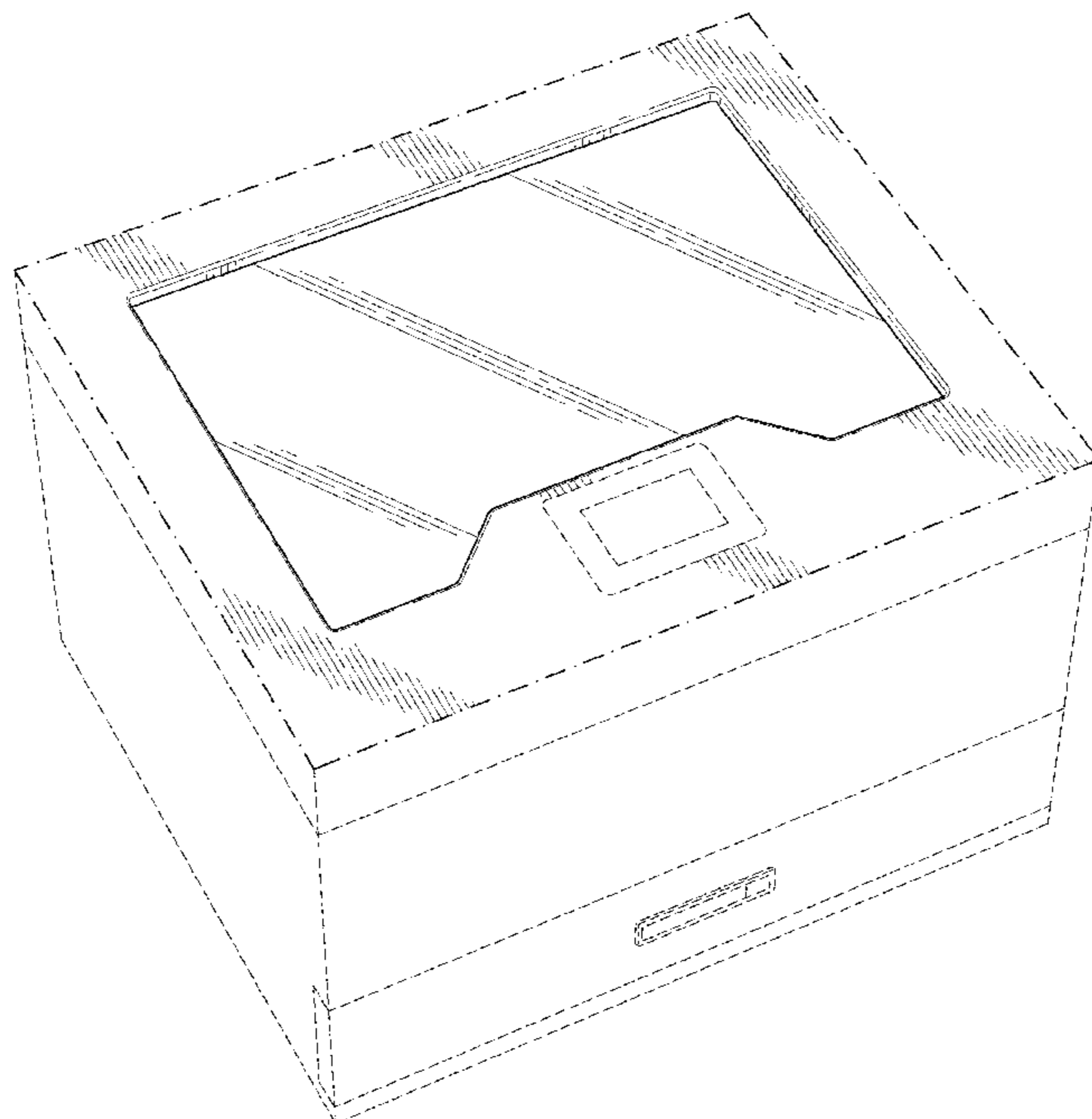
FIG. 1 is a perspective view of a humidor showing the design;

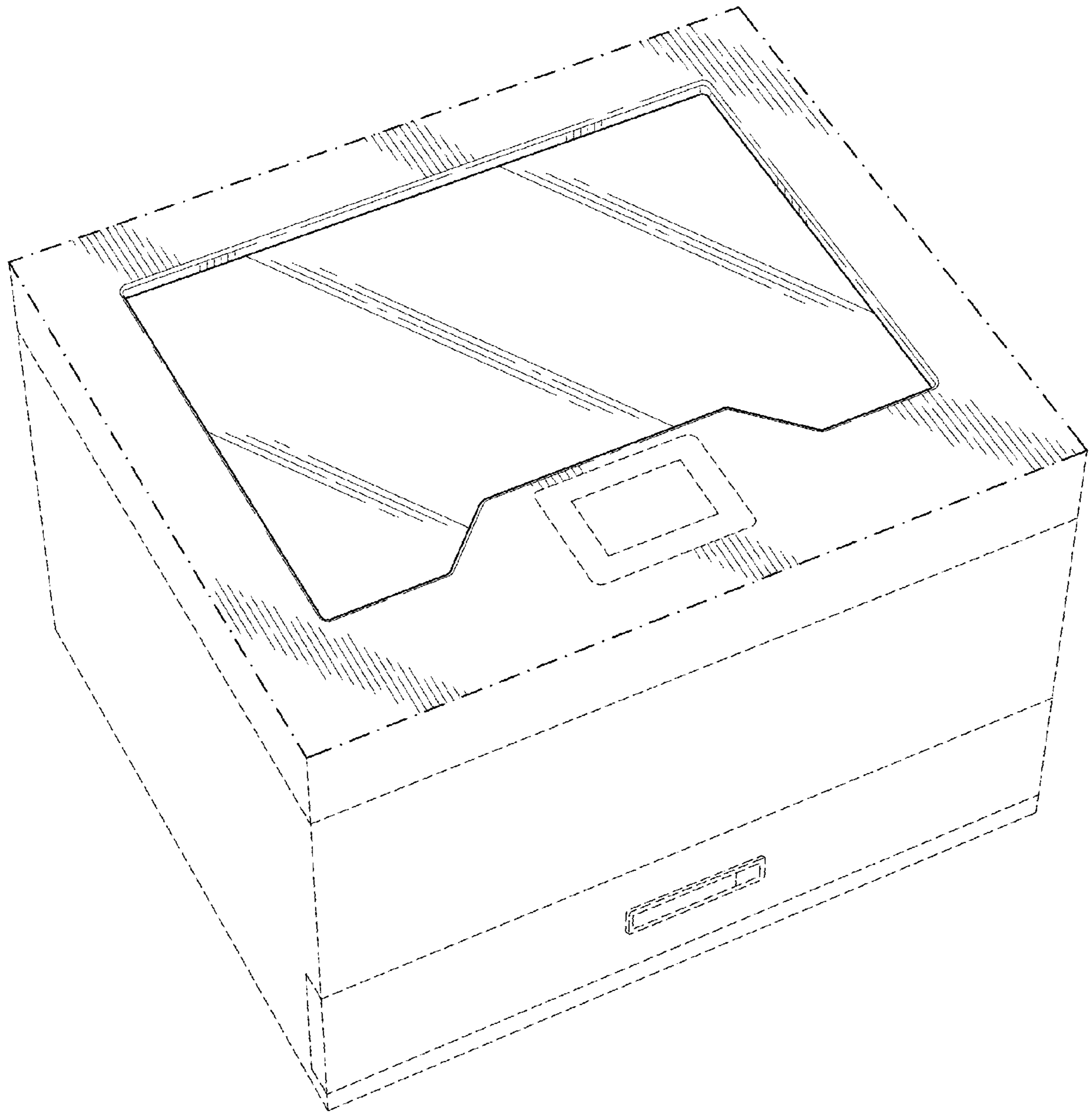

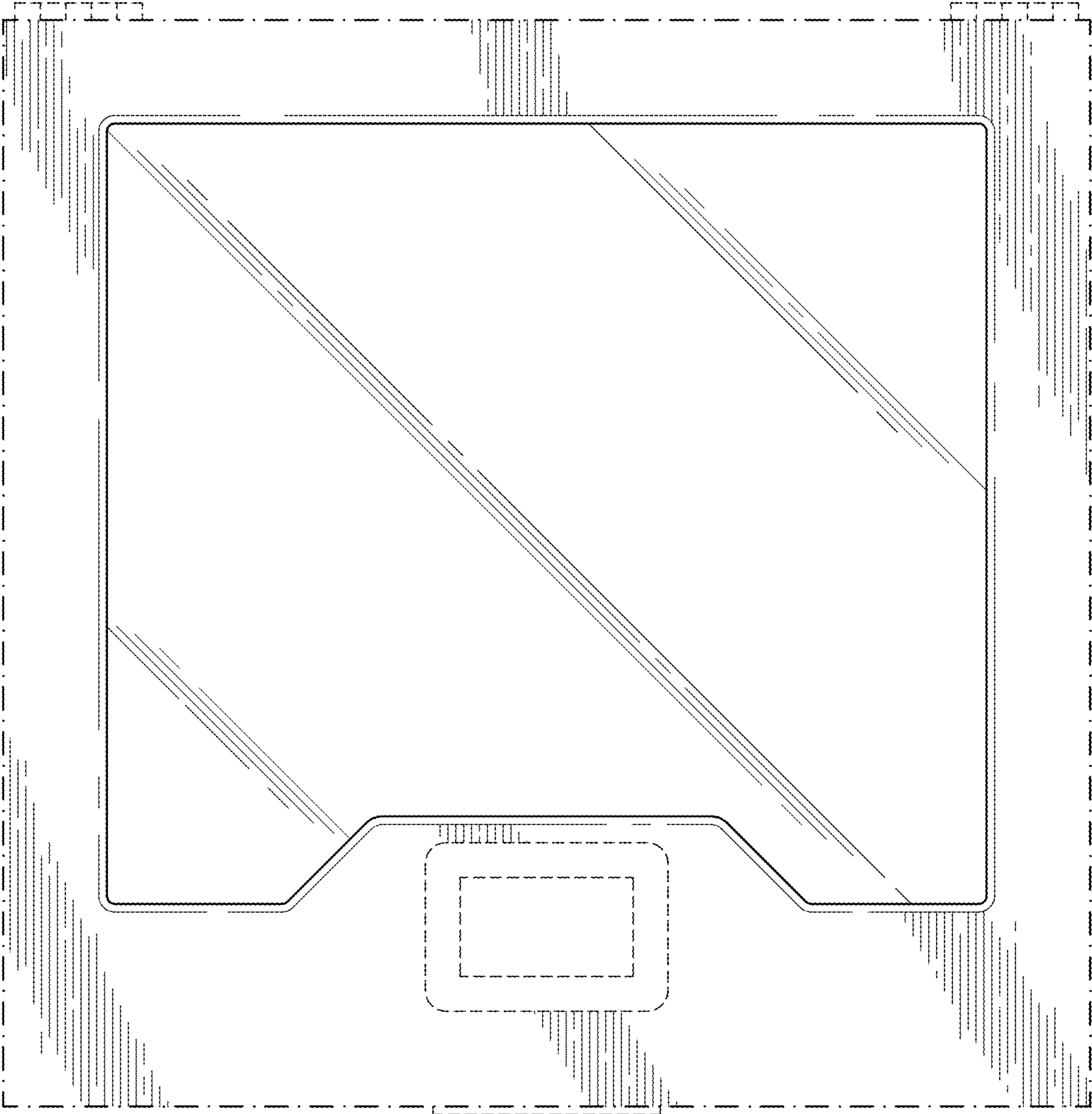

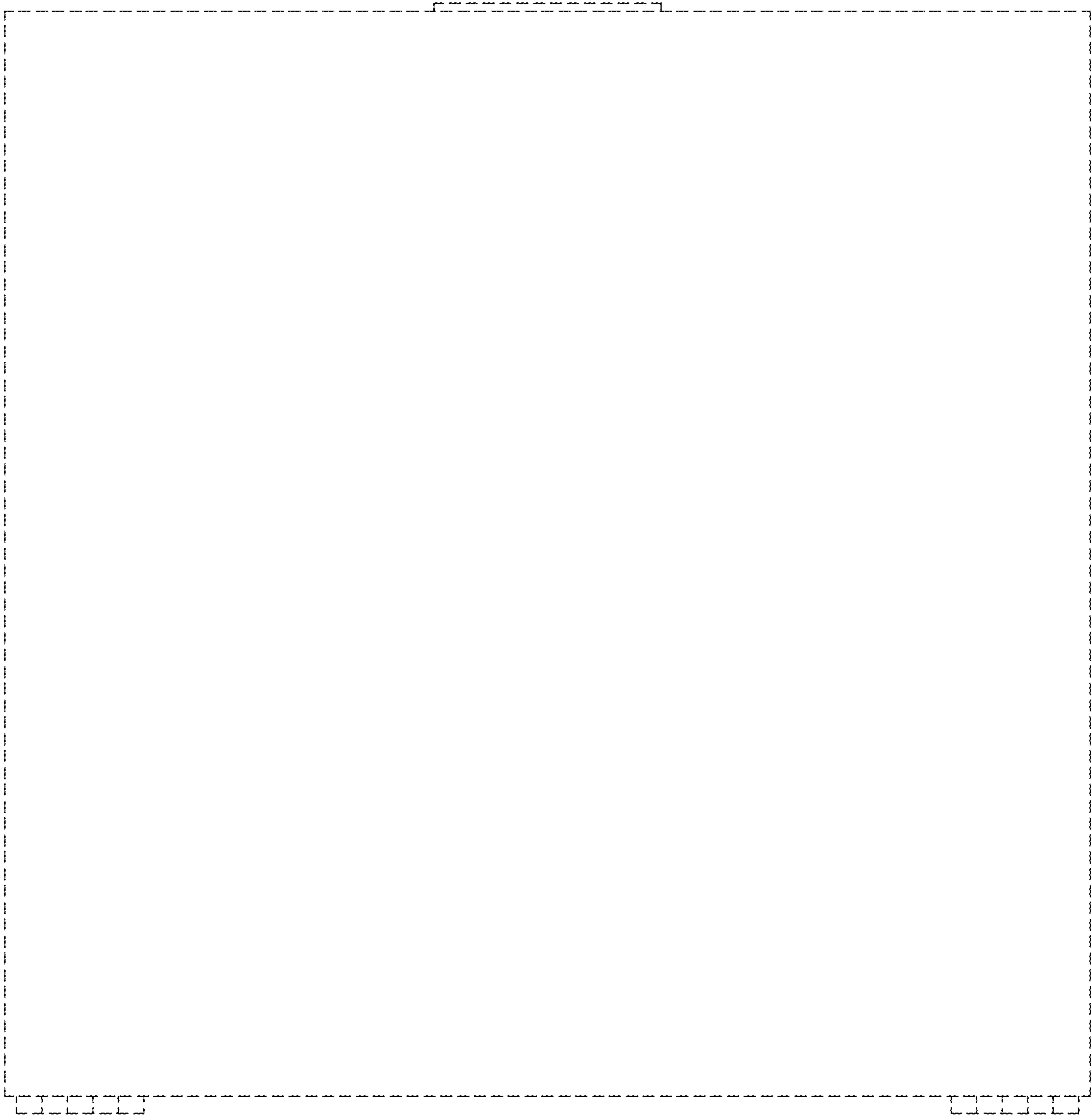

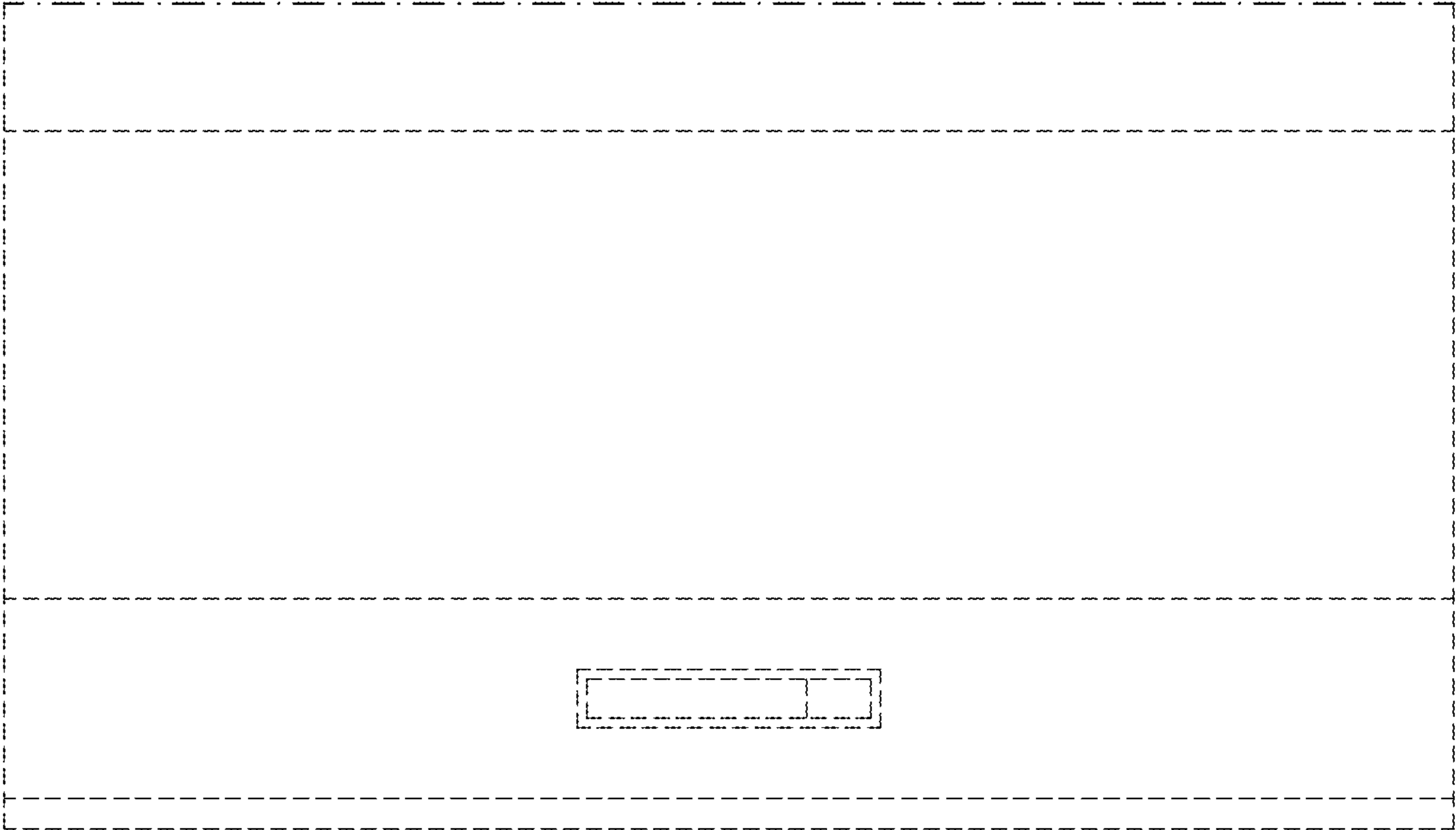

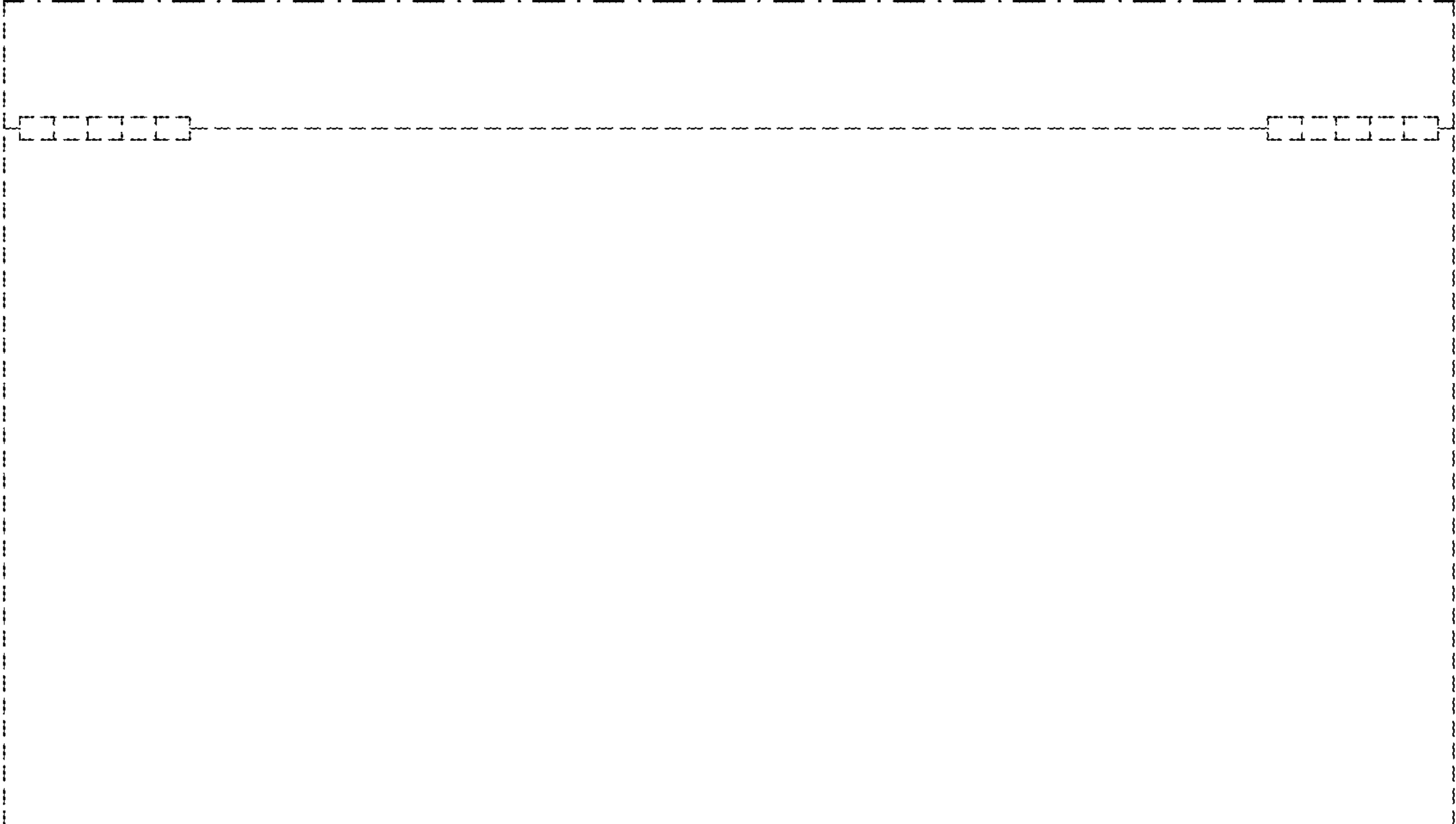
