(57) **CLAIM**

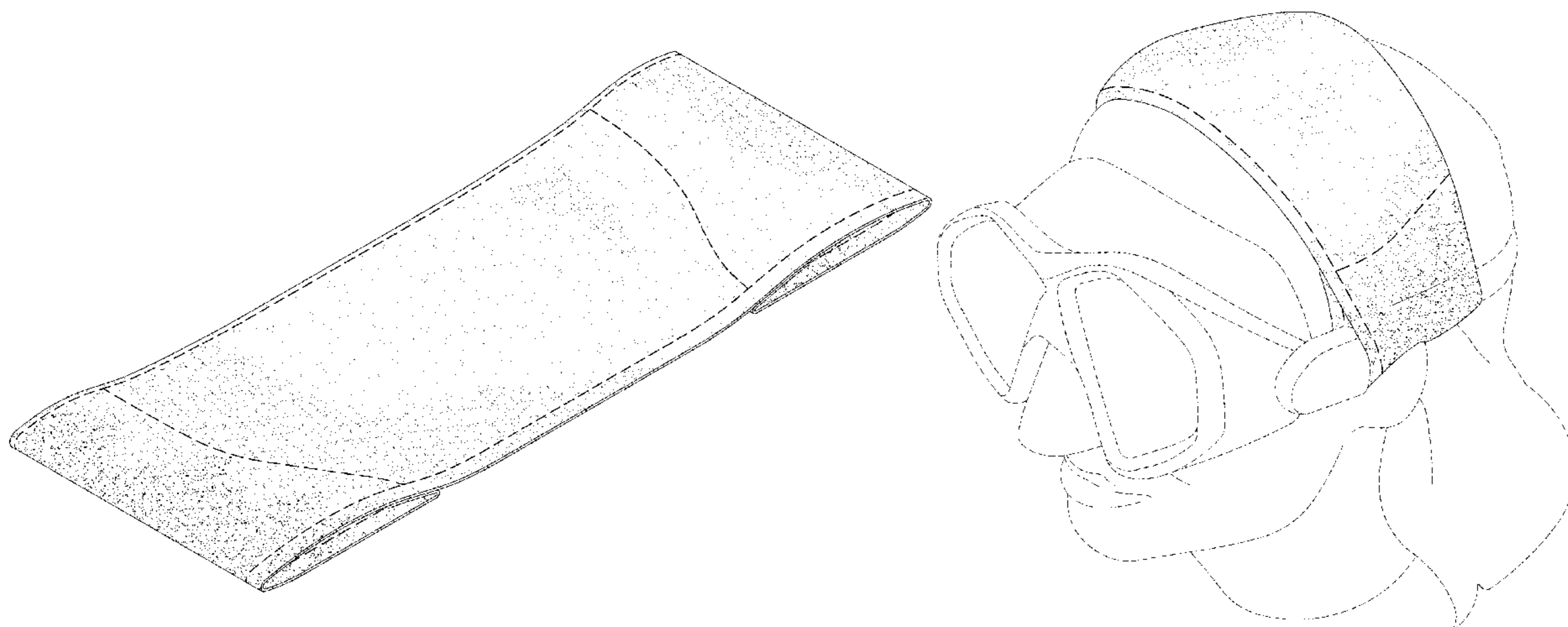
The ornamental design for a hair accessory, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a hair accessory, showing an exemplary embodiment of my new design;  
FIG. 2 is a front view thereof;

FIG. 4 is a right side elevation view thereof;

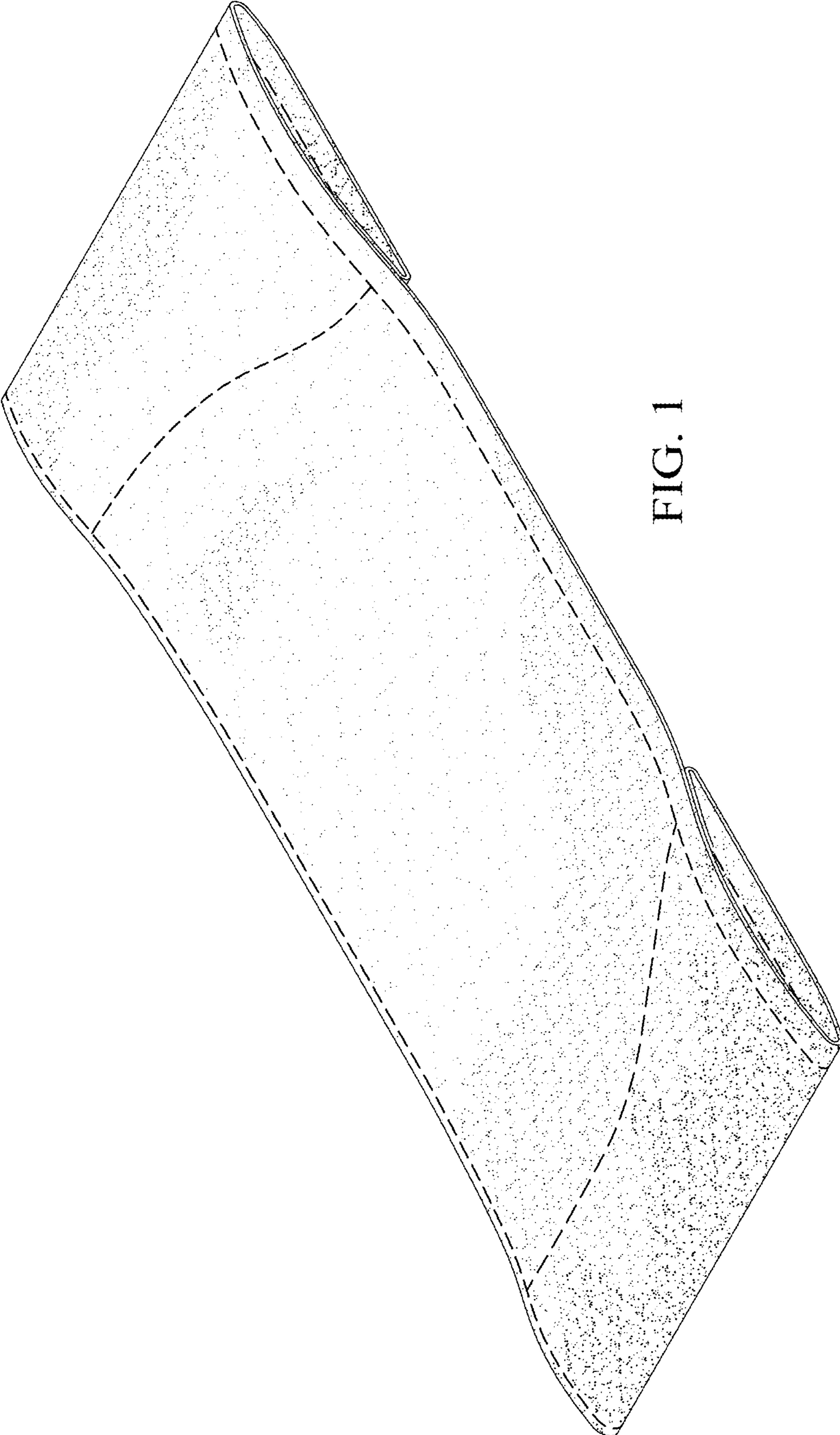

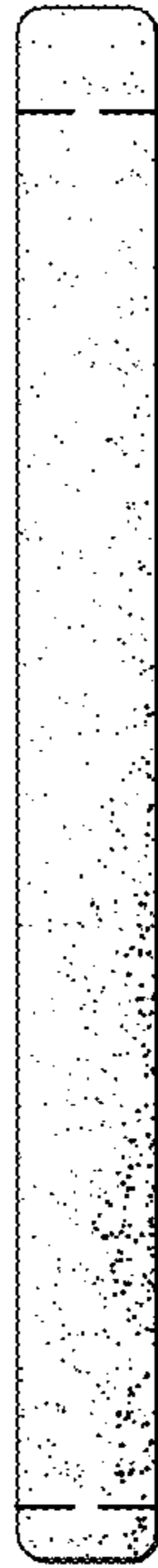

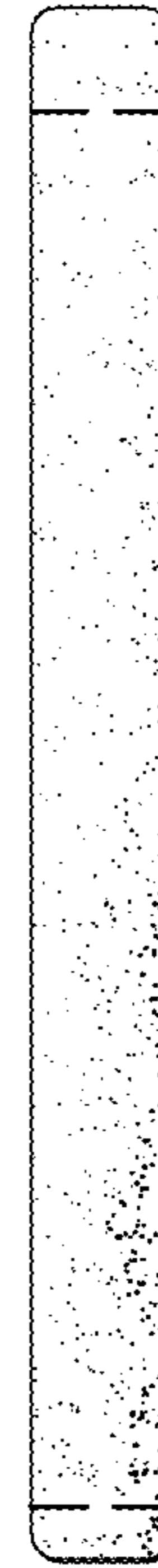

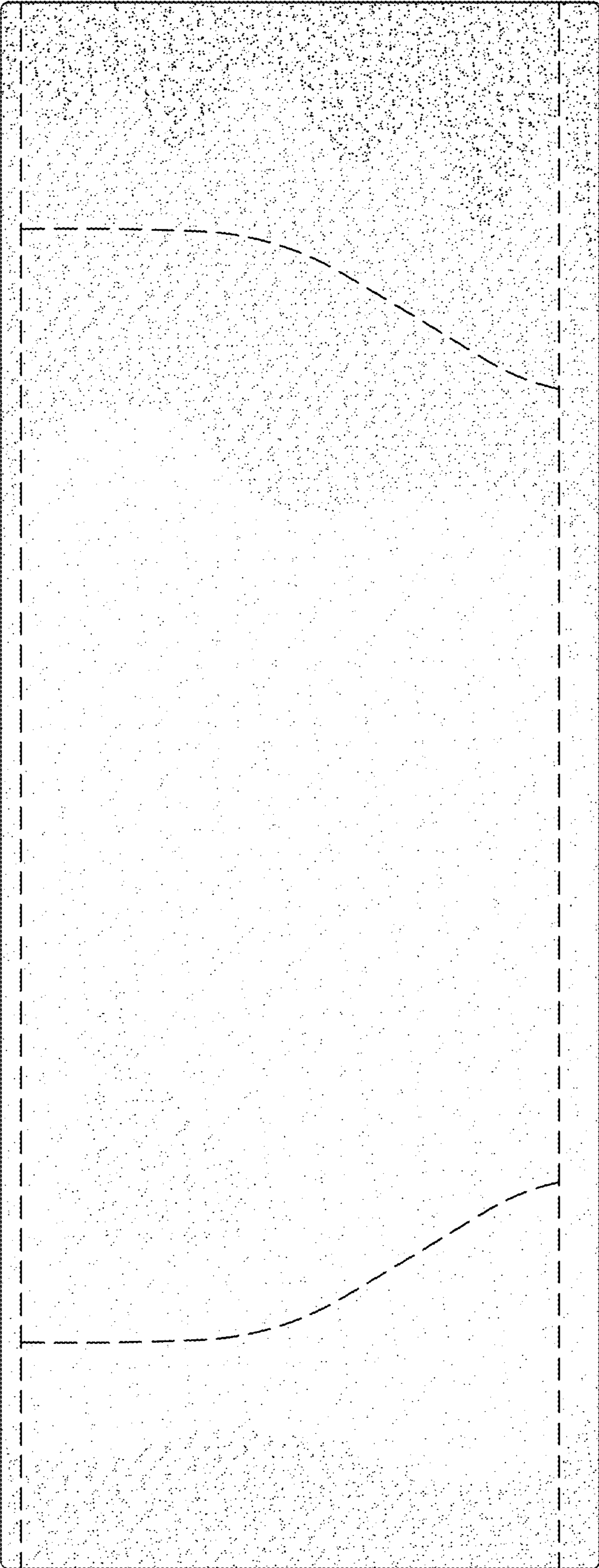

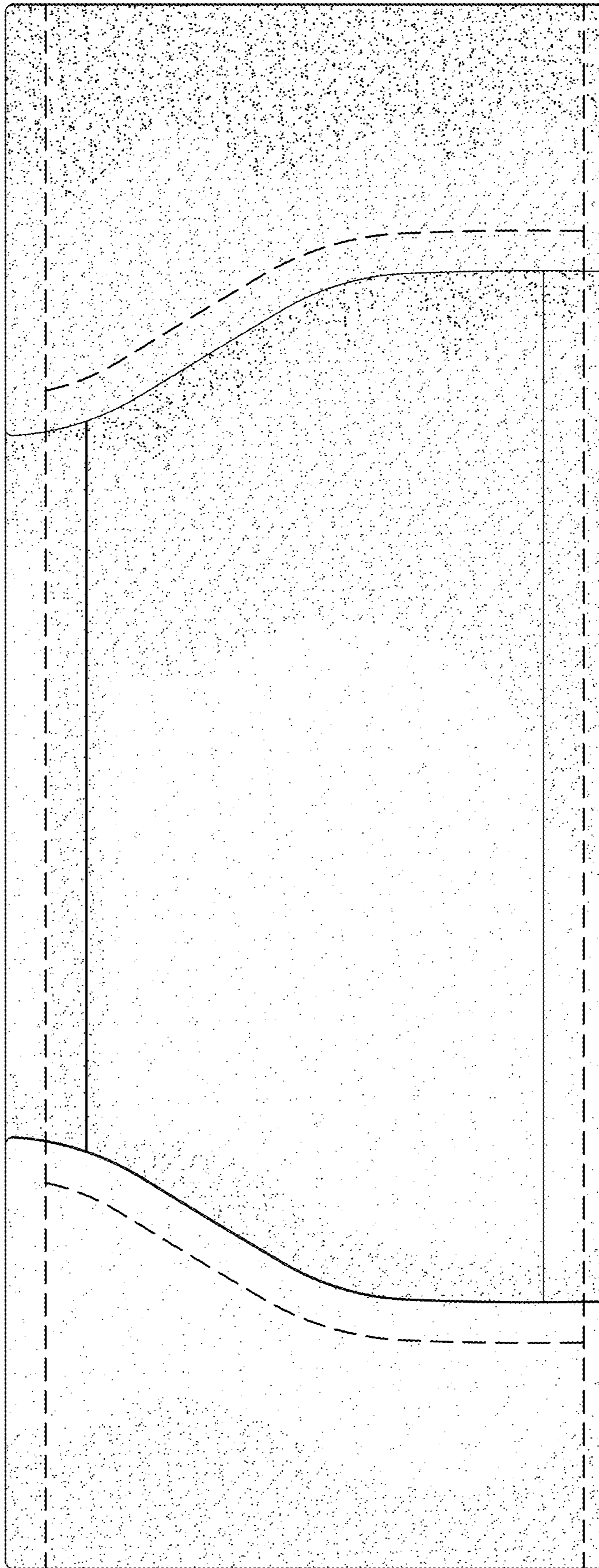

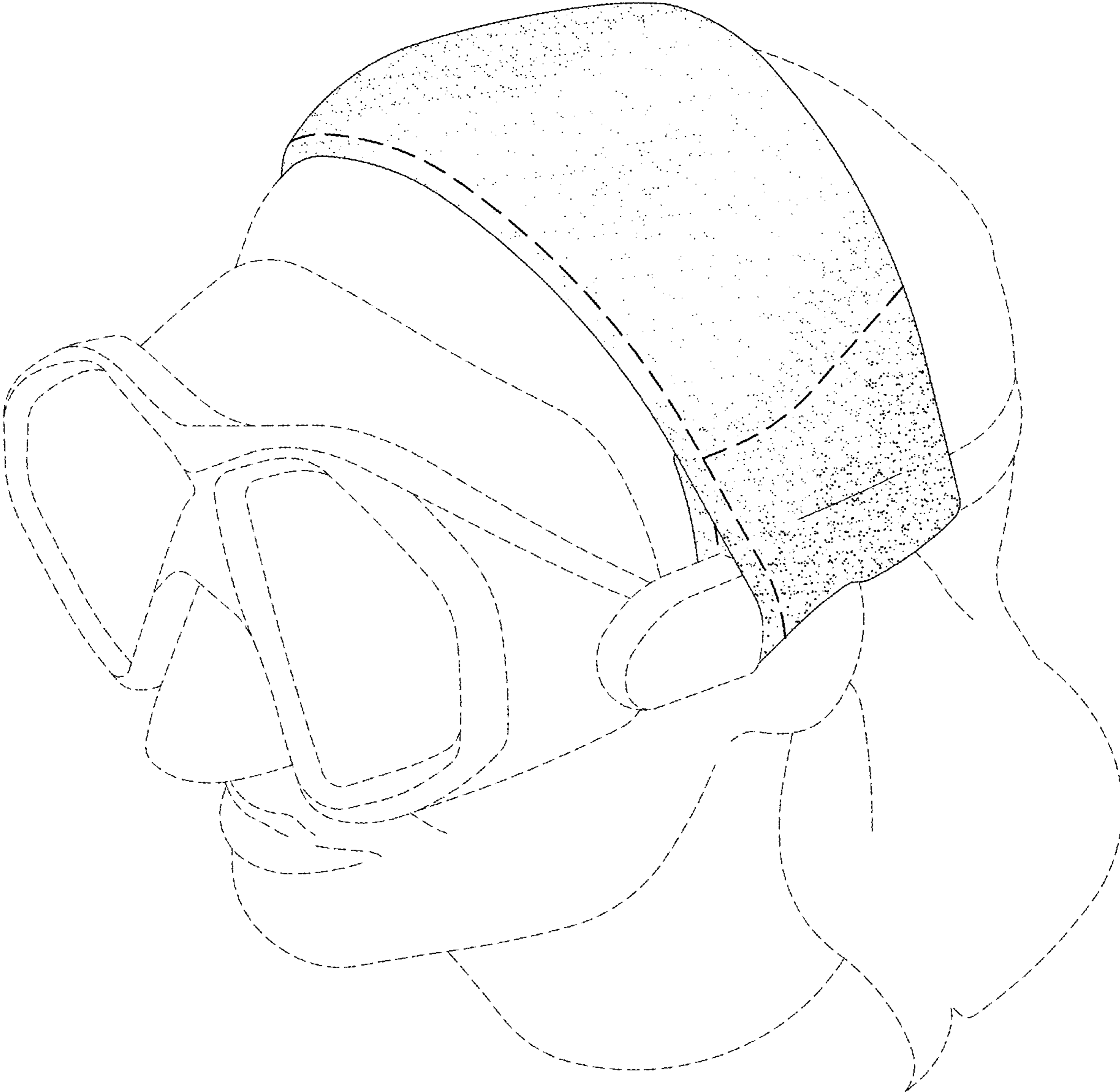
