(57) **CLAIM**

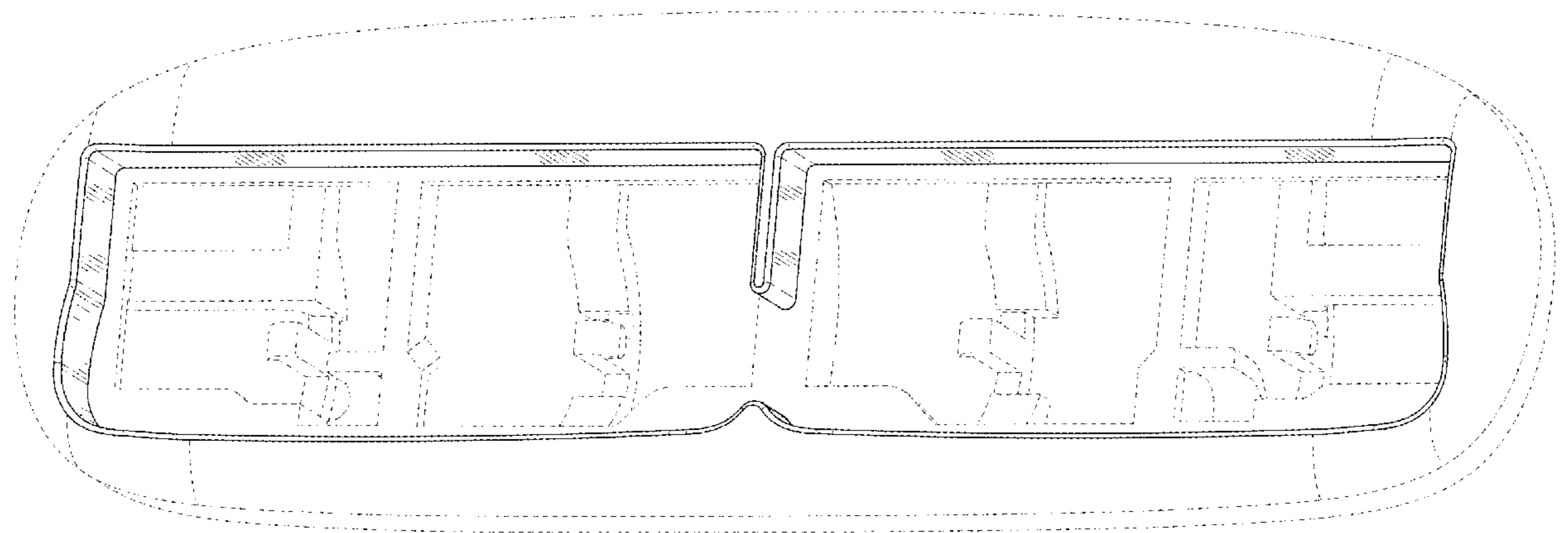
The ornamental design for a back shaver head, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a back shaver head showing my new design;
FIG. 2 is another perspective view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a left side elevational view thereof;
FIG. 6 is a right side elevational view thereof;
FIG. 7 is a top plan view thereof;
FIG. 8 is a bottom plan view thereof; and,
FIG. 9 is a perspective view of the back shaver head where the back shaver head is in a configuration of use.

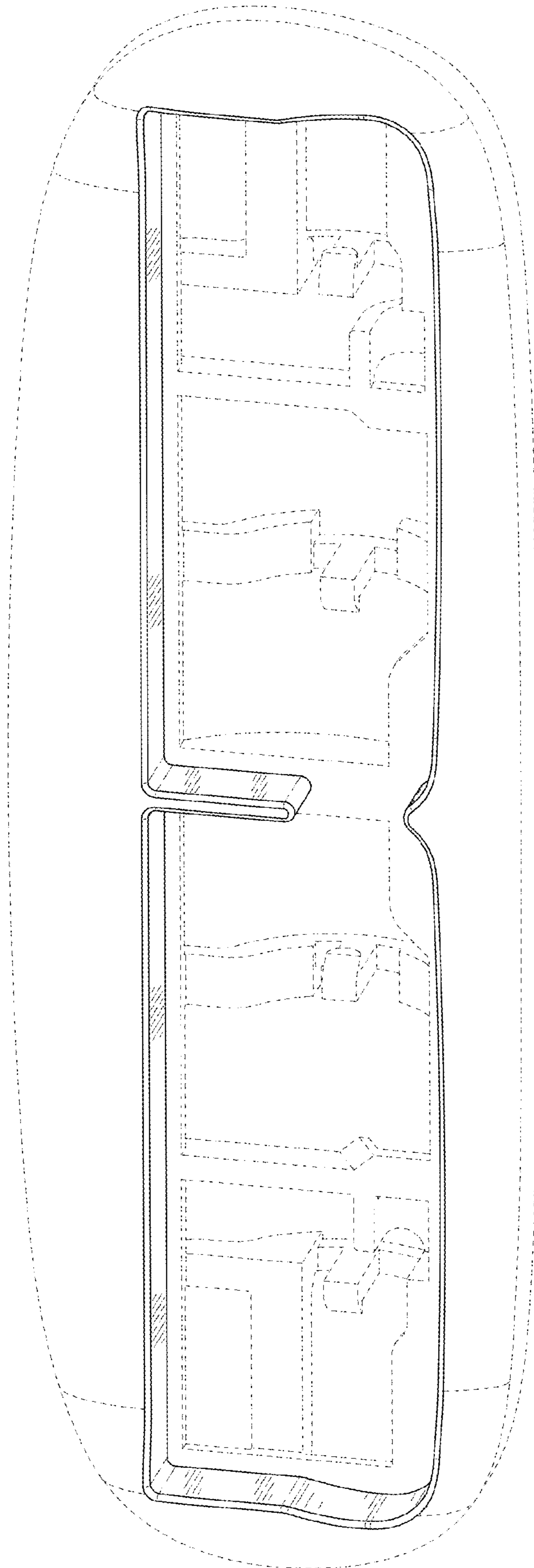

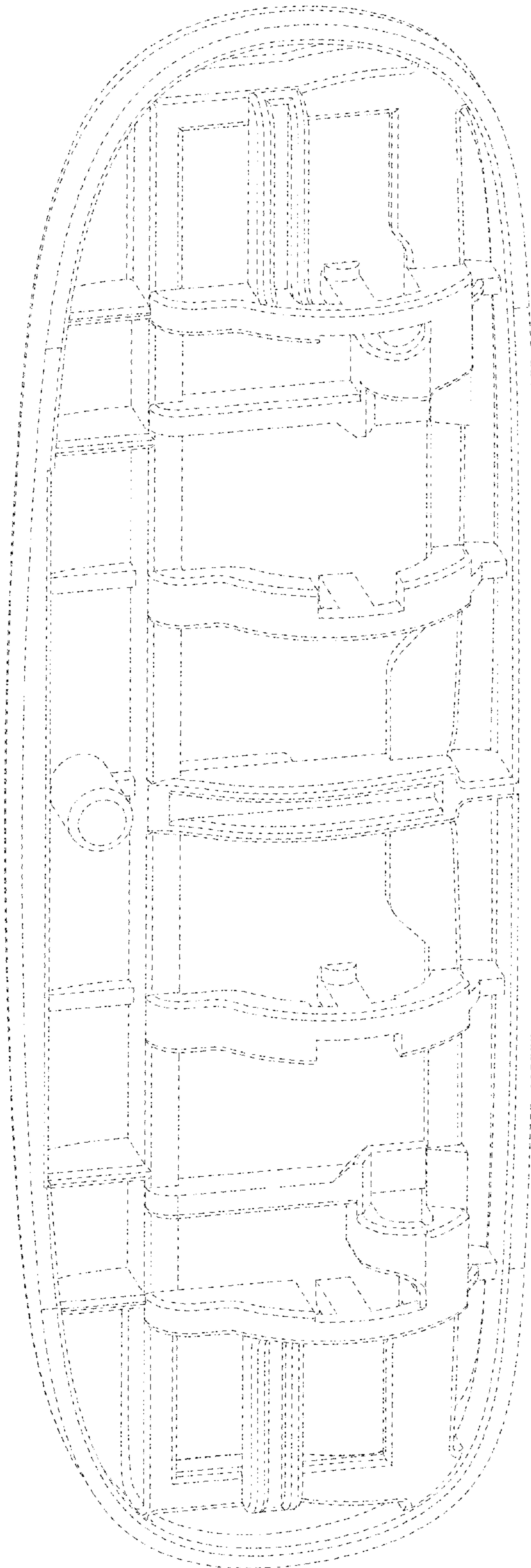

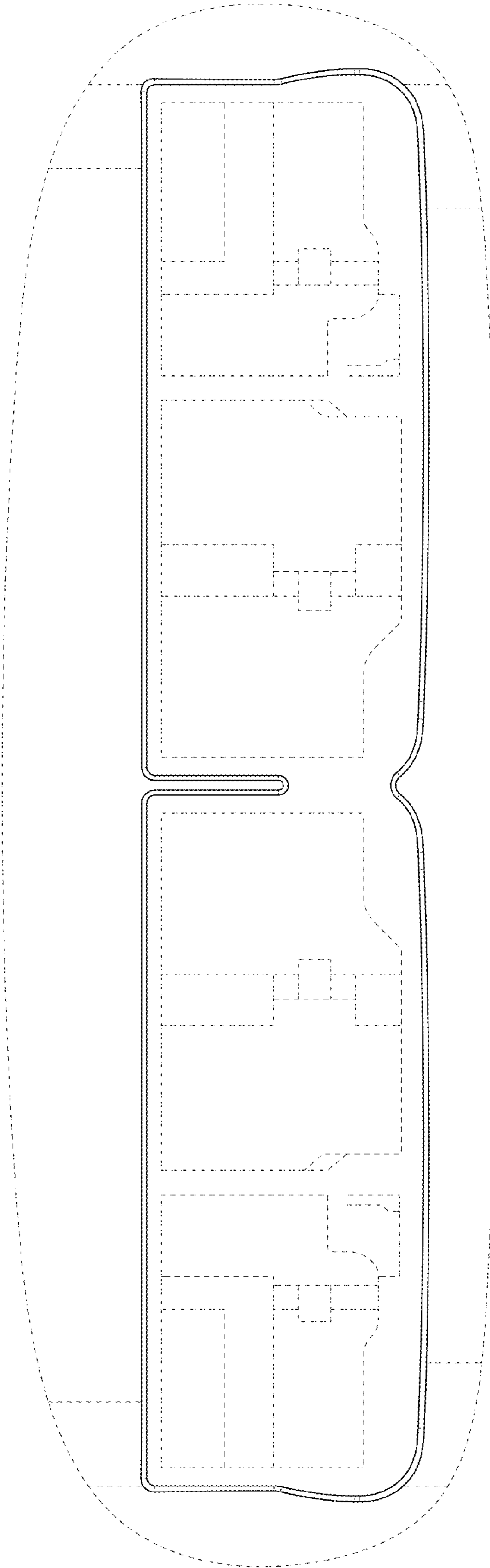

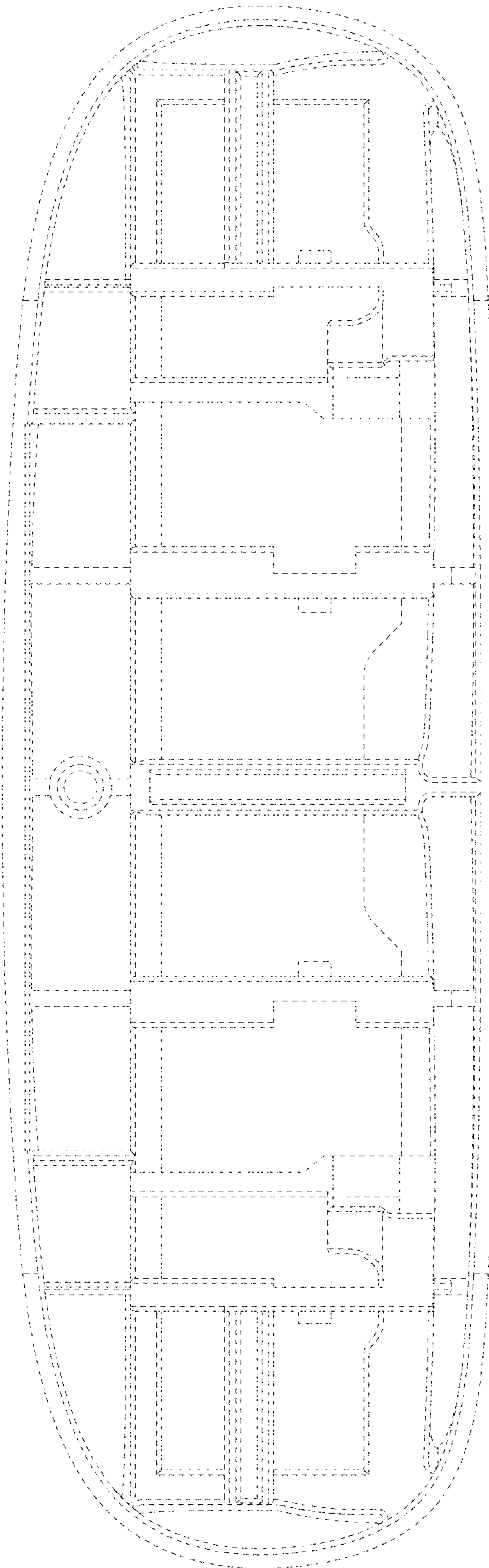

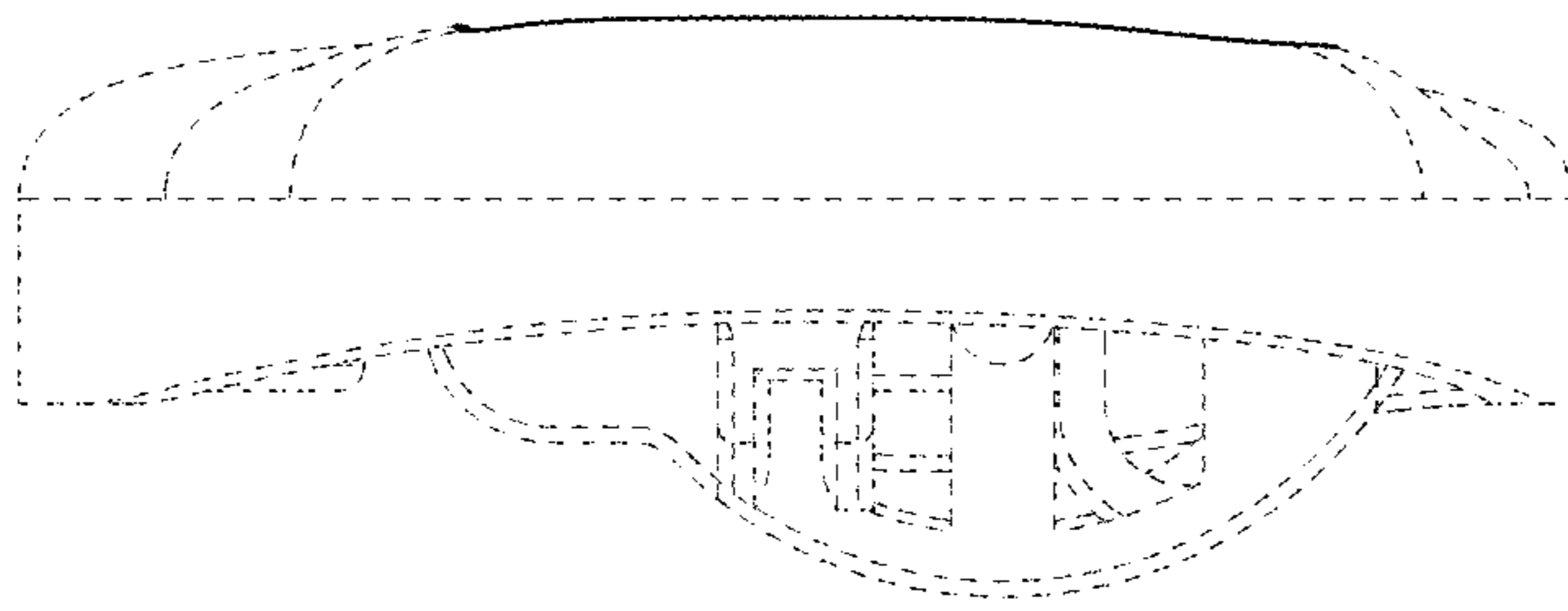

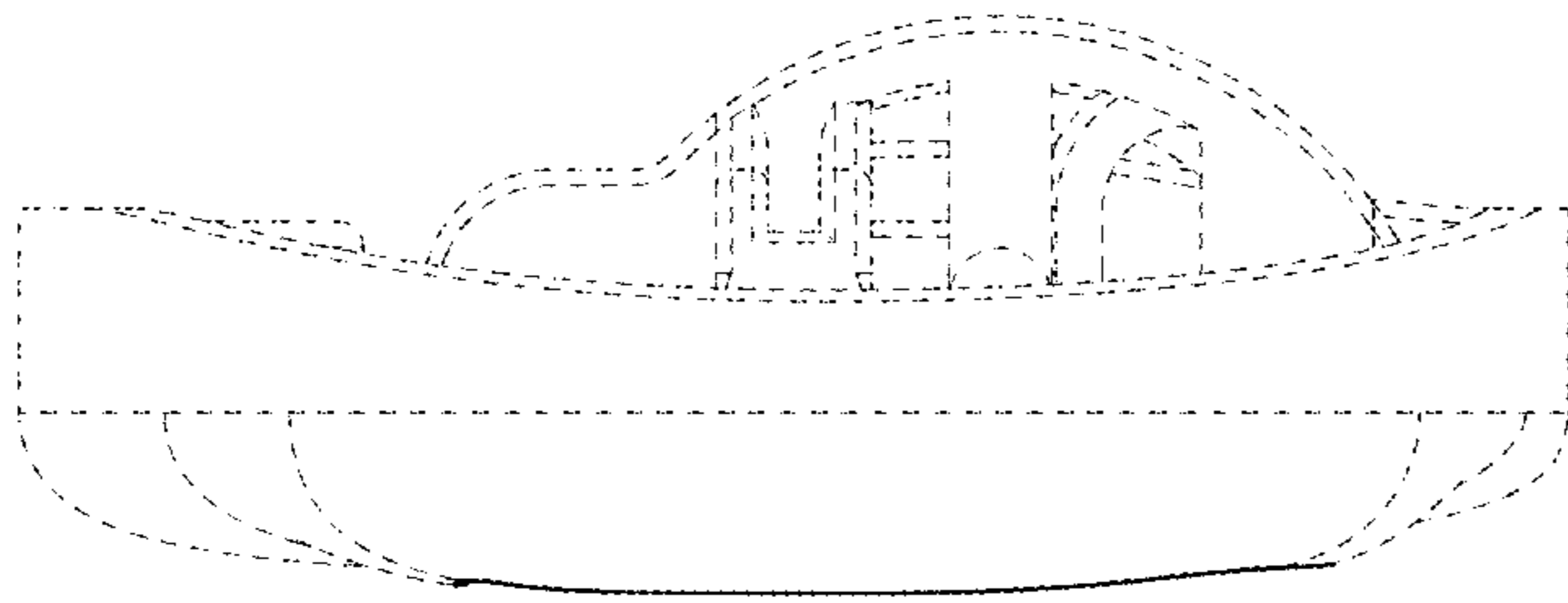

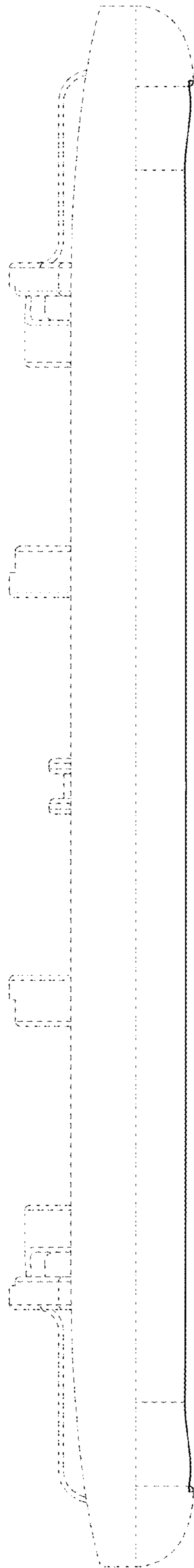

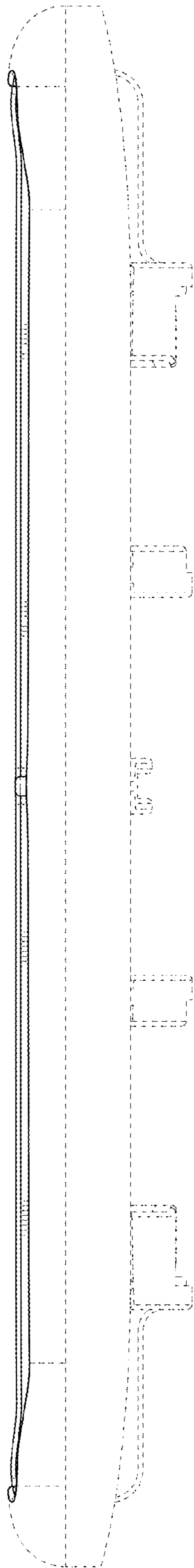

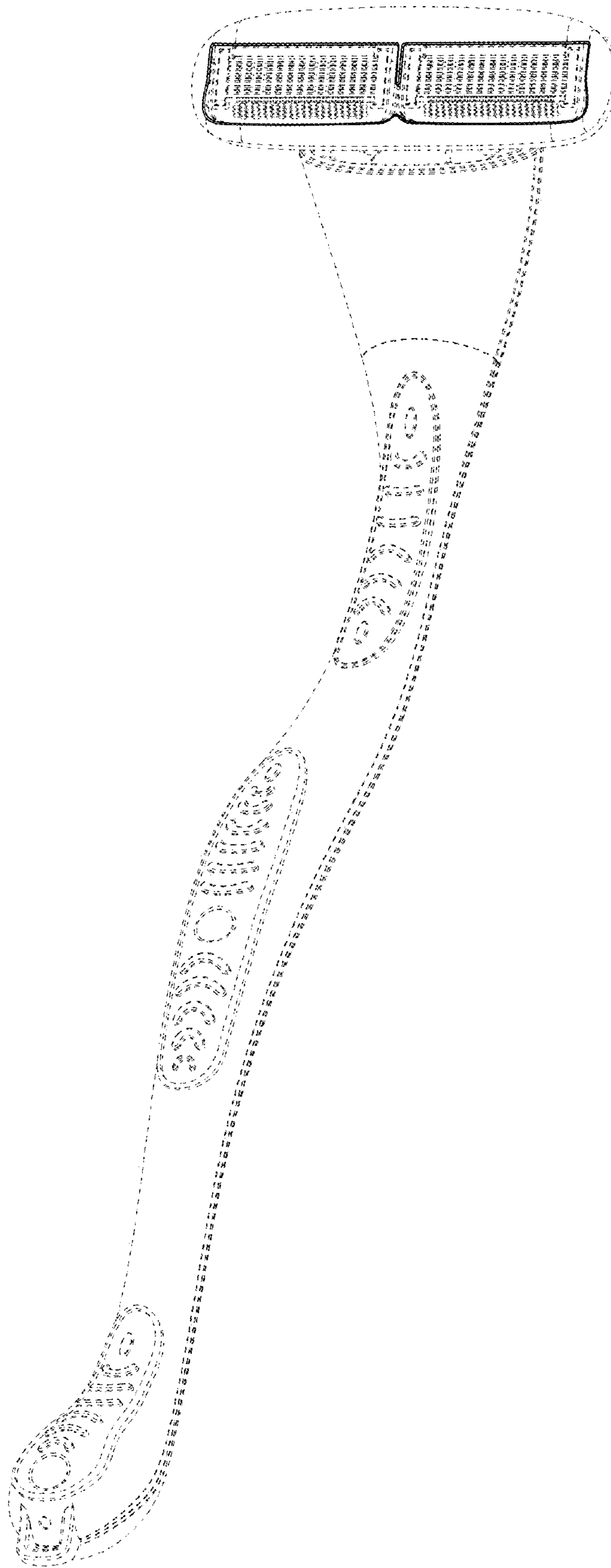
