FIG. 1 is a photographic front perspective view of a garment, showing my new design;

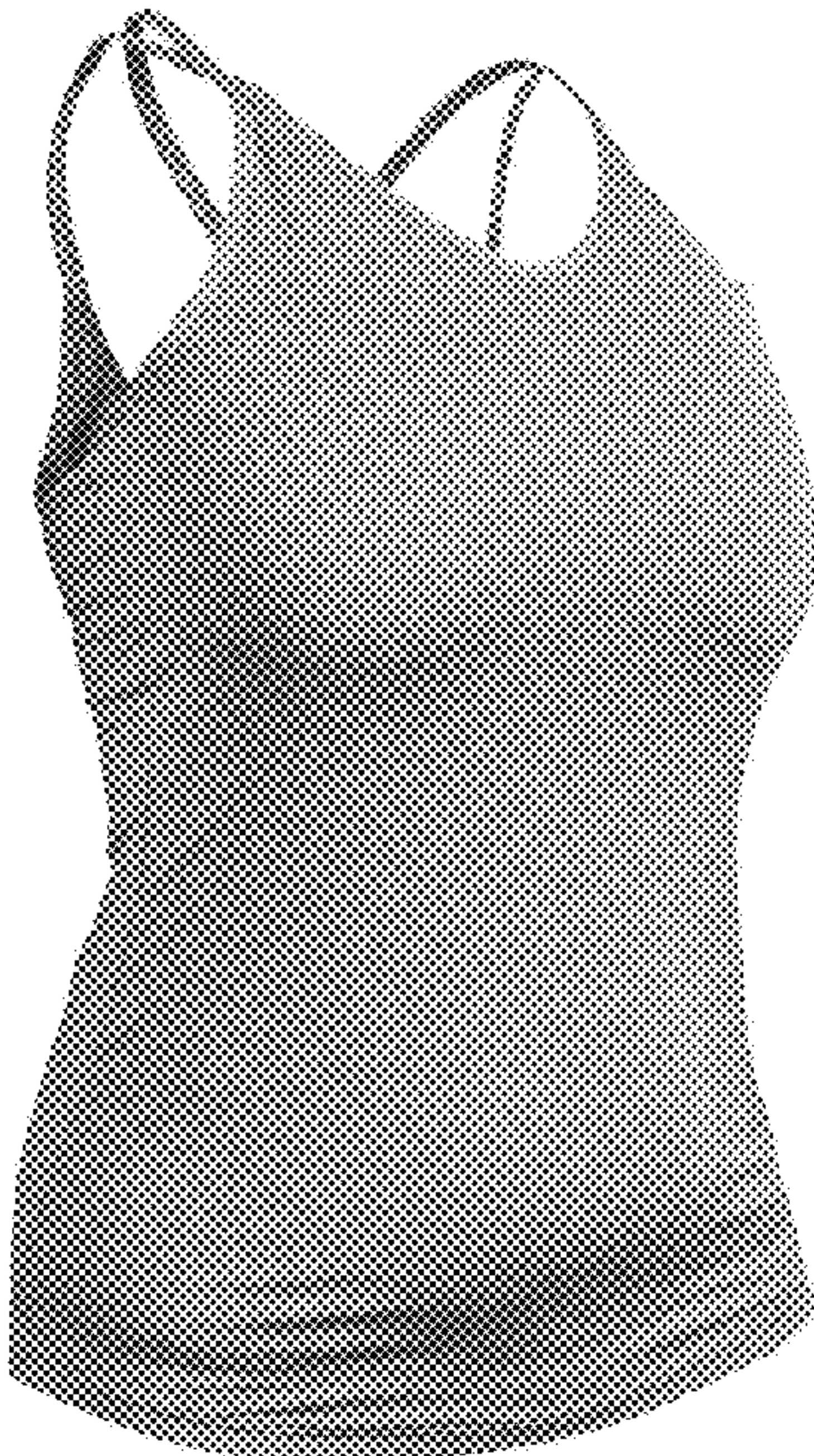
FIG. 2 is a right side view thereof;
