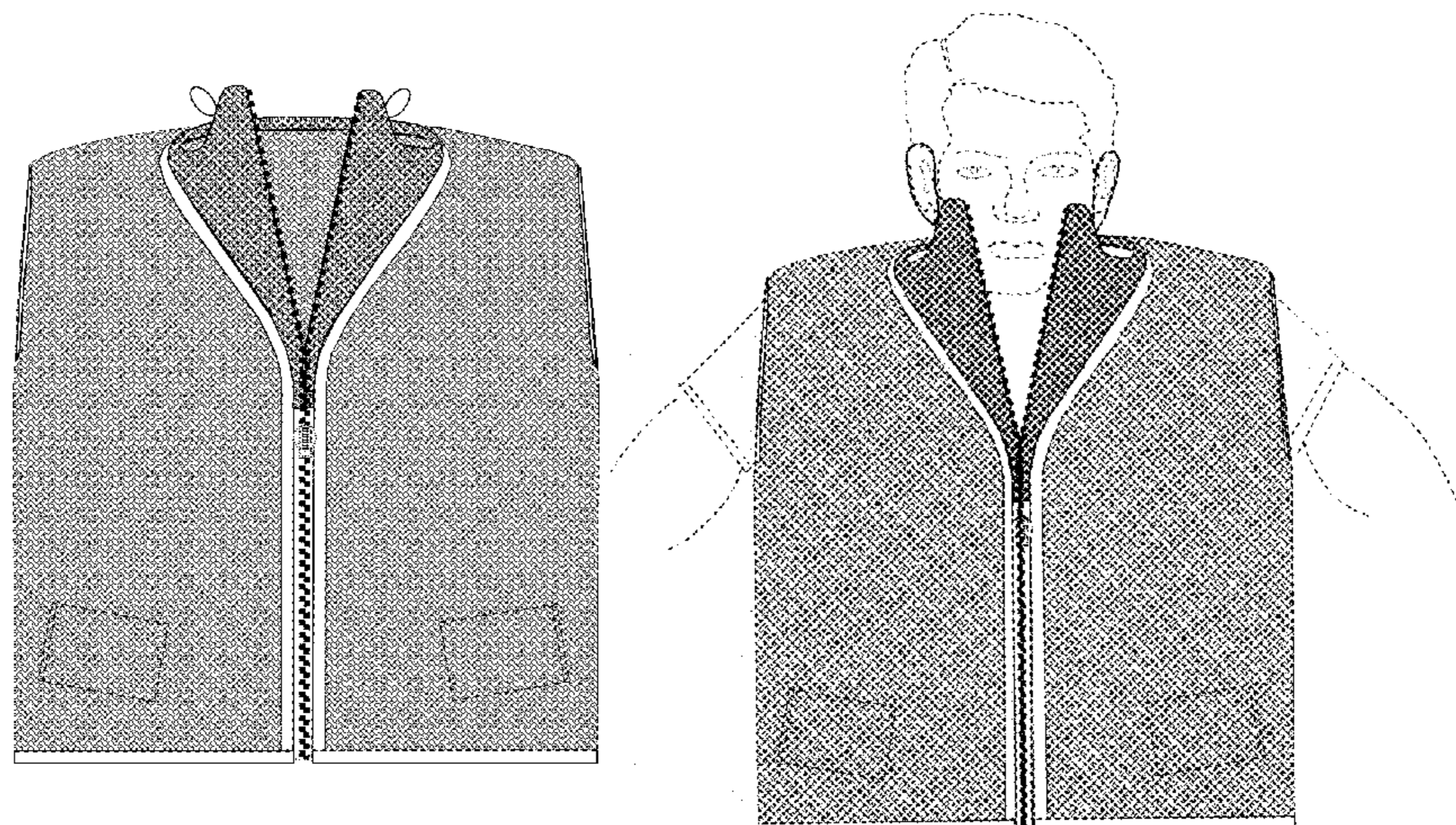
(57) **CLAIM**

The ornamental design for a personal protection vest, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the personal protection vest according to the present design;
FIG. 2 is a front elevation view of the personal protection vest as shown in FIG. 1;
FIG. 3 is another front elevation view of the personal protection vest showing the inner side of the protective mouth and nose covering as shown in FIG. 1;
FIG. 4 is a left side view of the personal protection vest as shown in FIG. 1;
FIG. 5 is a right side view of the personal protection vest as shown in FIG. 1;
FIG. 6 is a back view of the personal protection vest as shown in FIG. 1;
FIG. 7 is top view of the personal protection vest as shown in FIG. 1;
FIG. 8 is a bottom view of the personal protection vest as shown in FIG. 1; and,
FIG. 9 is a front view of the vest in FIG. 1 showing an integral protective mouth and nose covering illustrating a deployment position in a personal protection vest.
The broken lines in the drawings depict stitching and form no part of the claimed design.
The broken line showing of person in FIG. 9 is for the purpose of depicting environmental structure and forms no part of the claimed design.
The claimed protection of mouth and nose covering of the personal protection vest is illustrated as integral part of an apparel.

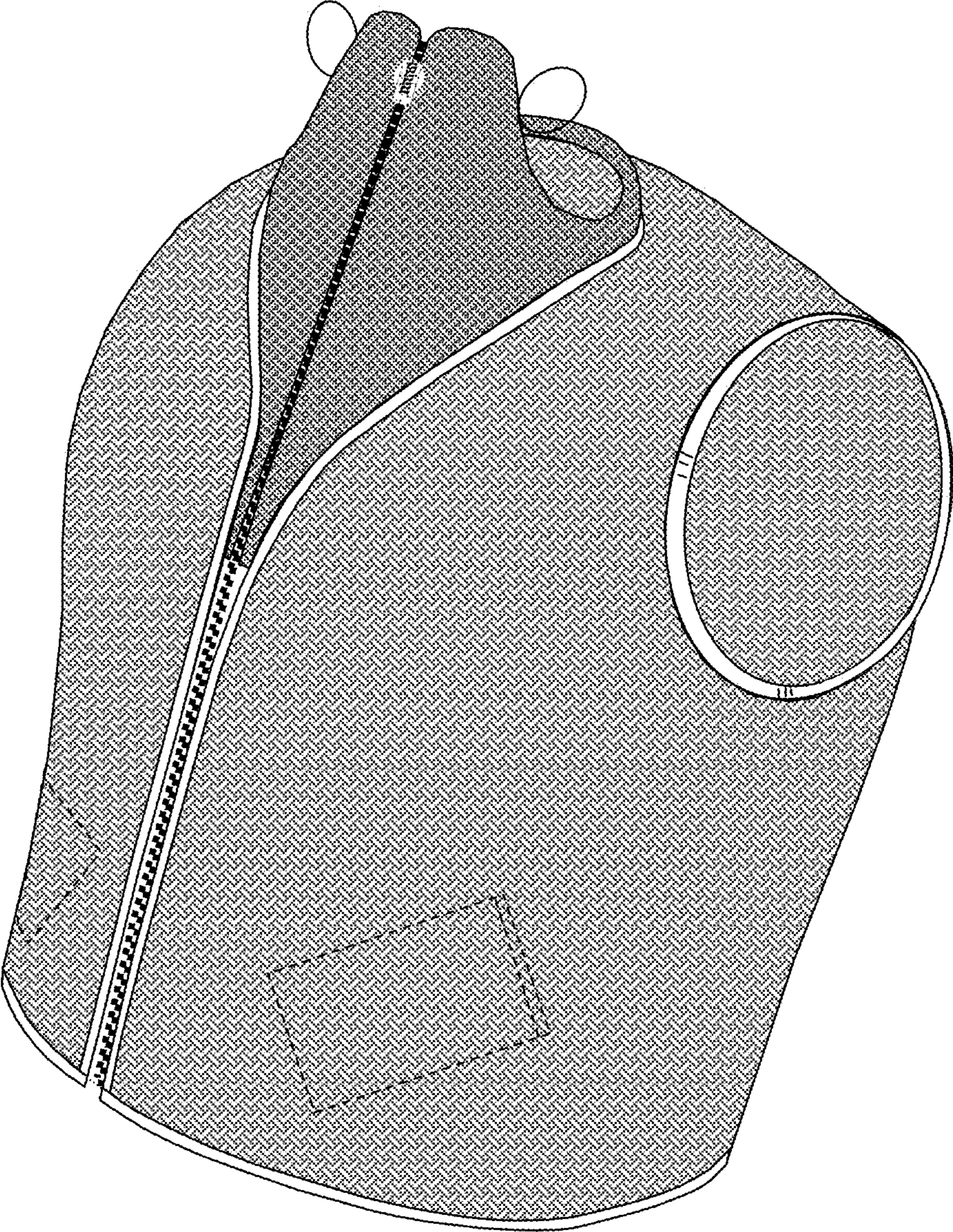

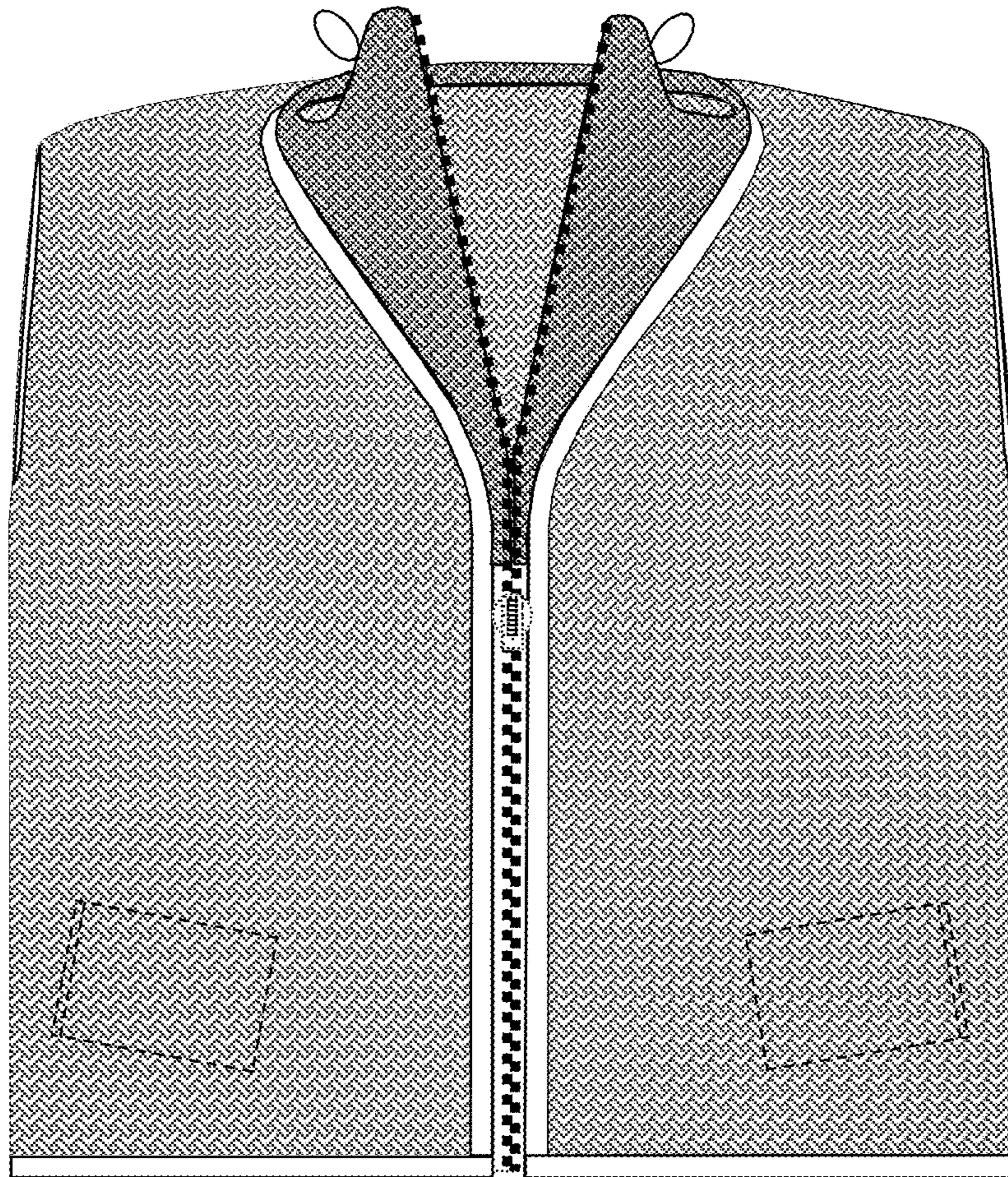

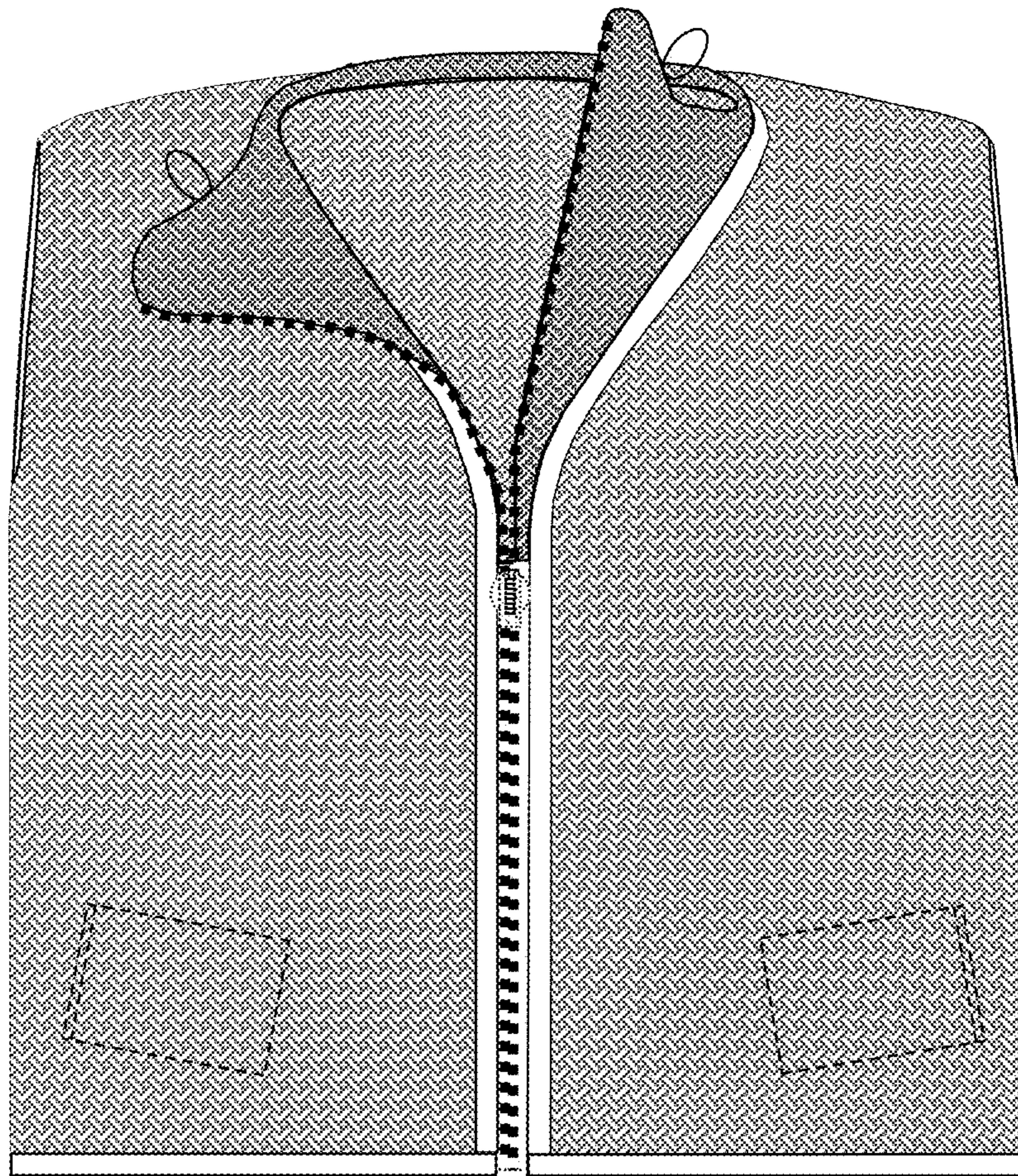

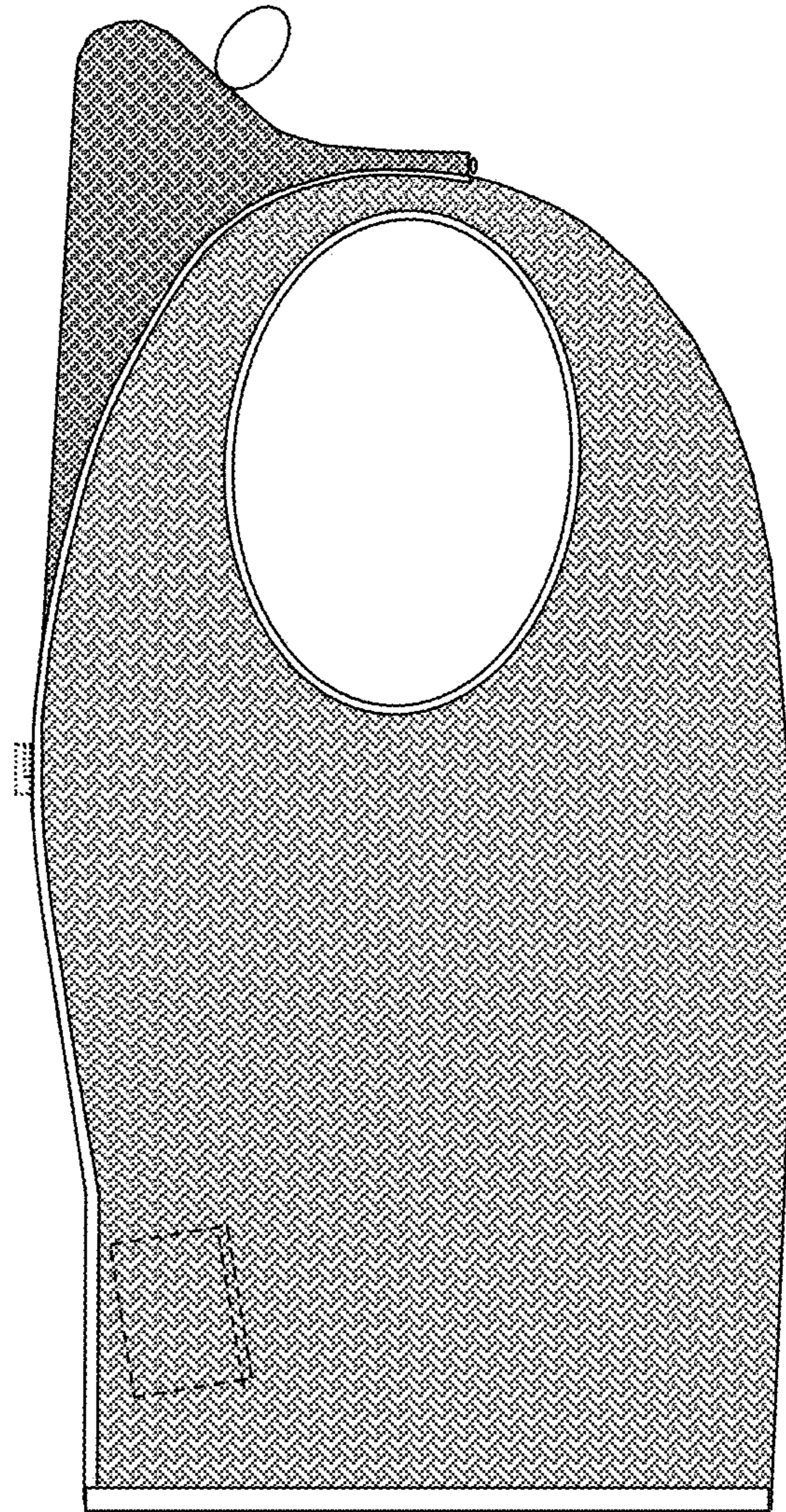

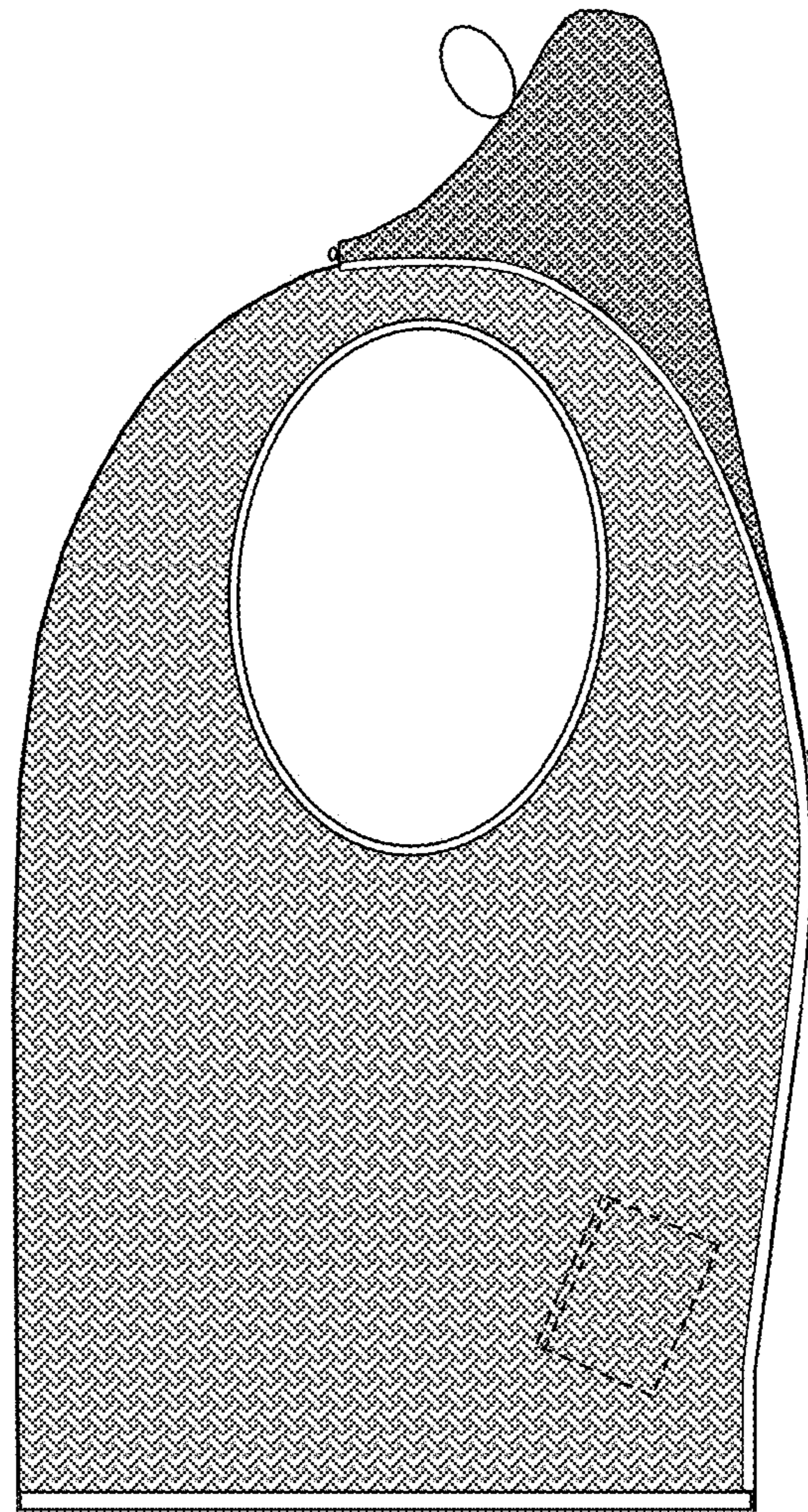

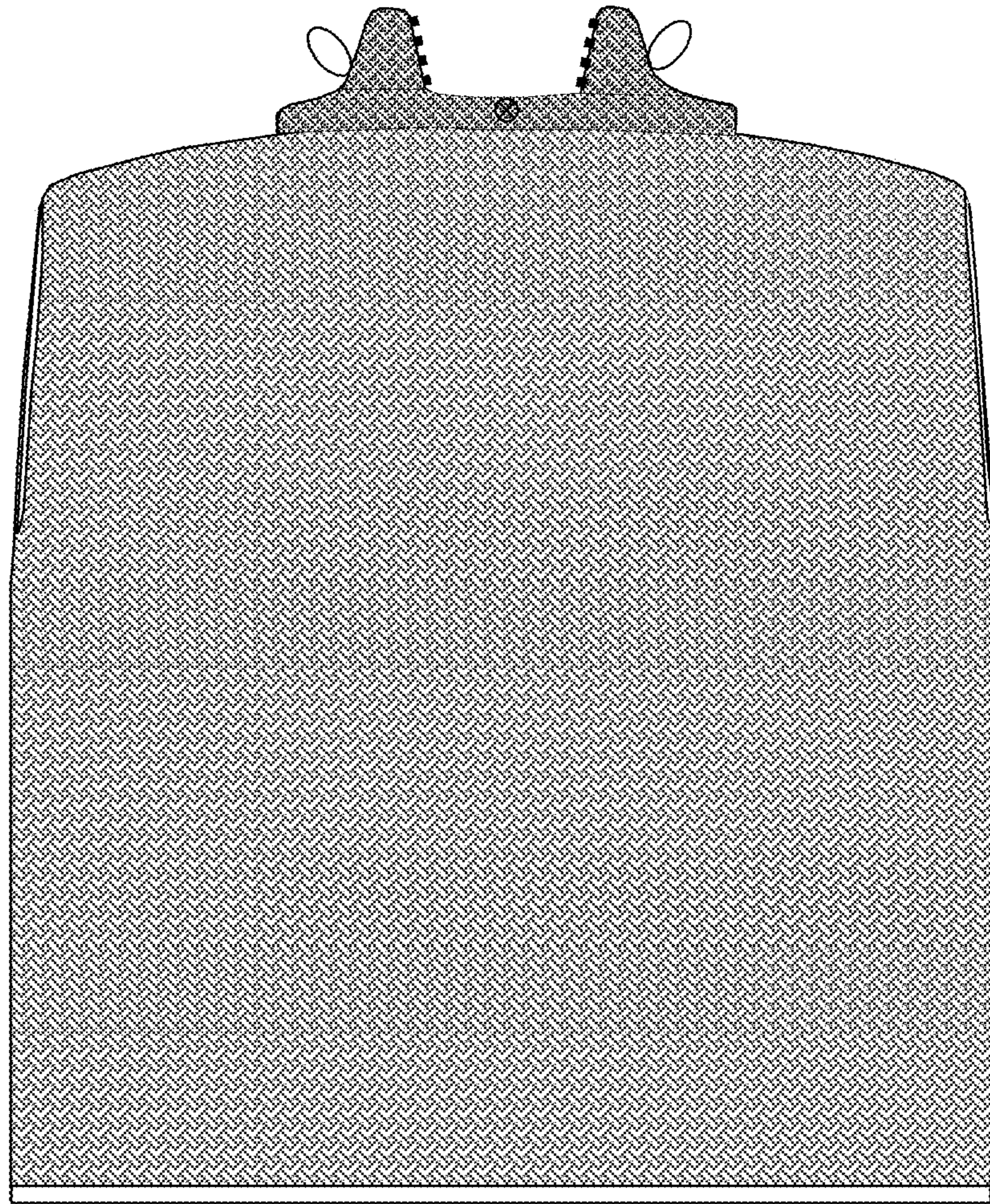

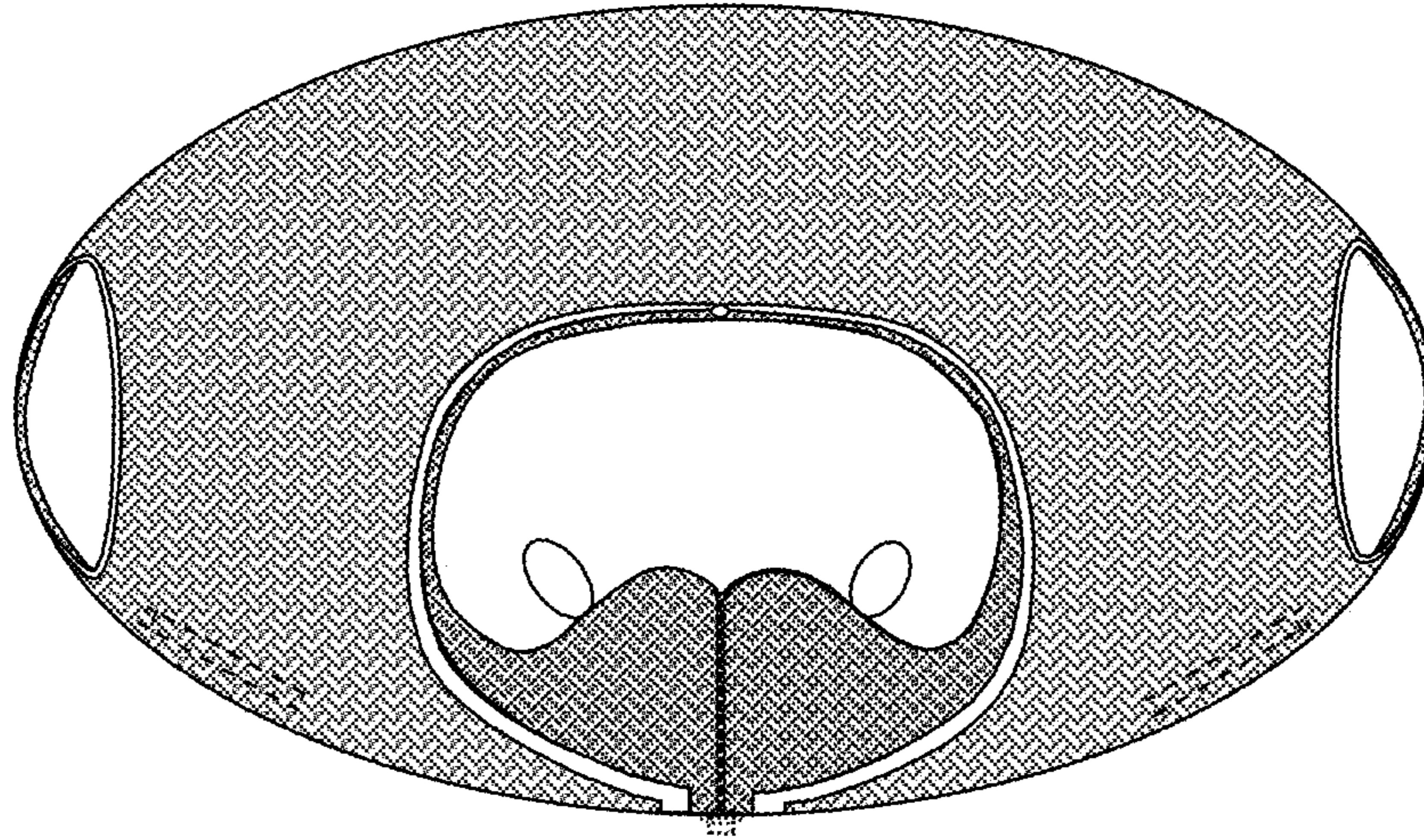

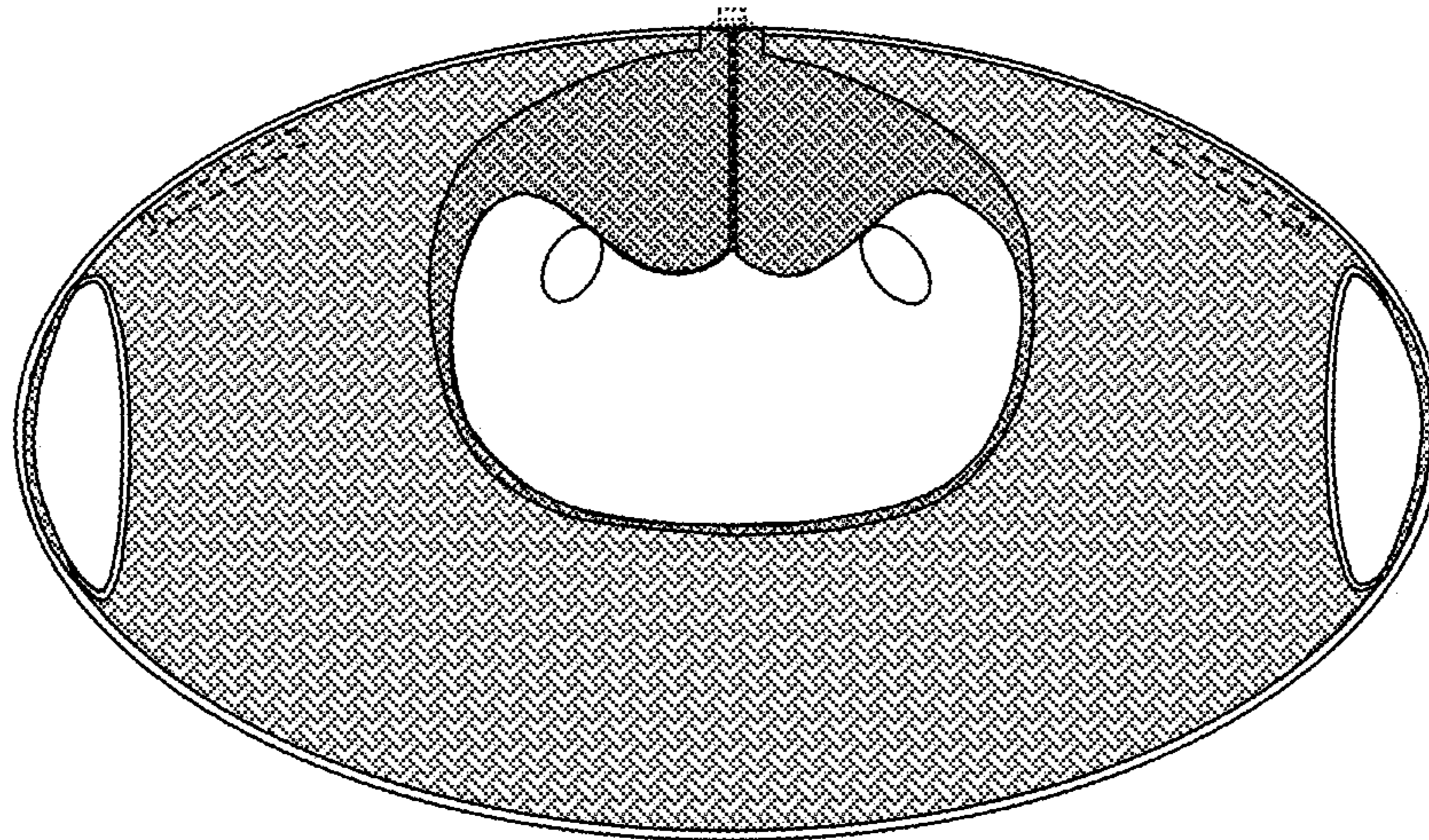
