(57) **CLAIM**

I claim the ornamental design for an adjustable head wrap, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of my new design, the adjustable head wrap, in the configuration of a circular bun; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a left side view thereof; FIG. 5 is a right-side view thereof; FIG. 6 is a top view thereof; FIG. 7 is a bottom view thereof; FIG. 8 is a front perspective view of the adjustable head wrap turned inside out in the configuration of a circular bun; FIG. 9 is a front perspective view of the adjustable head wrap turned inside out in the configuration of a floral bun; and, FIG. 10 is a front perspective view of the adjustable head wrap with components separated.

The applied shading and stippling techniques do not depict any type of surface material of the claimed design. The broken lines that run parallel with the opening of the adjustable head wrap depict claimed stitching. The unshaded interior surface of the adjustable head wrap depicts portions of the adjustable head wrap that form no part of the claimed design.

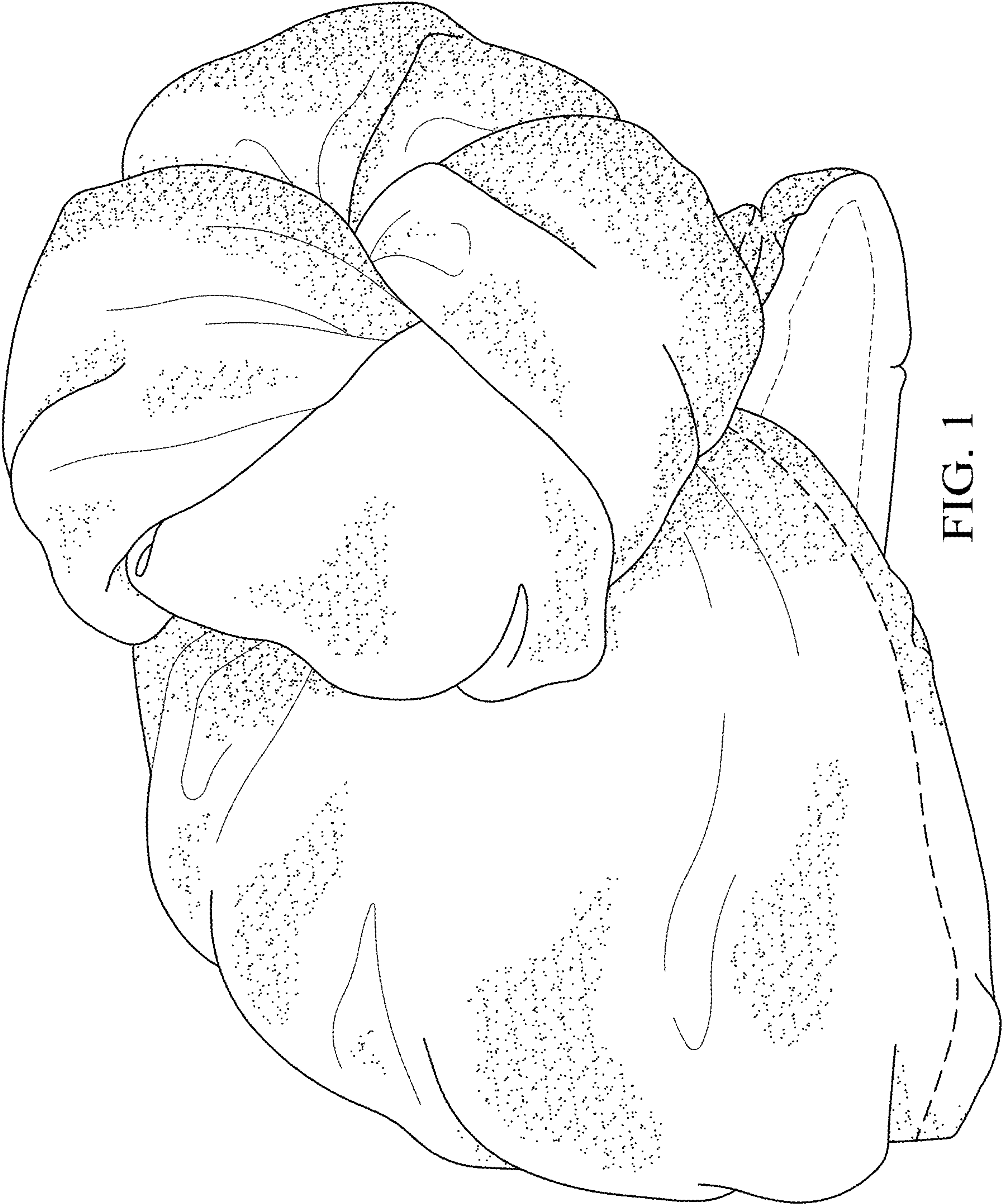

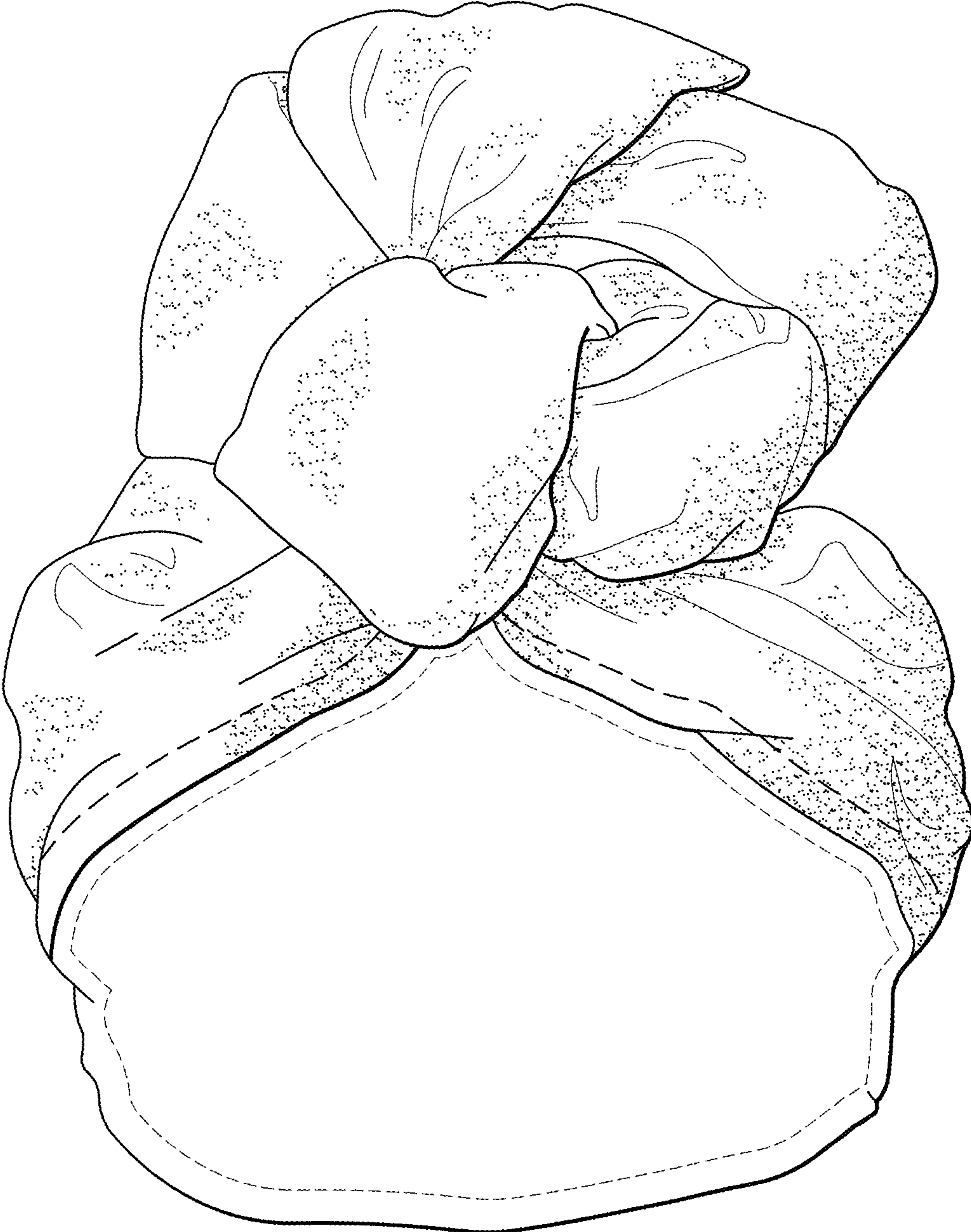

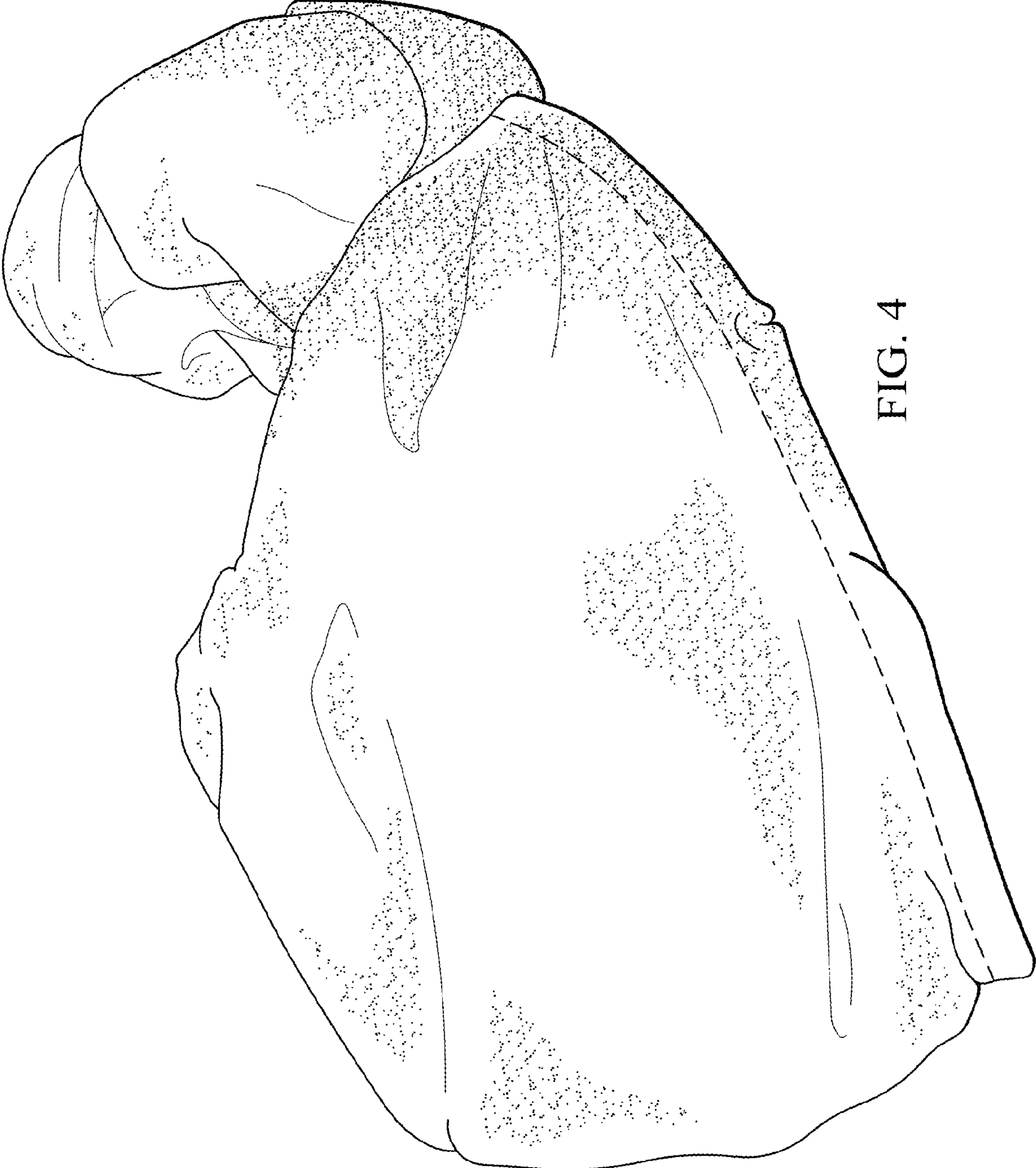

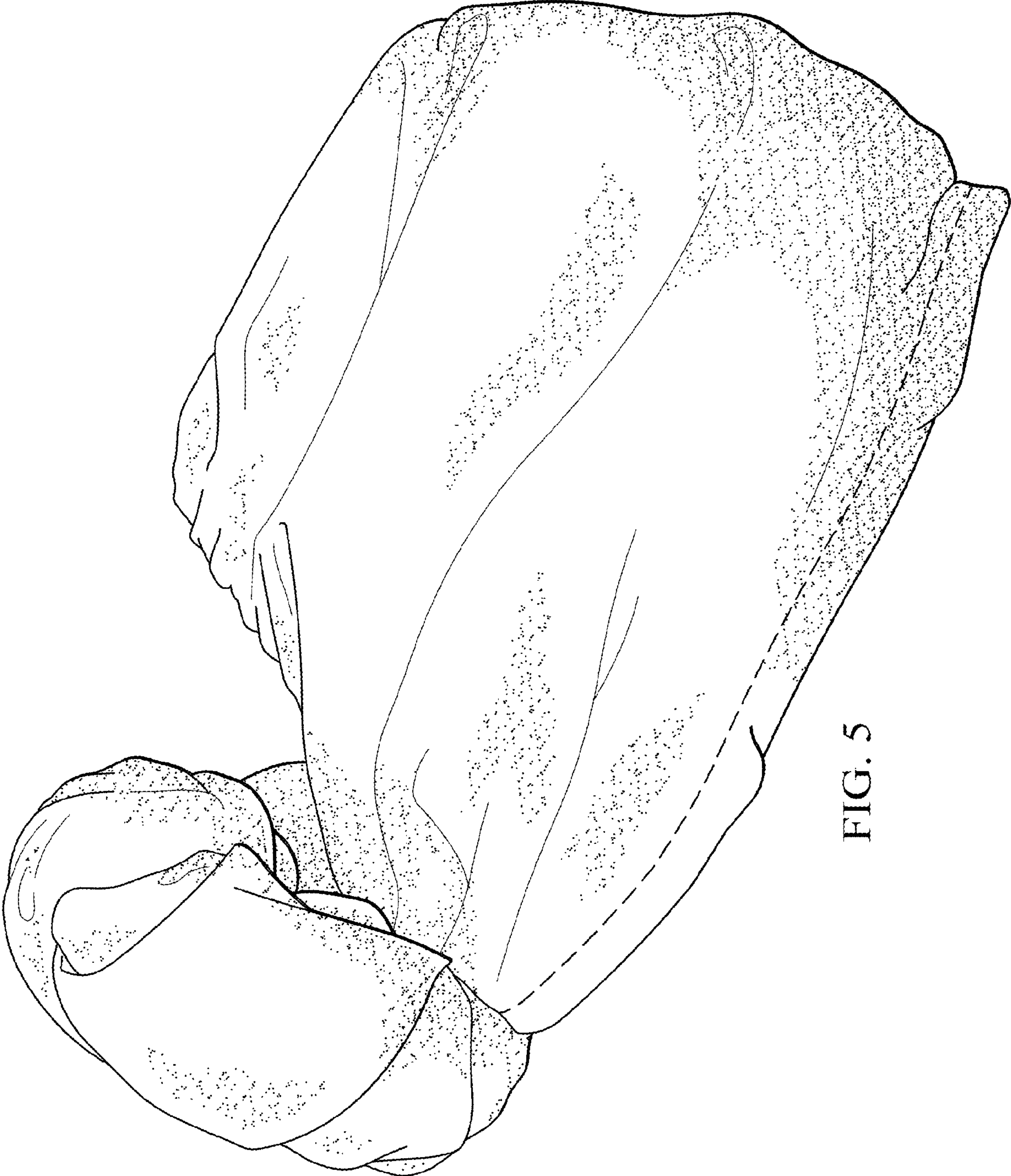

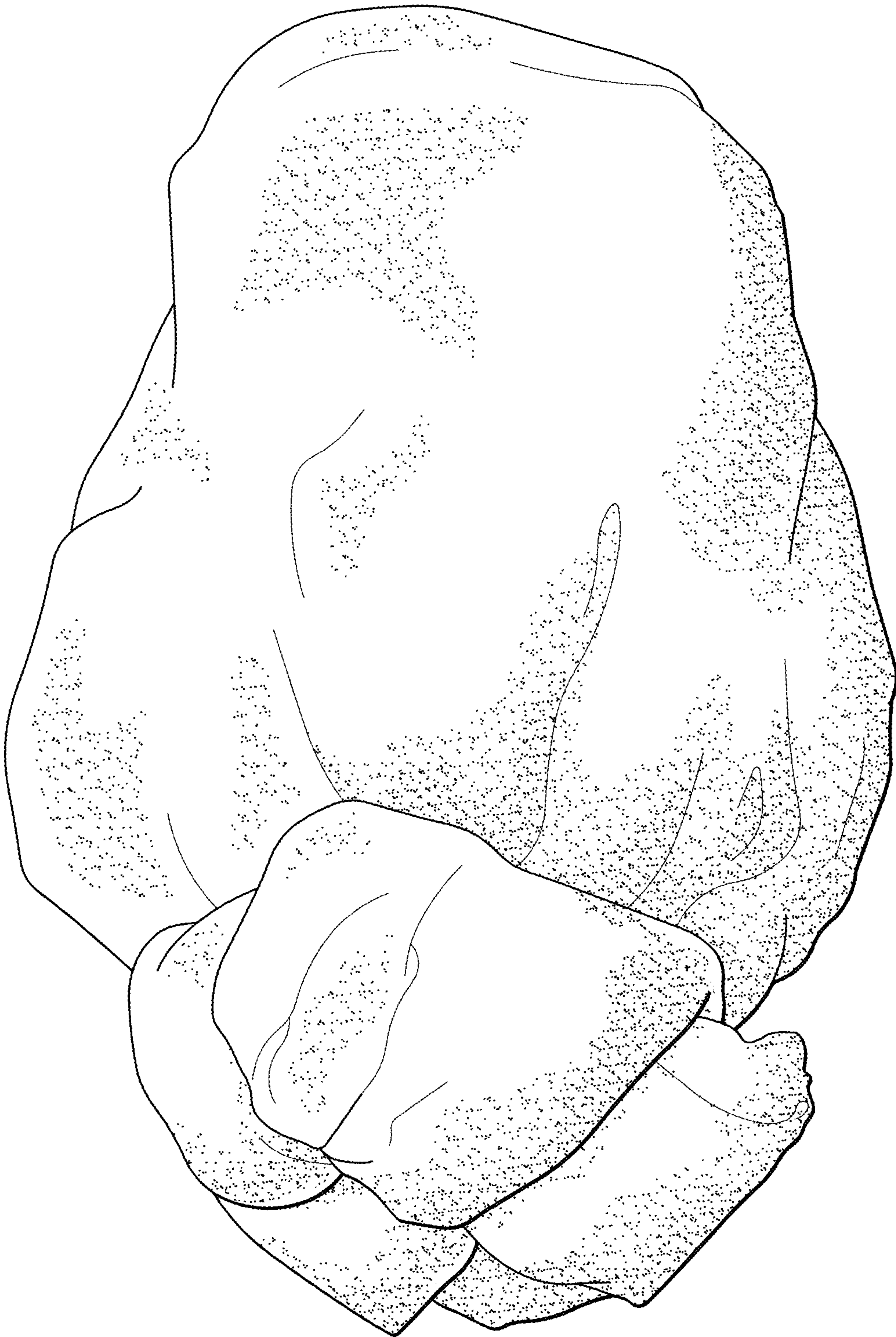

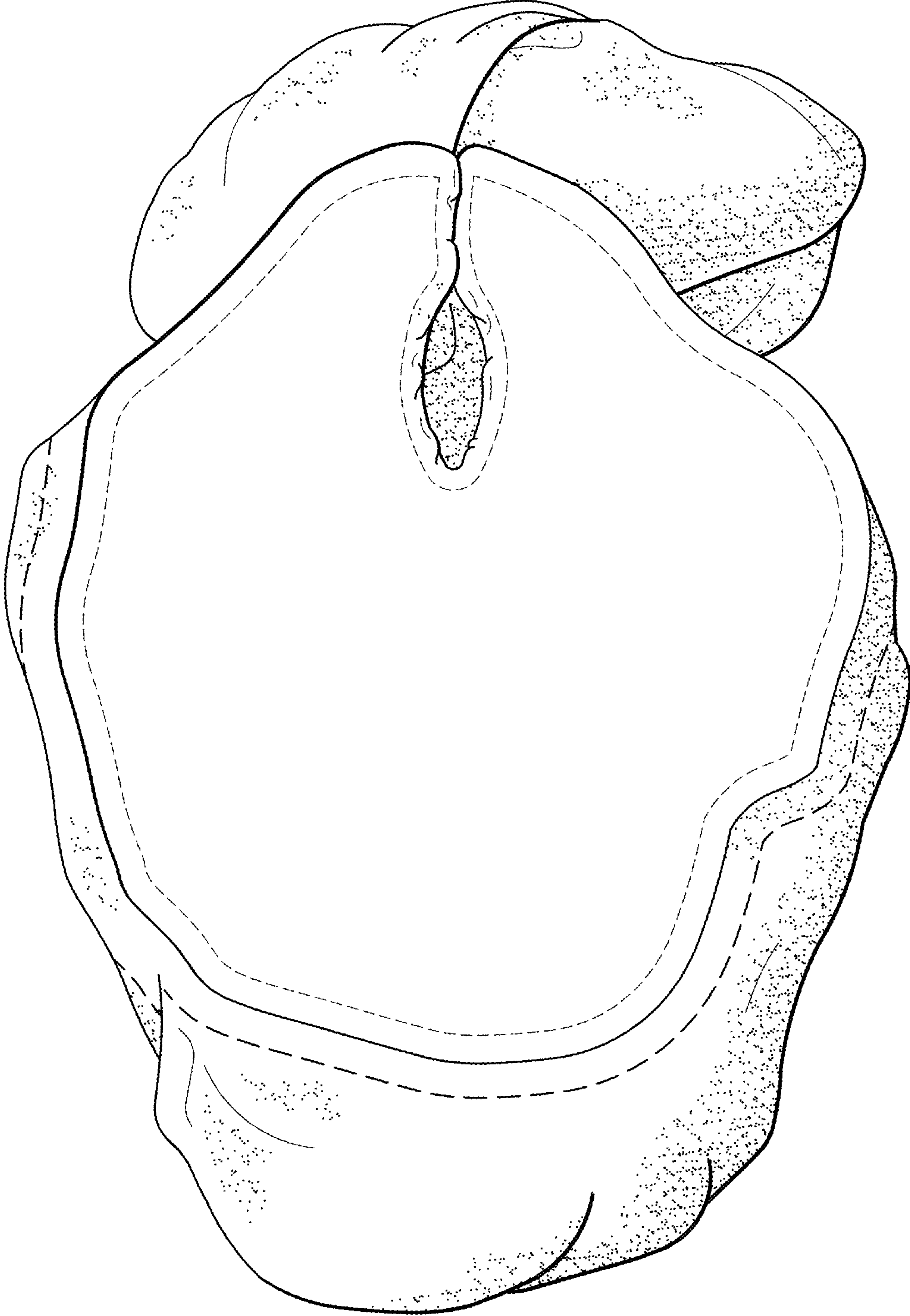

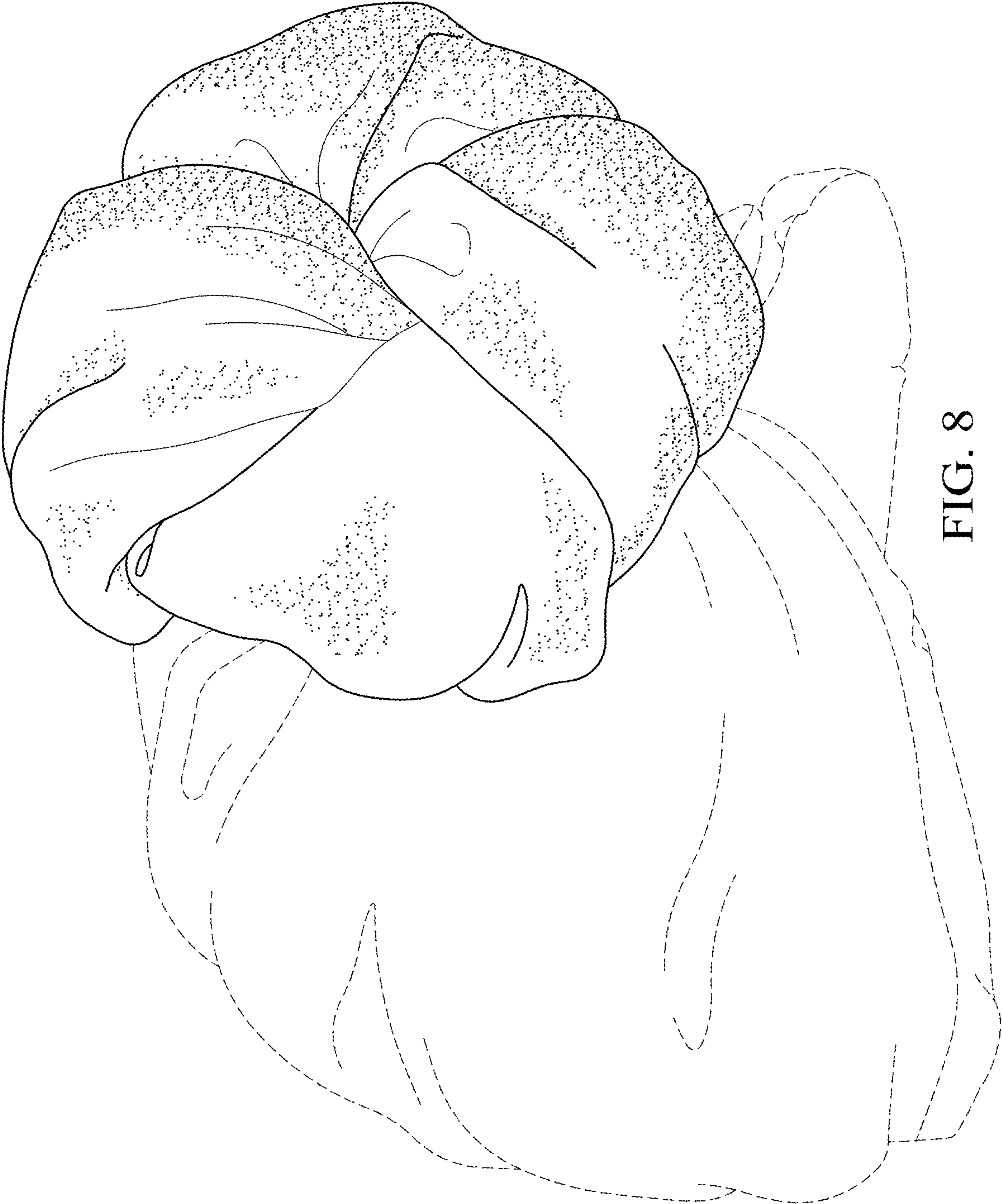

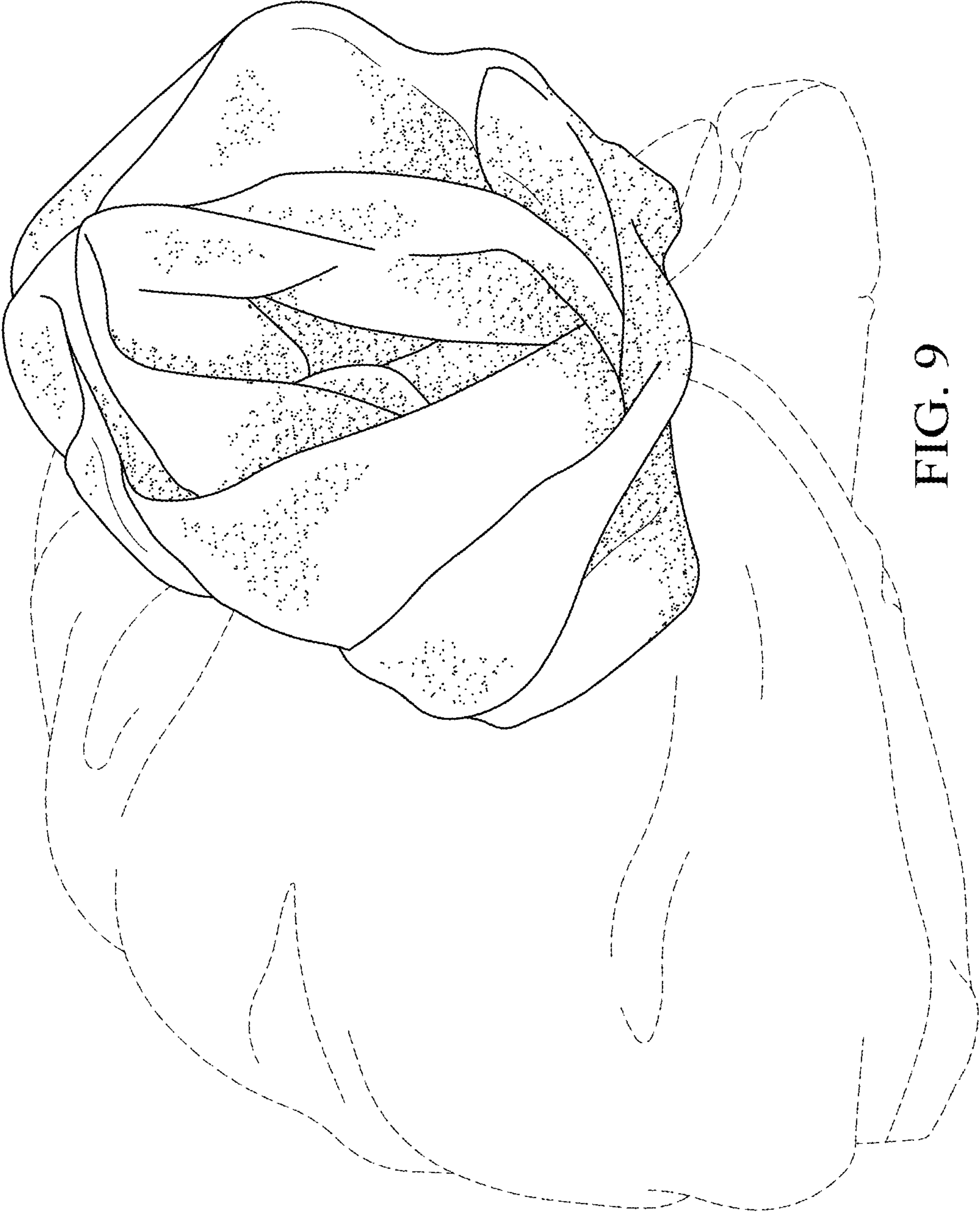

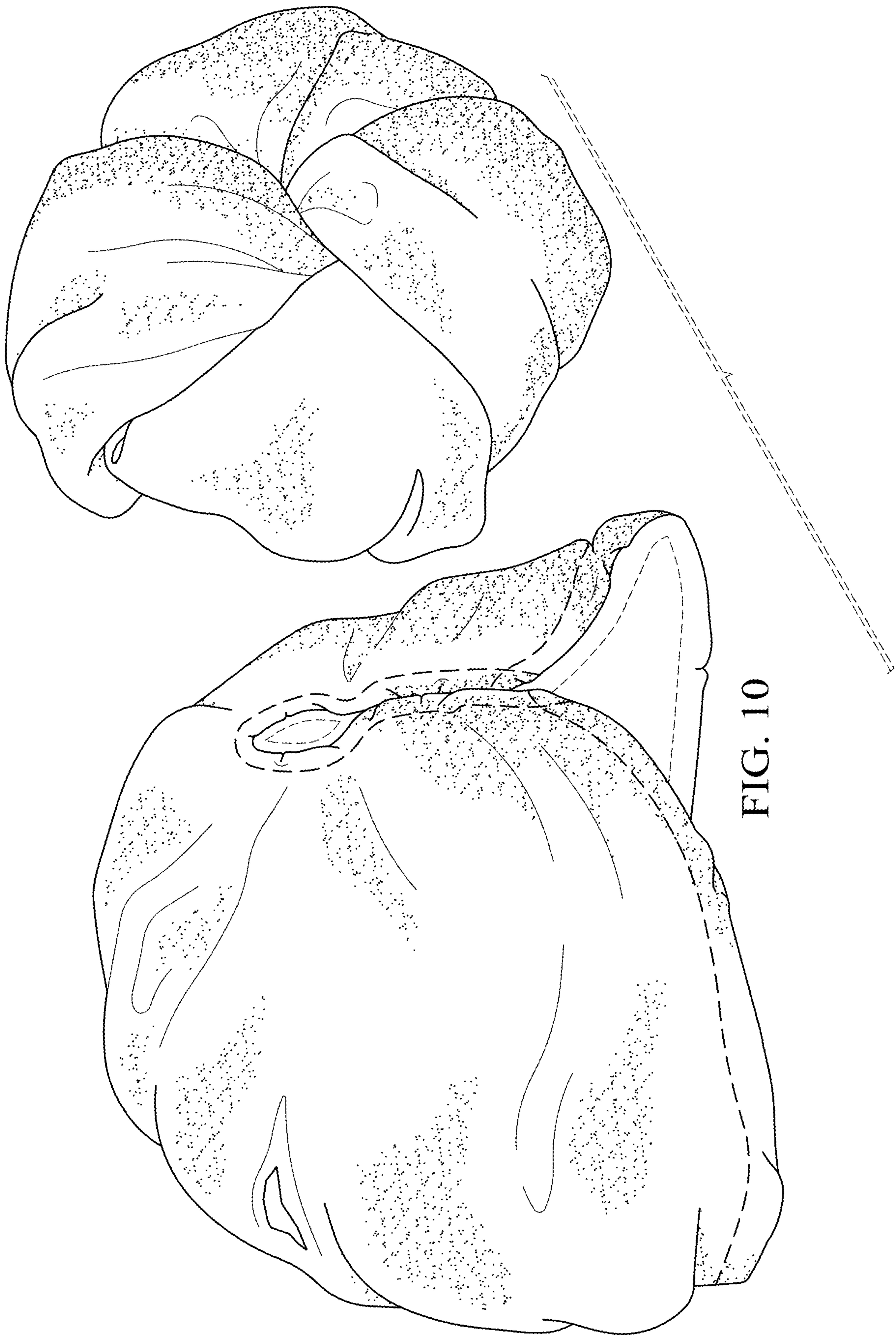
