DESCRIPTION

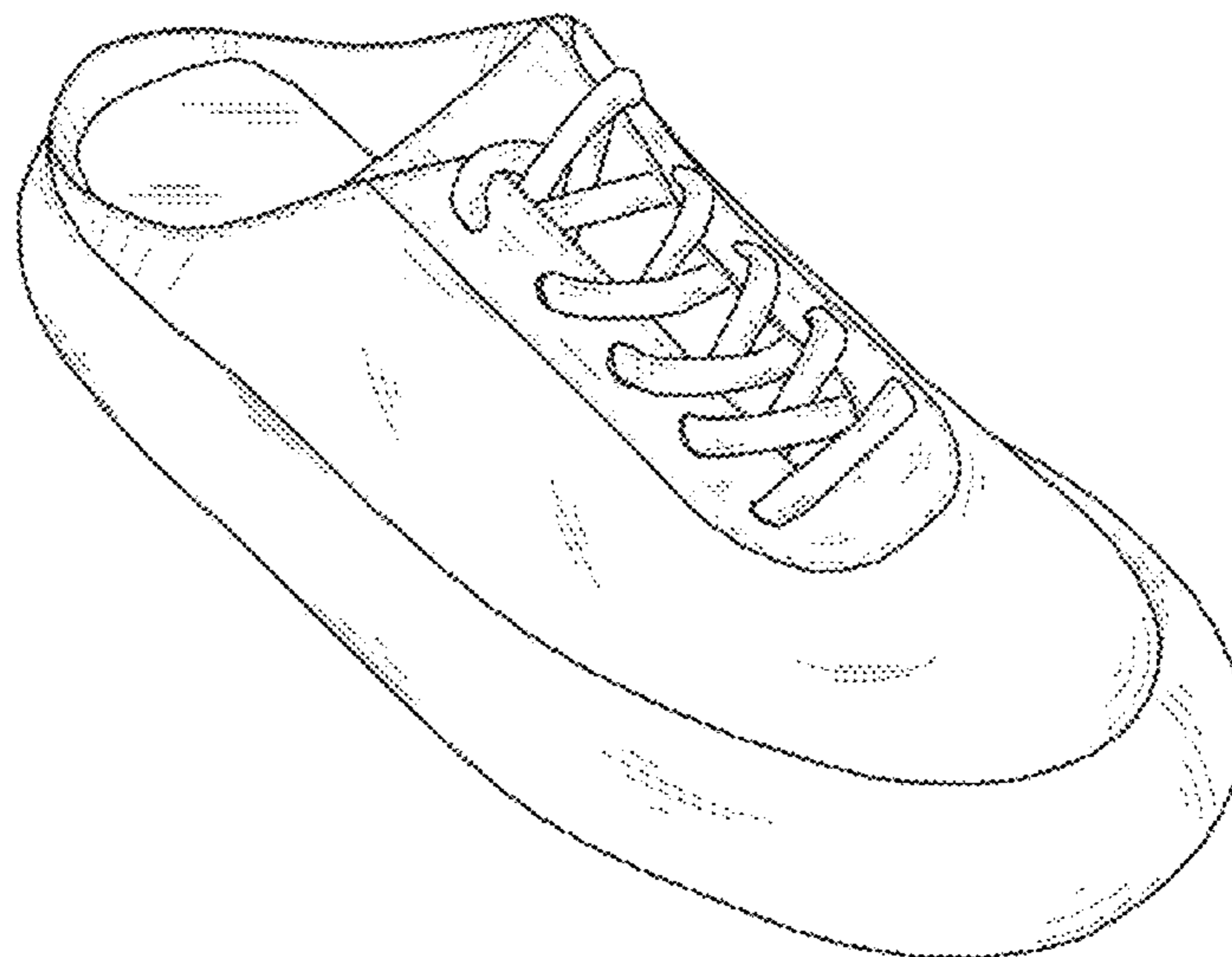

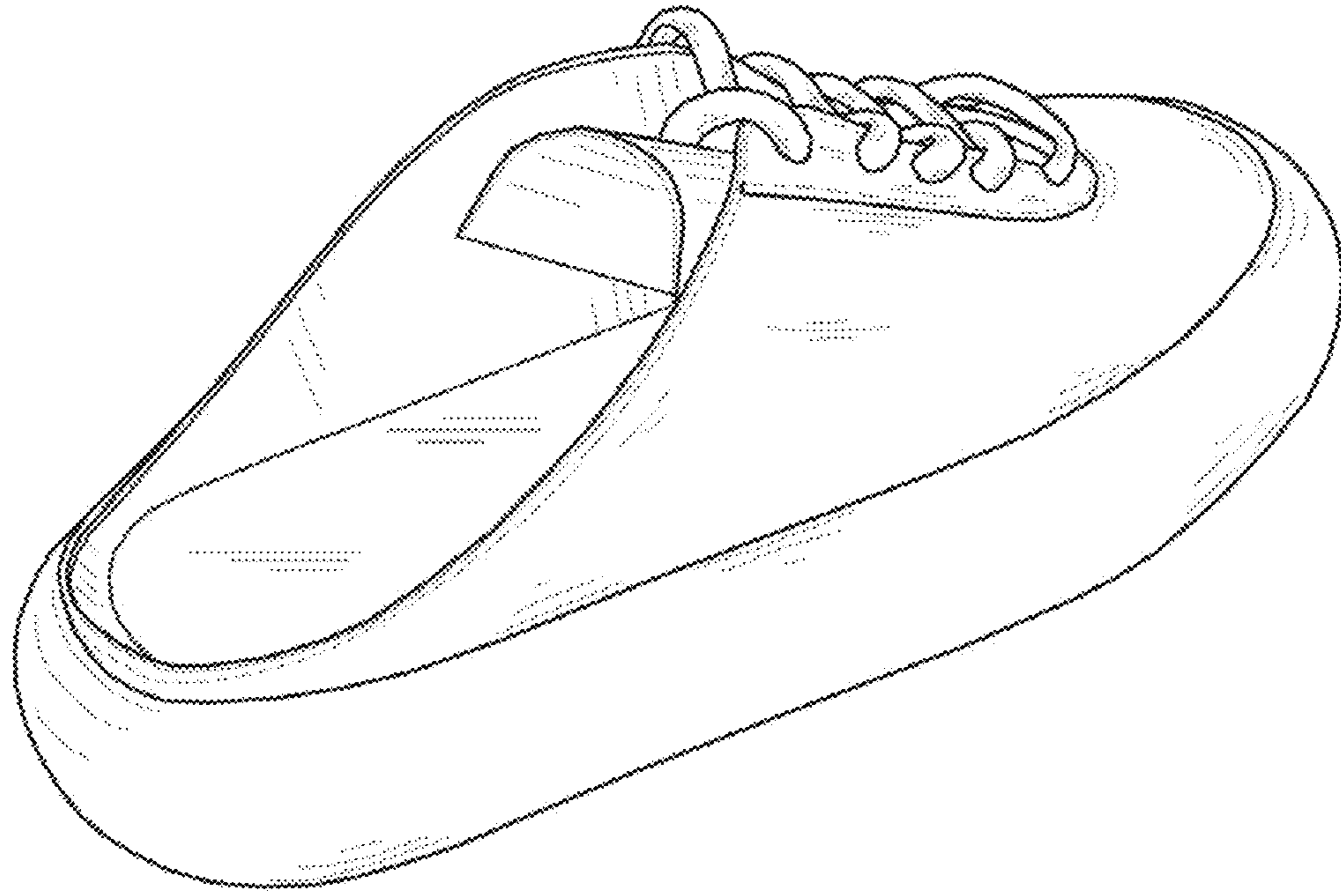

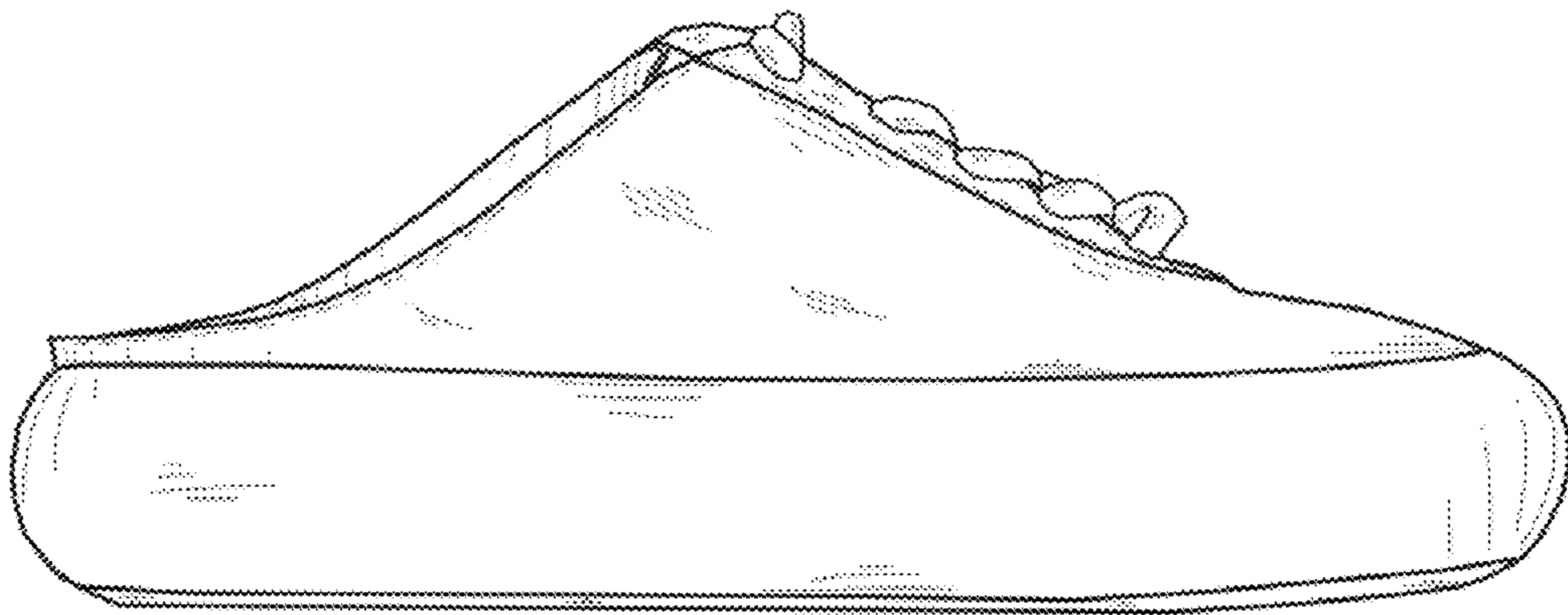

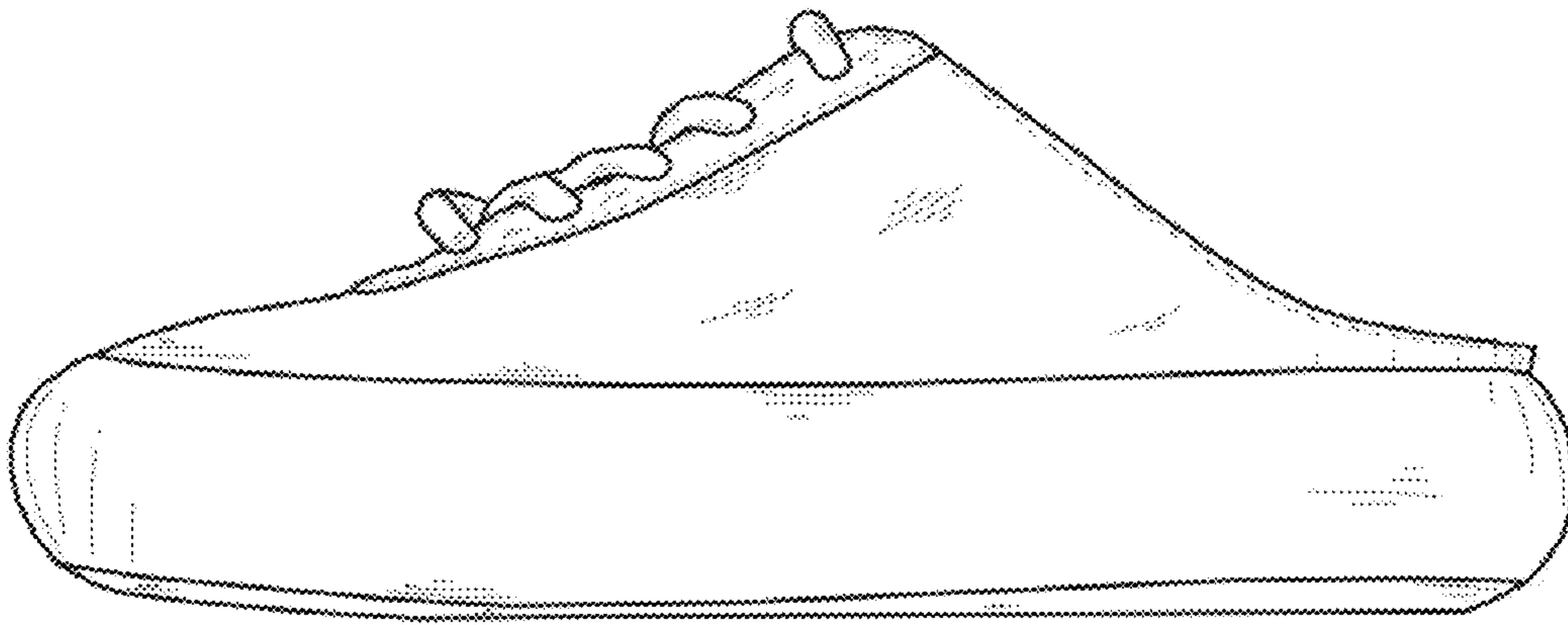

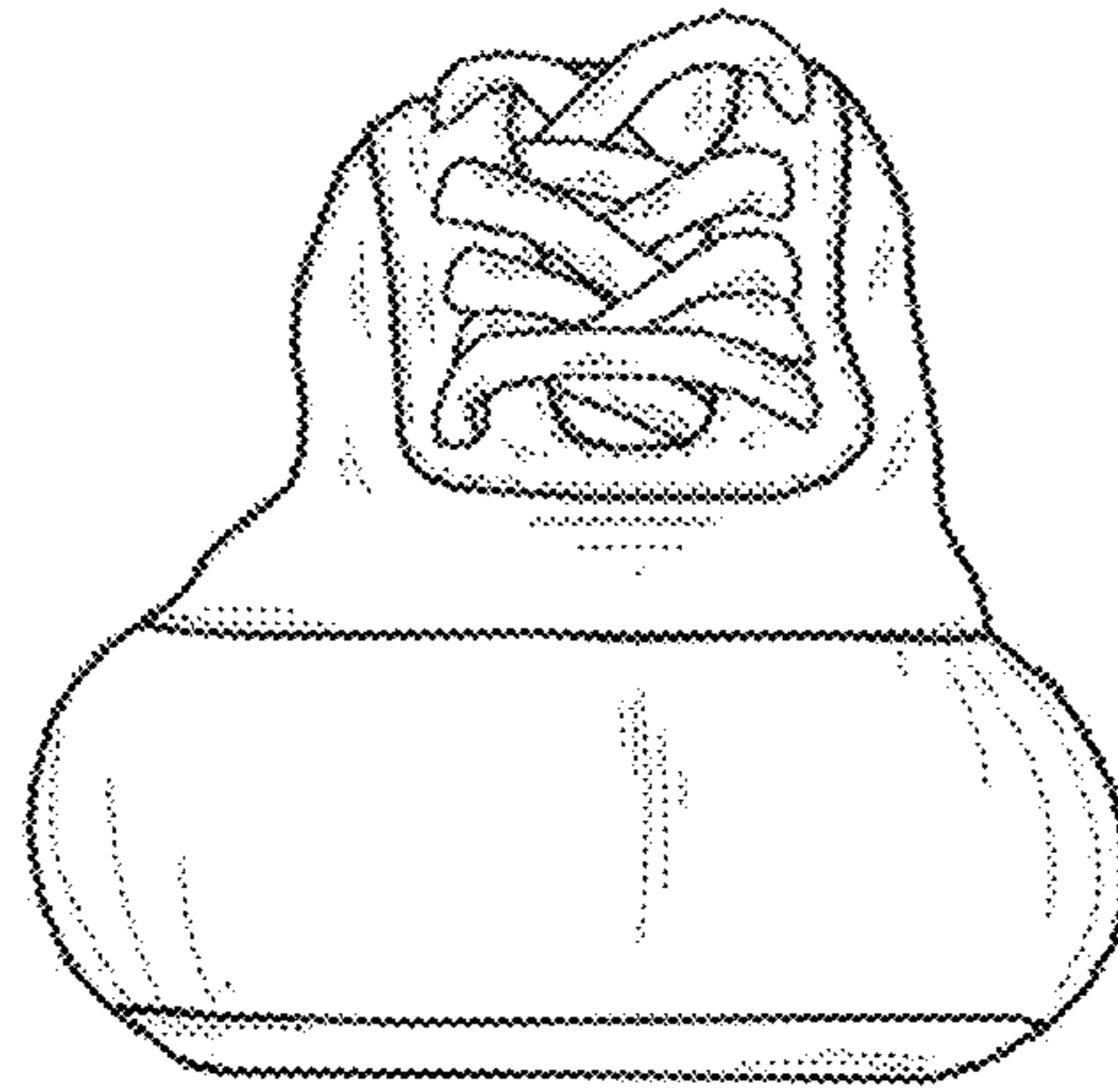

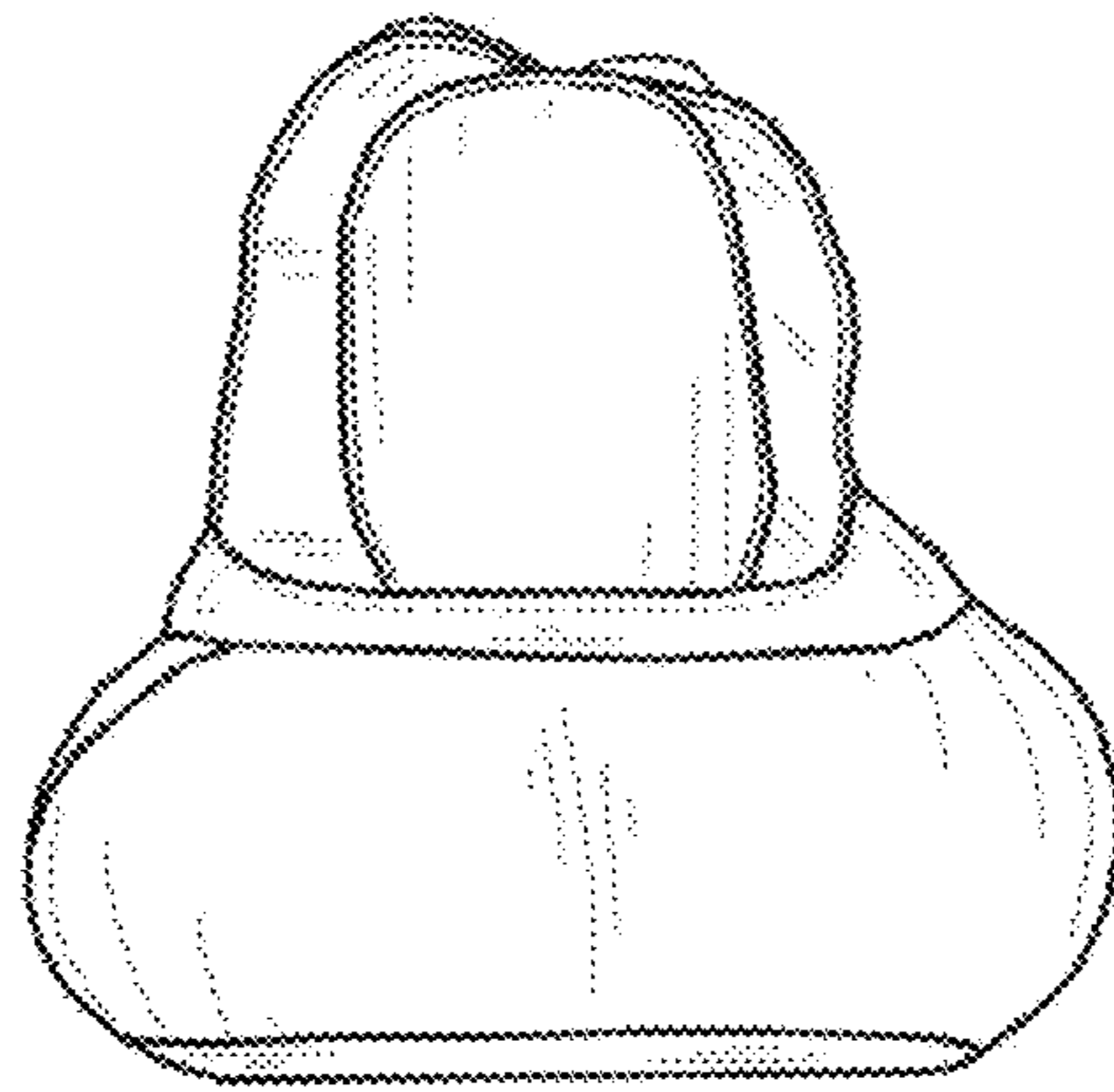

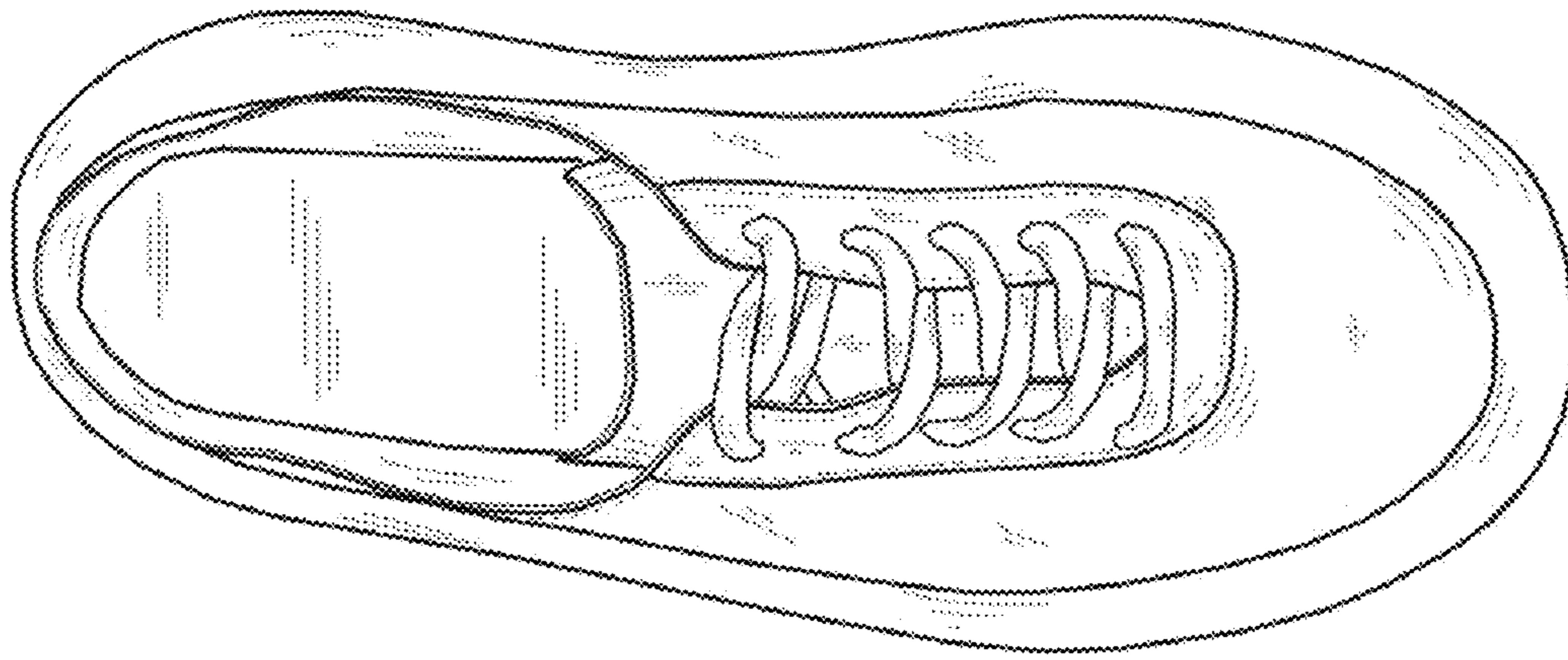
