DESCRIPTION

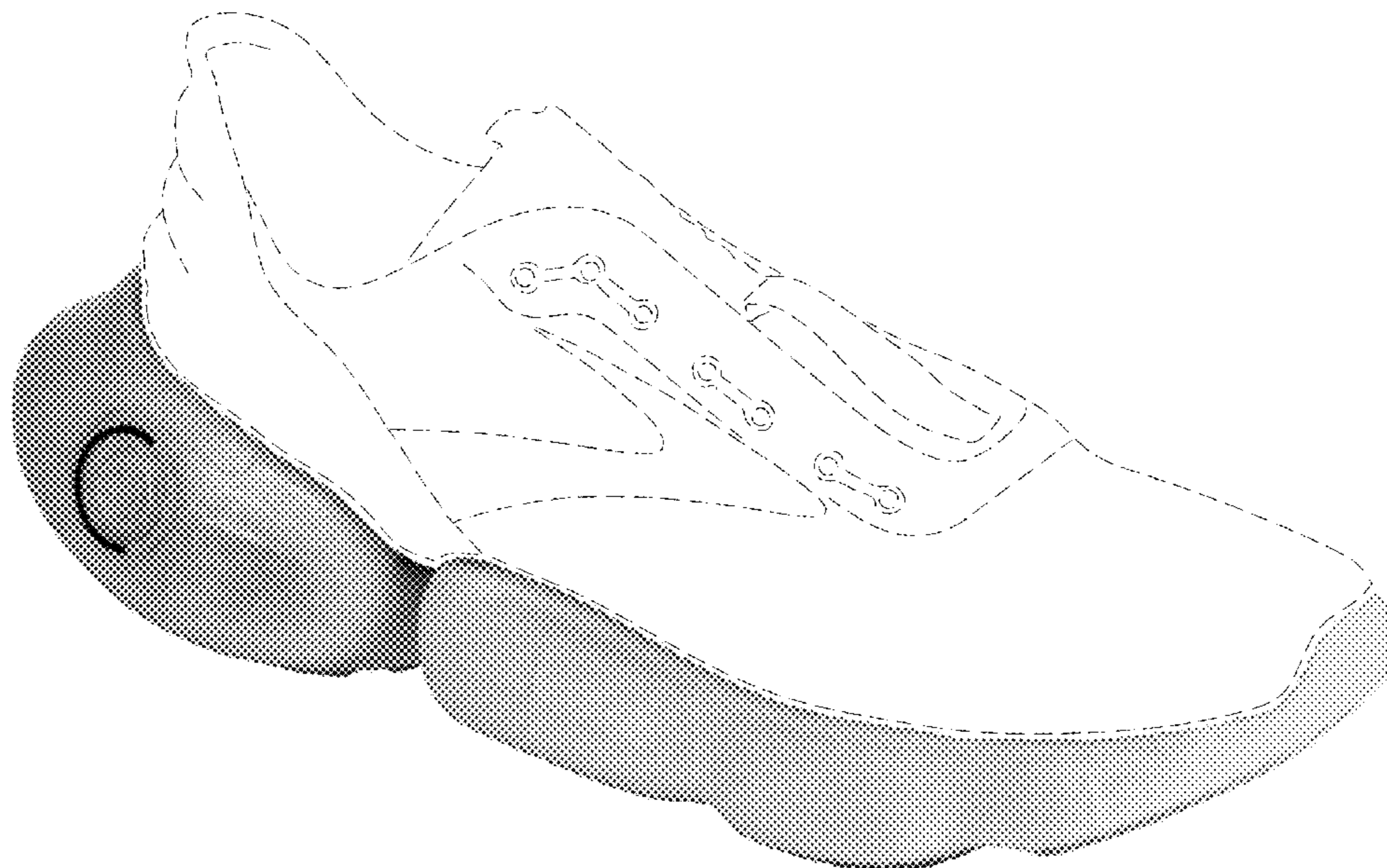
FIG. 1 is a perspective view of a shoe sole, showing my new design;

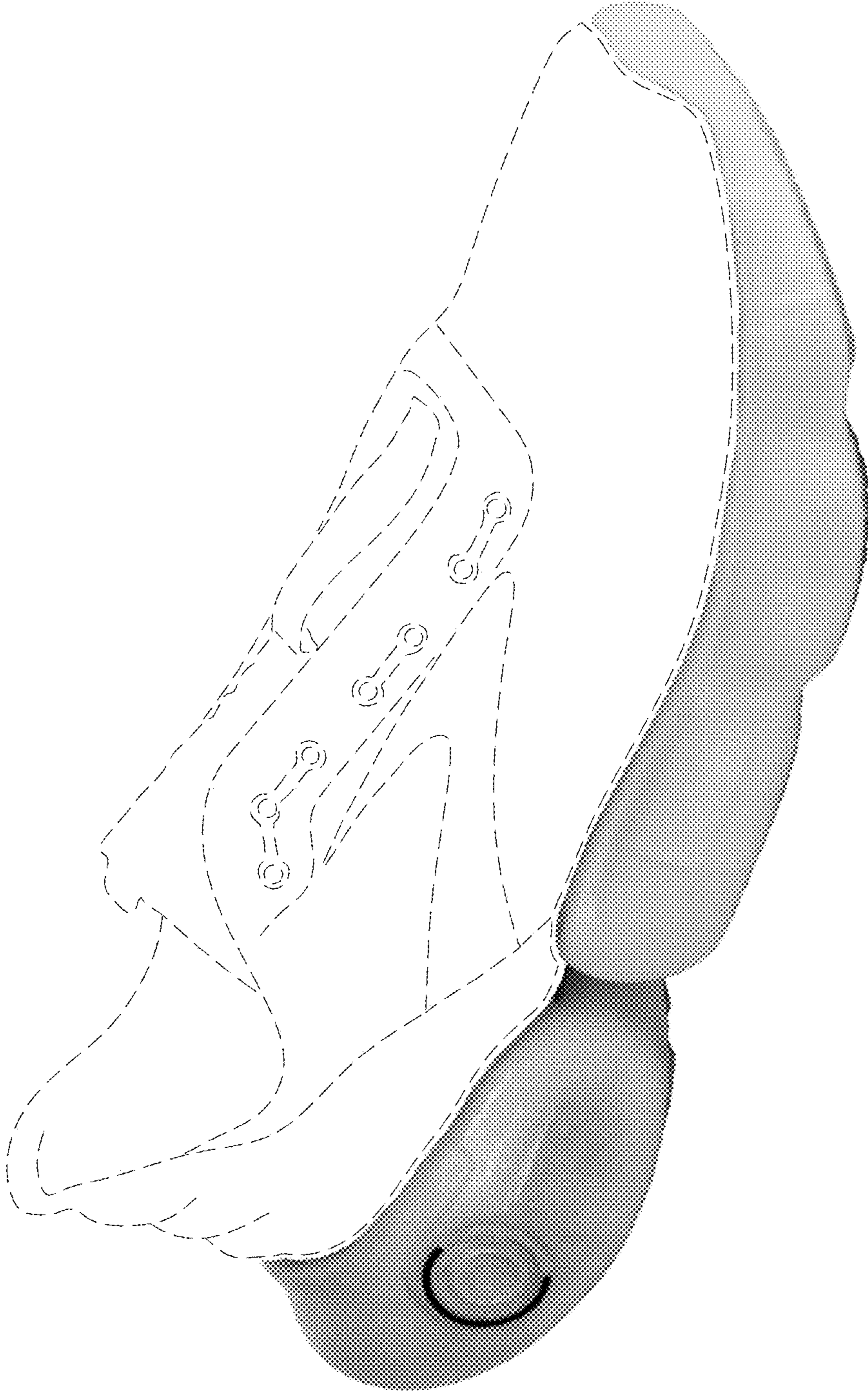

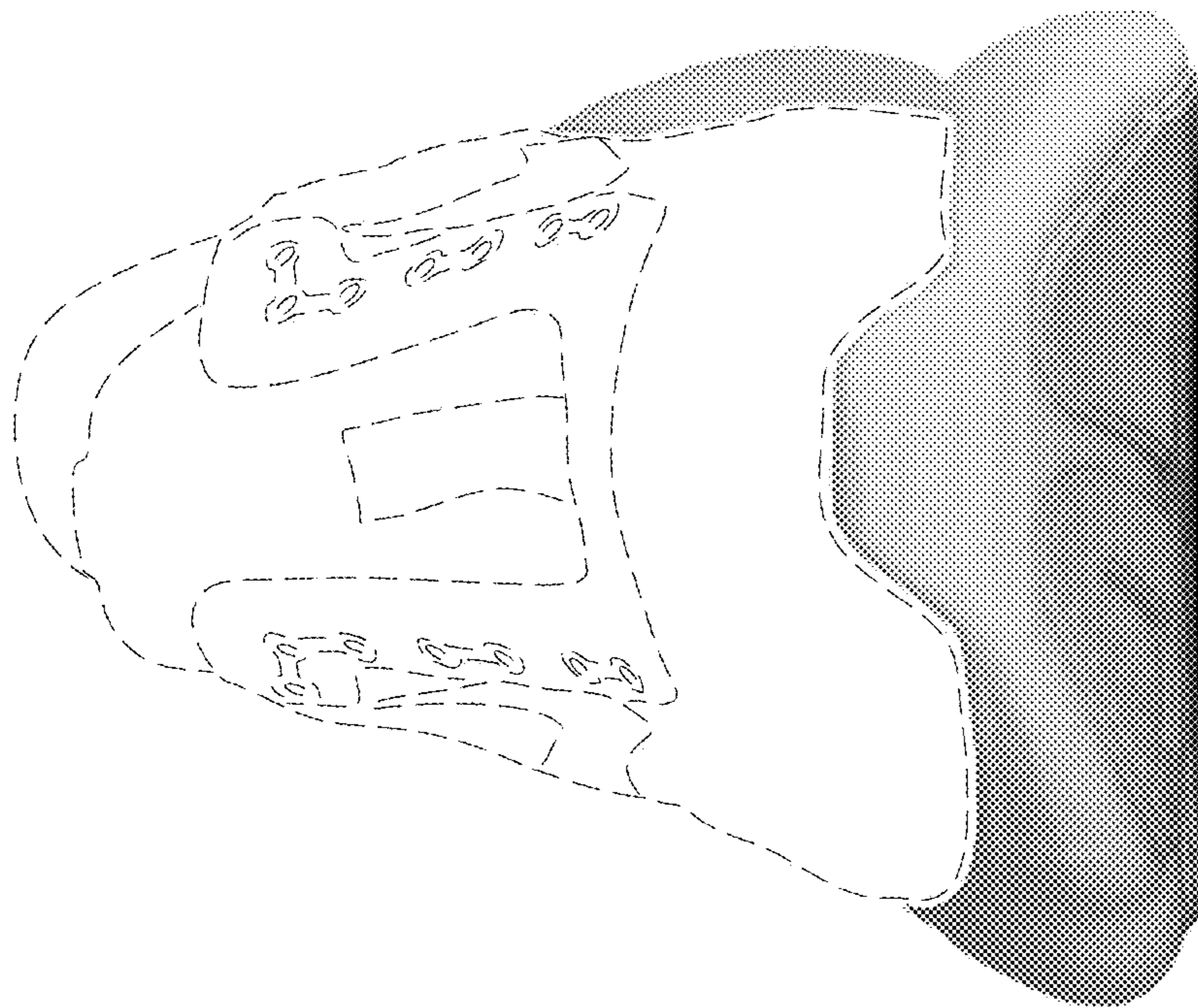

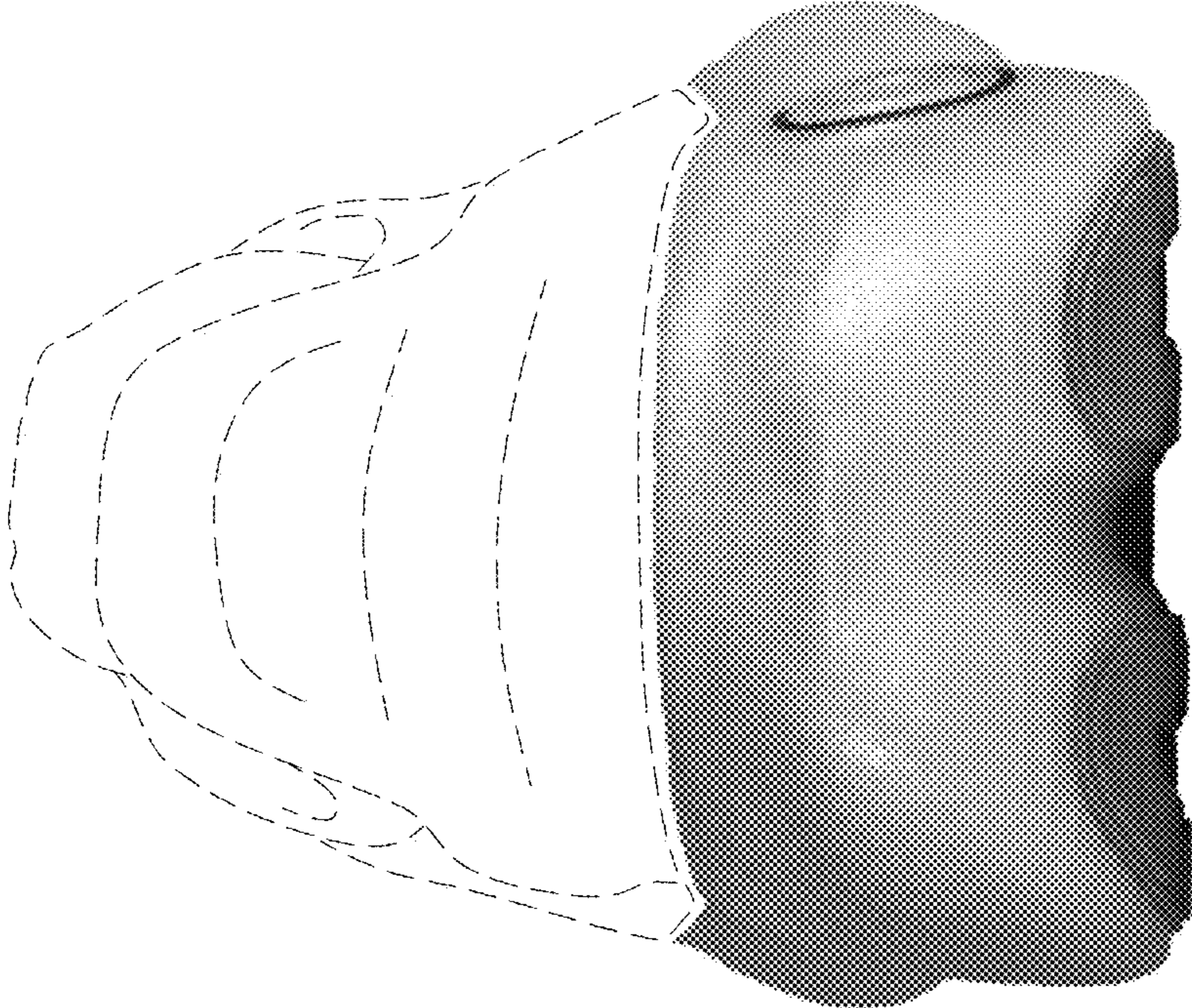

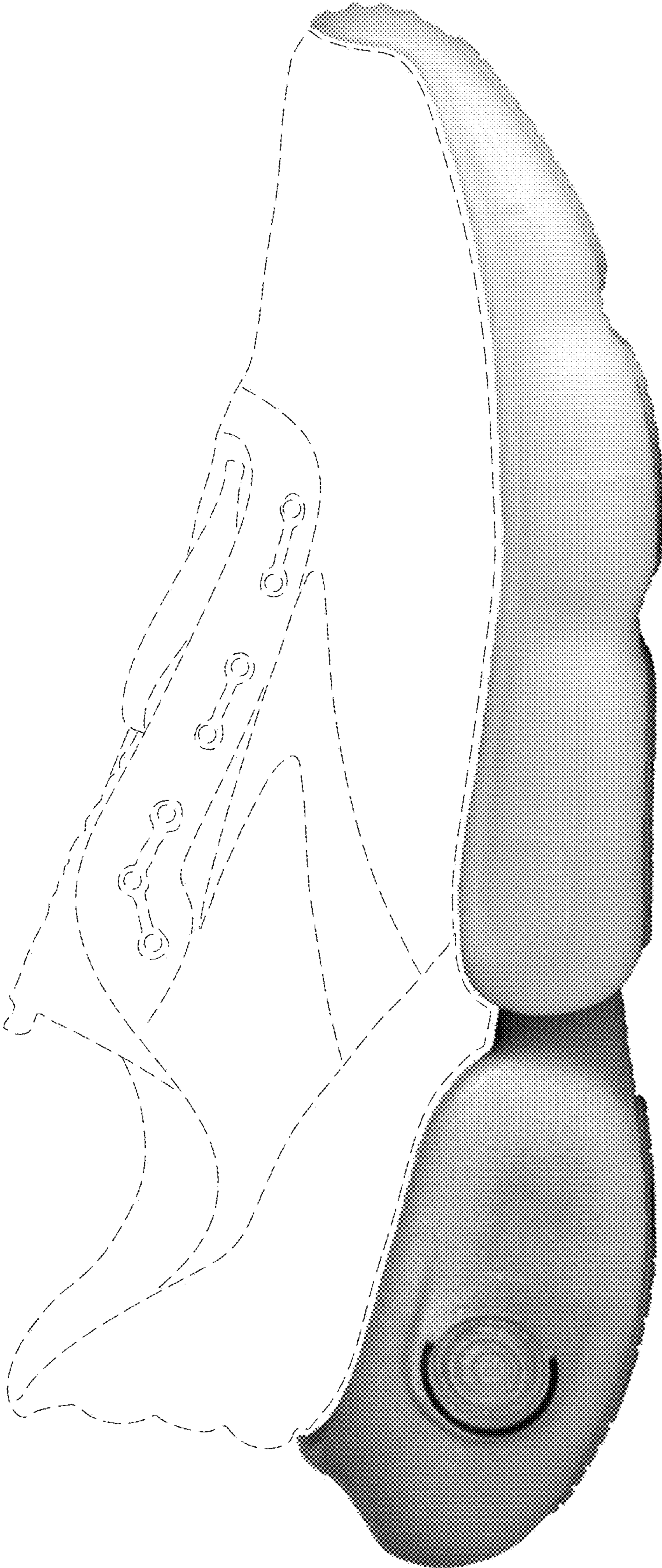

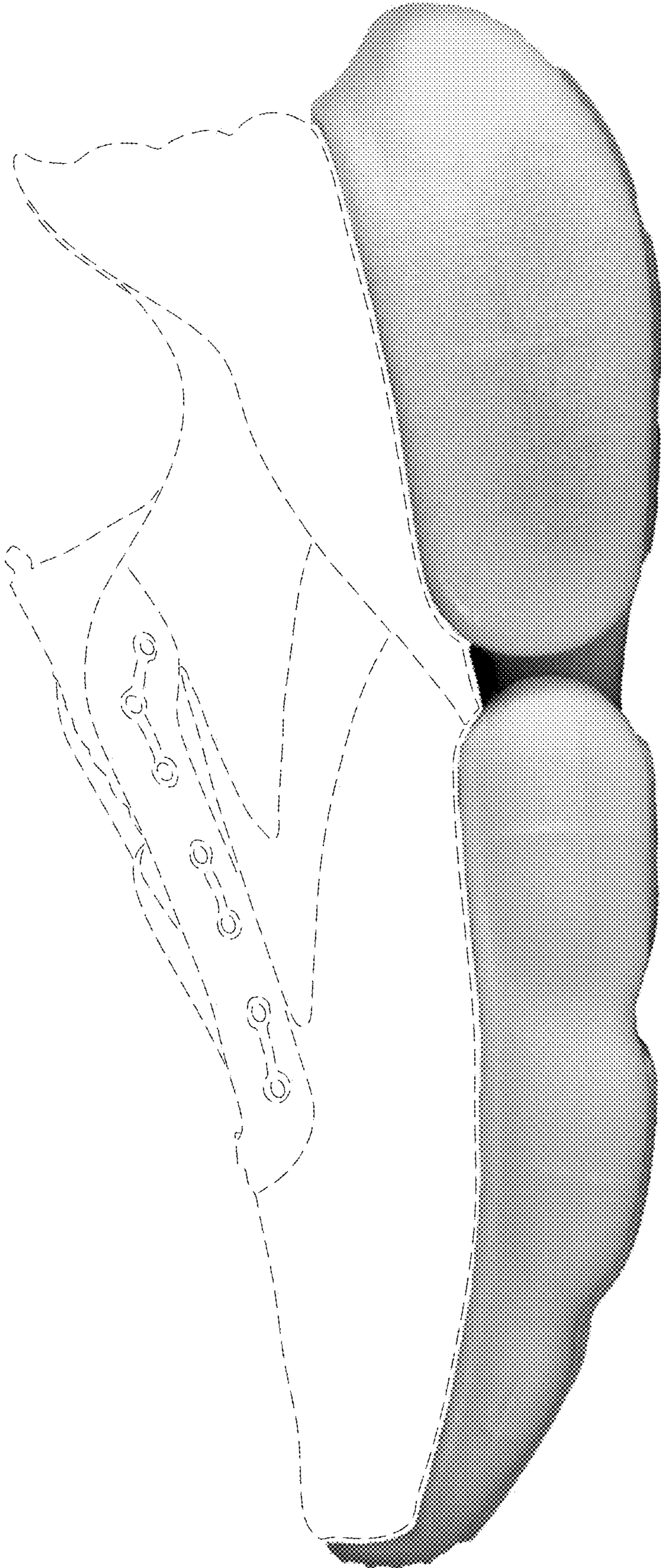

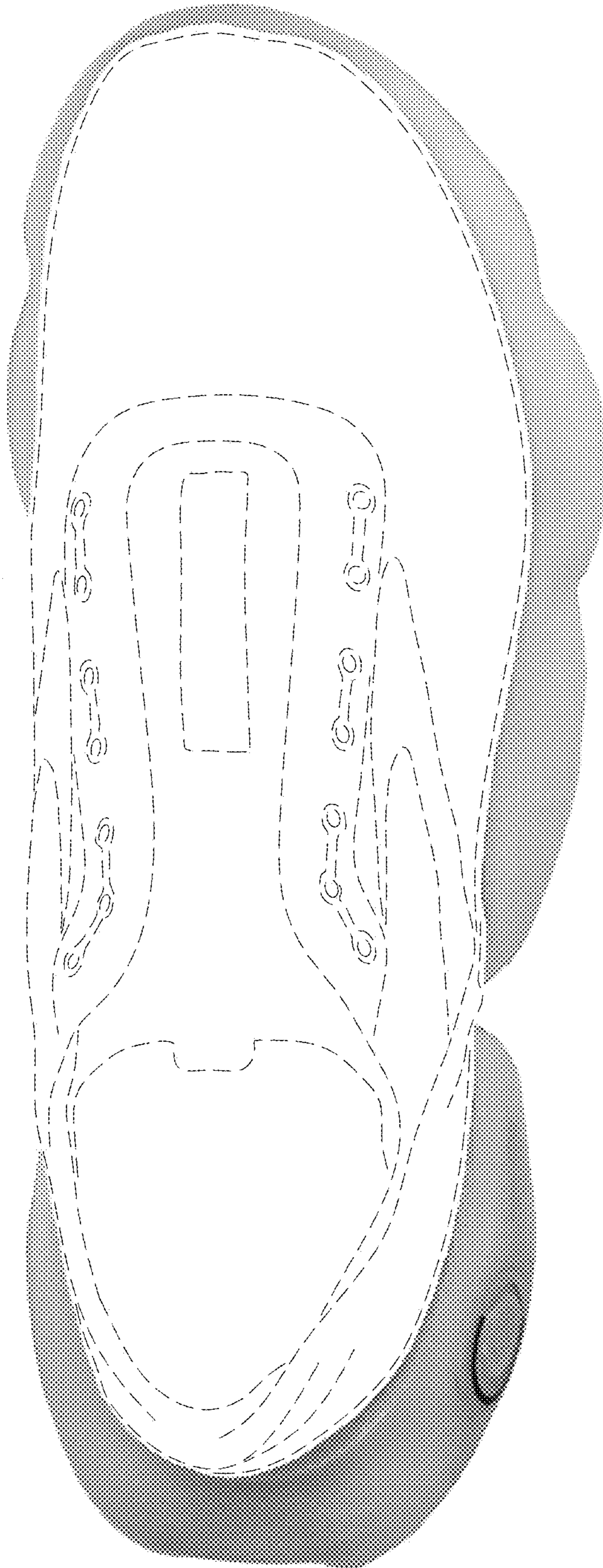

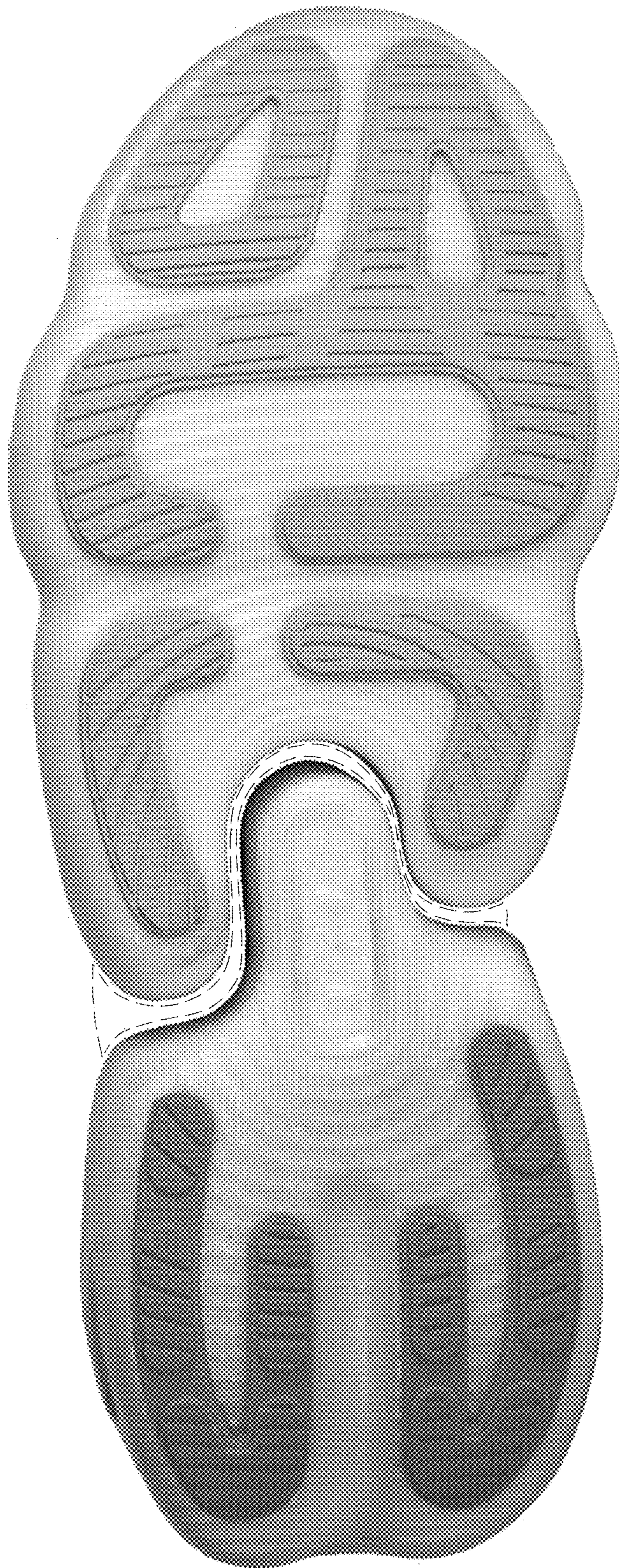
