FIG. 4 is a side view thereof;

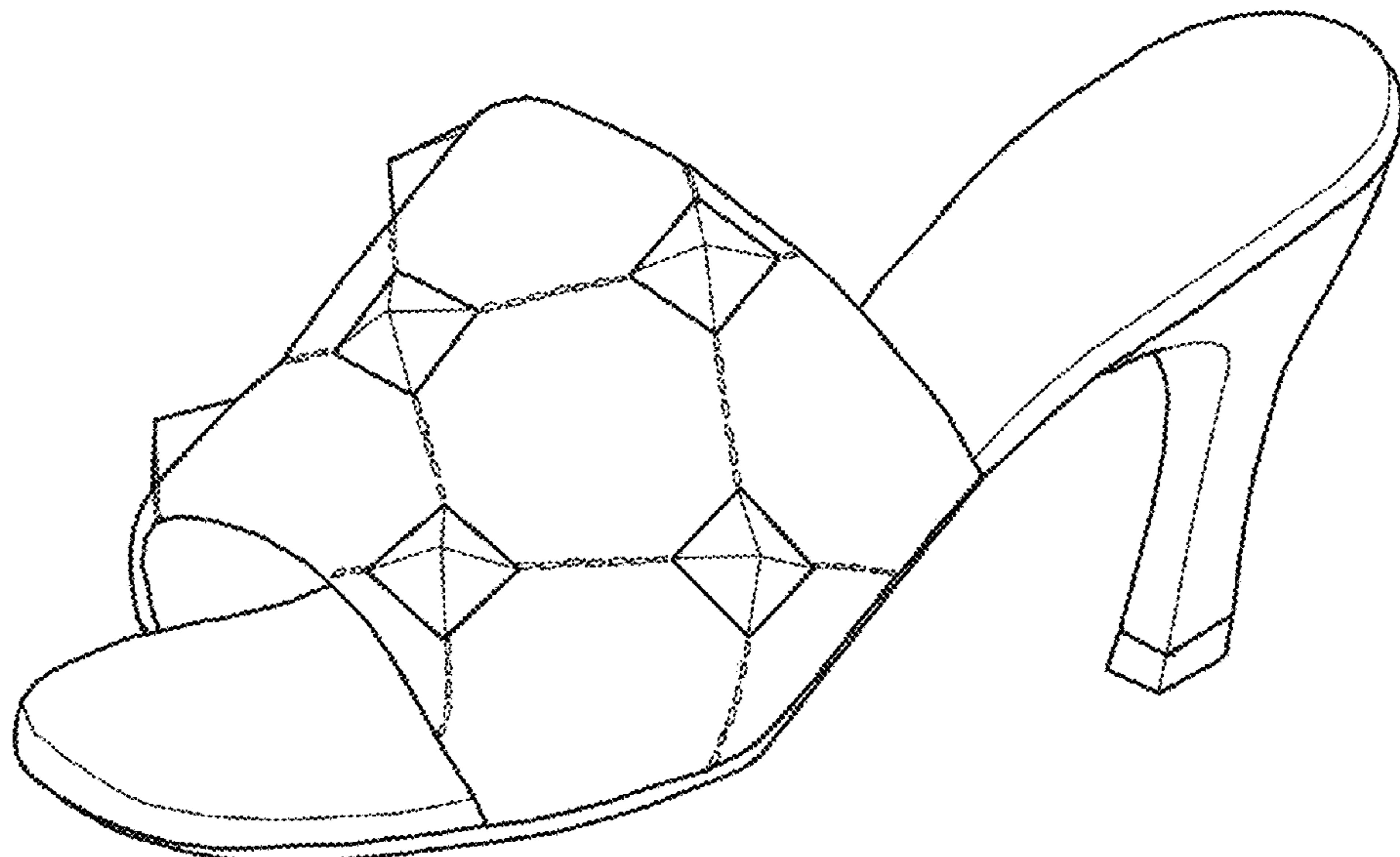
FIG. 5 is a side view thereof, opposite that of FIG. 4;

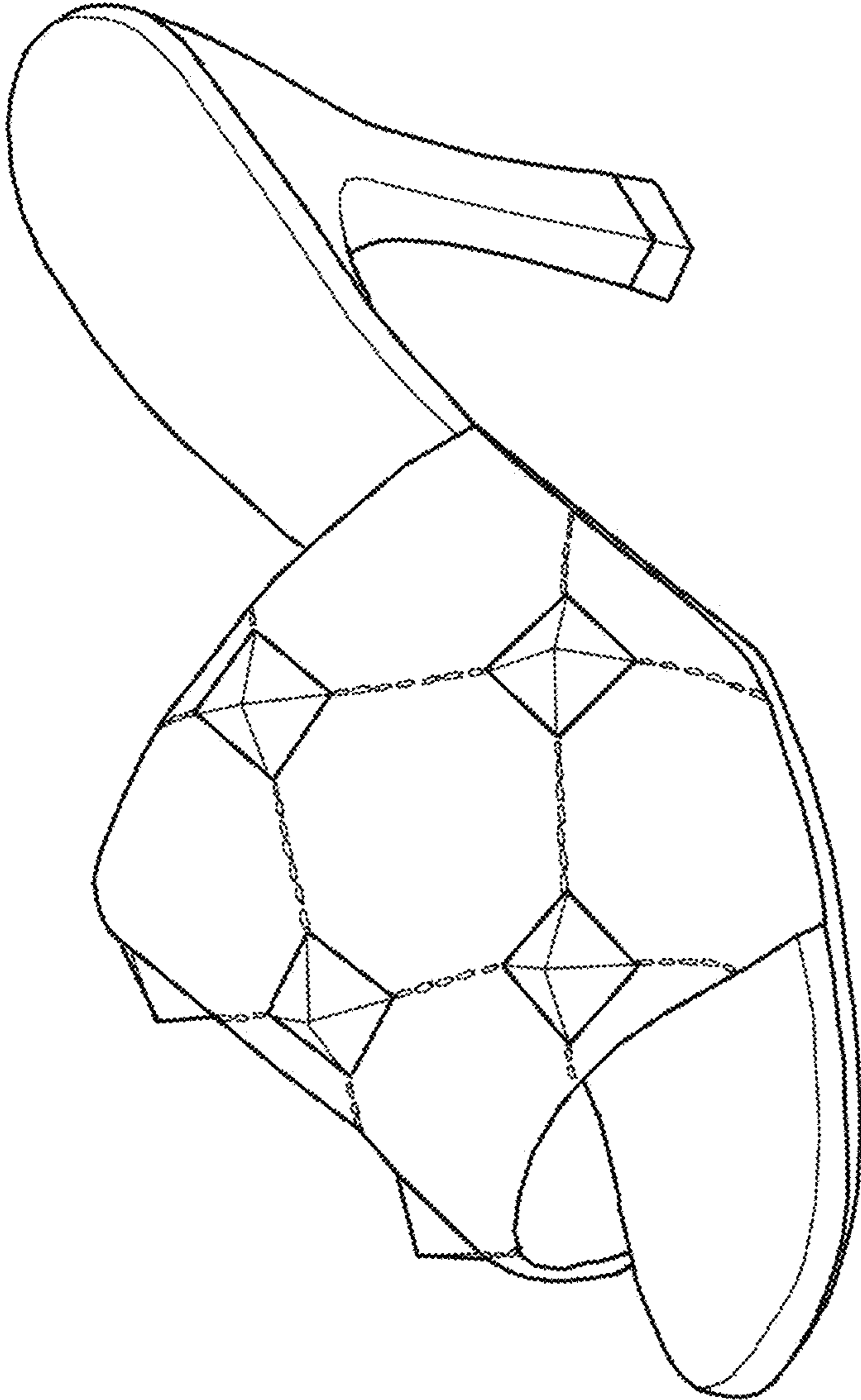

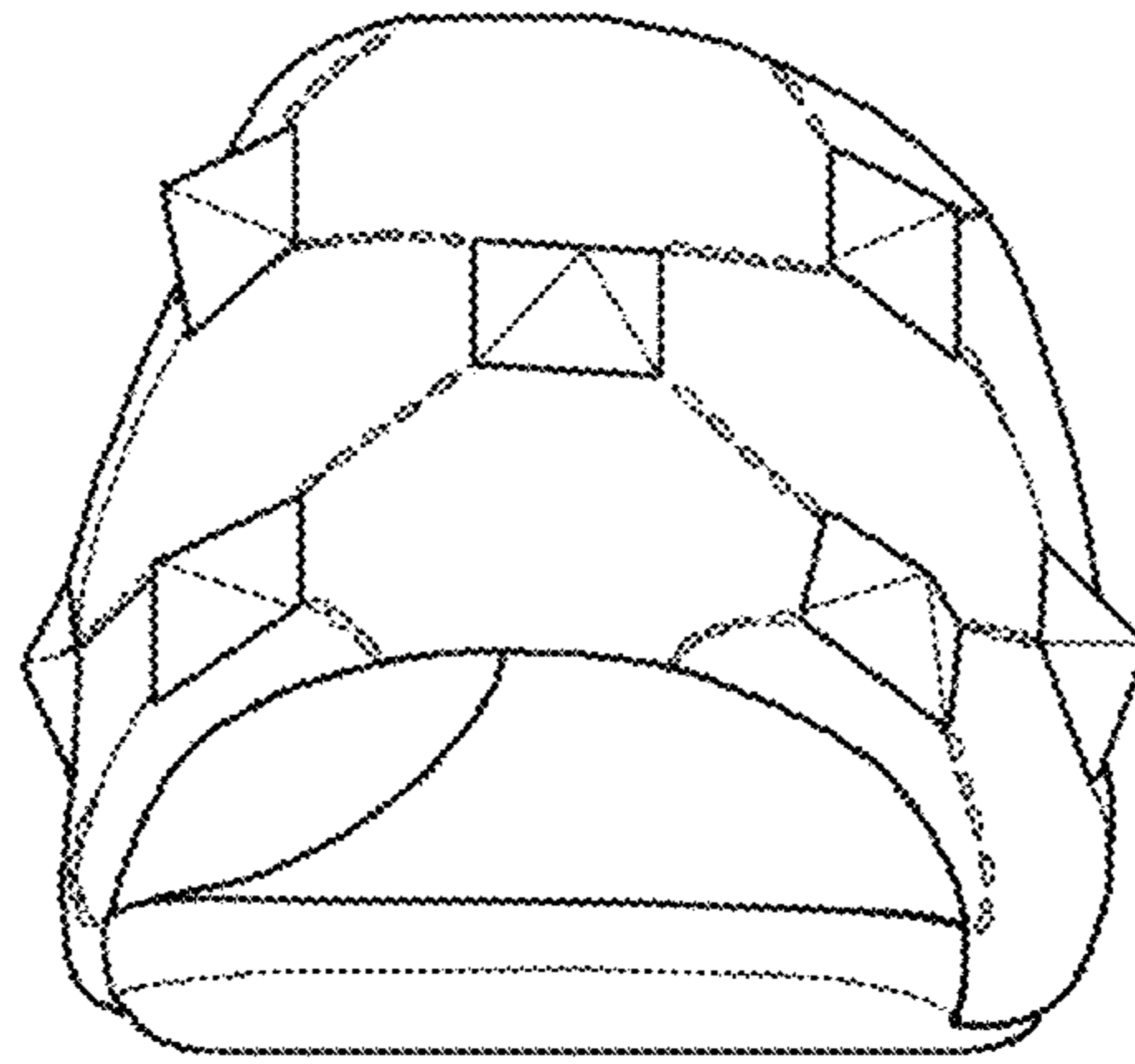

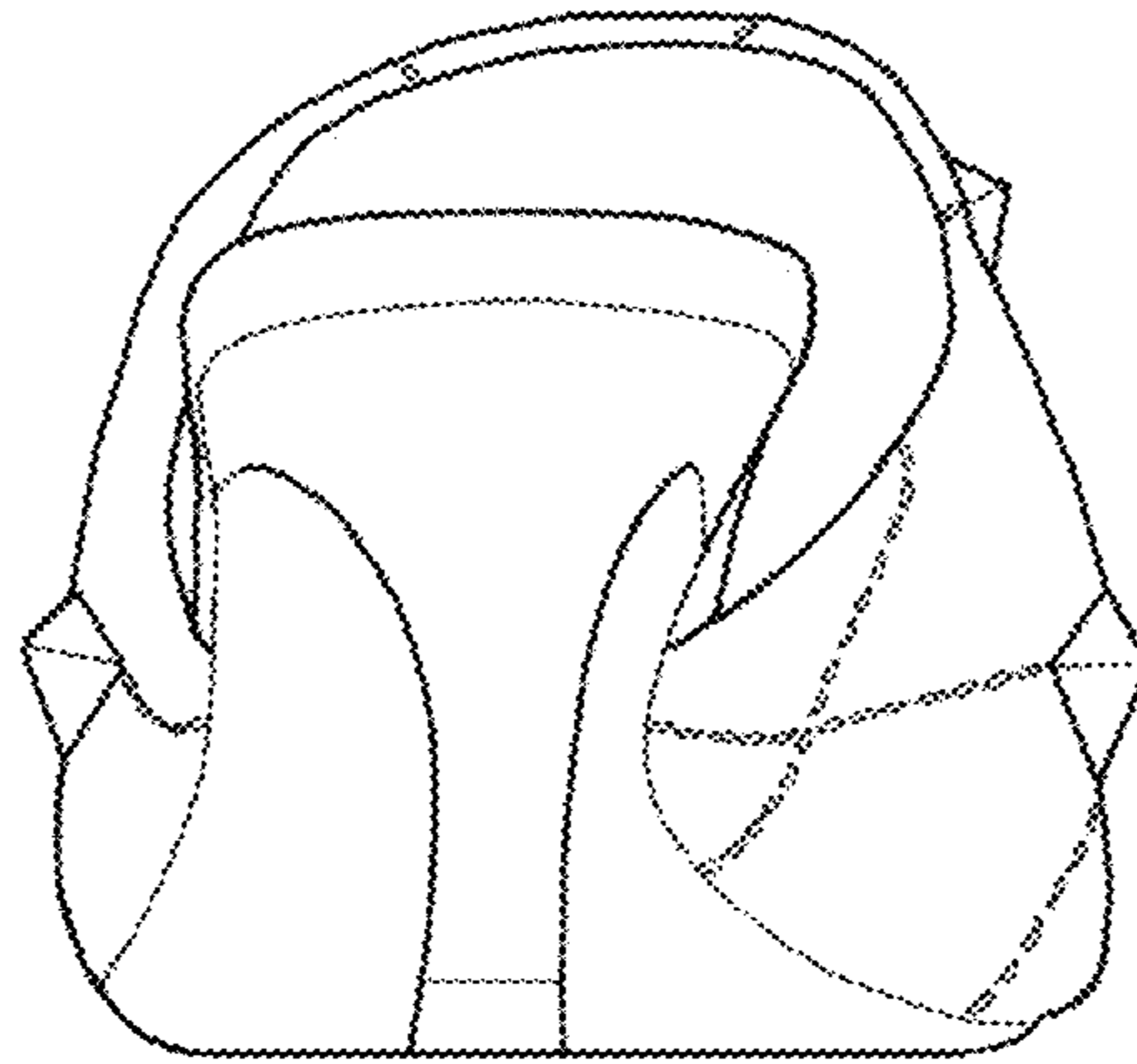

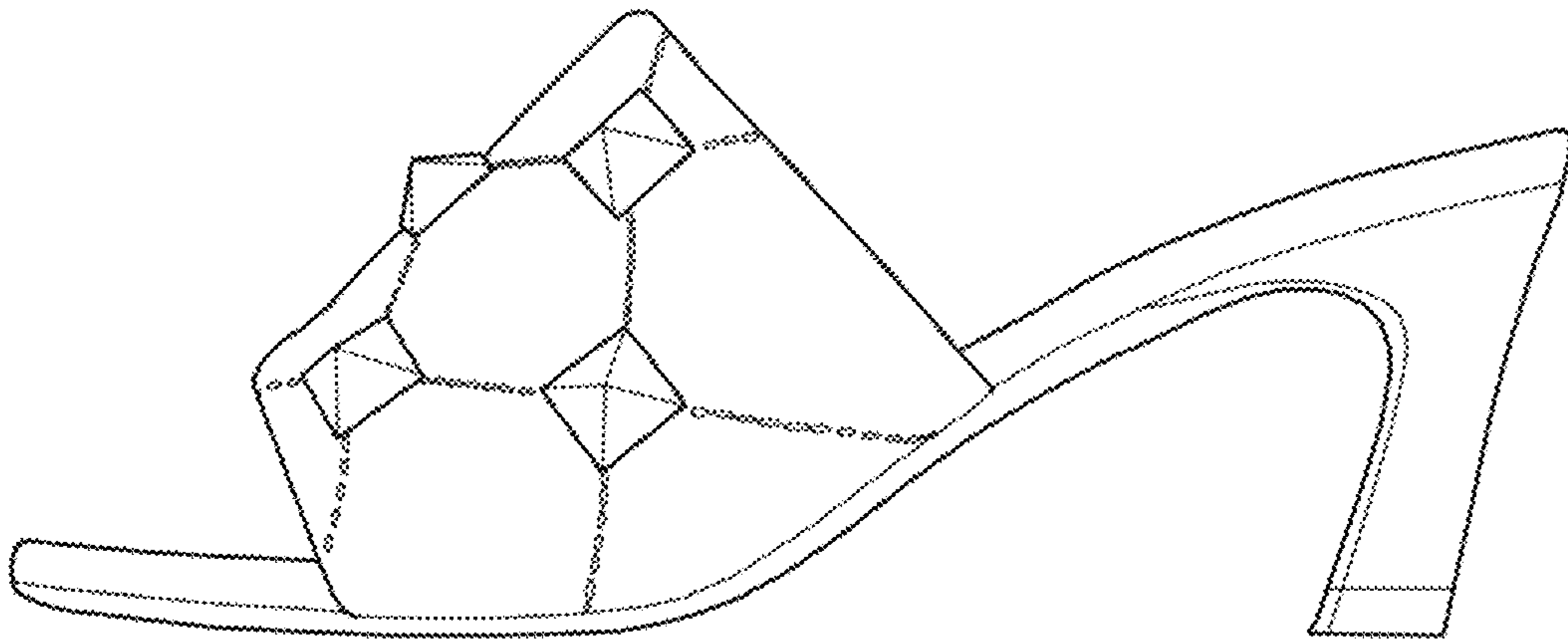

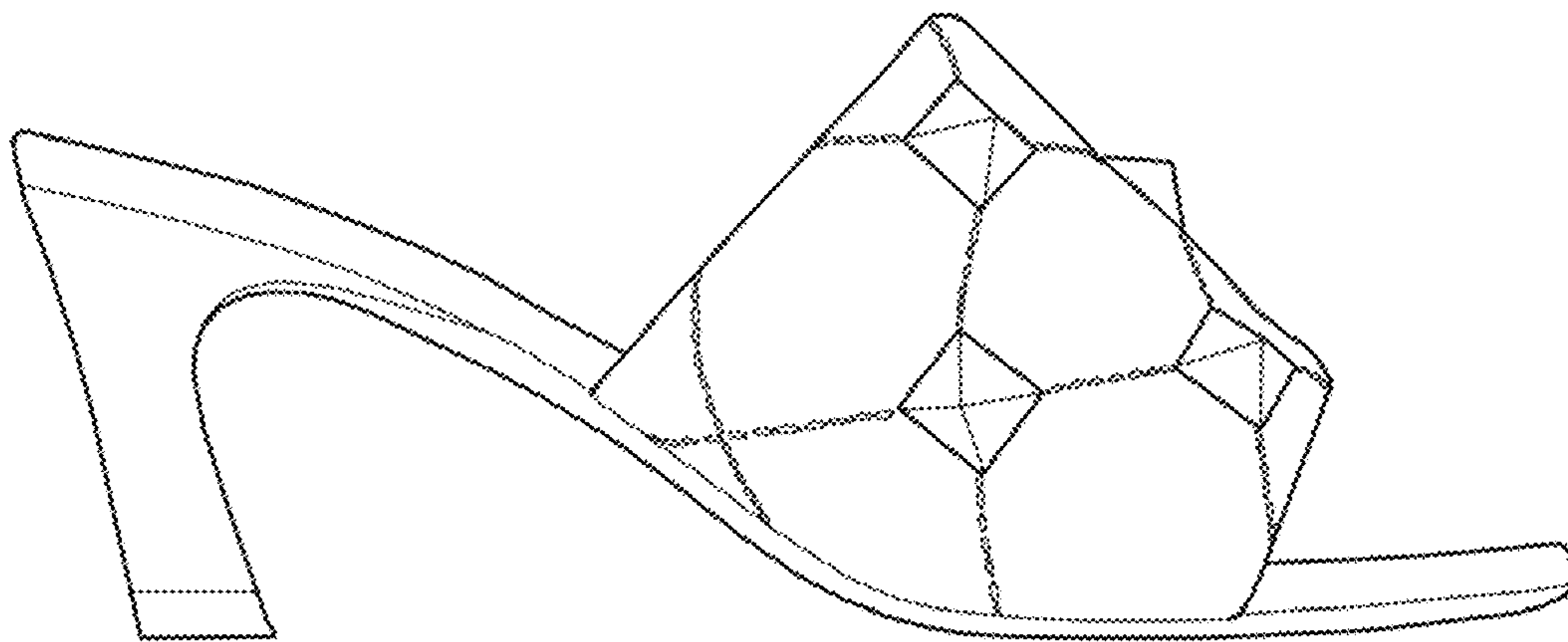

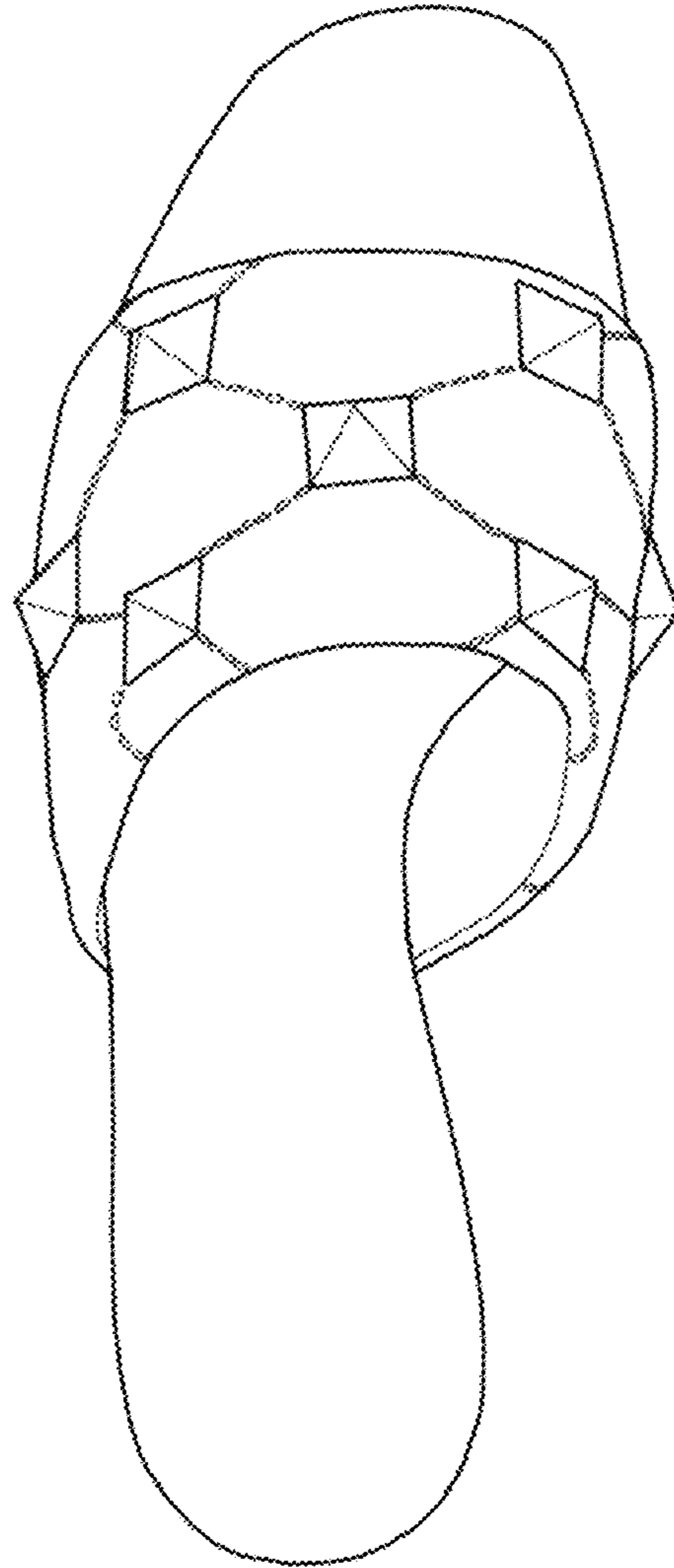

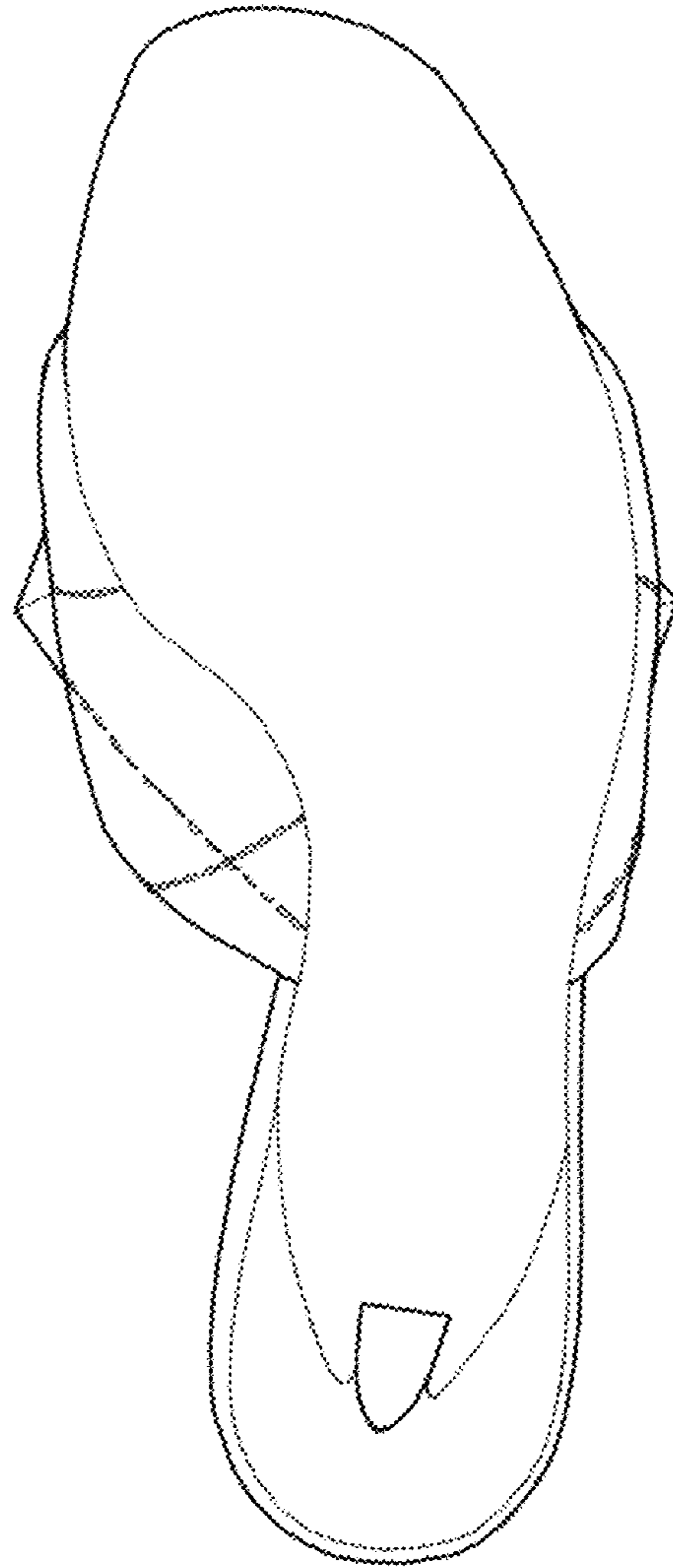
