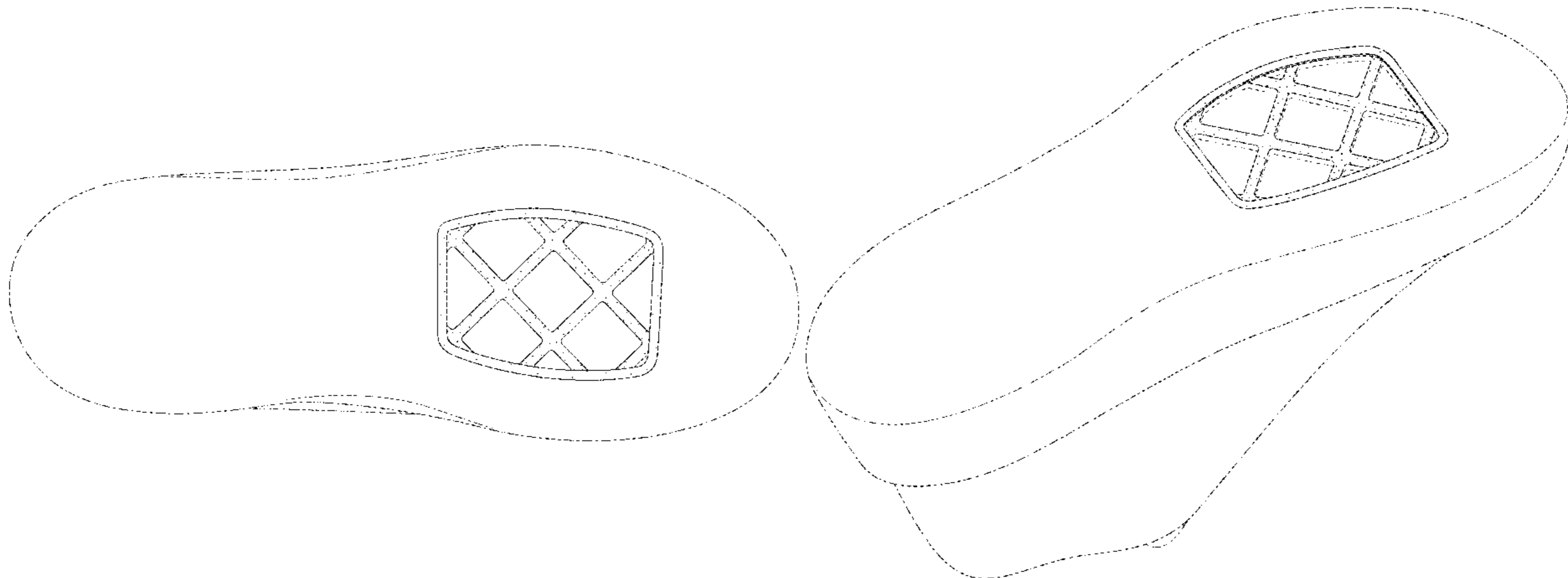
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a bottom front perspective view of a shoe showing our new design;  
FIG. 2 is a bottom view thereof;  
FIG. 3 is a bottom rear perspective view thereof;  
FIG. 4 is a bottom front perspective view of a shoe showing an alternate embodiment of our new design;

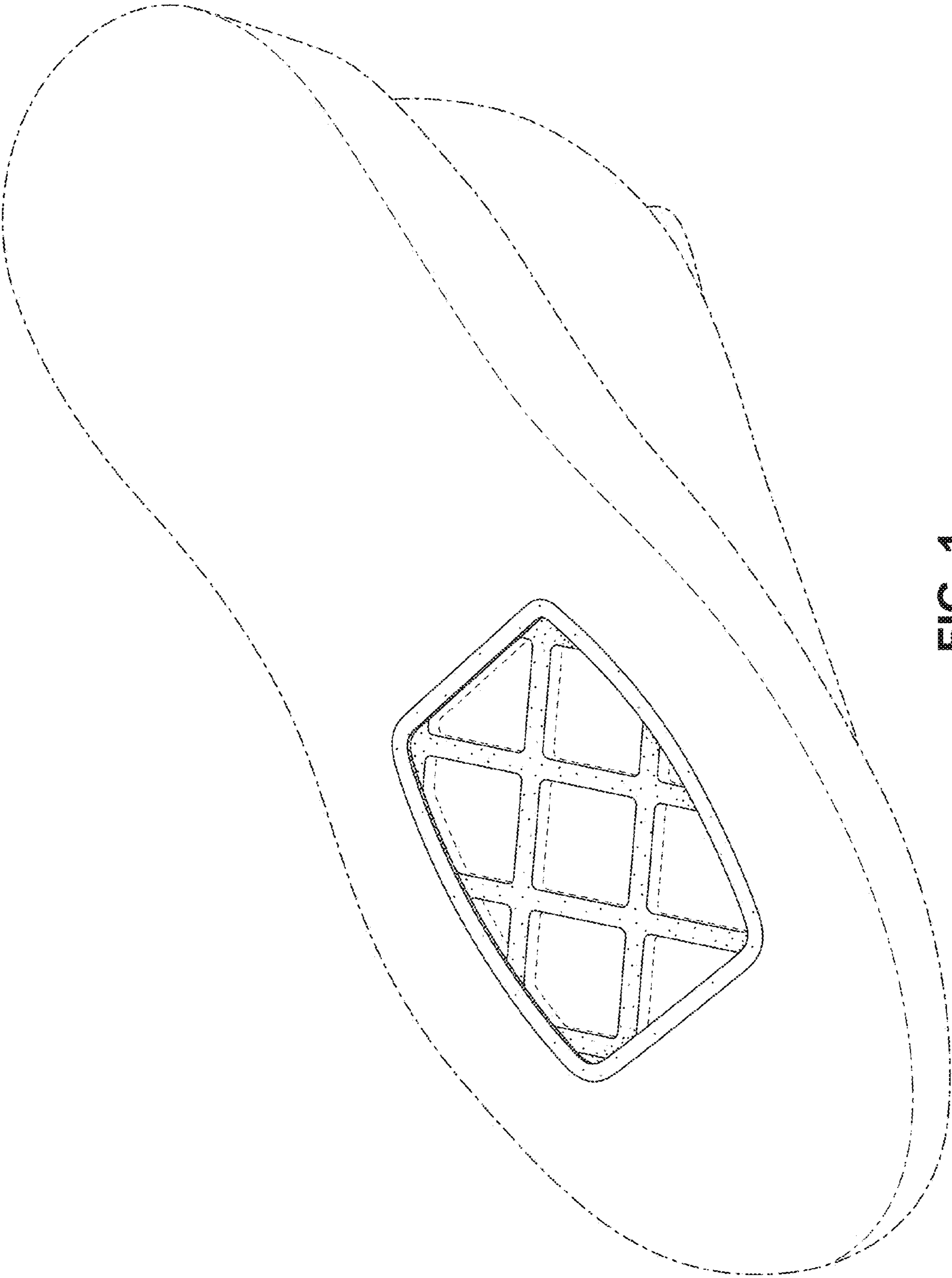

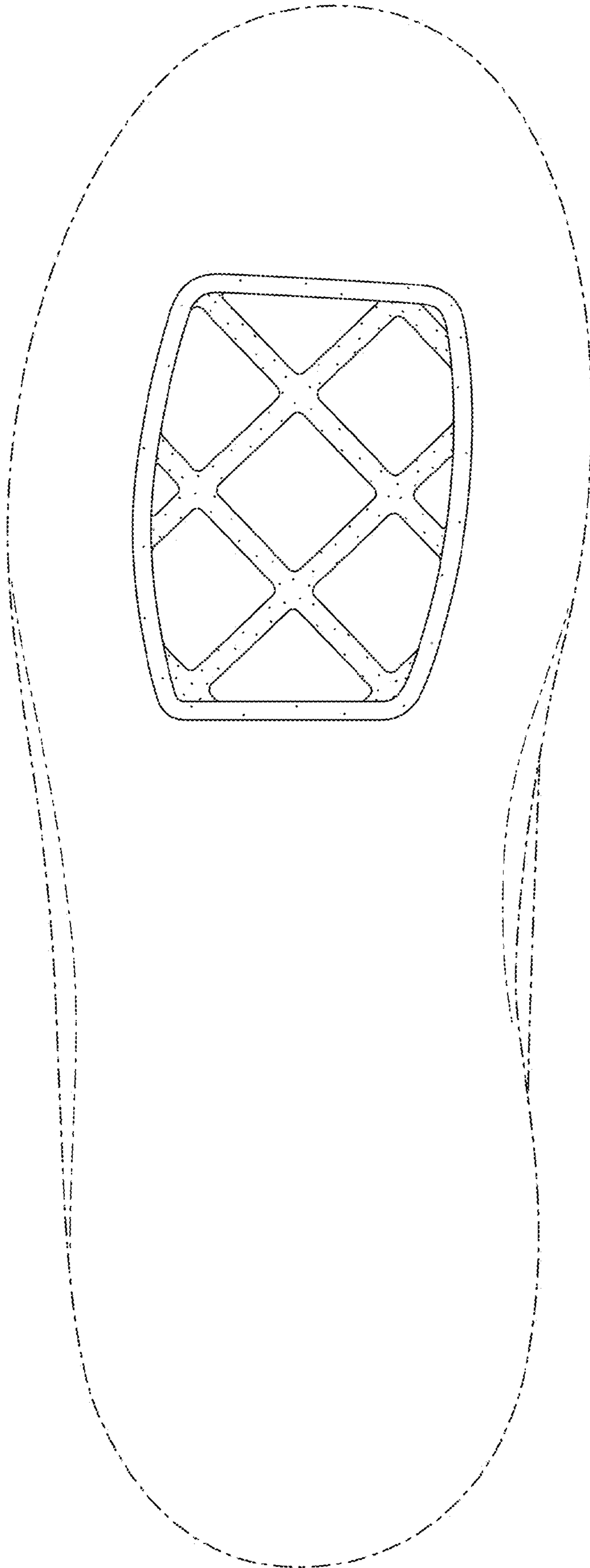

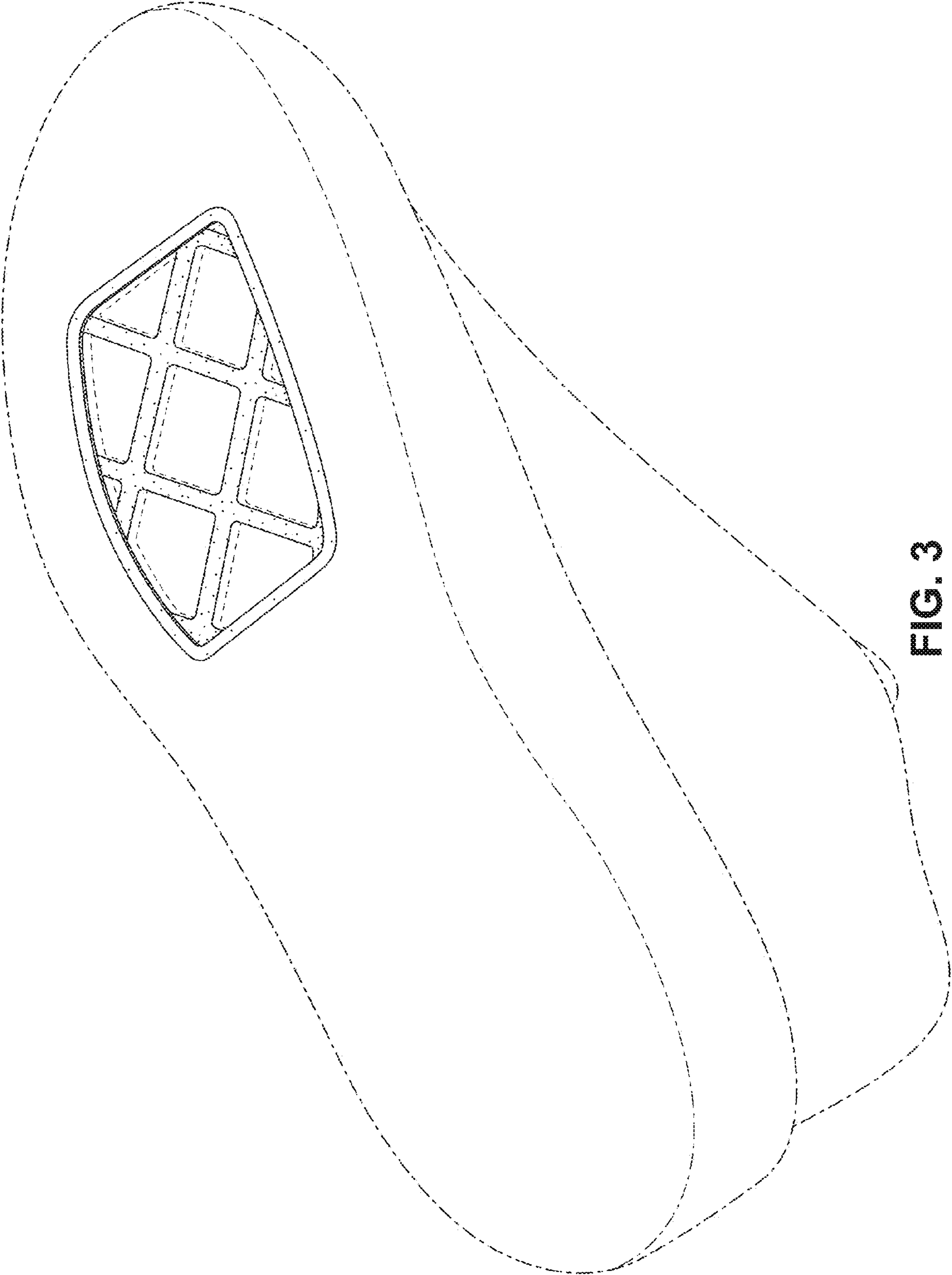

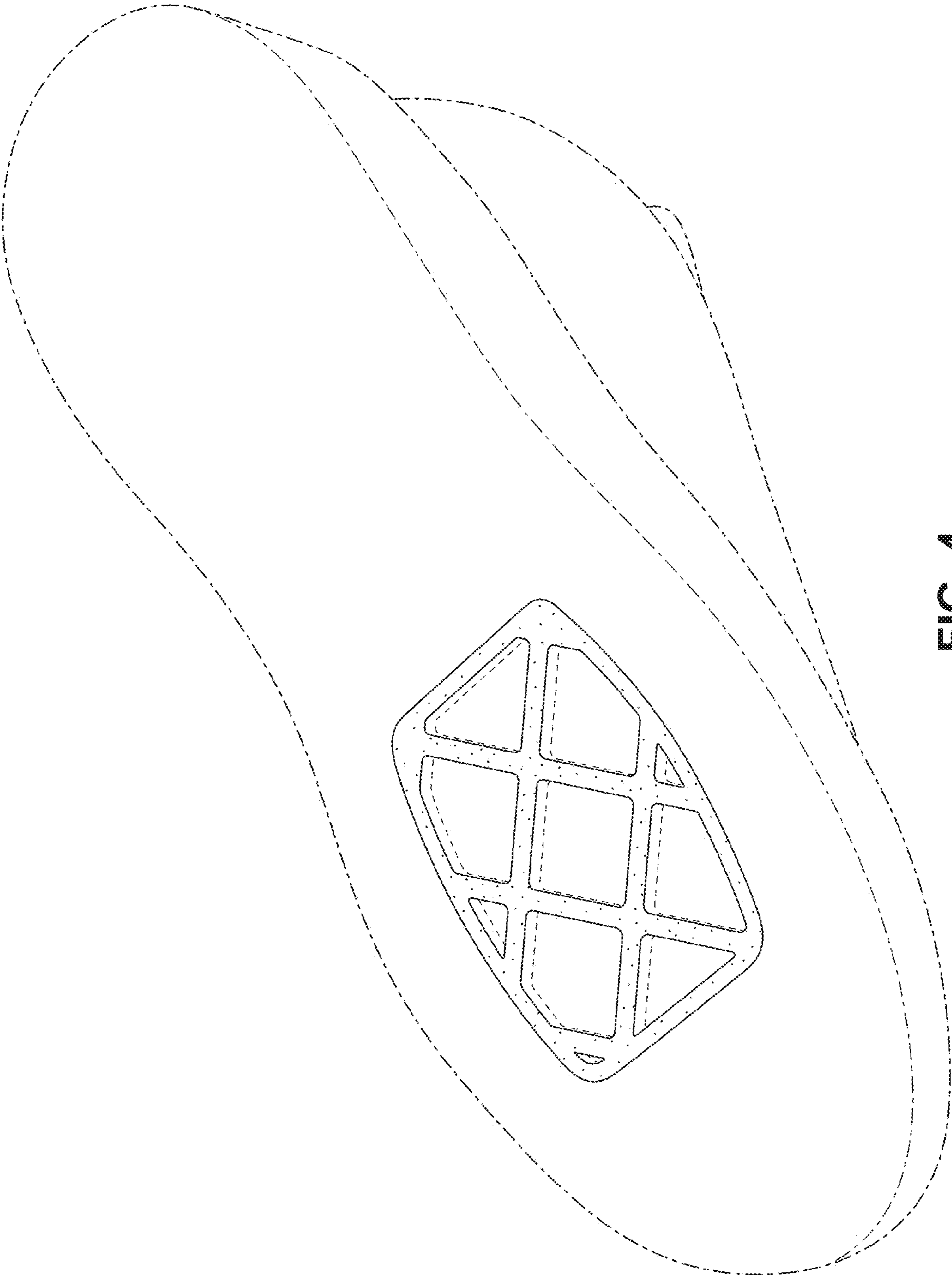

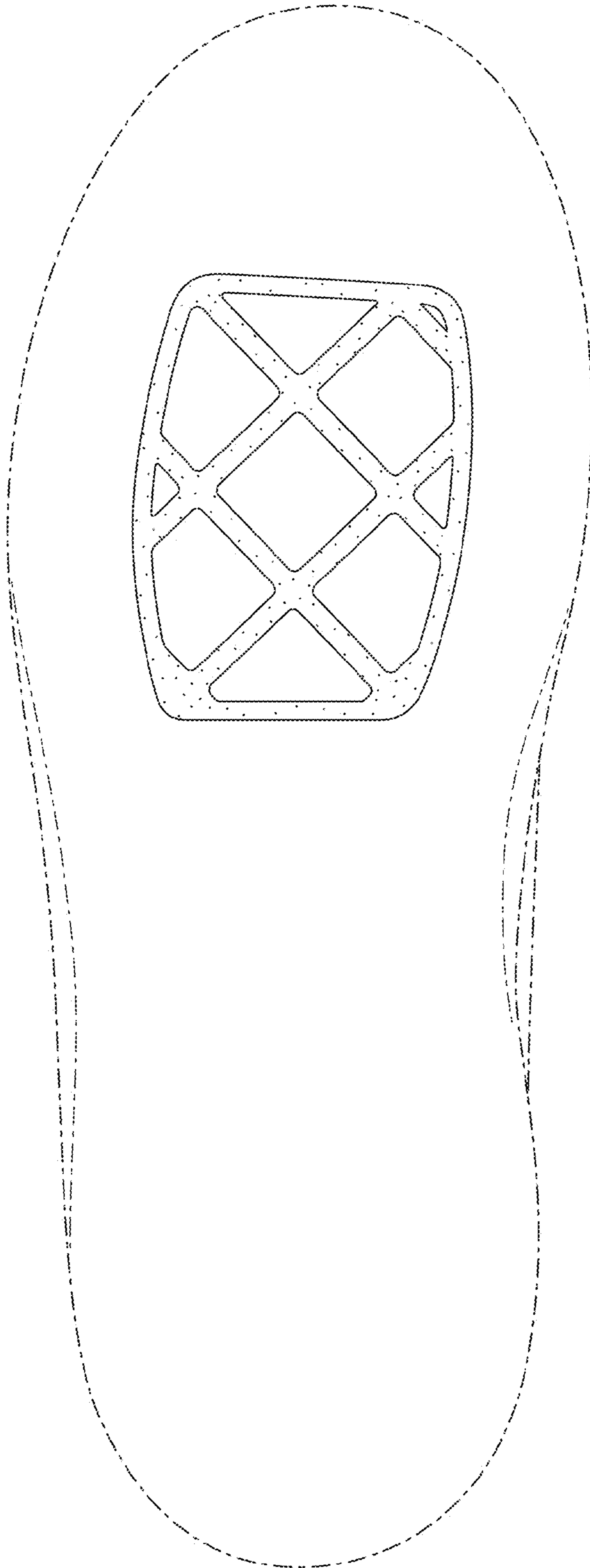

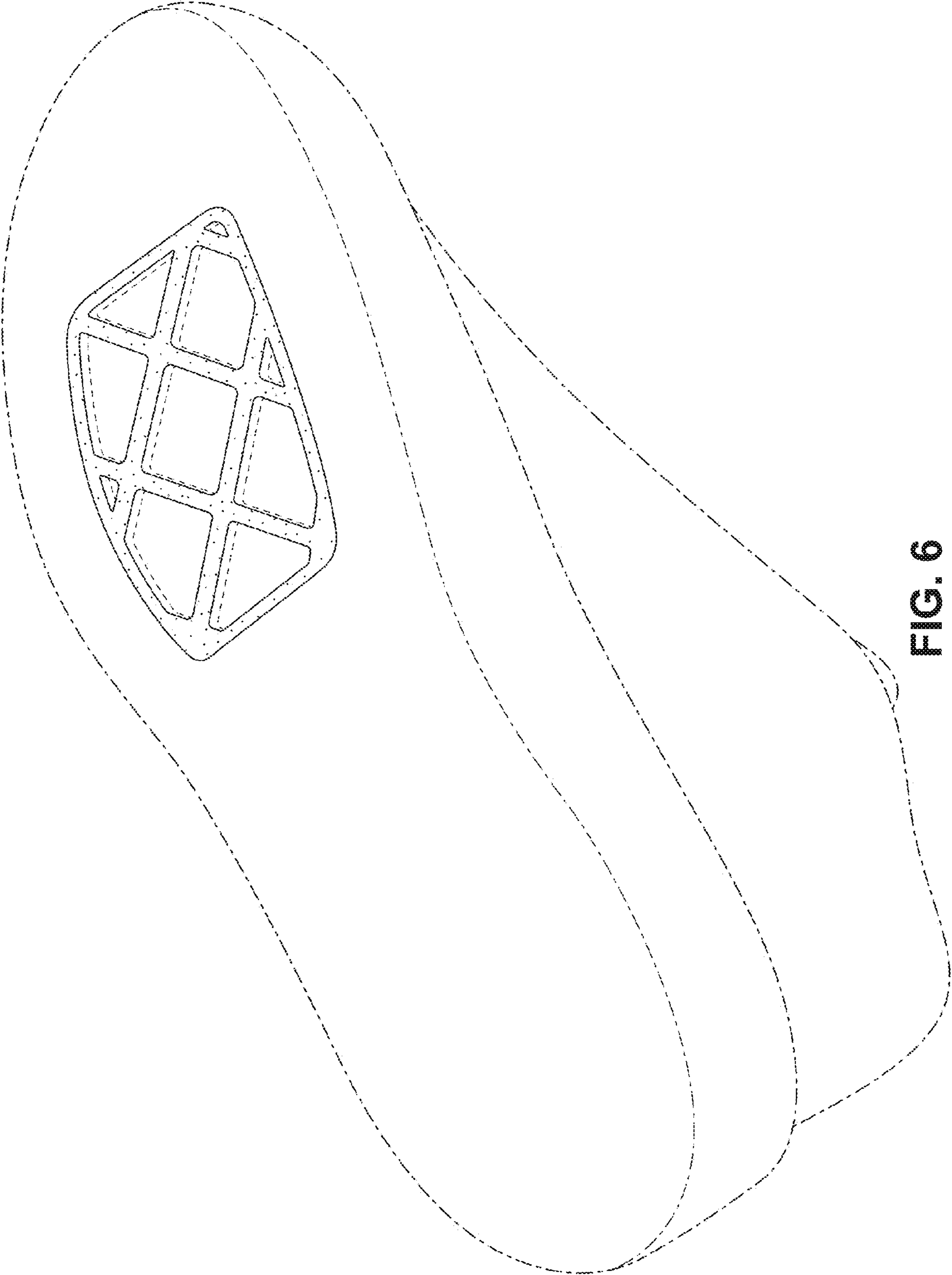
