The ornamental design for an armchair, as shown and described.

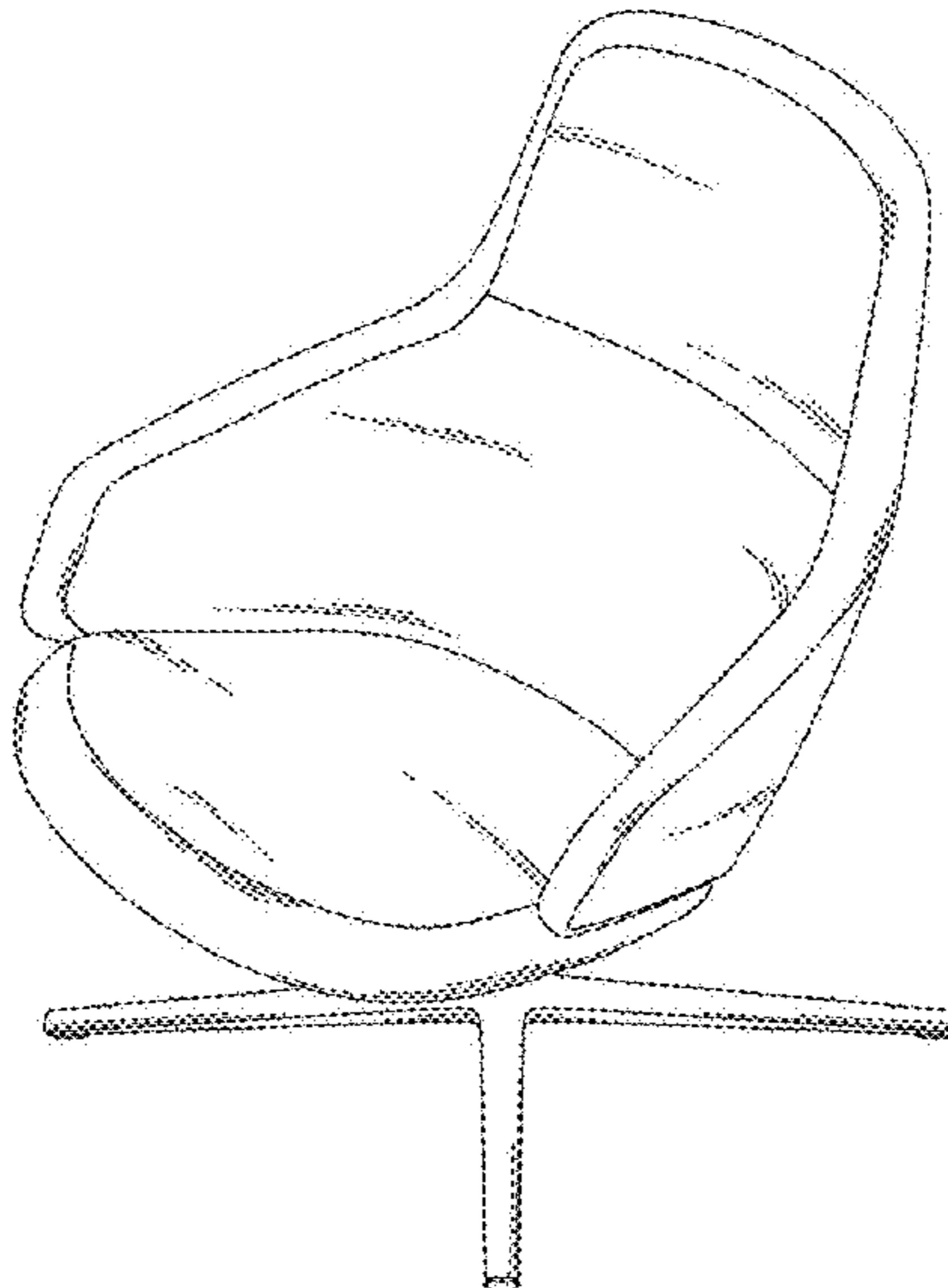
**DESCRIPTION**

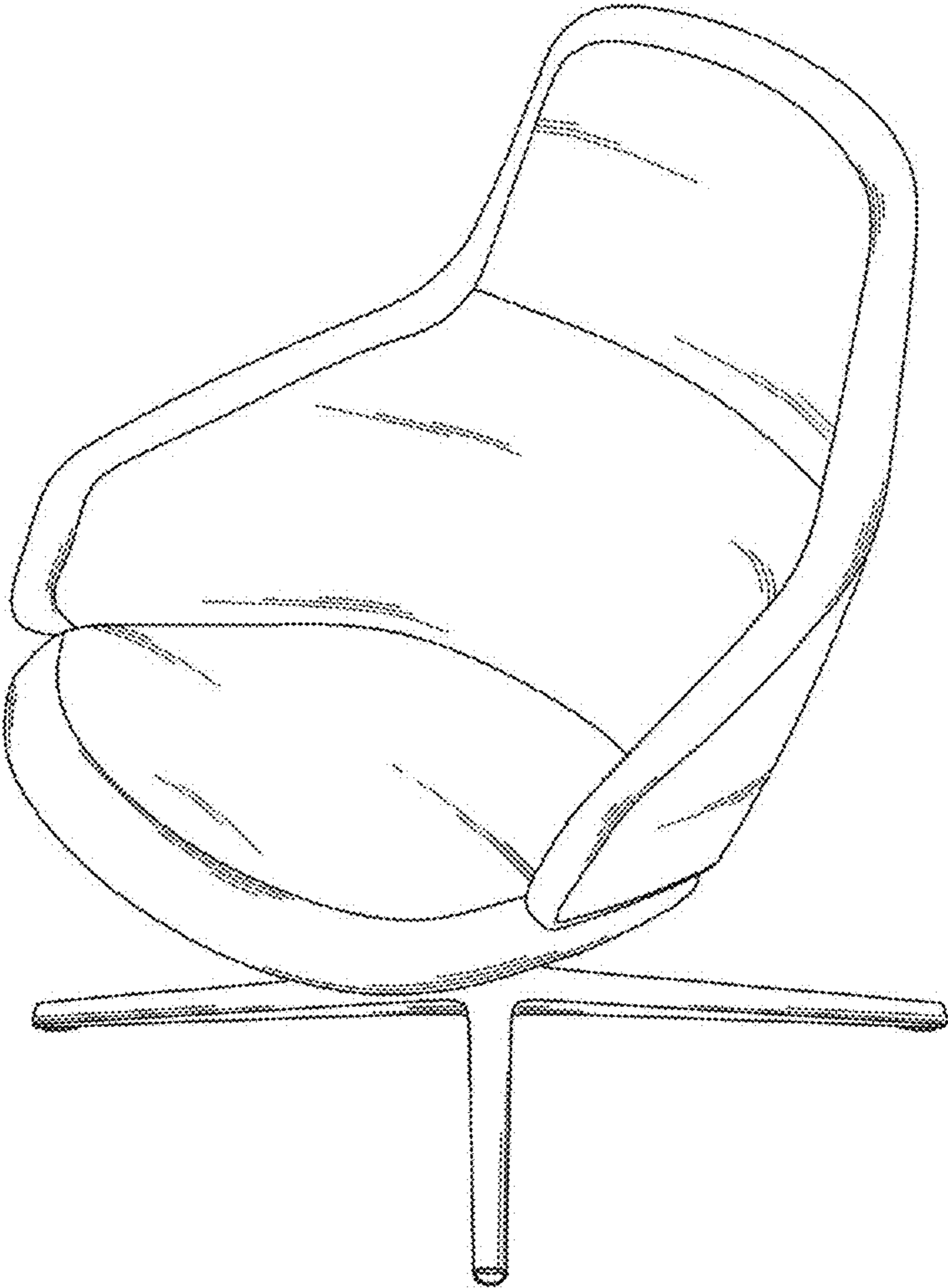

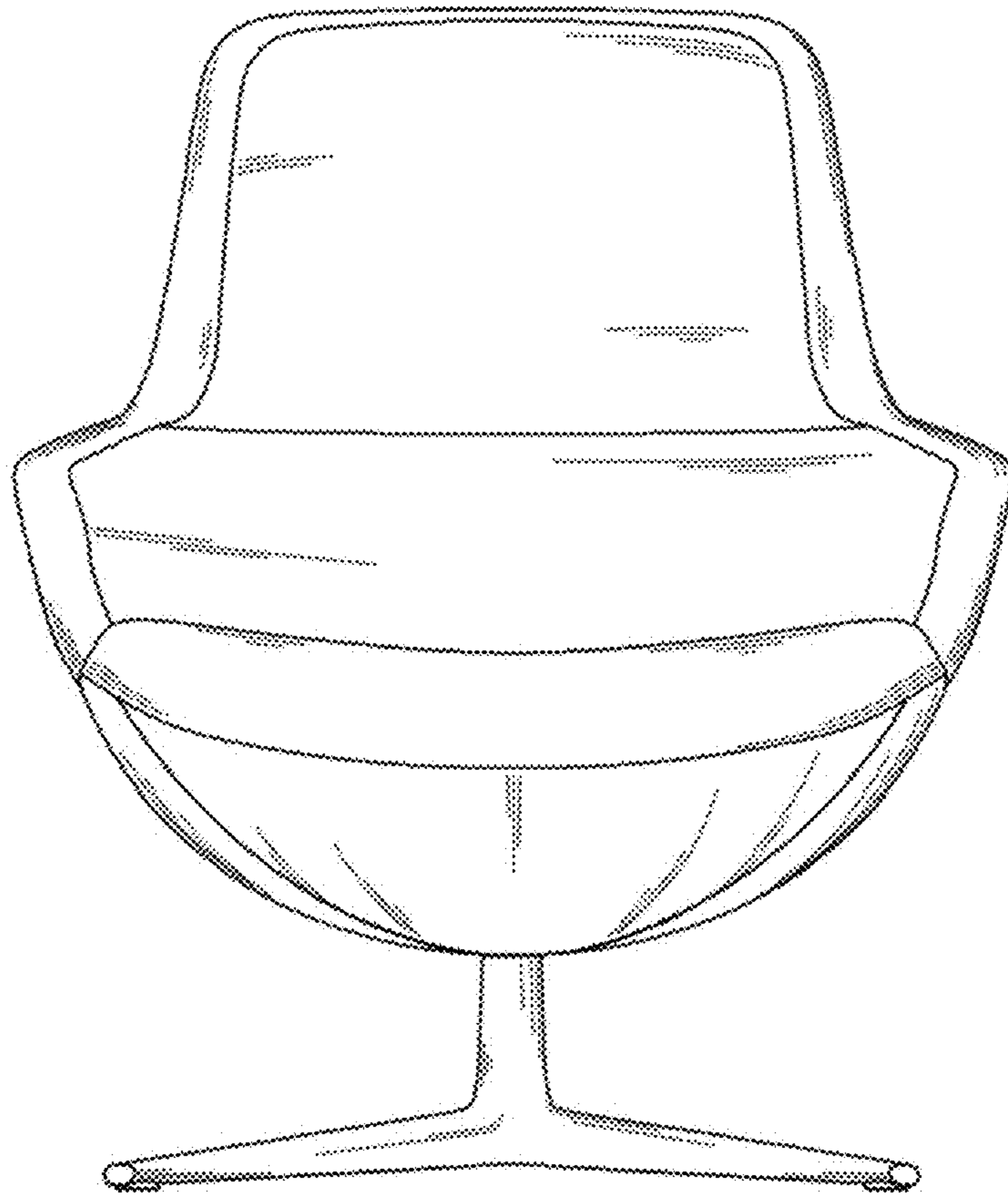

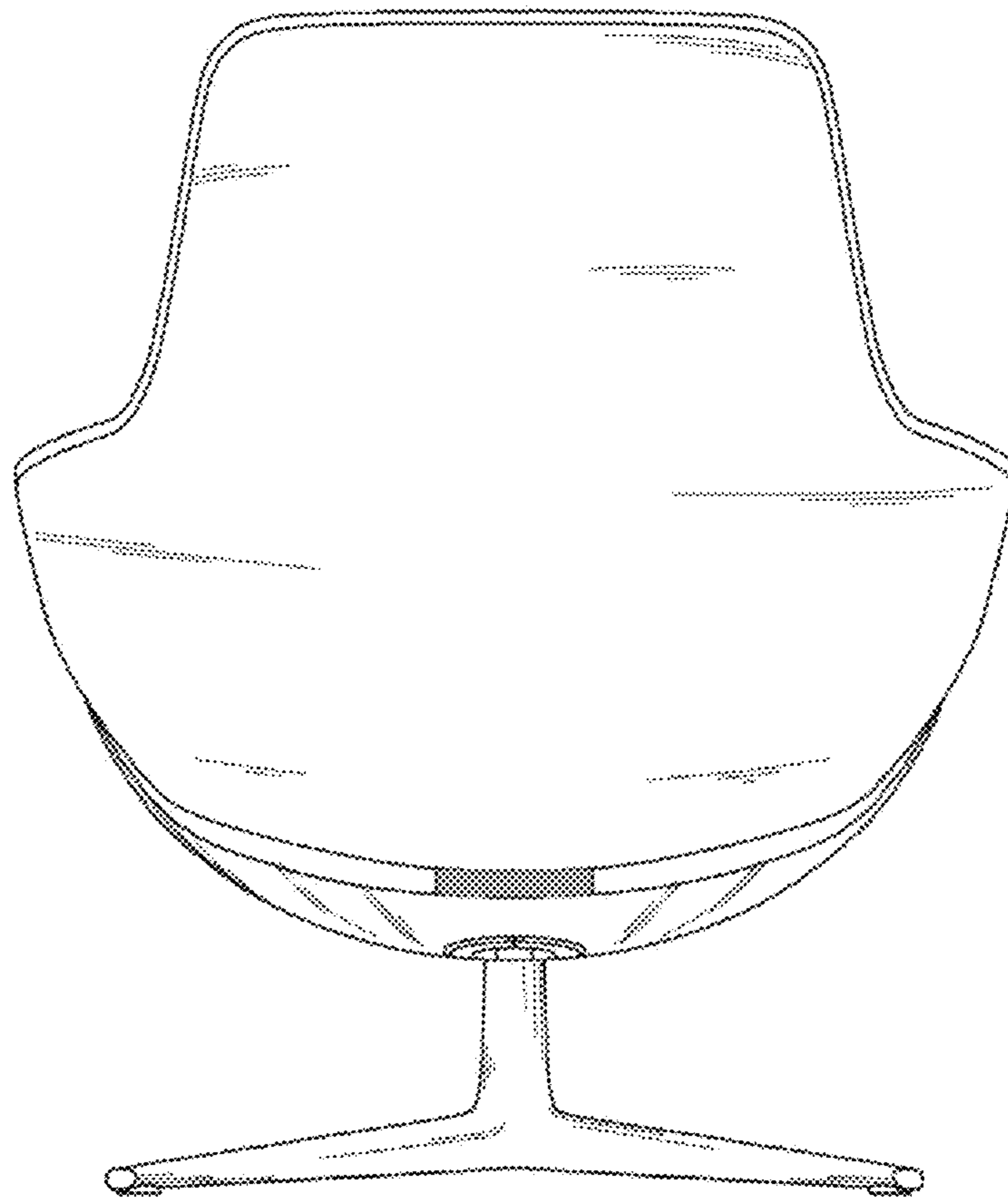

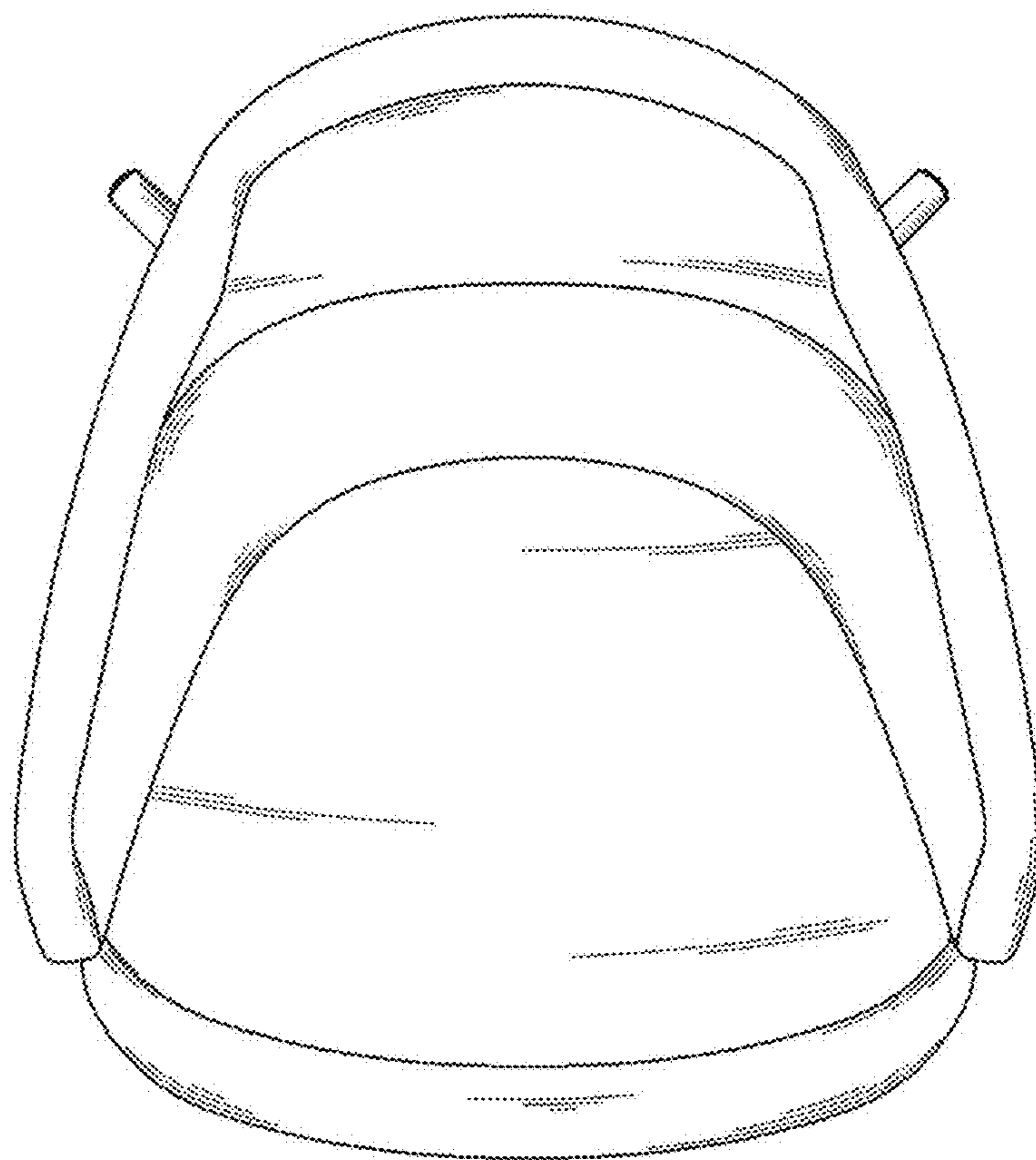
