FIG. 6 is a color photograph showing a front view thereof;

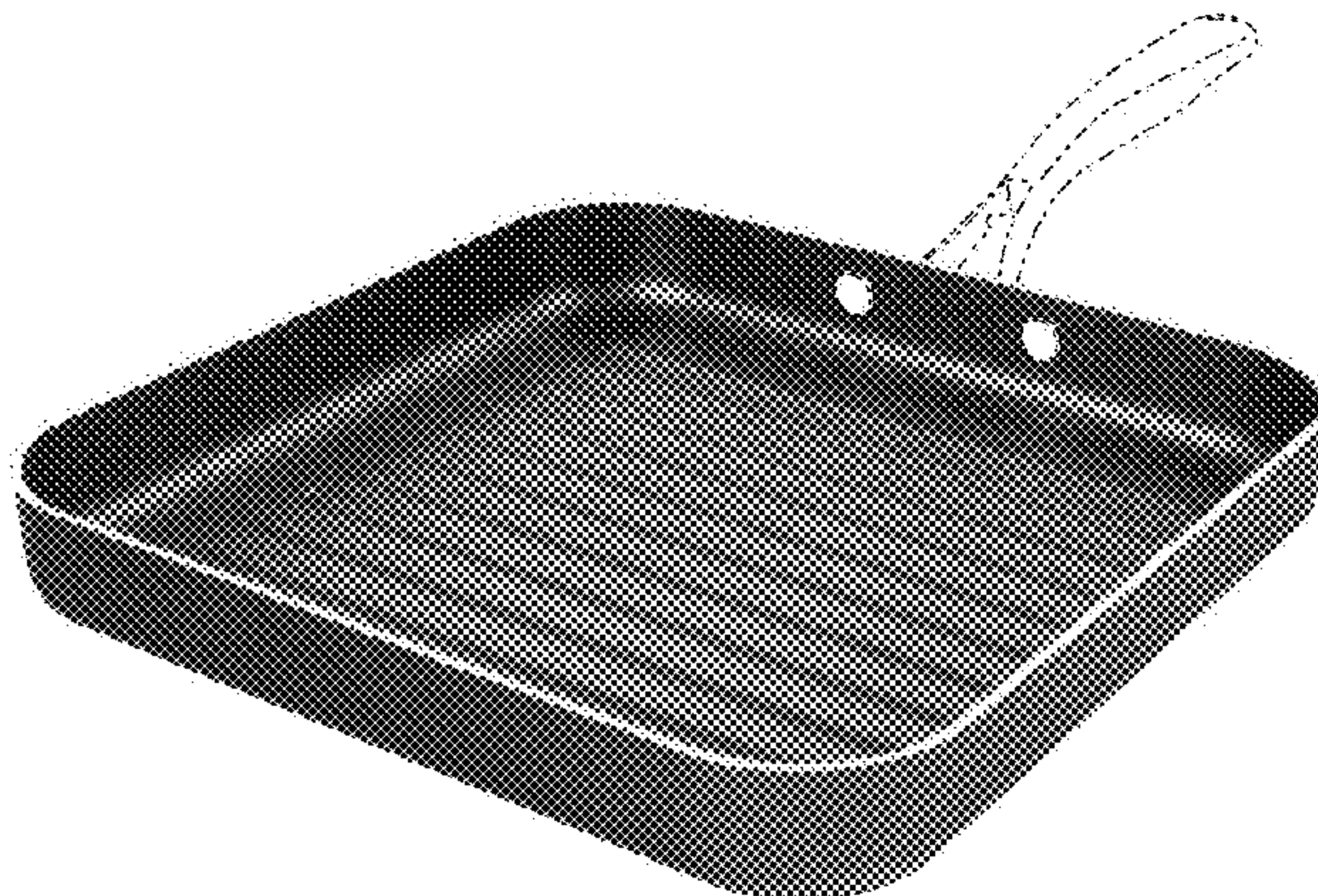
FIG. 7 is a color photograph showing a rear view thereof;

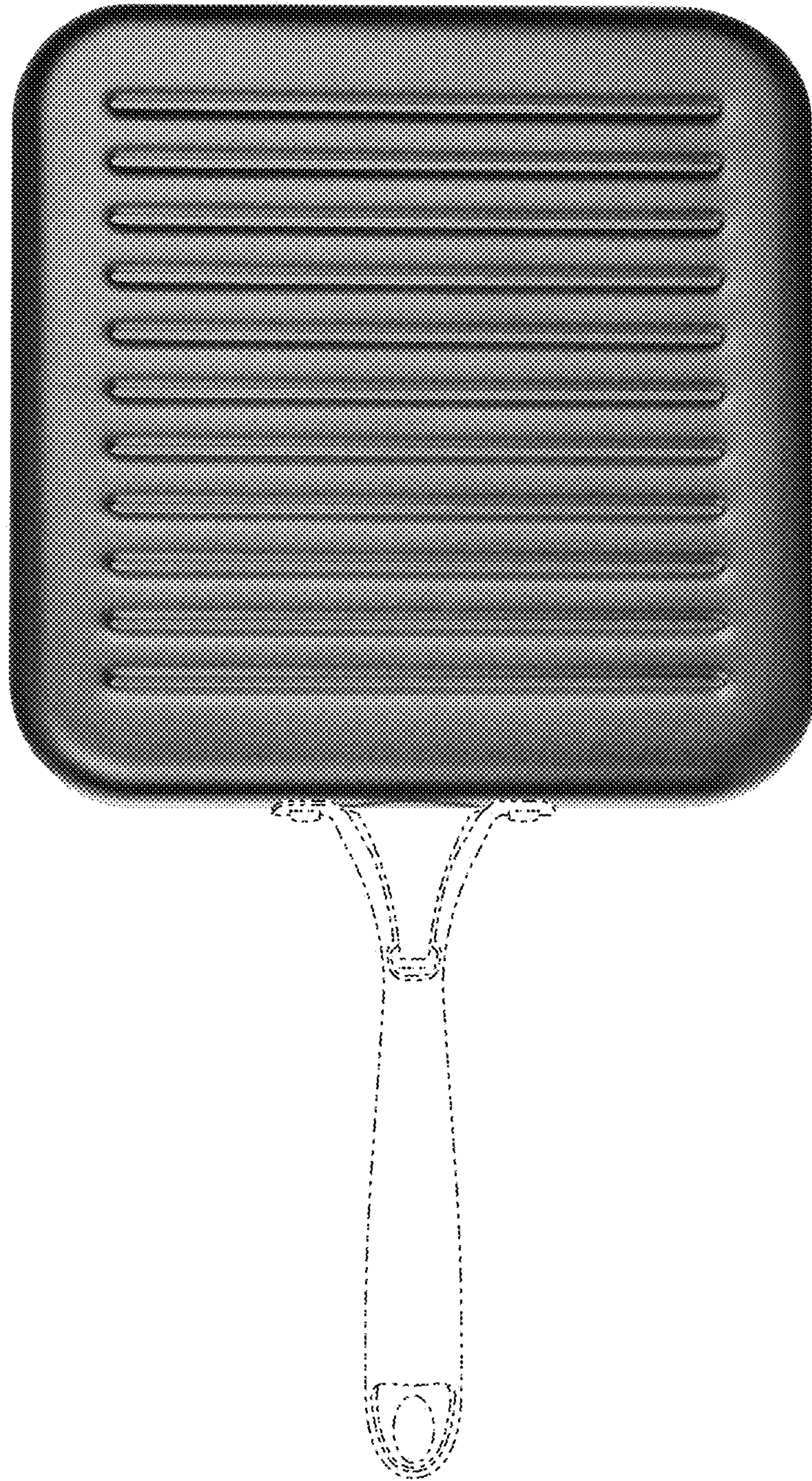

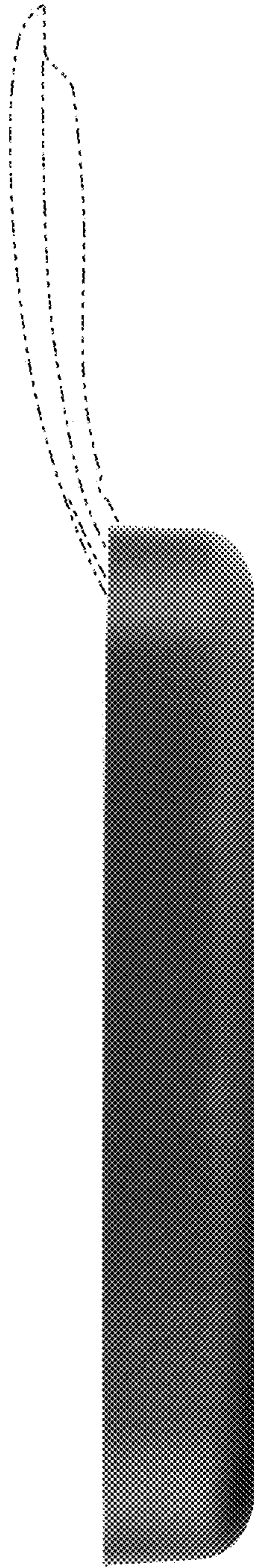

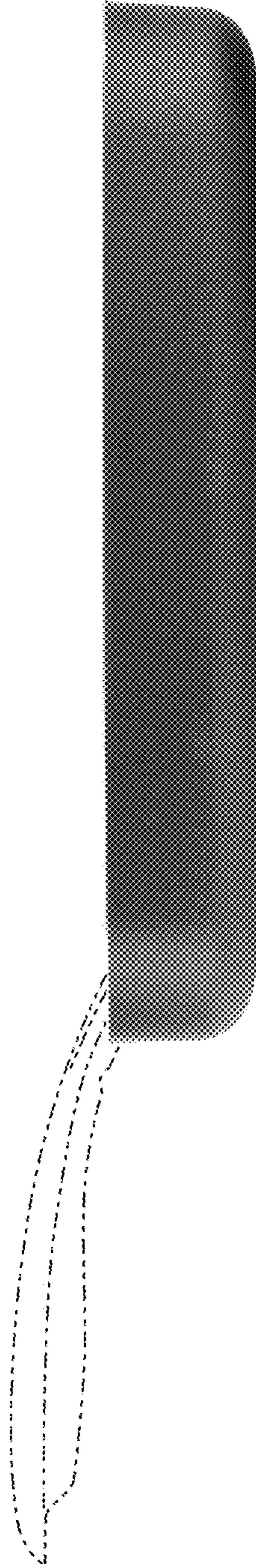

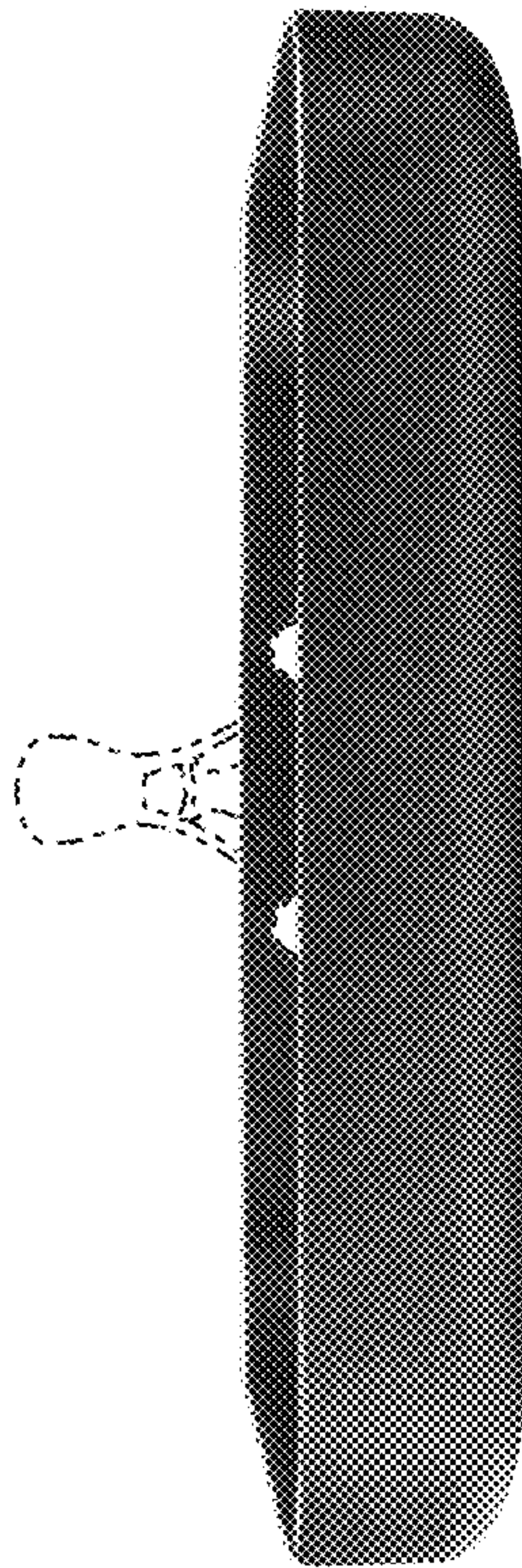

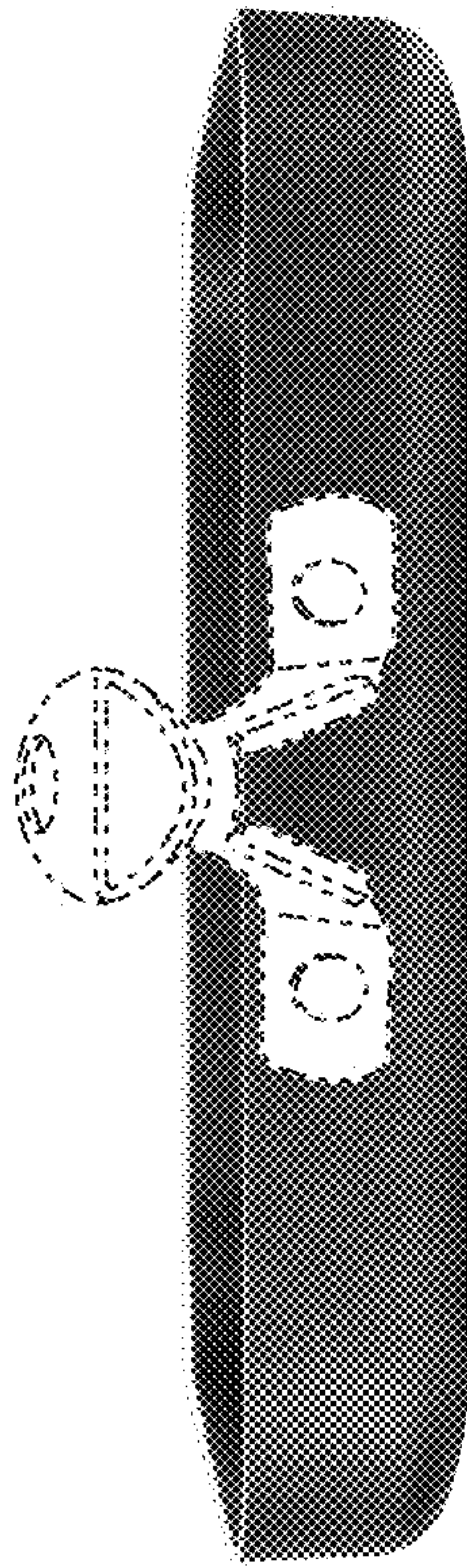
