(57) **CLAIM**

The ornamental design for a container with cutting board attachment, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a container with cutting board attachment in a closed configuration in accordance with the present design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a left side elevational view thereof;

FIG. 5 is a right side elevational view thereof;

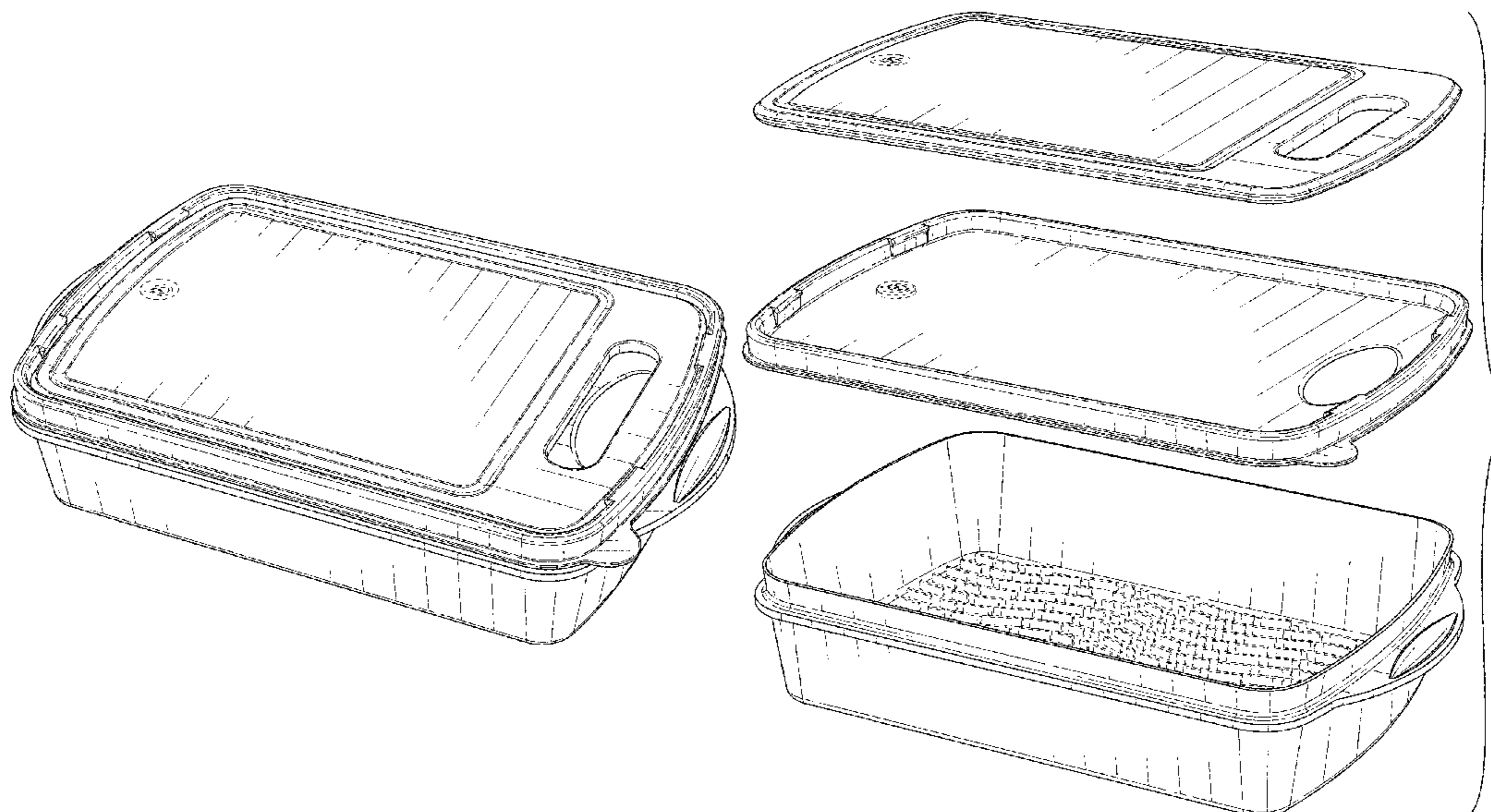
FIG. 6 is a top plan view thereof;

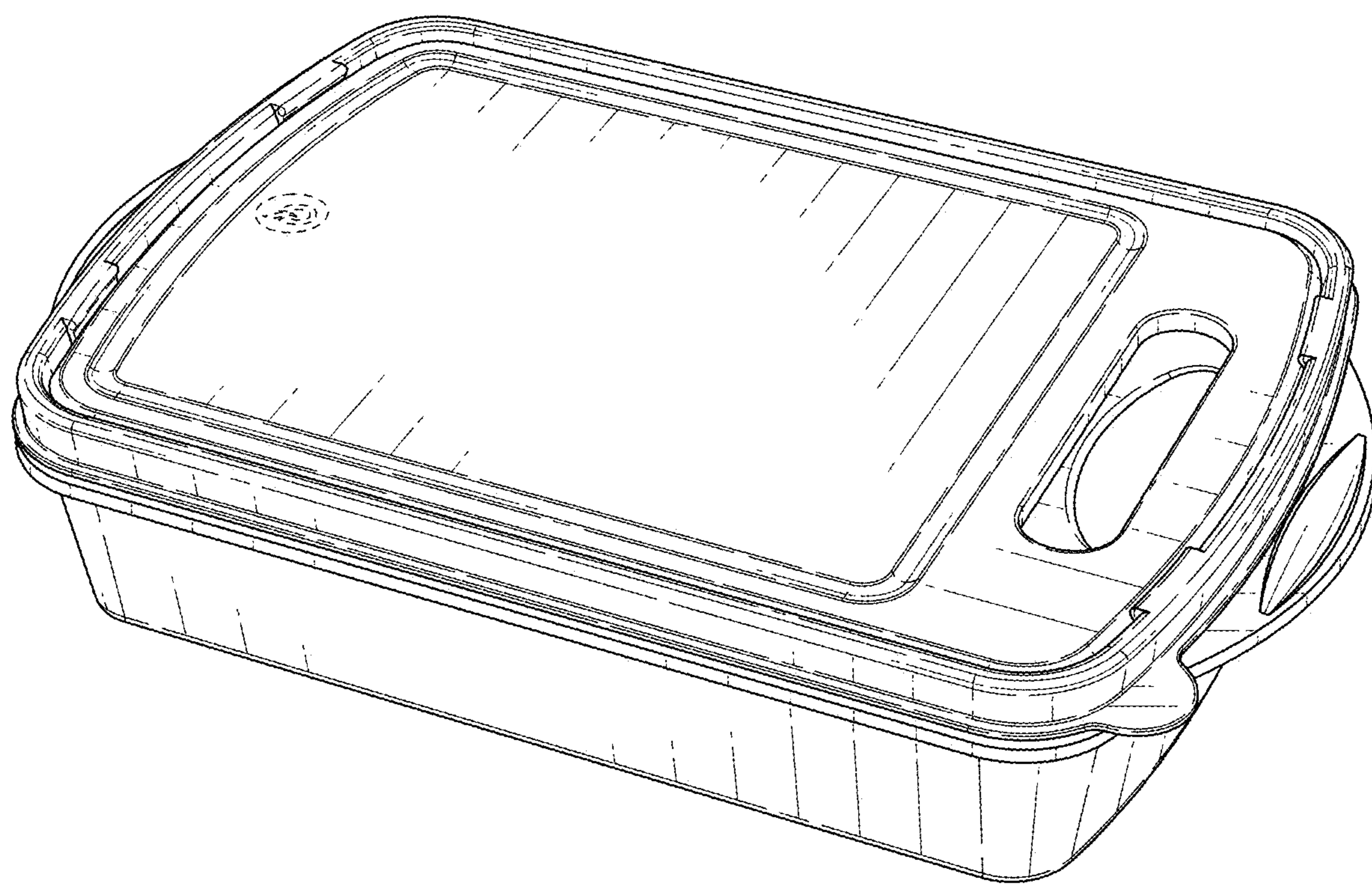

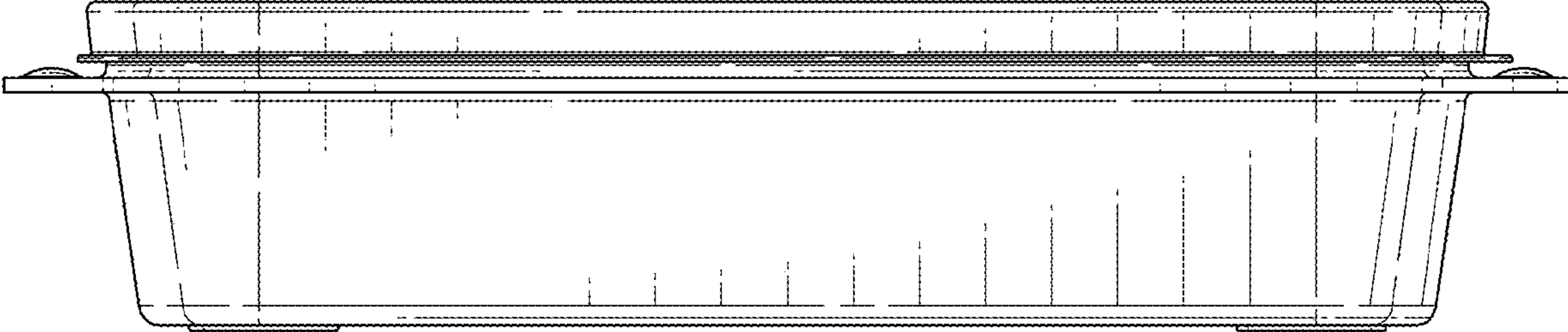

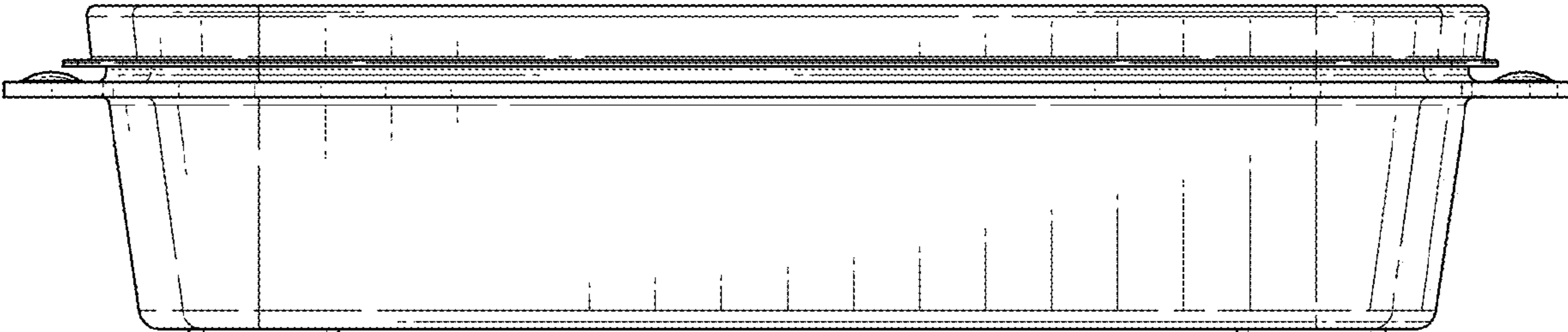

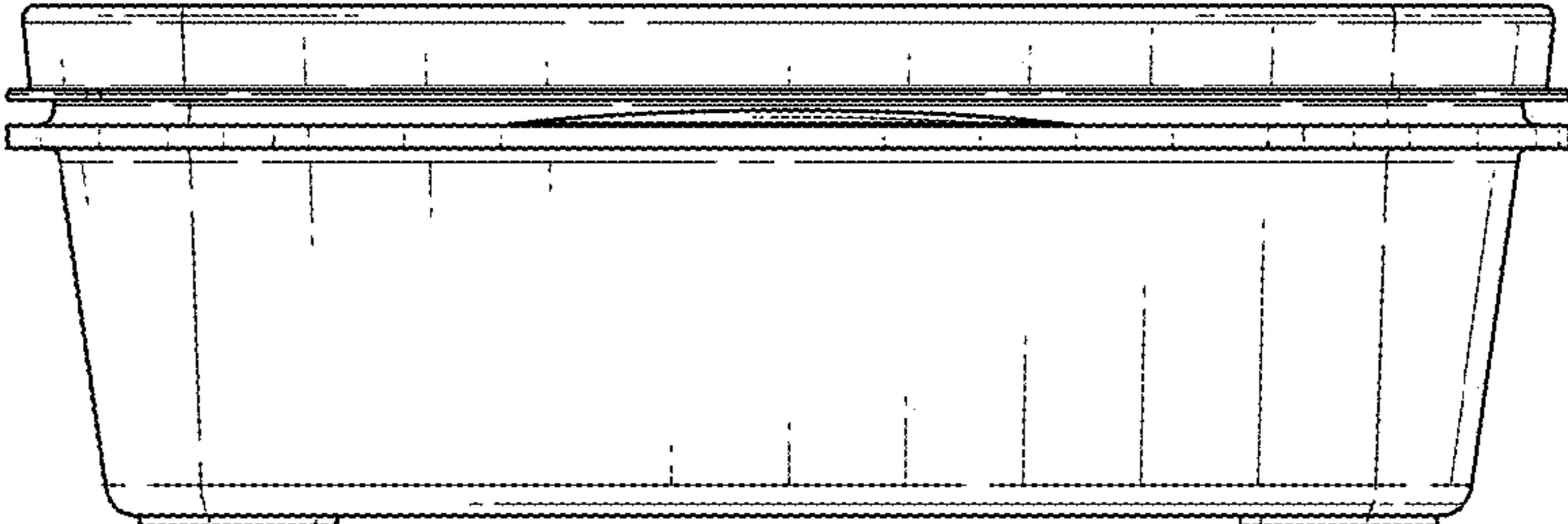

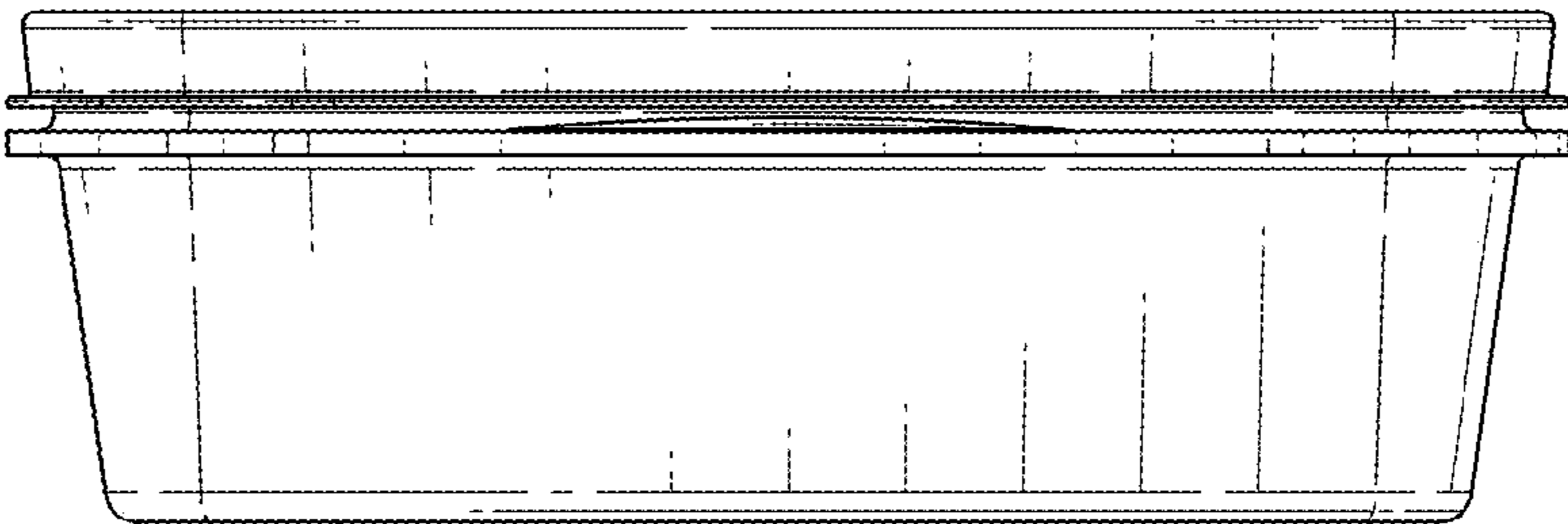

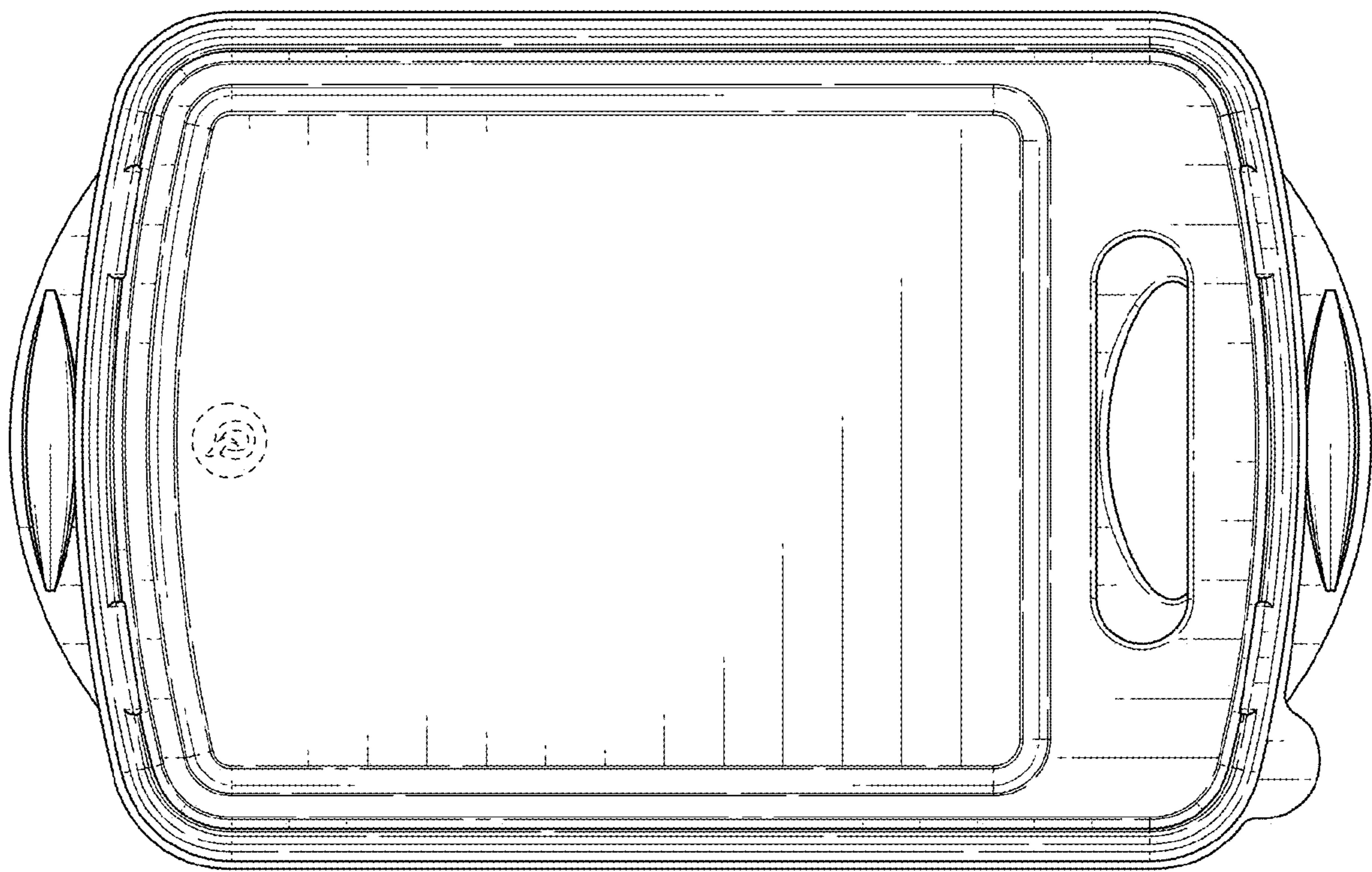

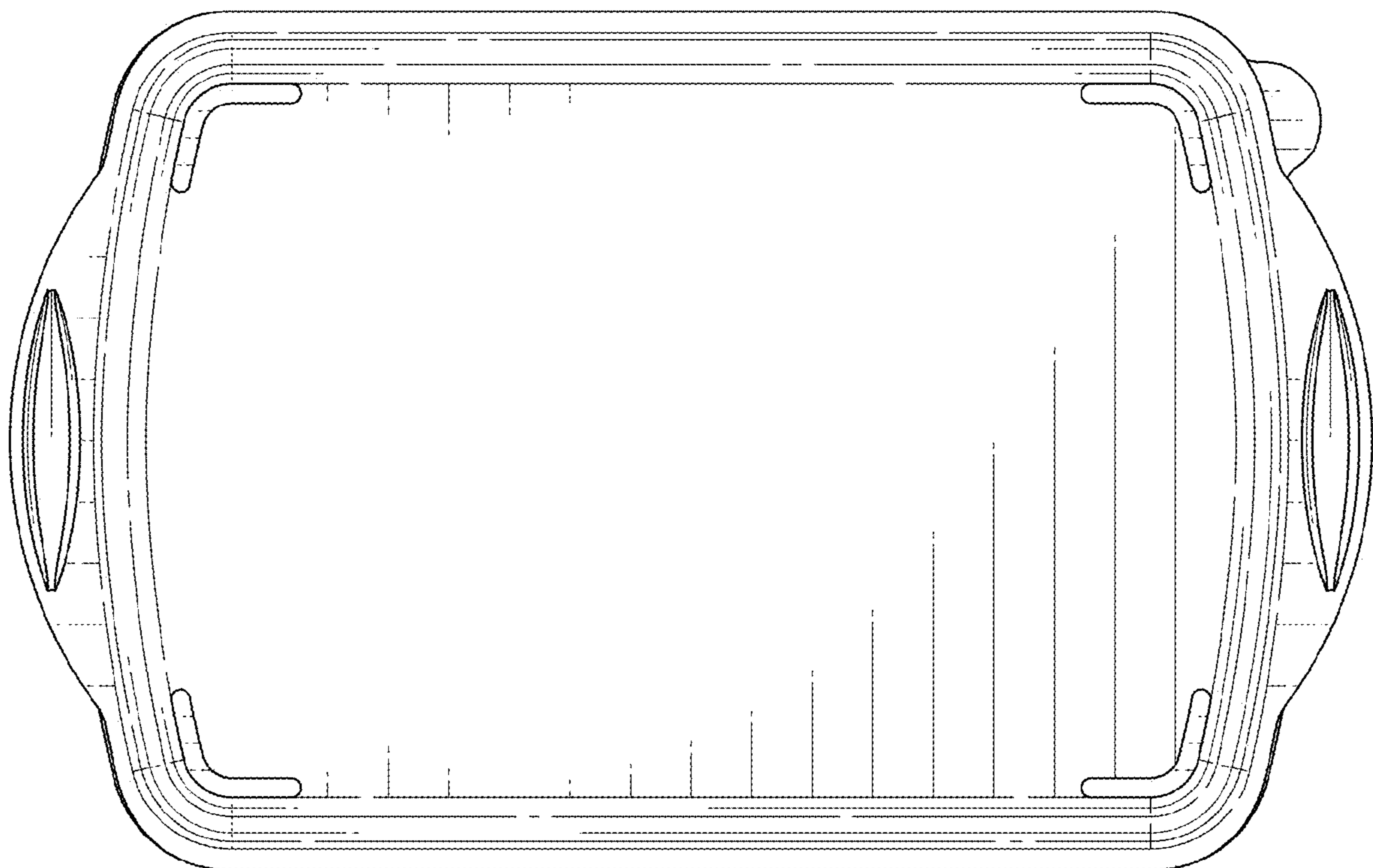

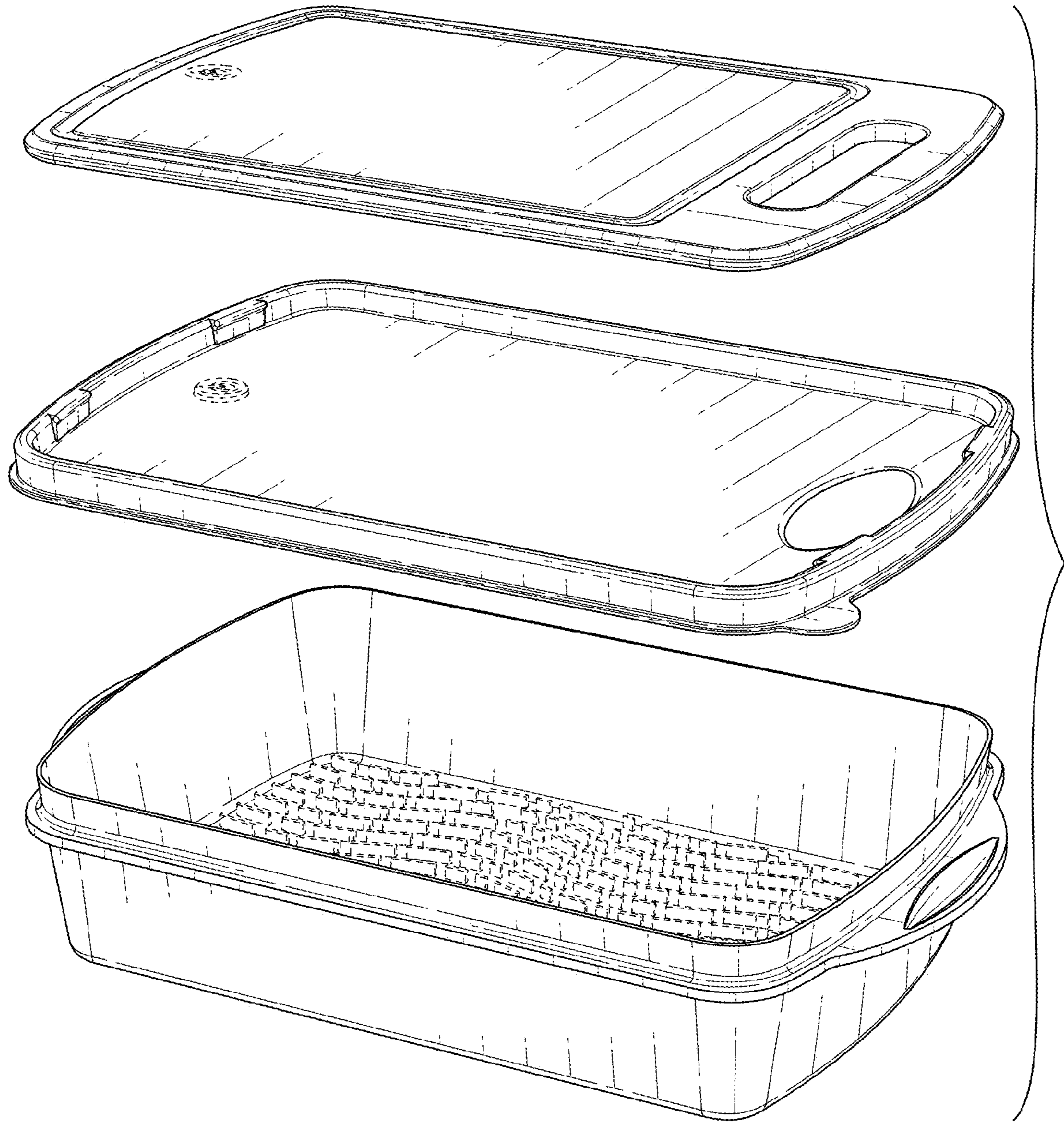
