(57) **CLAIM**

The ornamental design for a beverage container insulator, as shown and described.

DESCRIPTION

FIG. 1 is a first perspective view of the beverage container insulator;

FIG. 2 is a right-side view of the beverage container insulator;

FIG. 4 is a rear view of the beverage container insulator;

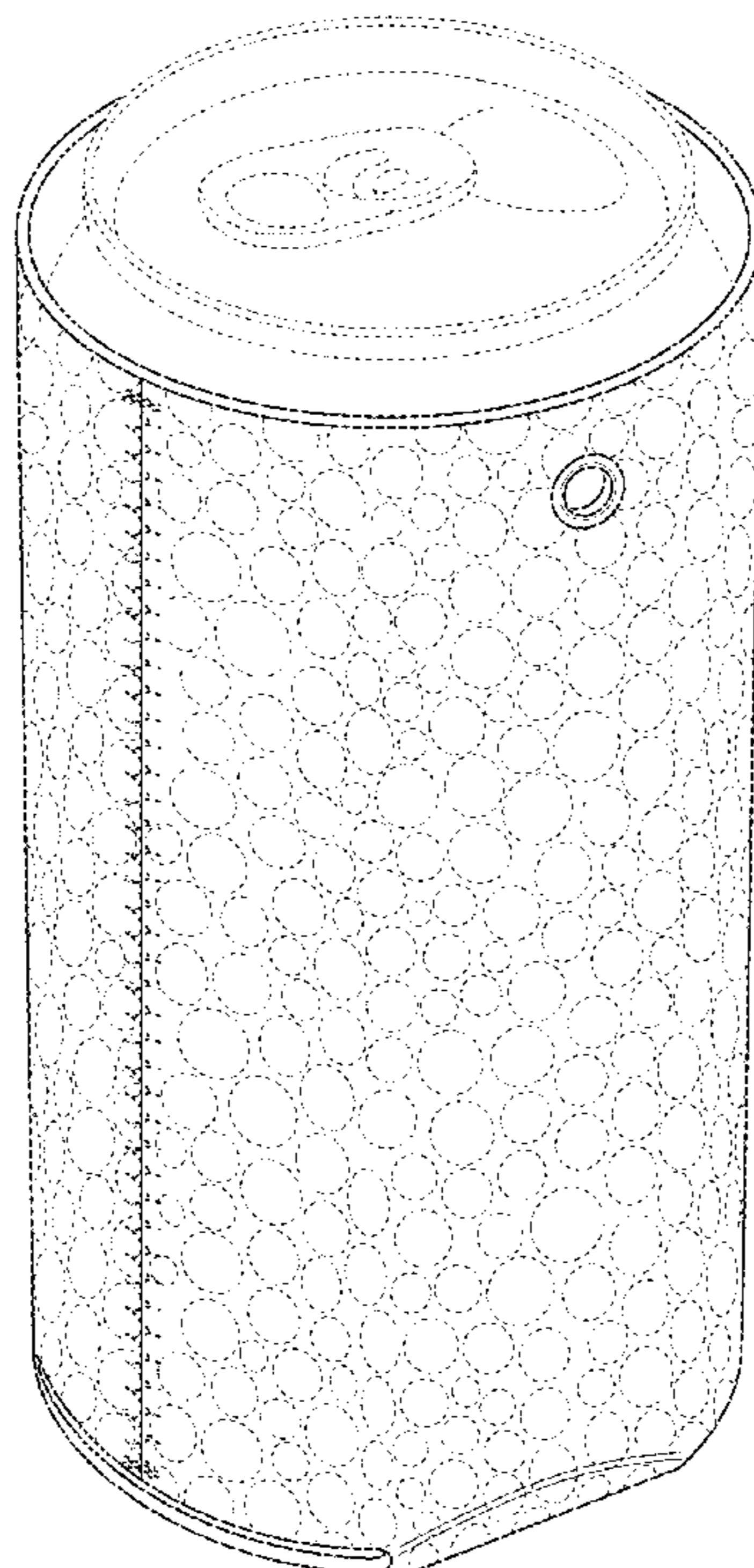
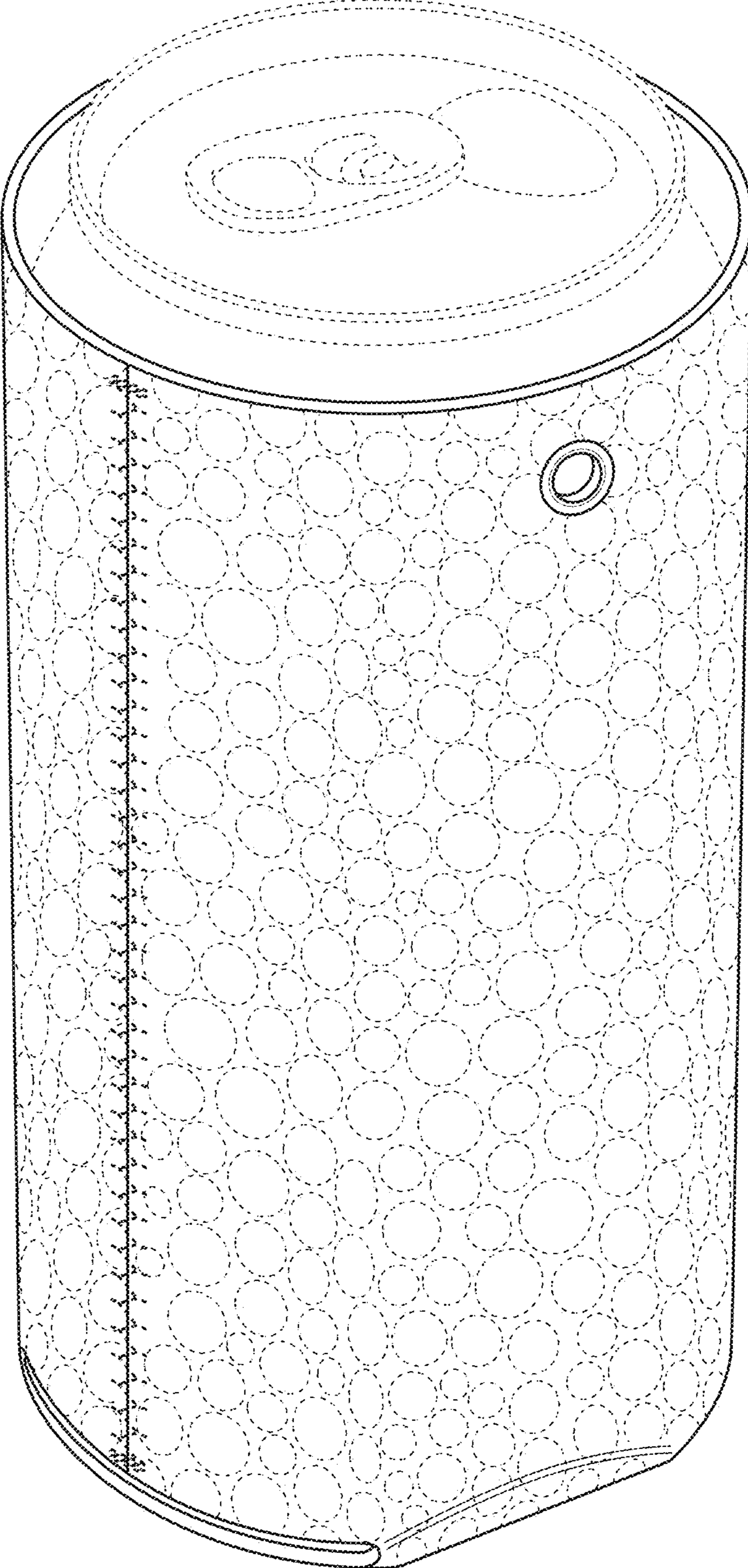

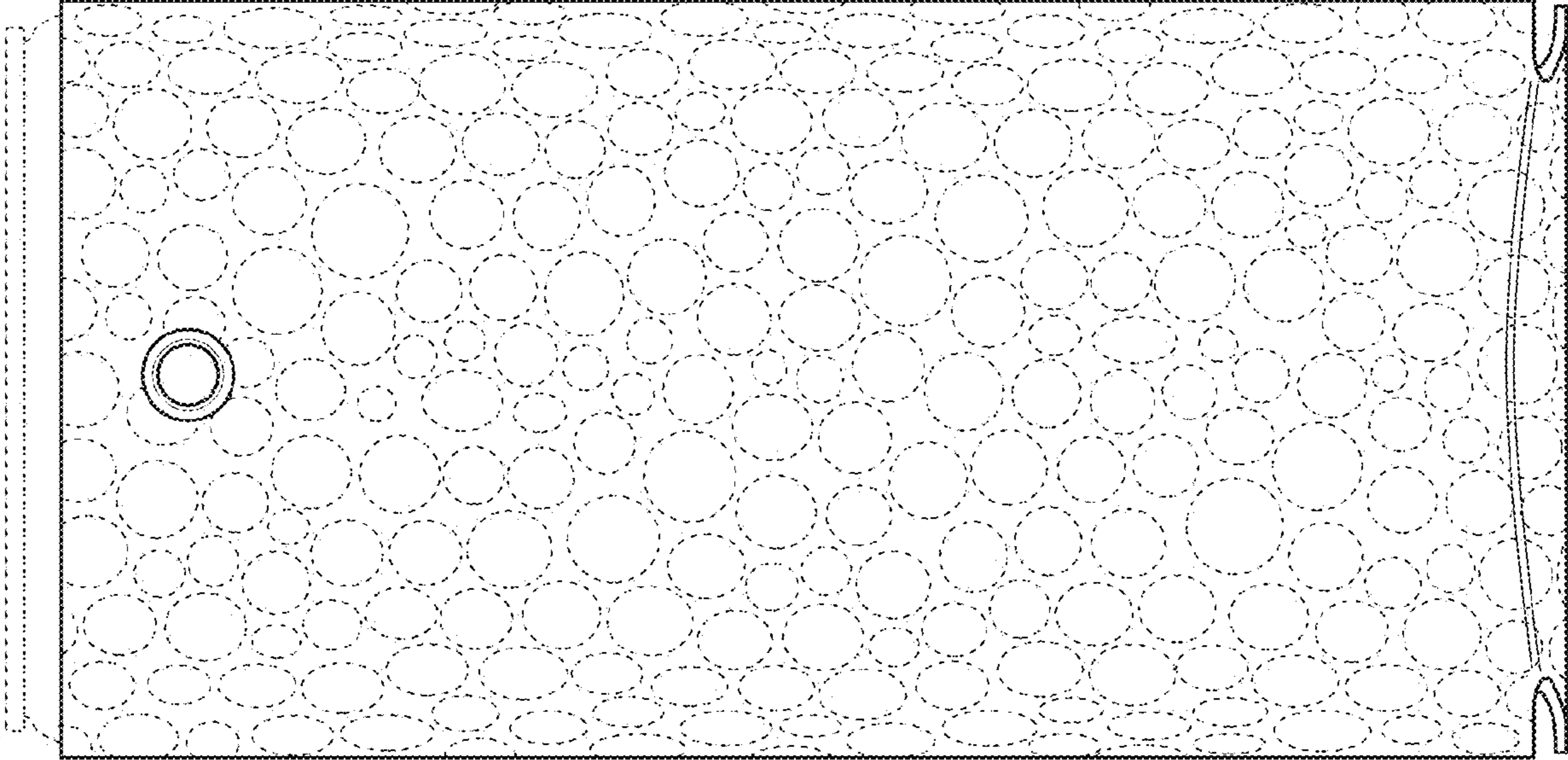

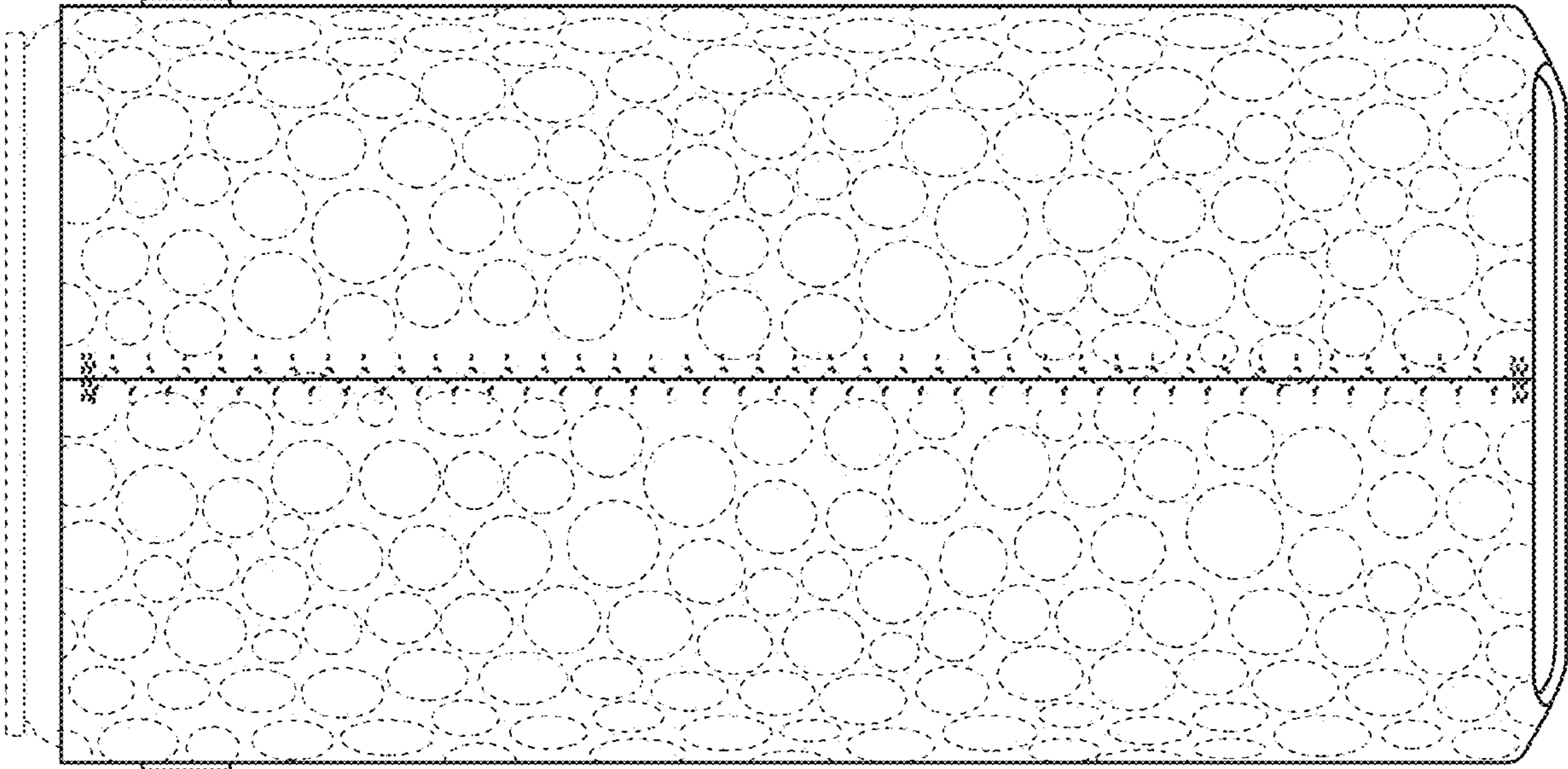

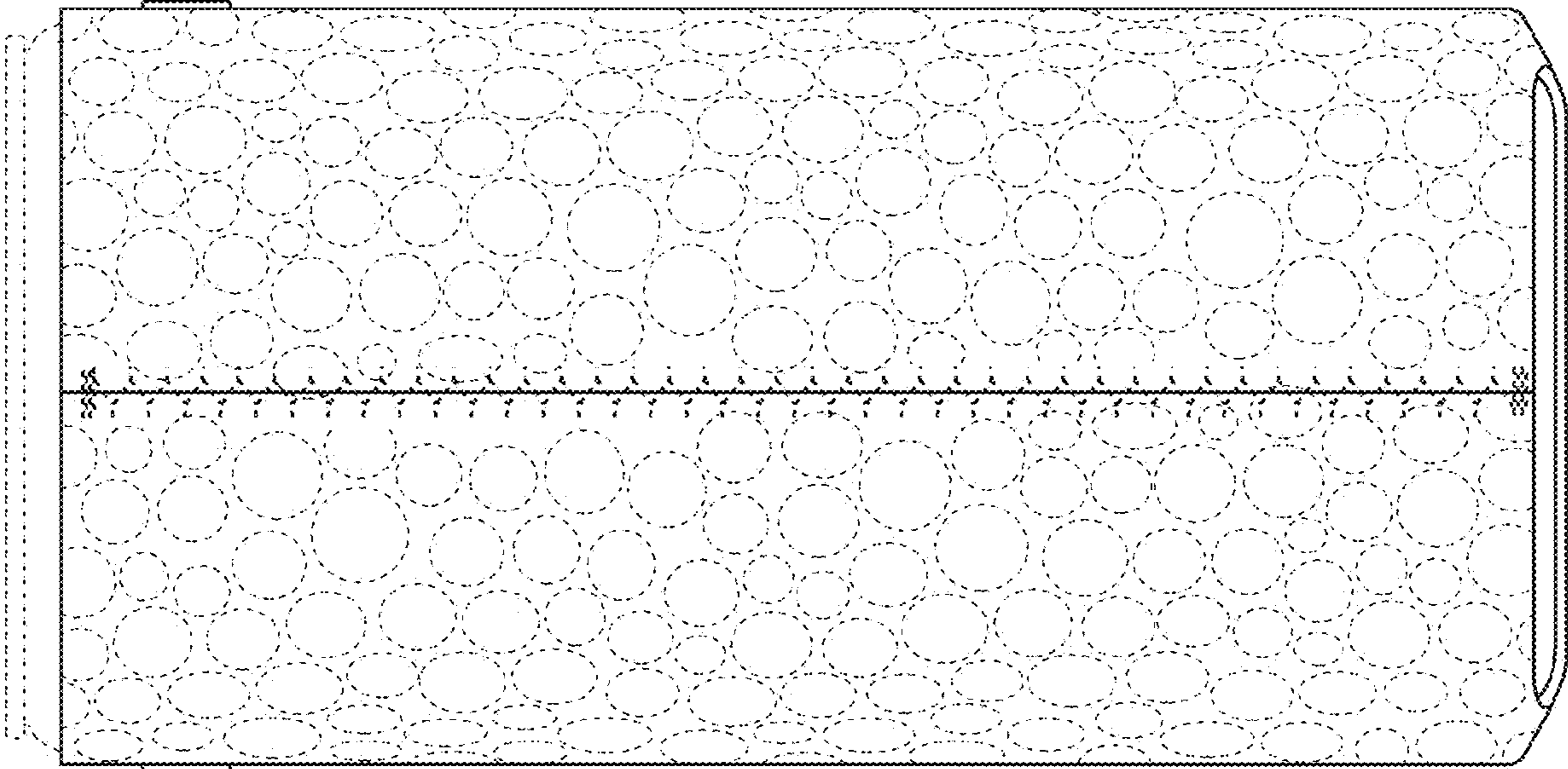

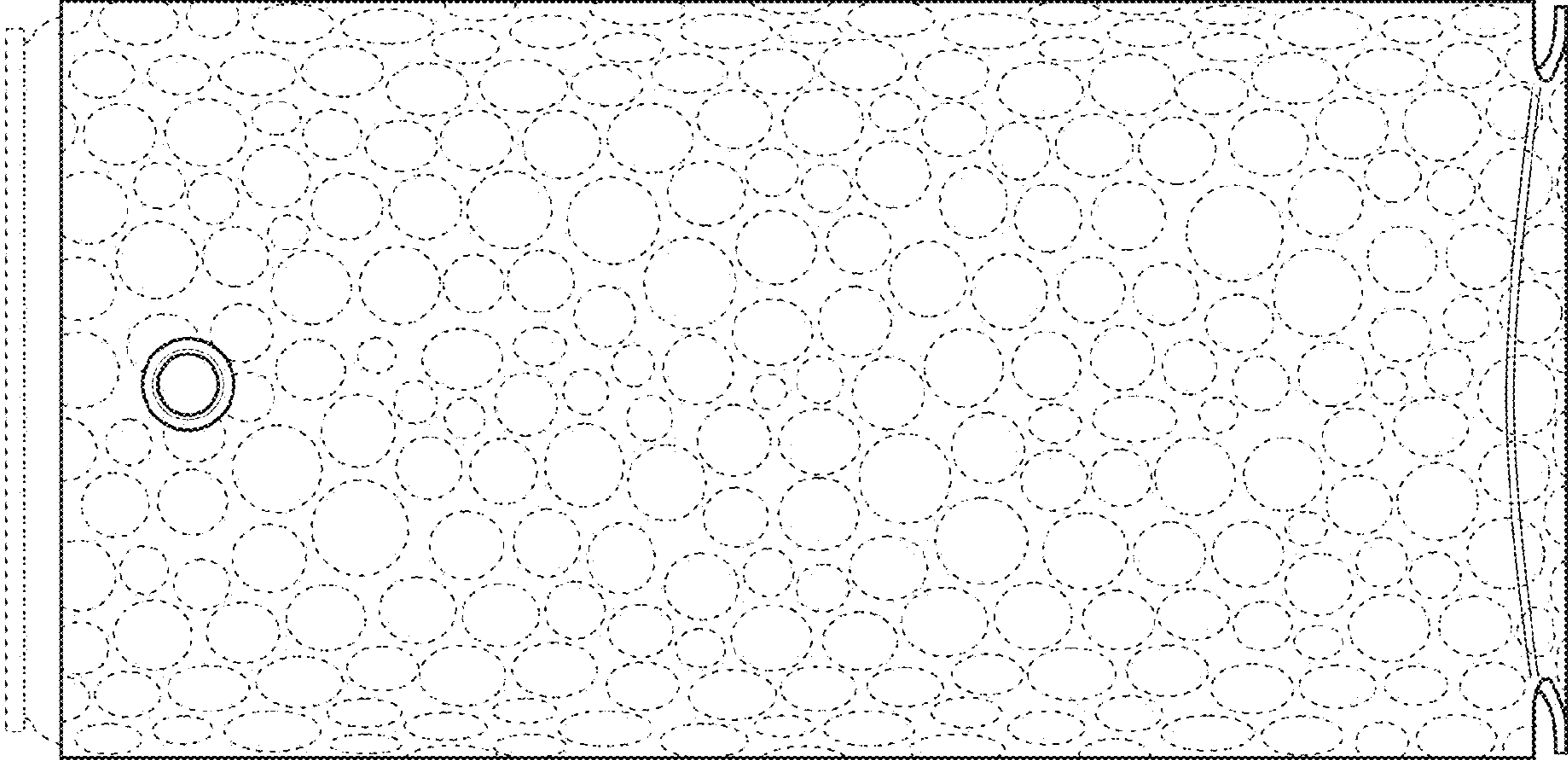

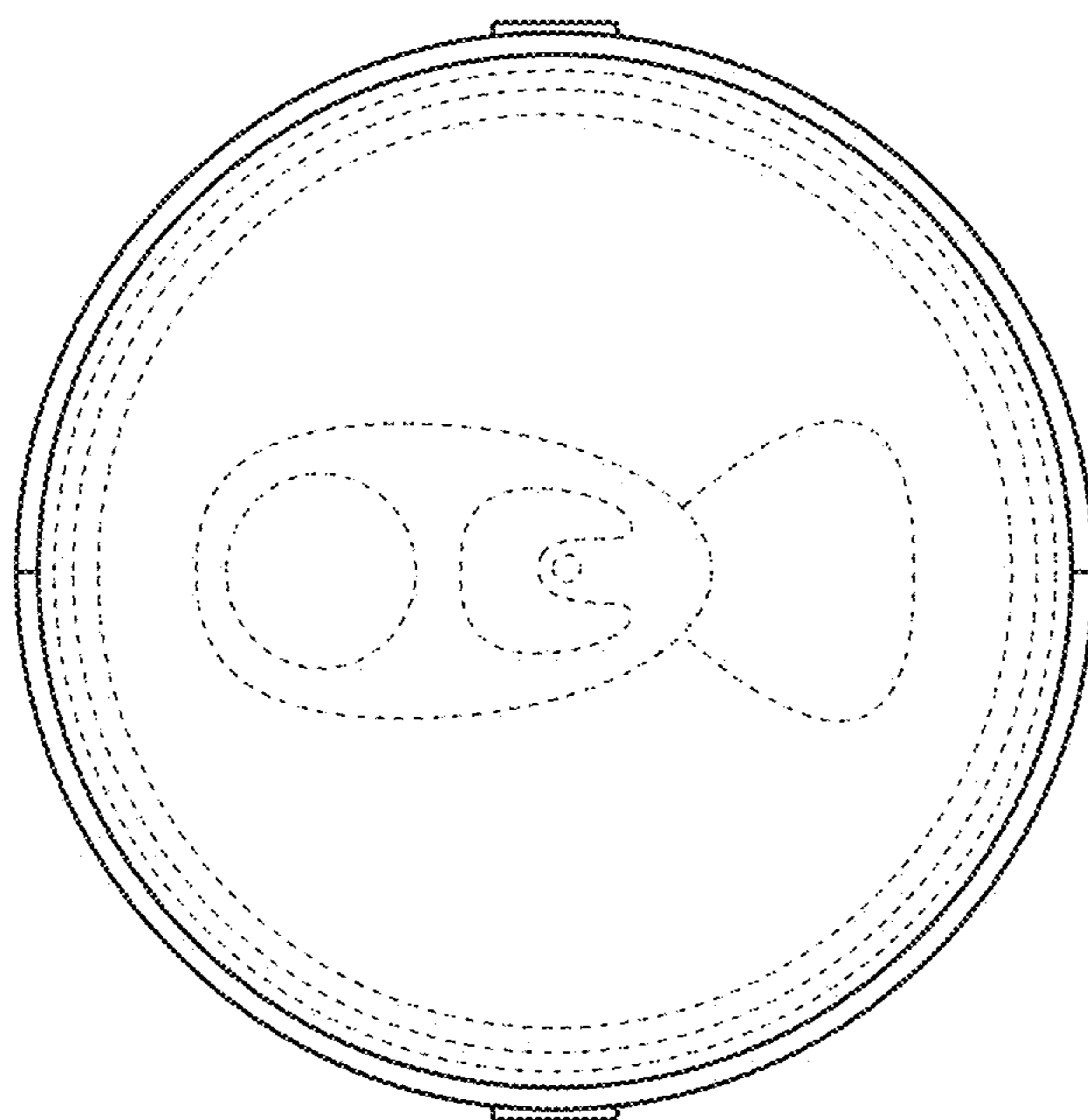

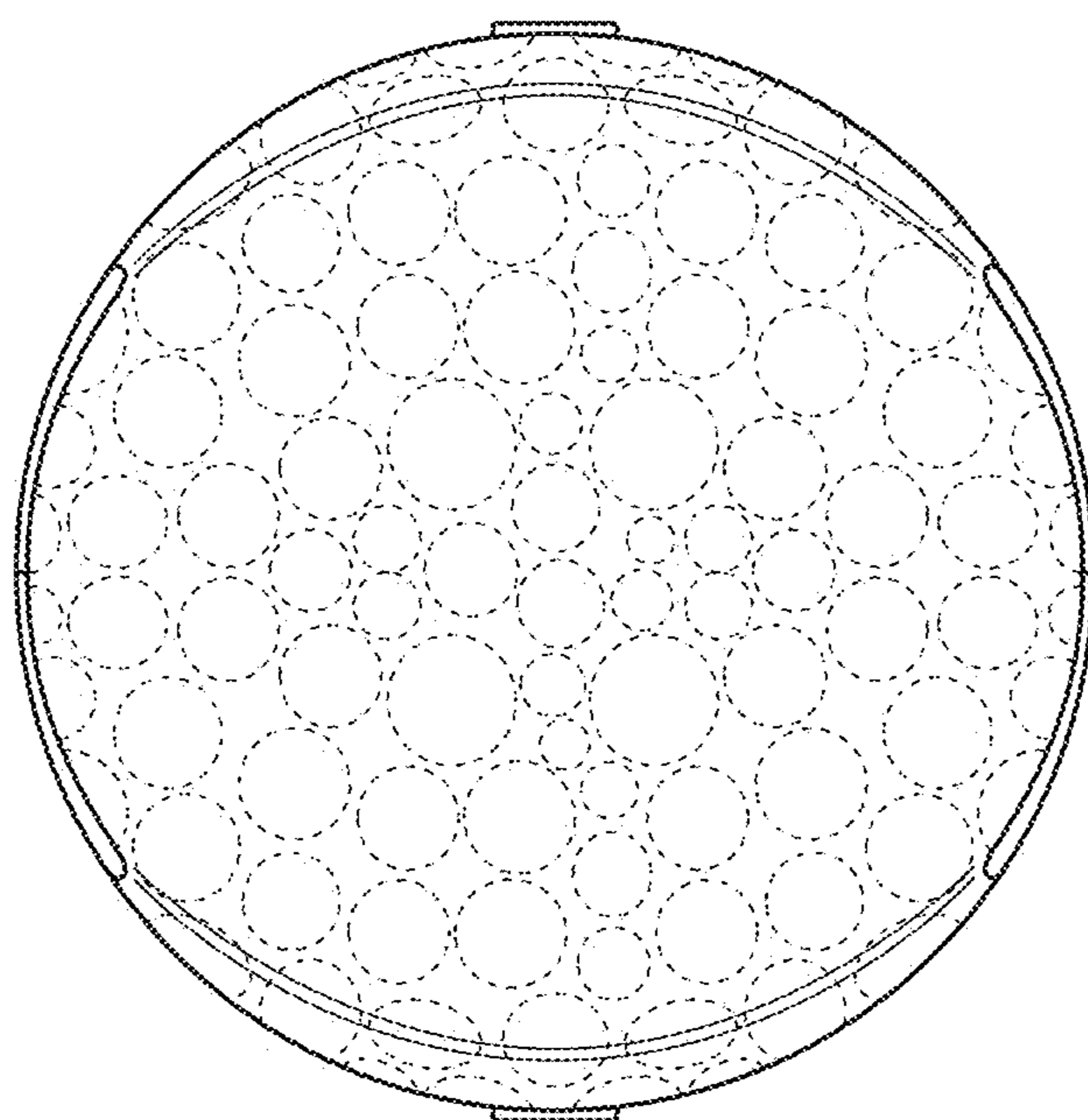

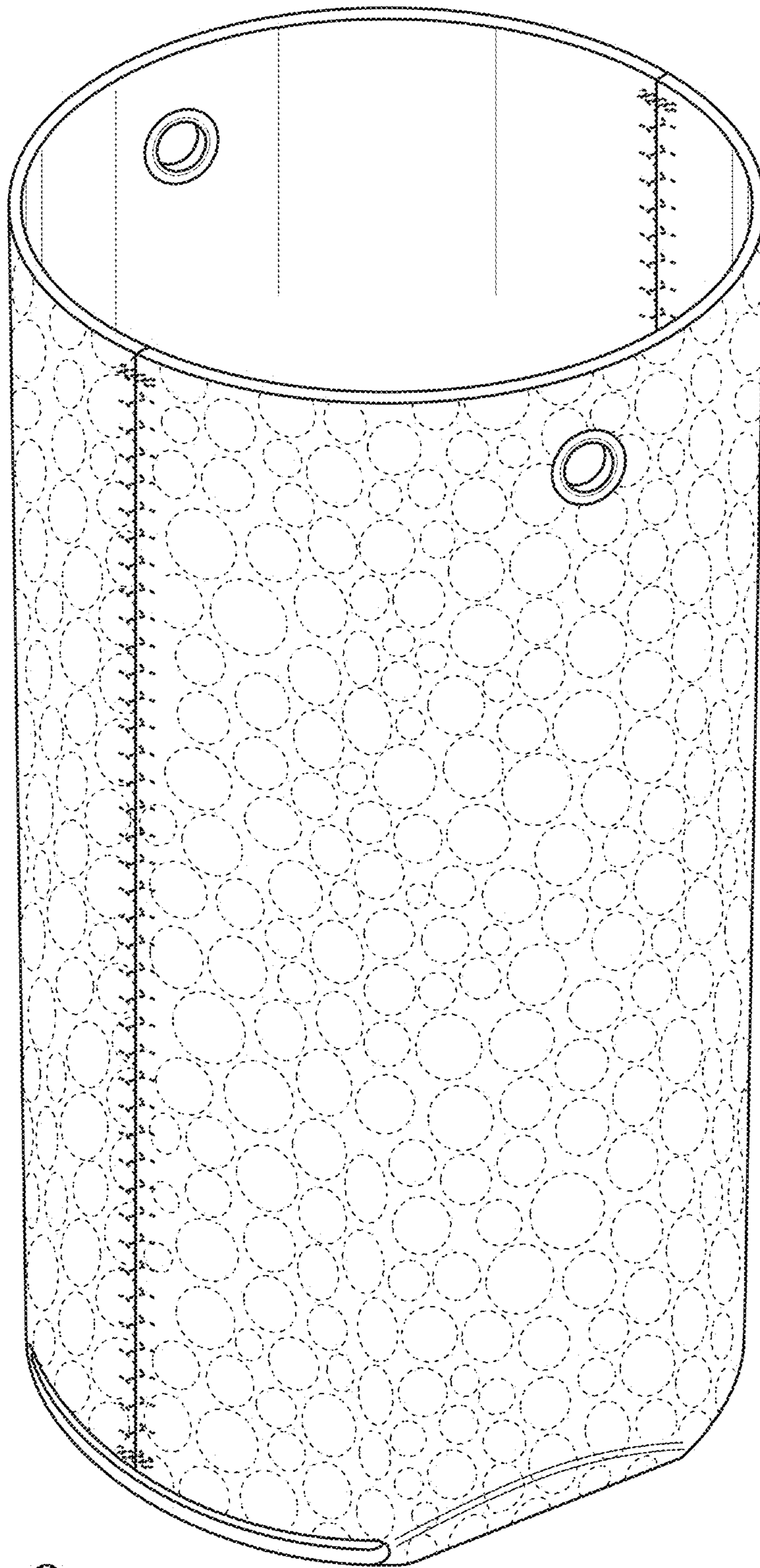
