The ornamental design for a container, as shown and described.

DESCRIPTION

FIG. 1 is a front, top and right-side perspective view of a container showing a first embodiment of our new design; FIG. 2 is a front view thereof; FIG. 3 is a rear view thereof; FIG. 4 is a top view thereof; FIG. 5 is a bottom view thereof; FIG. 6 is a right-side view thereof; FIG. 7 is a left-side view thereof; FIG. 8 is a front, top and right-side perspective view of a container showing a second embodiment of our new design; FIG. 9 is a front view thereof; FIG. 10 is a rear view thereof; FIG. 11 is a top view thereof; FIG. 12 is a bottom view thereof; FIG. 13 is a right-side view thereof; and, FIG. 14 is a left-side view thereof. 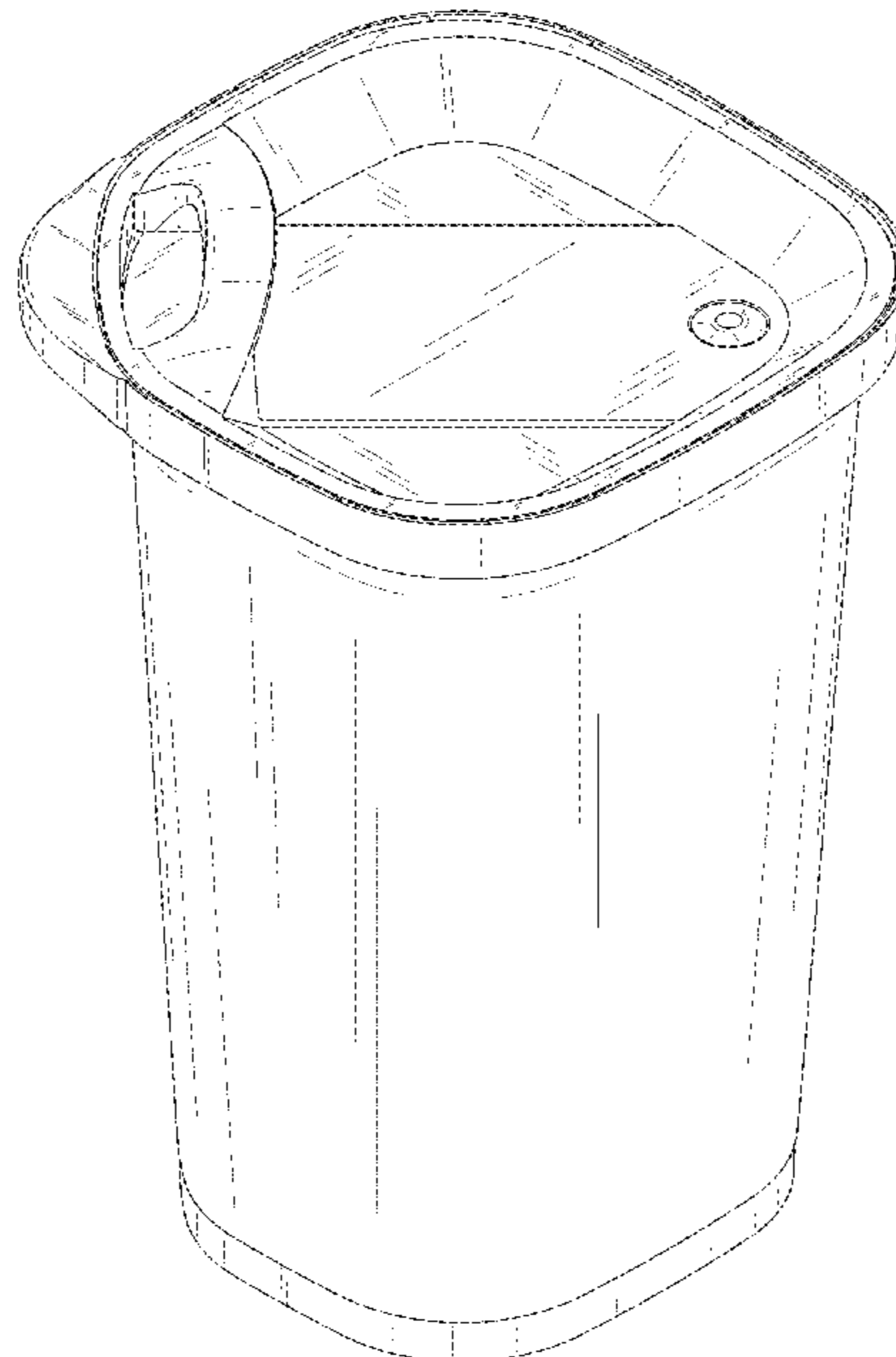

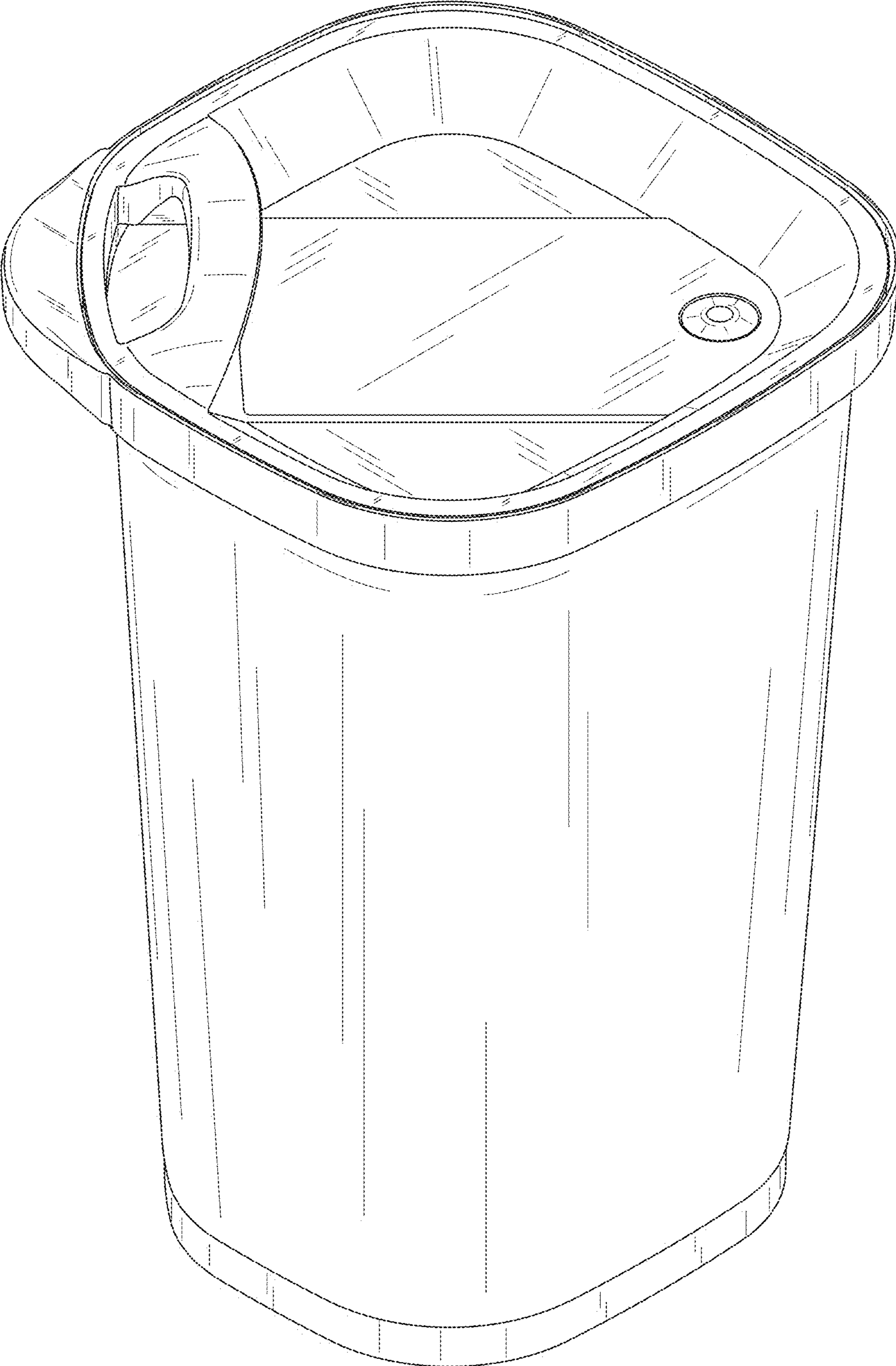

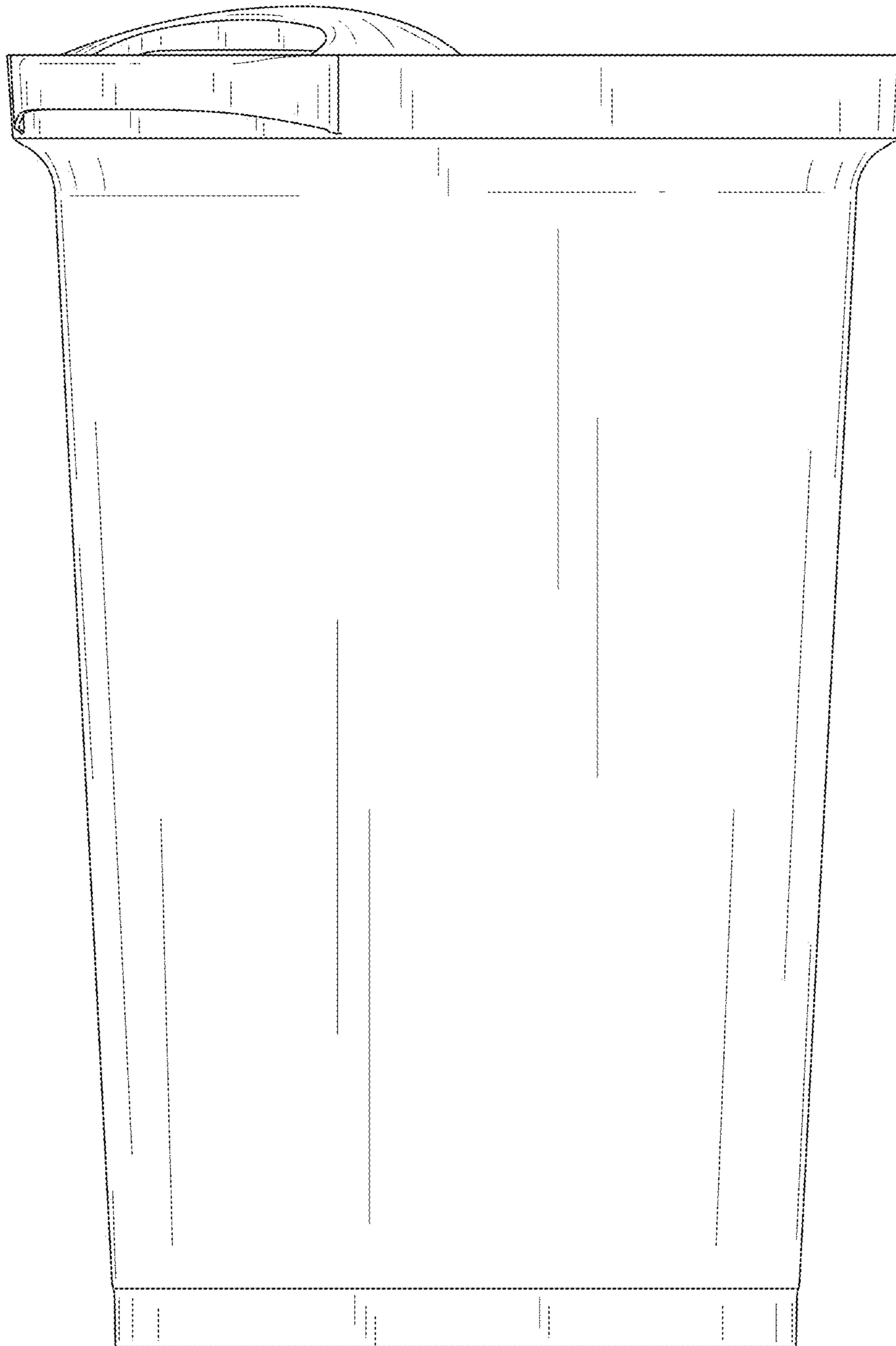

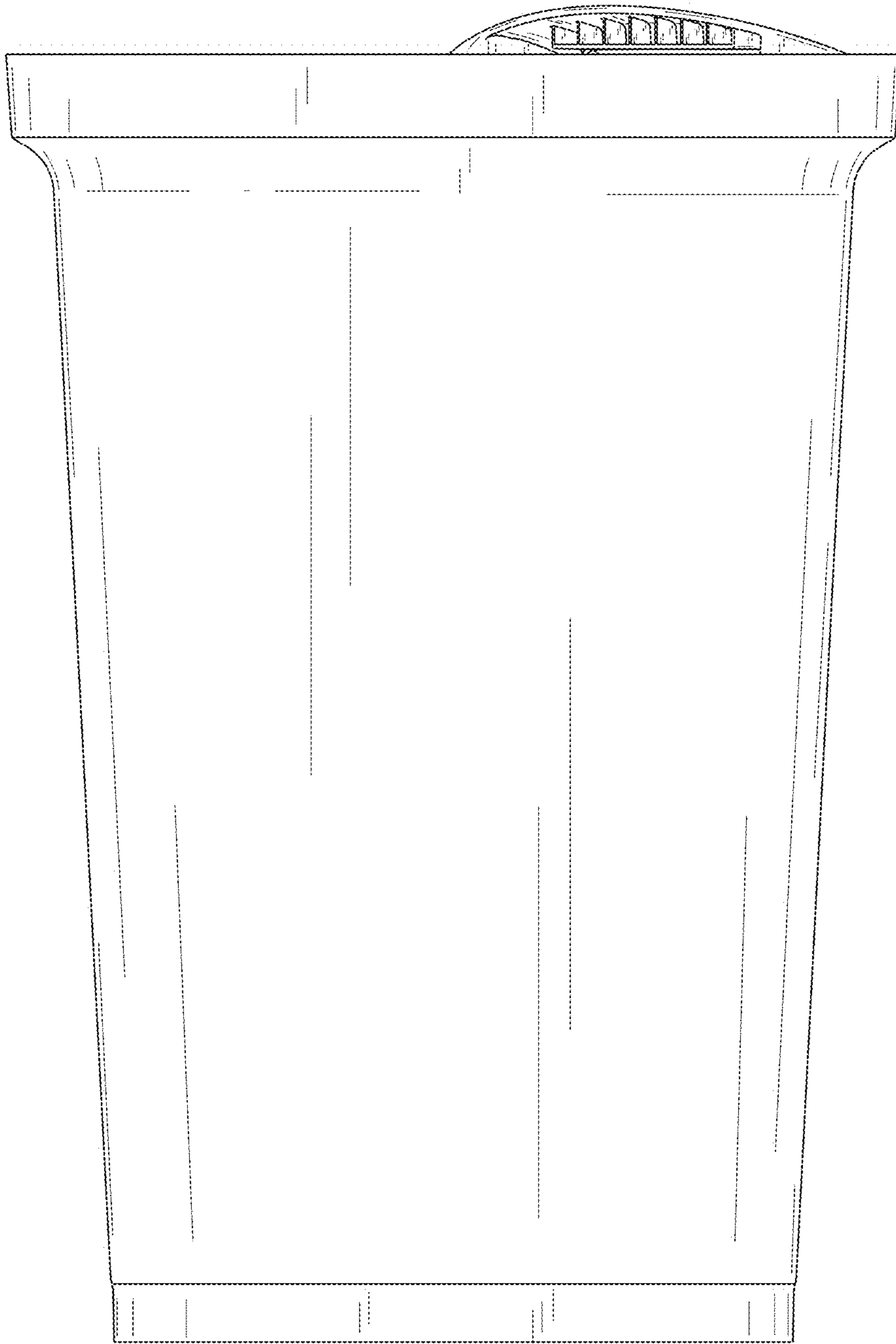

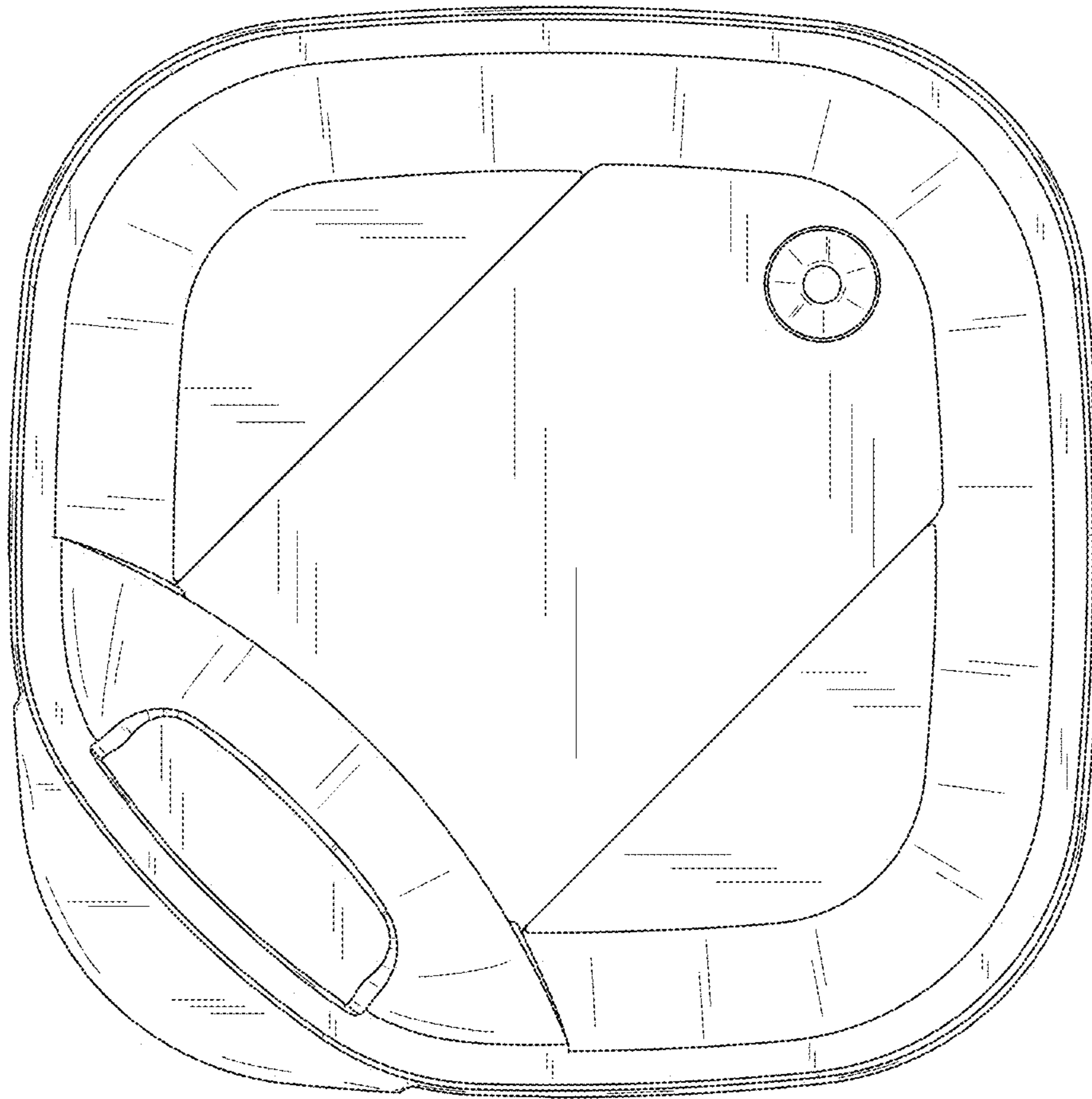

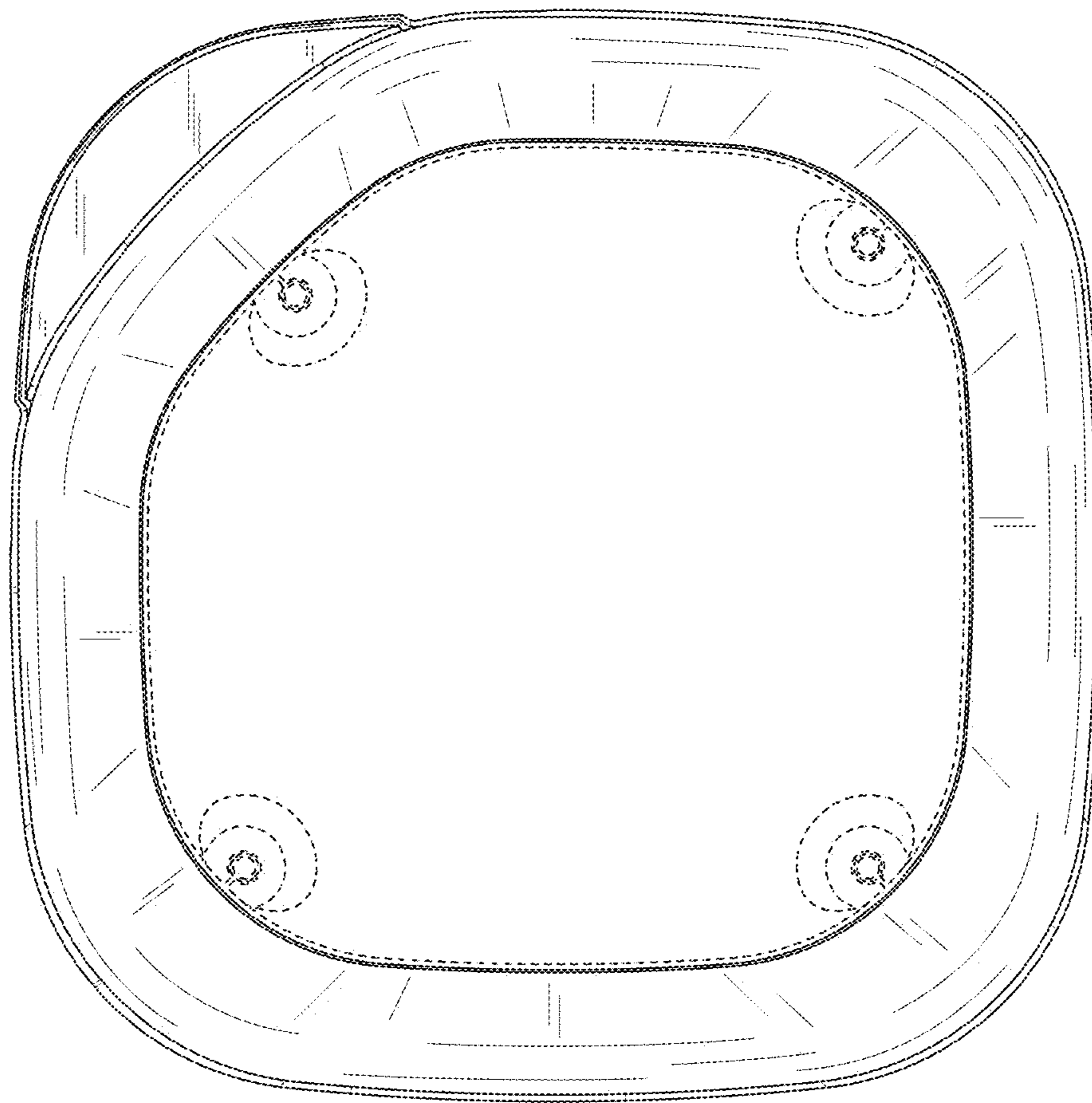

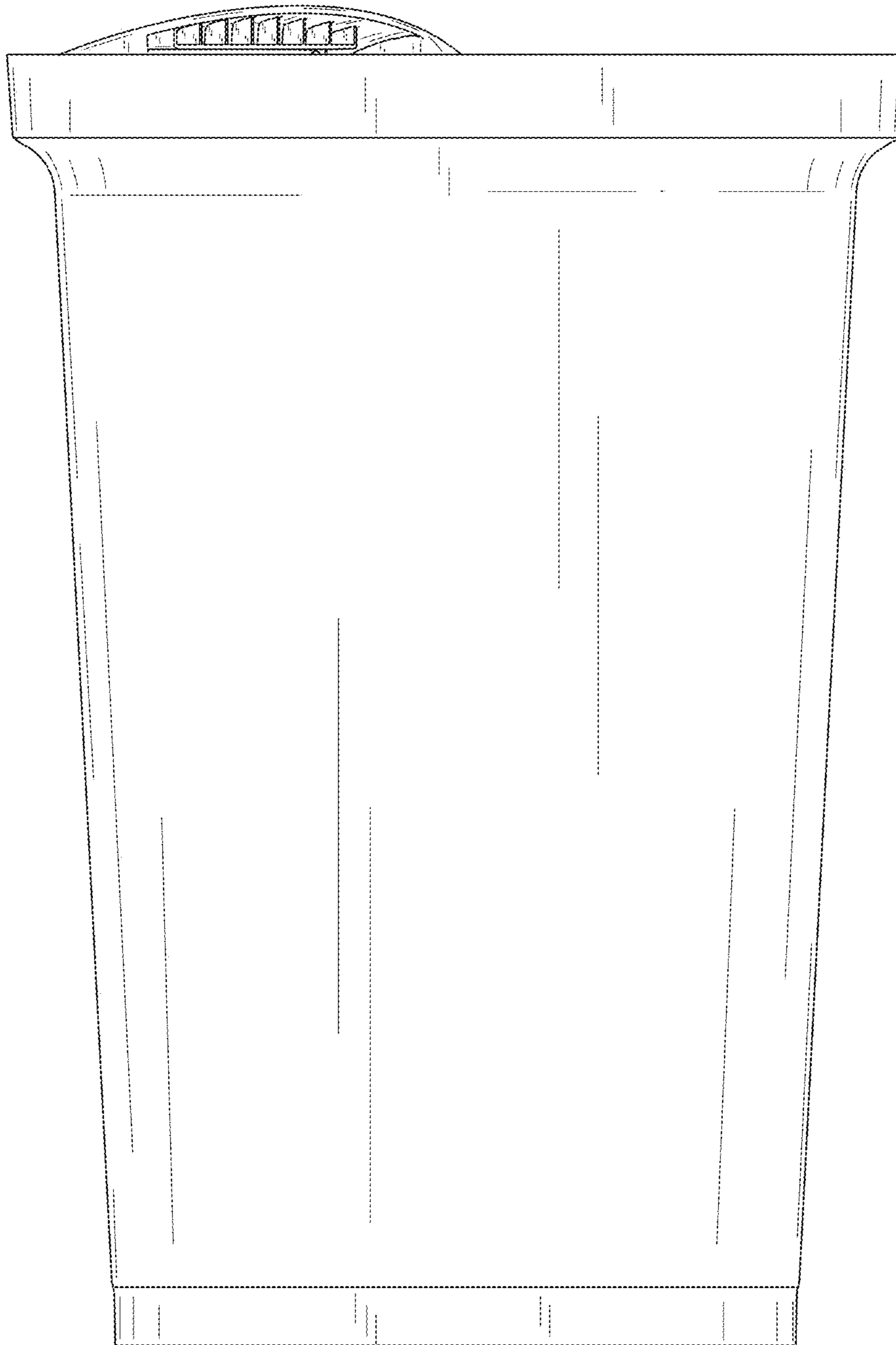

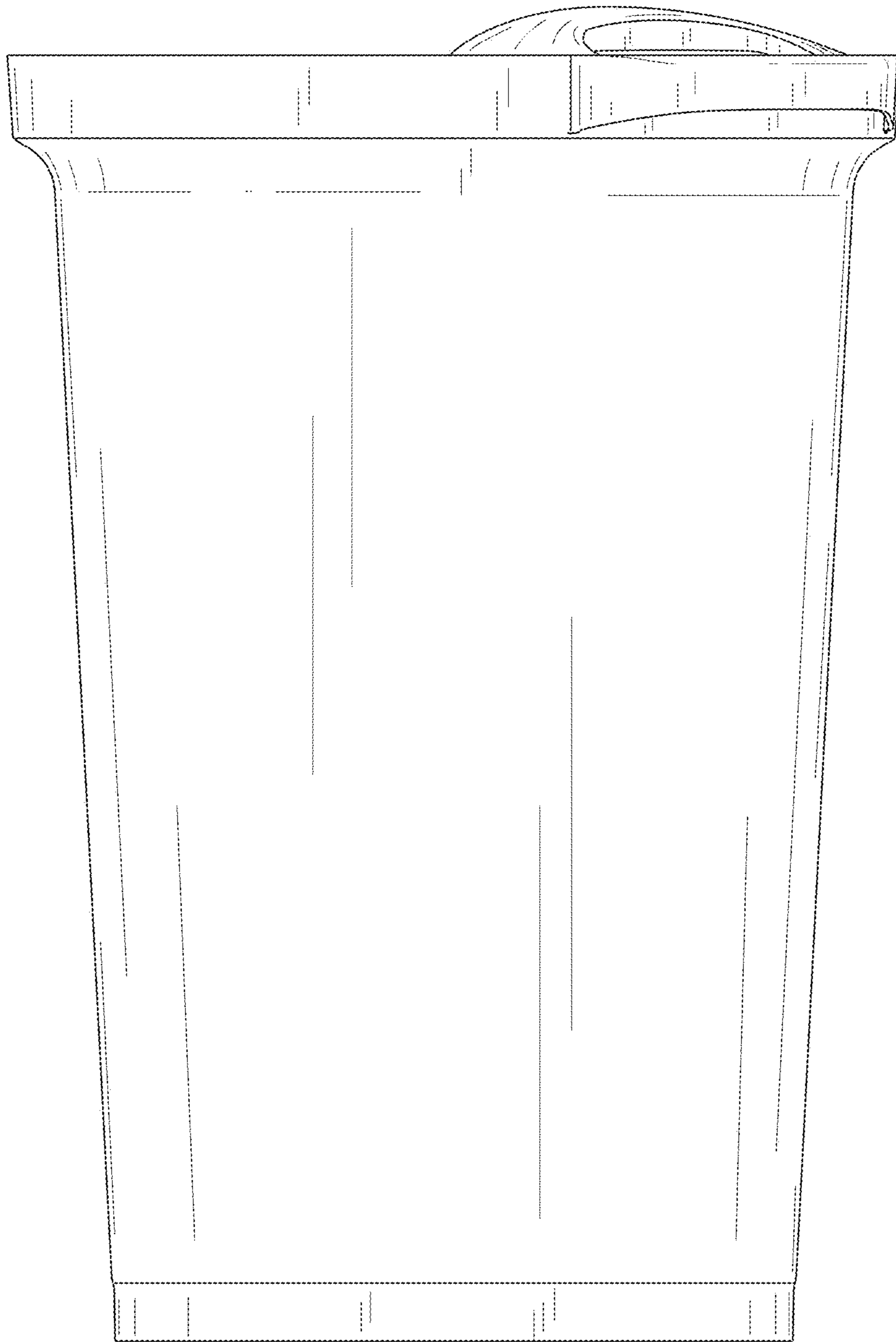

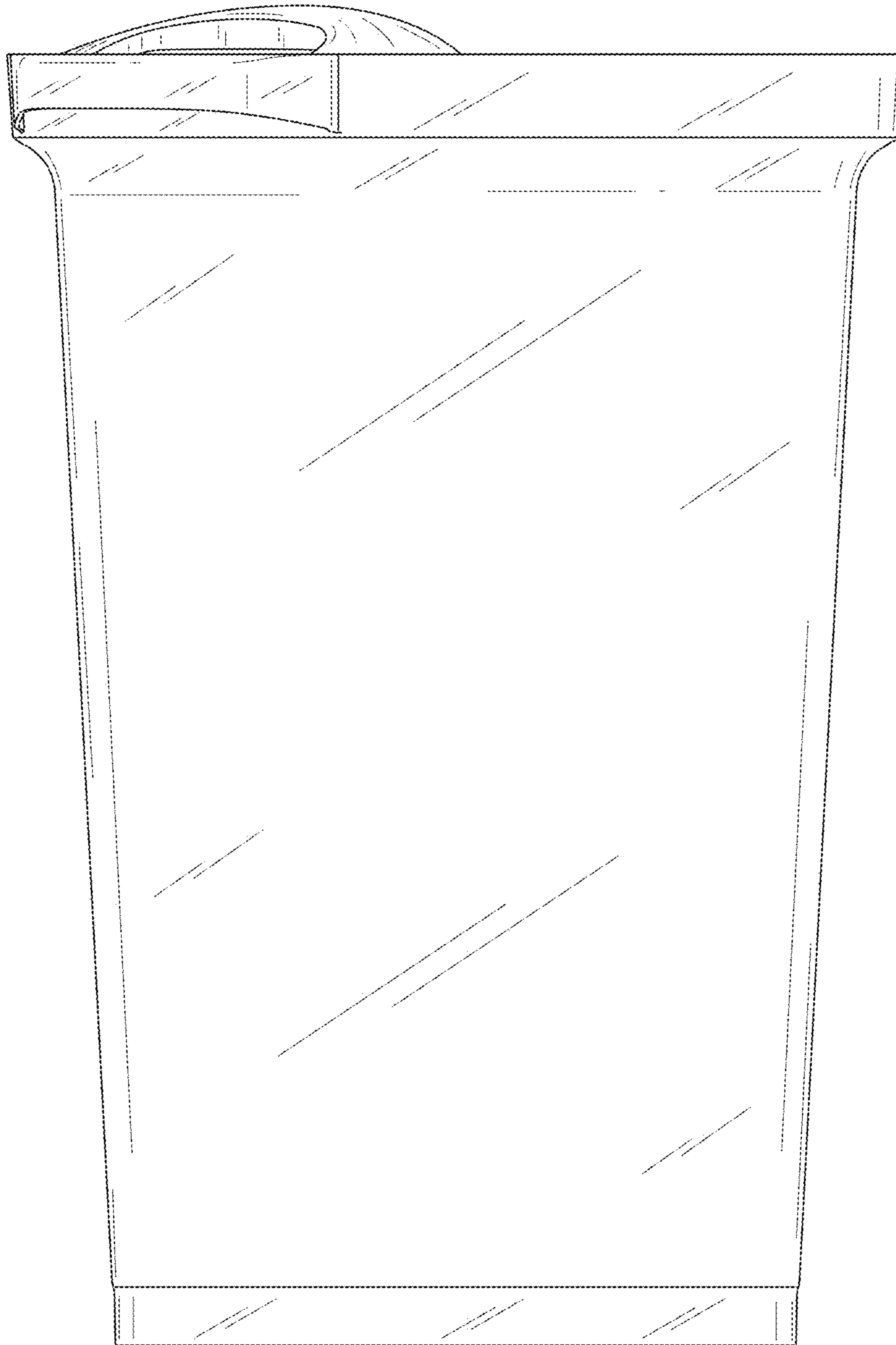

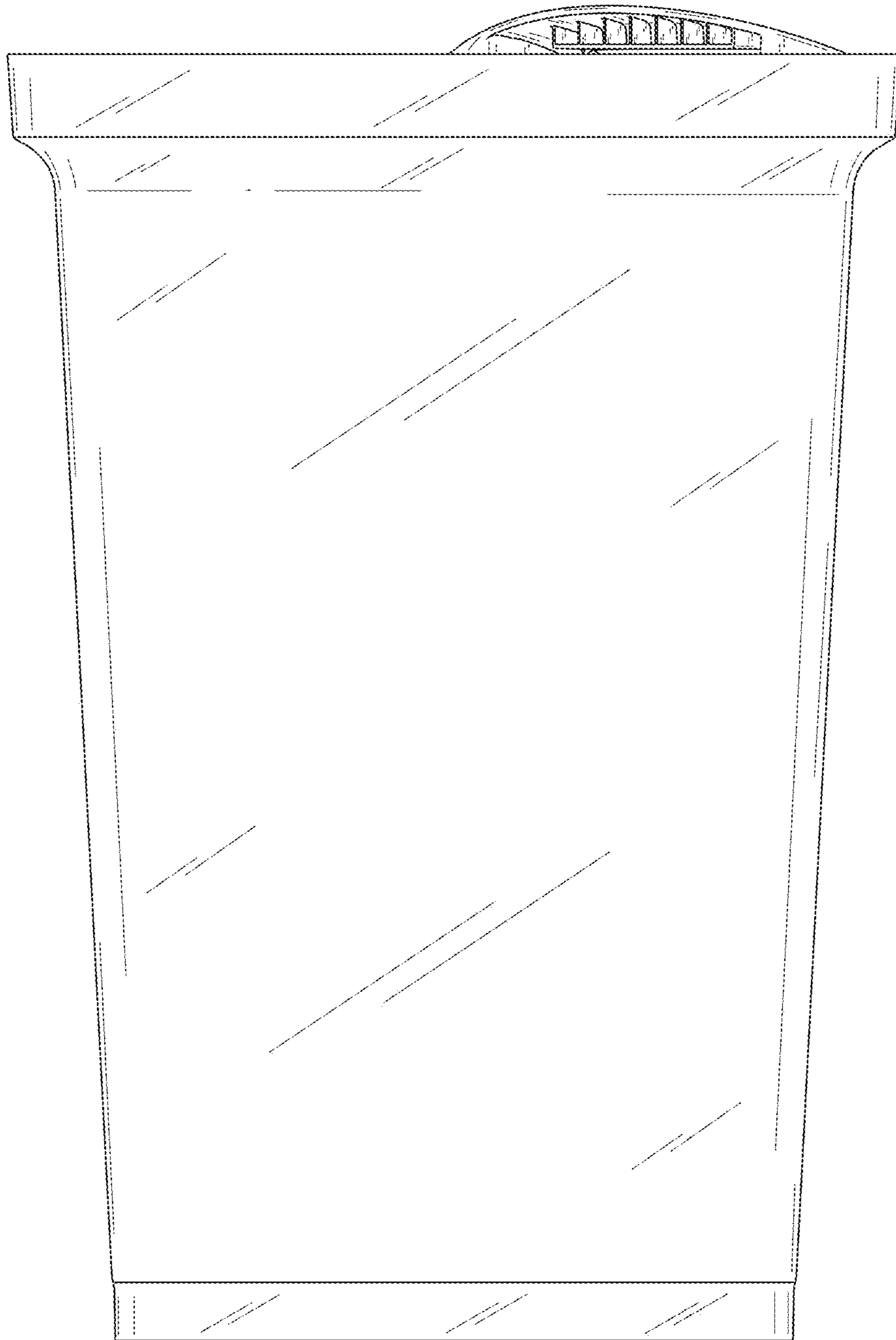

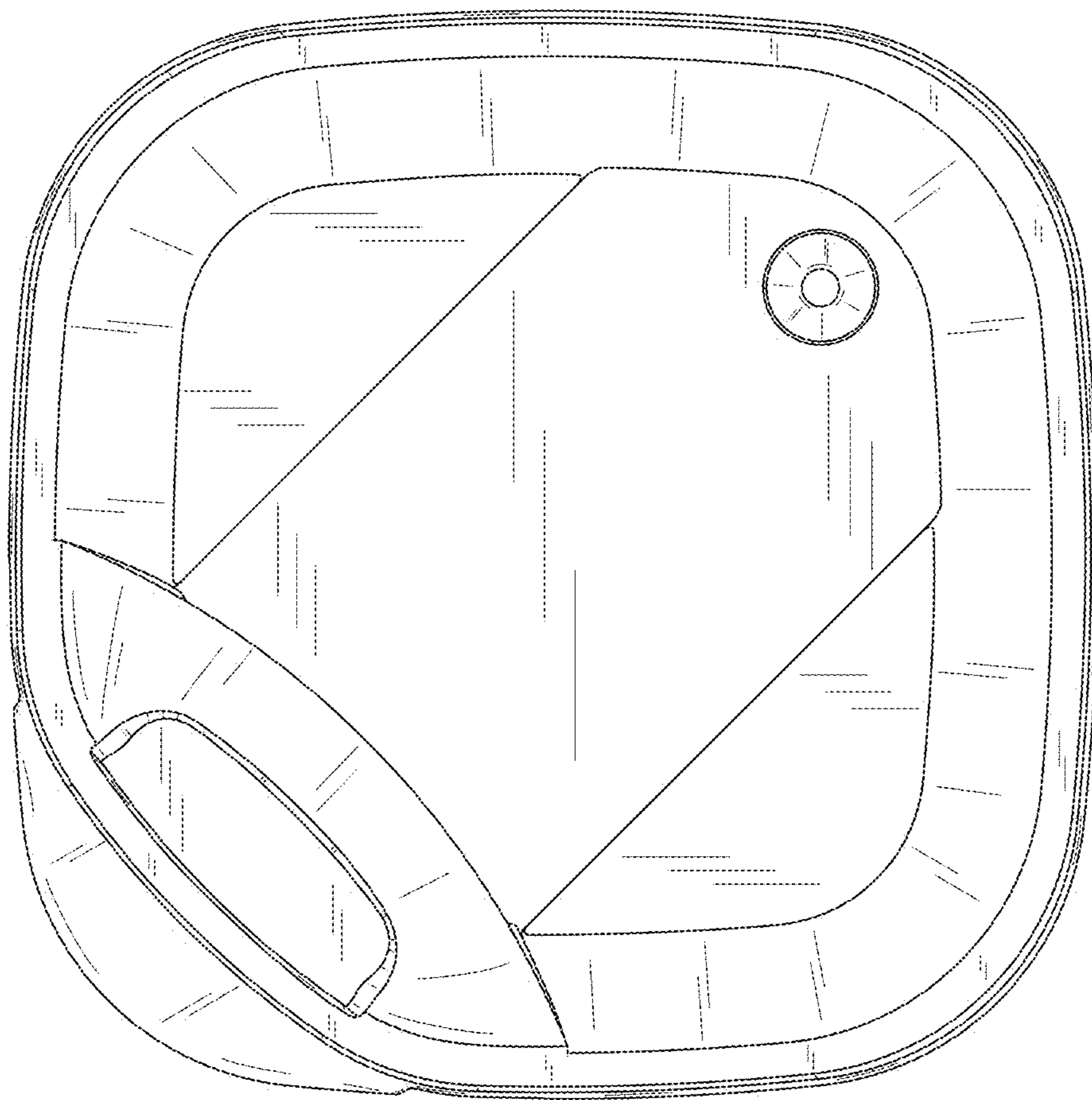

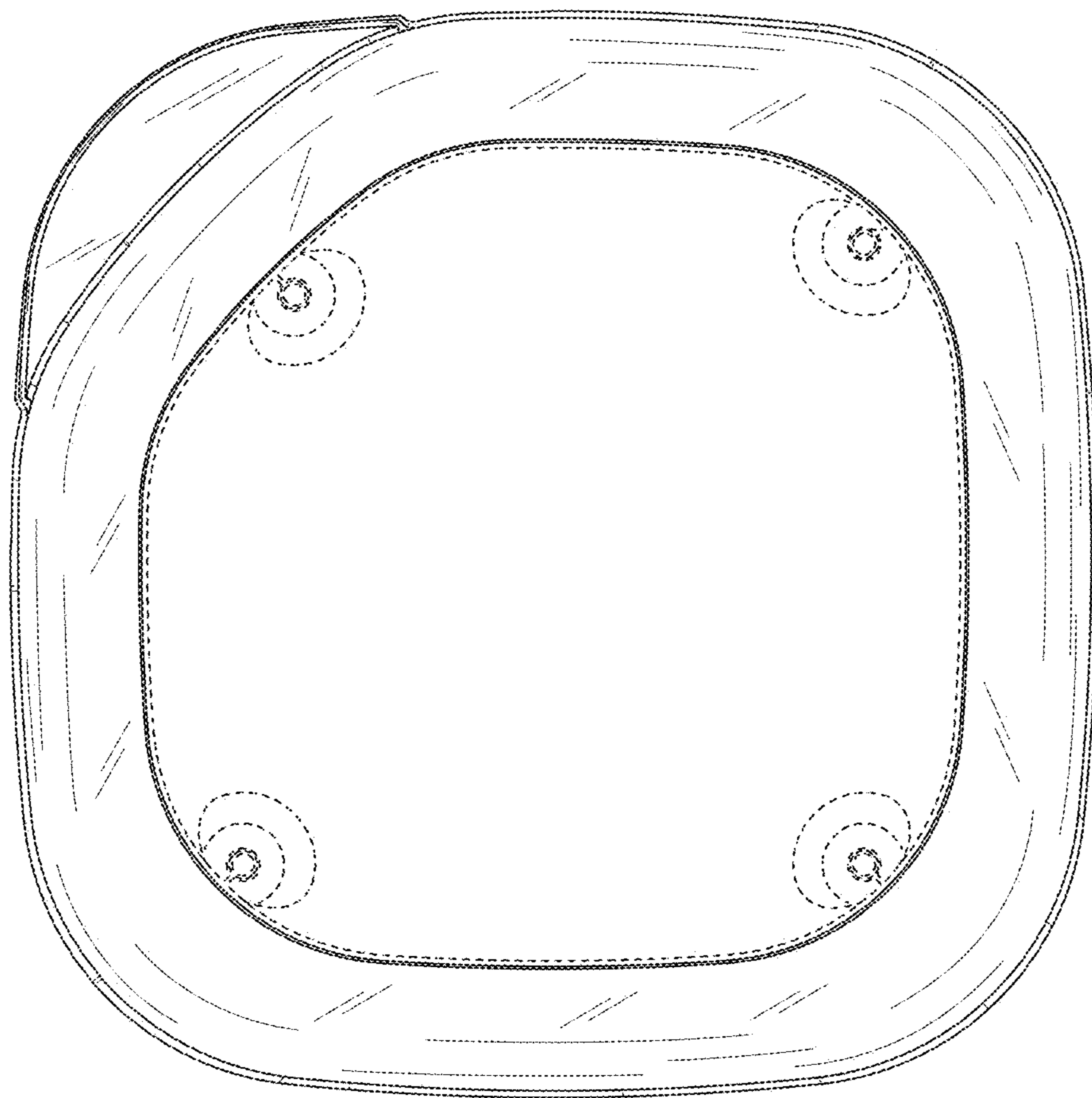

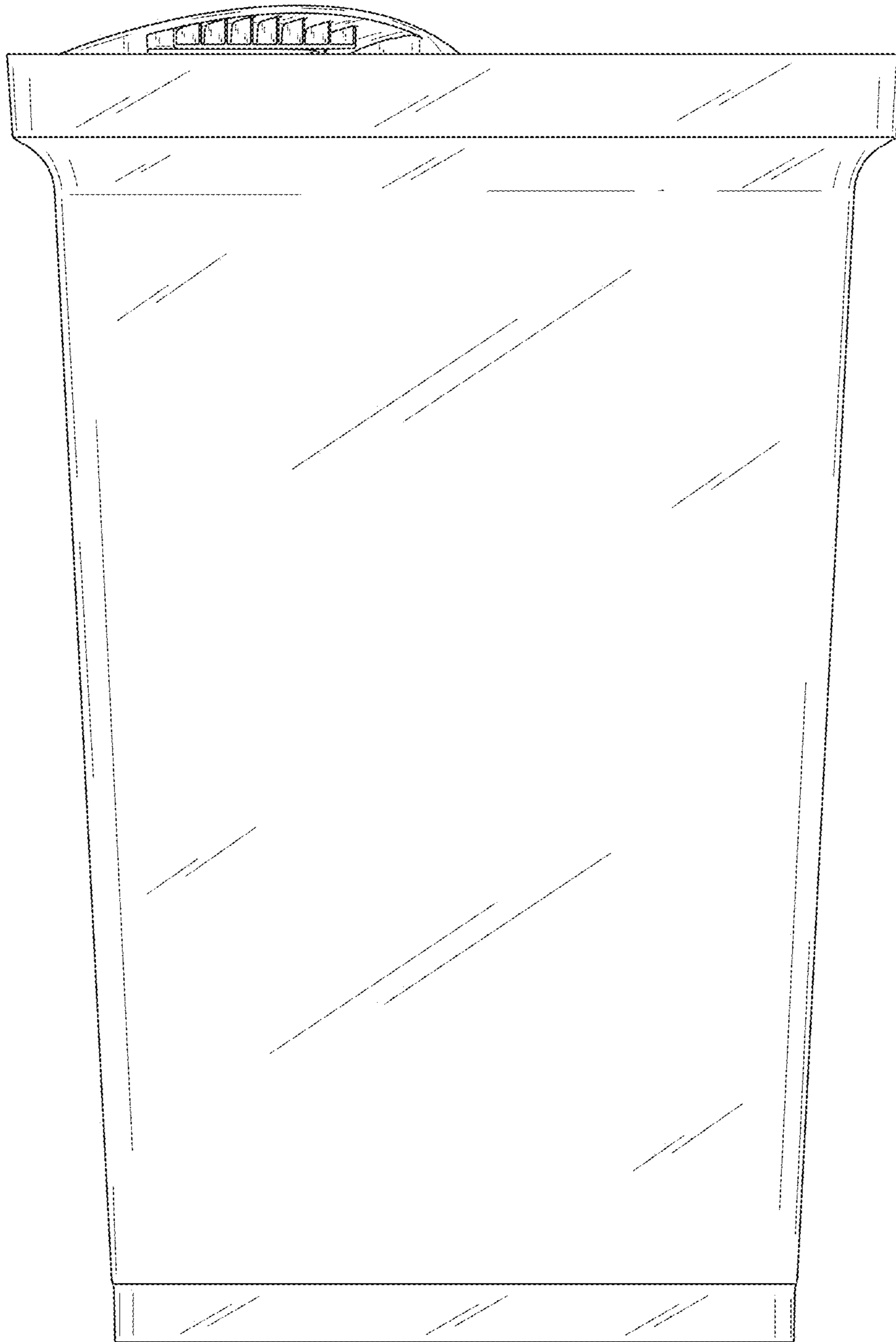
