**DESCRIPTION**

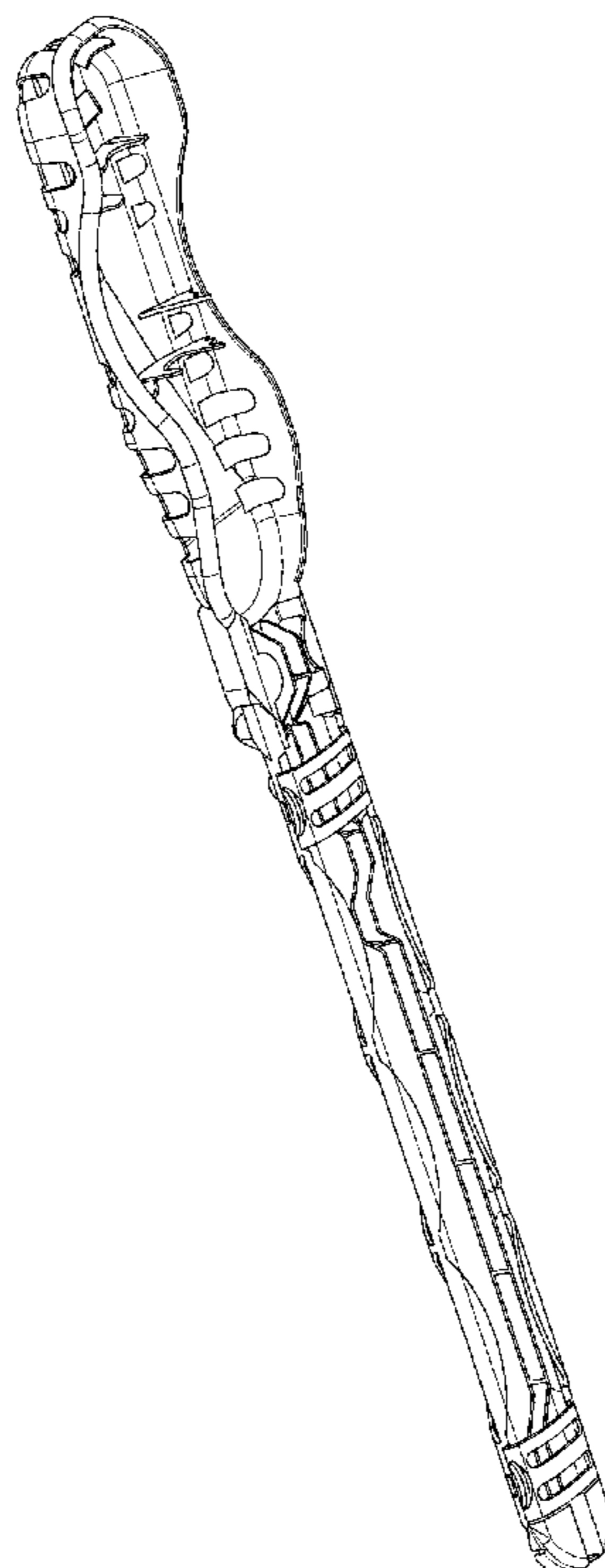
FIG. 1 is a top perspective view of the packaging container.

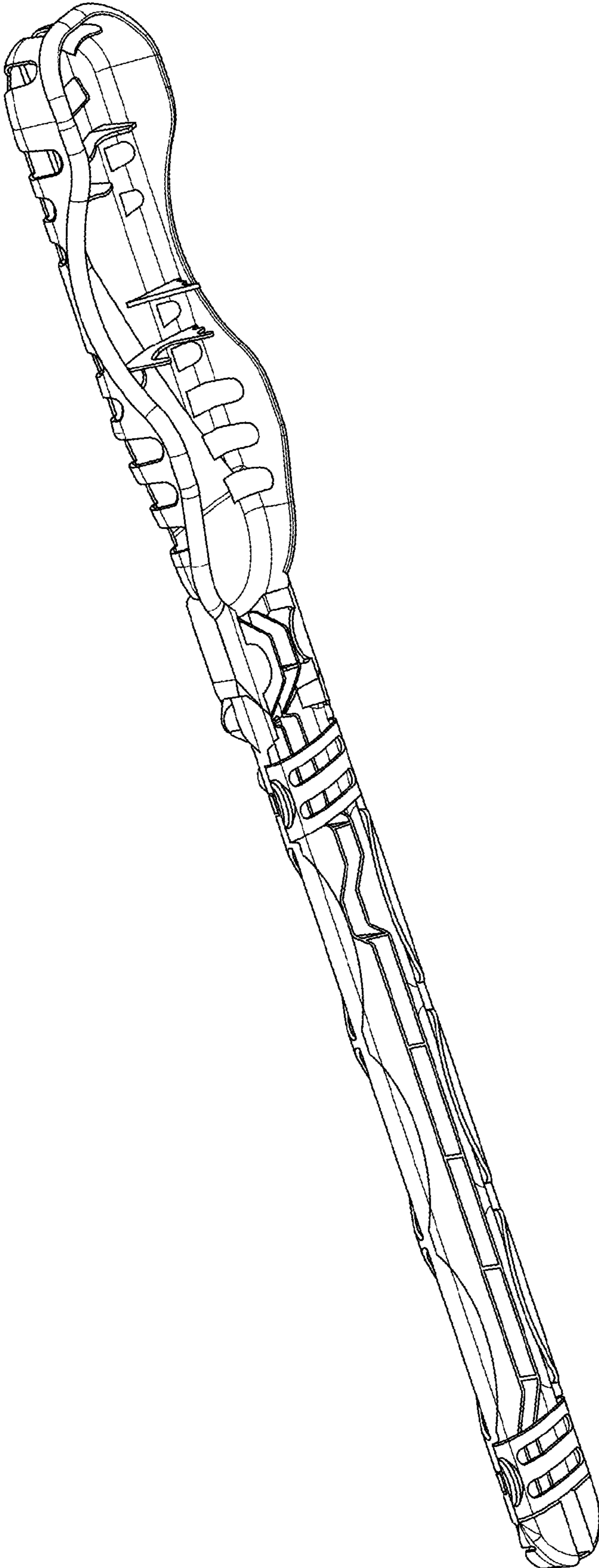

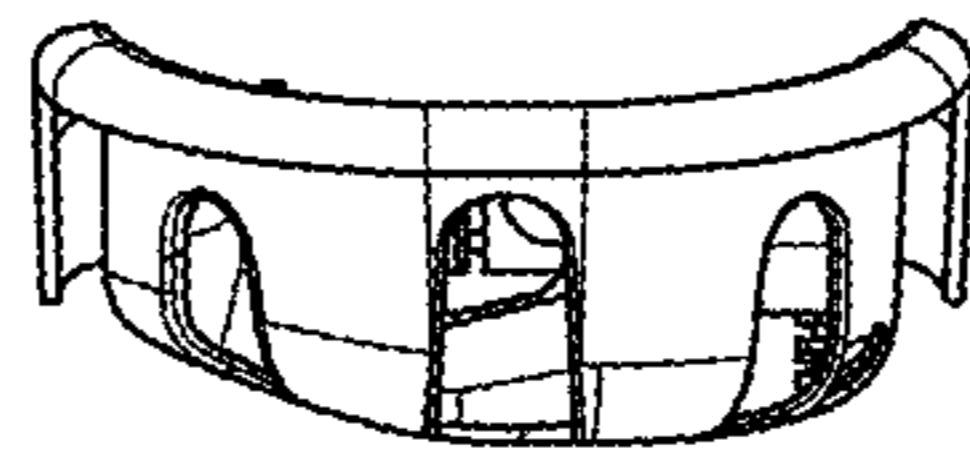

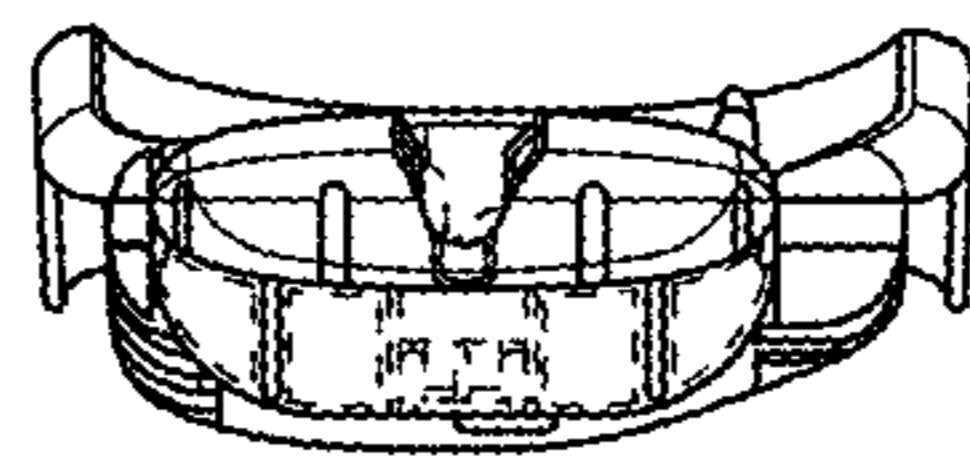

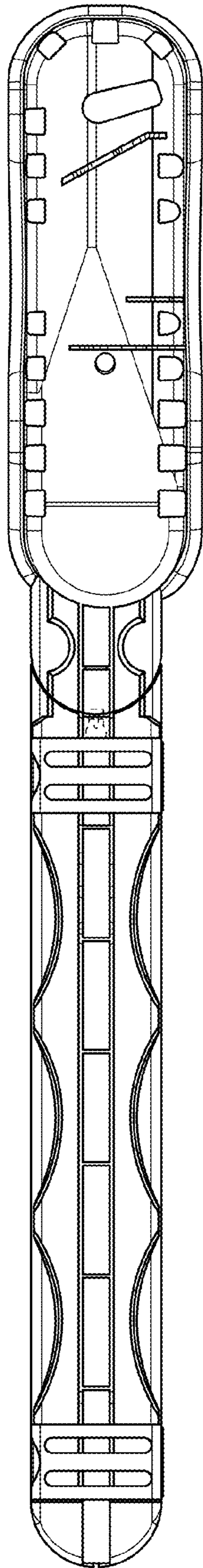

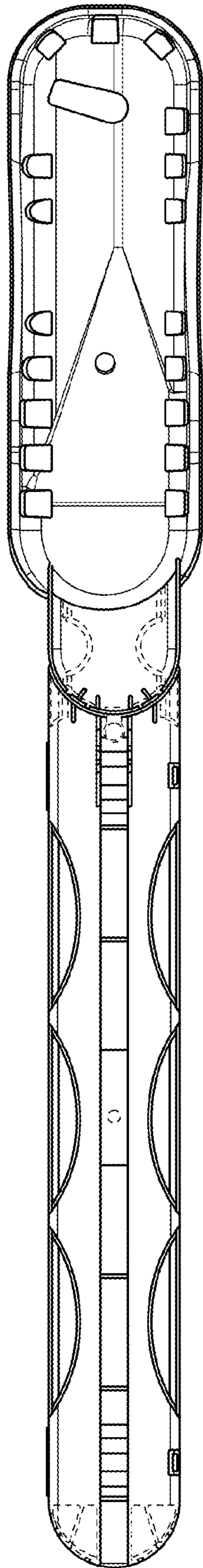

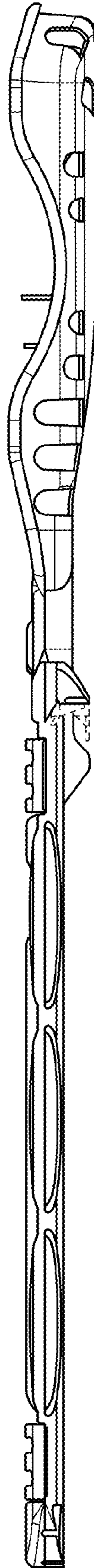

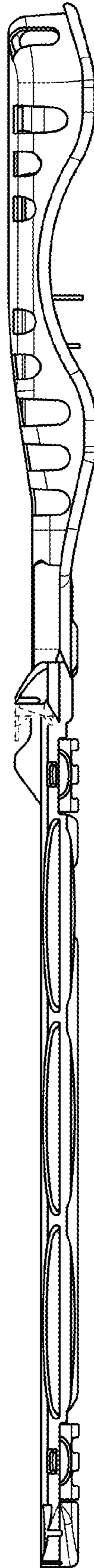
