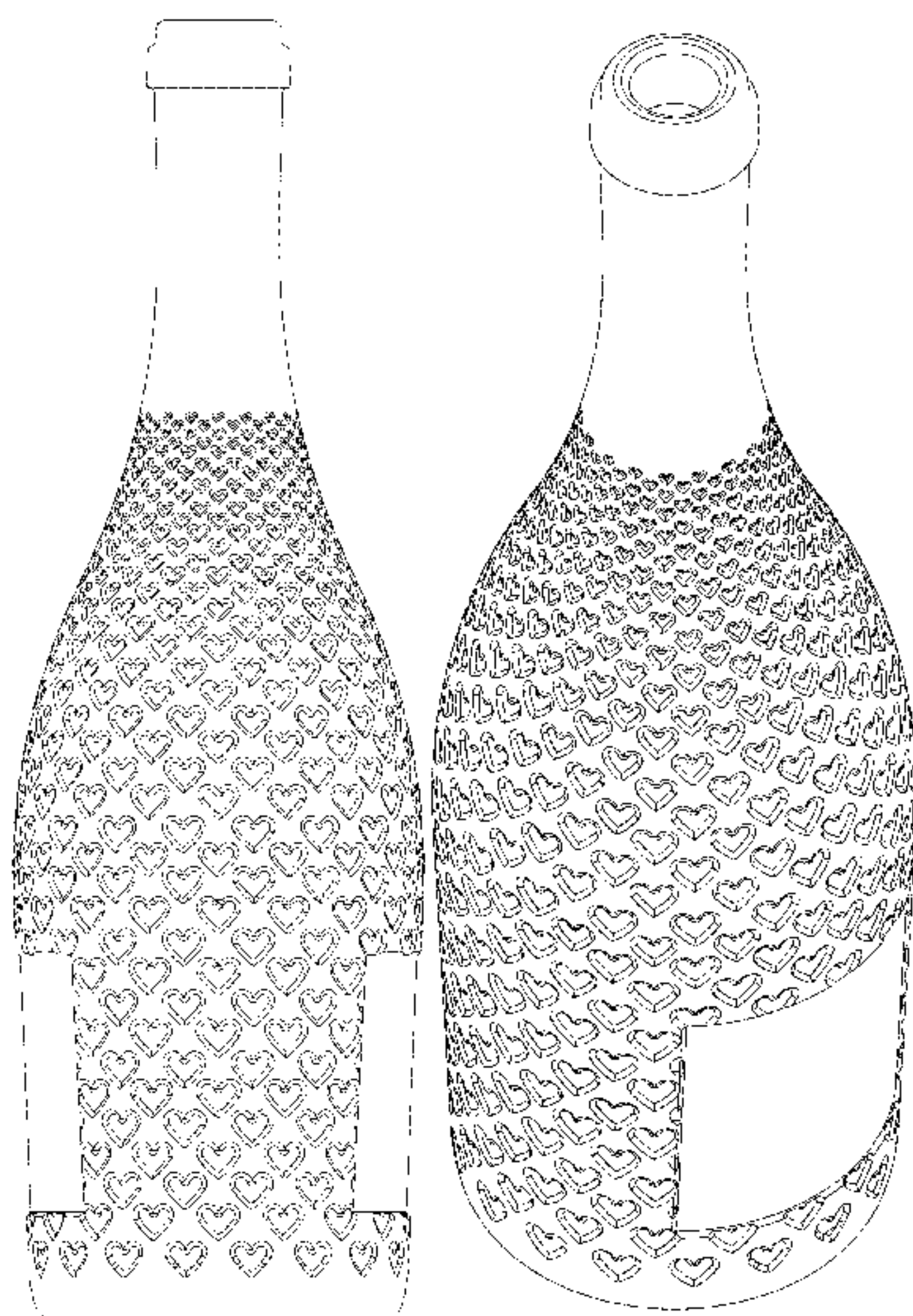

The ornamental design for a bottle, as shown and described.

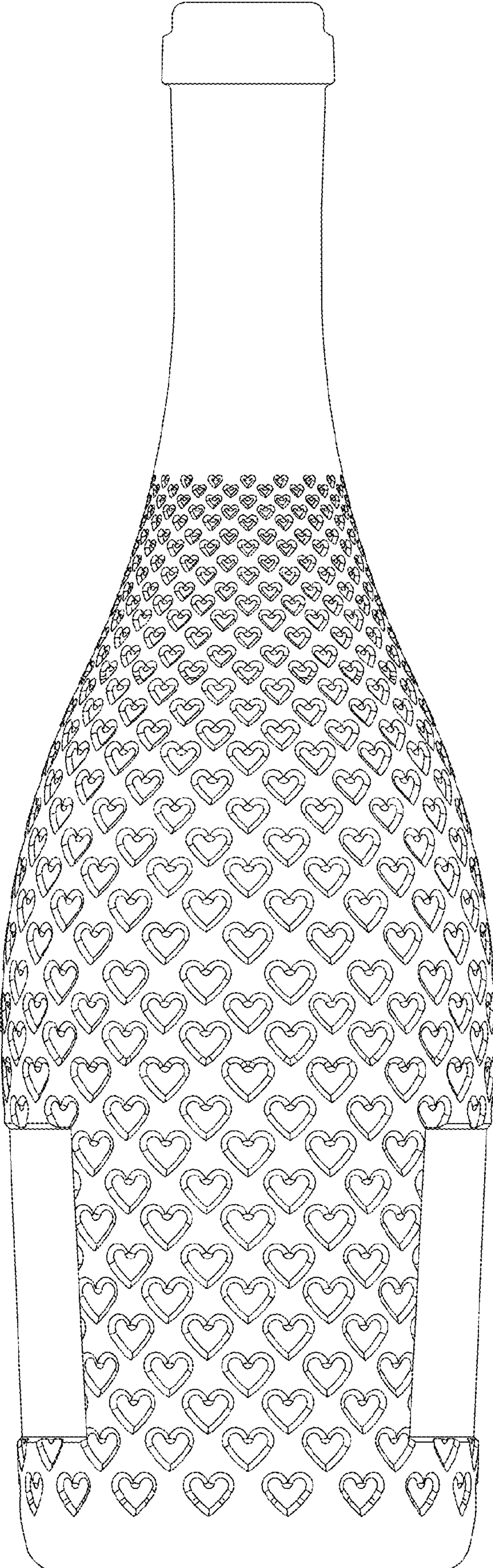
DESCRIPTION

Figure 1.6 is an upper perspective view thereof.

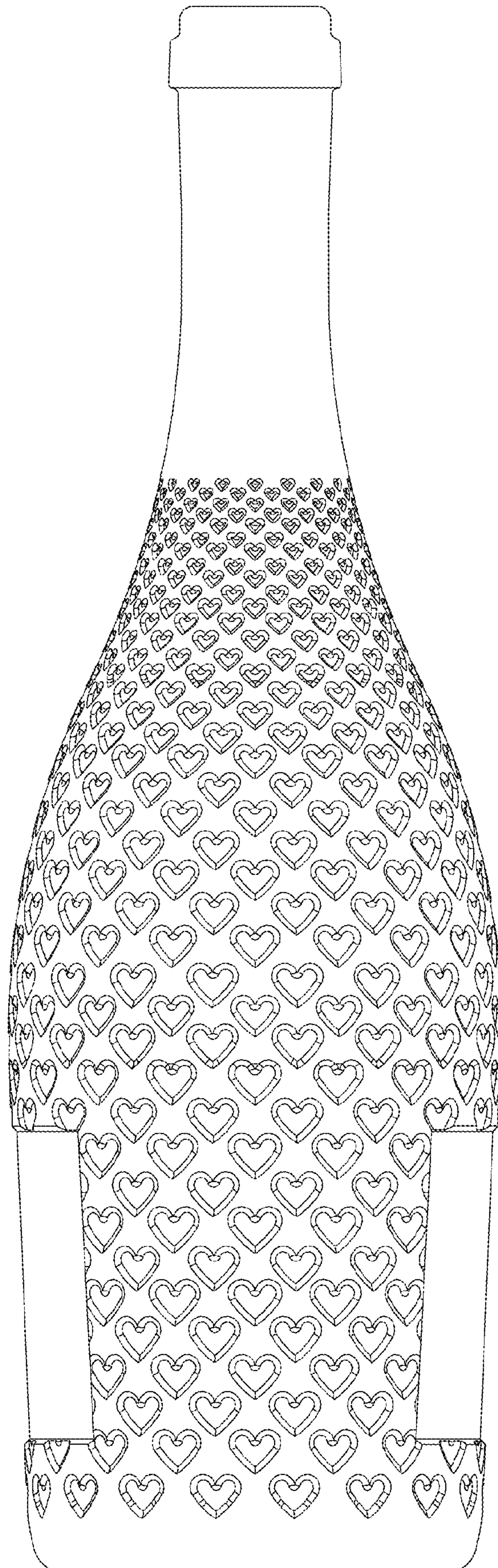

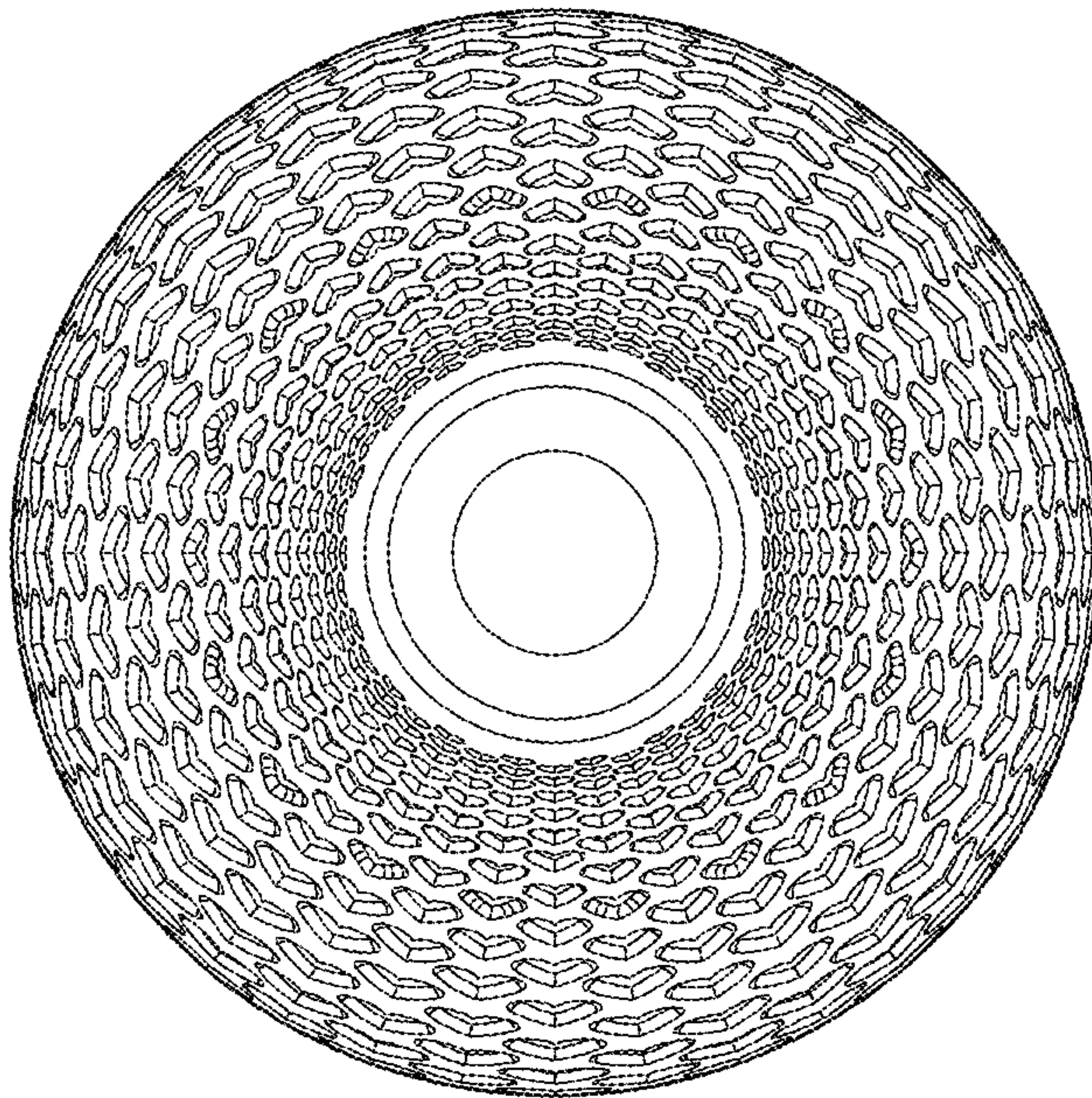

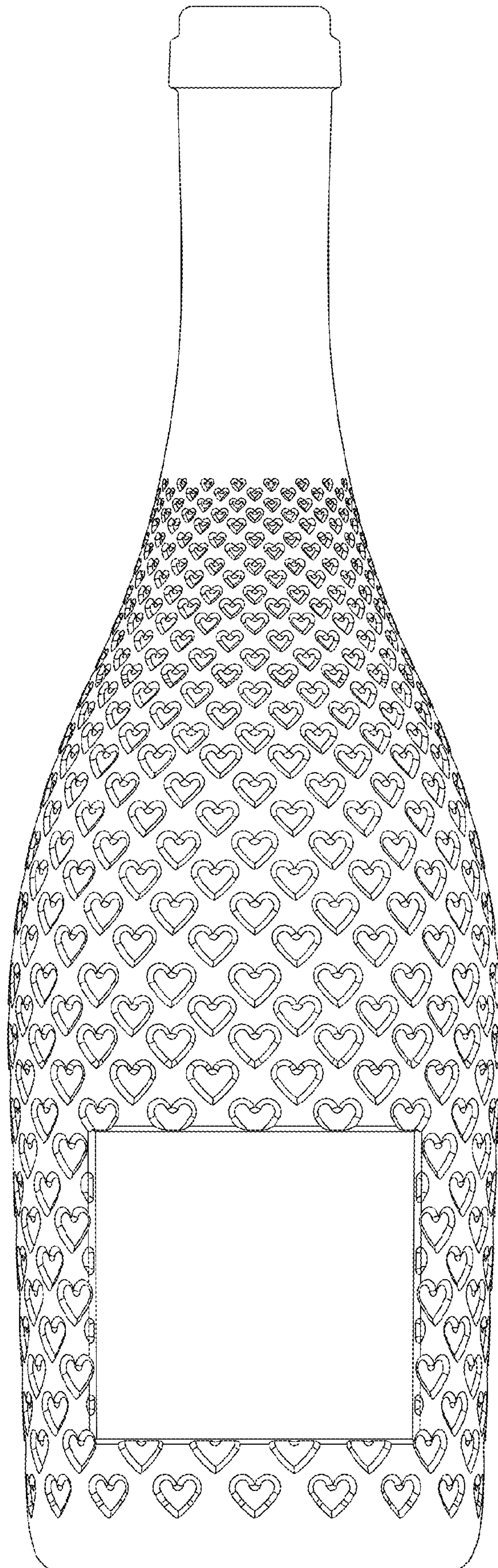

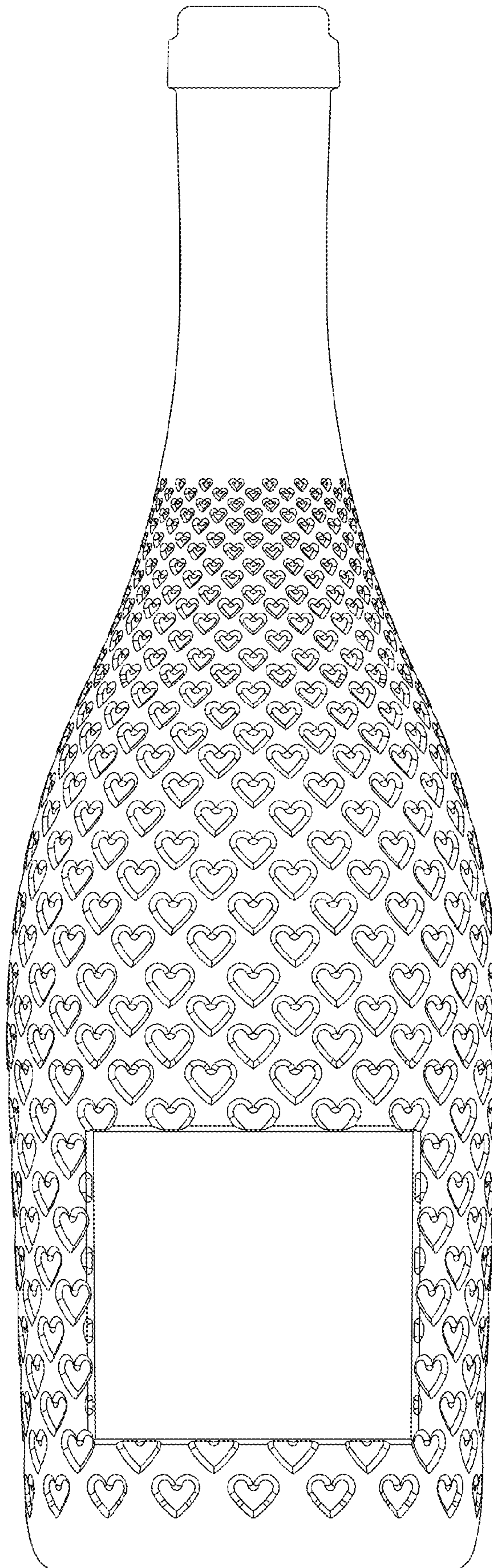
