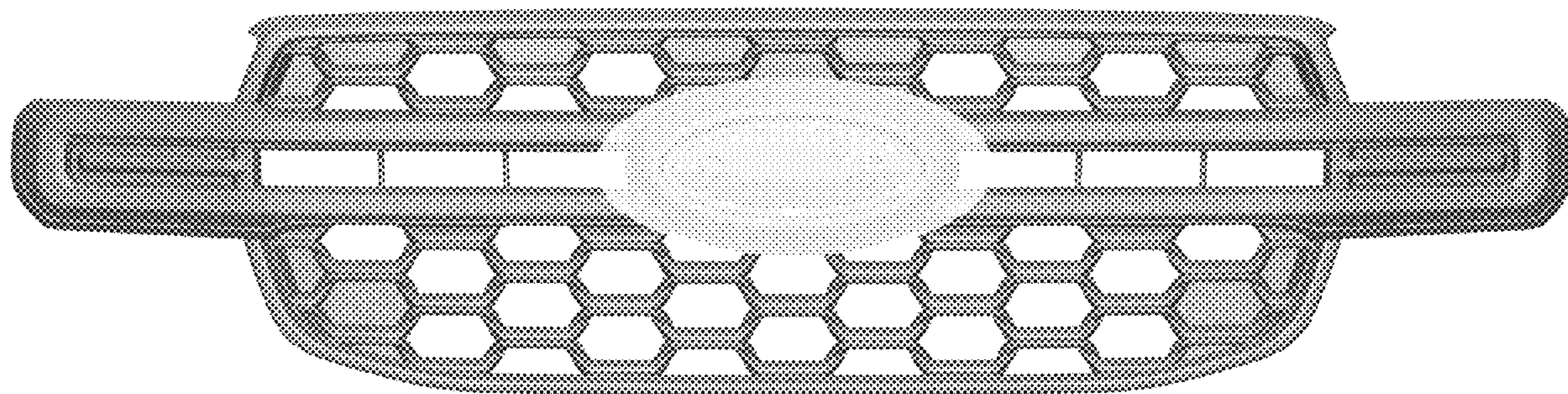
The ornamental design for a vehicle front center grille, as shown and described.

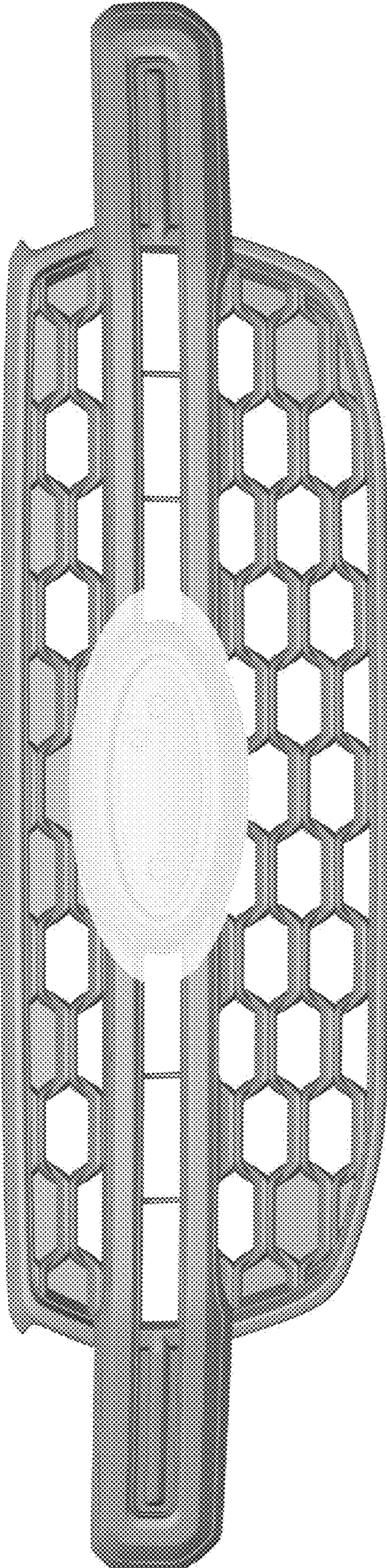

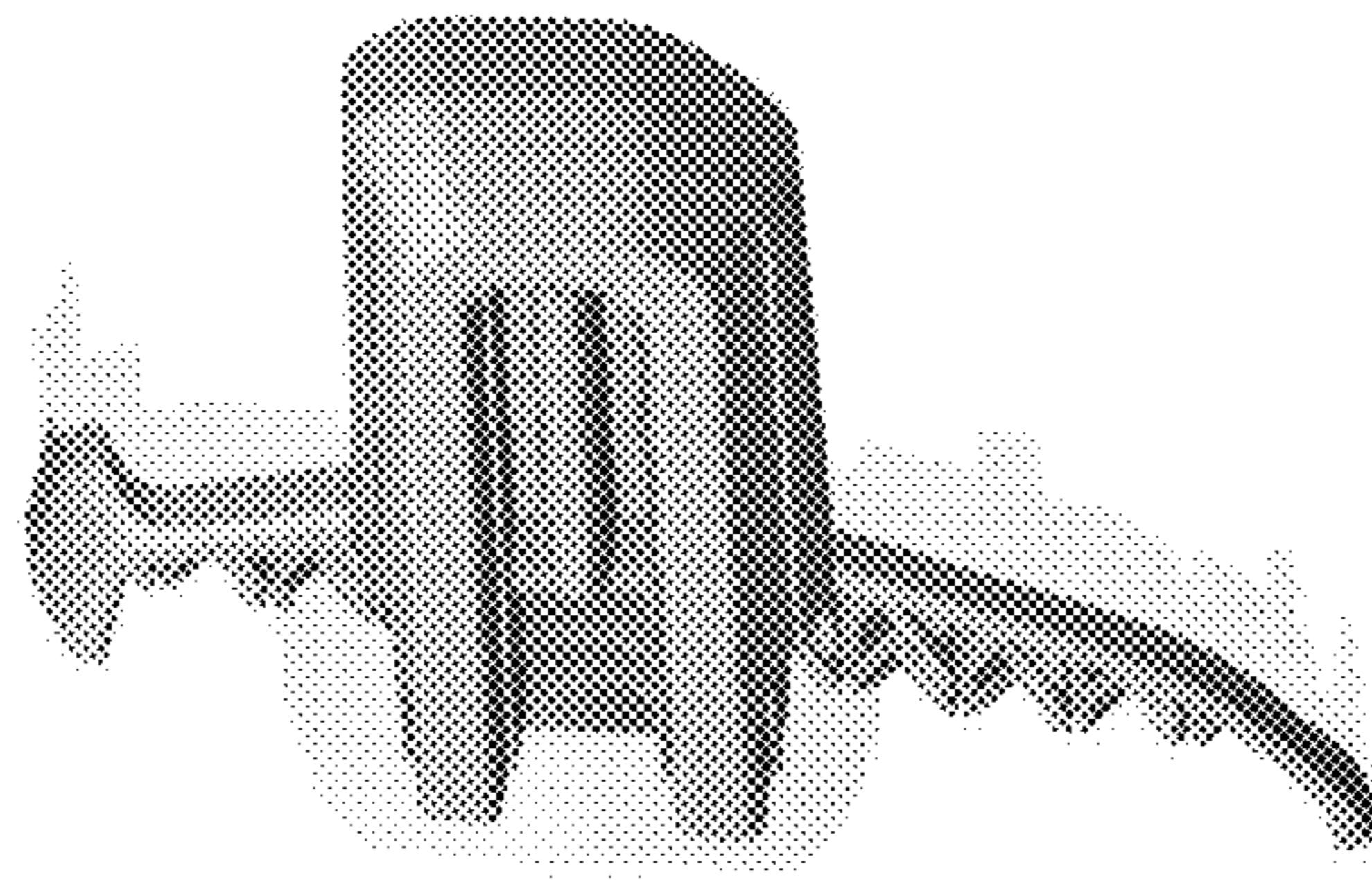

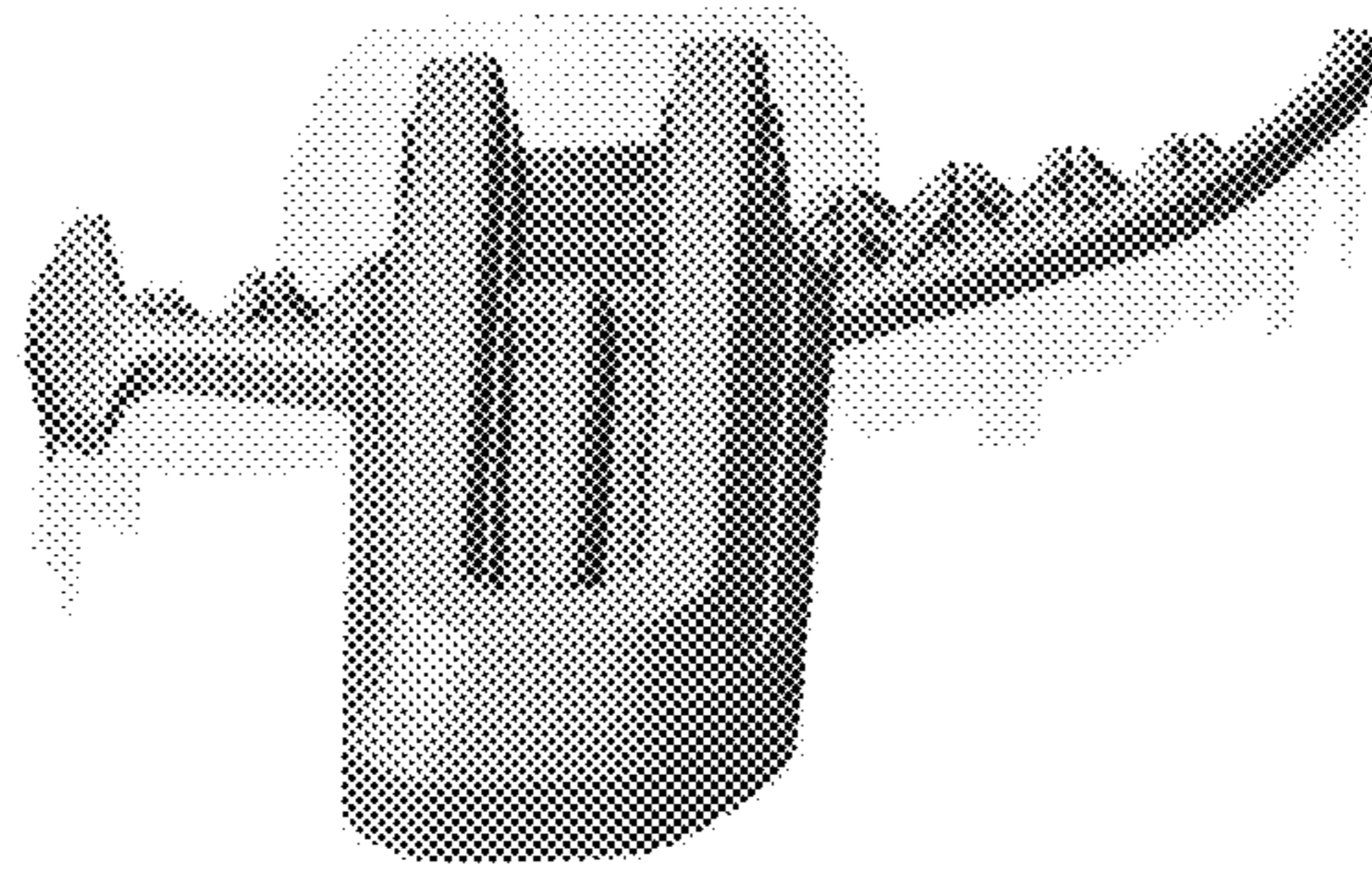

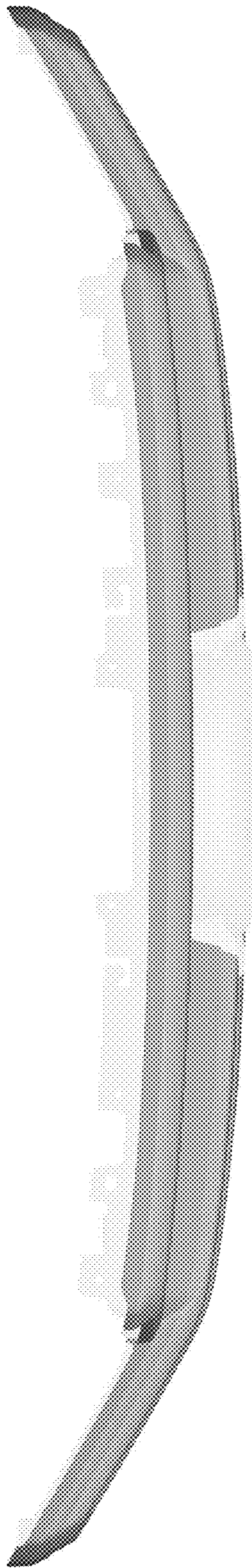

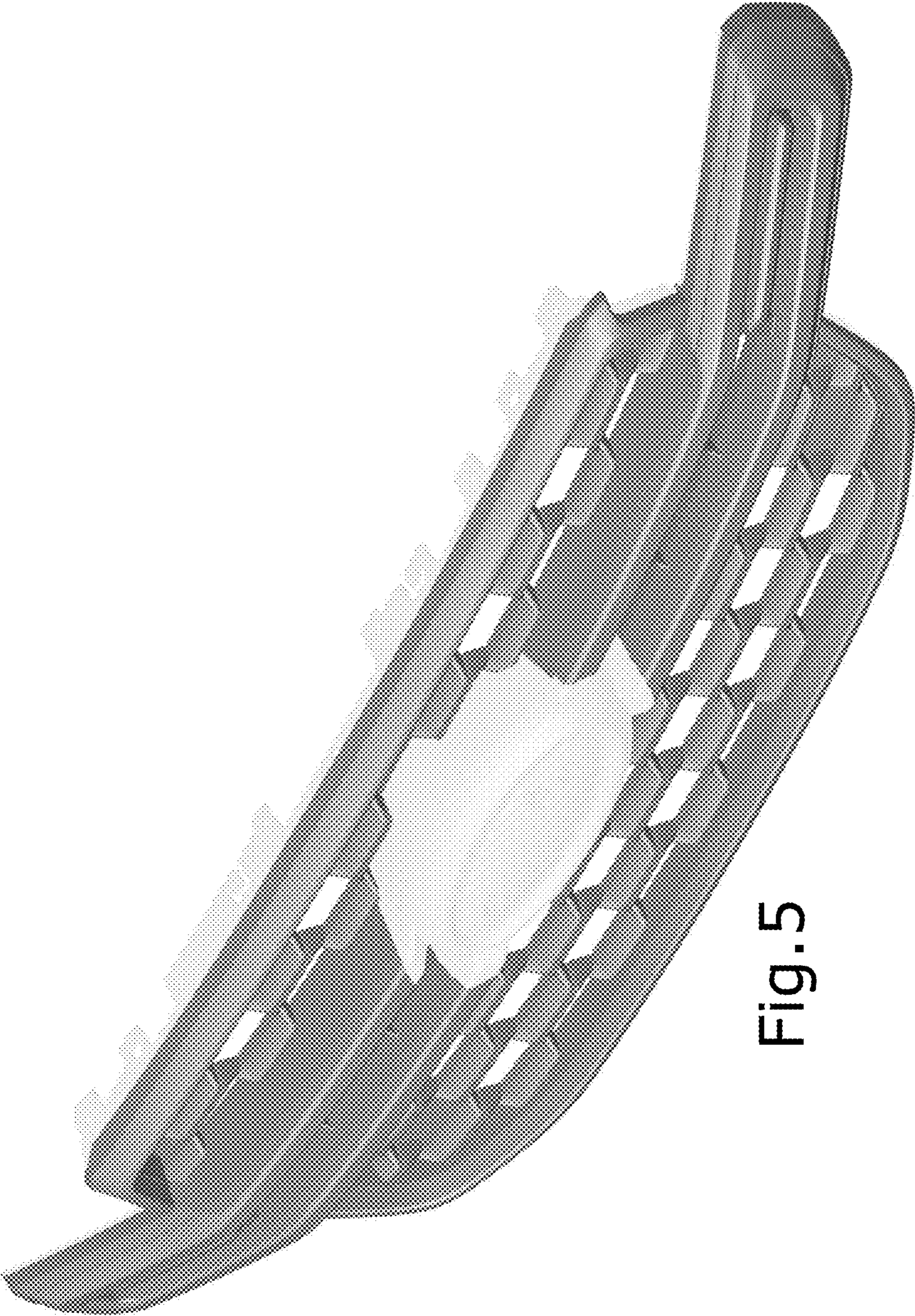

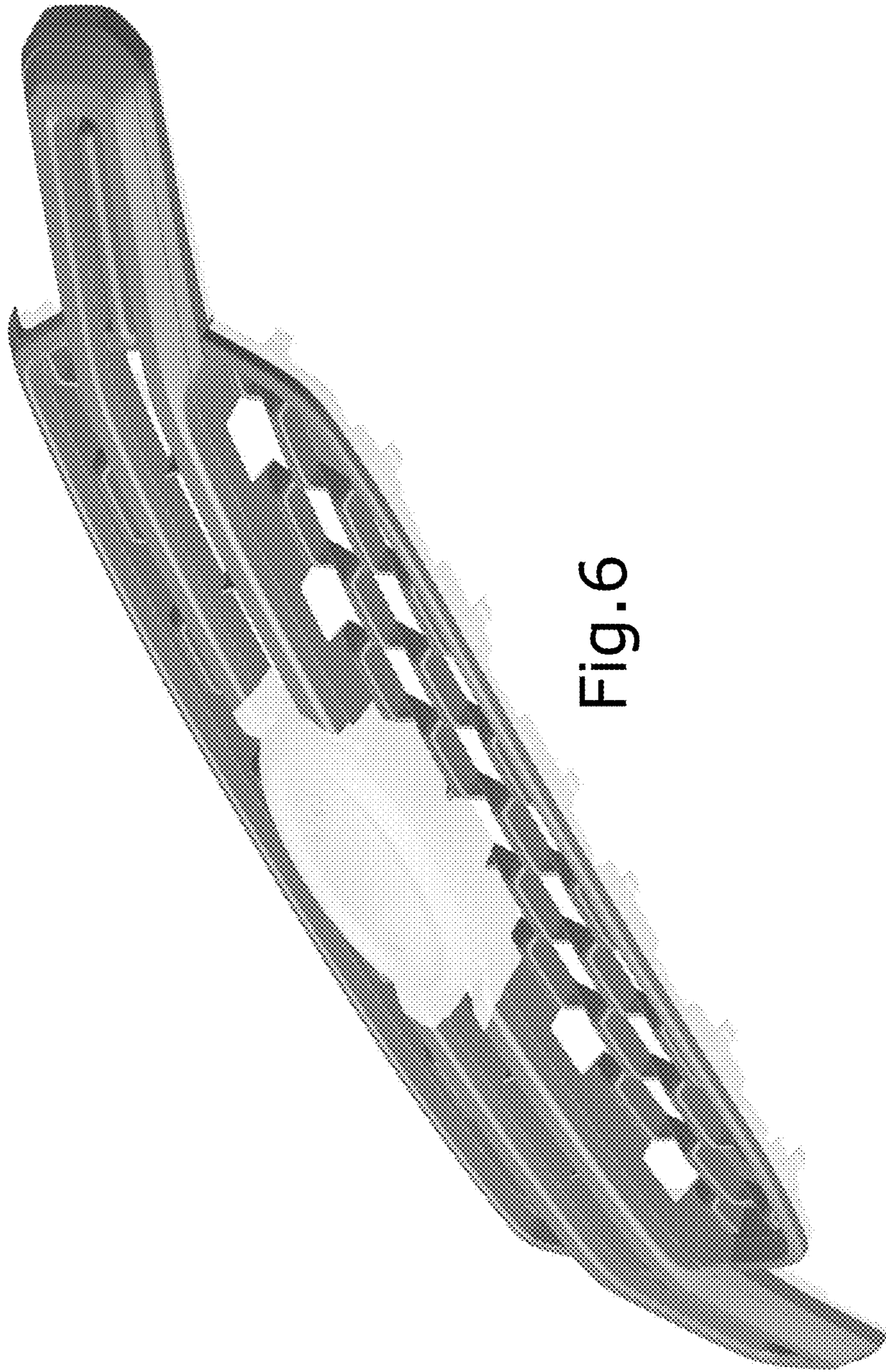
