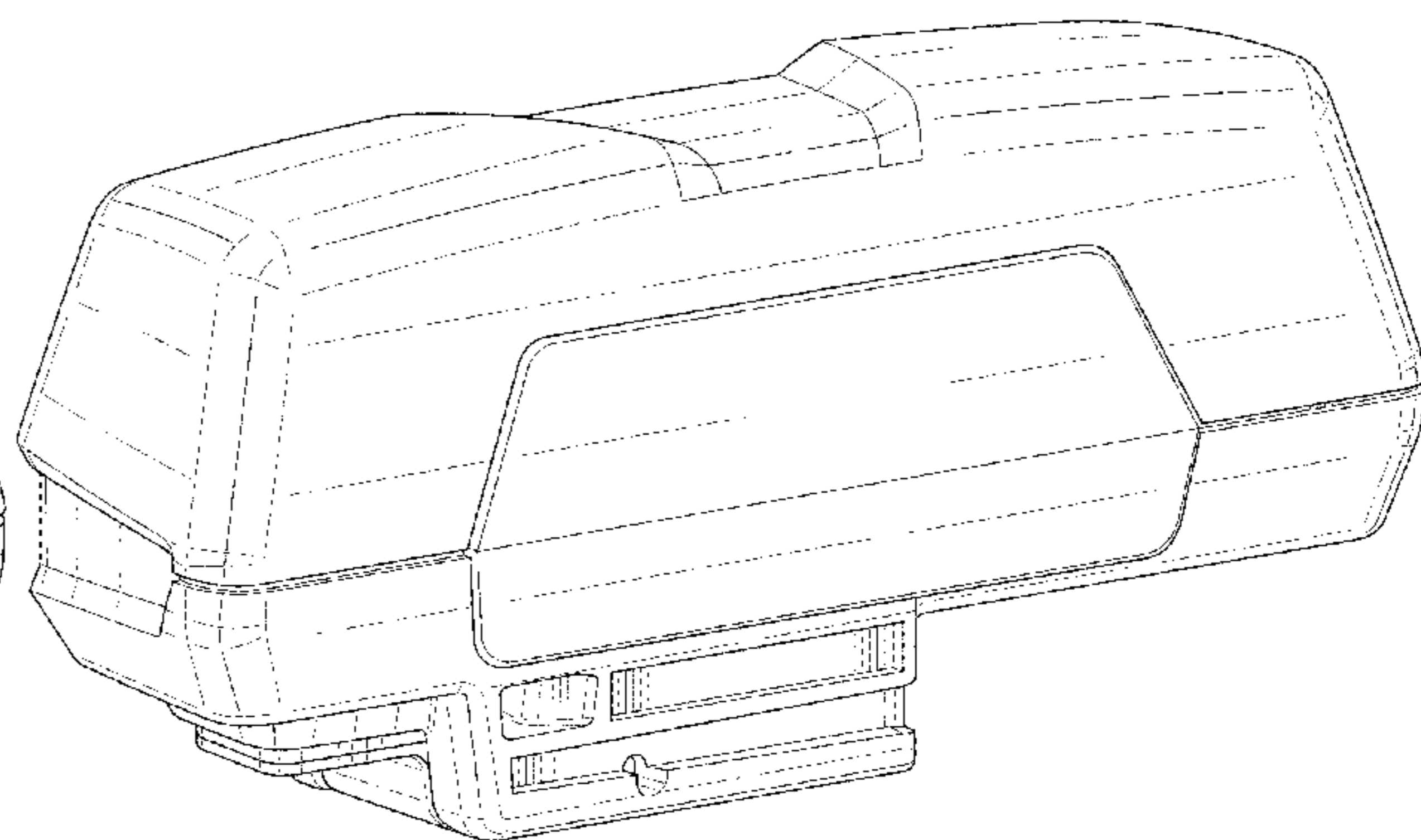
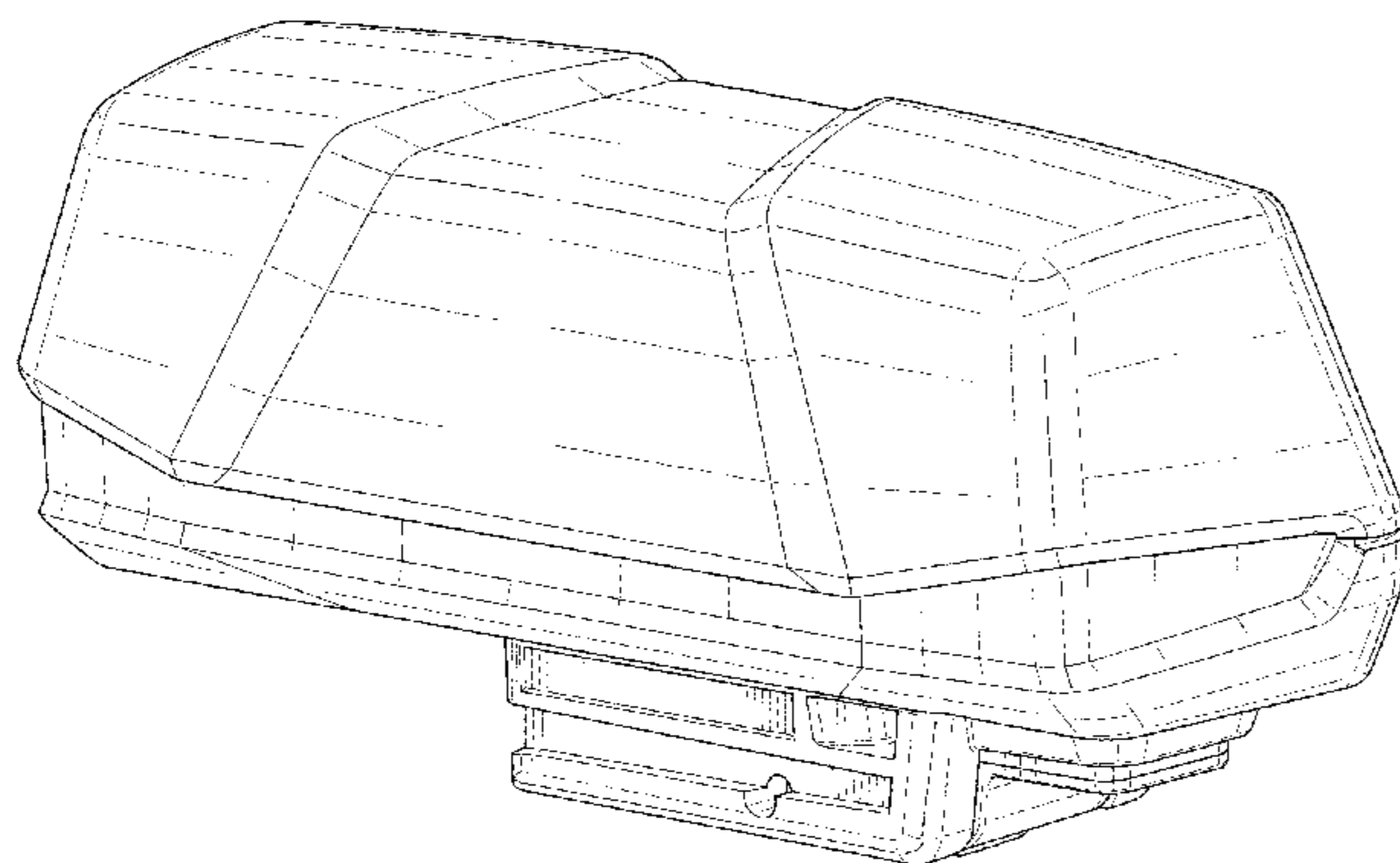
(57) **CLAIM**

The ornamental design for a battery for headlamp, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, top, right-side perspective view of a battery for headlamp, showing the new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a rear view elevational thereof;  
FIG. 4 is a left-side elevational view thereof;

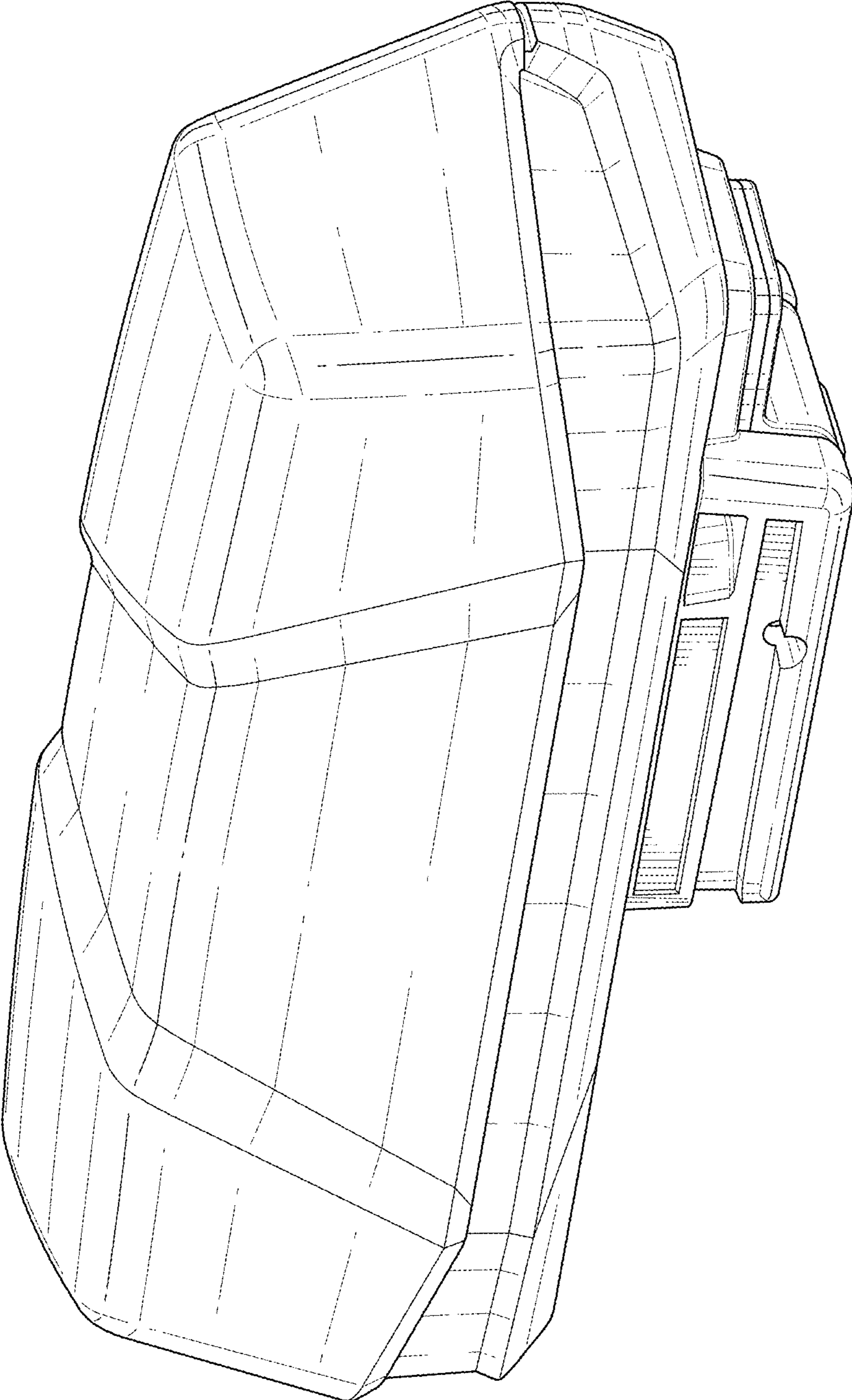

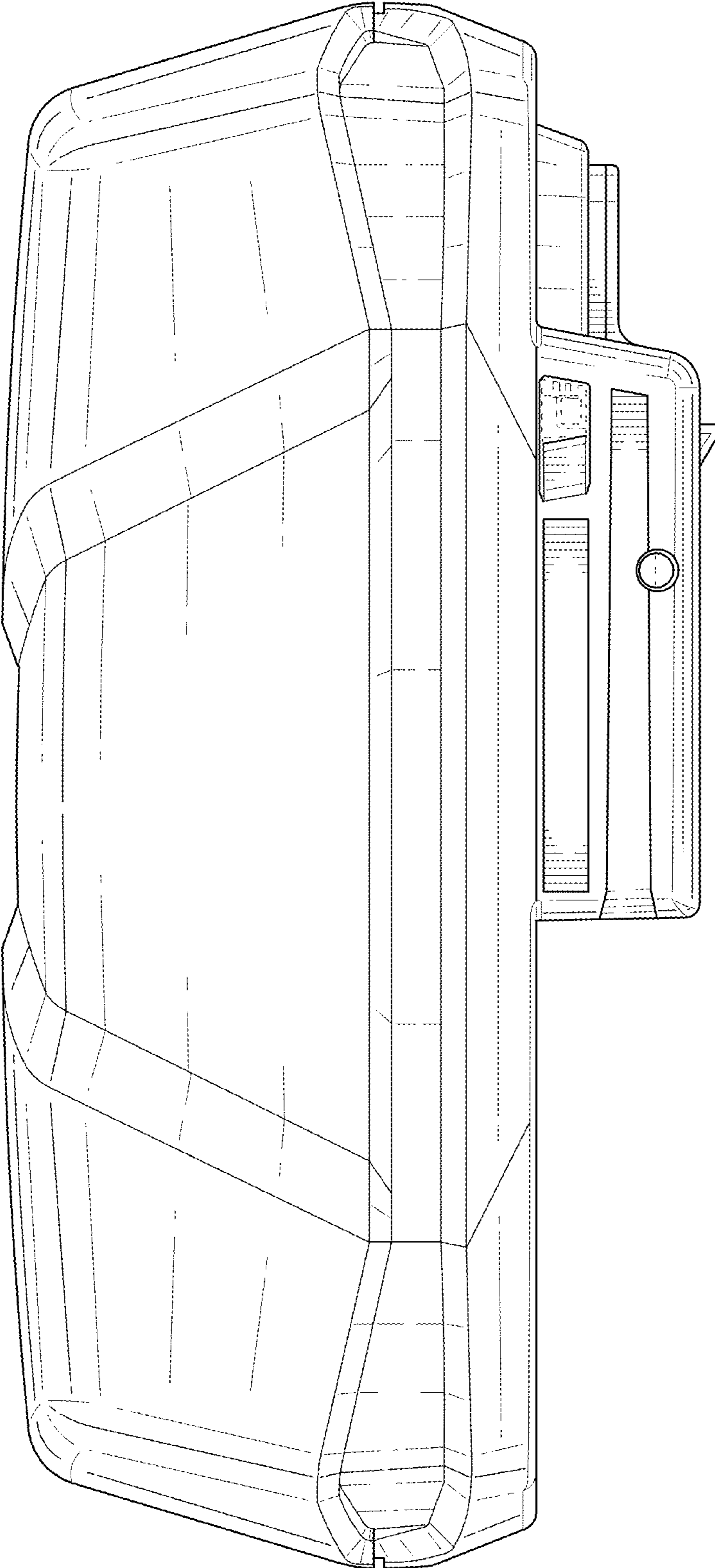

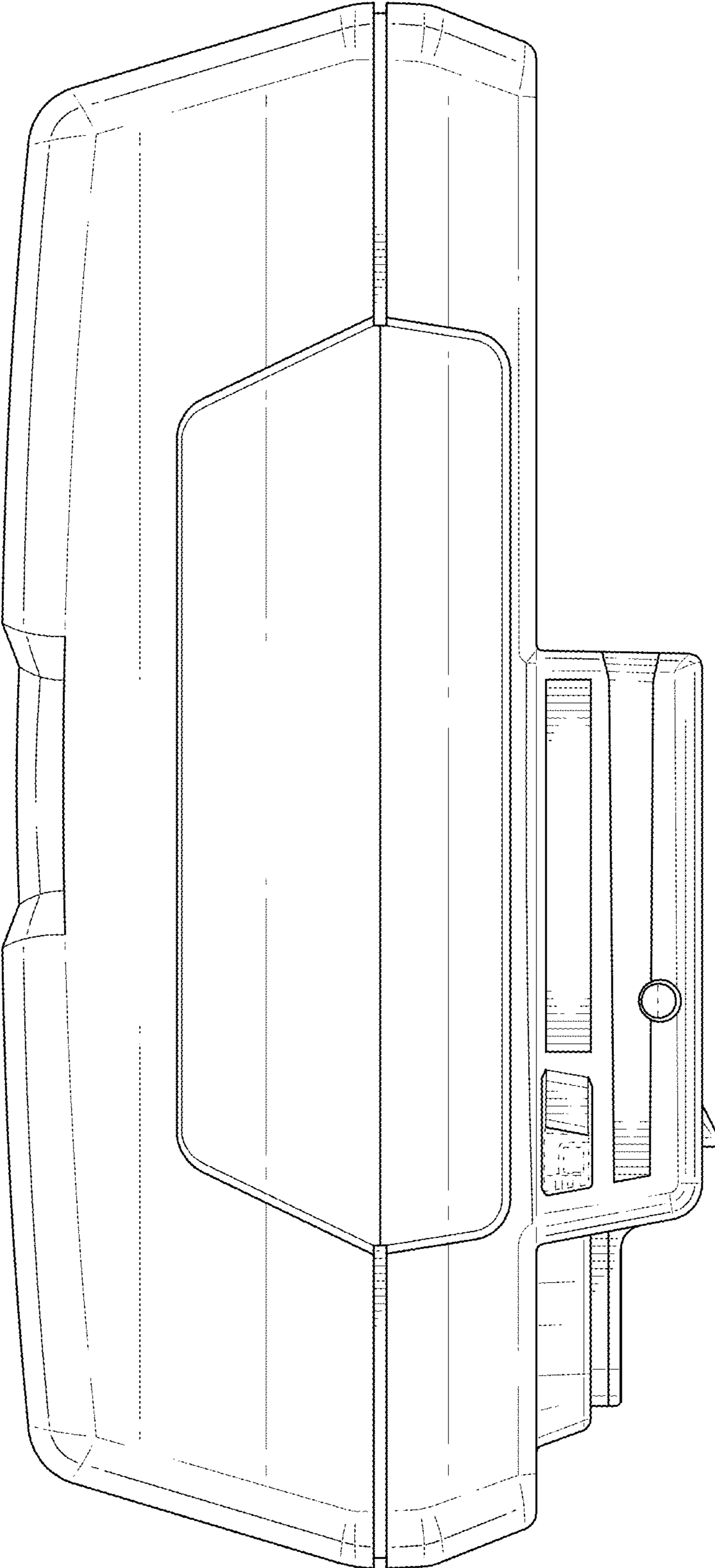

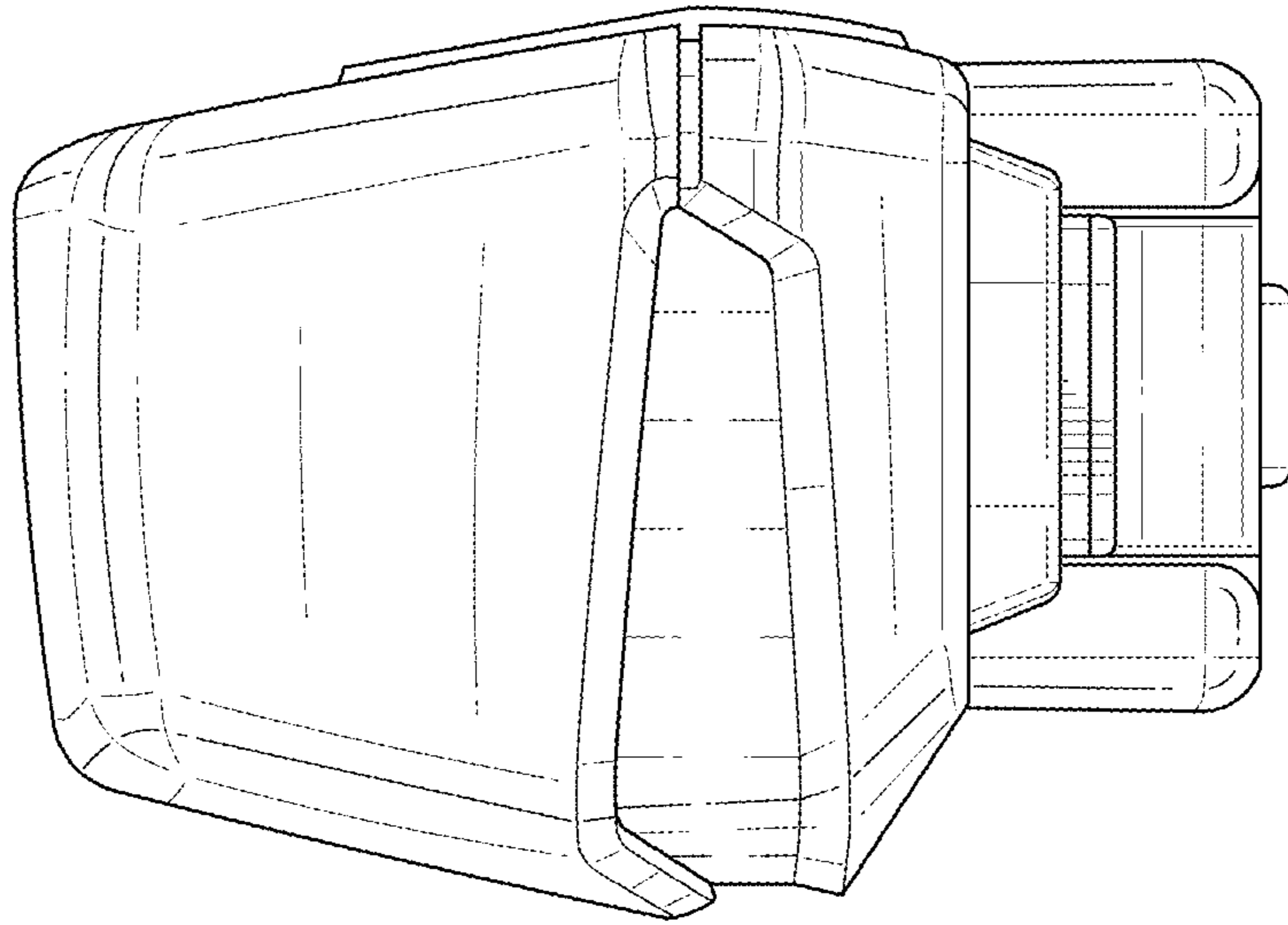

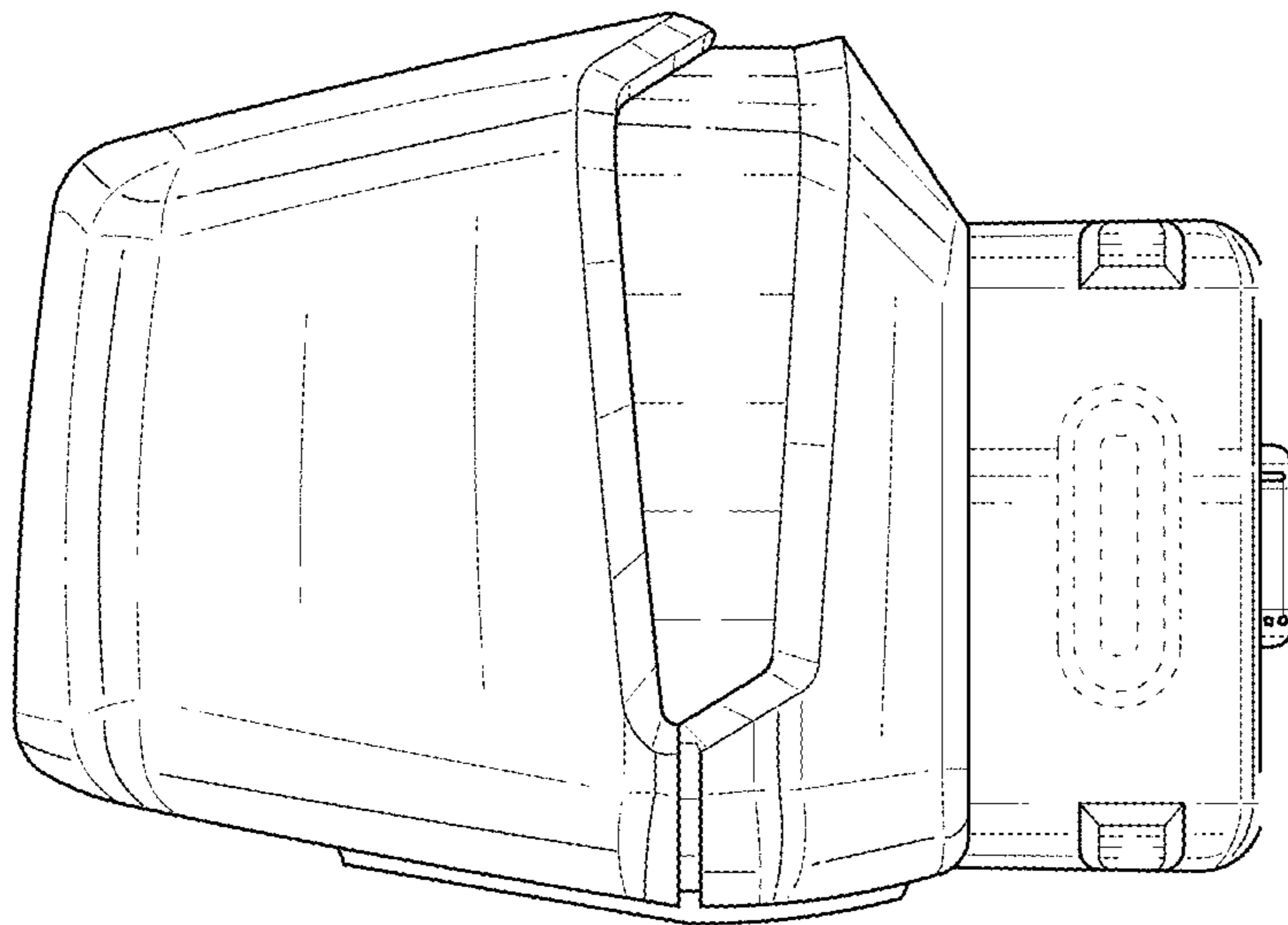

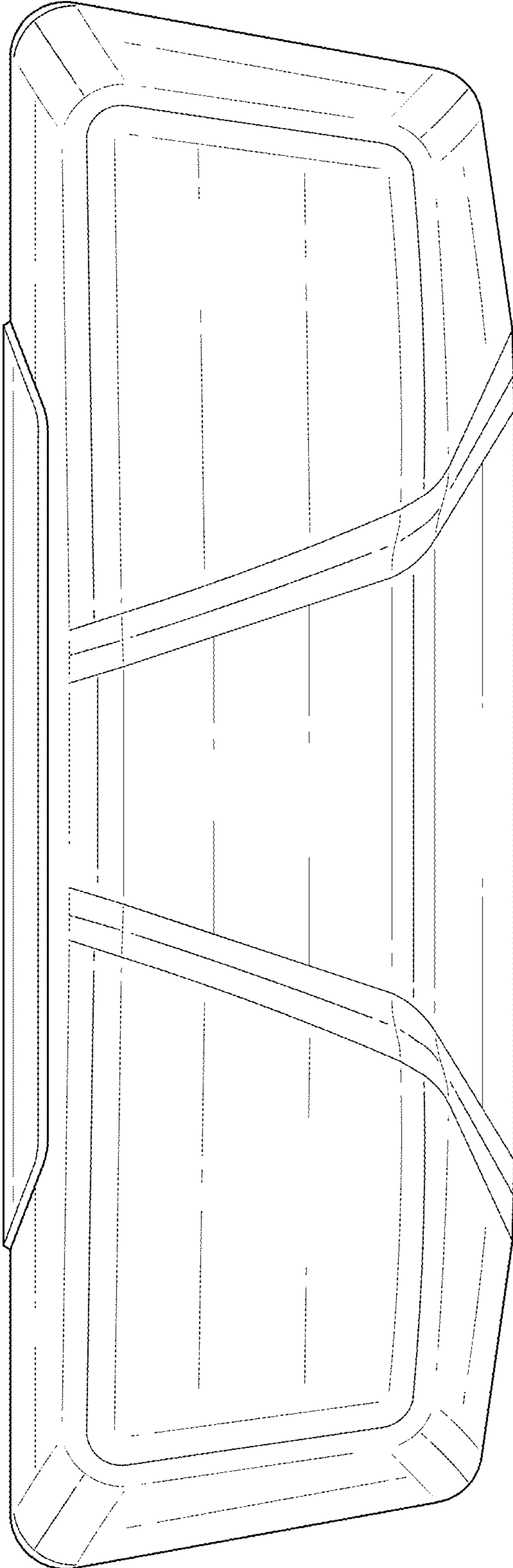

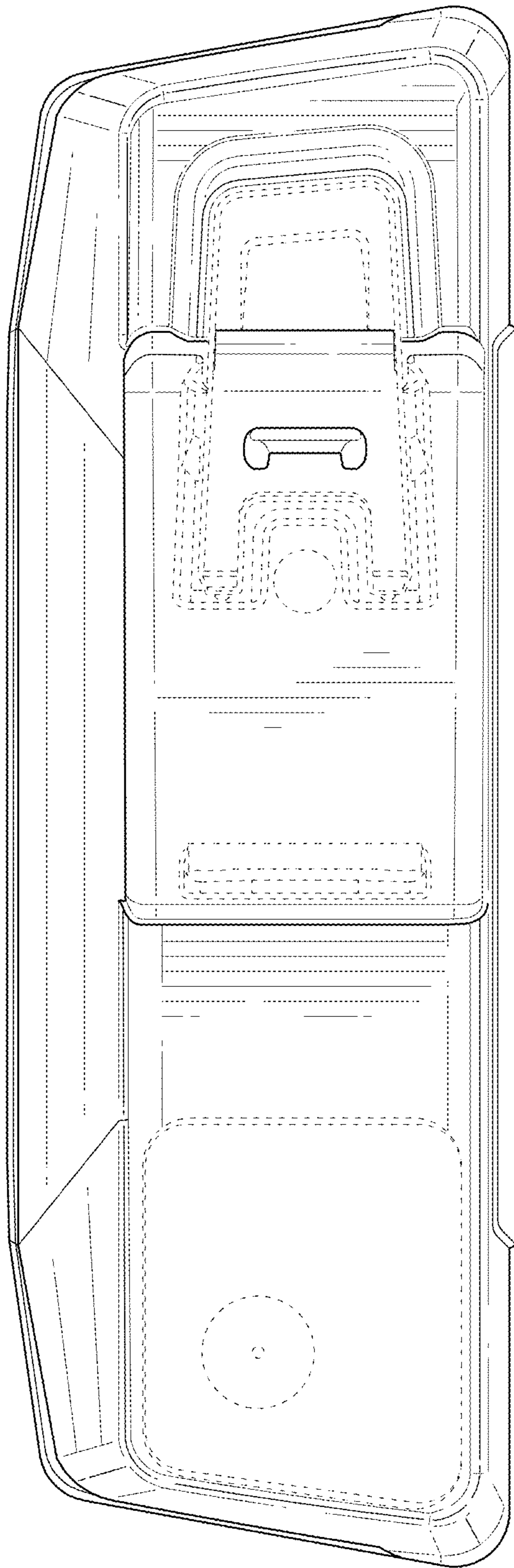

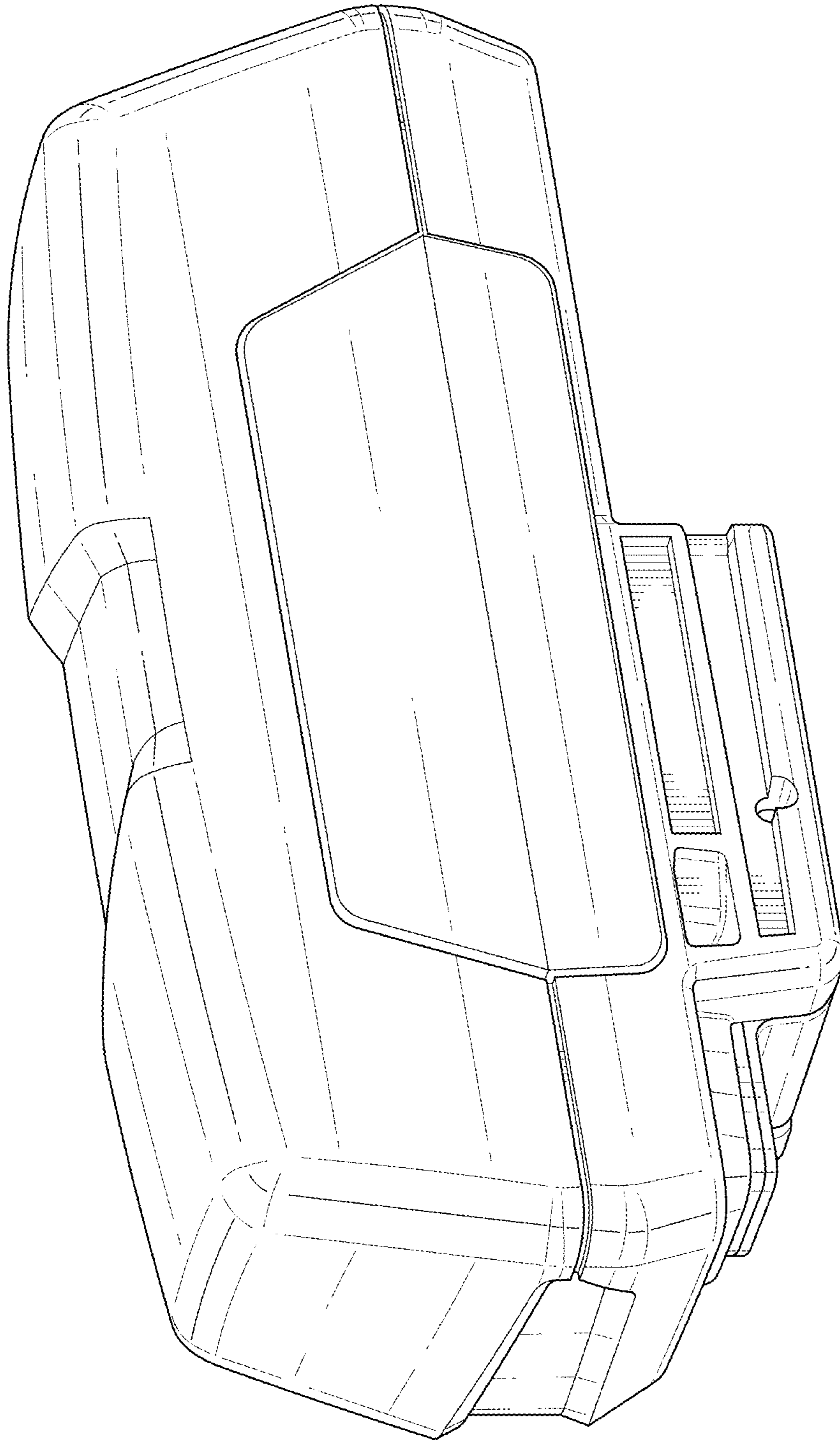
