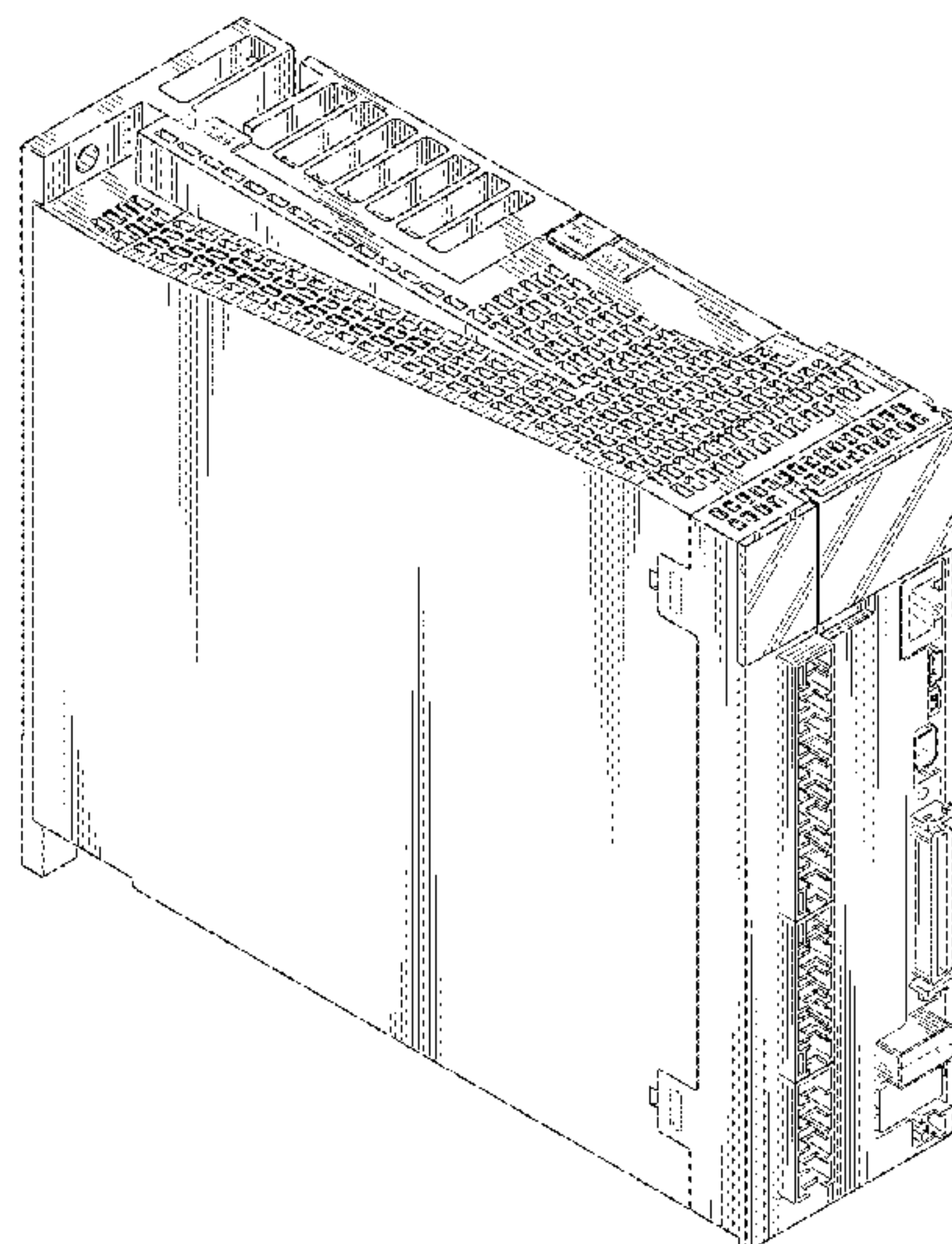
The ornamental design for a servo amplifier, as shown and described.

**DESCRIPTION**

FIG. 1. is a front perspective view of the front, left, and top sides of a servo amplifier showing our new design;

FIG. 3. is a front view thereof;  
FIG. 4. is a rear view thereof;  
FIG. 5. is a top plan view thereof;  
FIG. 6. is a bottom plan view thereof;

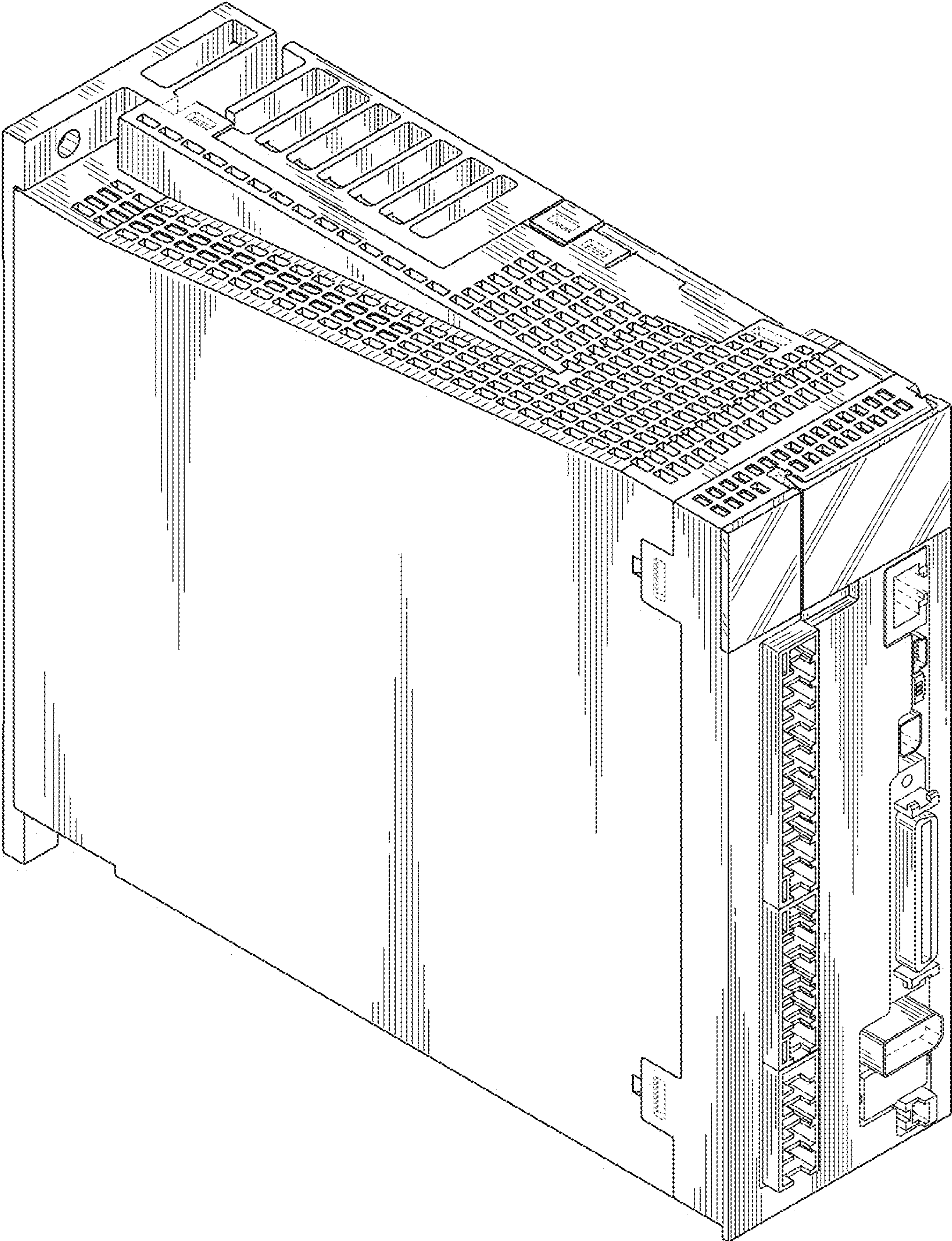

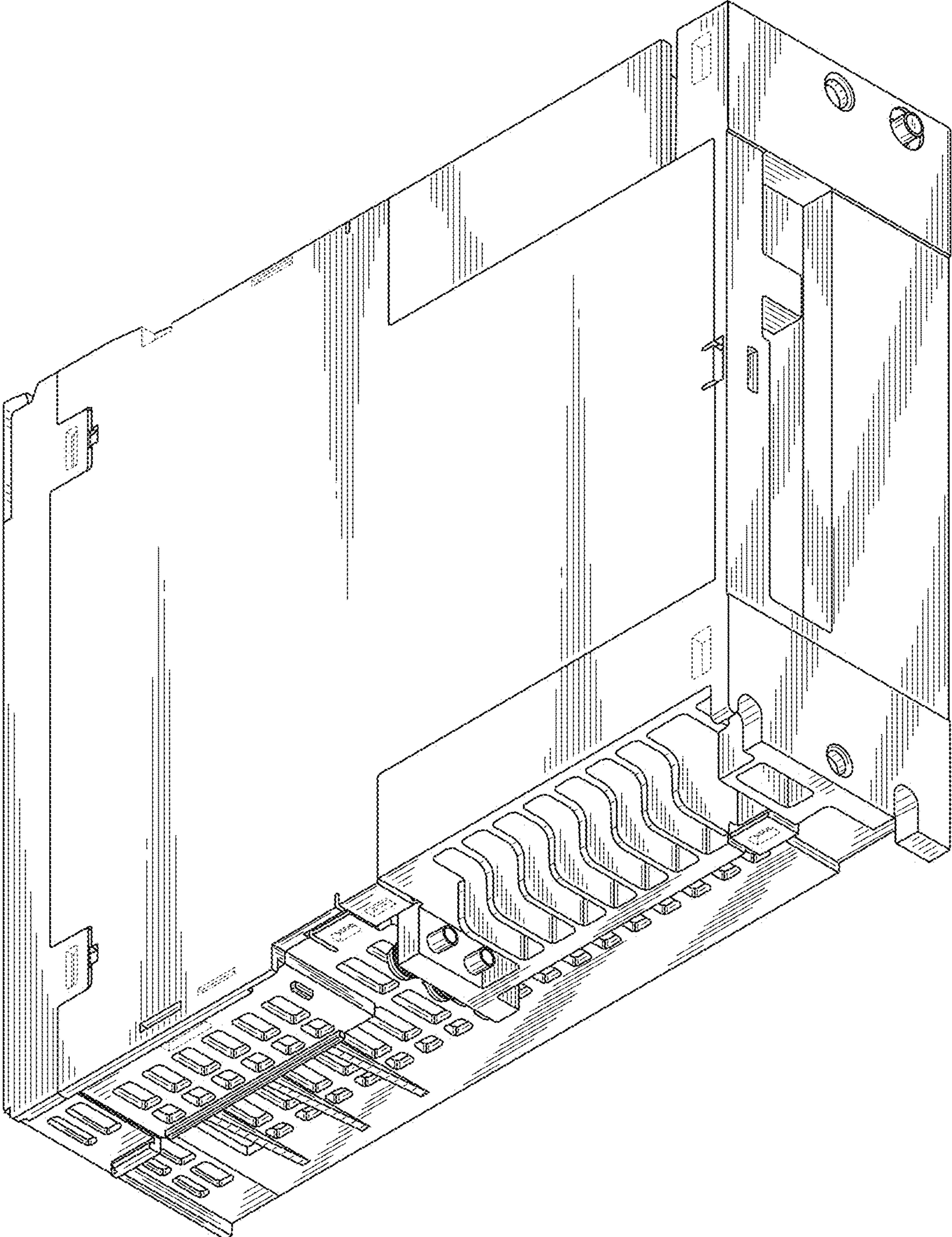

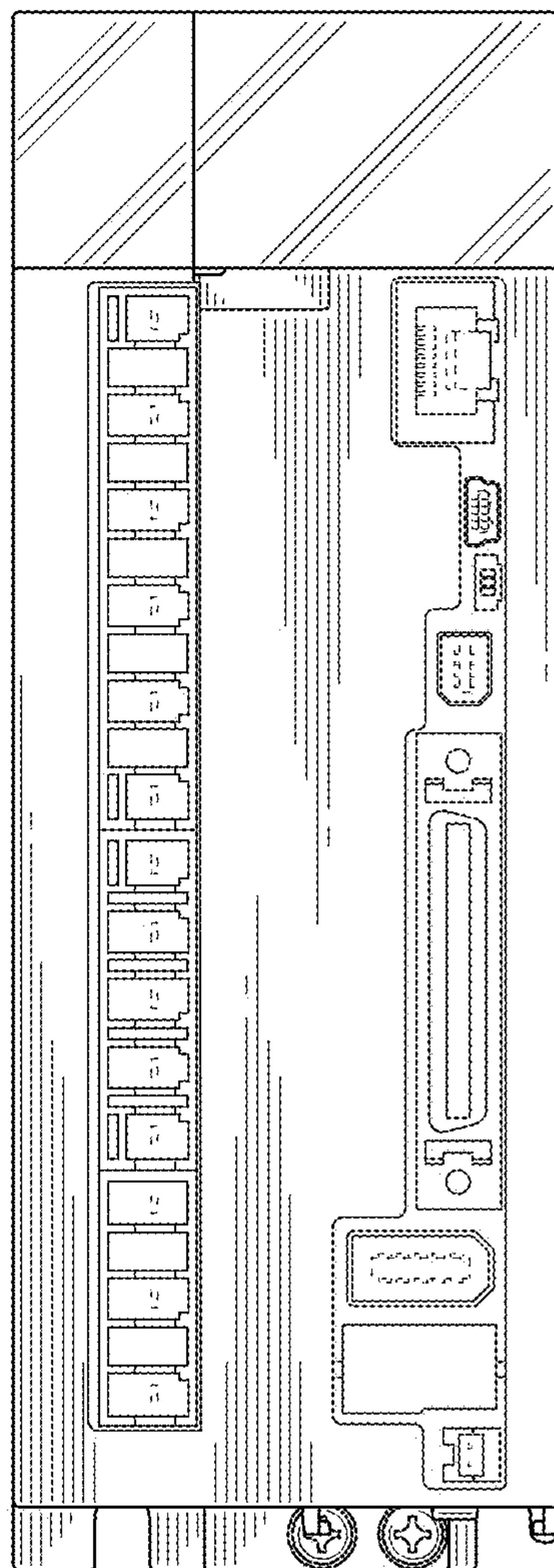




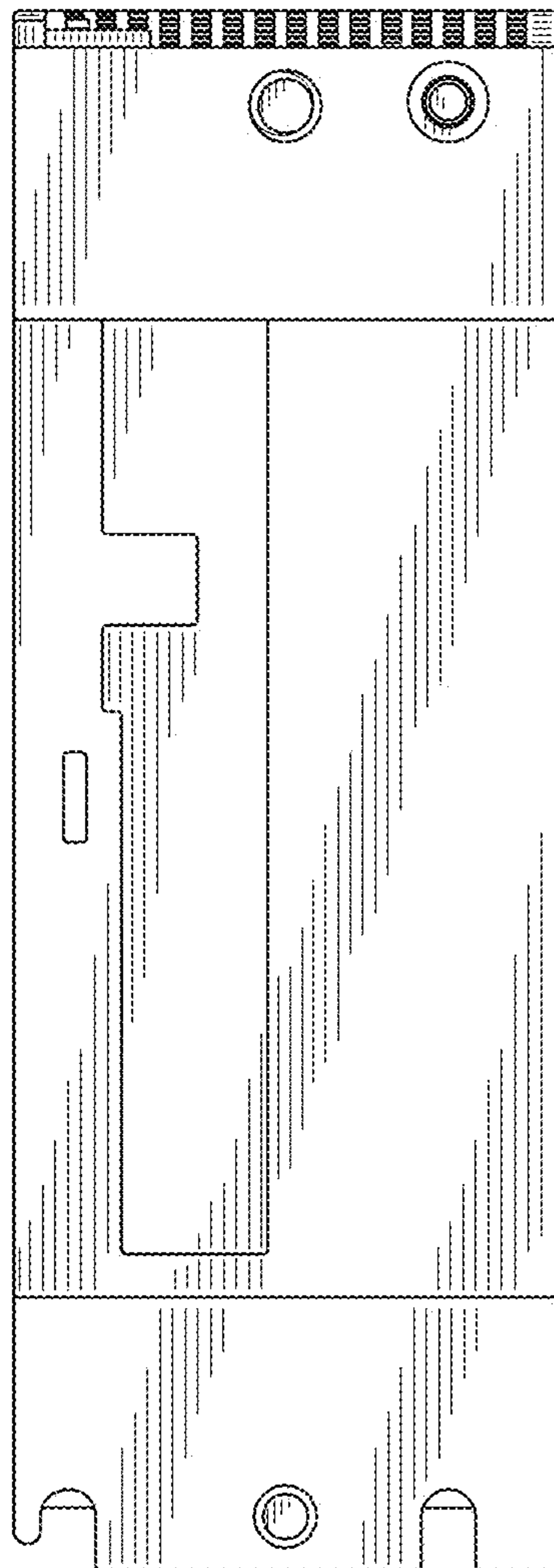

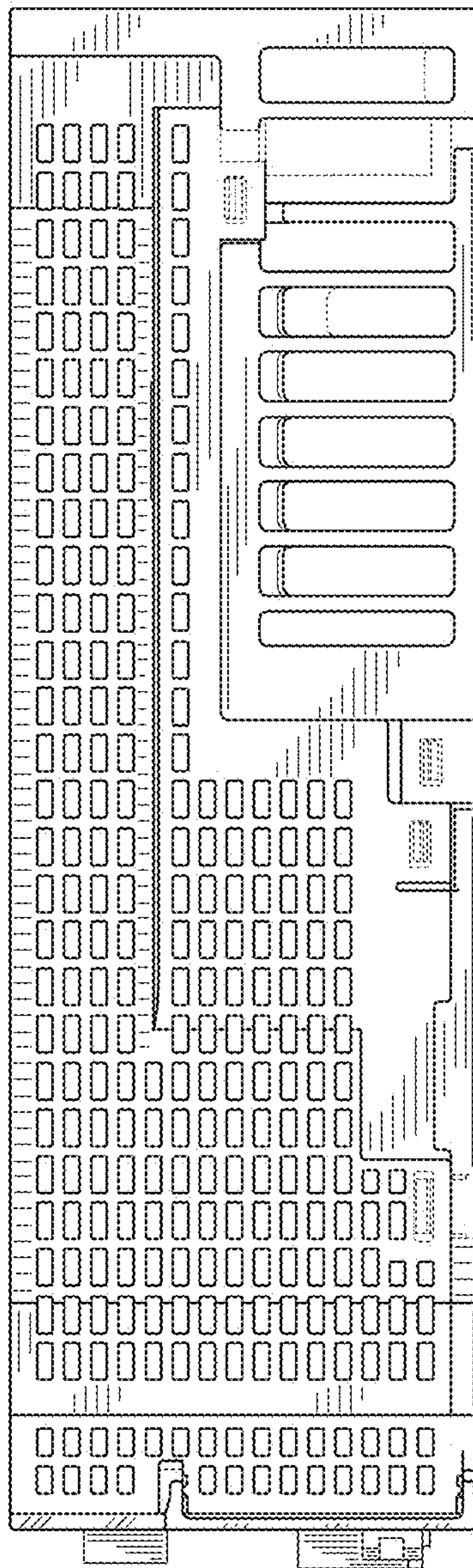

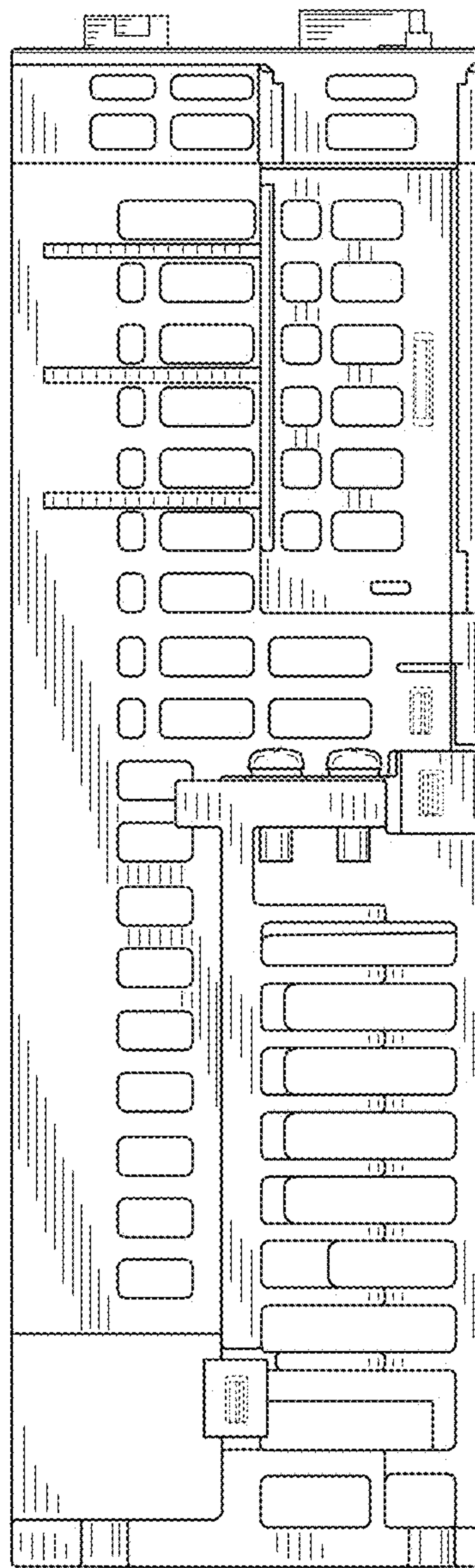
