(57) **CLAIM**

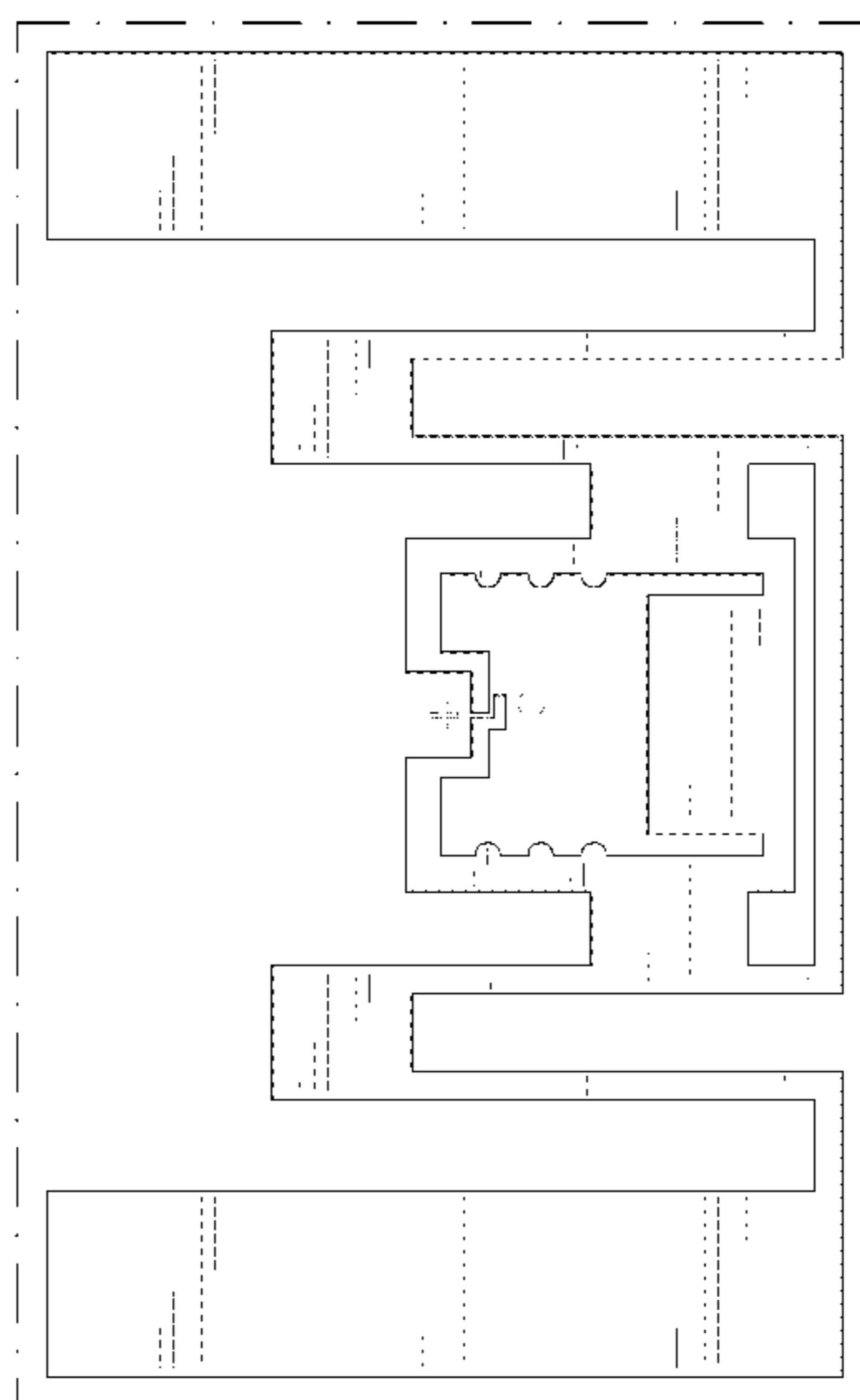
The ornamental design for an RFID antenna, as shown and described.
