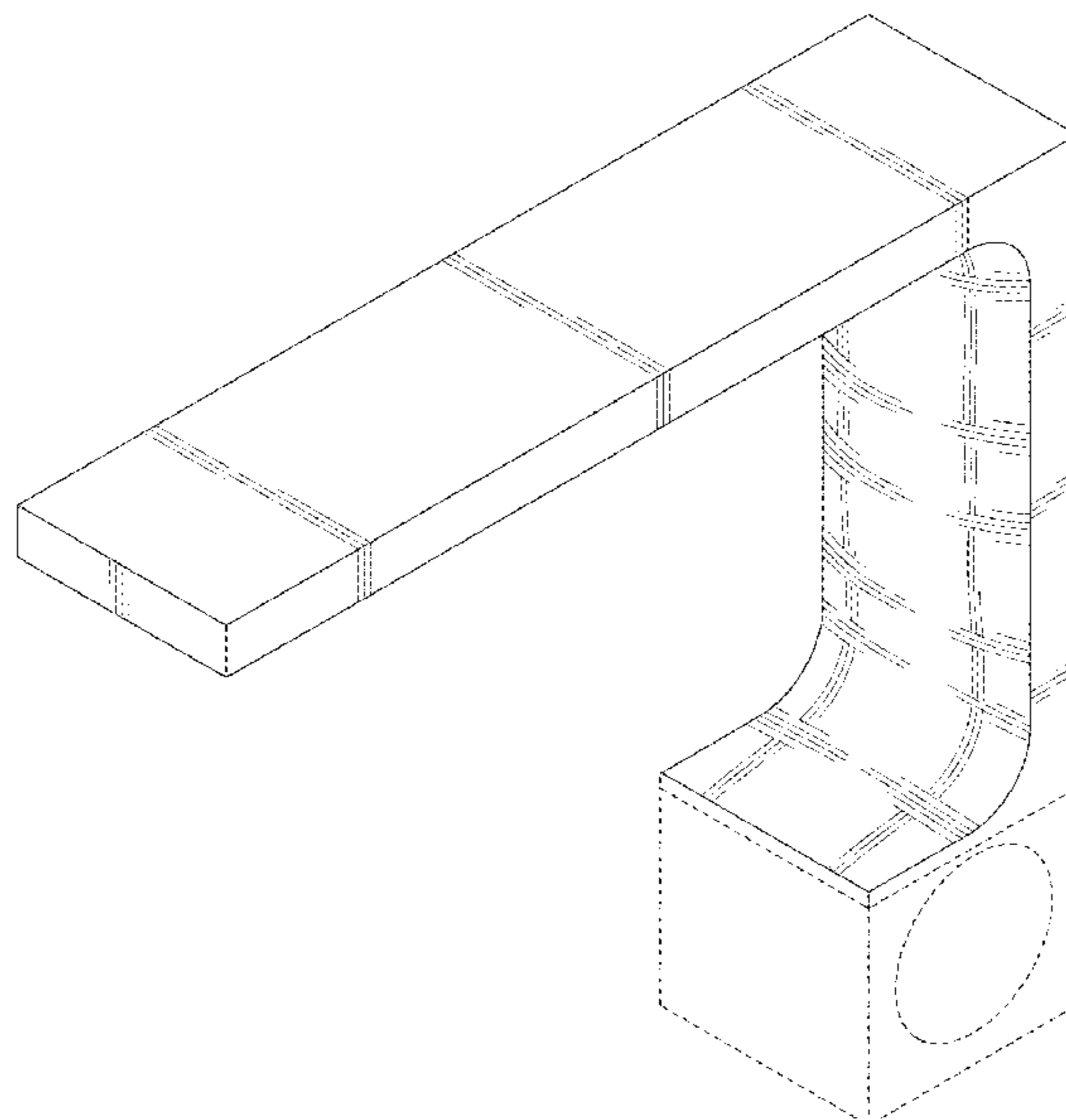
(57) **CLAIM**

The ornamental design for a faucet, as shown and described.

DESCRIPTION

FIG. 1 is a front, right perspective view of a faucet of the new design;
FIG. 2 is a front elevational view of the faucet of FIG. 1;
FIG. 3 is a rear elevational view of the faucet of FIG. 1;
FIG. 4 is a left side elevational view of the faucet of FIG. 1;
FIG. 5 is a right side elevational view of the faucet of FIG. 1;
FIG. 6 is a top plan view of the faucet of FIG. 1;
FIG. 7 is a bottom plan view of the faucet of FIG. 1;
FIG. 8 is a cross-sectional view of the faucet of FIG. 1, taken along the line 8-8 in FIG. 2, showing the contour of a portion of the exterior surface of the faucet;
FIG. 9 is a cross-sectional view of the faucet of FIG. 1, taken along the line 9-9 in FIG. 2, showing the contour of another portion of the exterior surface of the faucet;
FIG. 10 is a cross-sectional view of the faucet of FIG. 1, taken along the line 10-10 in FIG. 5, showing the contour of another portion of the exterior surface of the faucet;
FIG. 11 is a cross-sectional view of the faucet of FIG. 1, taken along the line 11-11 in FIG. 5, showing the contour of another portion of the exterior surface of the faucet;
FIG. 12 is a cross-sectional view of the faucet of FIG. 1, taken along the line 12-12 in FIG. 5, showing the contour of another portion of the exterior surface of the faucet; and
FIG. 13 is a cross-sectional view of the faucet of FIG. 1, taken along the line 13-13 in FIG. 5, showing the contour of another portion of the exterior surface of the faucet.

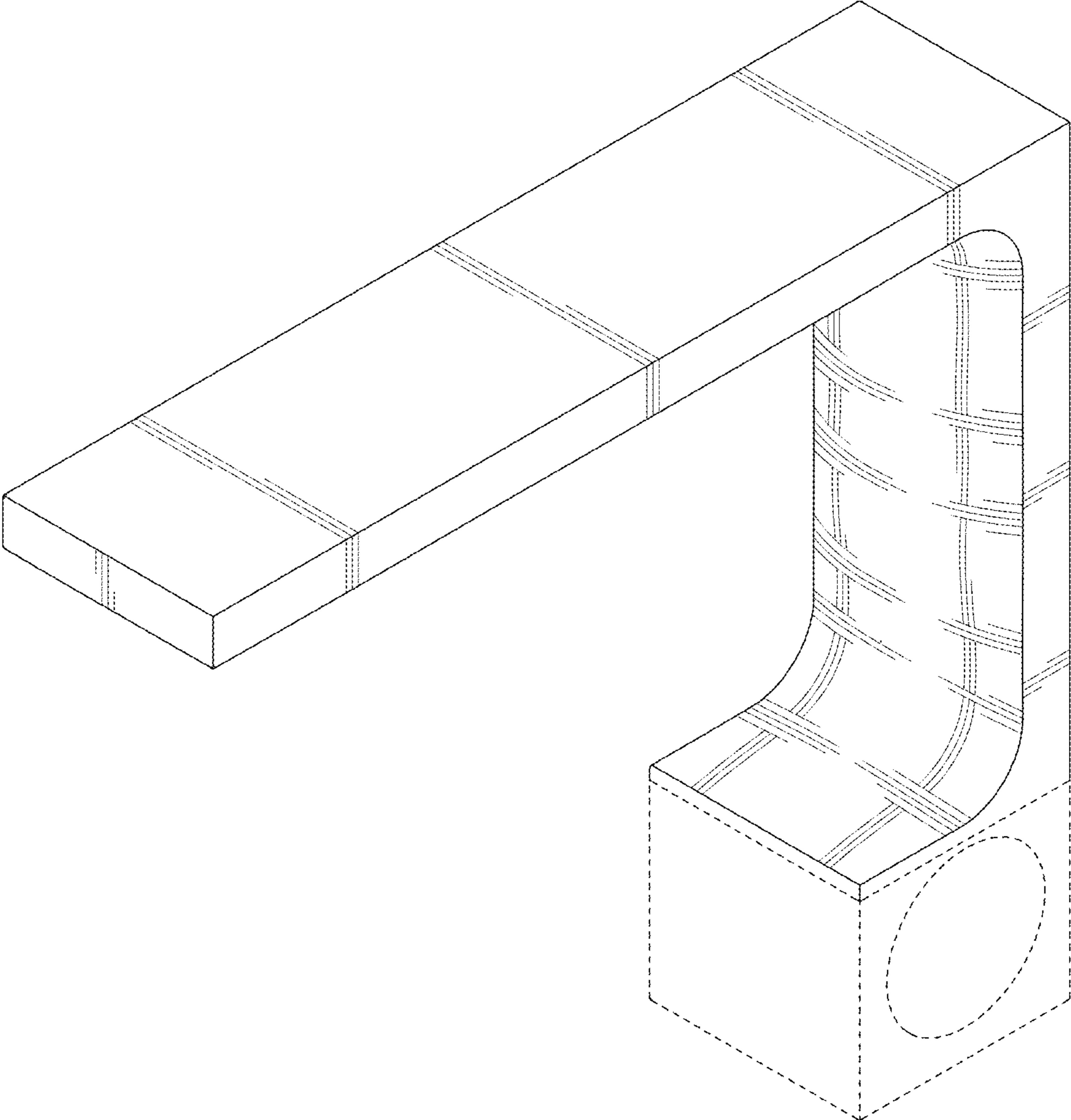

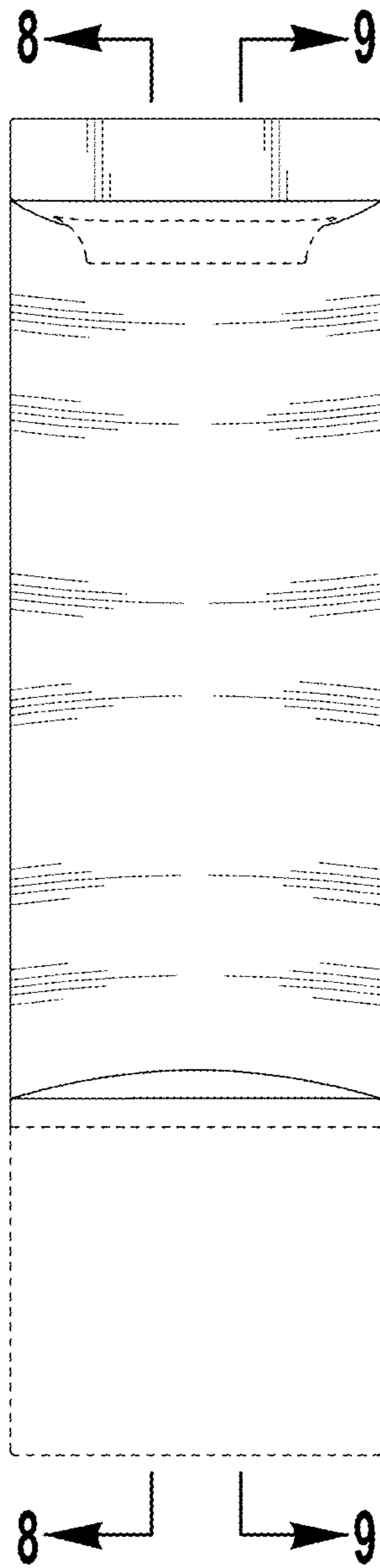

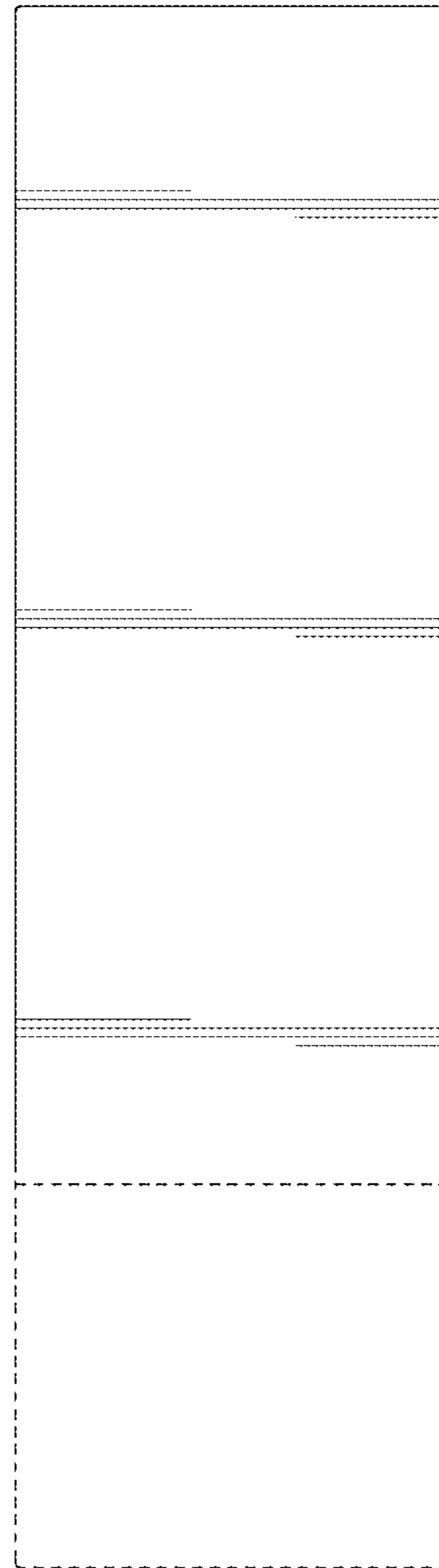

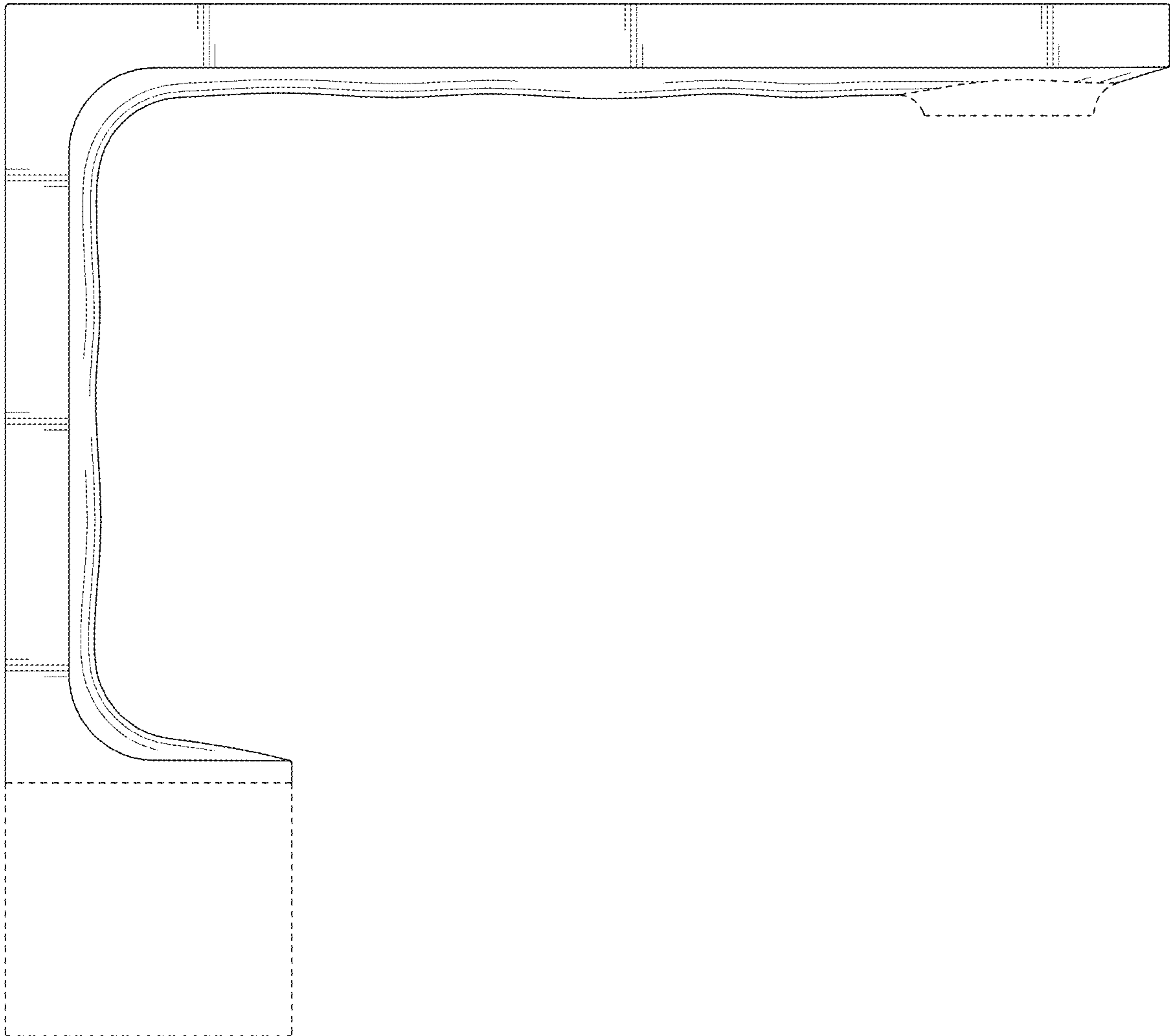

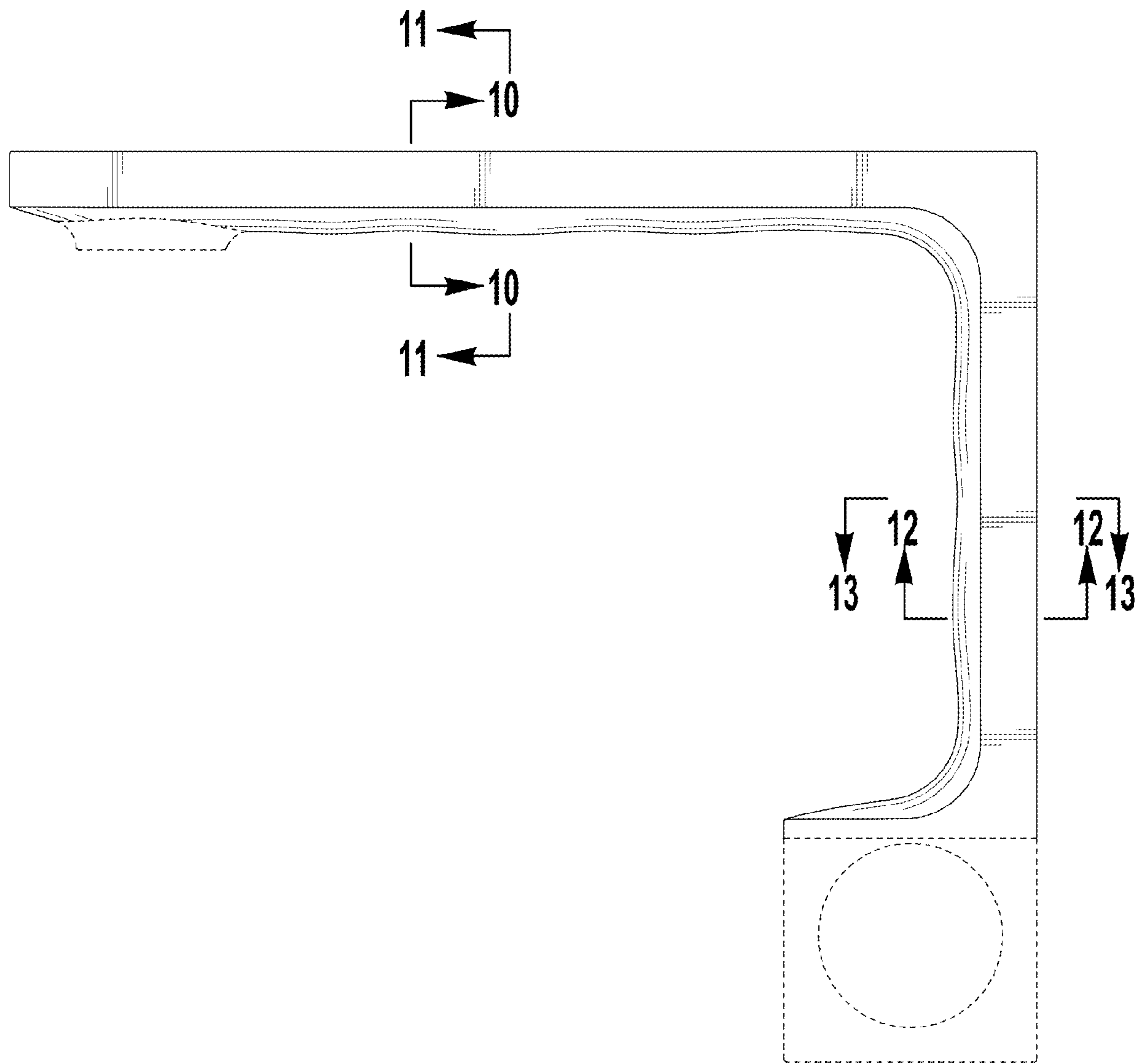

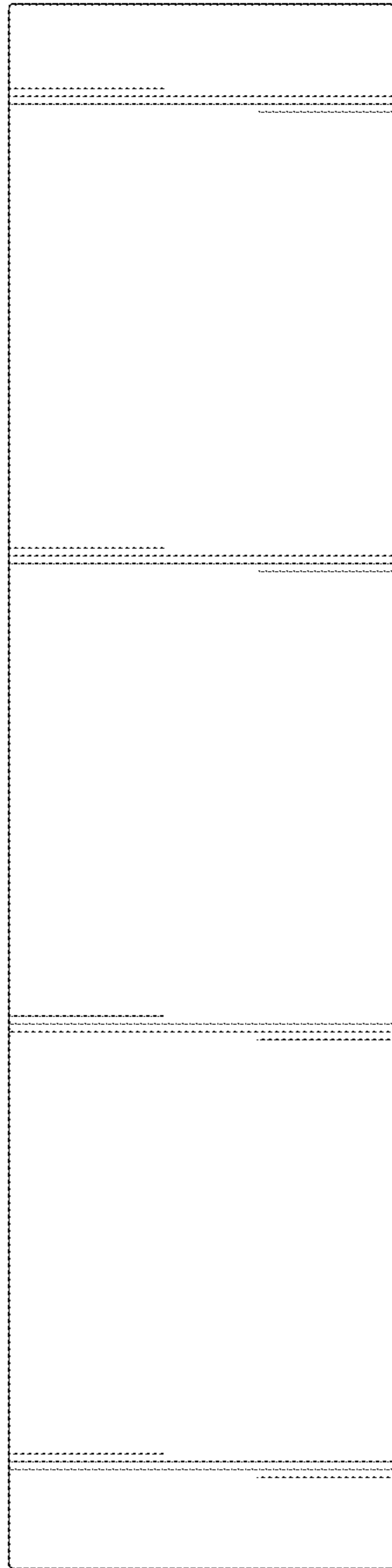

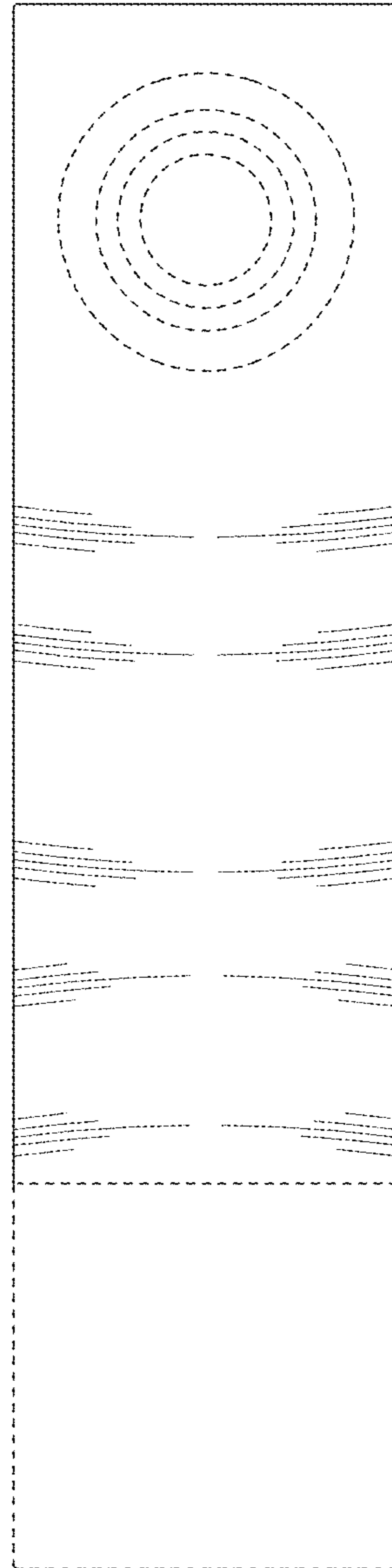

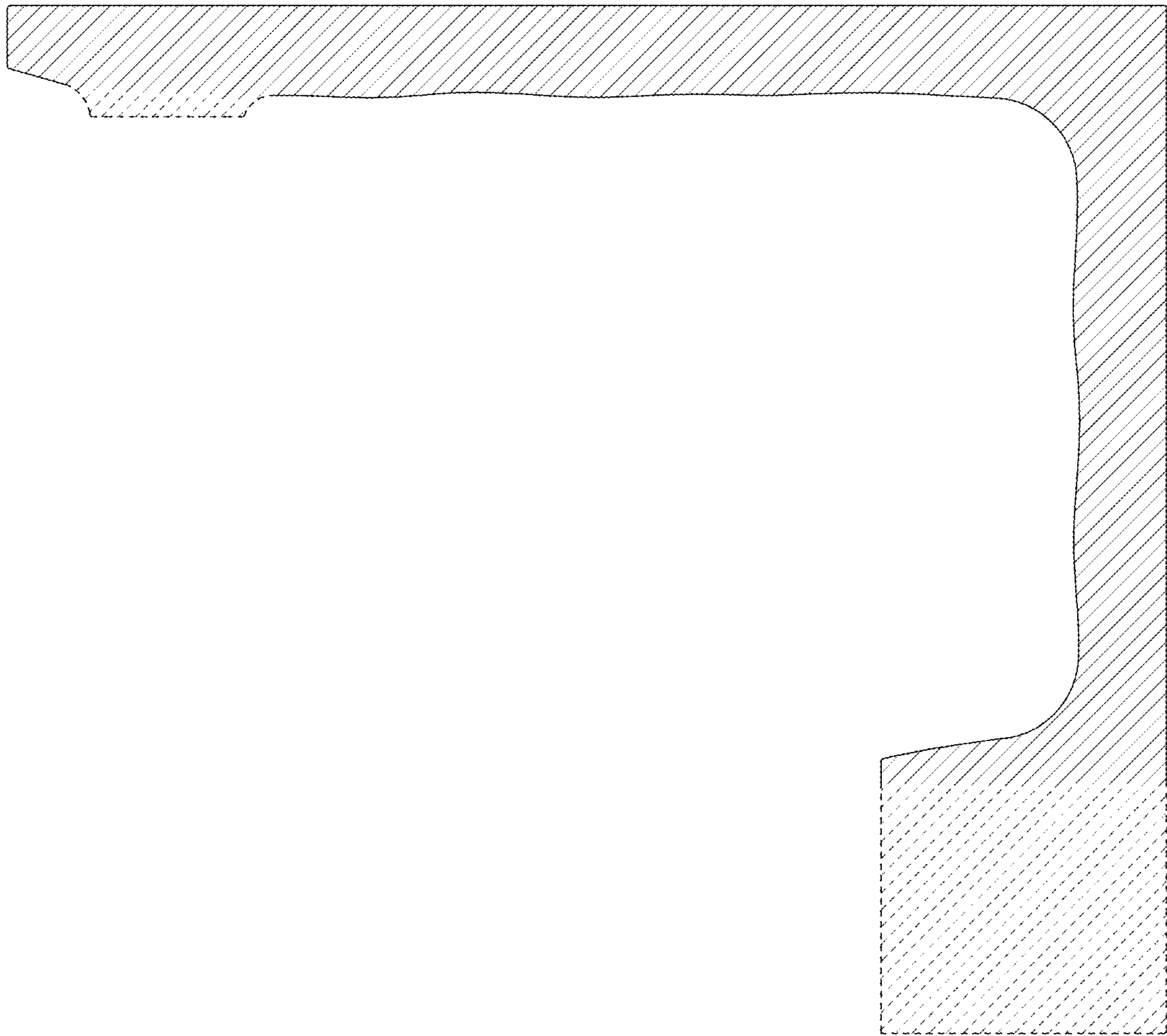

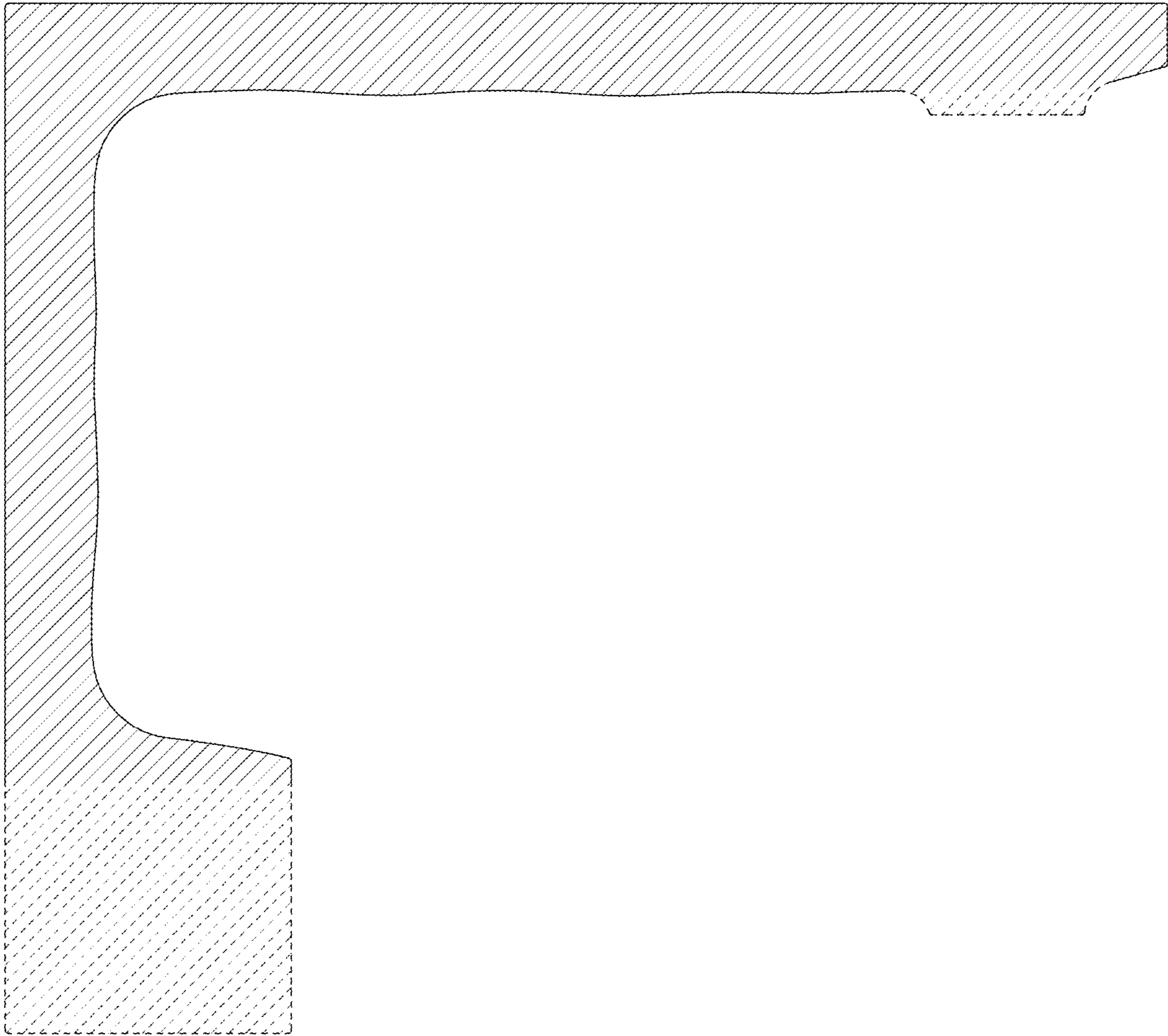

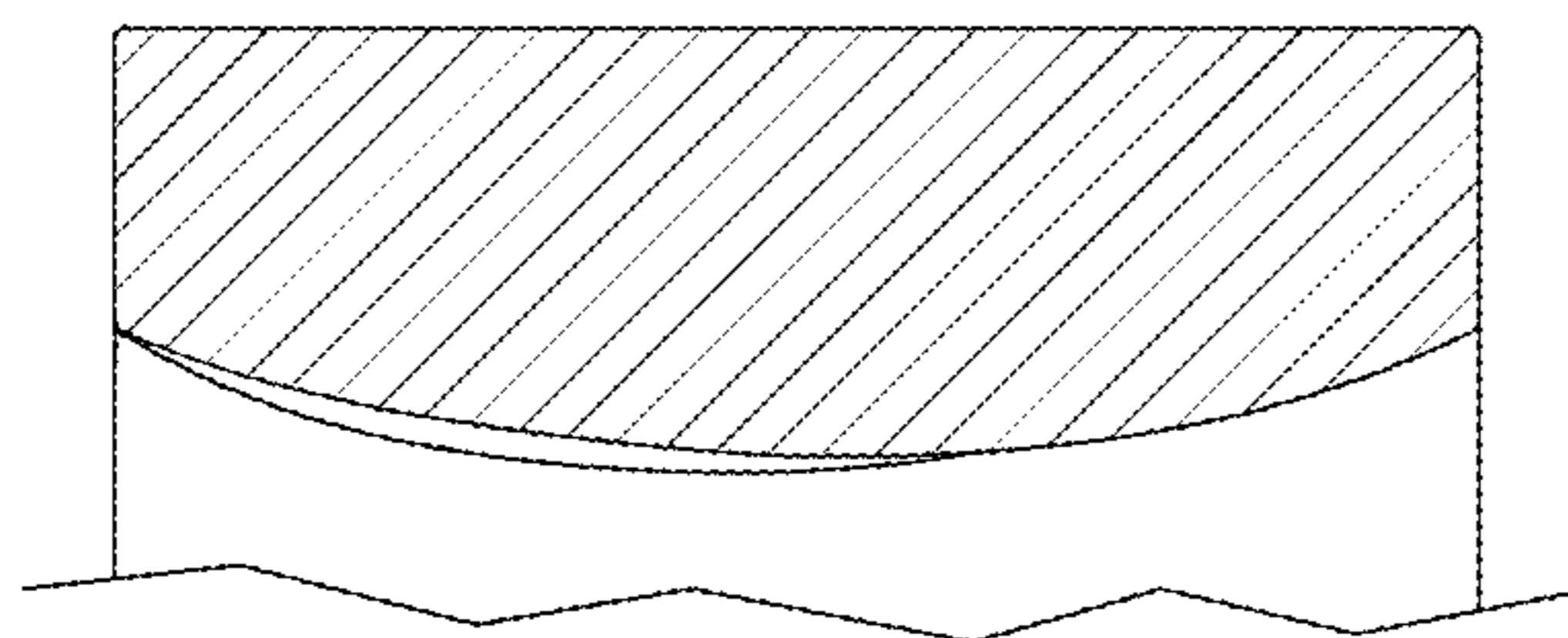

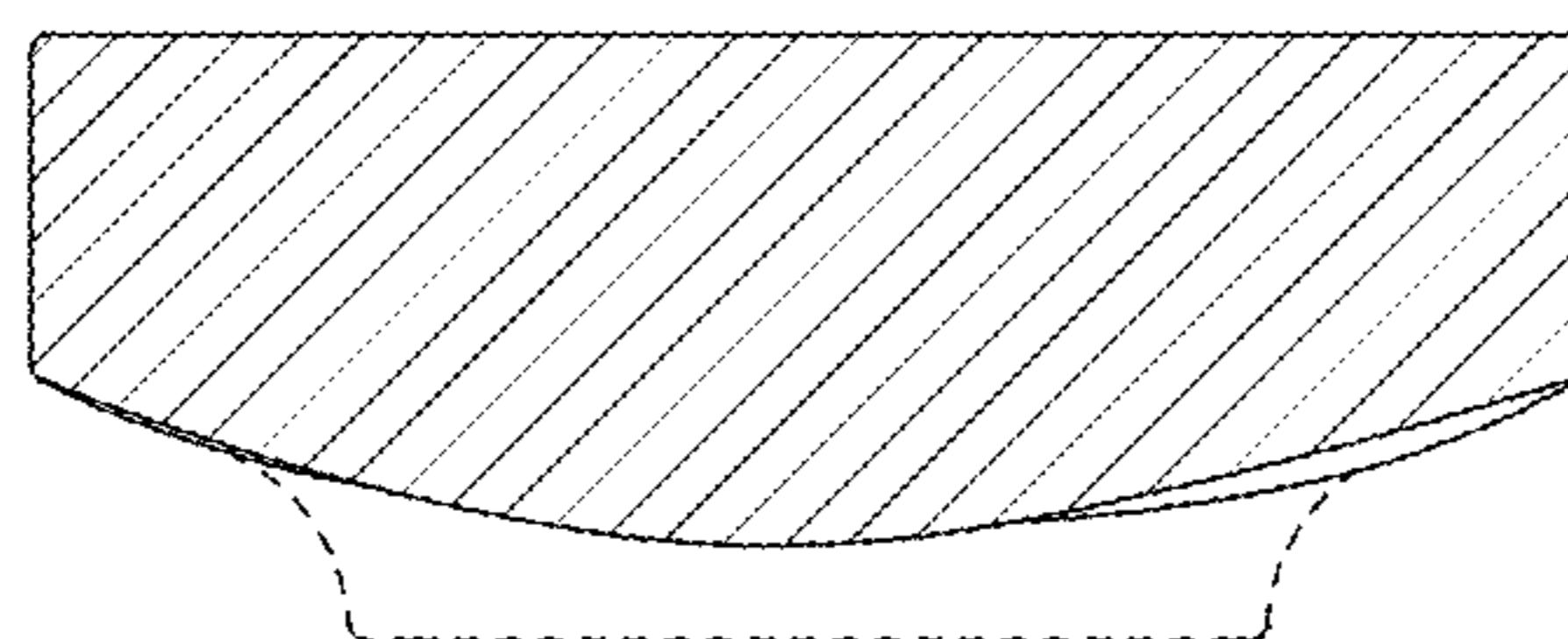

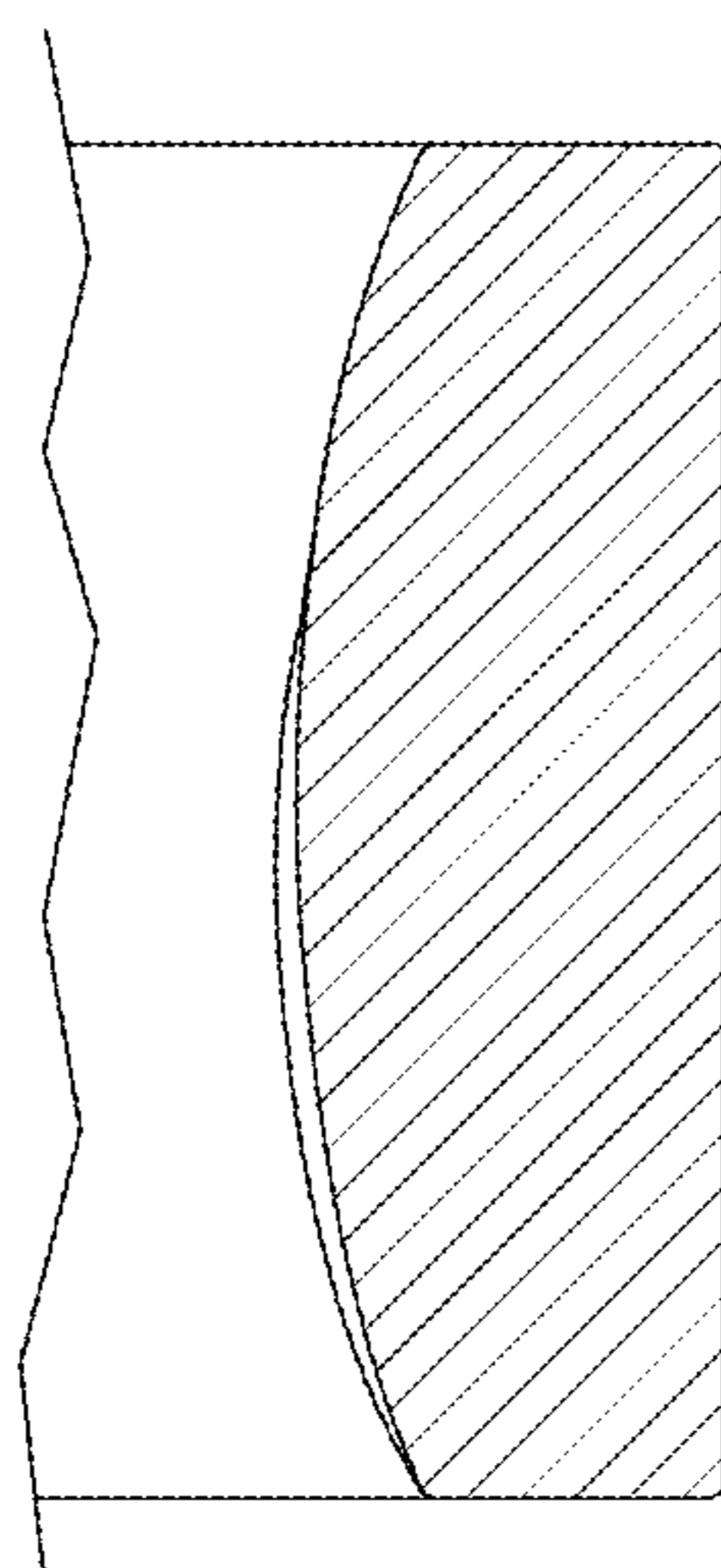

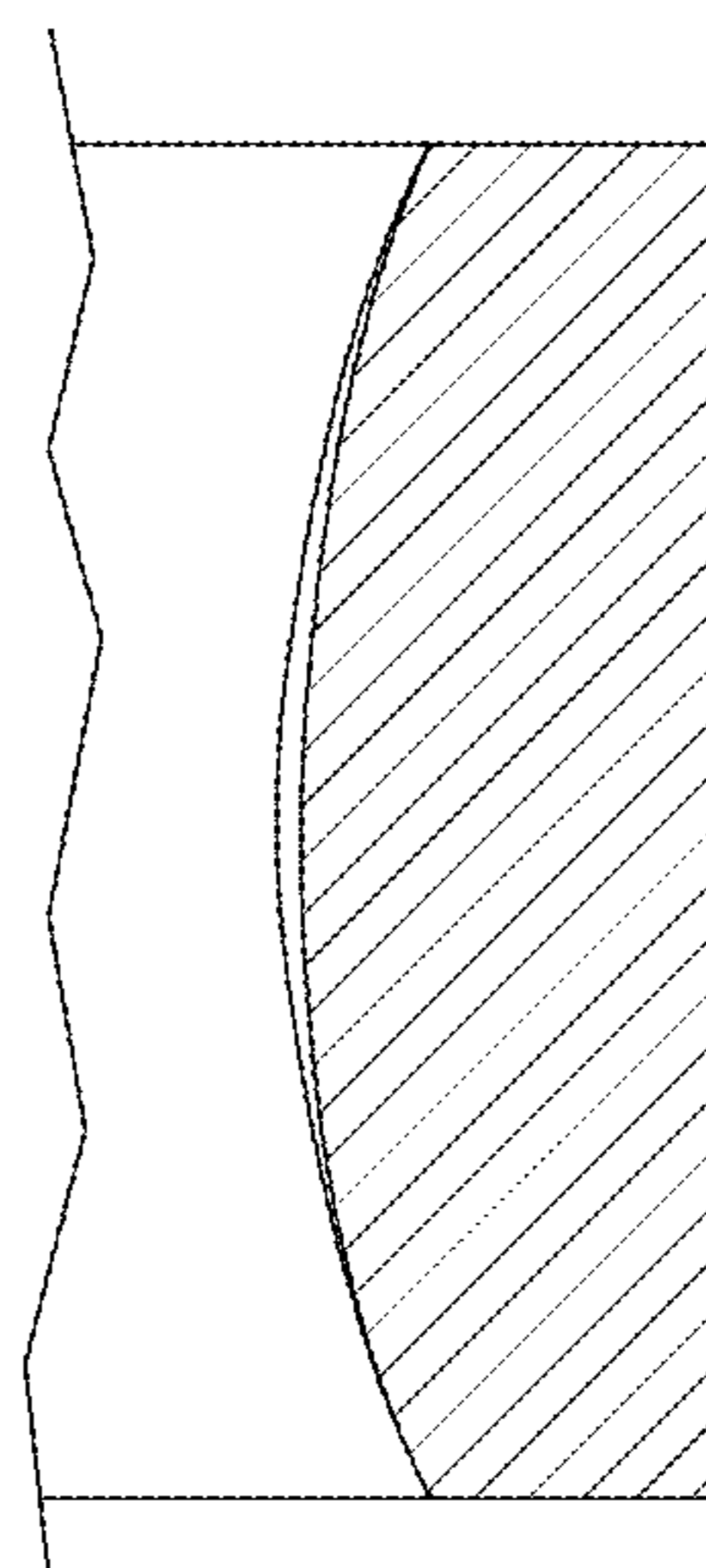
