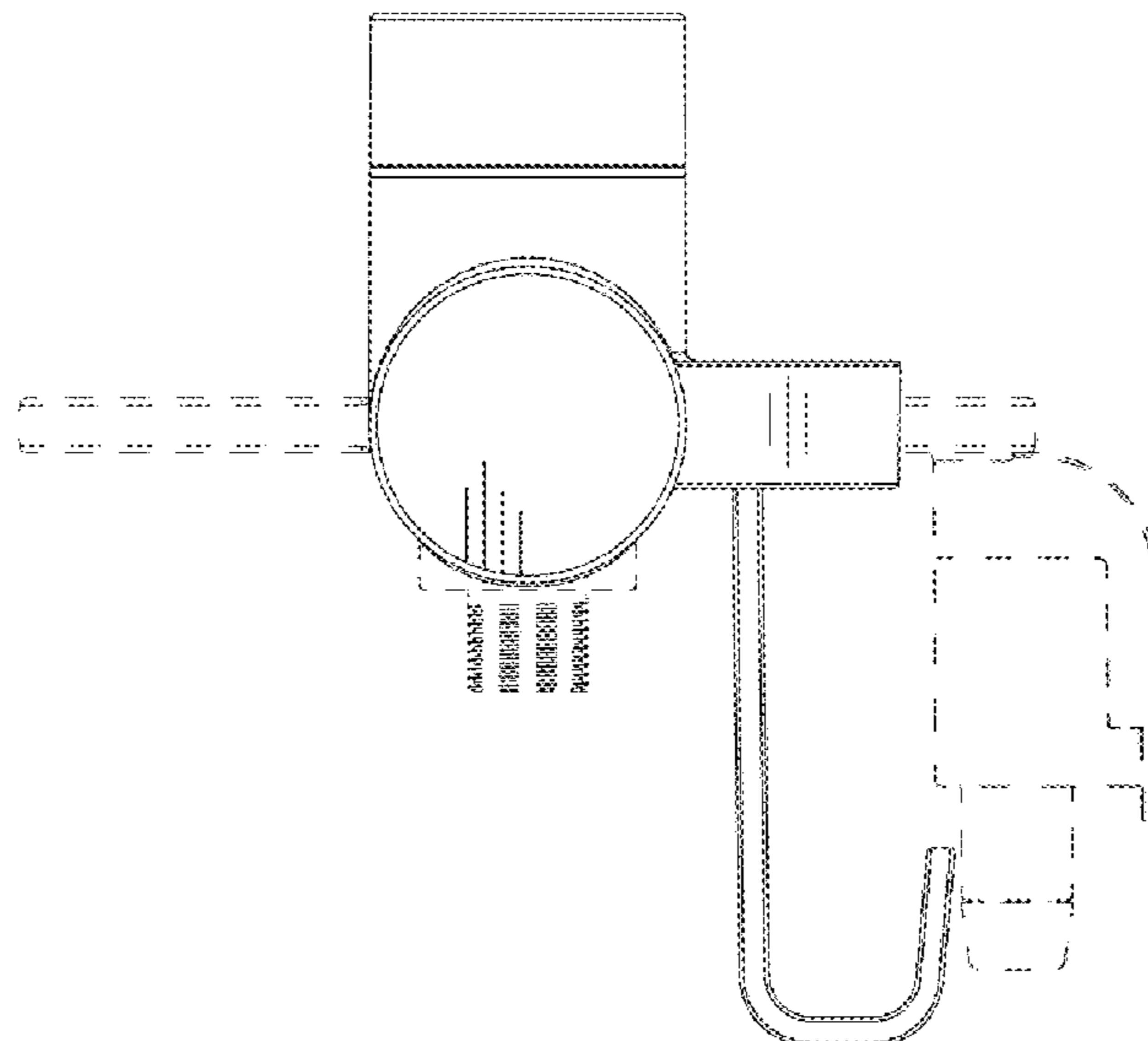
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top plan view of a bidet apparatus showing the new design;

 FIG. 4 is a right-side elevational view thereof;
 FIG. 5 is a rear elevational view thereof;

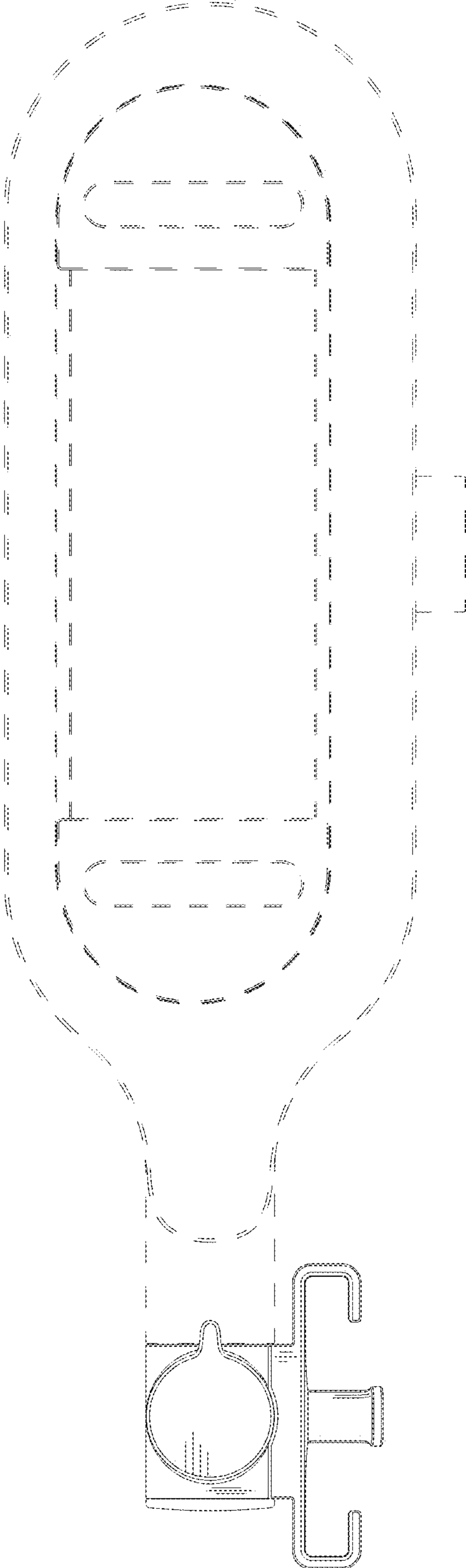

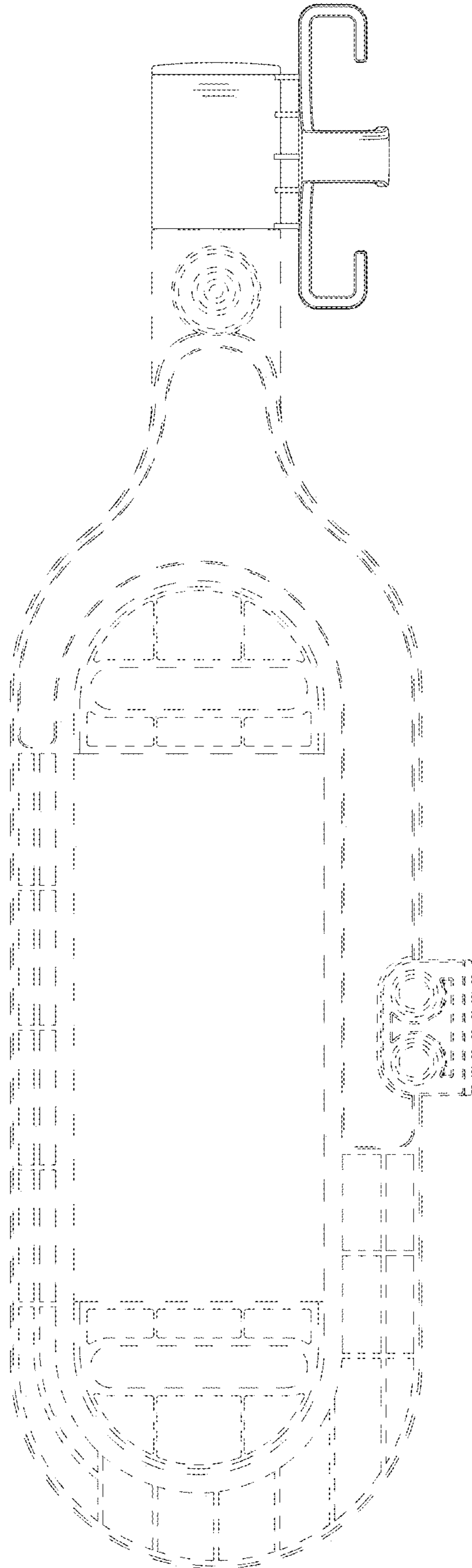

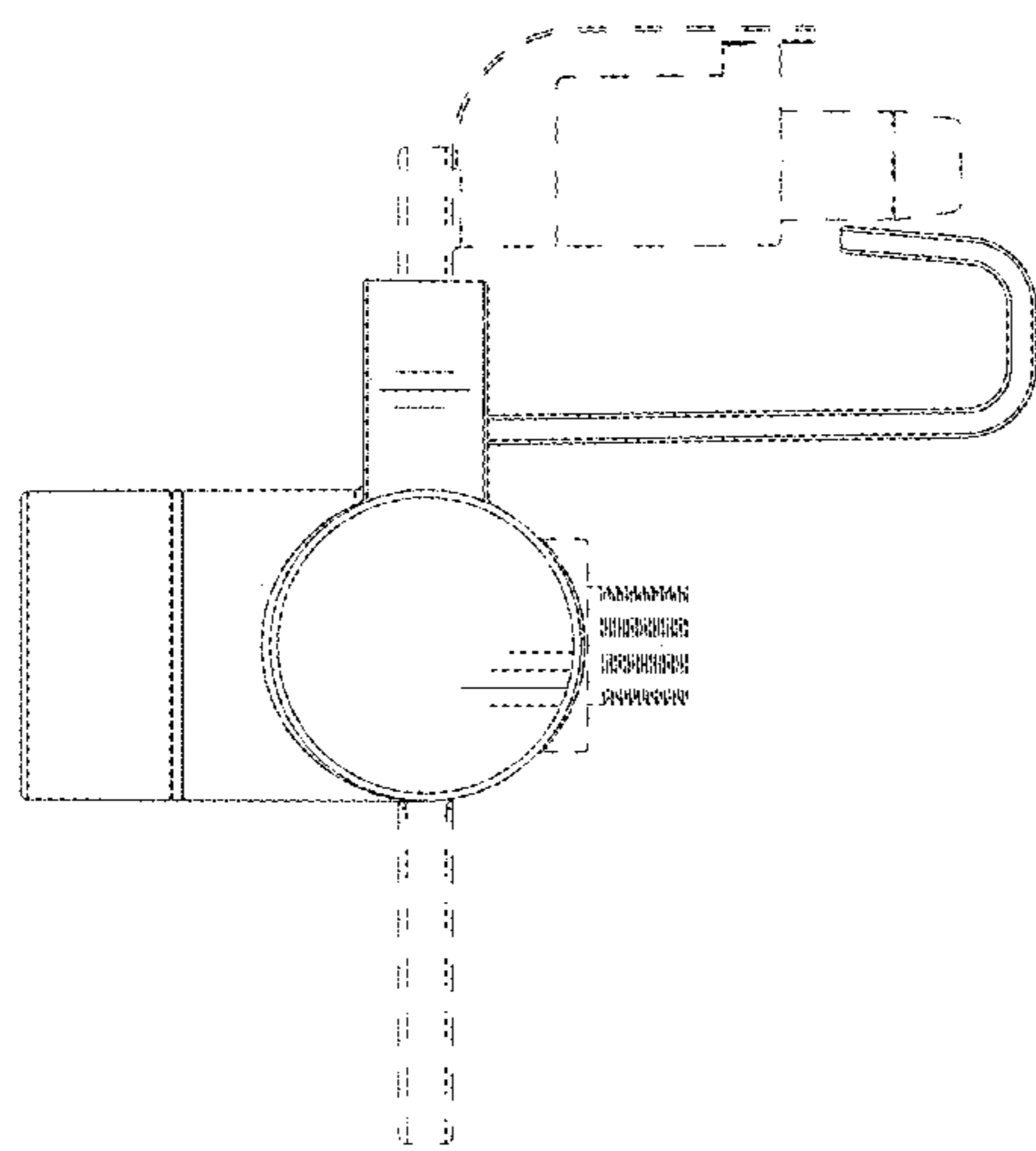

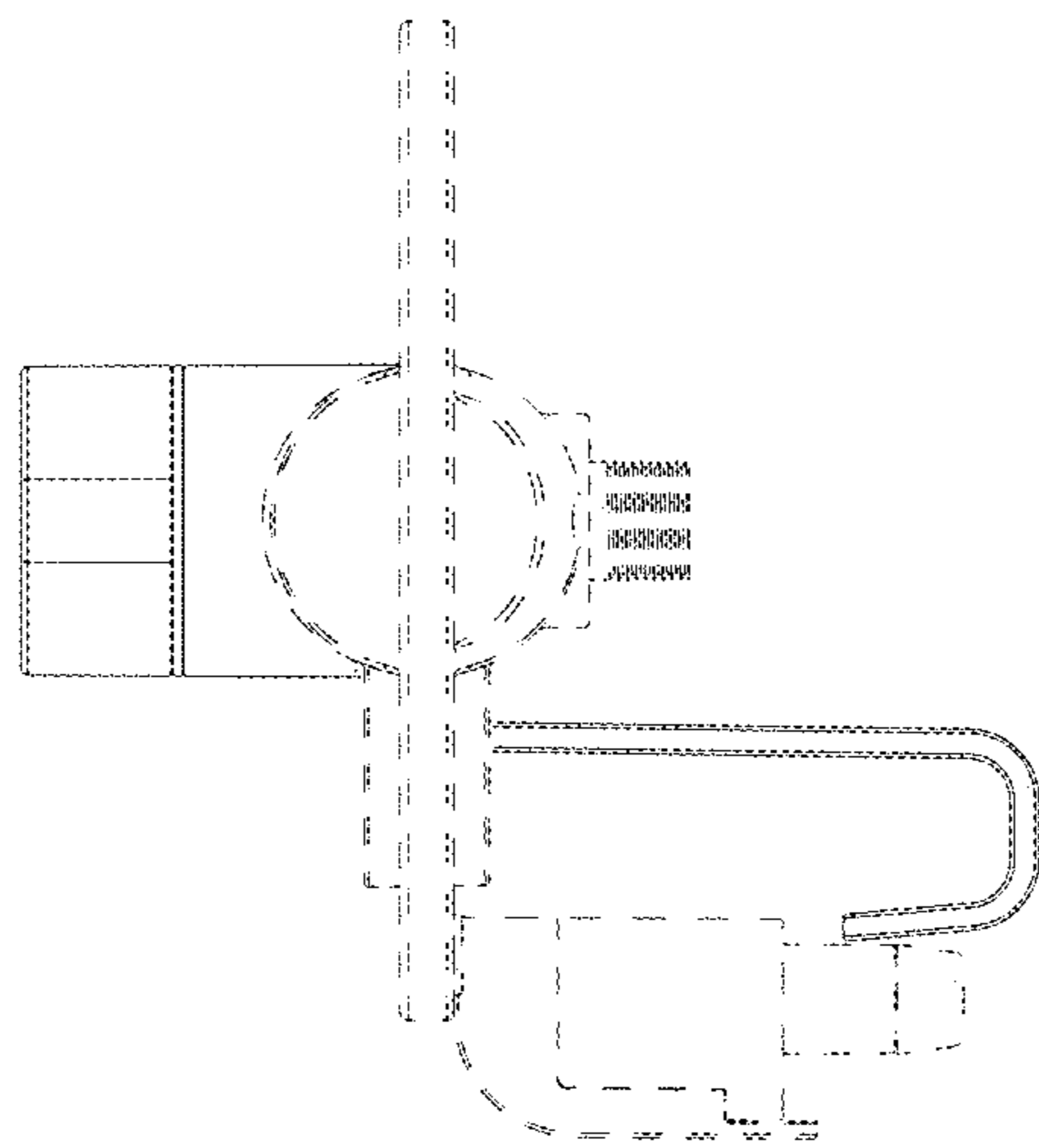

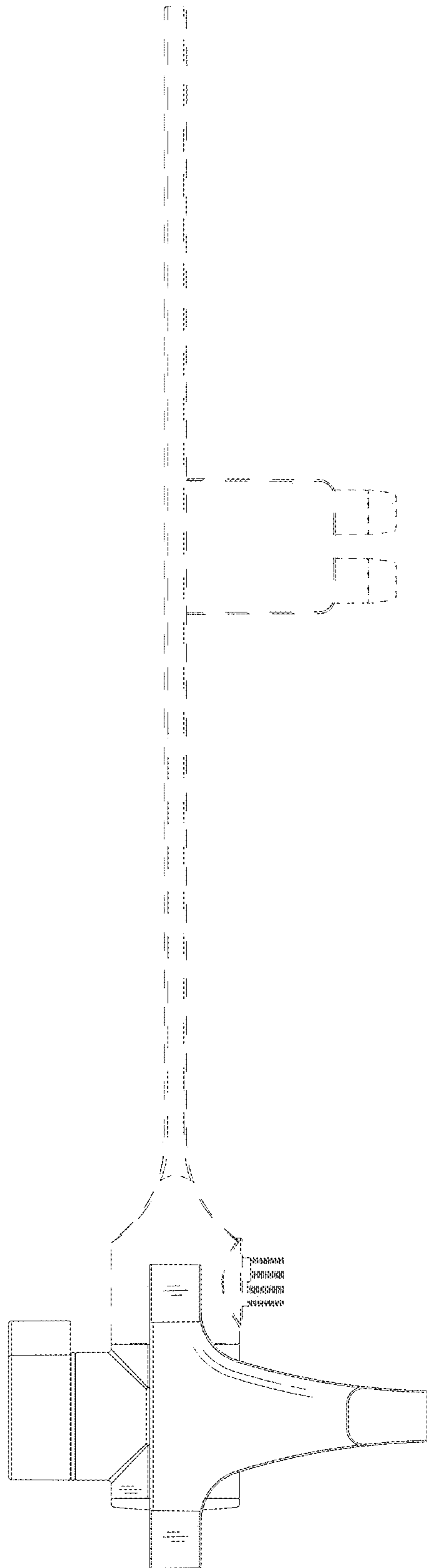

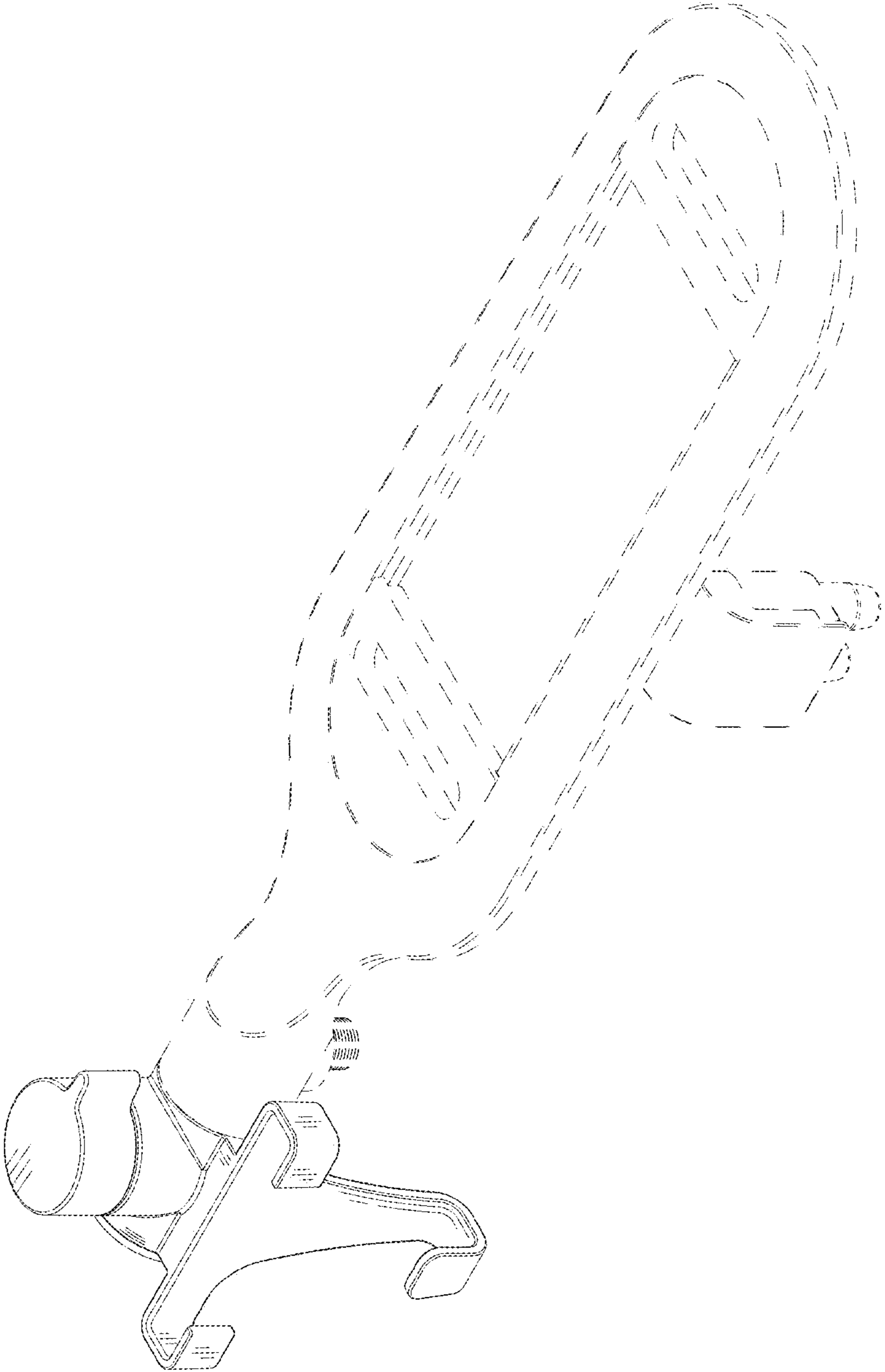

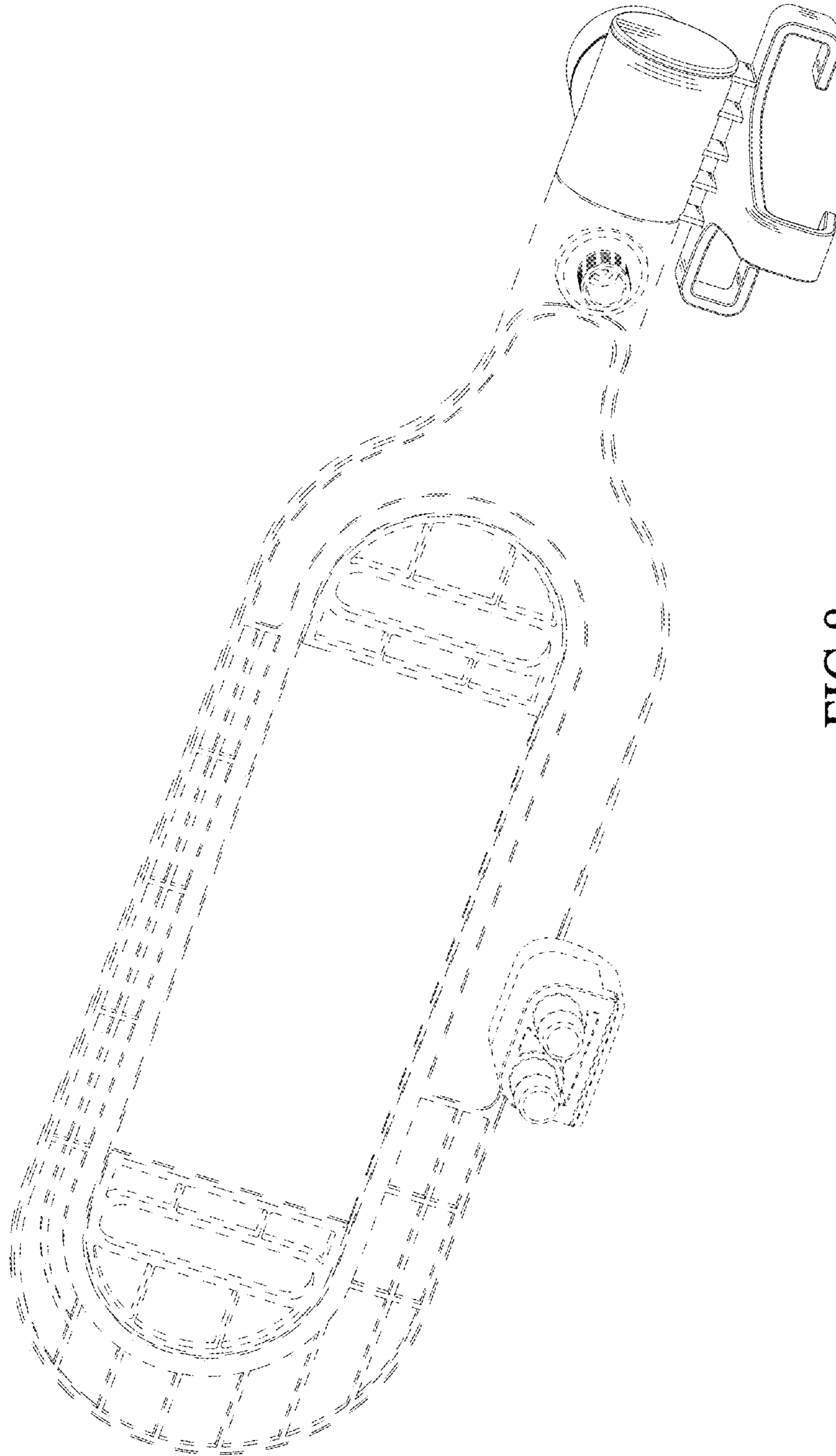
