We claim the ornamental design for a toilet seat lid, as shown and described.

DESCRIPTION

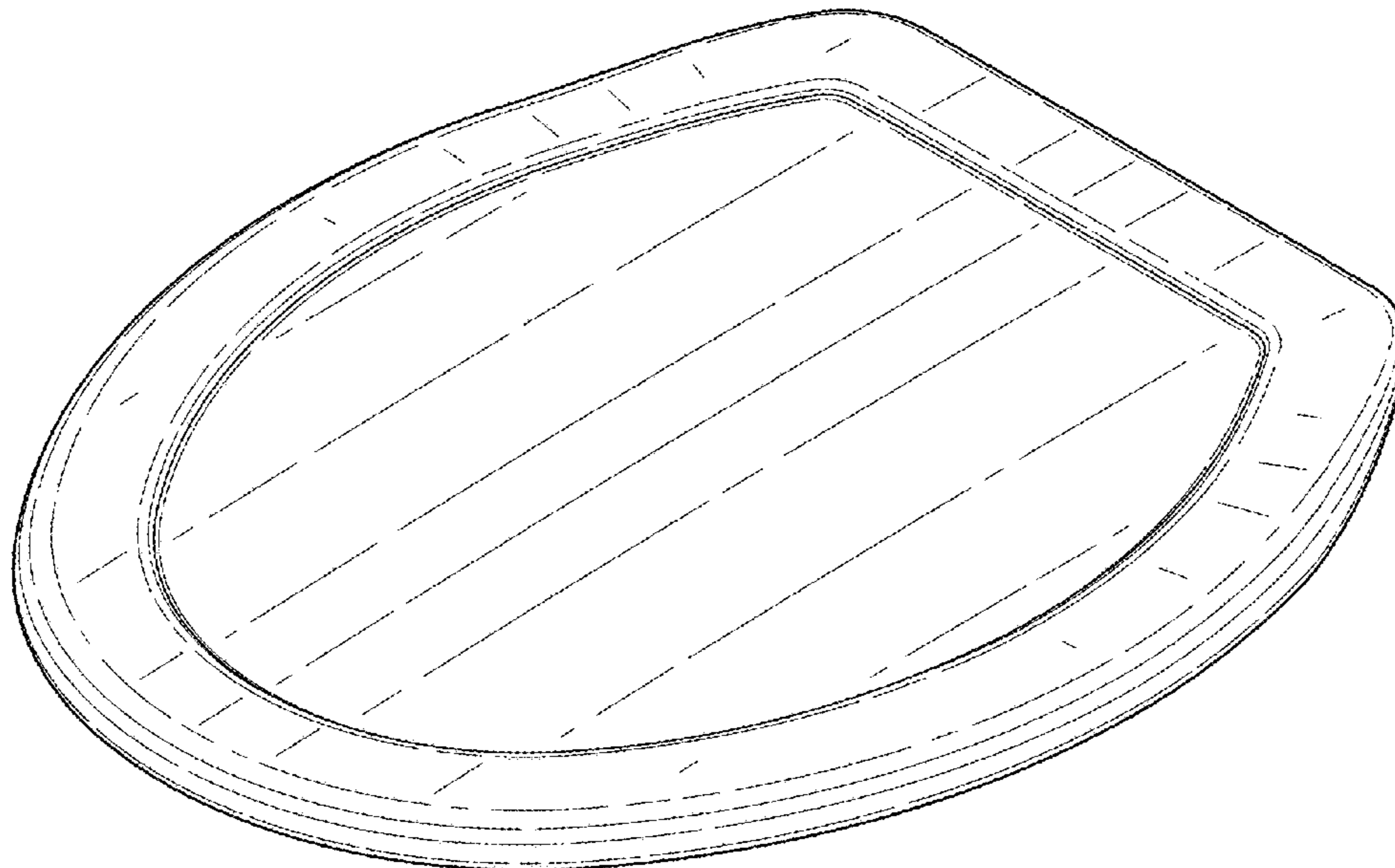
FIG. 1 is a first perspective view of a toilet seat lid according to one embodiment.

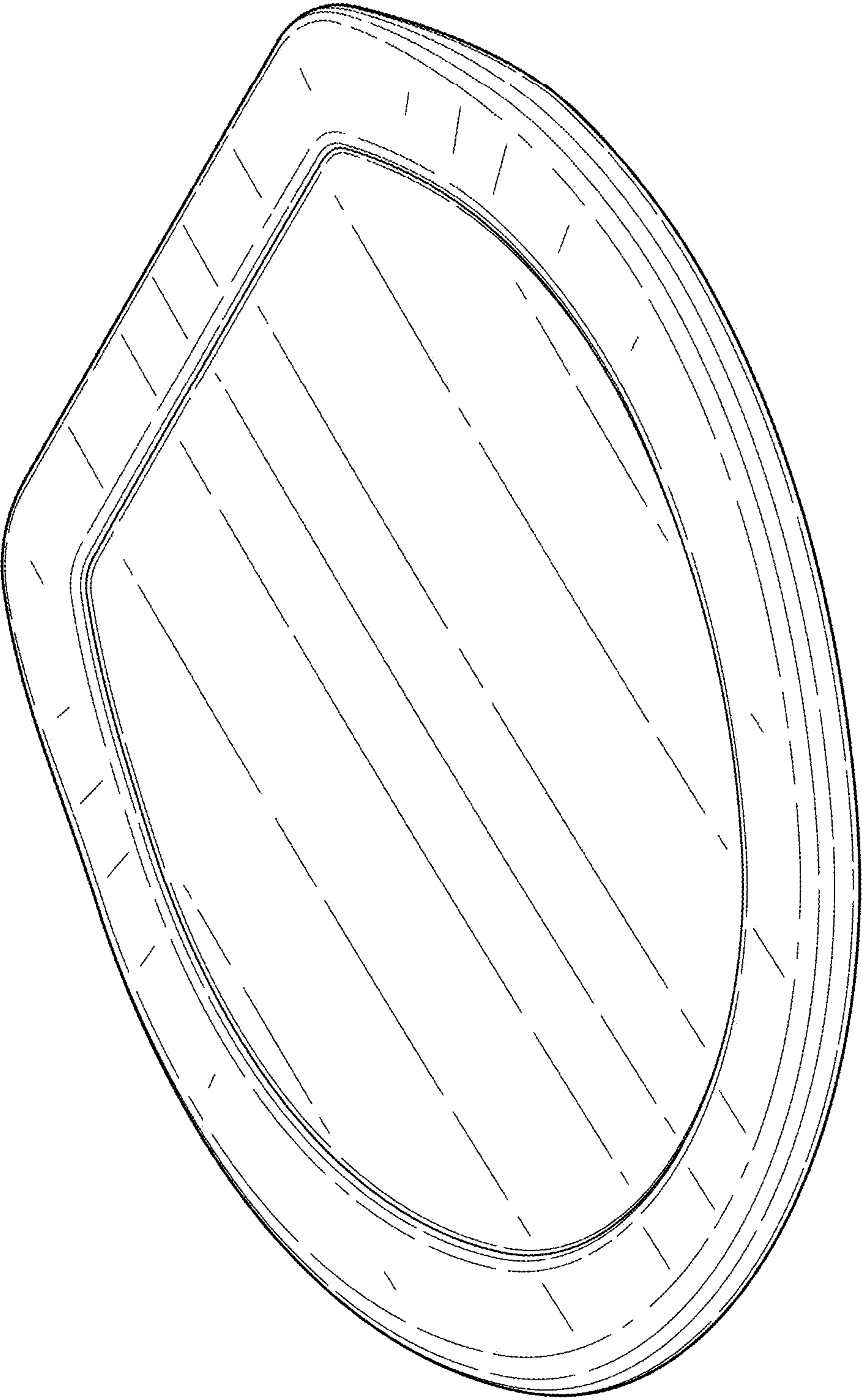

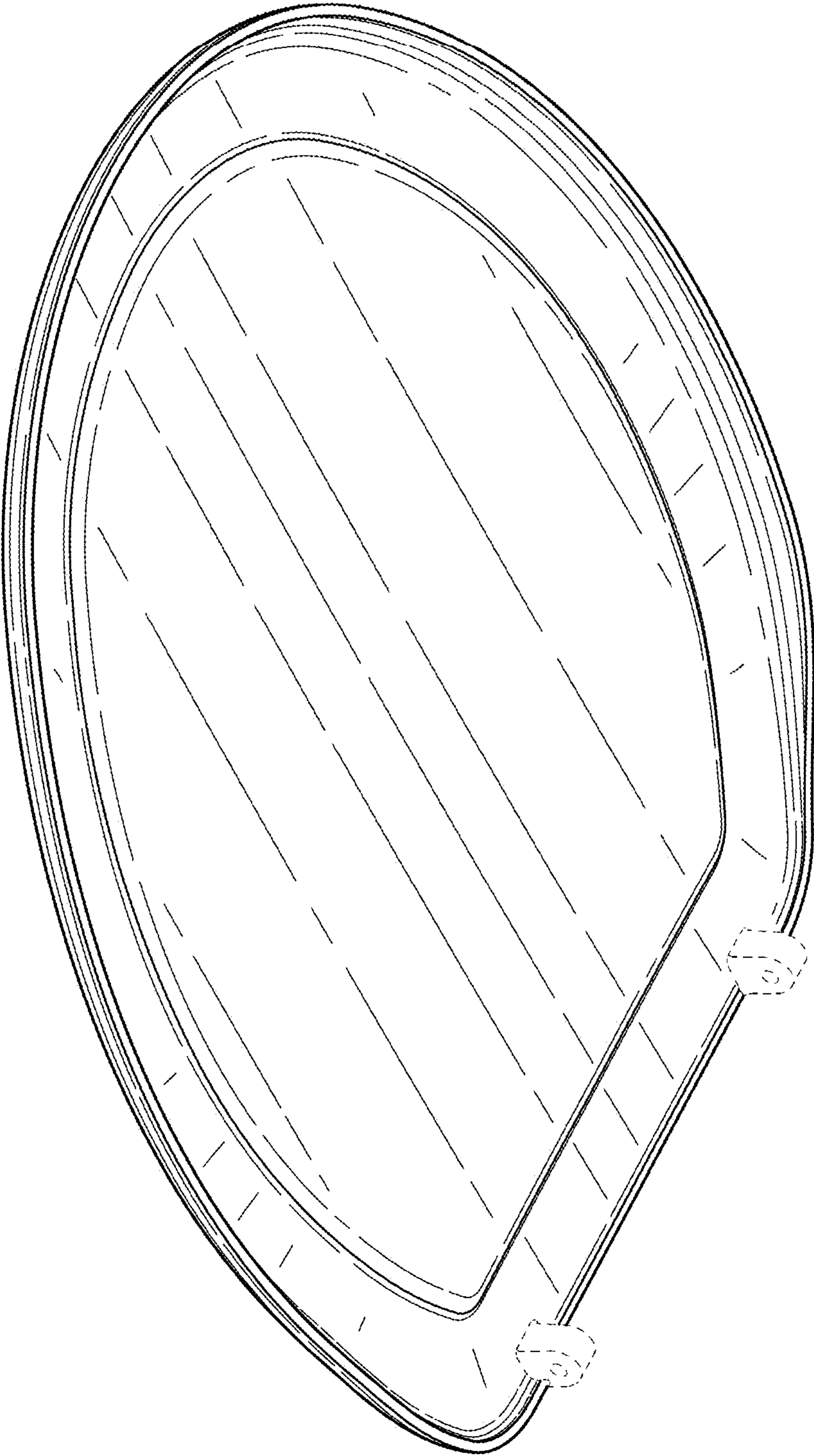

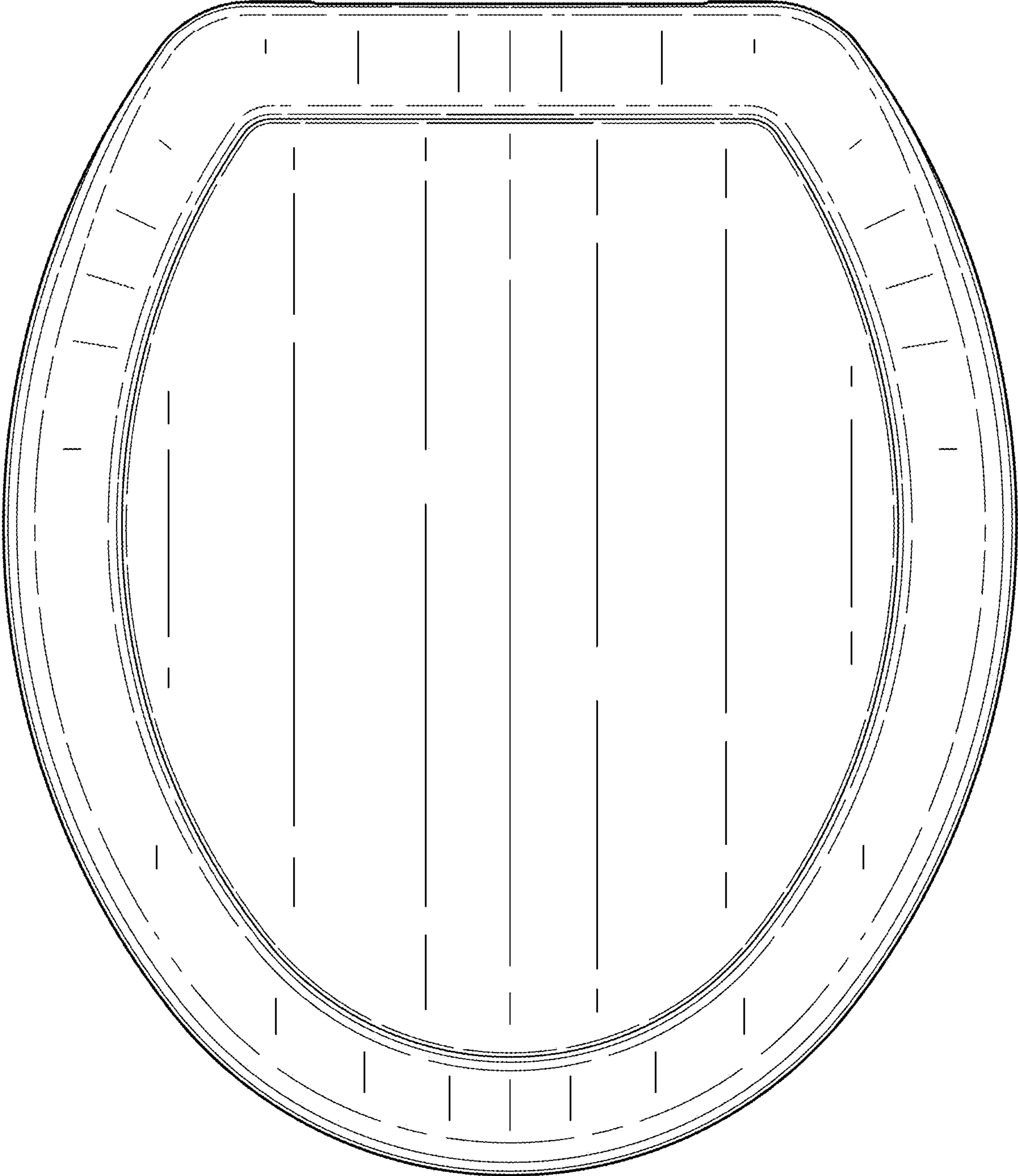

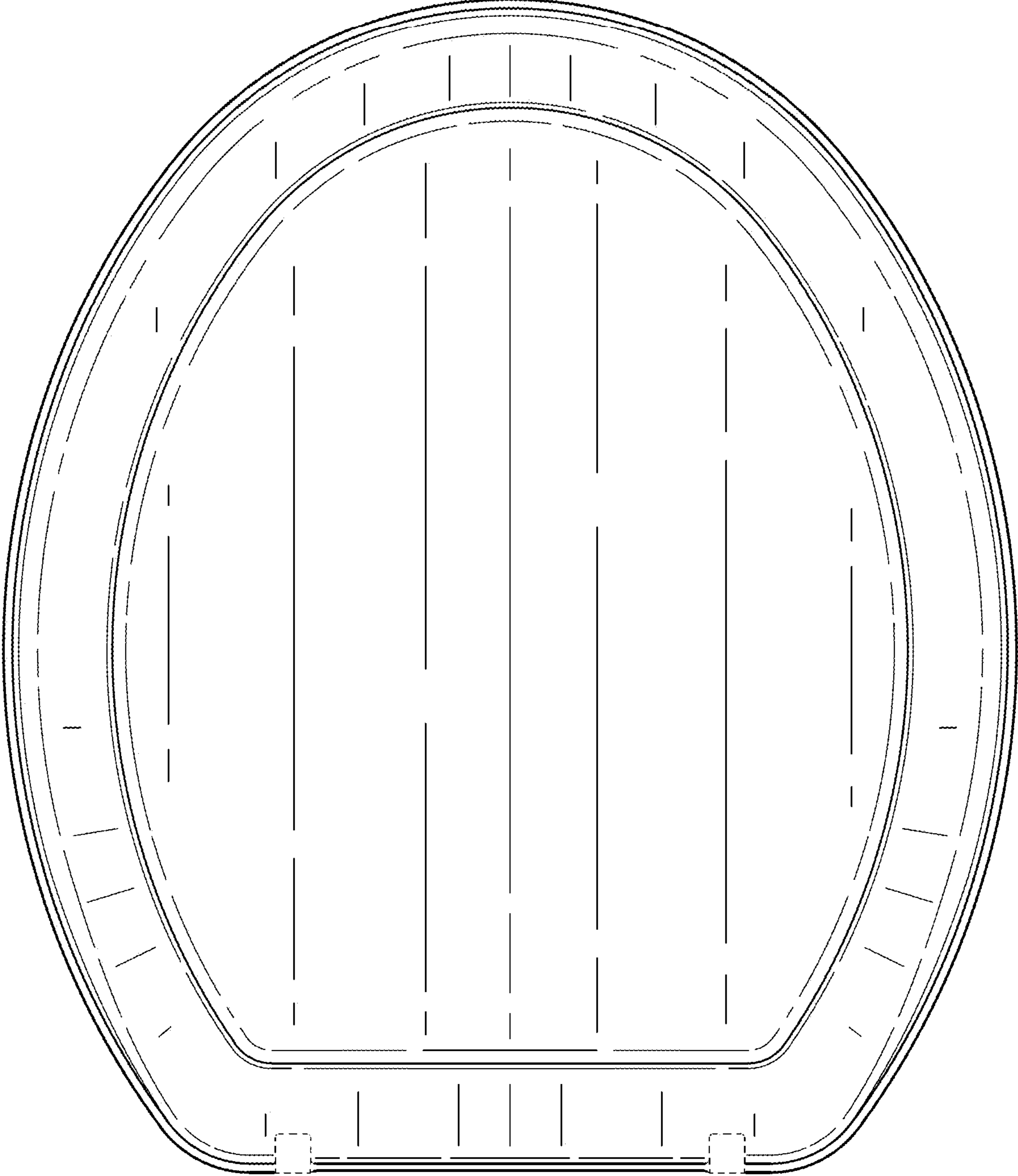

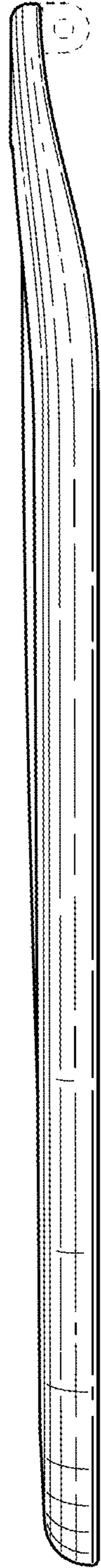

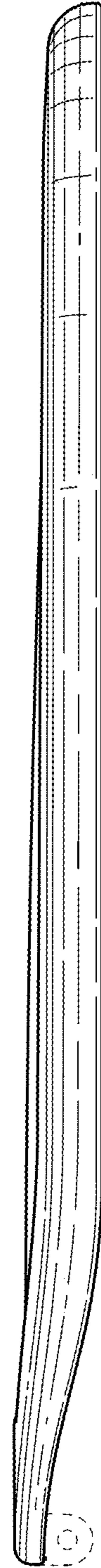

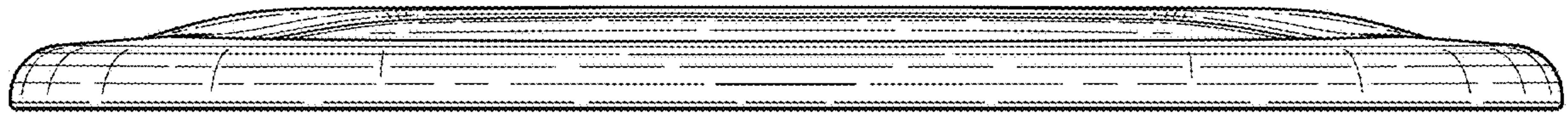
