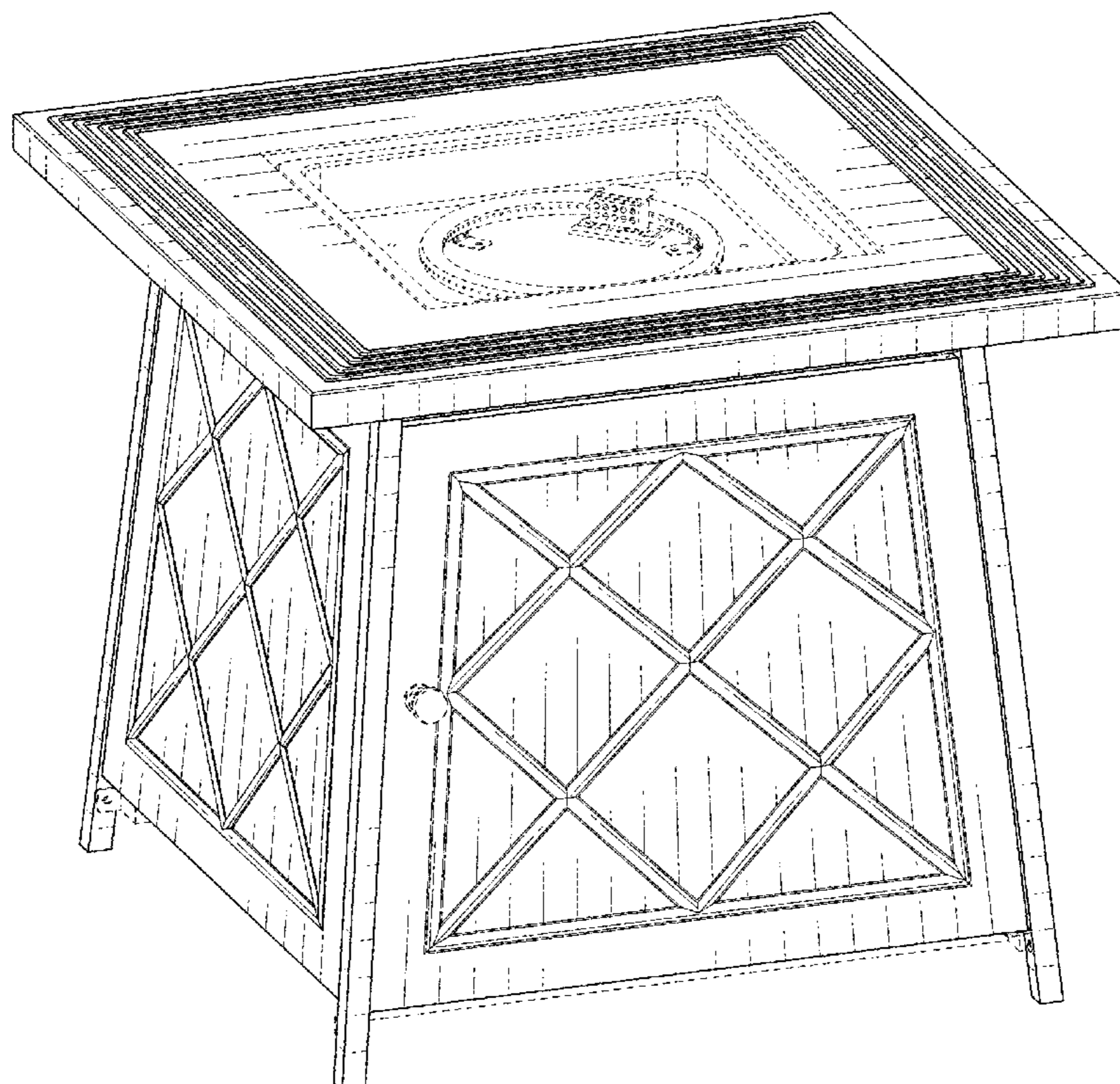
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of a fire pit in accordance with the present design;

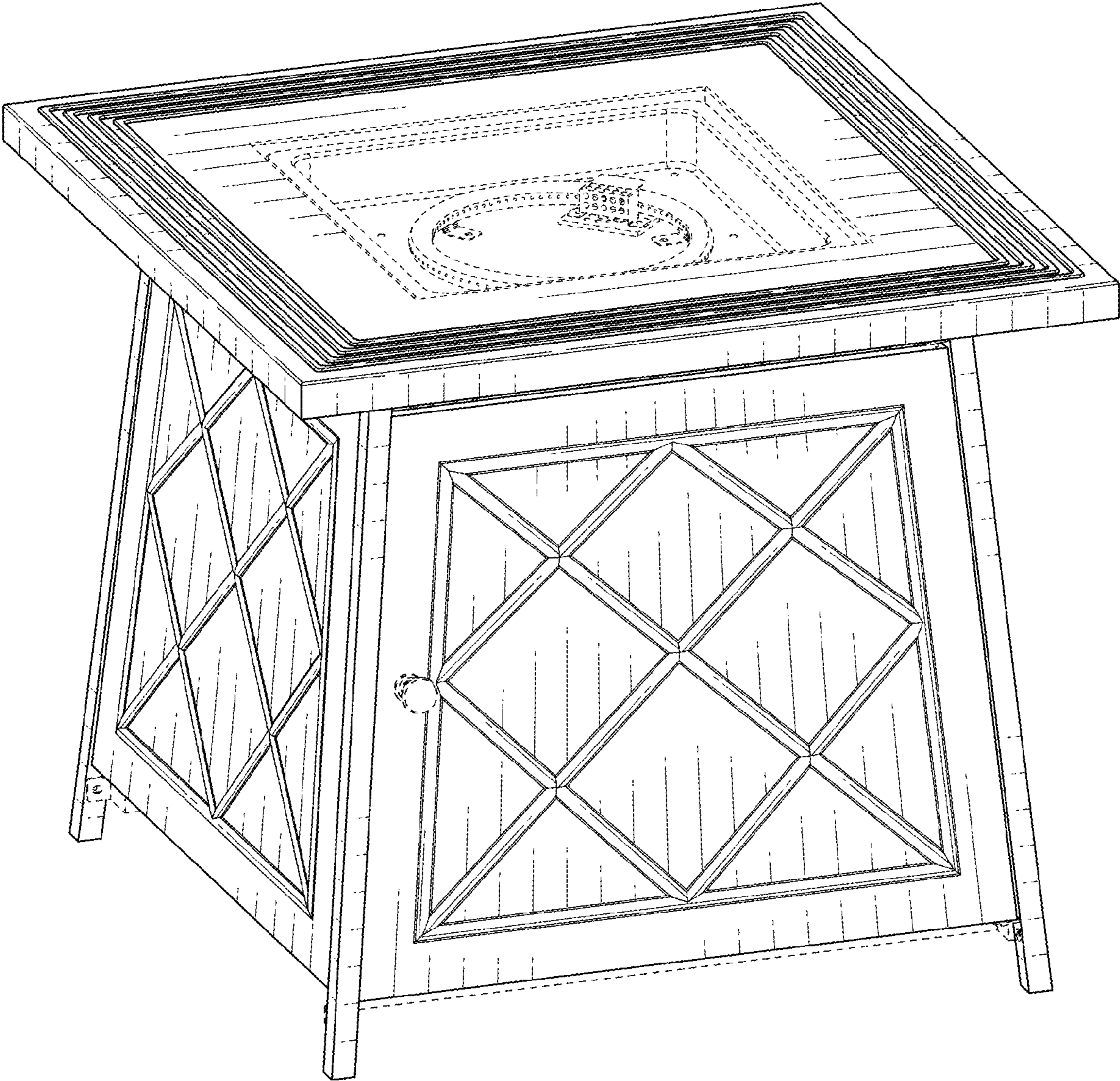

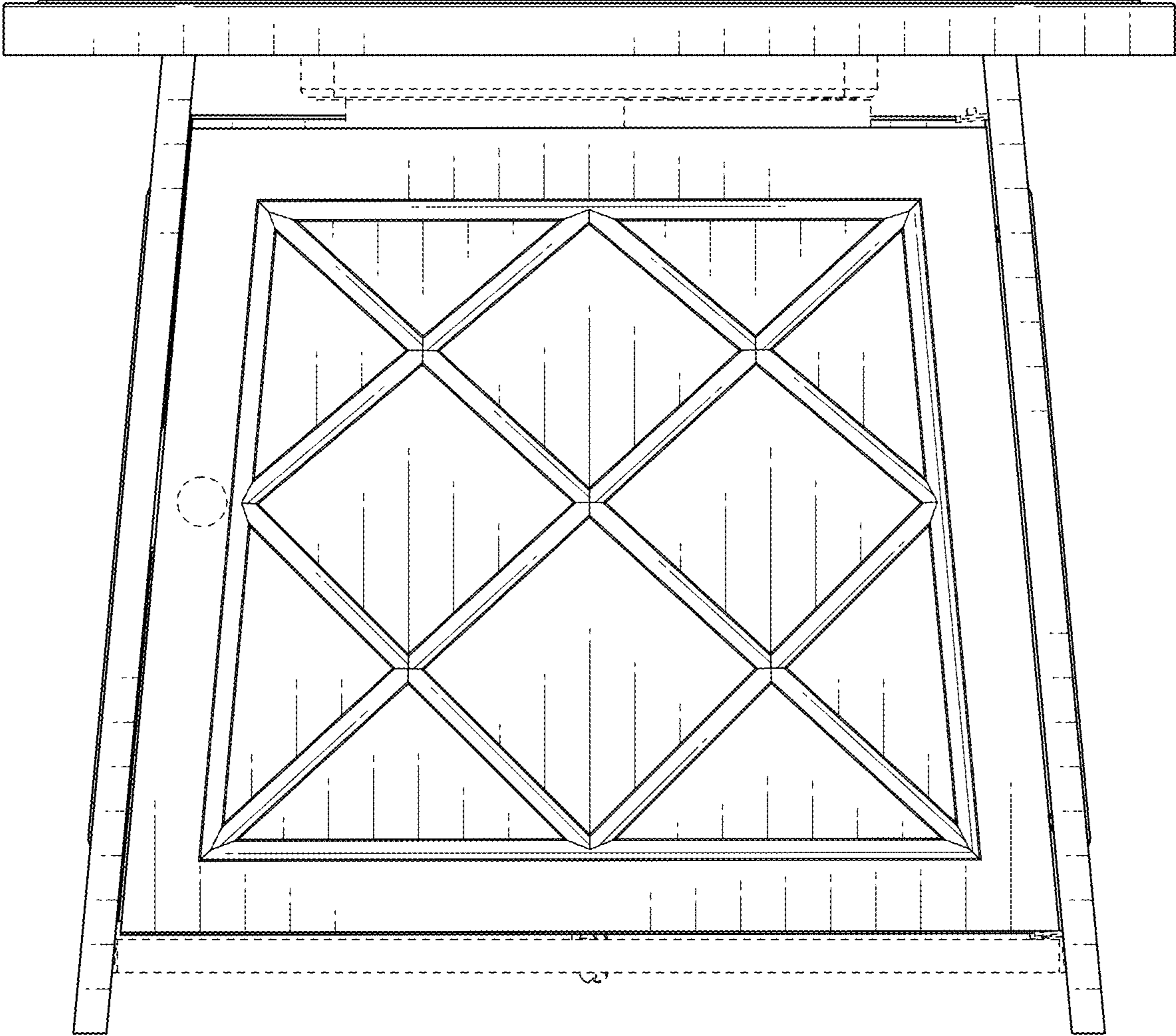

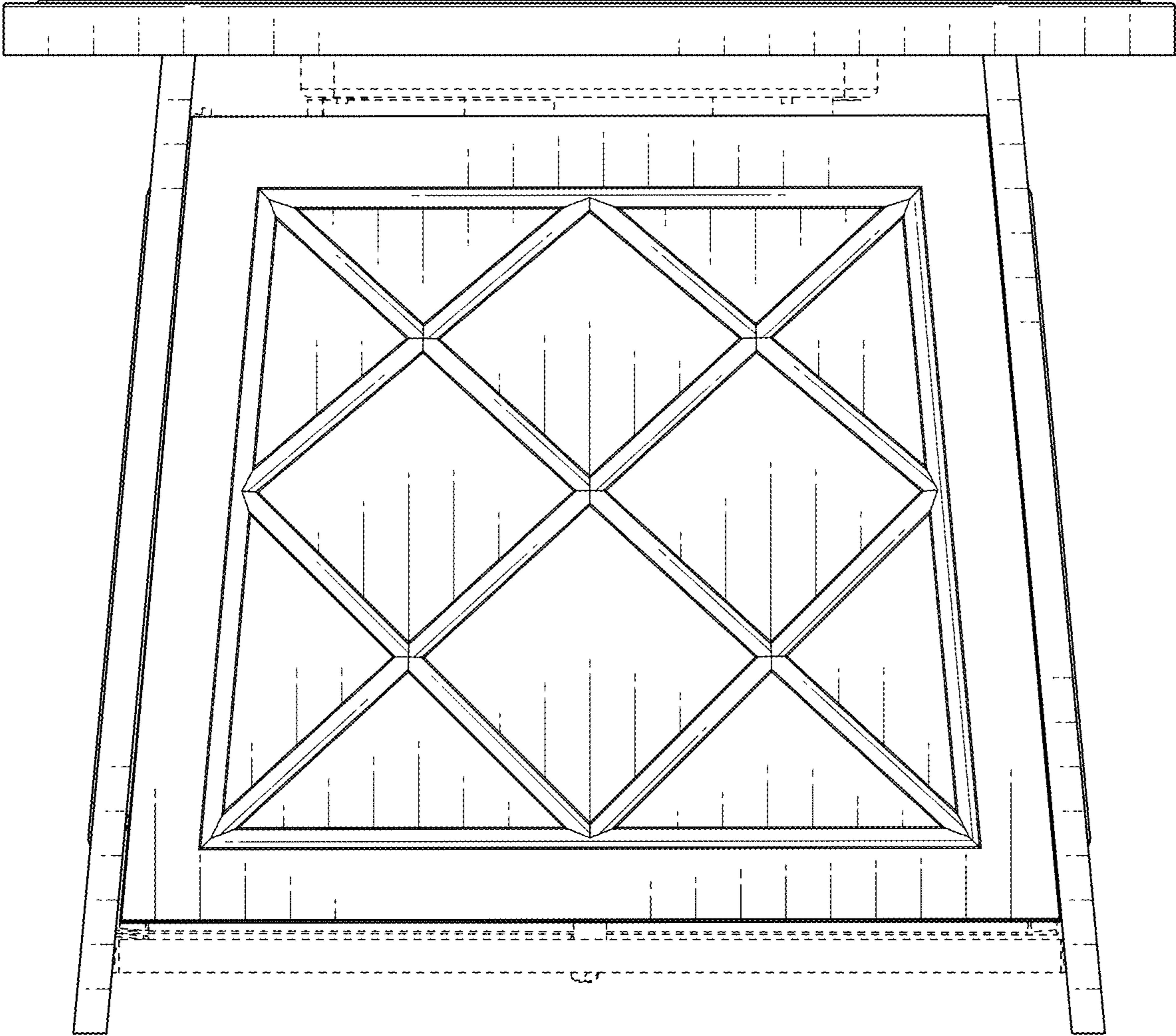

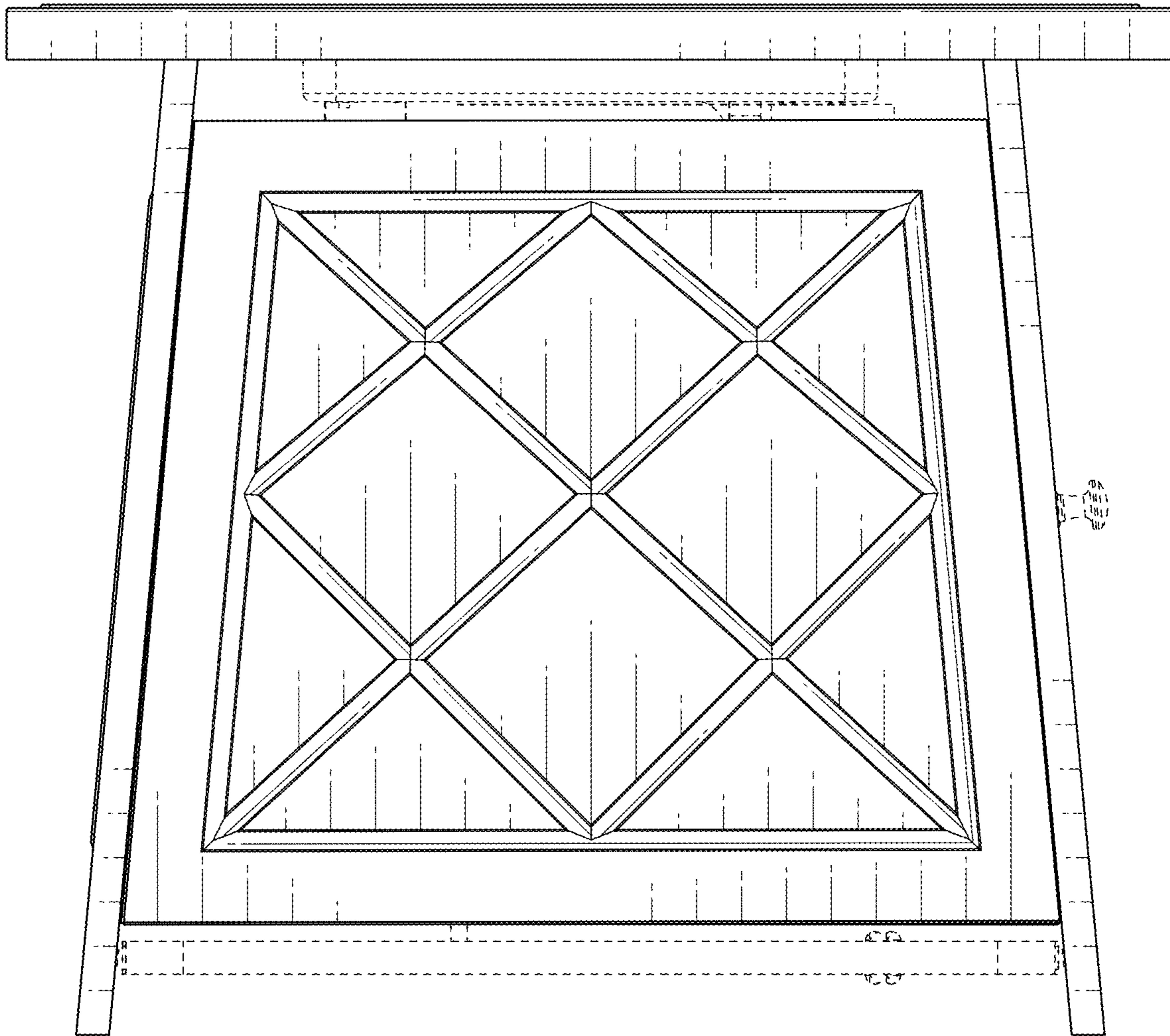

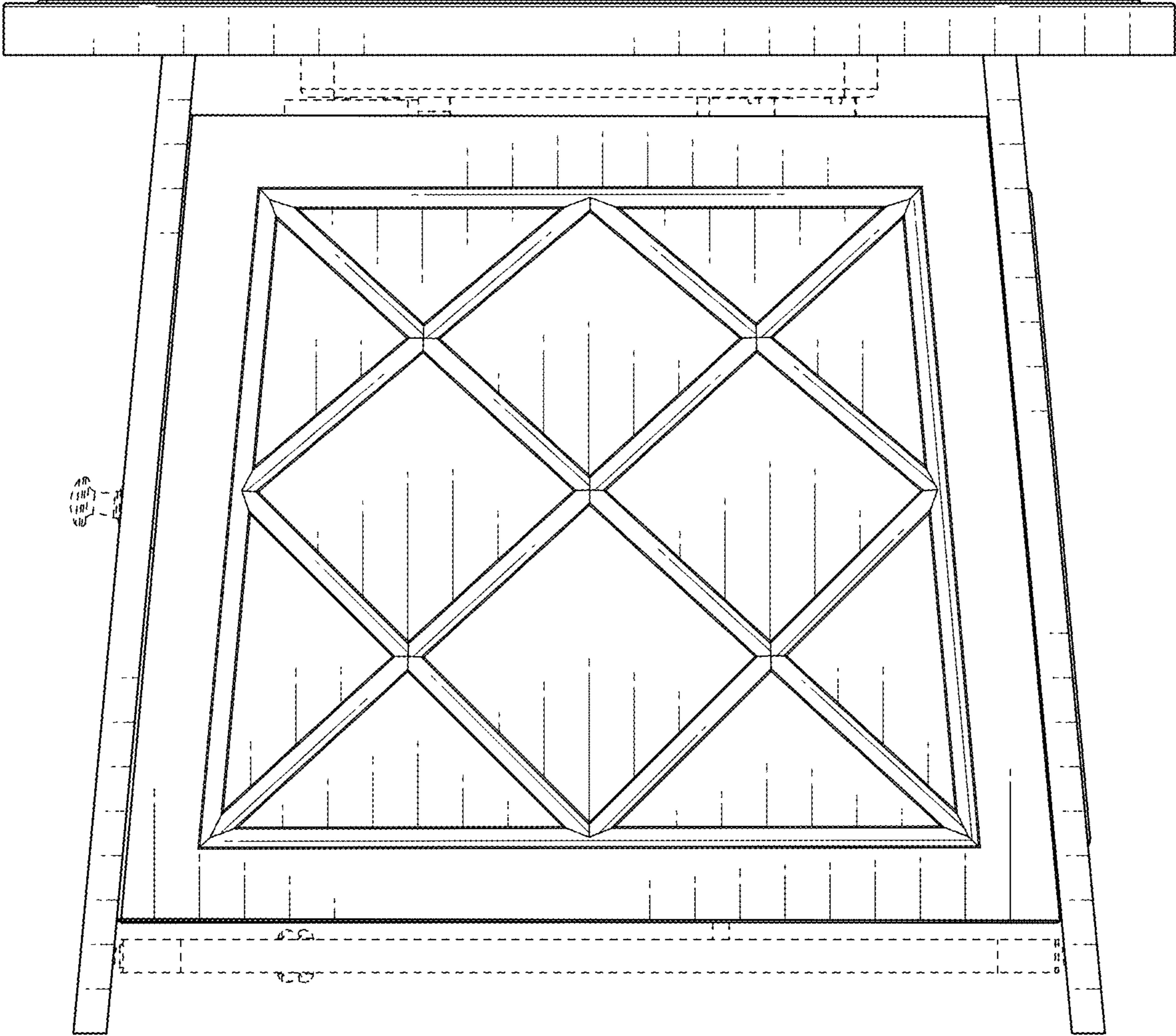

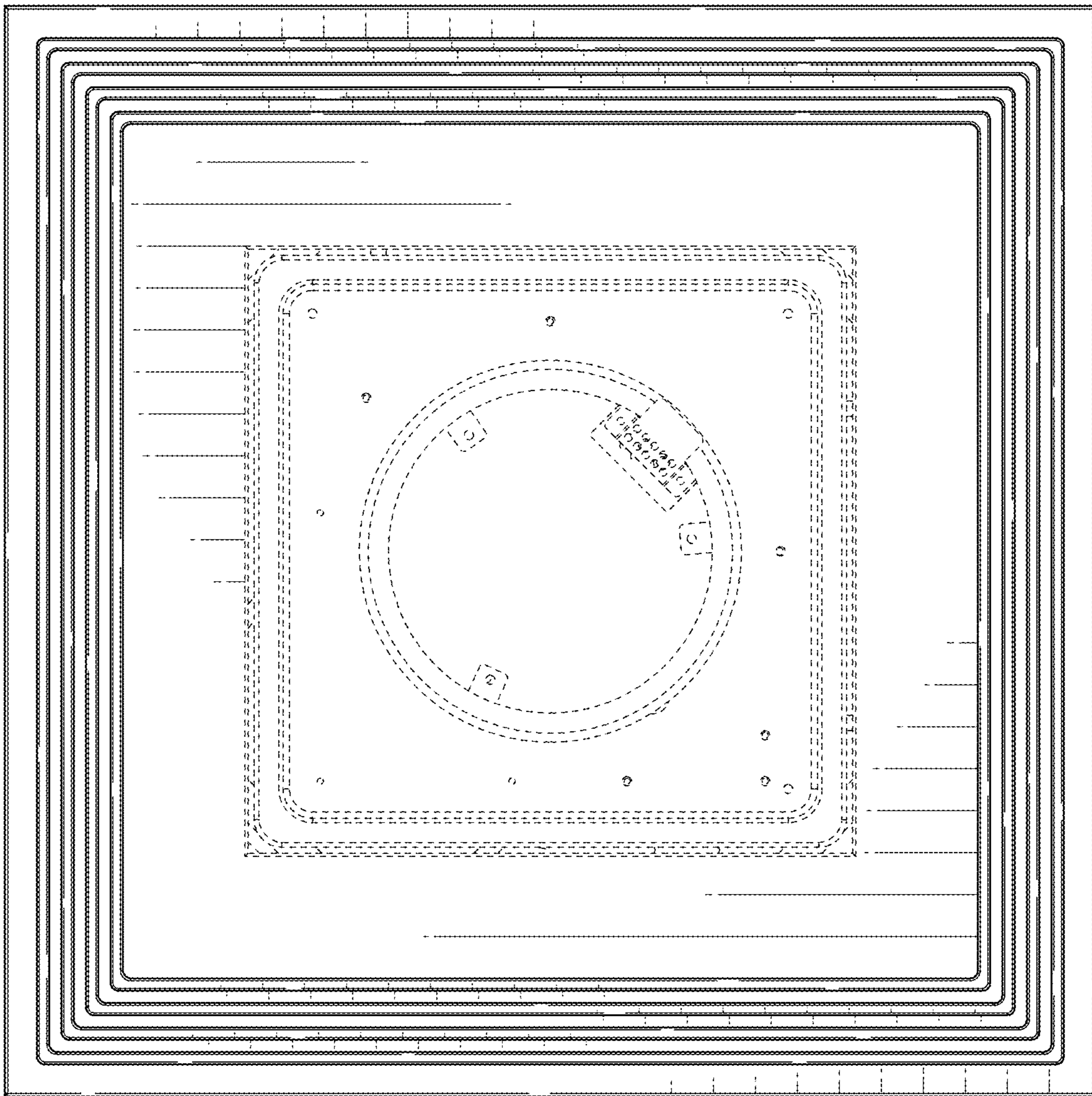

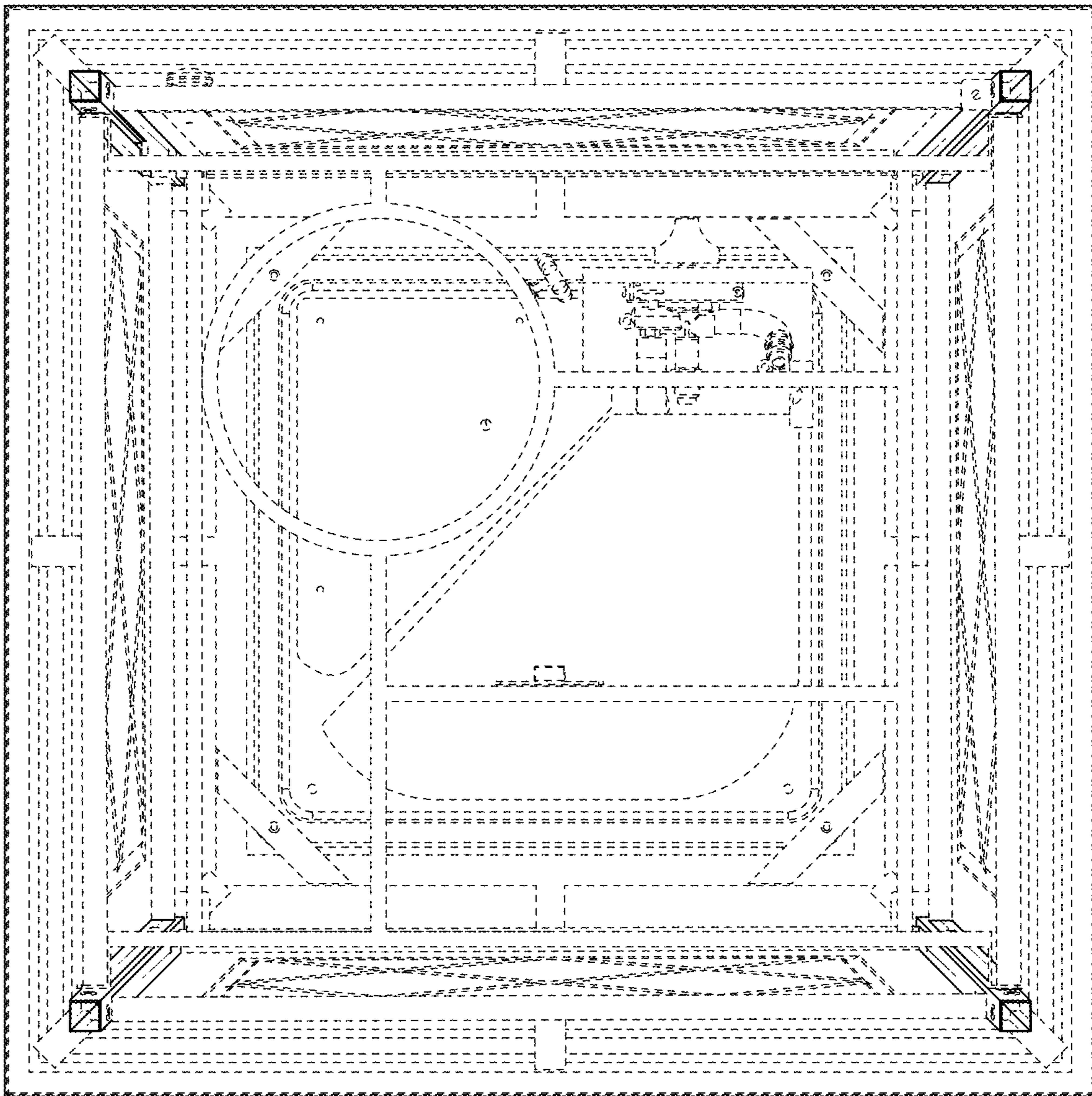
