**DESCRIPTION**

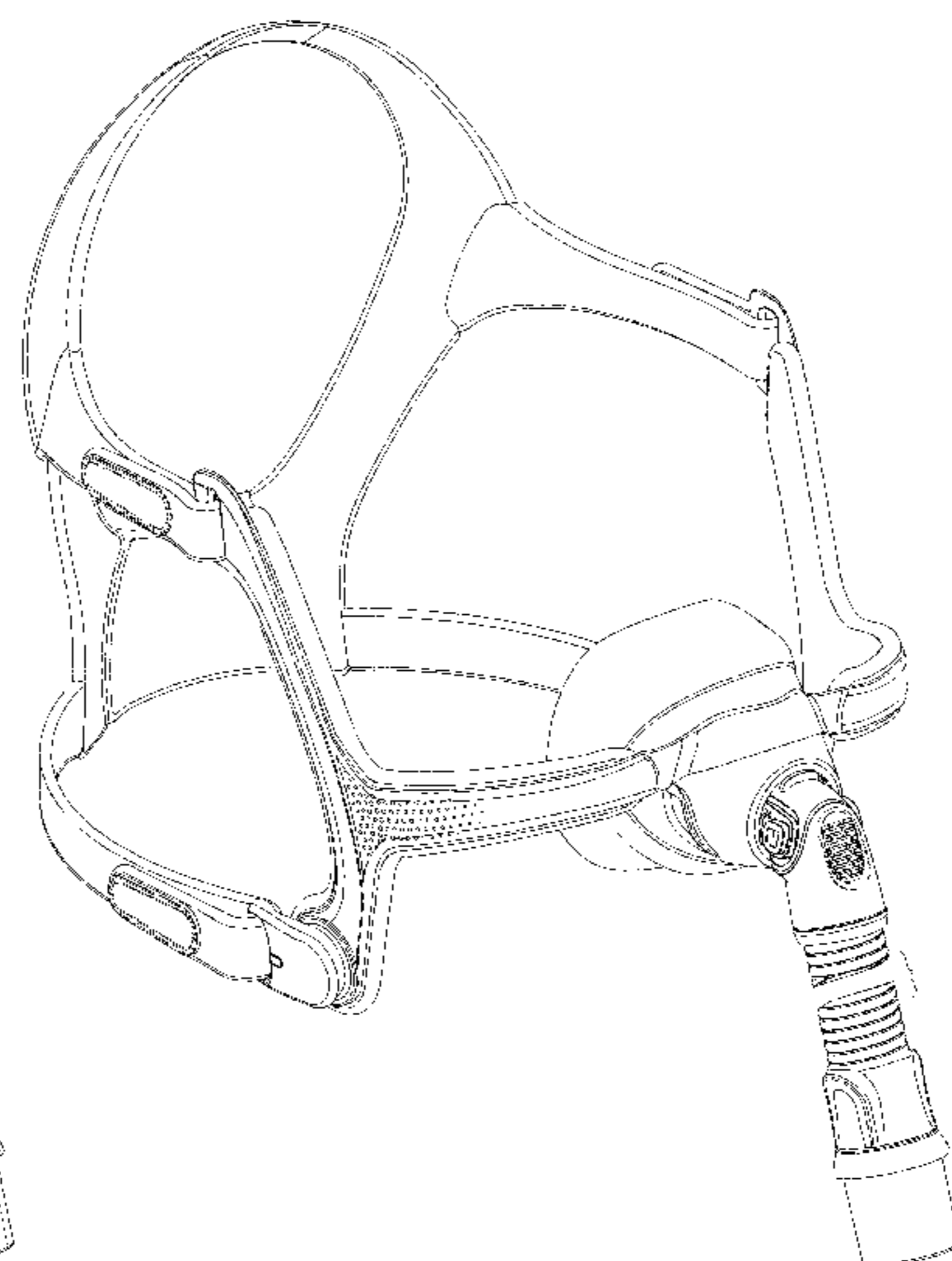
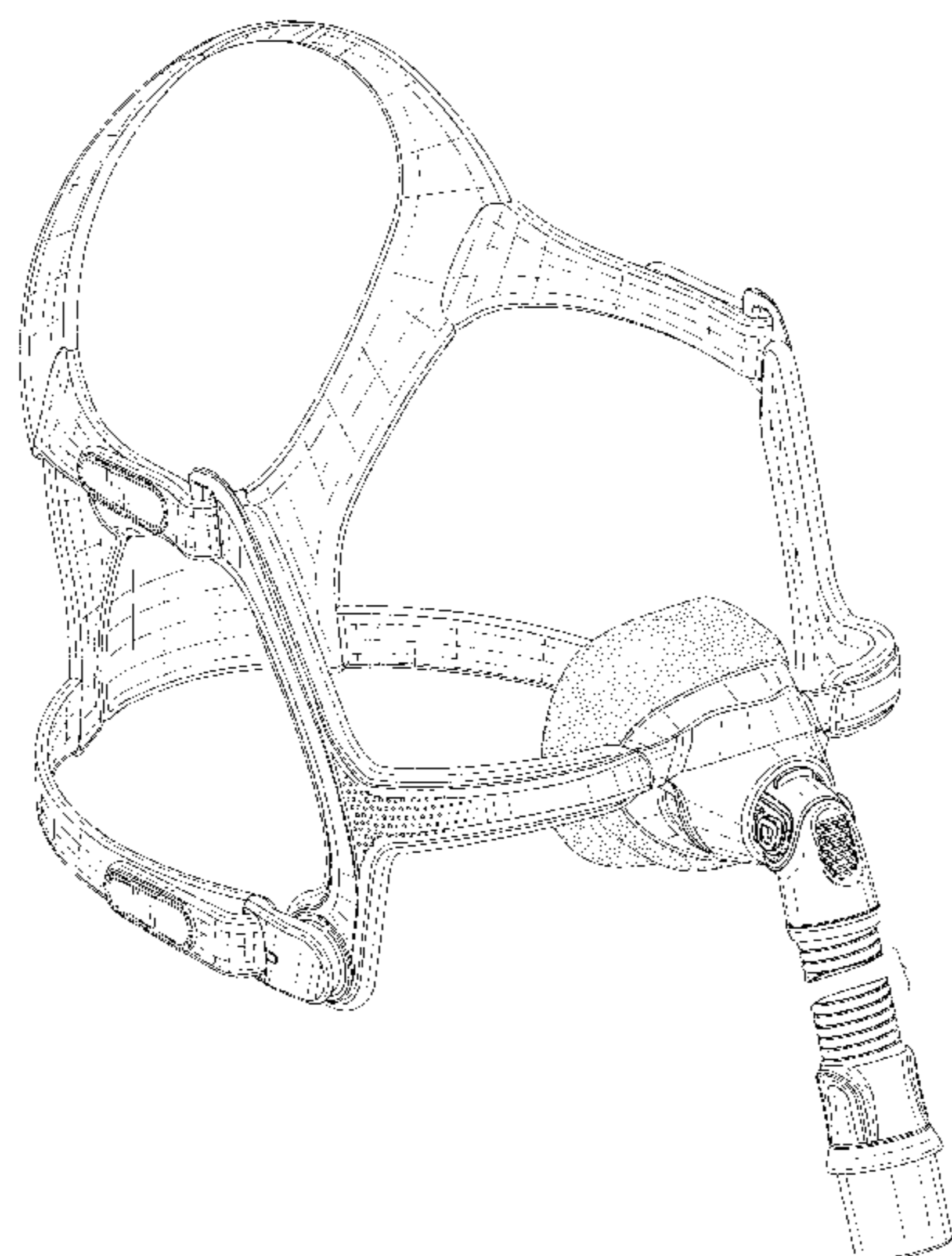

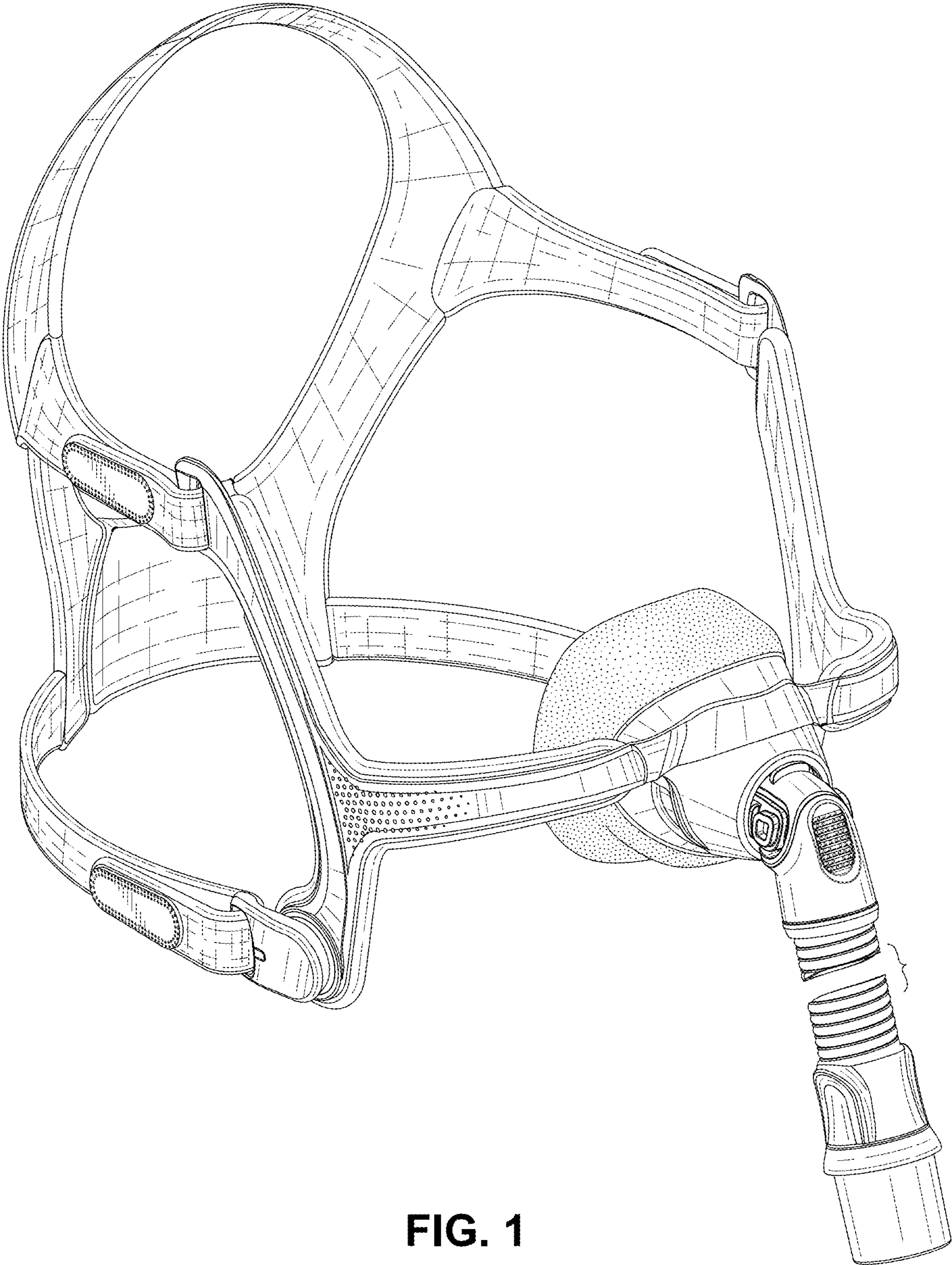

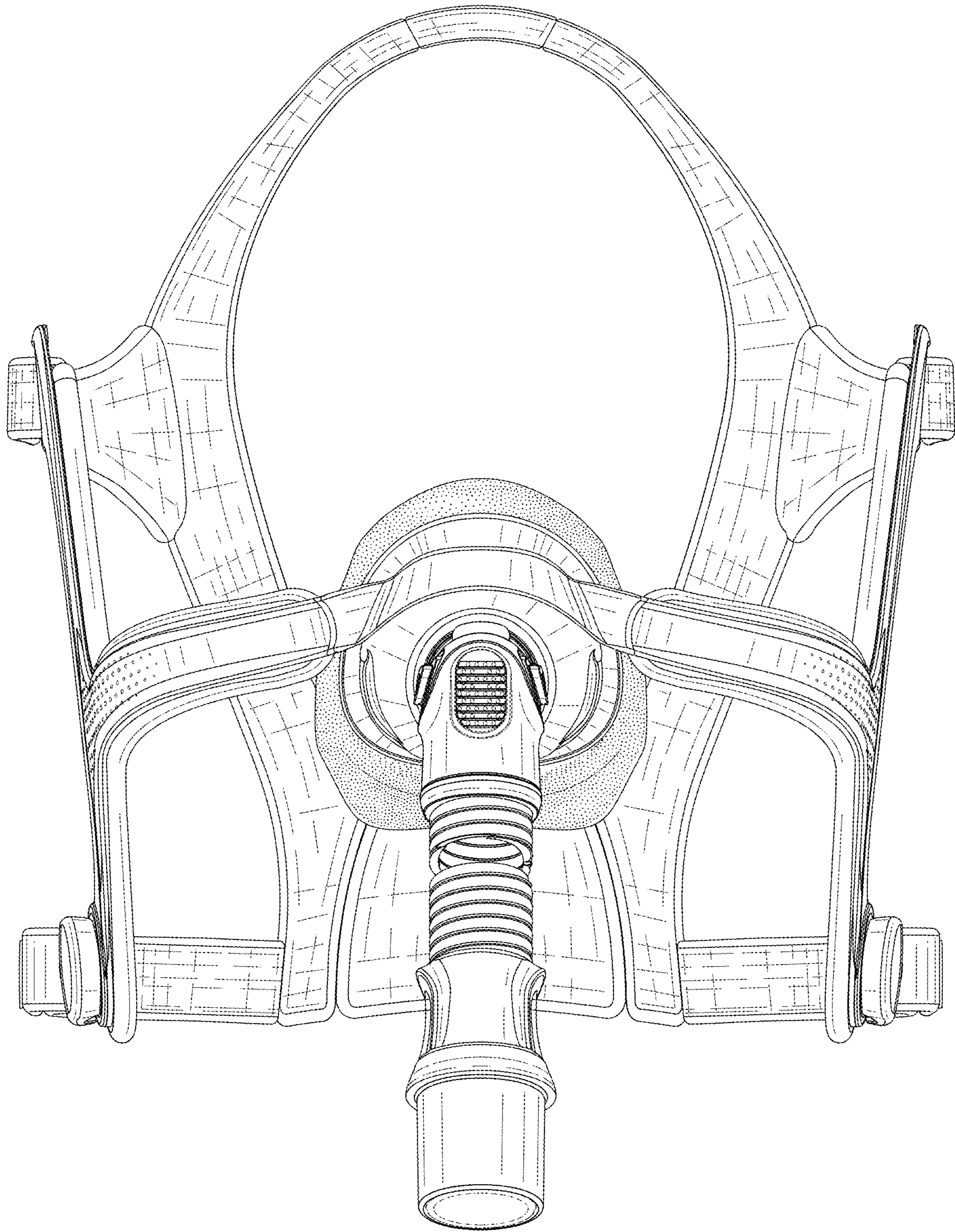
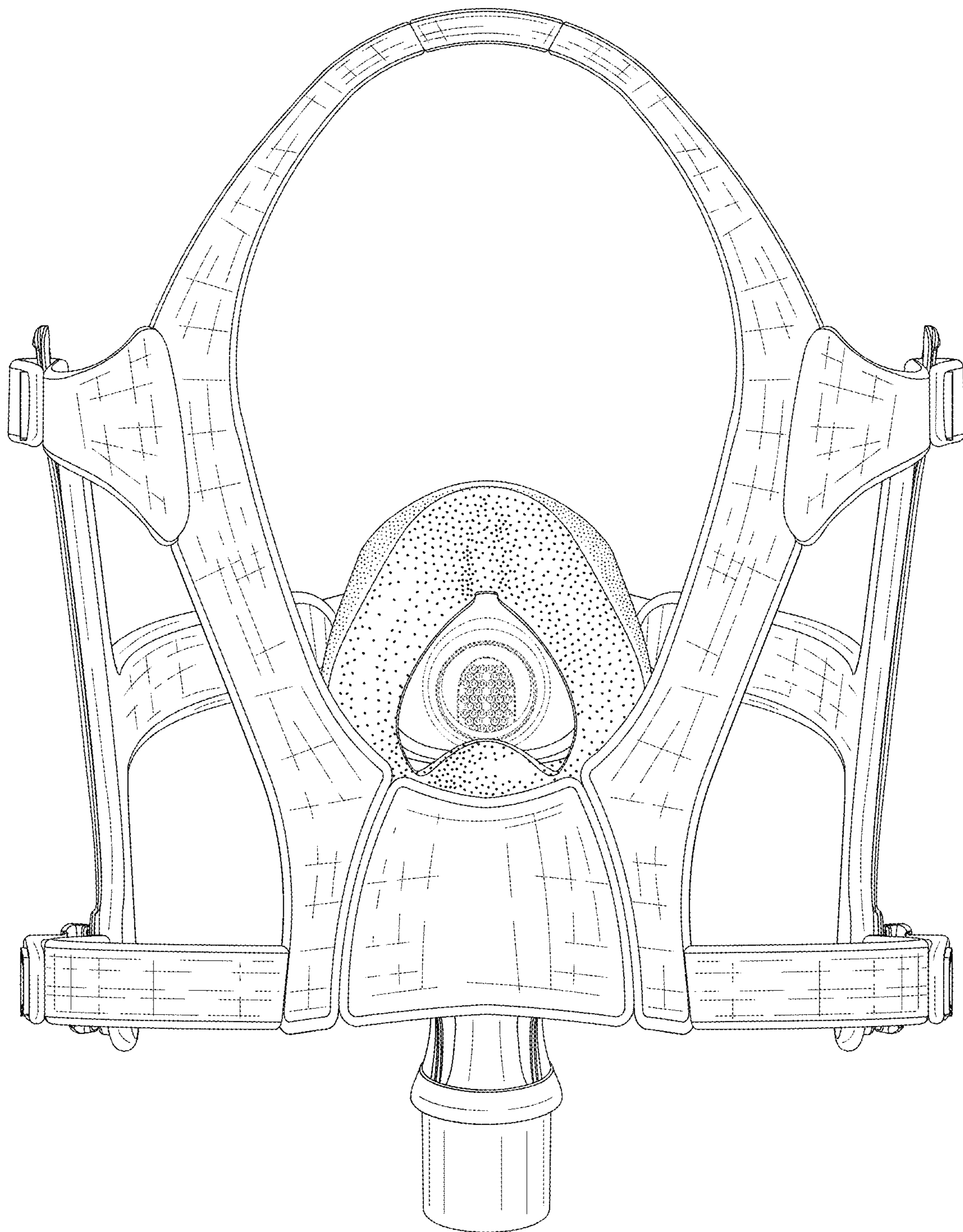

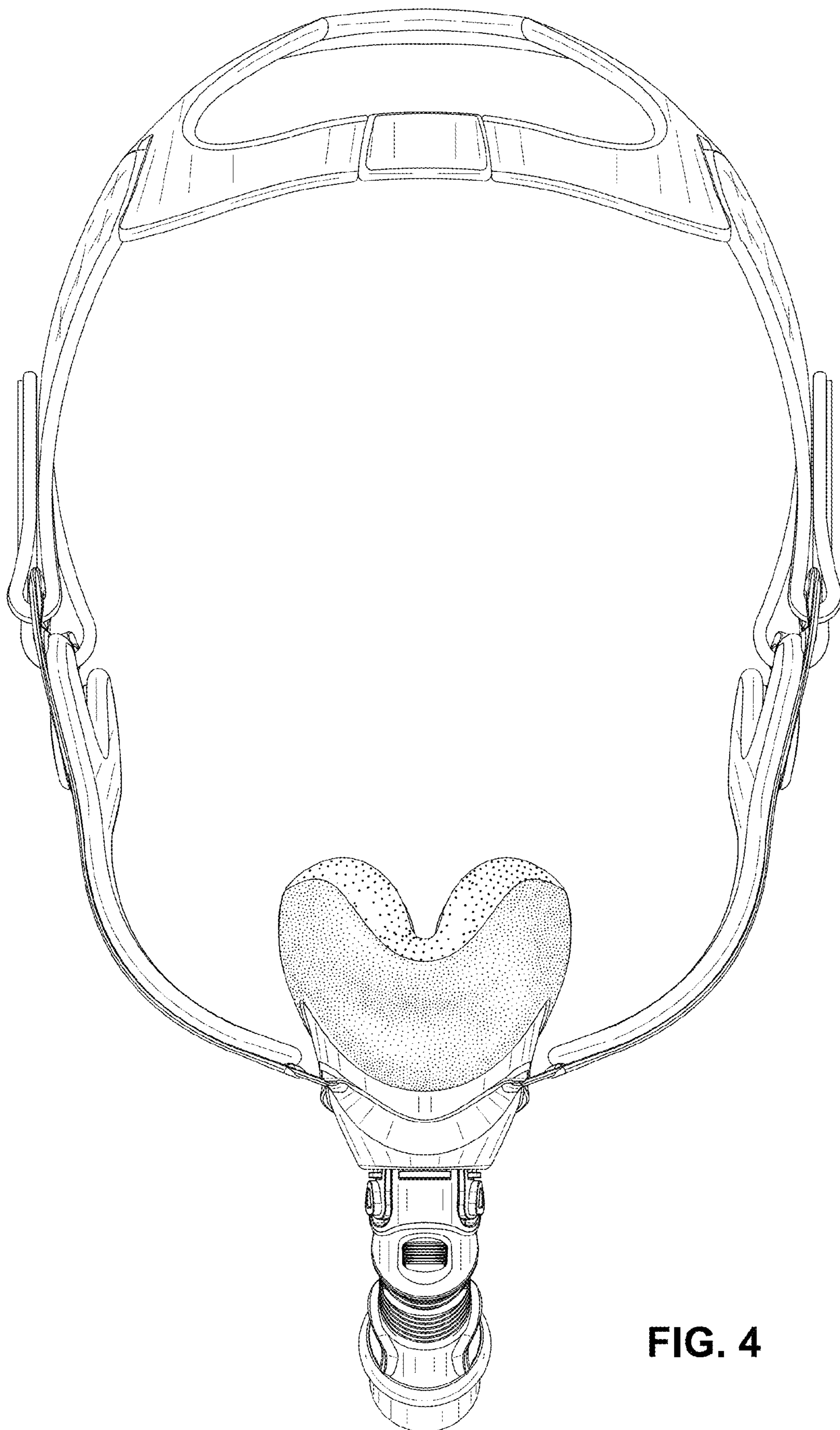
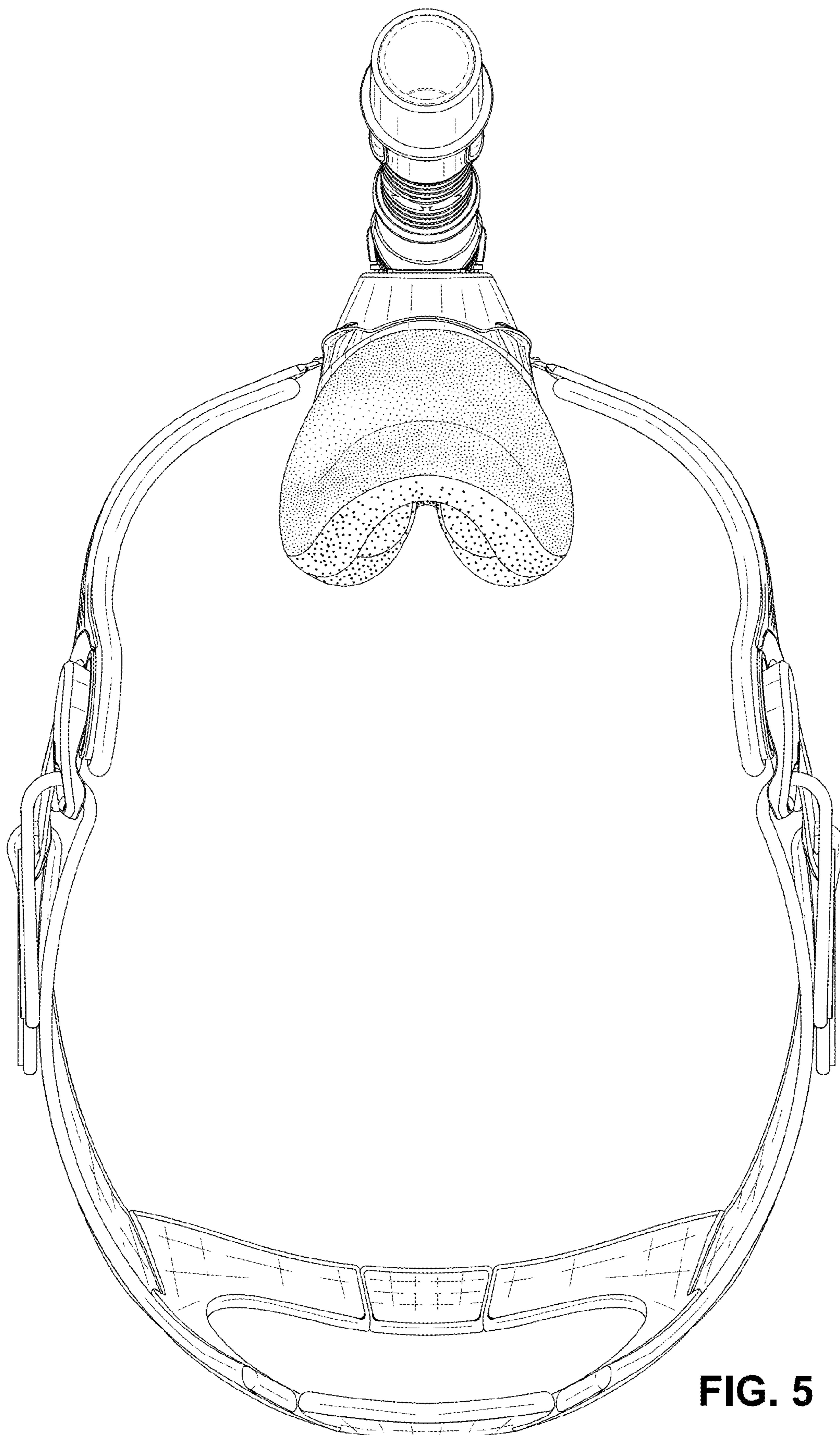
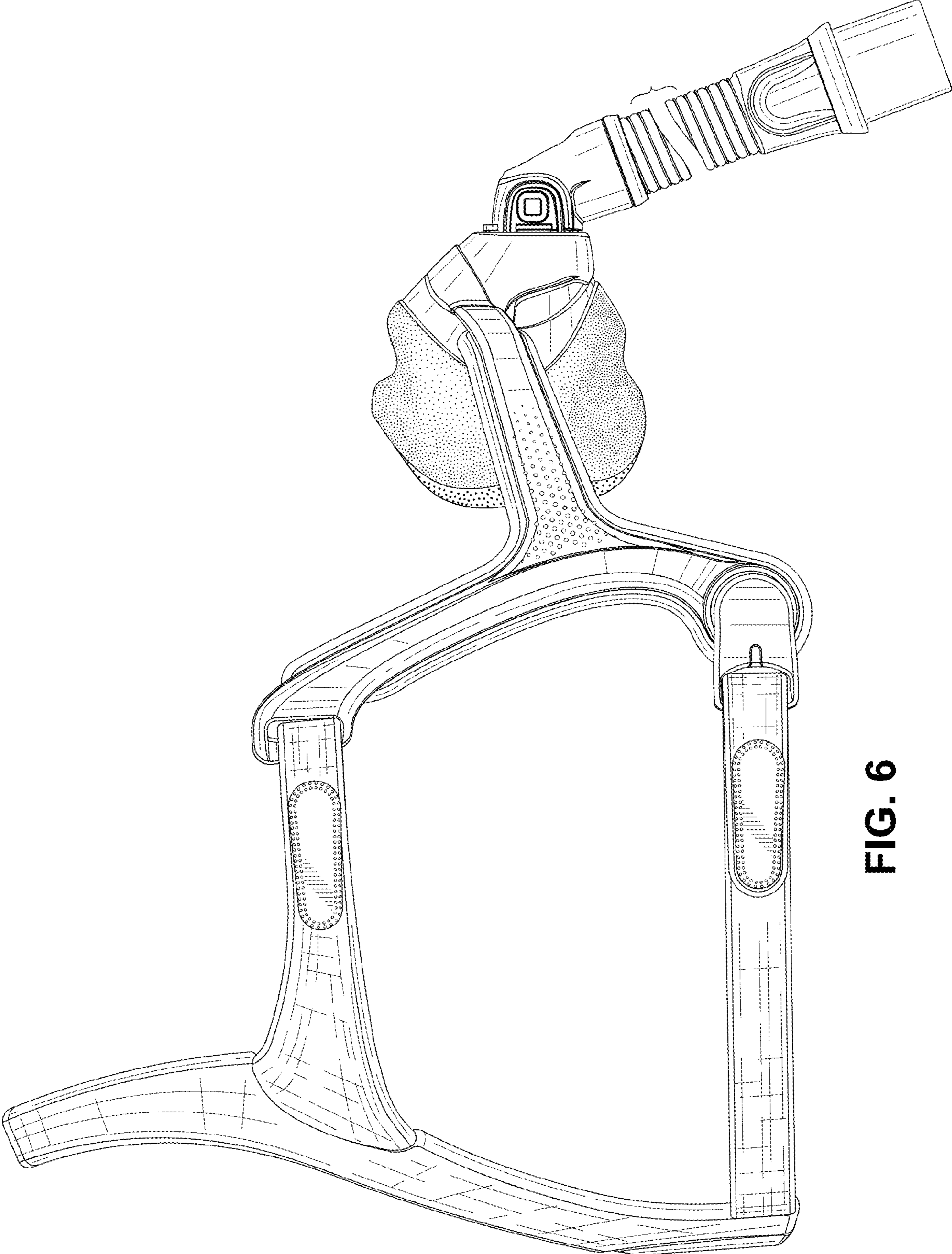

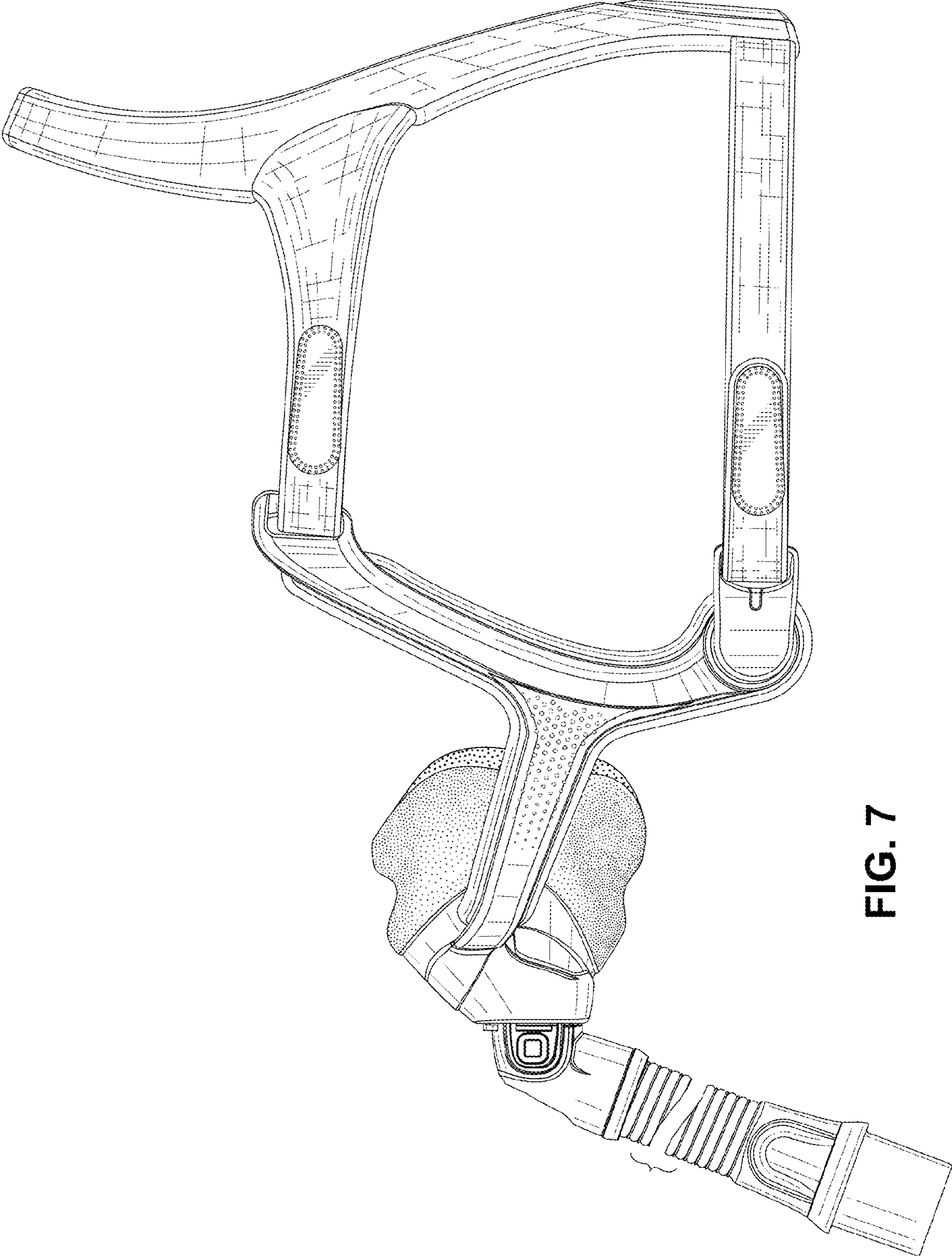

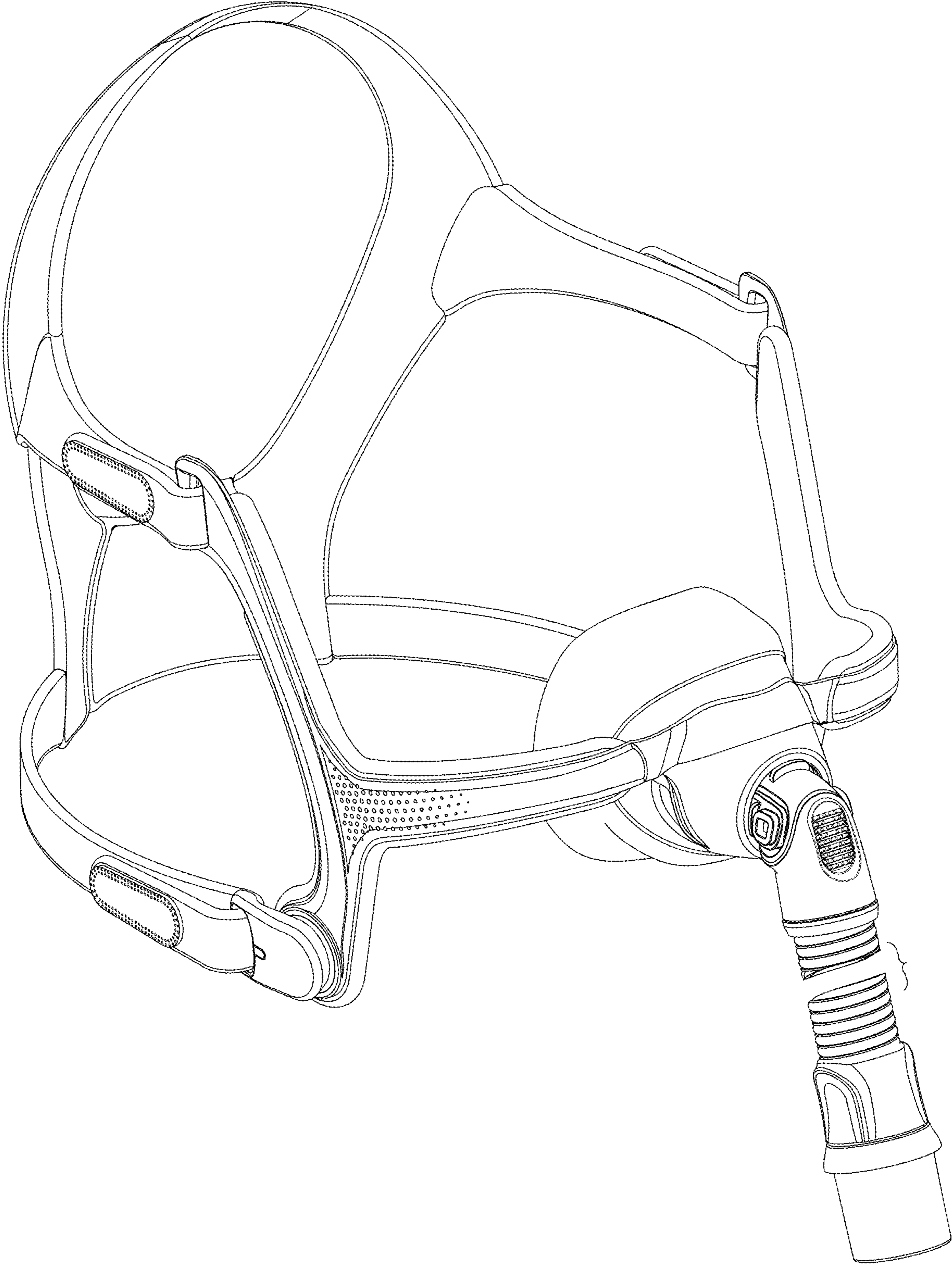

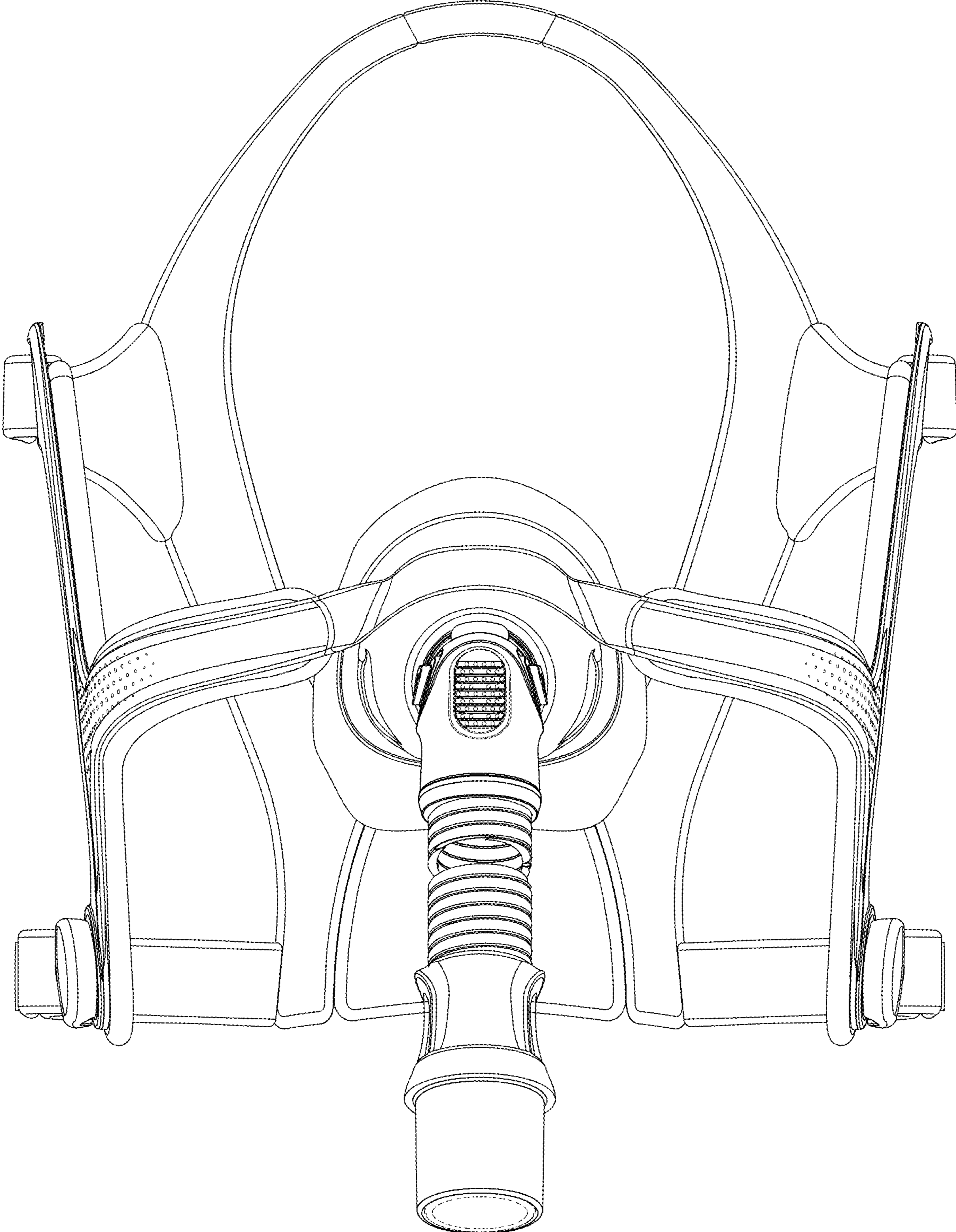
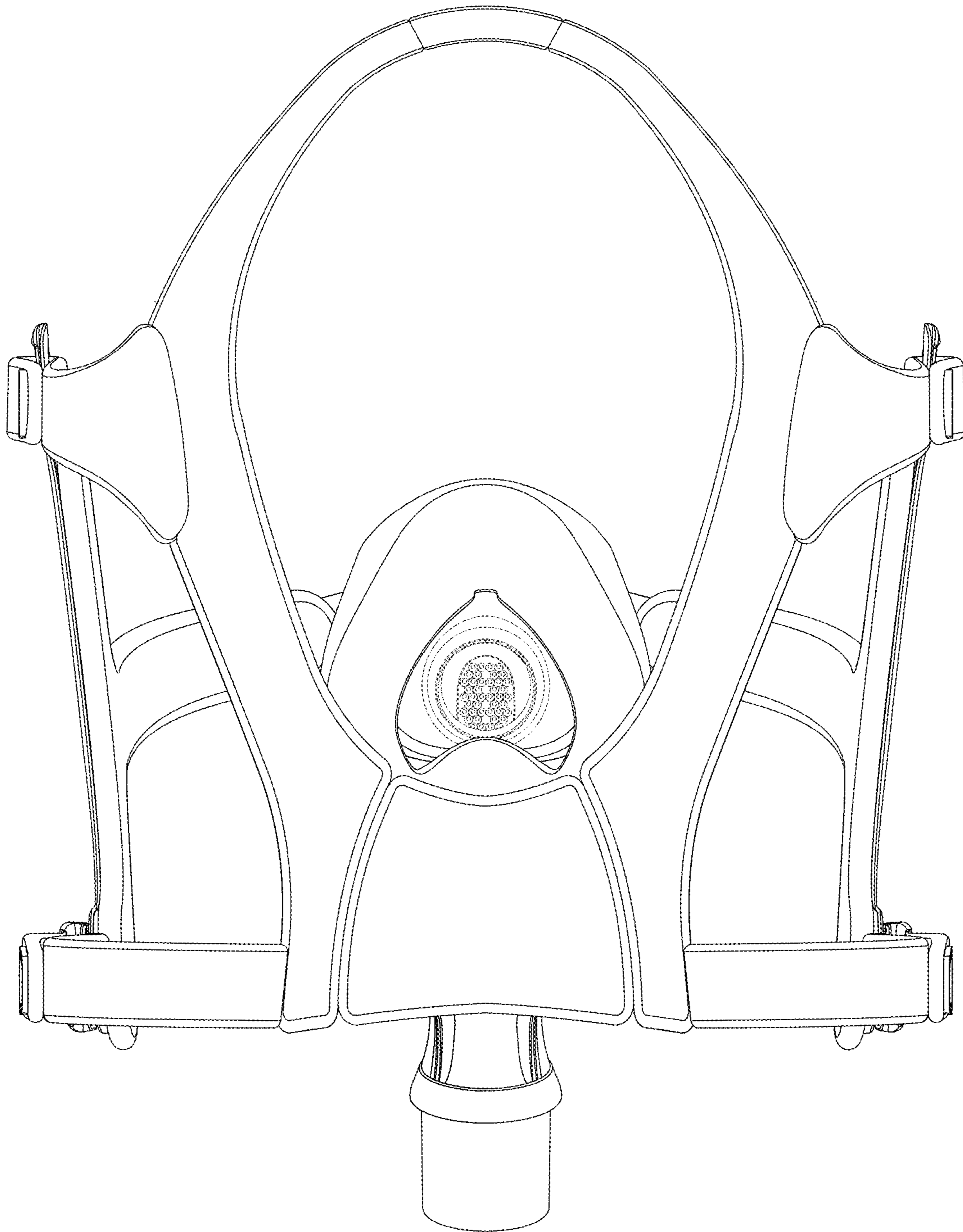

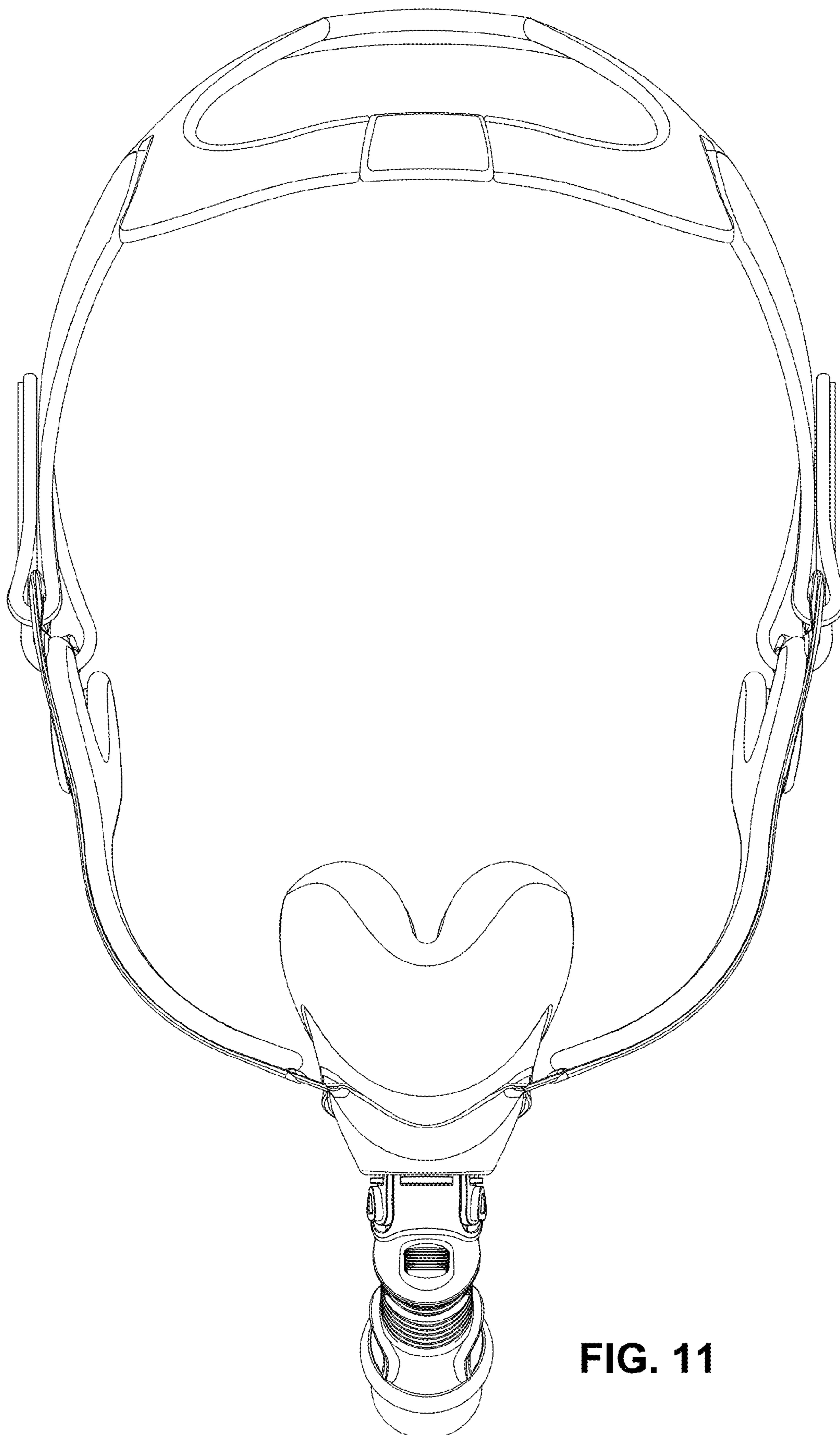
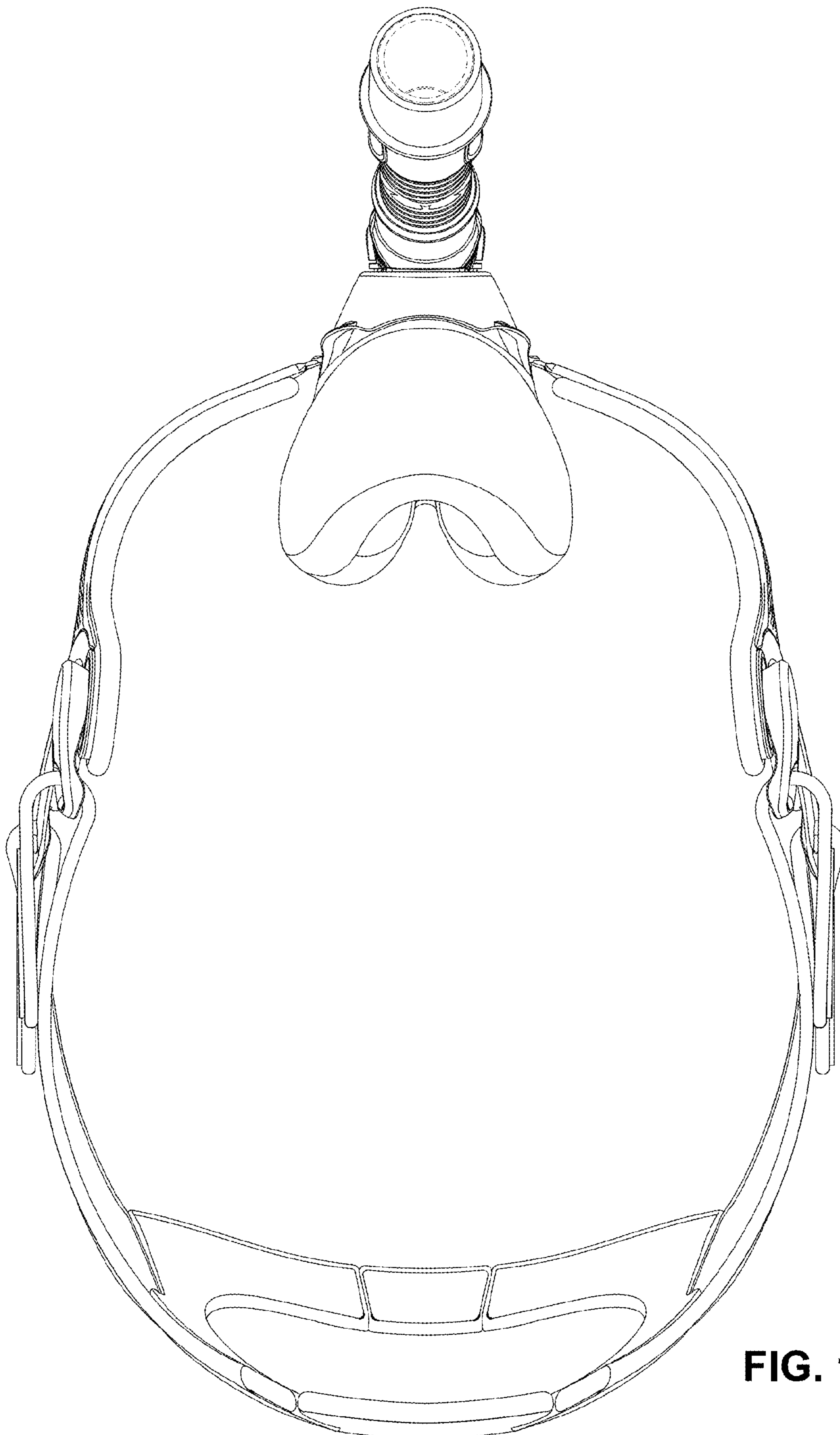

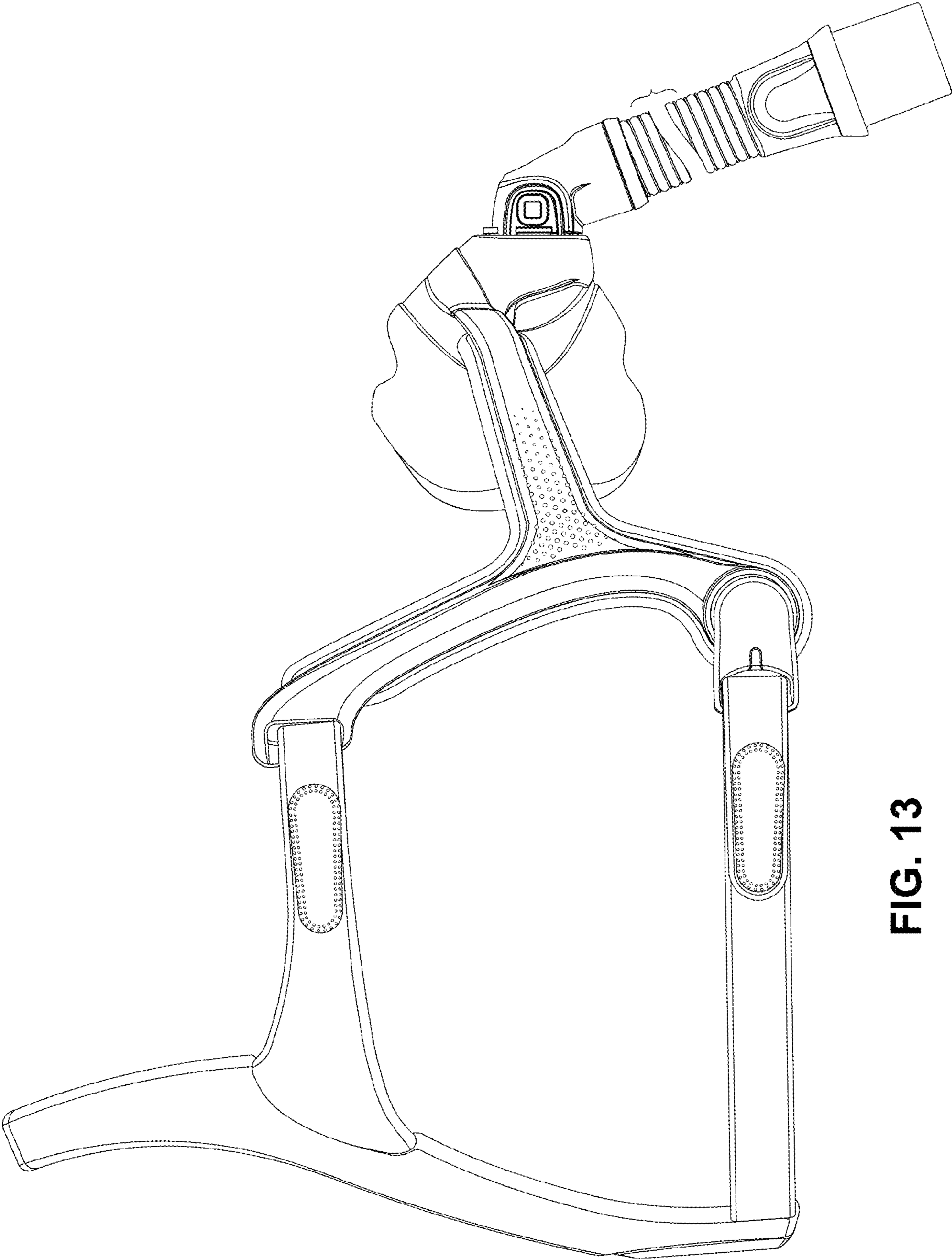

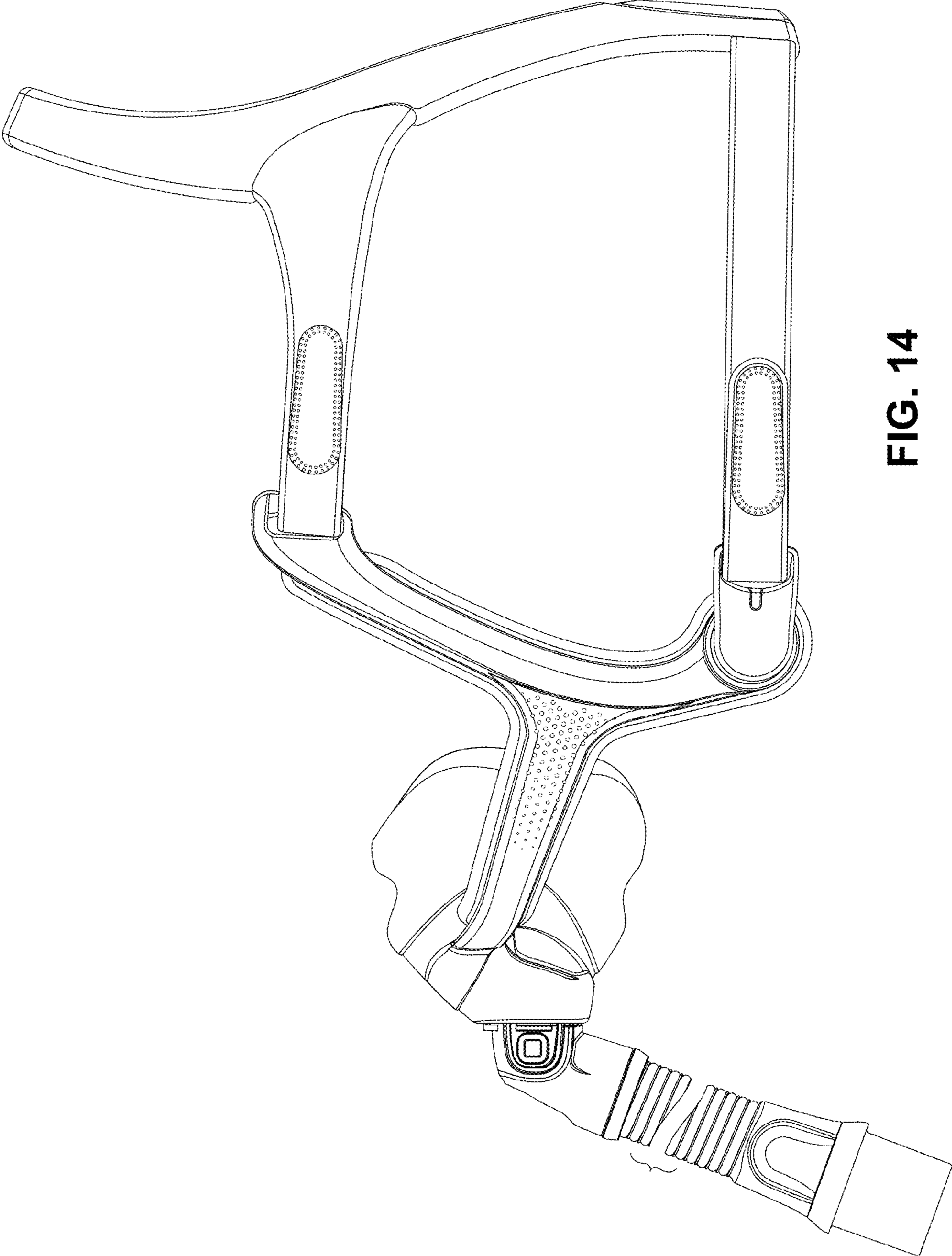
