FIG. 3 is a back view of FIG. 1.

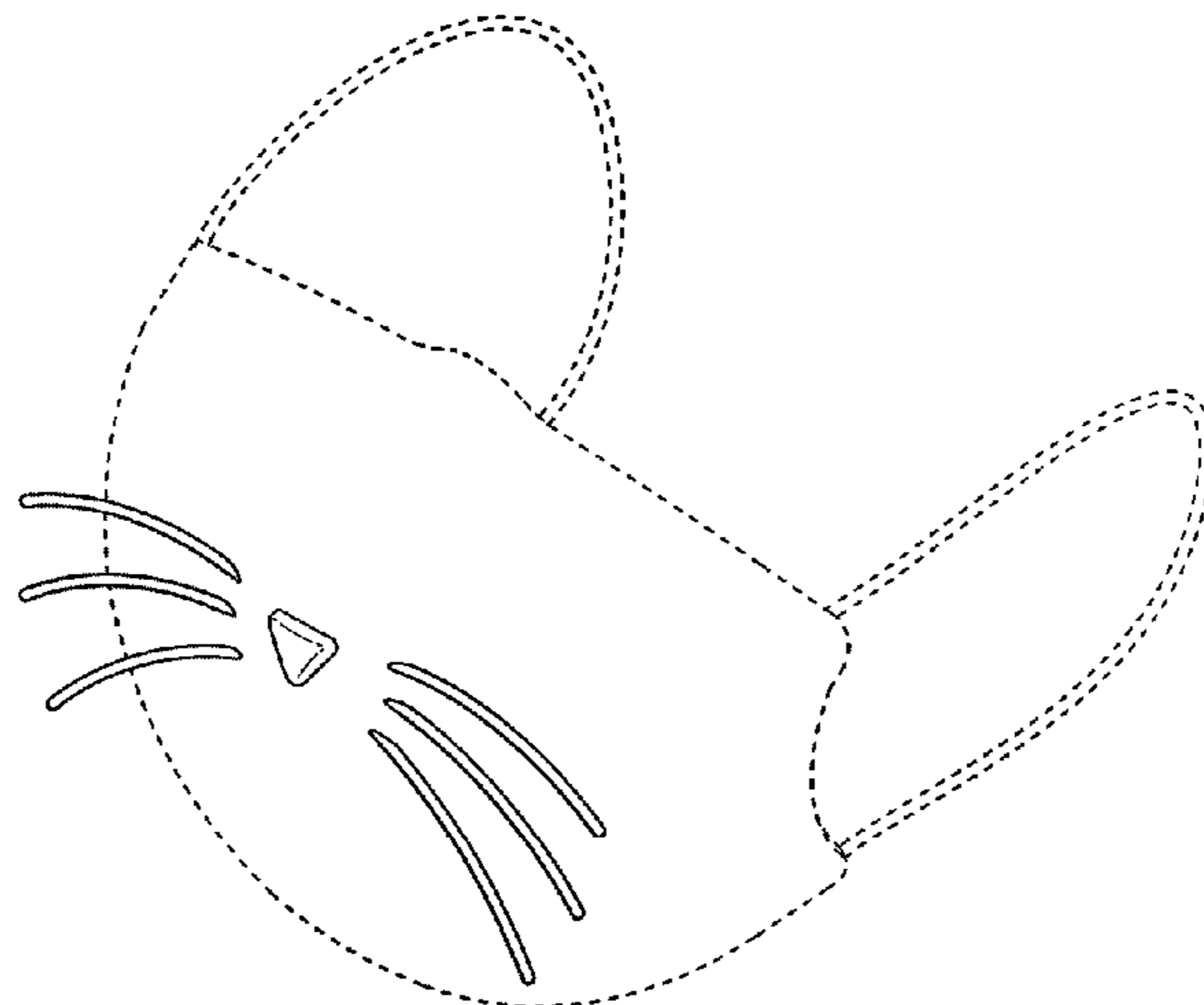
FIG. 4 is a left side view of FIG. 1.

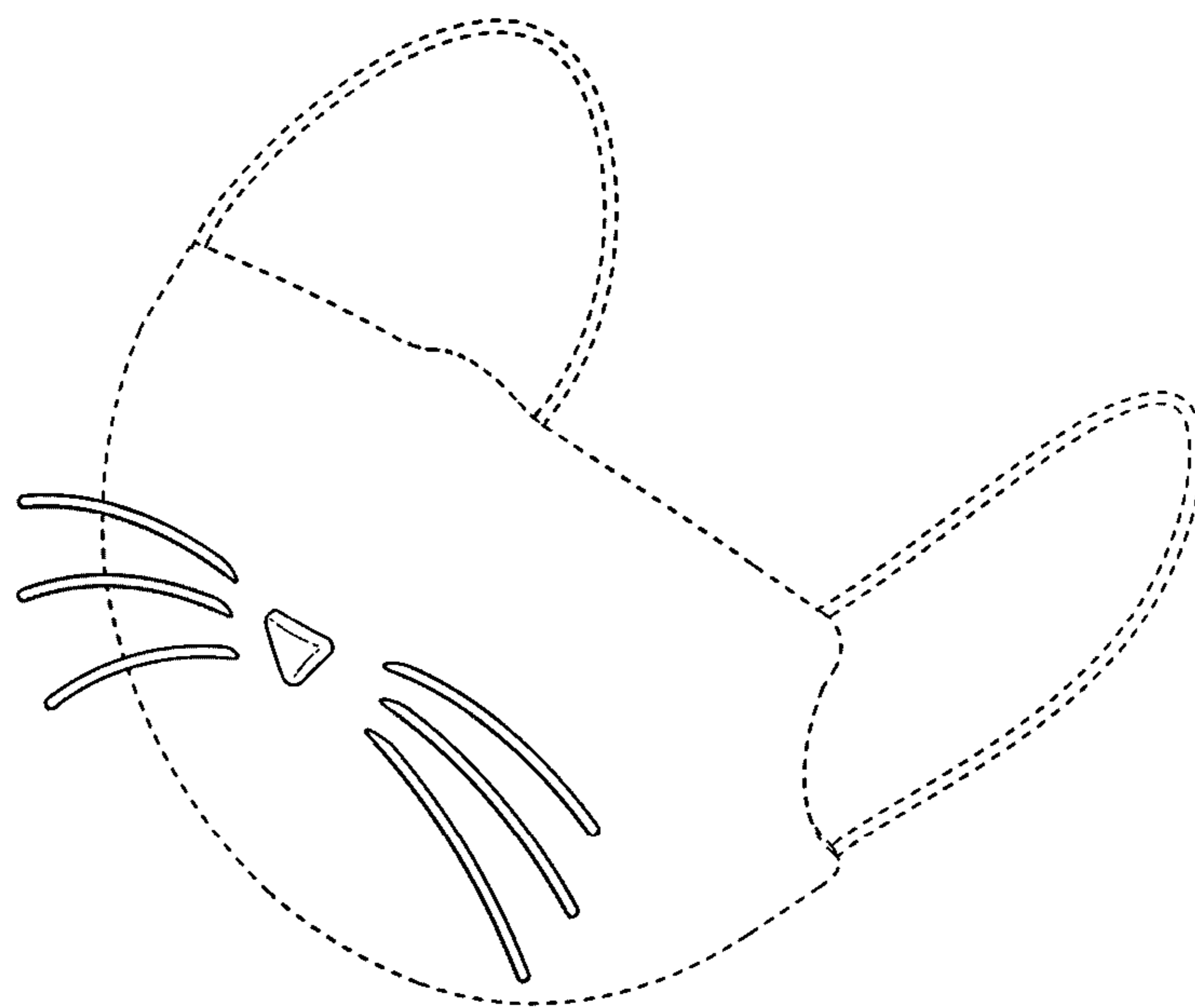

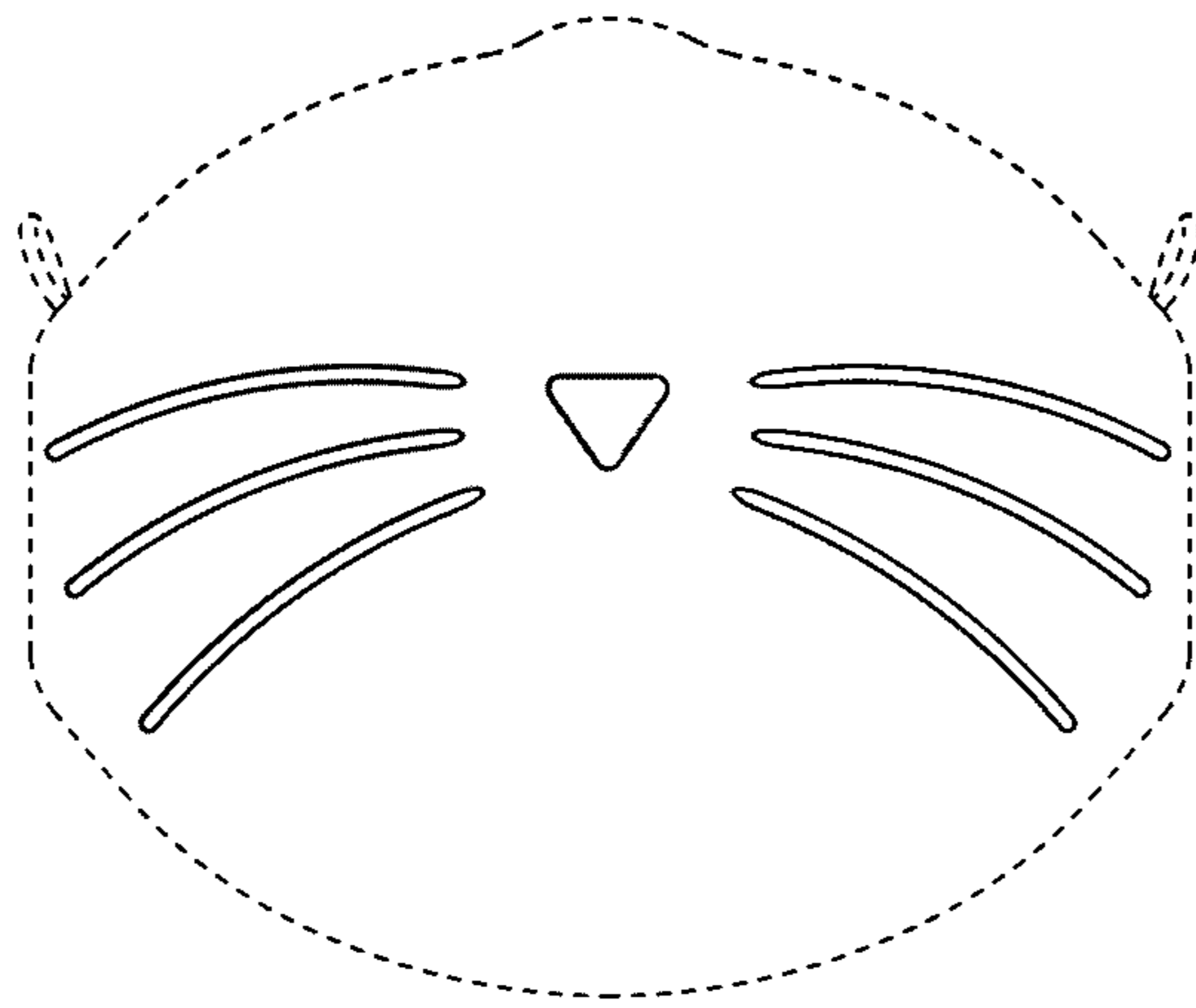

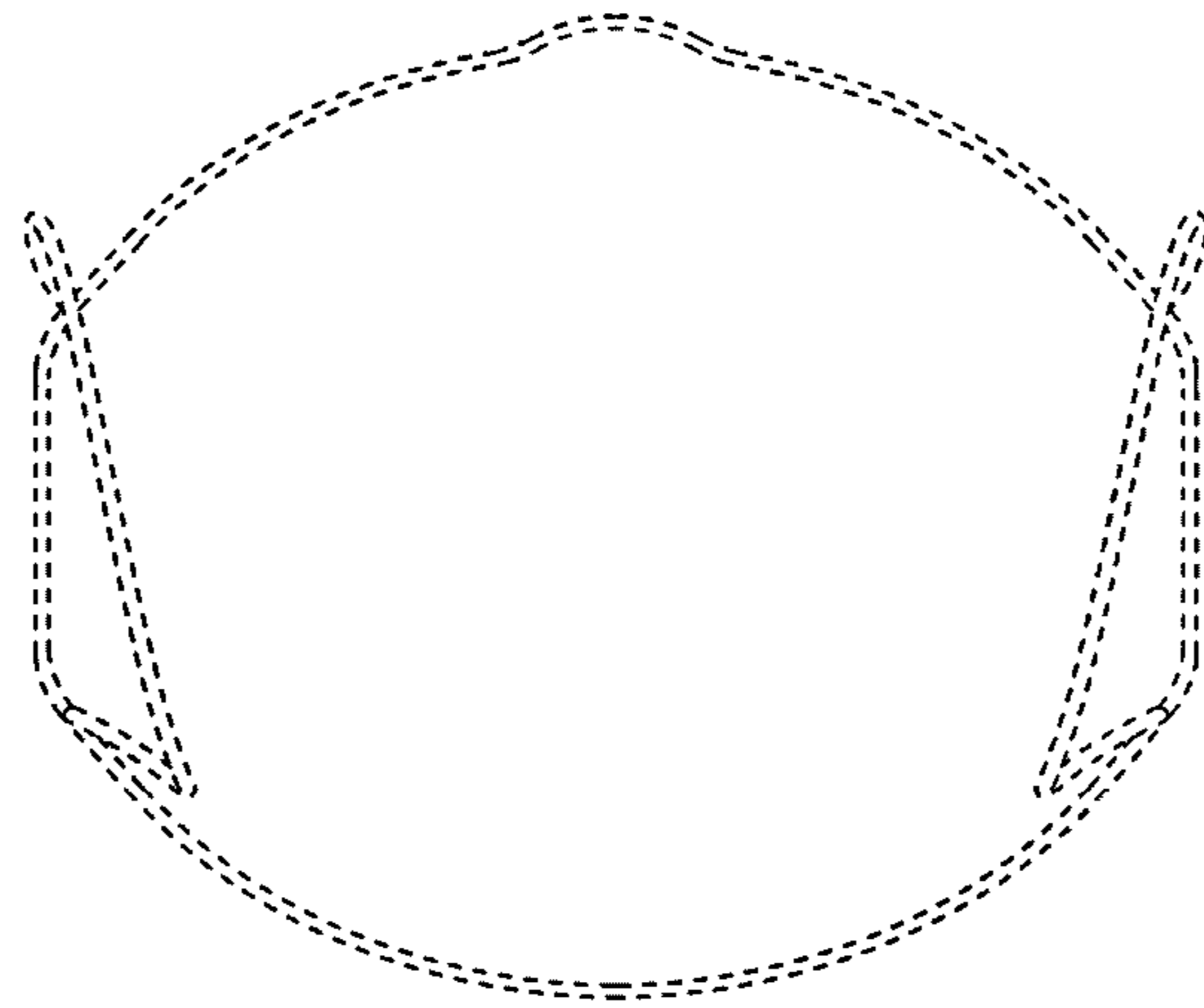

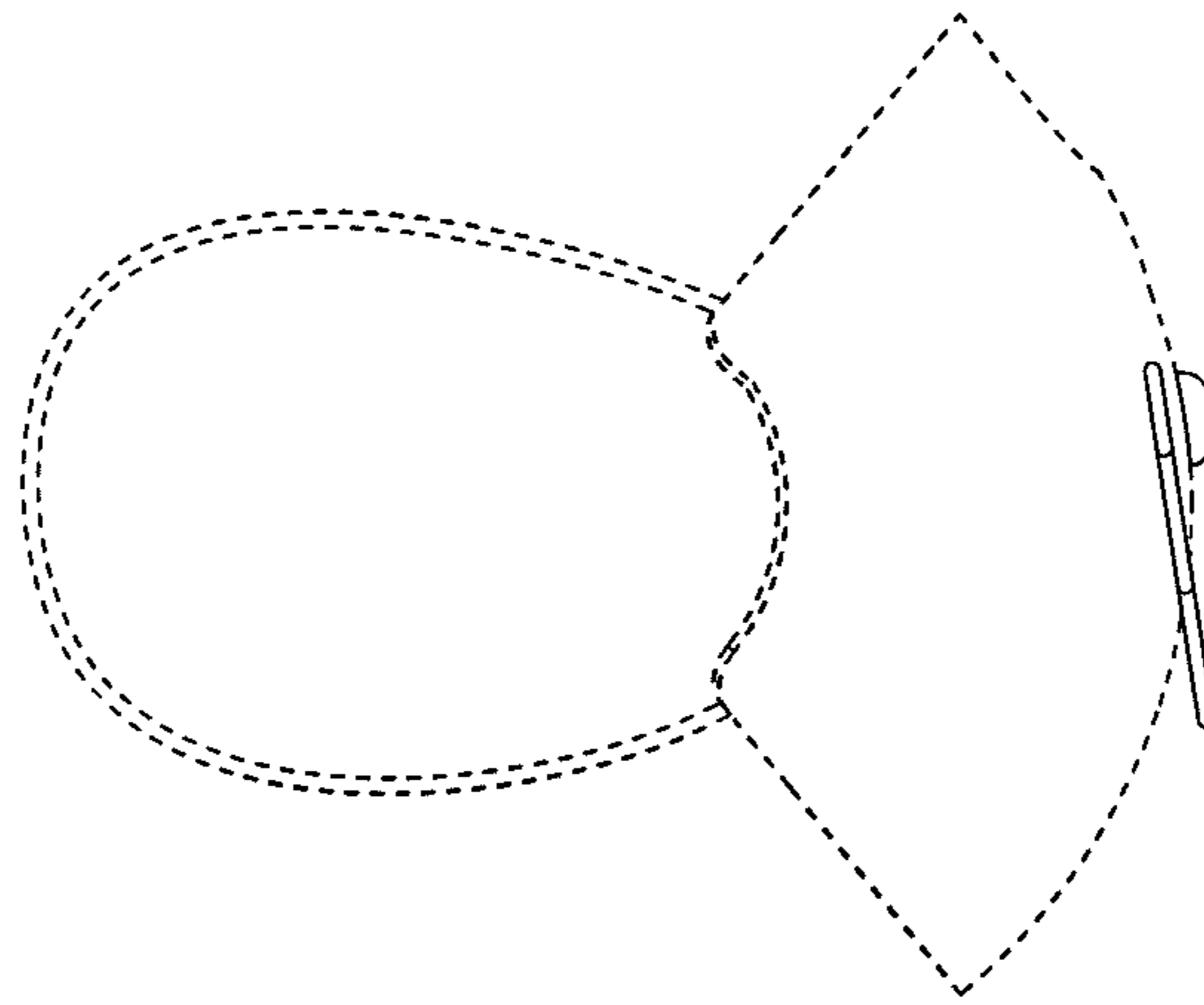

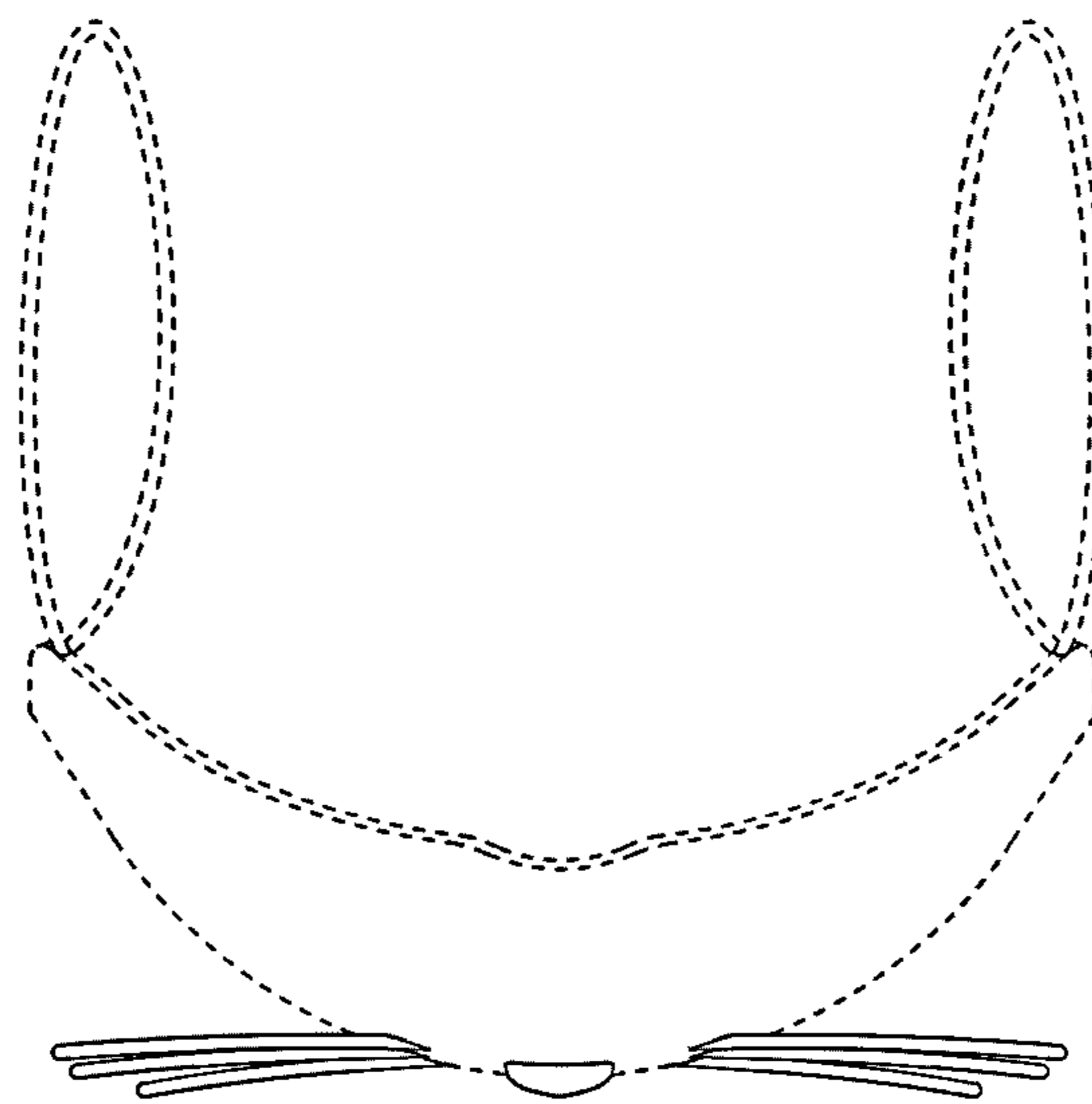

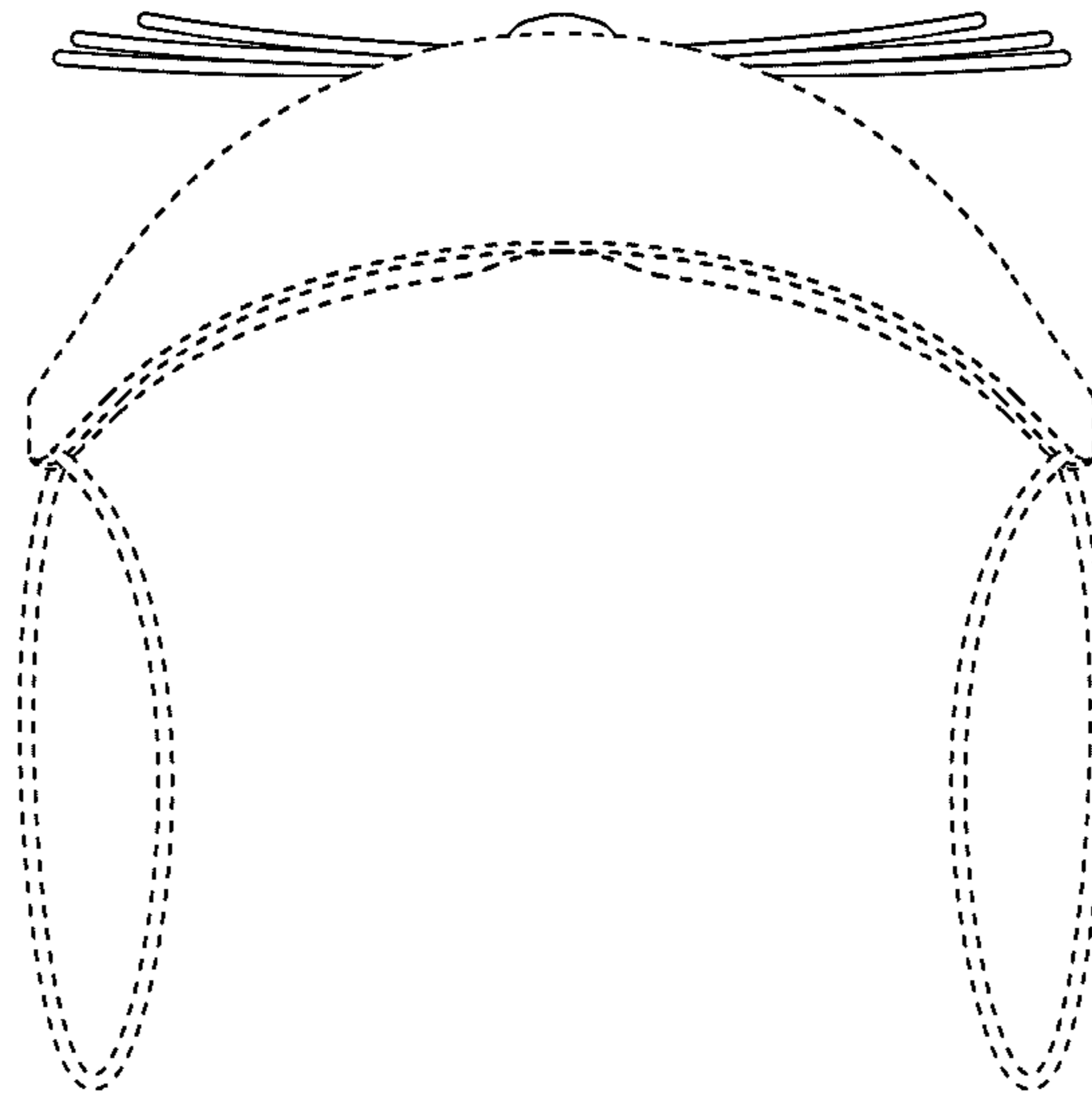
