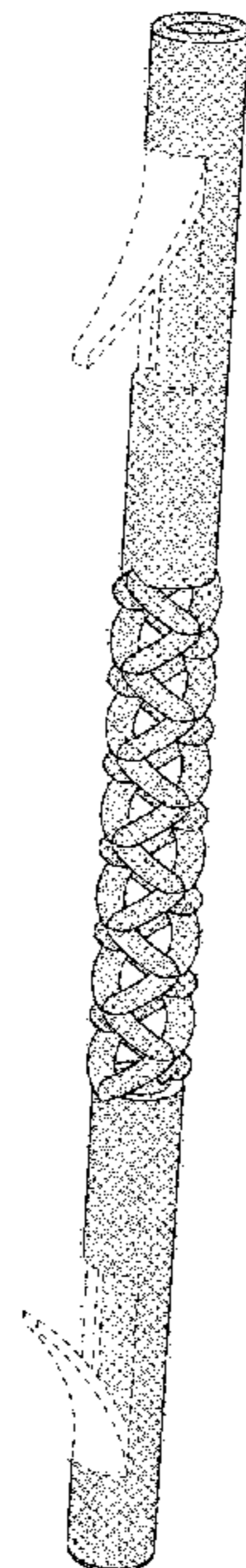
FIG. 1 is a perspective frontal view of a Patmas weave stent showing our new design;

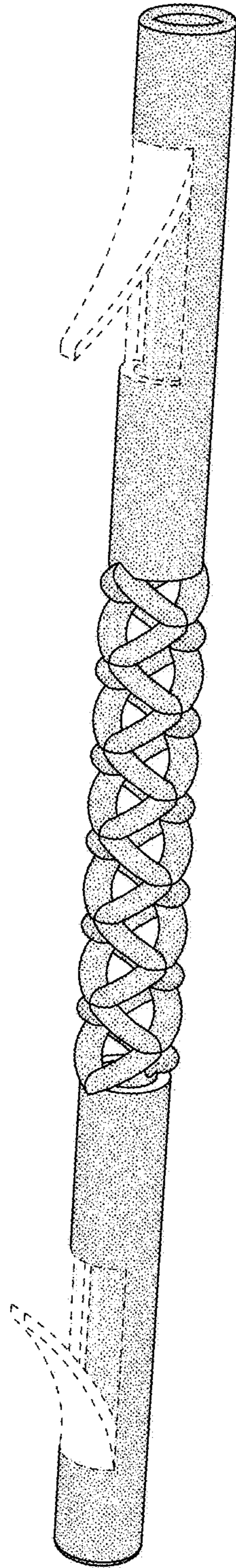

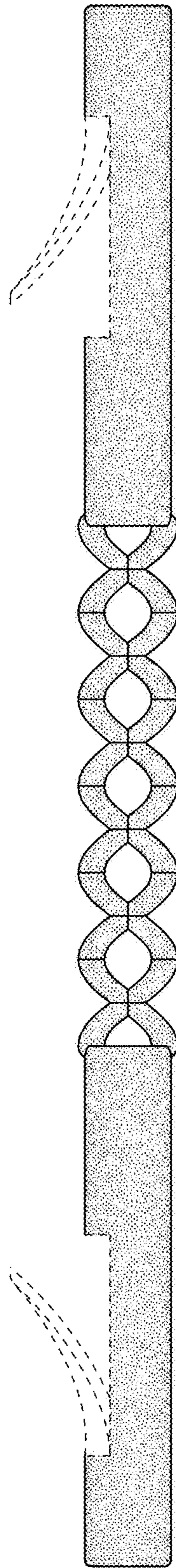

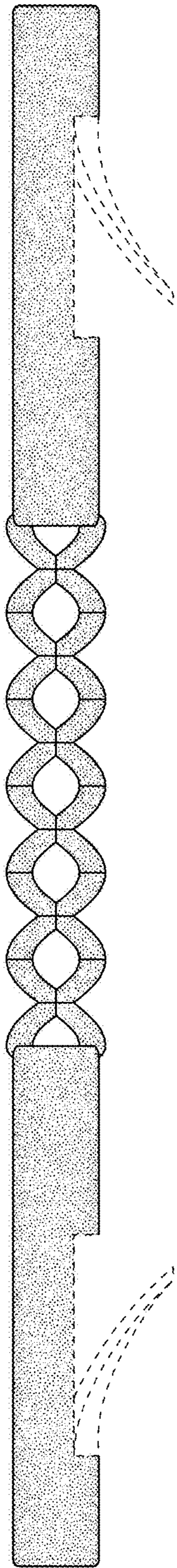

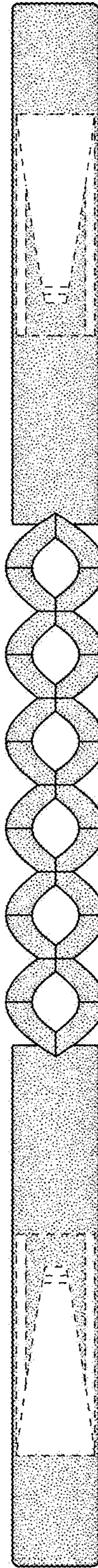

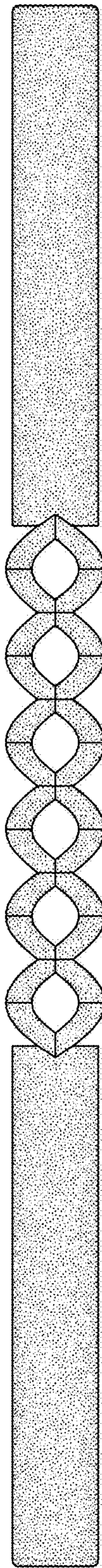

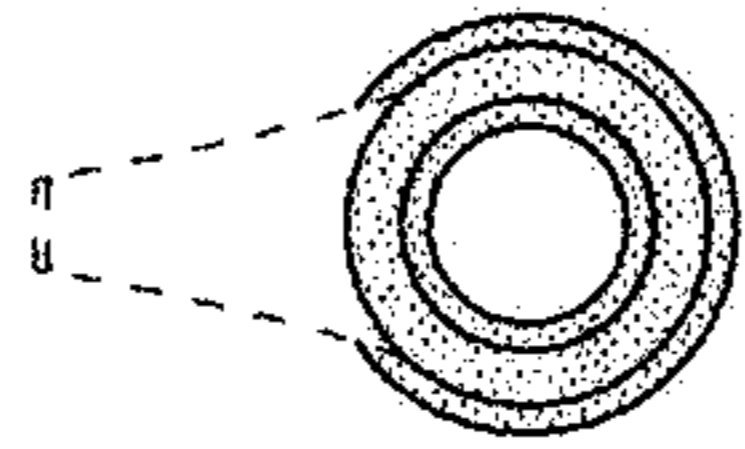

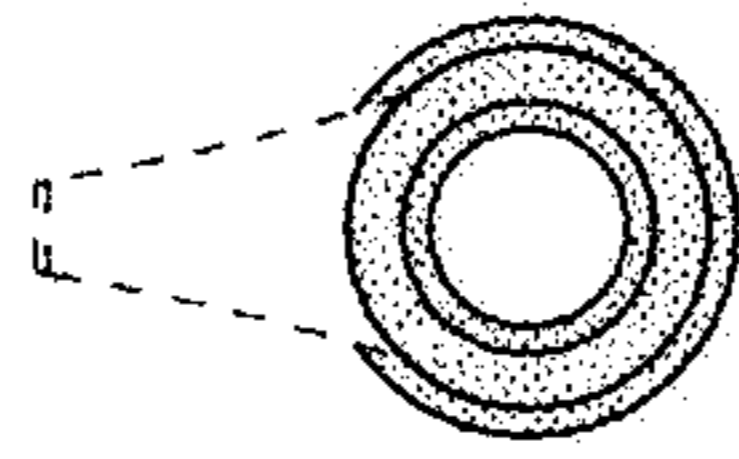

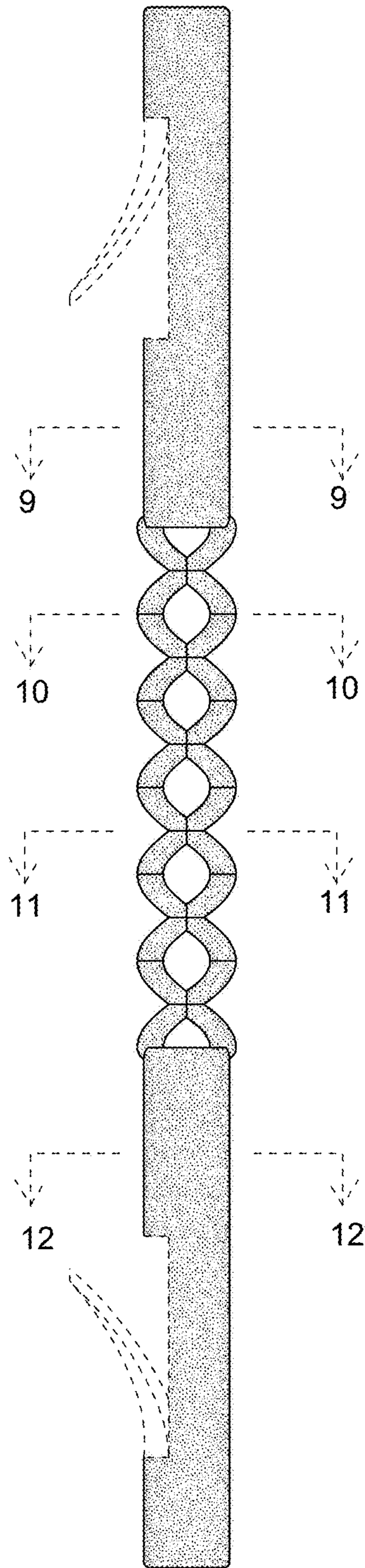

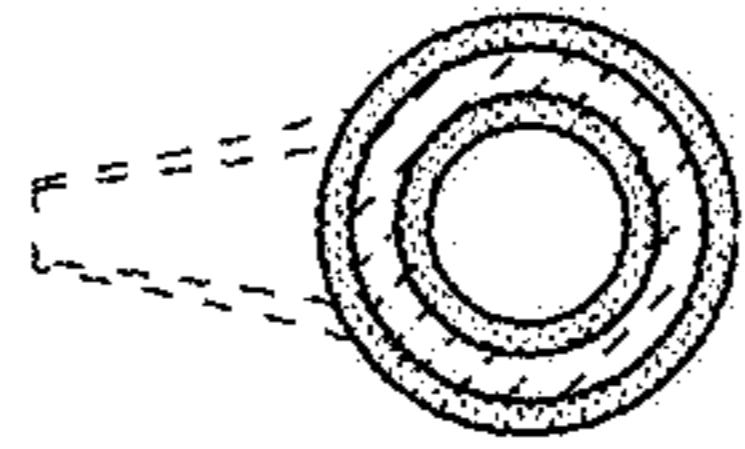

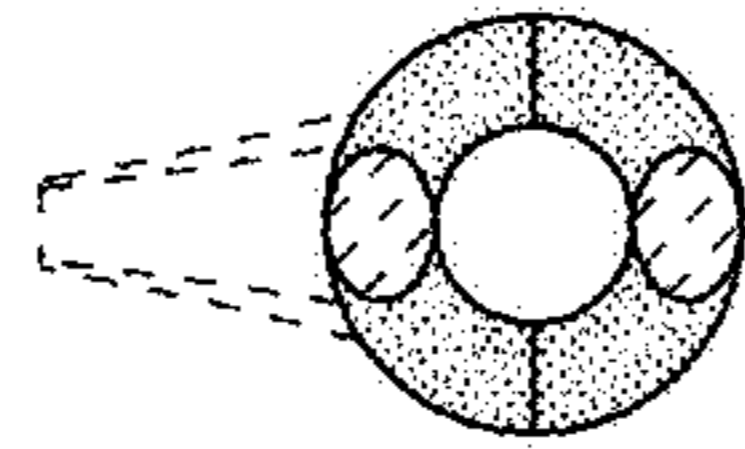

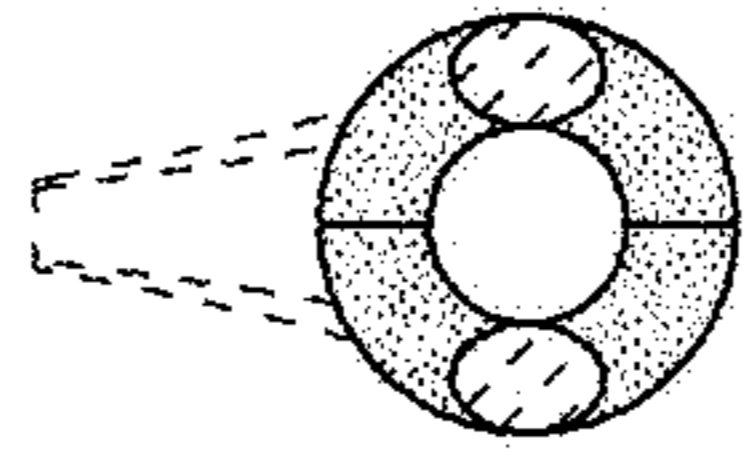

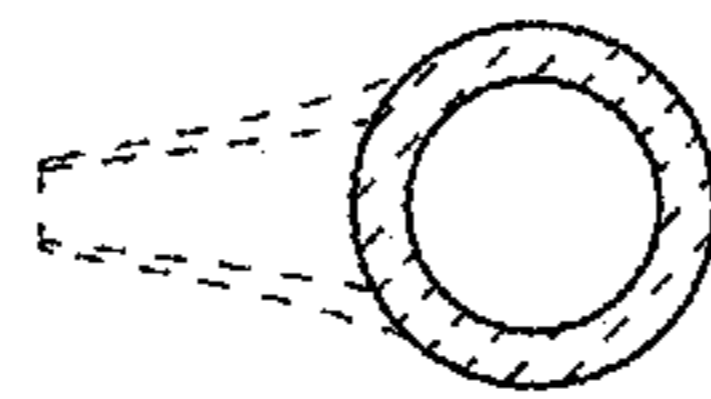
