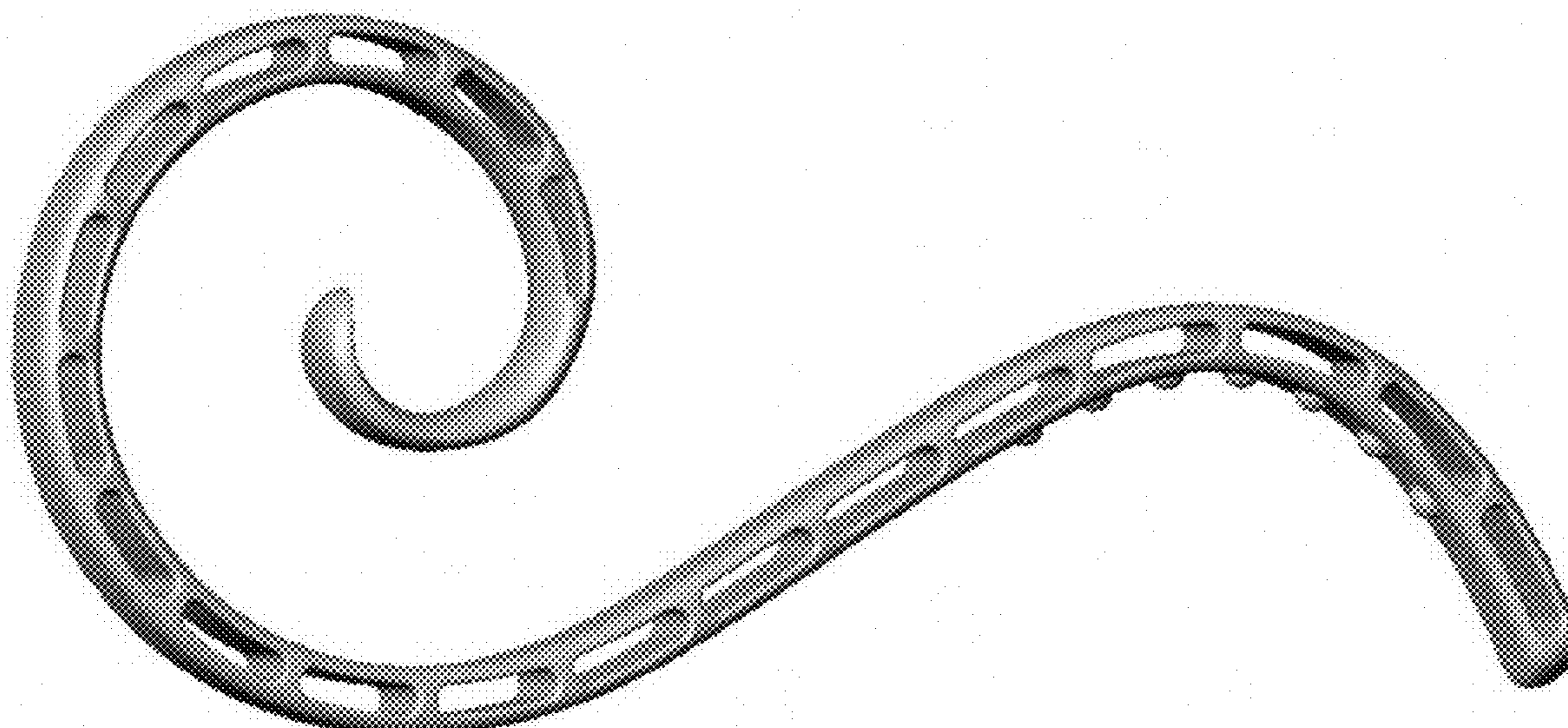
The ornamental design for a massage appliance, as shown and described.

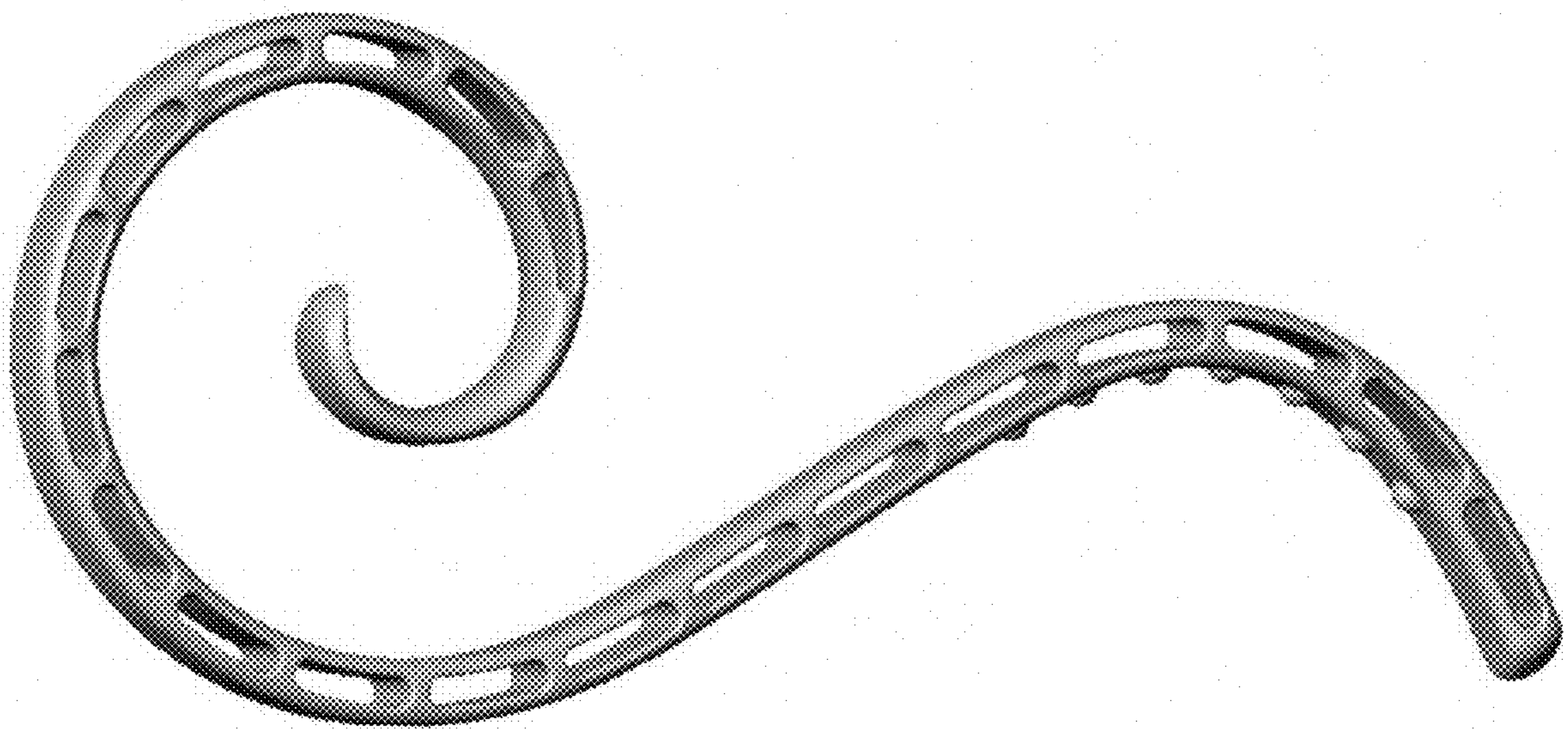

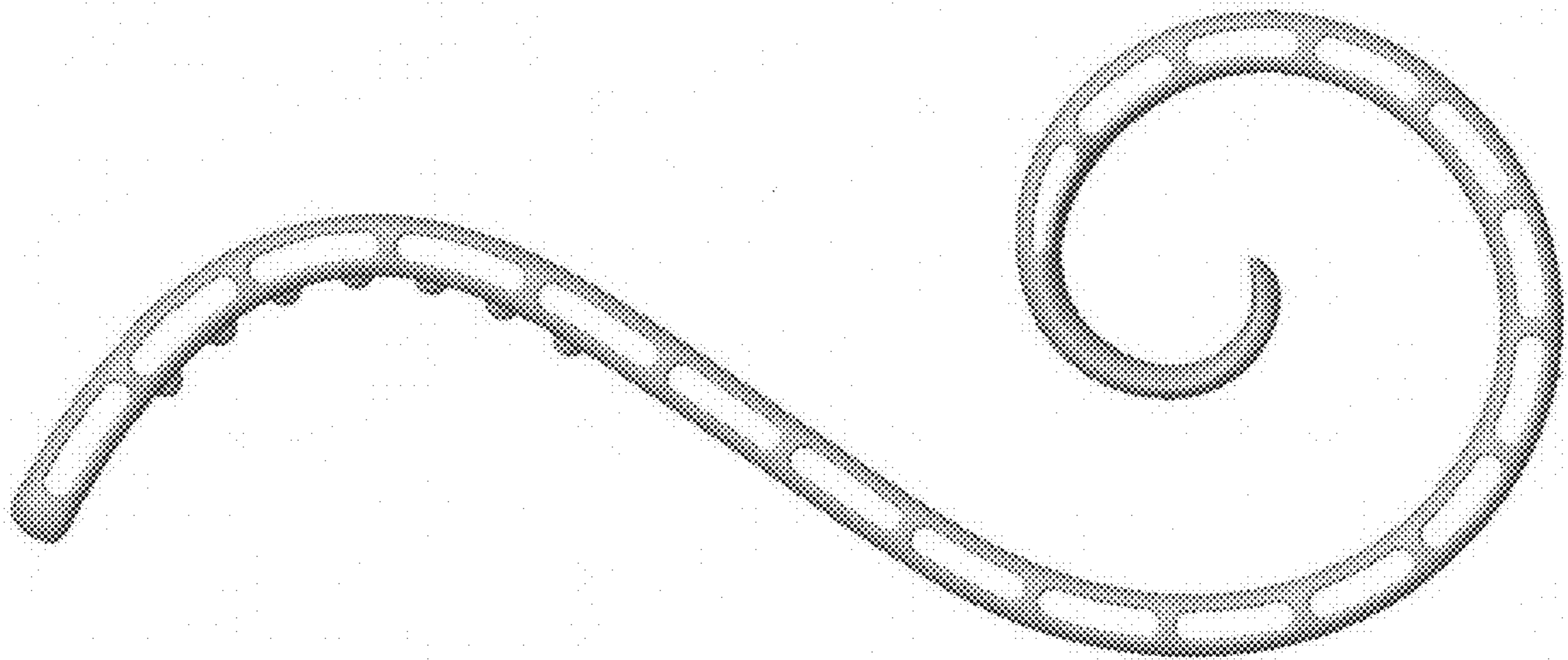

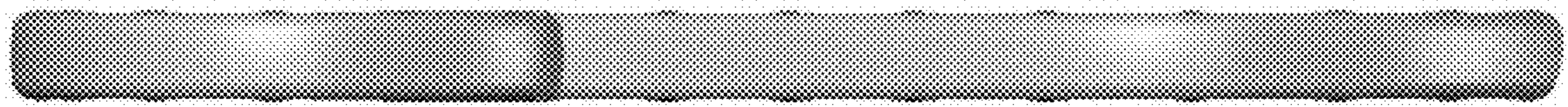

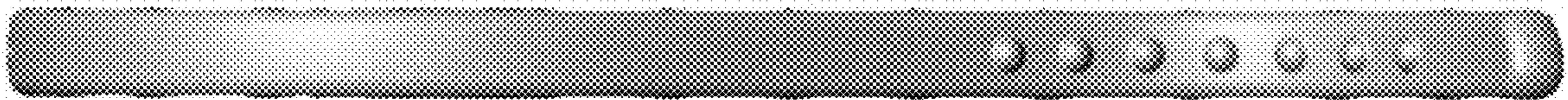

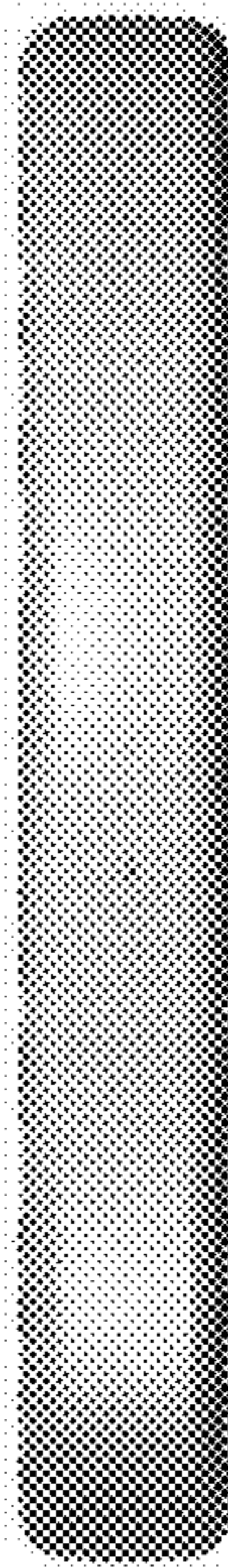

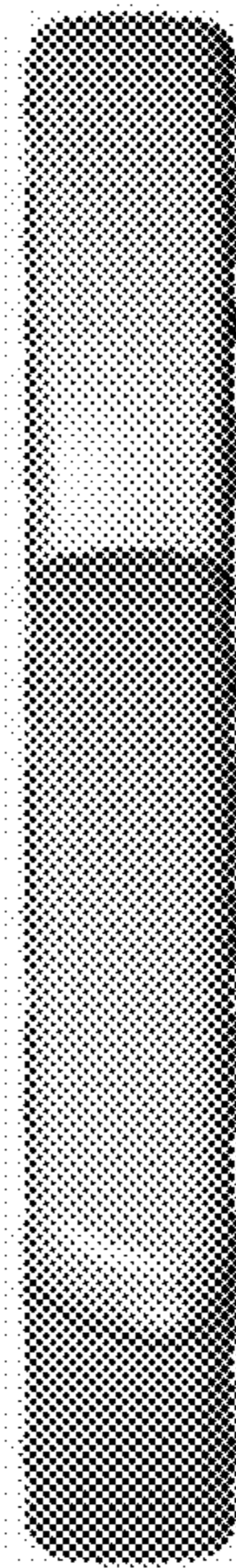

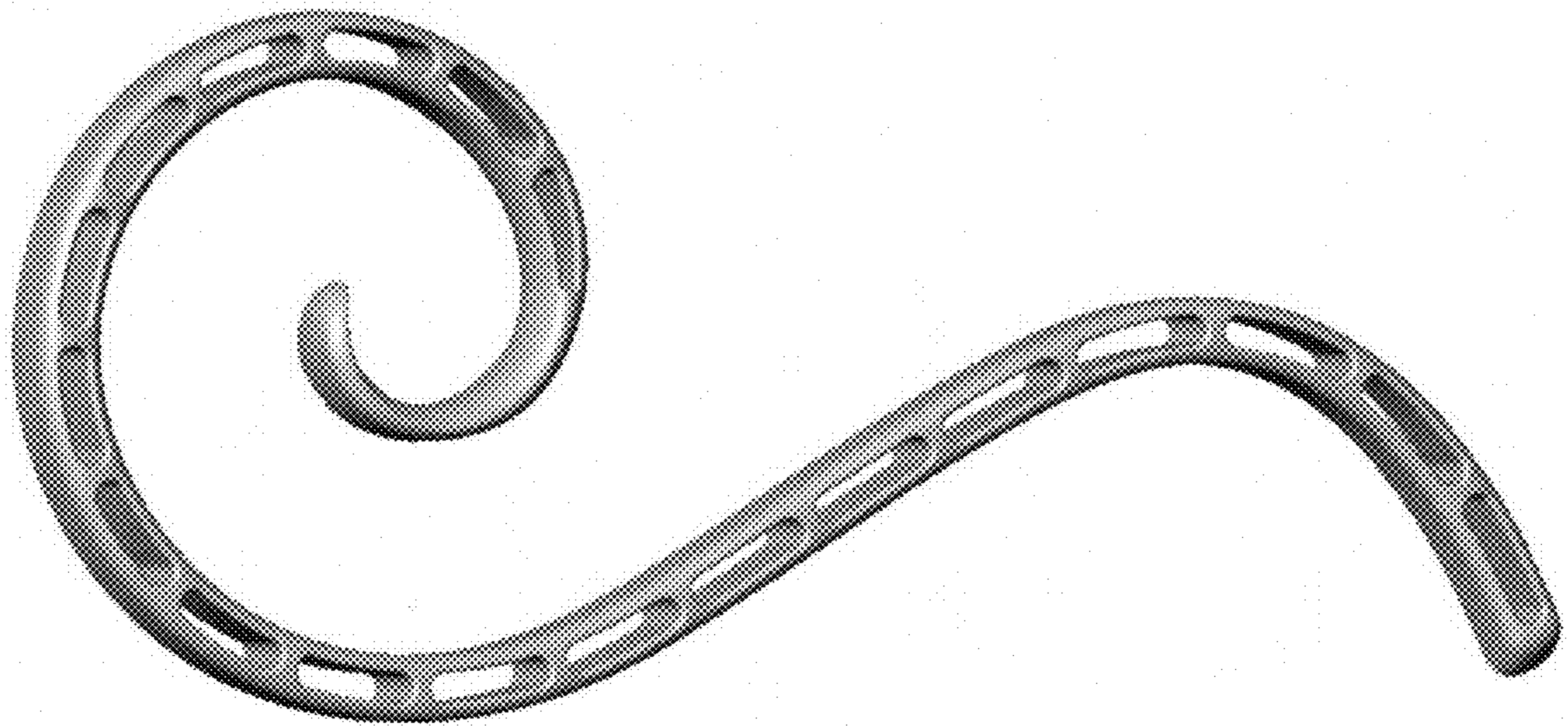




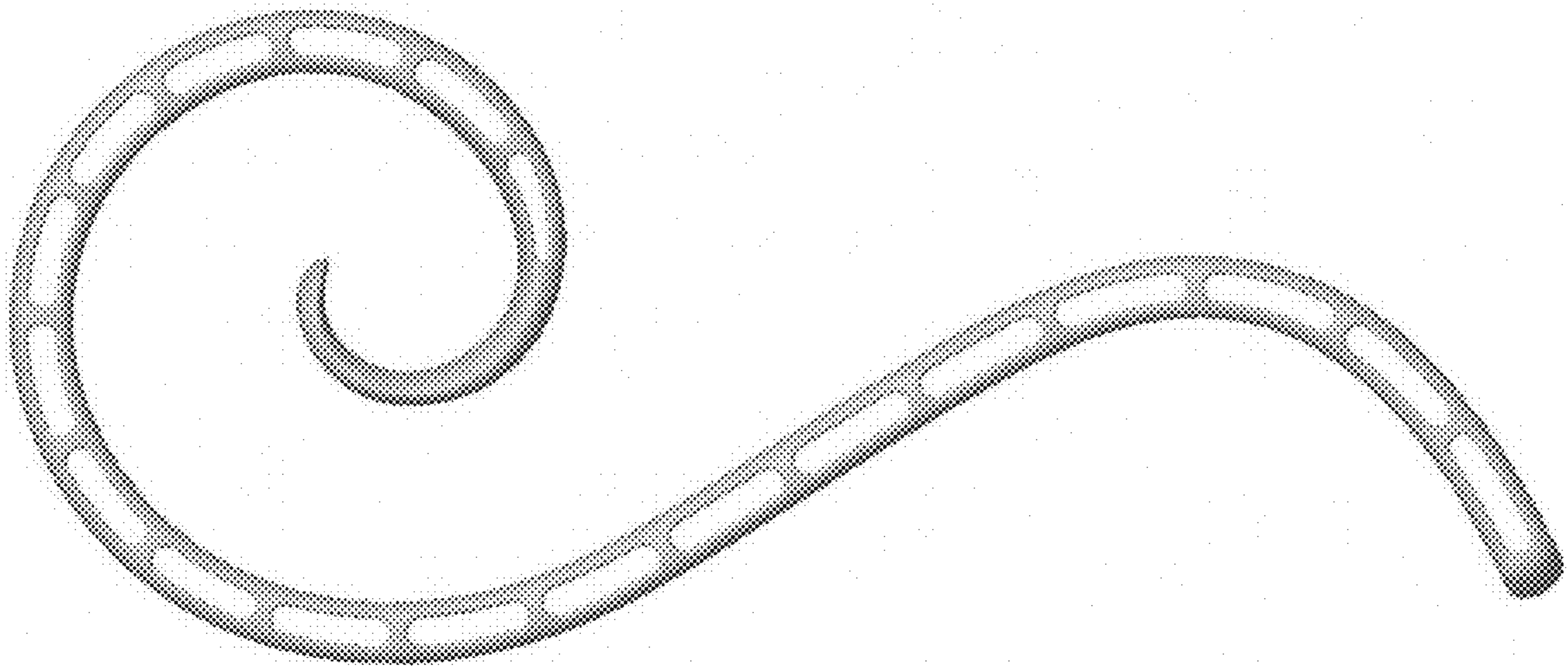

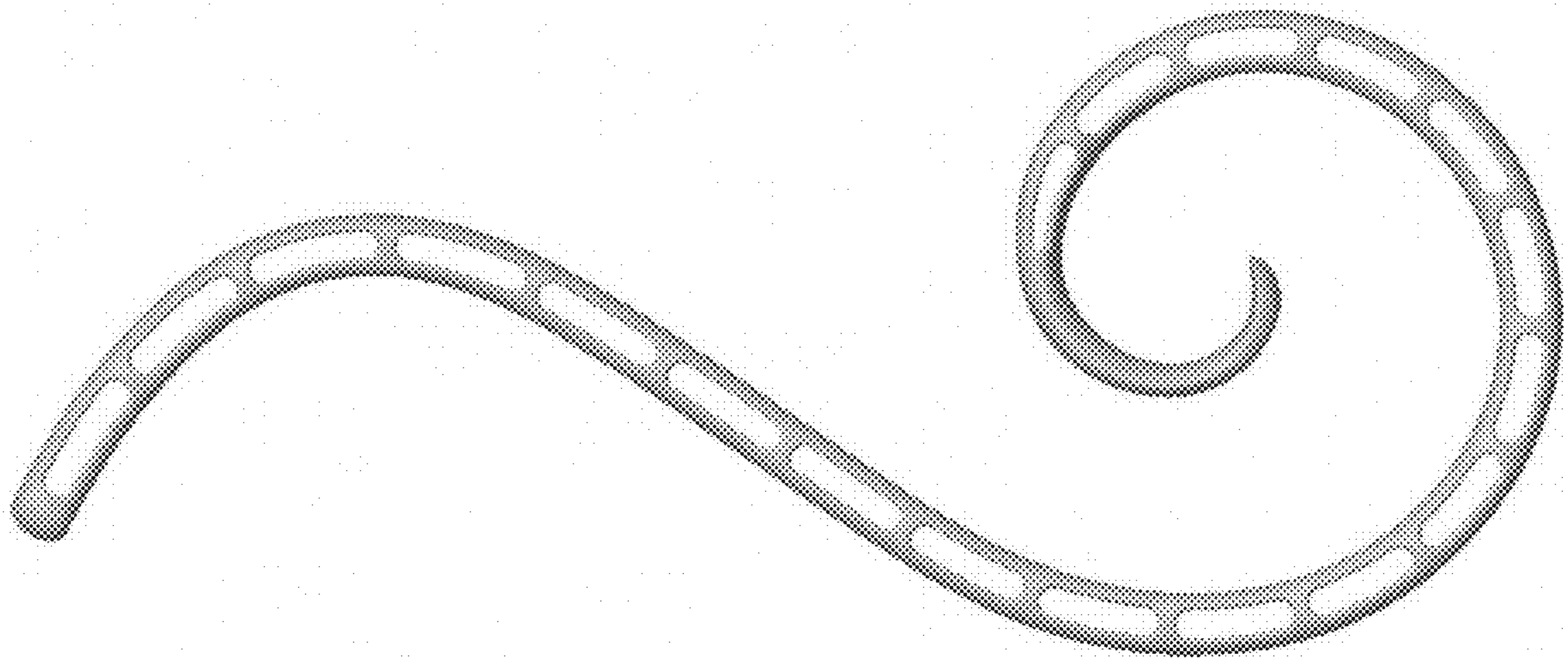

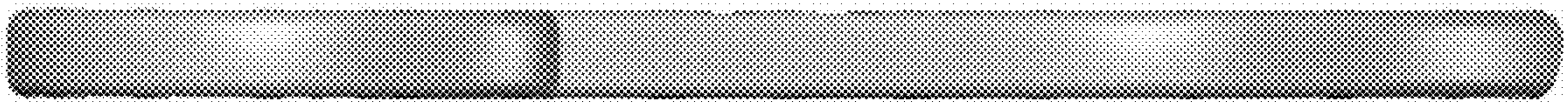

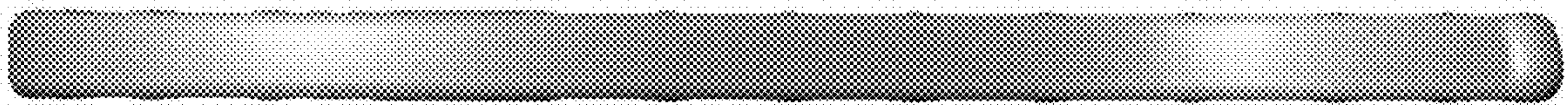

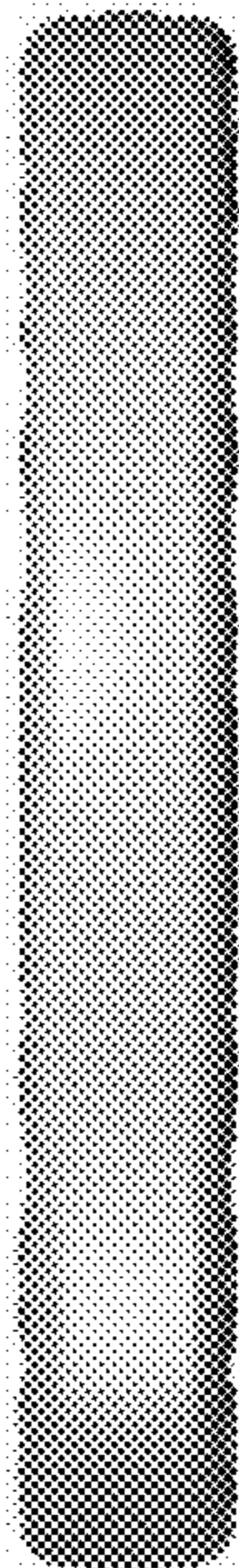
