(57) **CLAIM**

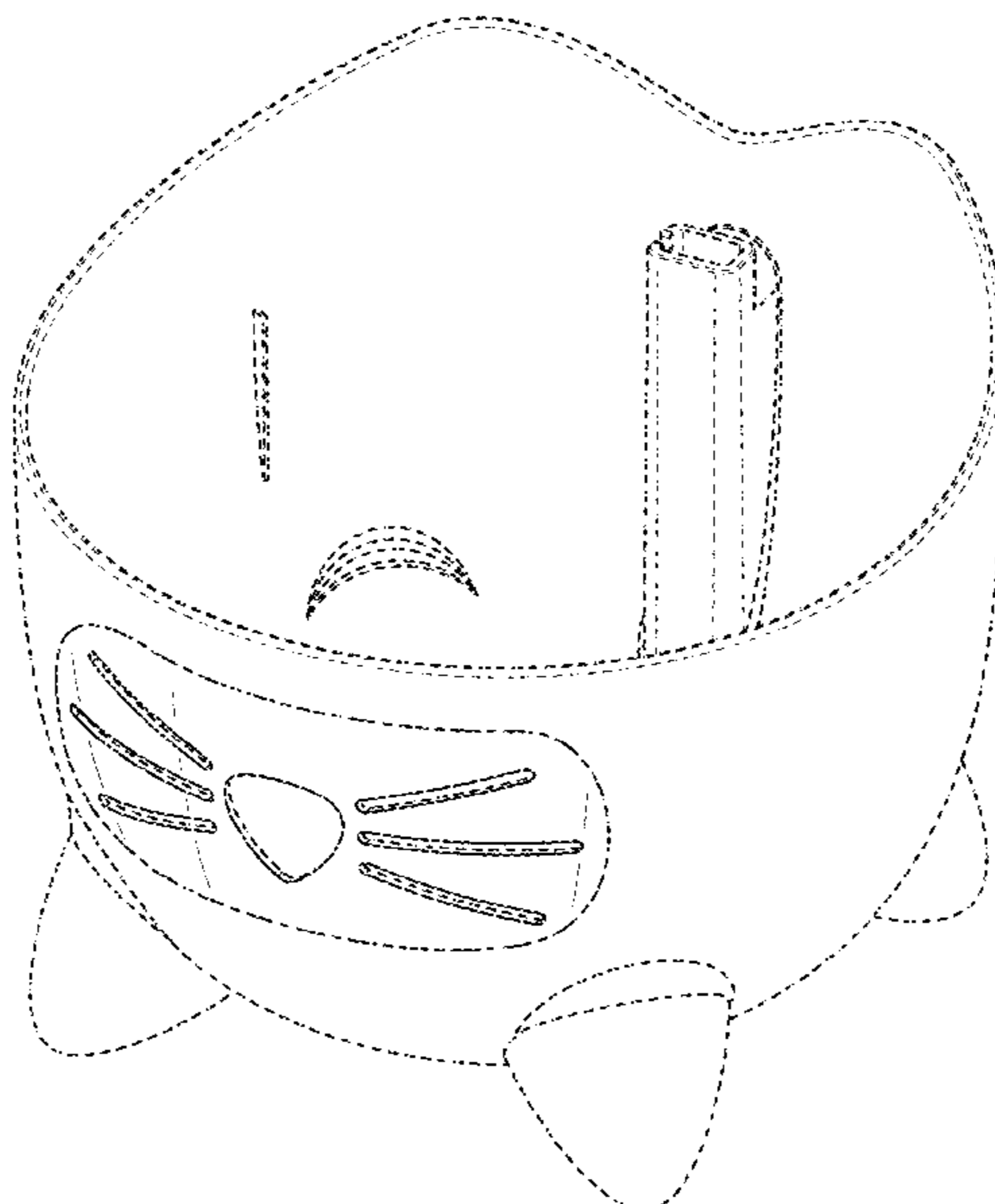
The ornamental design for a pet accessory, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, right side perspective view of a pet accessory showing our new design; FIG. 2 is a rear perspective view thereof; FIG. 3 is a front elevation view thereof; FIG. 4 is a rear elevation view thereof; FIG. 5 is a right side elevation view thereof; FIG. 6 is a left side elevation view thereof; FIG. 7 is a top plan view thereof; and, FIG. 8 is a bottom plan view thereof.

The dot-dash broken lines represent boundaries of the claimed design and form no part of the claimed design. The dash-dash broken lines depict portions of the pet accessory that form no part of the claimed design.

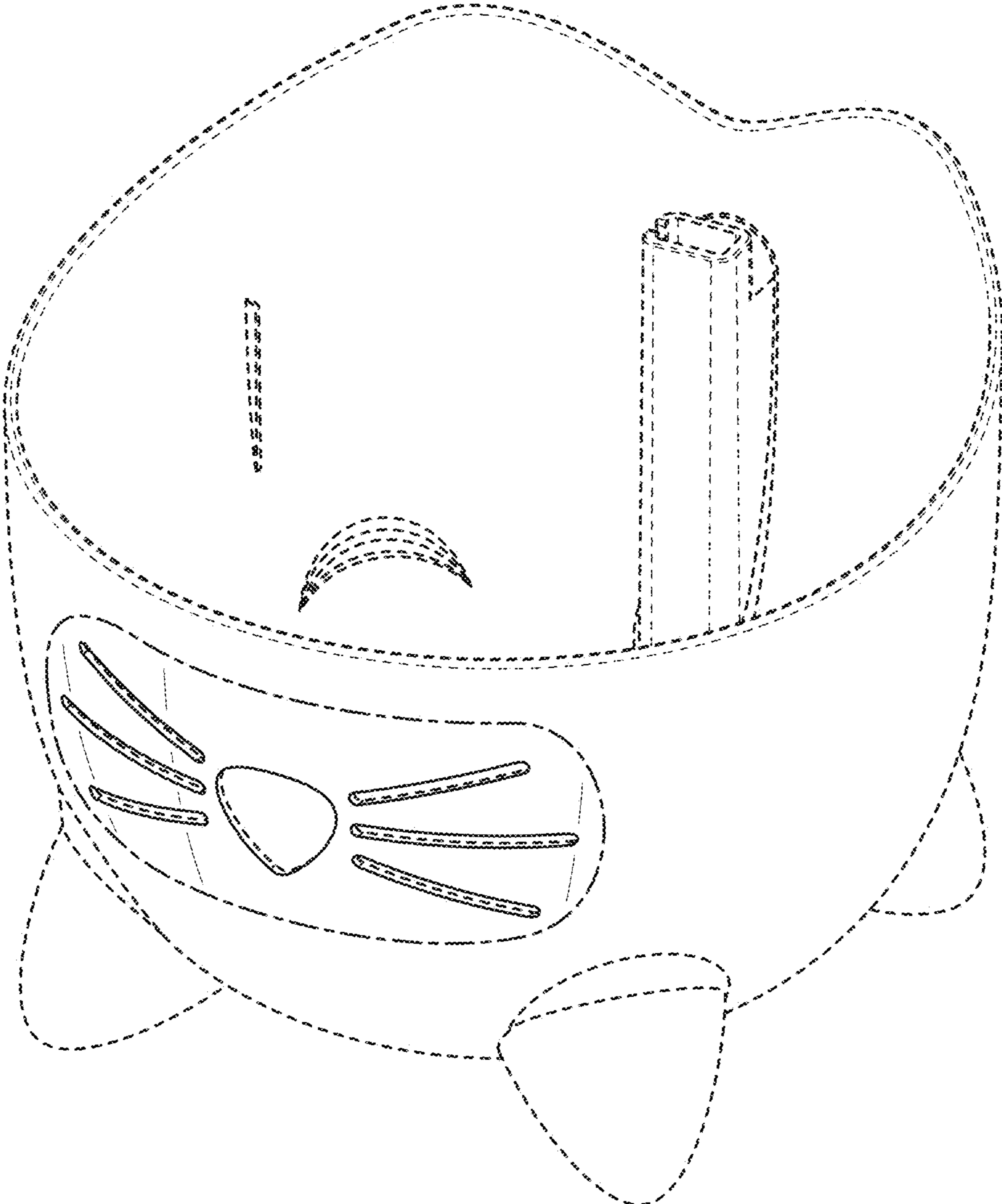

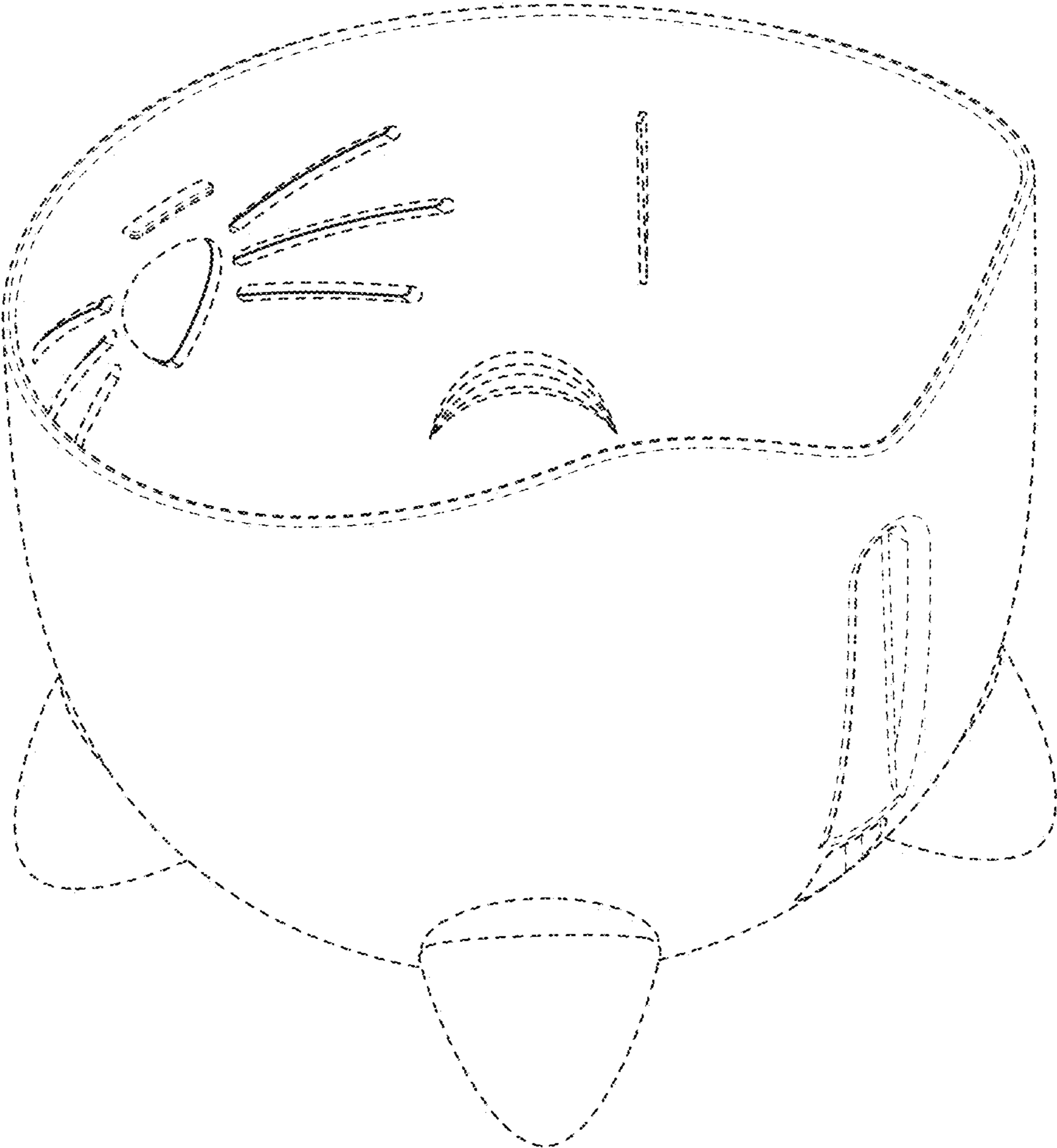

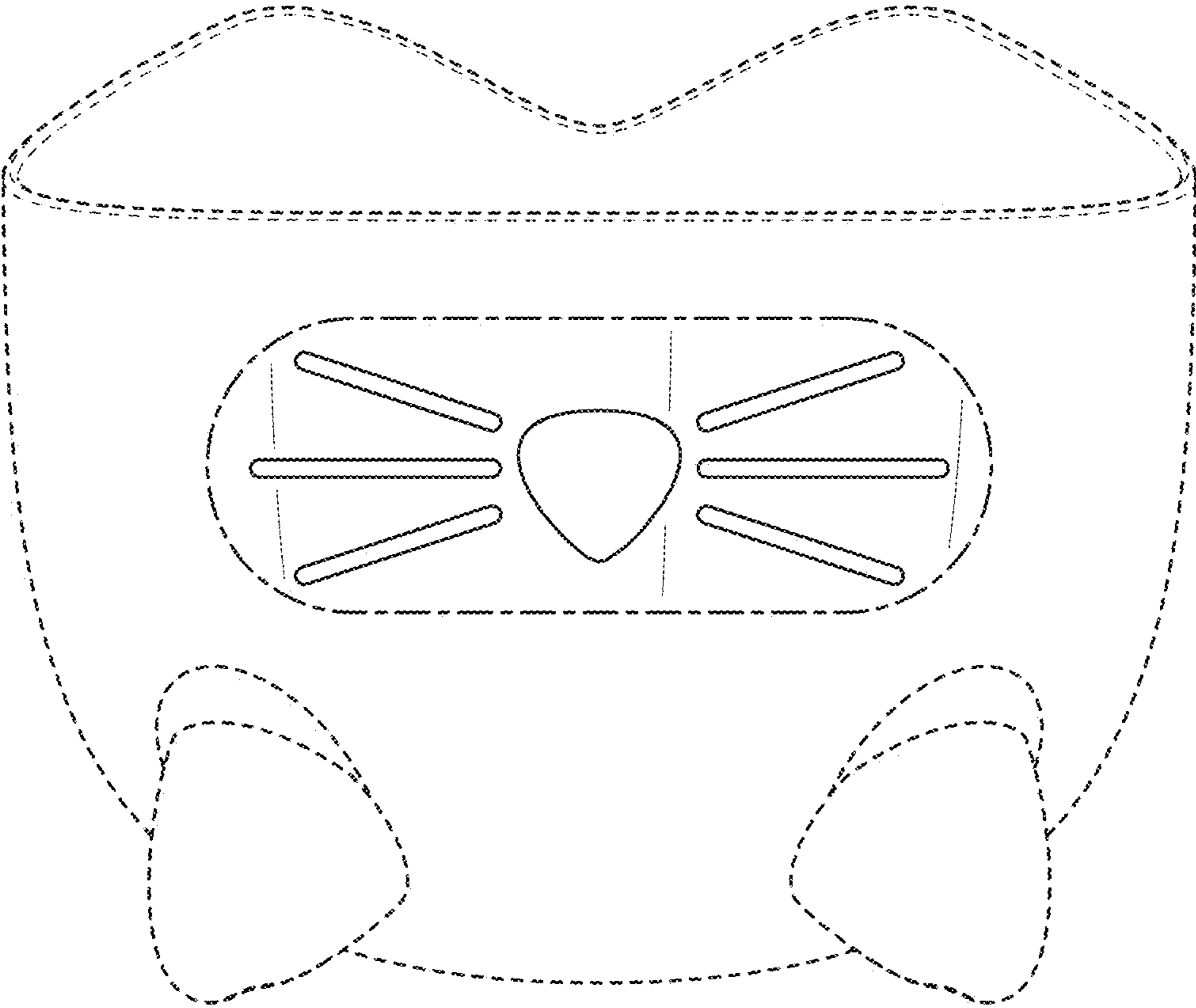

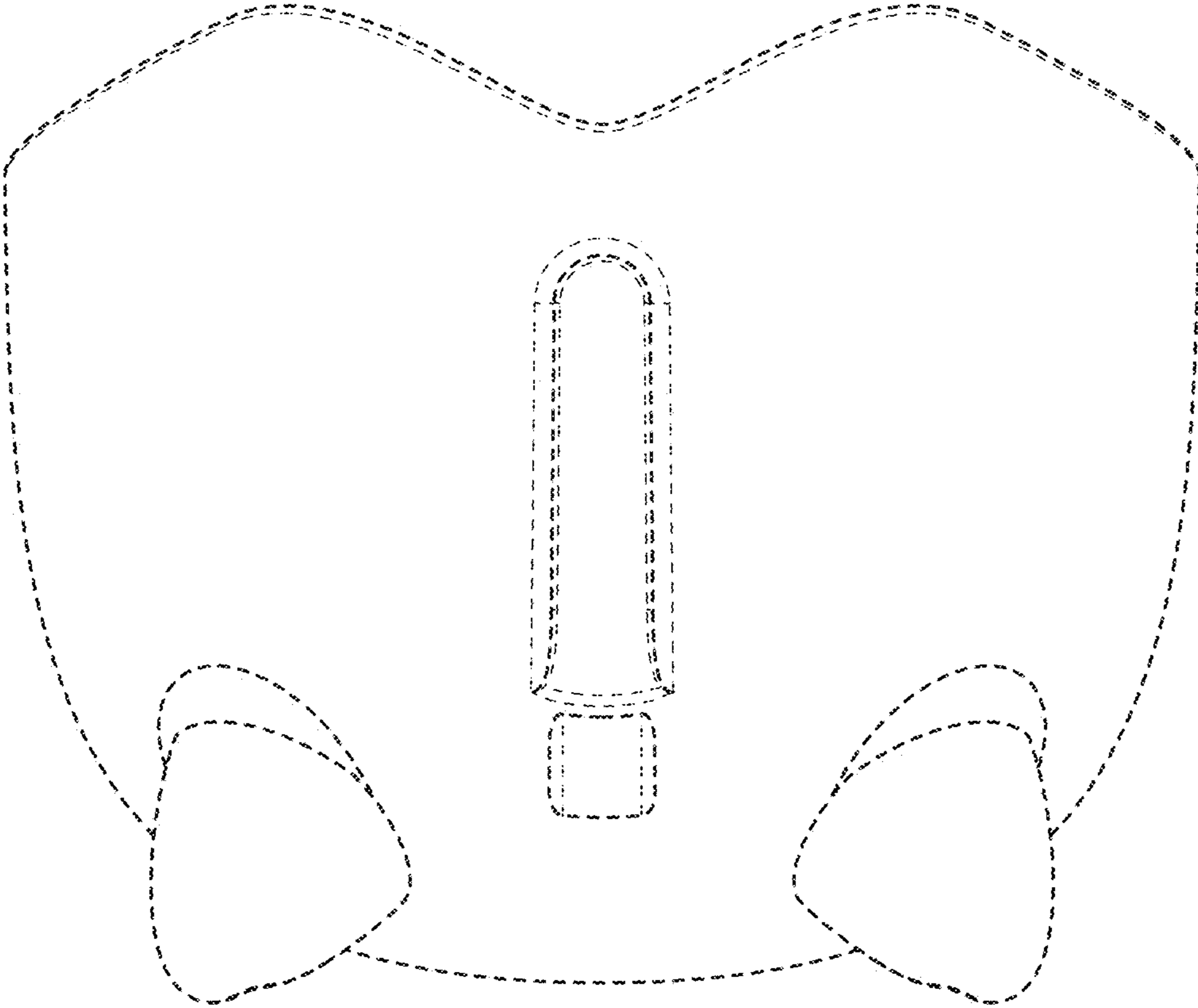

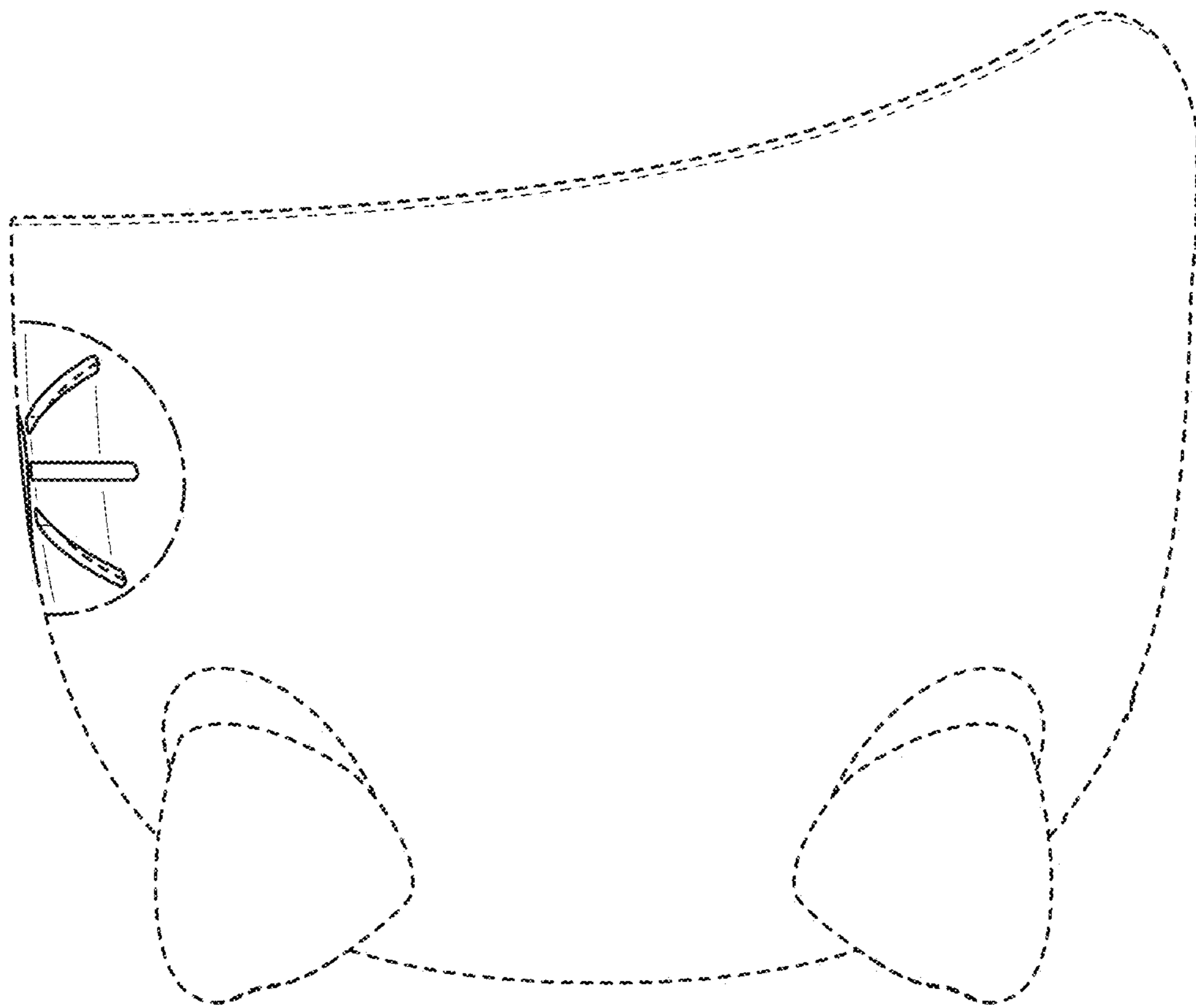

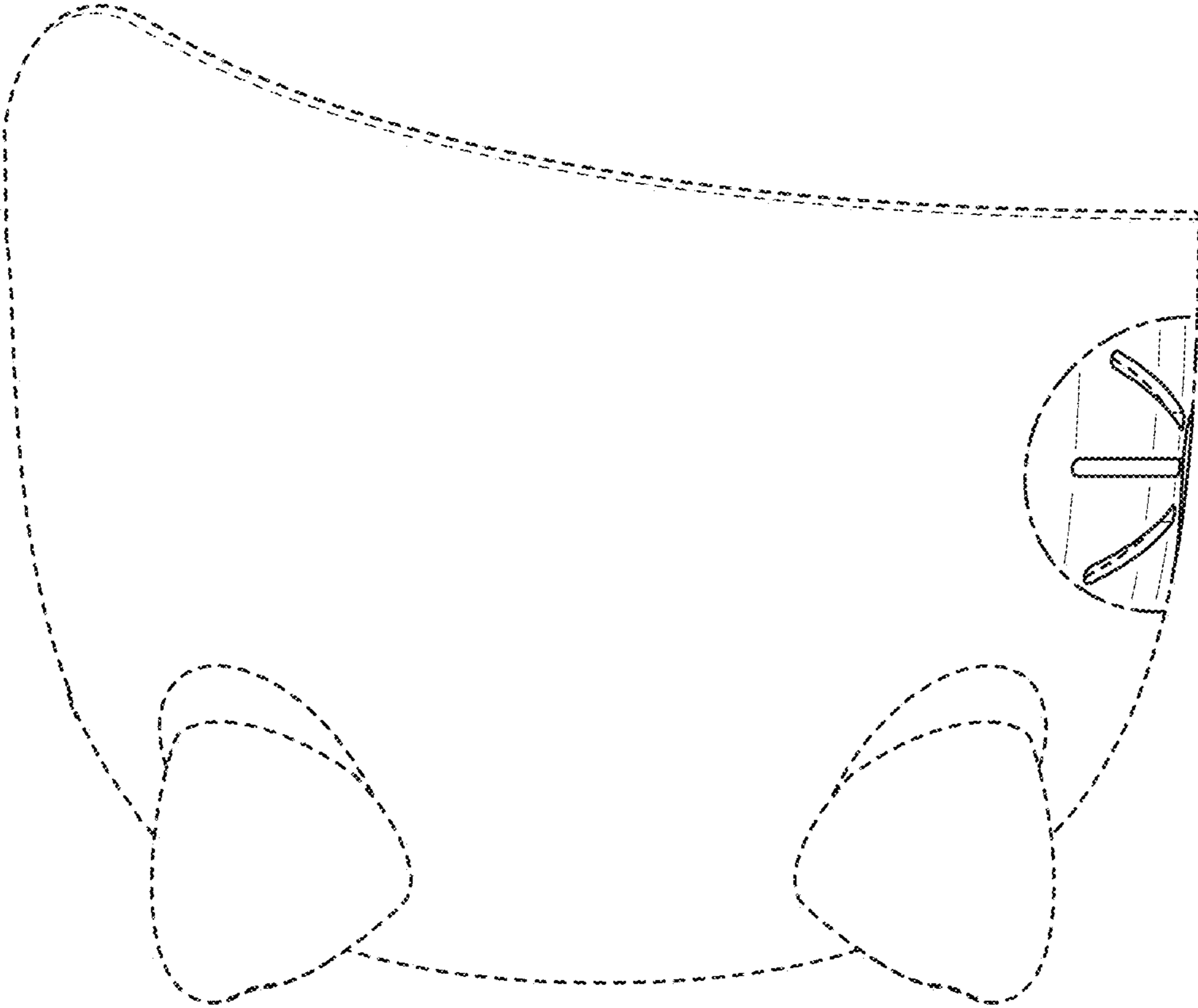

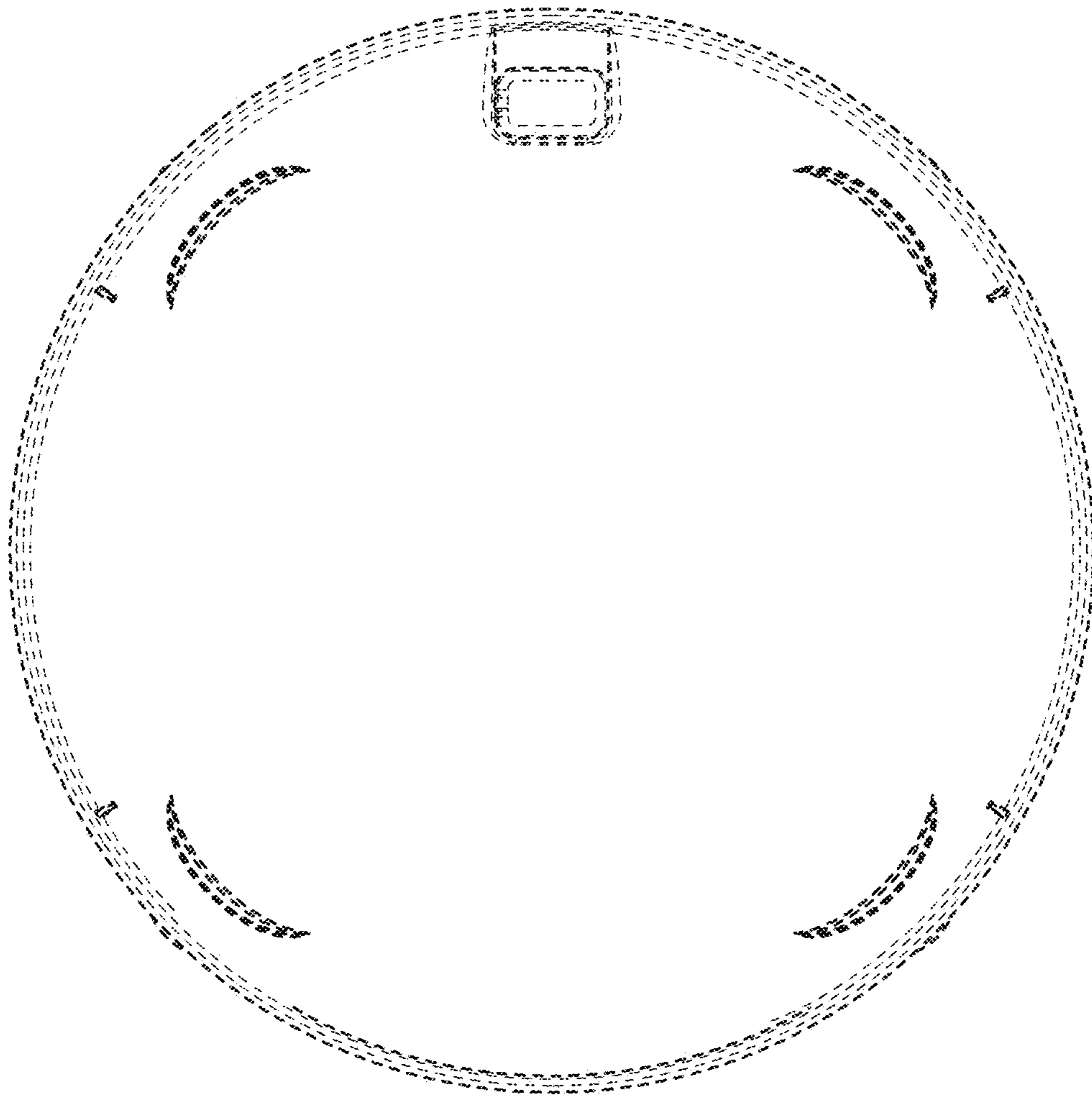

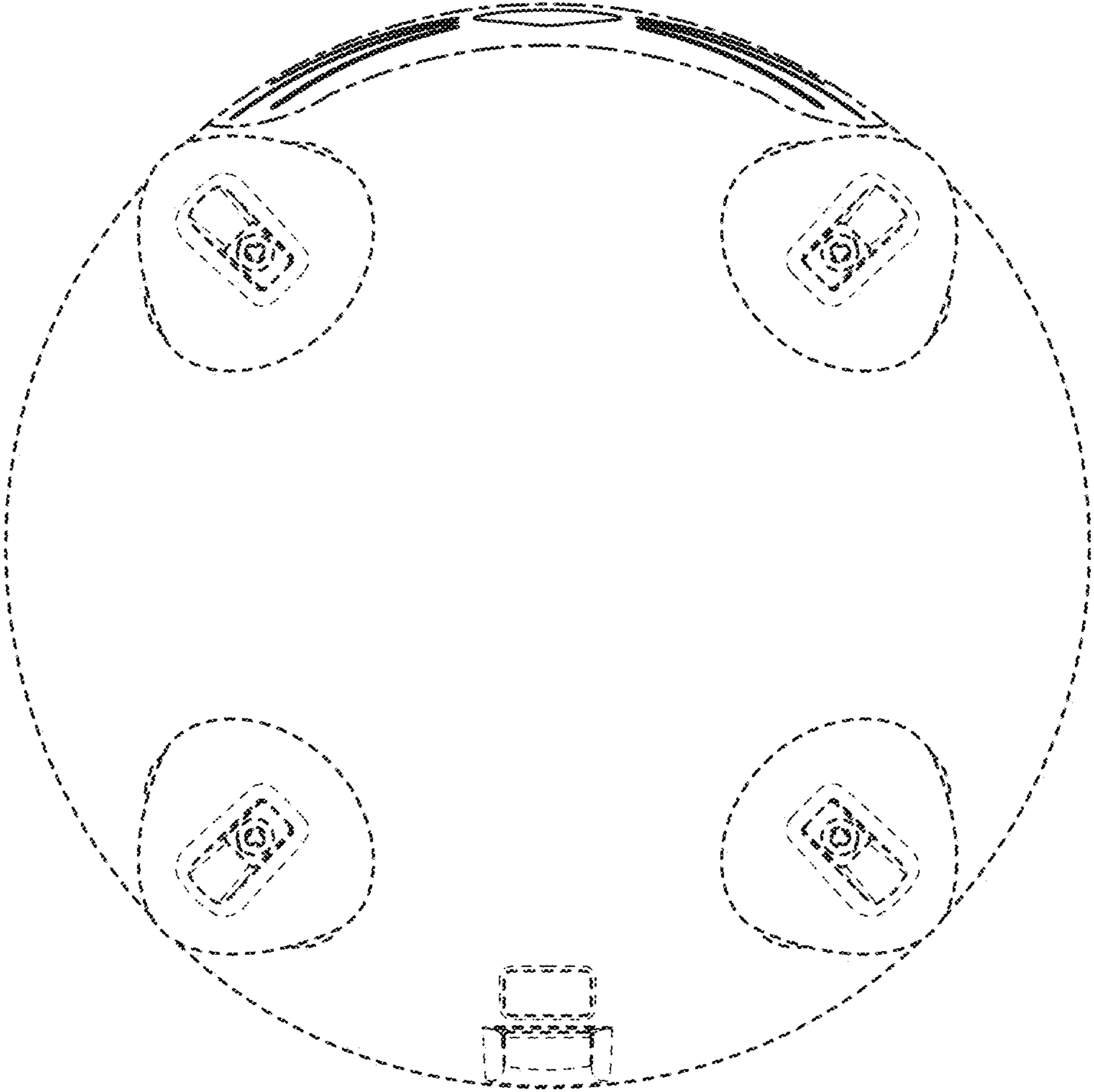
