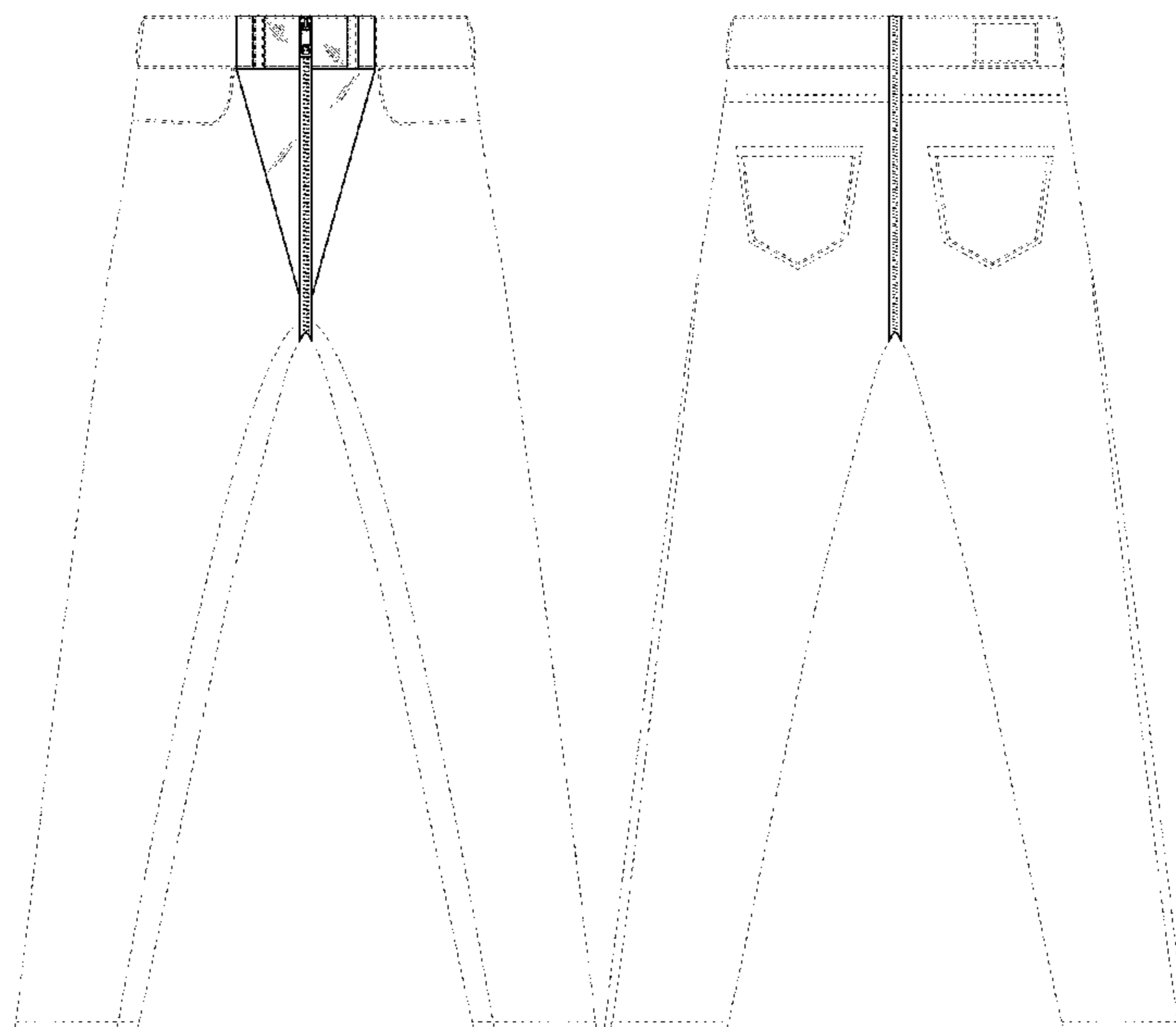
(57) **CLAIM**

I claim the ornamental design for jeans, as shown and described.

DESCRIPTION

FIG. 1 is a front view of jeans showing my new design; FIG. 2 is a back view thereof; FIG. 3 is a right side view thereof; FIG. 4 is a left side view thereof; FIG. 5 is a top view thereof; and, FIG. 6 is a bottom view thereof. 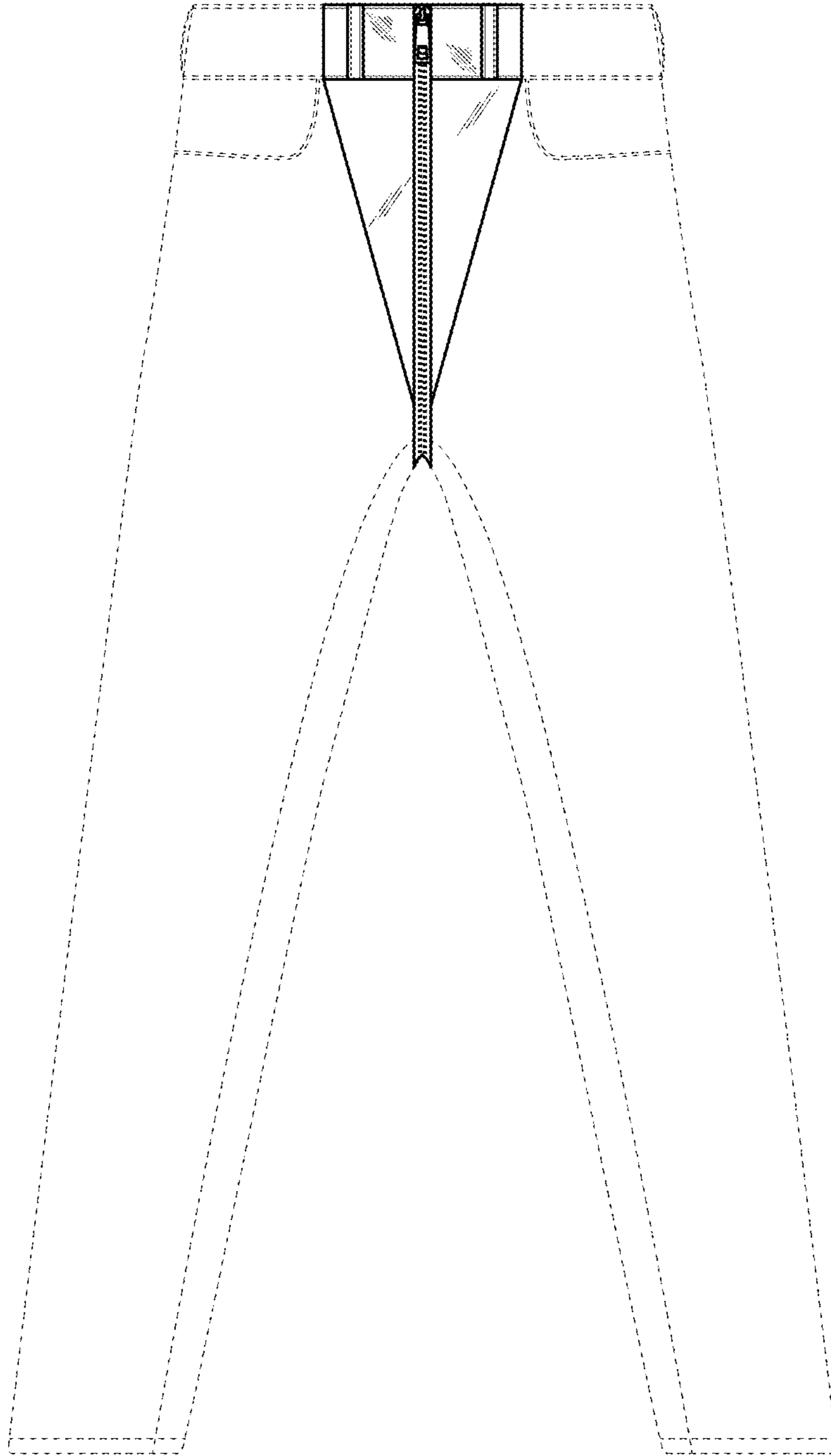

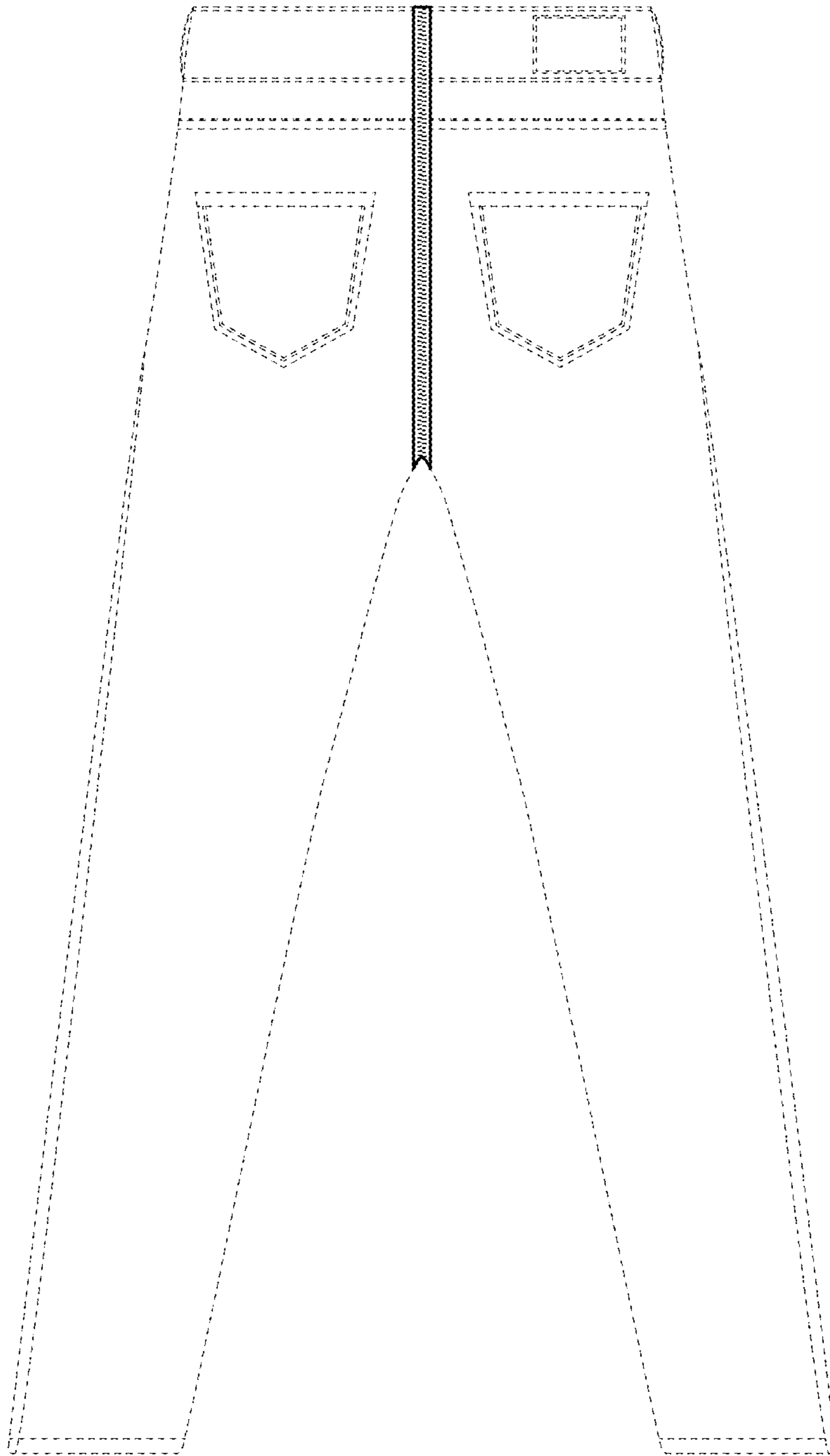

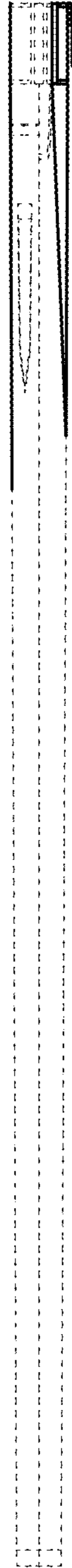

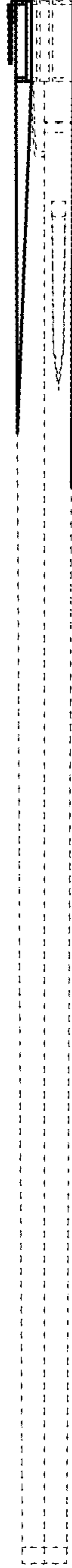

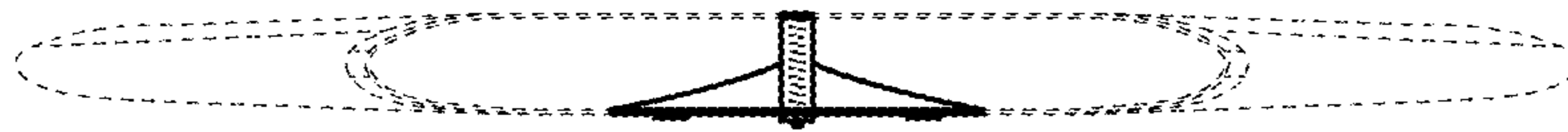
