(57) **CLAIM**

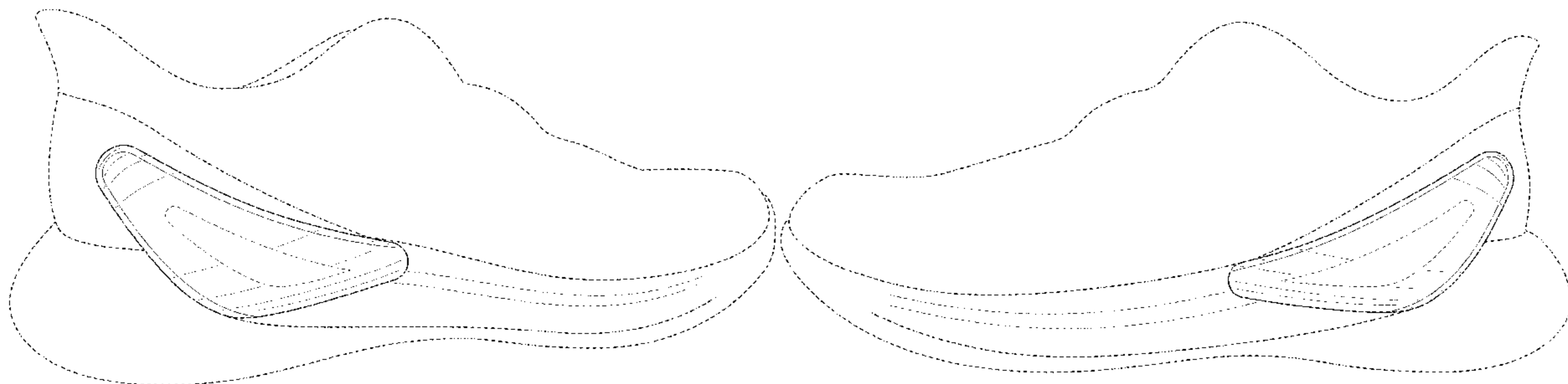
The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a medial side perspective view of a shoe showing the new design, according to a first embodiment in which the claimed design is shown as having an opaque surface; FIG. 2 is a lateral side perspective view thereof; FIG. 3 is a lateral side view thereof; FIG. 4 is a medial side view thereof; FIG. 5 is a rear view thereof; FIG. 6 is a top view thereof; FIG. 7 is a medial side perspective view of a shoe showing the new design, according to a second embodiment in which the claimed design is shown as having a transparent or translucent surface; FIG. 8 is a lateral side perspective view thereof; FIG. 9 is a lateral side view thereof; FIG. 10 is a medial side view thereof; FIG. 11 is a rear view thereof; and, FIG. 12 is a top view thereof.

The broken lines shown in the drawings illustrate portions of the shoe that form no part of the claimed design. A left-foot shoe is illustrated in FIGS. 1-12. Further embodiments of the claimed design include a right-foot shoe, which are mirror images of the views of the first and second embodiments.

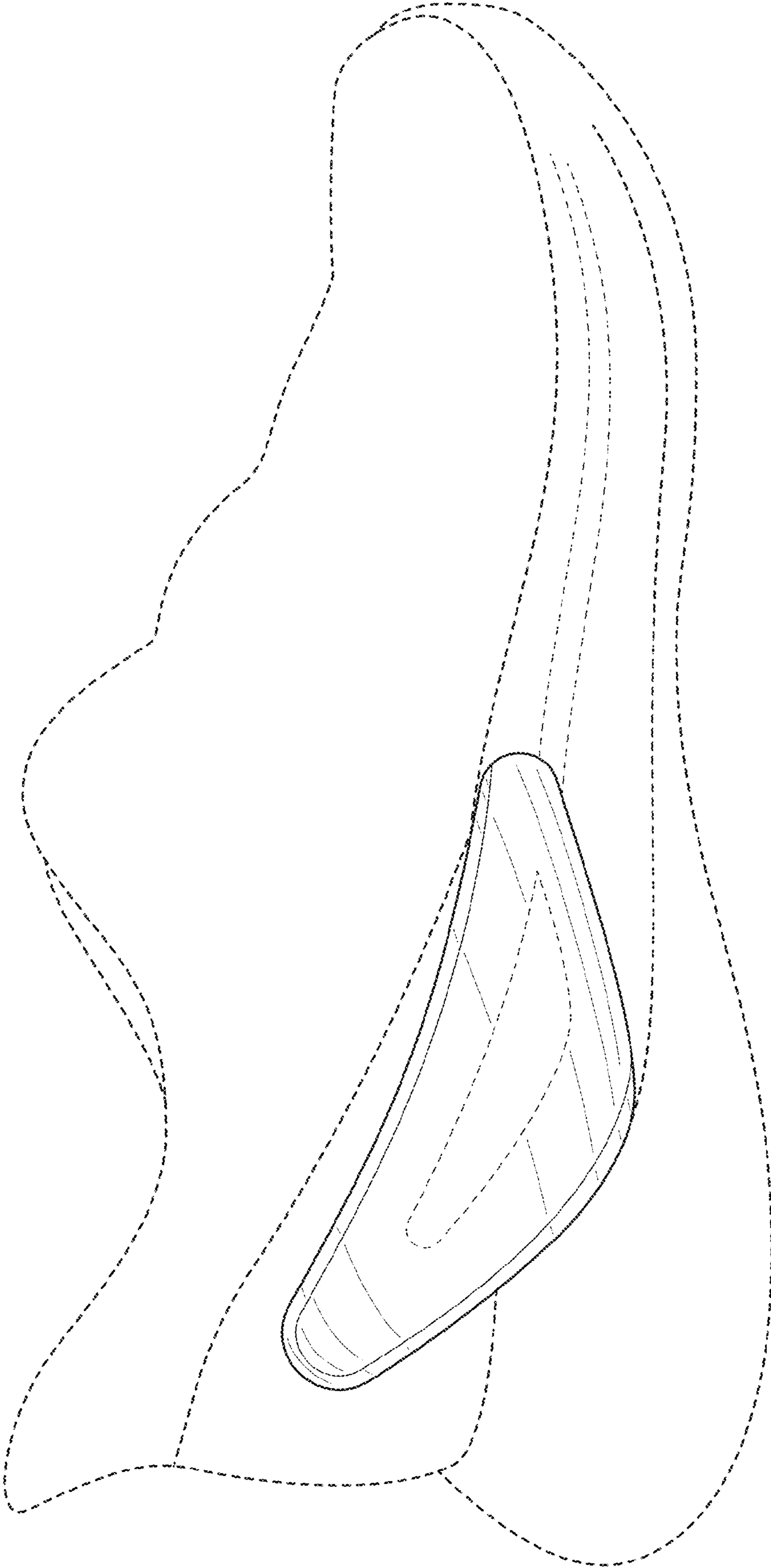

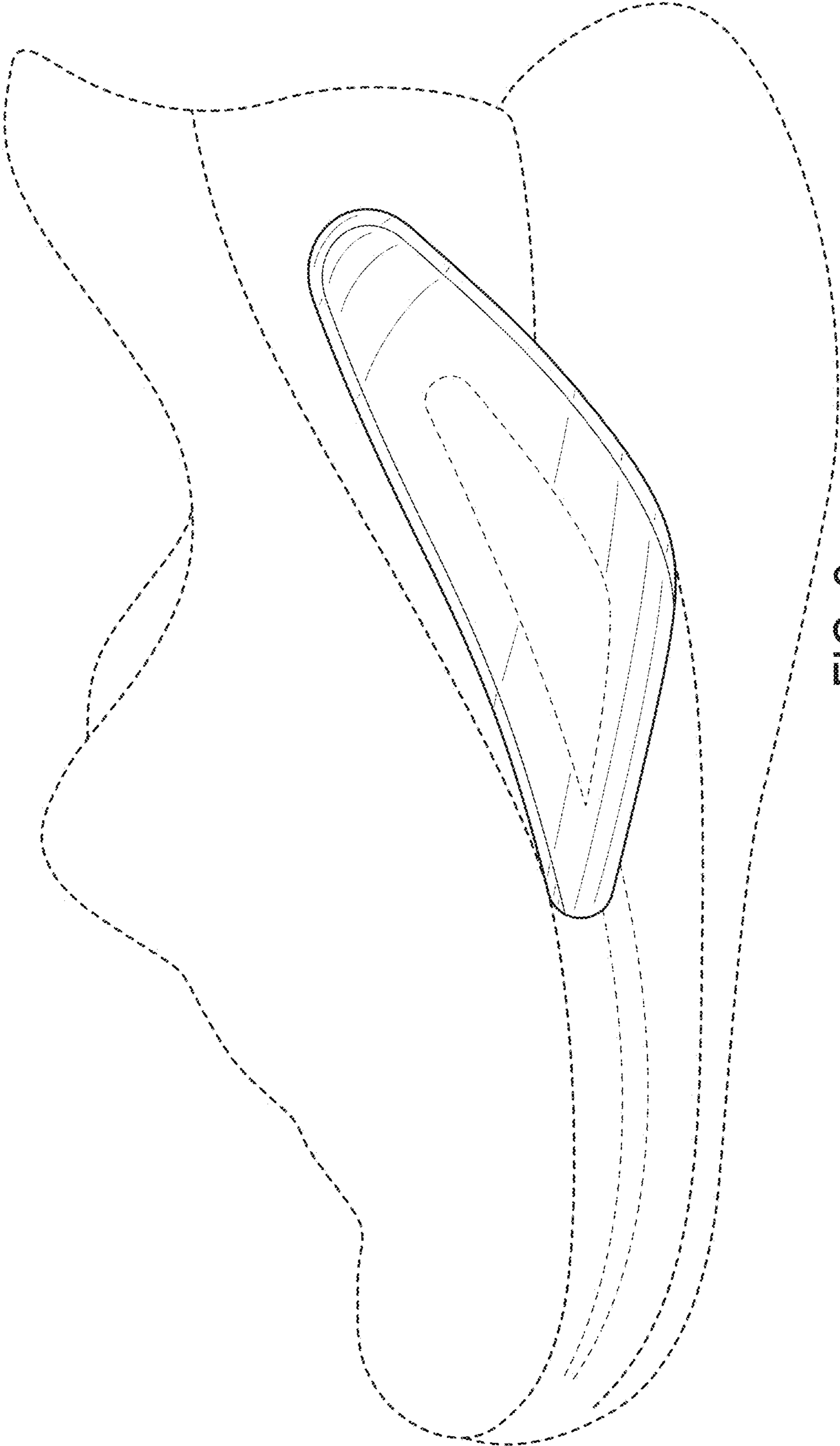

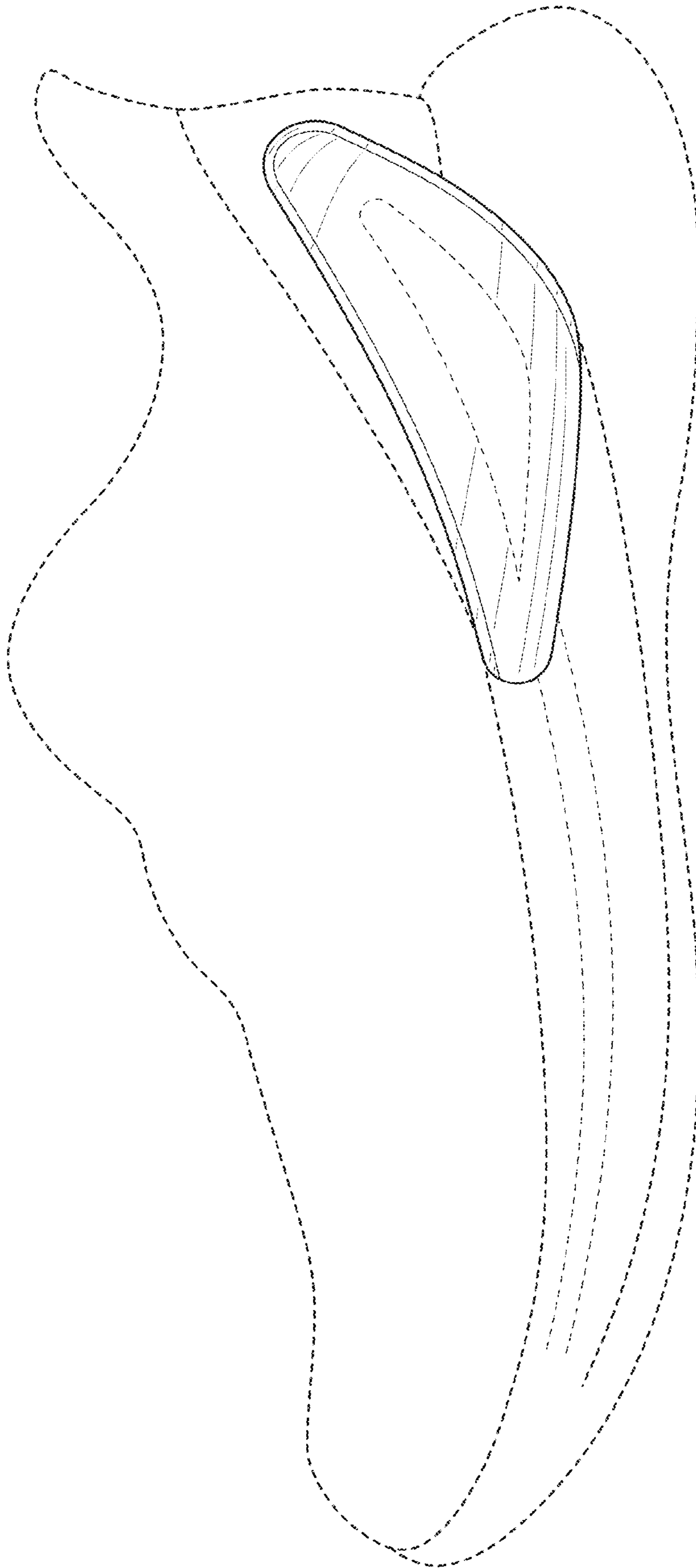

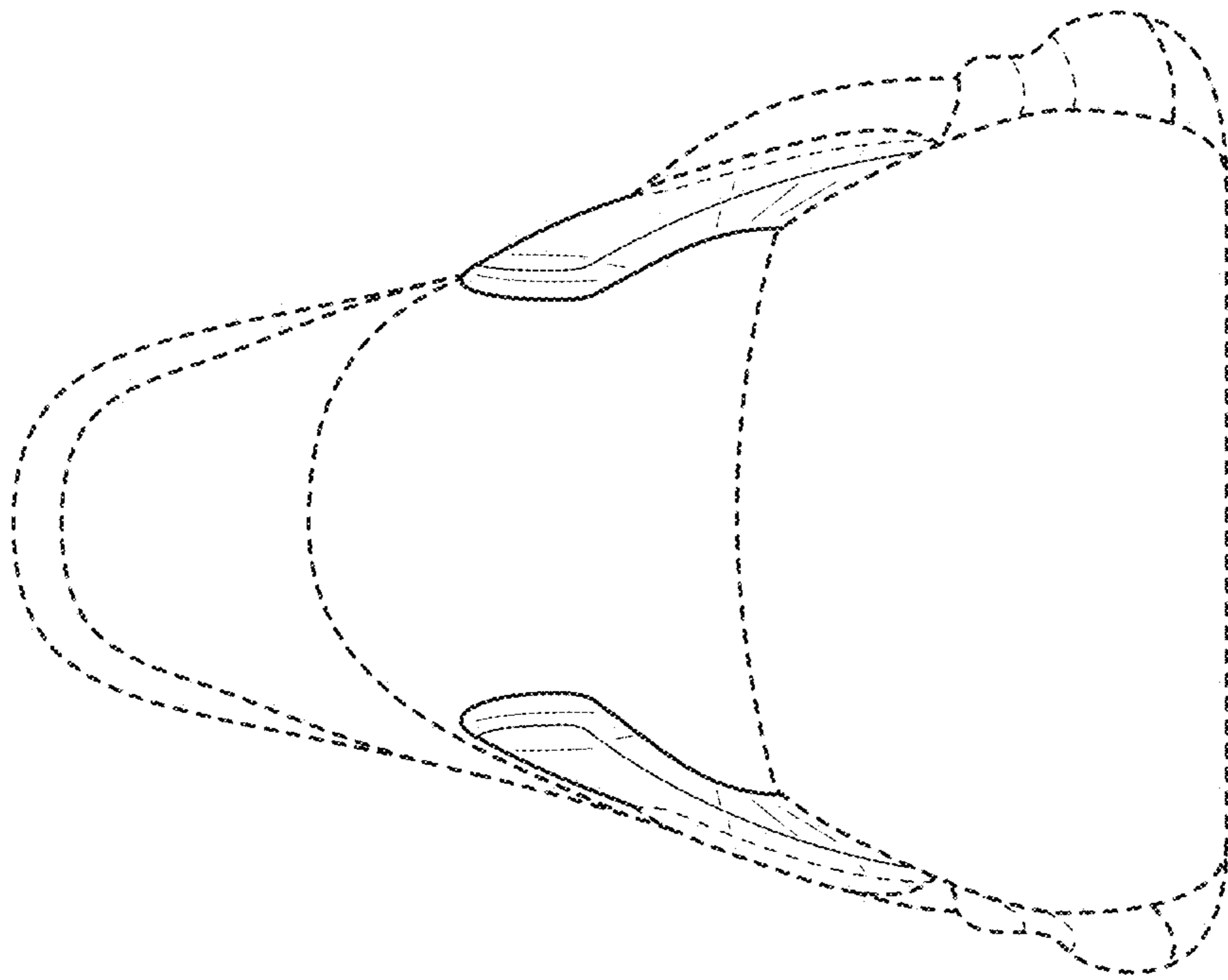

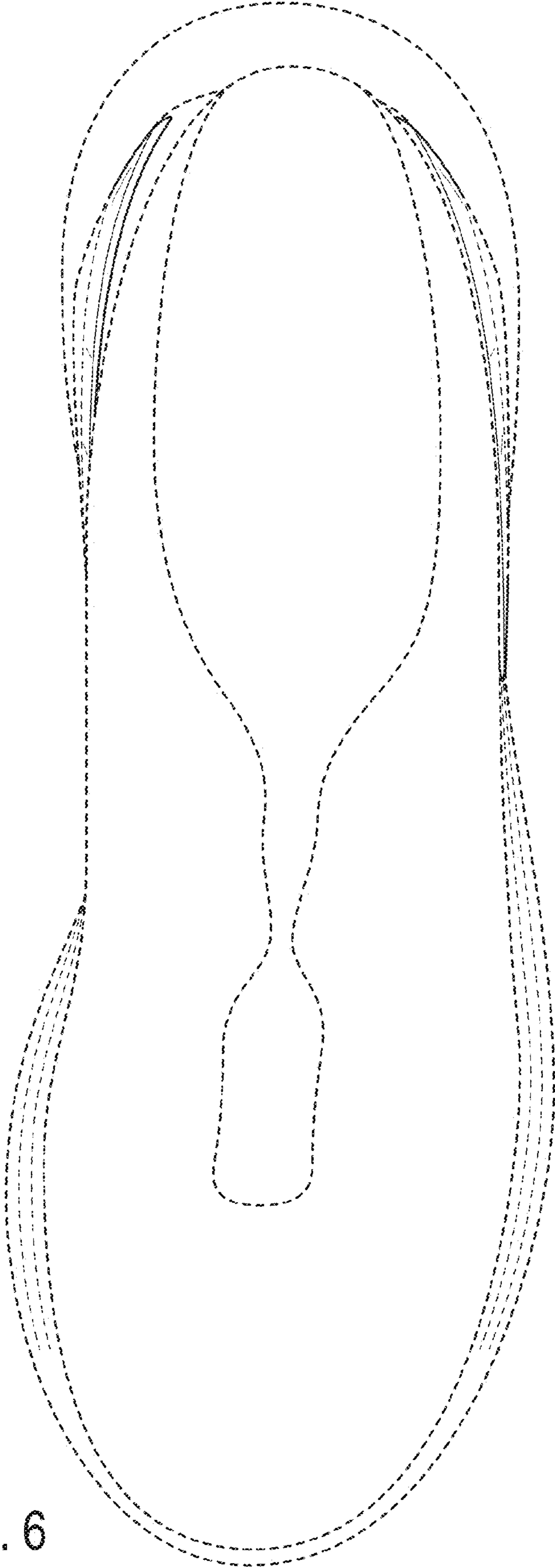

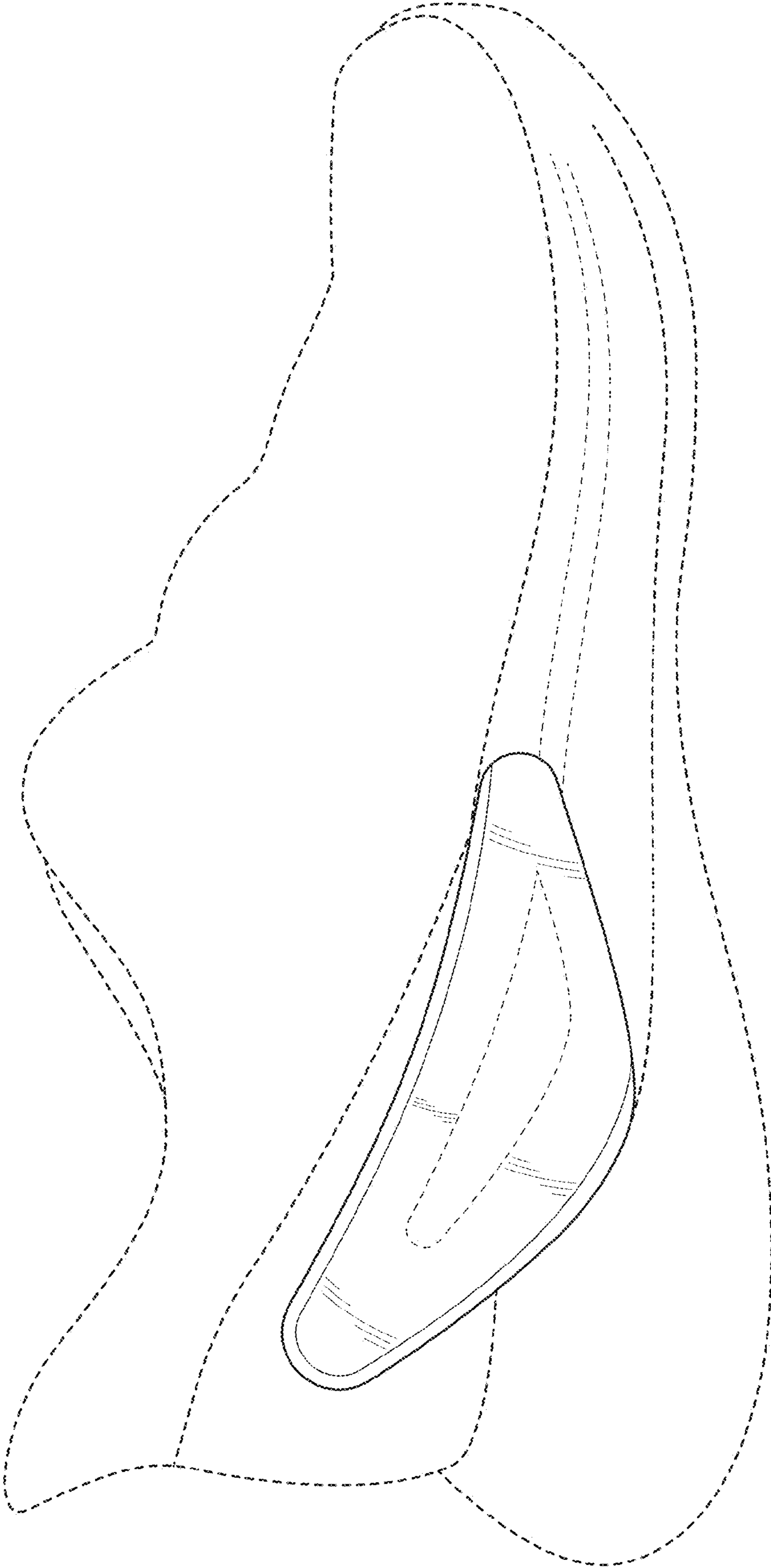

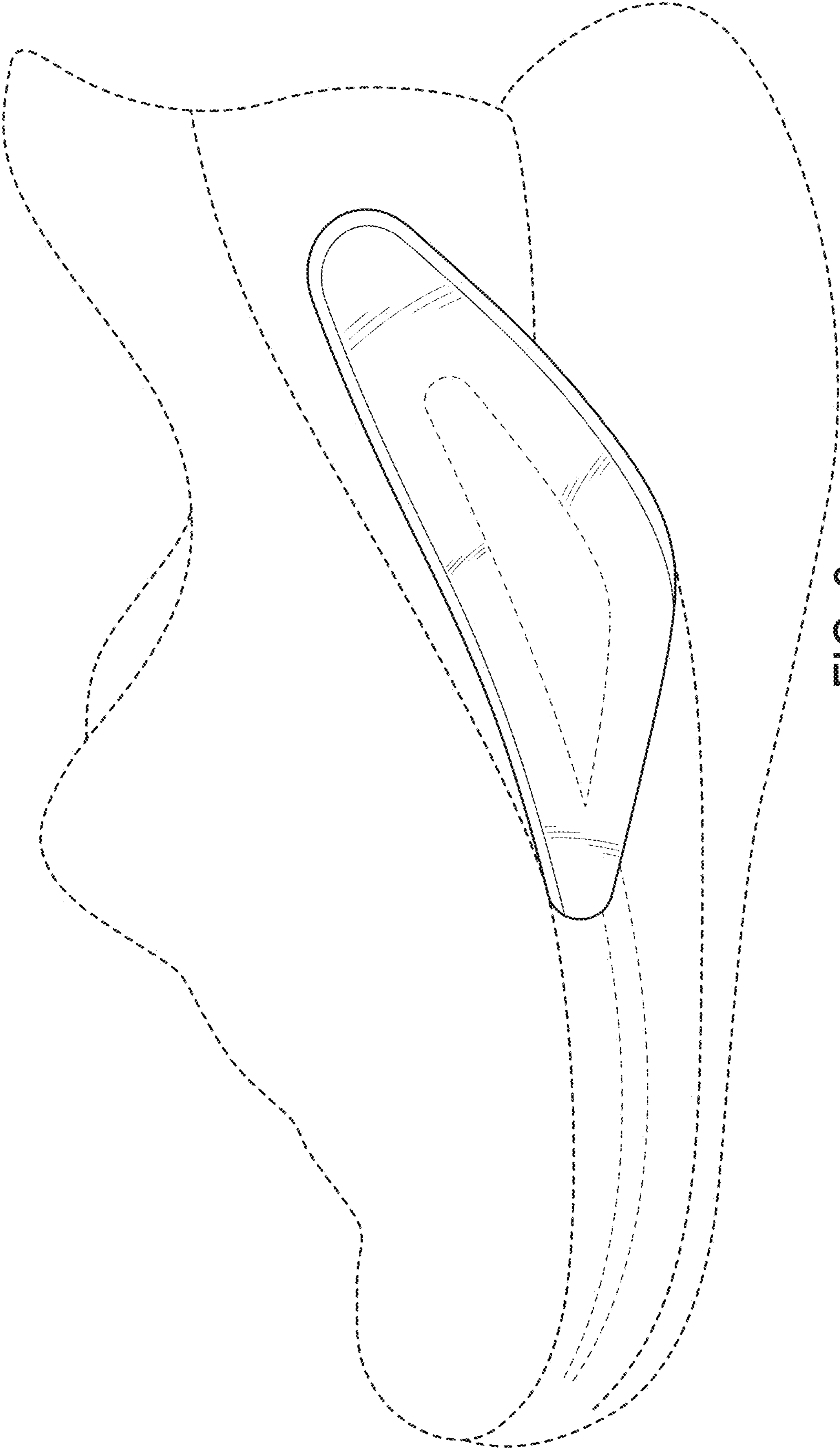

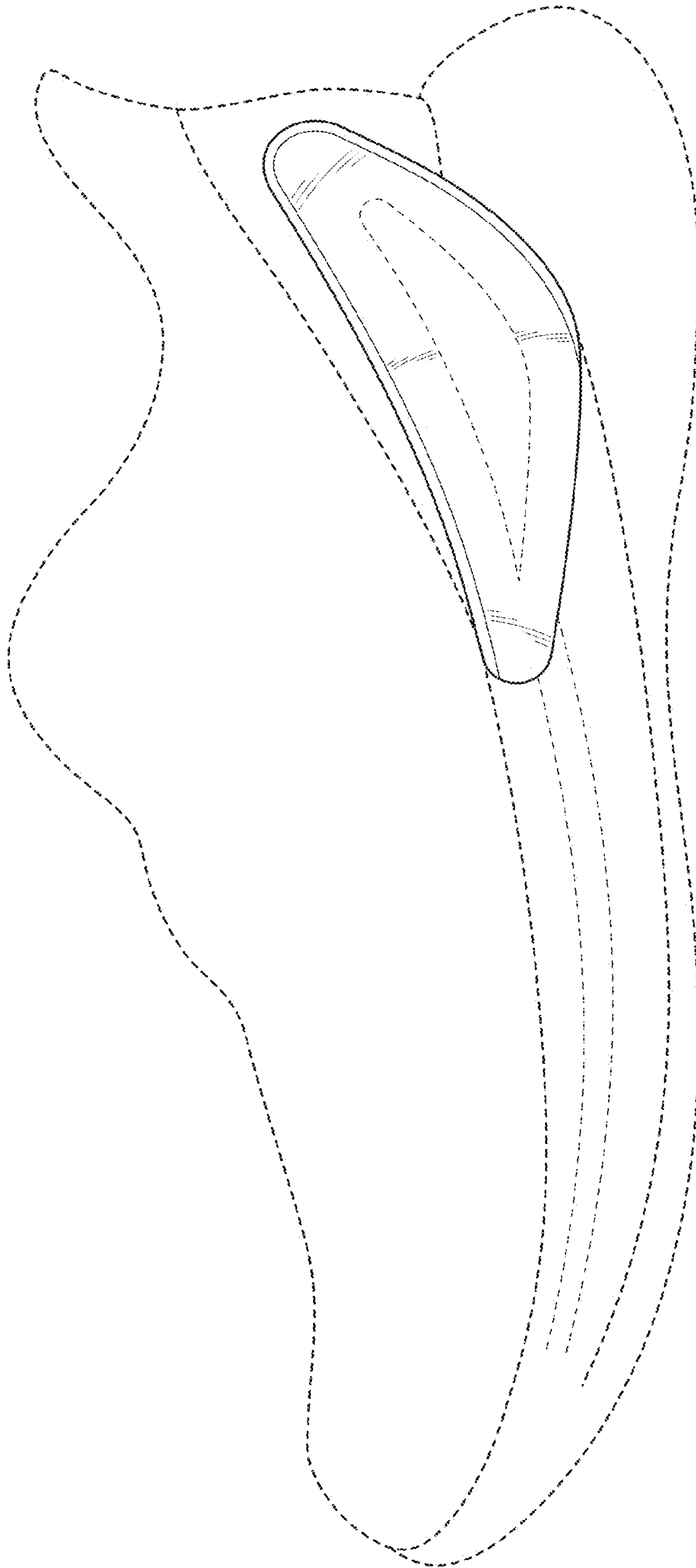

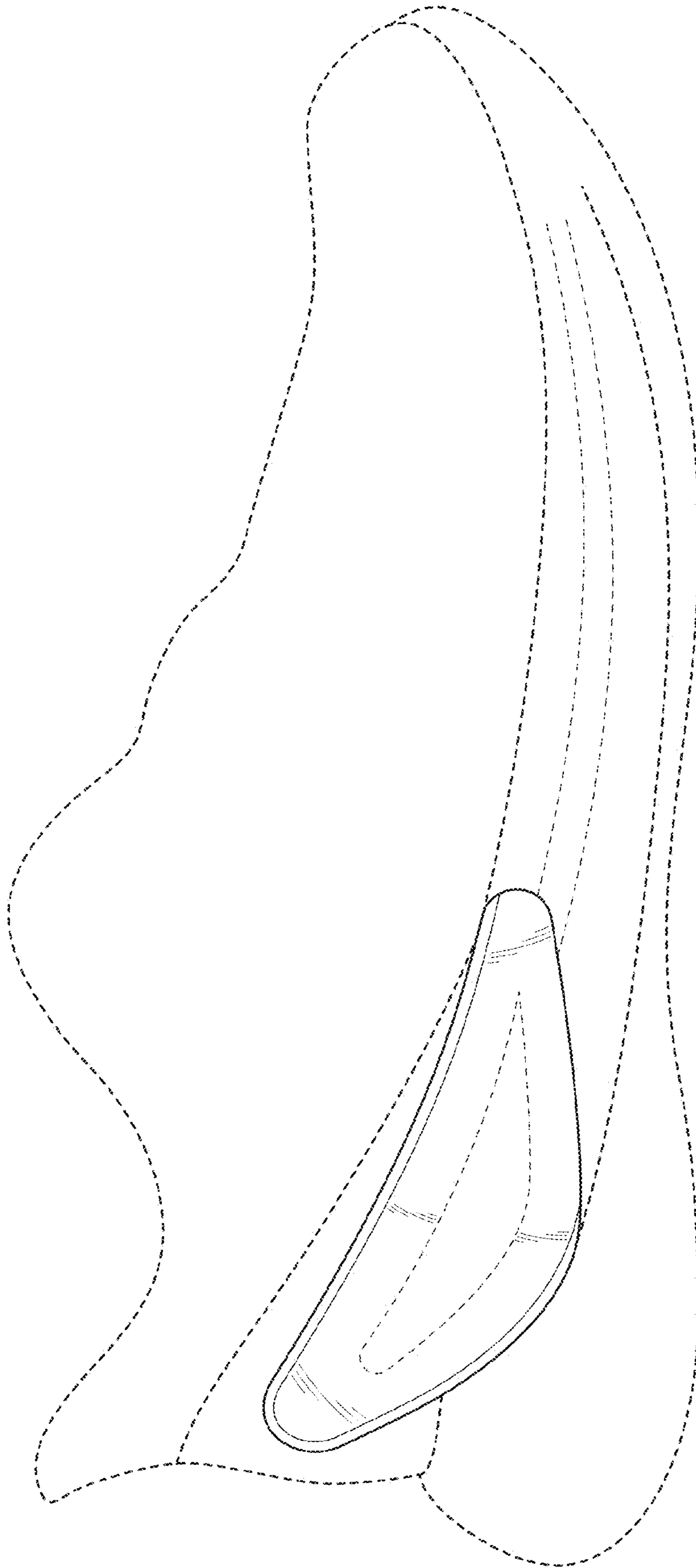

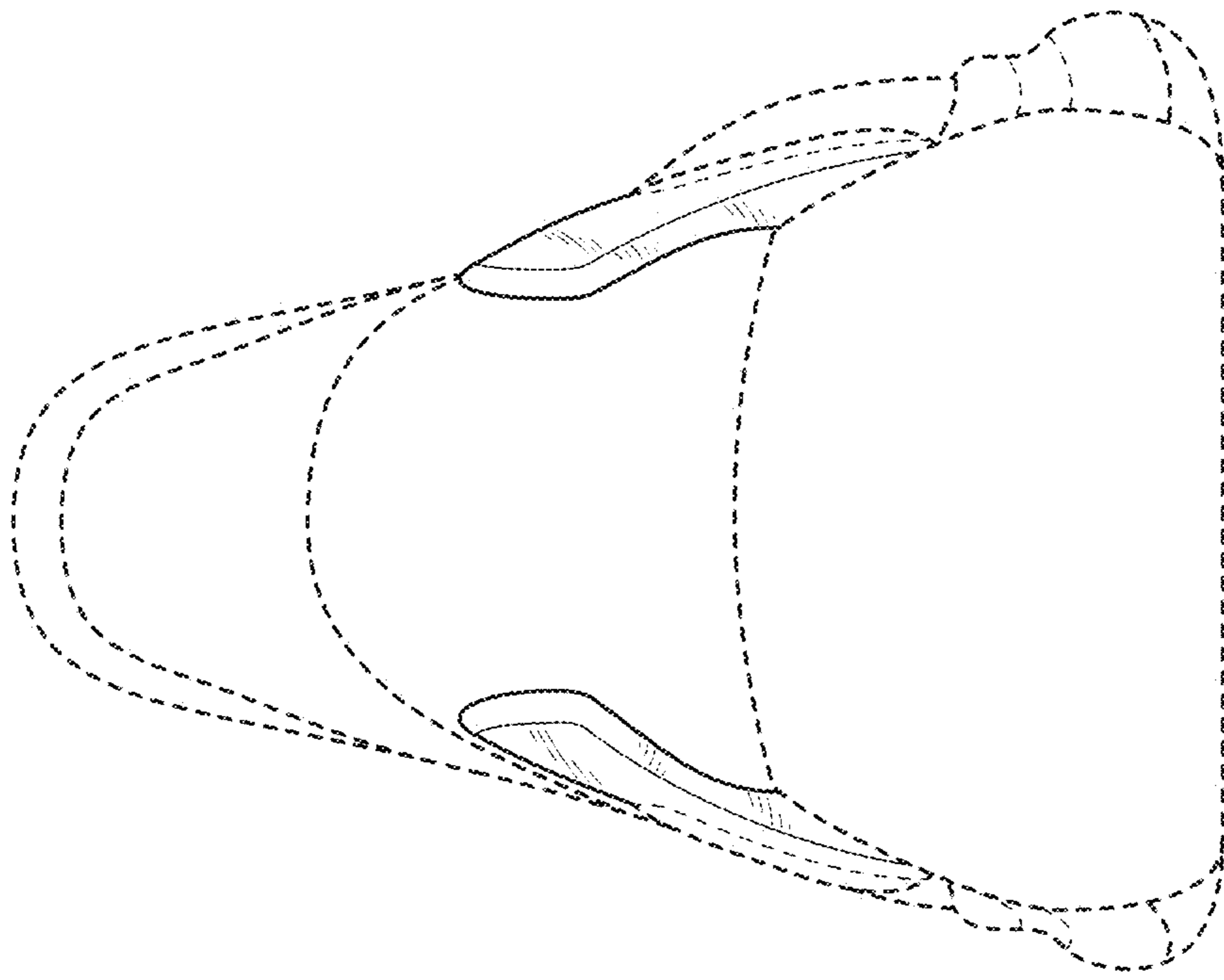

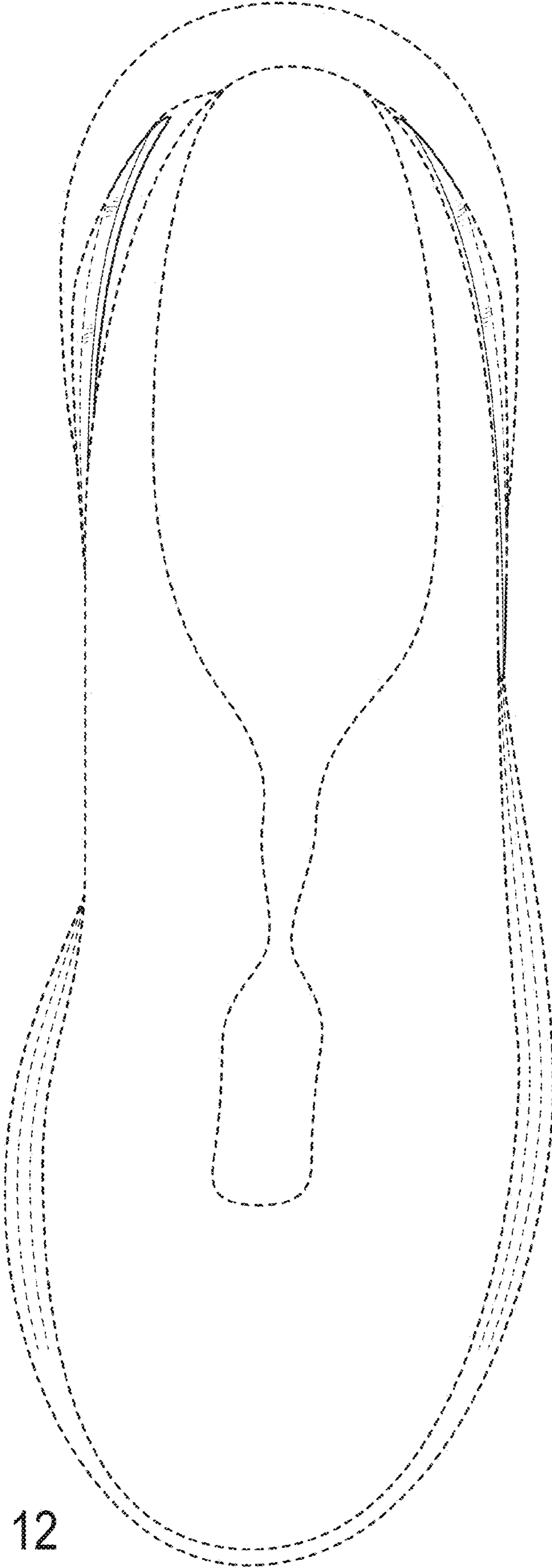
