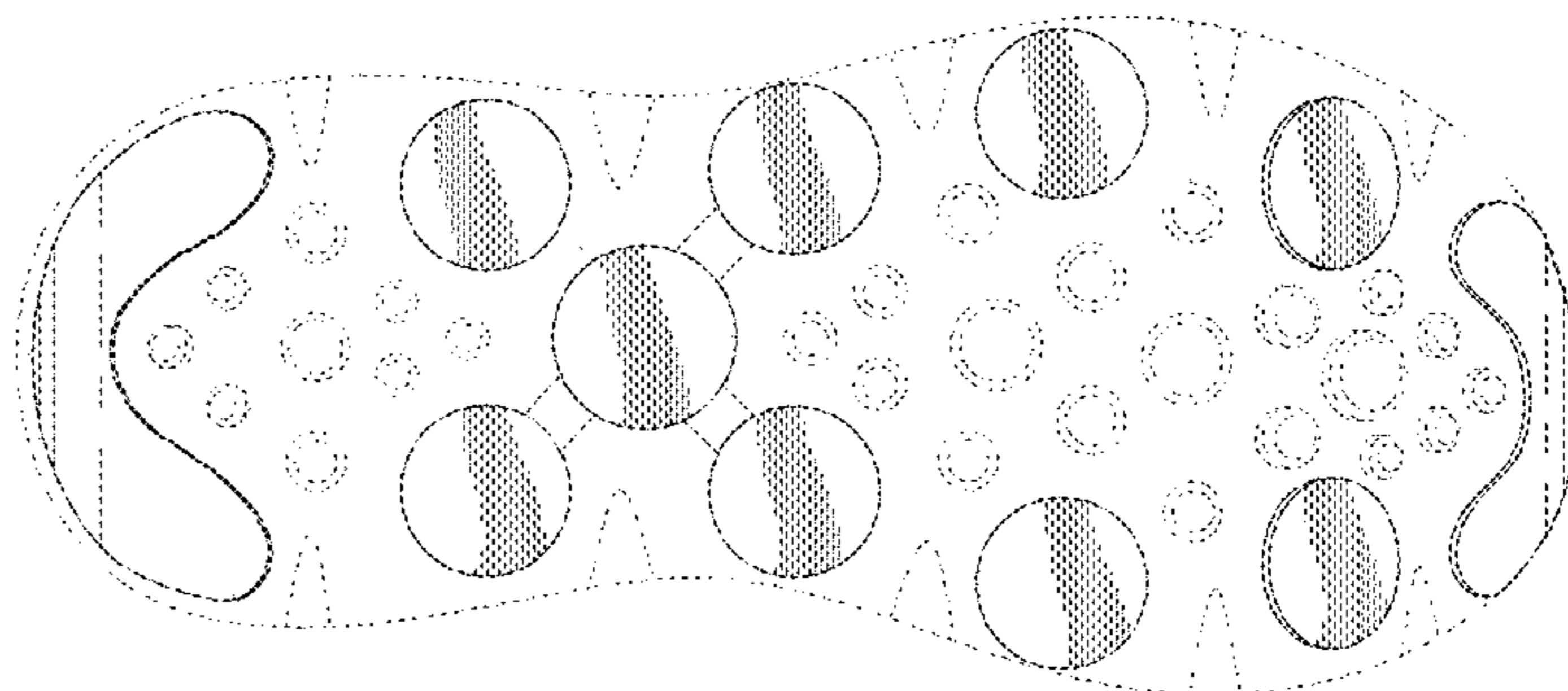
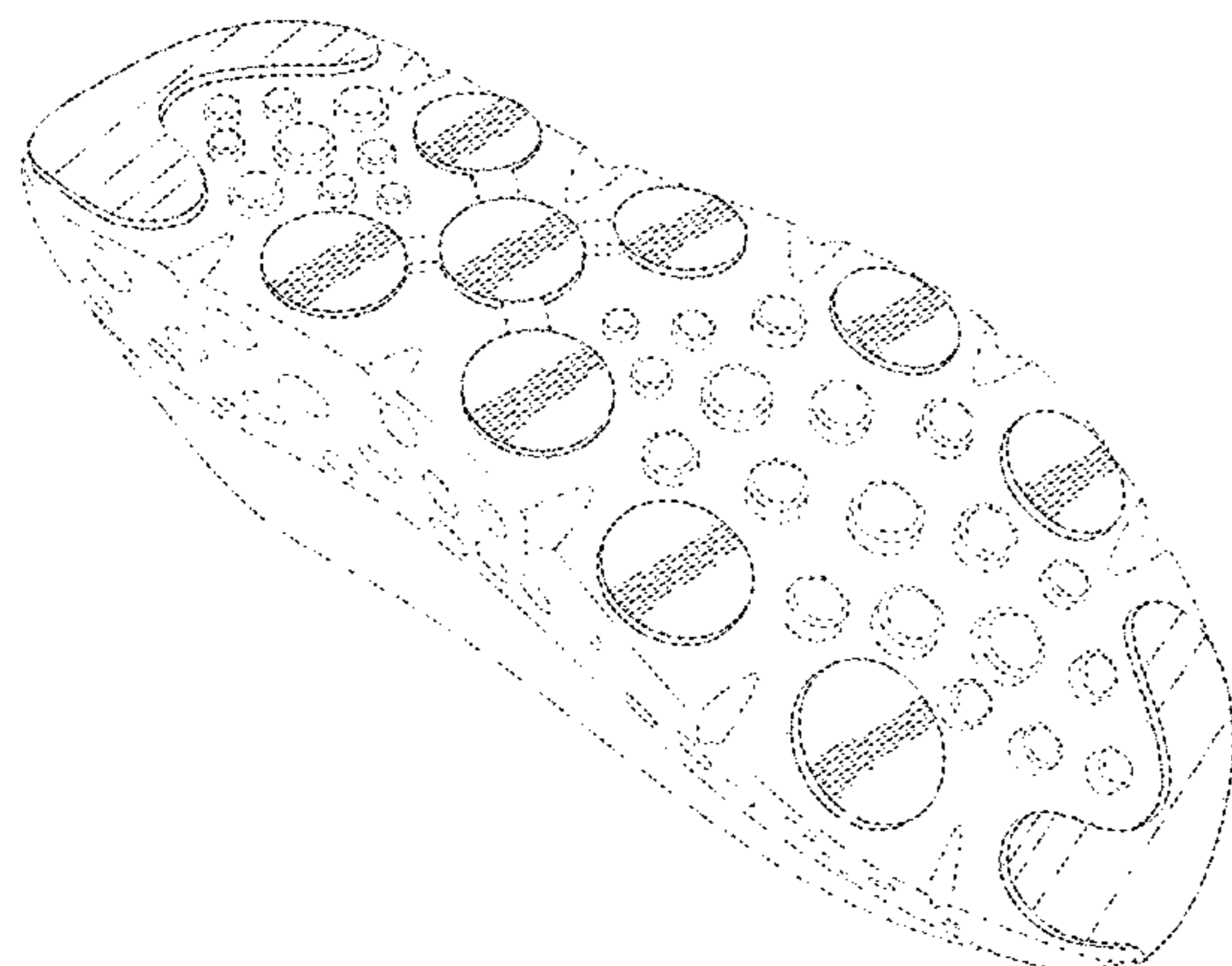
The ornamental design for a shoe sole, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a shoe sole in accordance with my new design;  
FIG. 2 is a left side elevation view thereof;  
FIG. 3 is a right side elevation view thereof;  
FIG. 4 is a rear elevation view thereof;  
FIG. 5 is a front elevation view thereof;  
FIG. 6 is a top plan view thereof; and,  
FIG. 7 is a bottom plan view thereof.

The broken lines shown in the drawings represent portions of the shoe sole and environmental structure in the form of a shoe upper and midsole that form no part of the claimed design. The surfaces devoid of shading lines form no part of the claimed design.

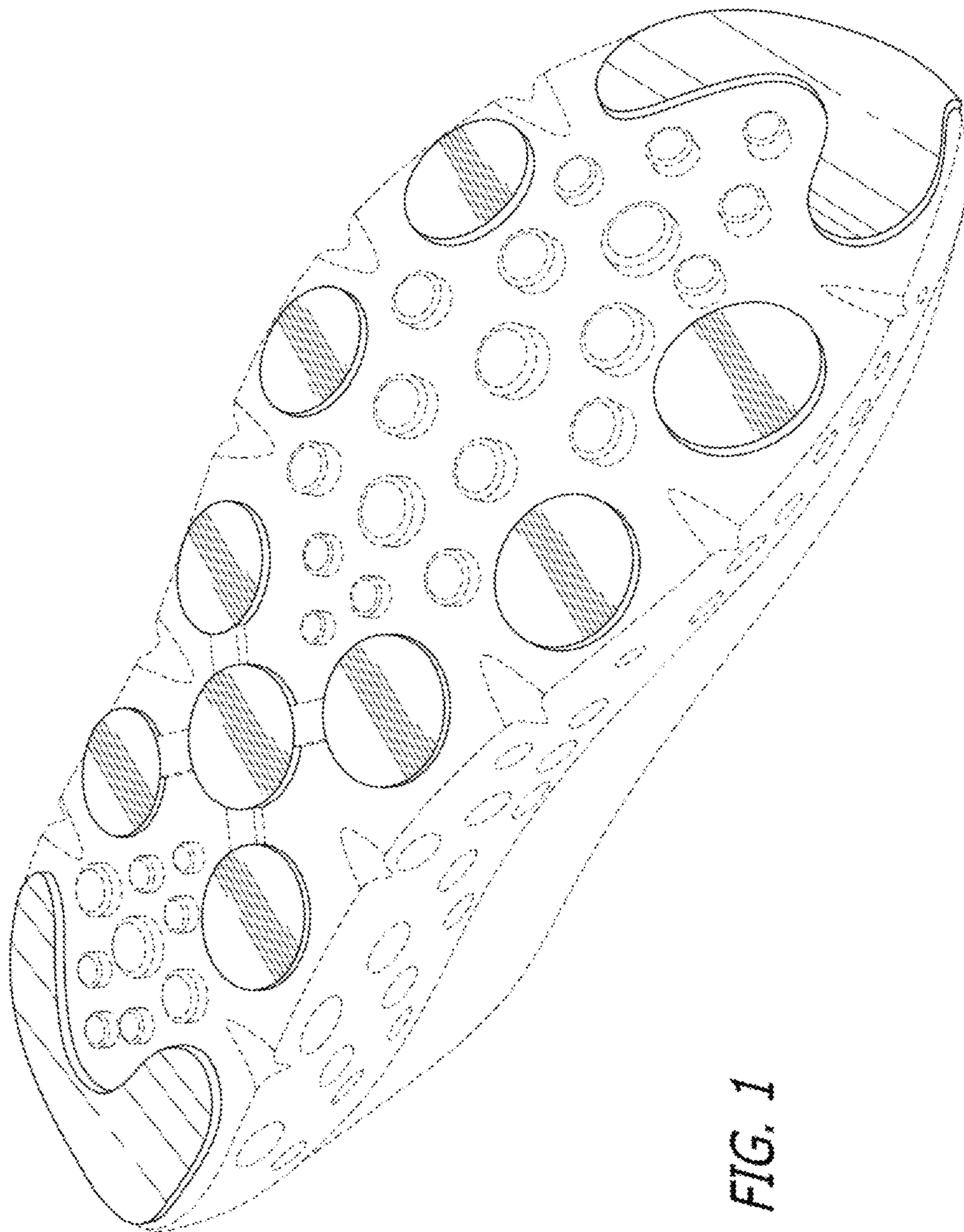

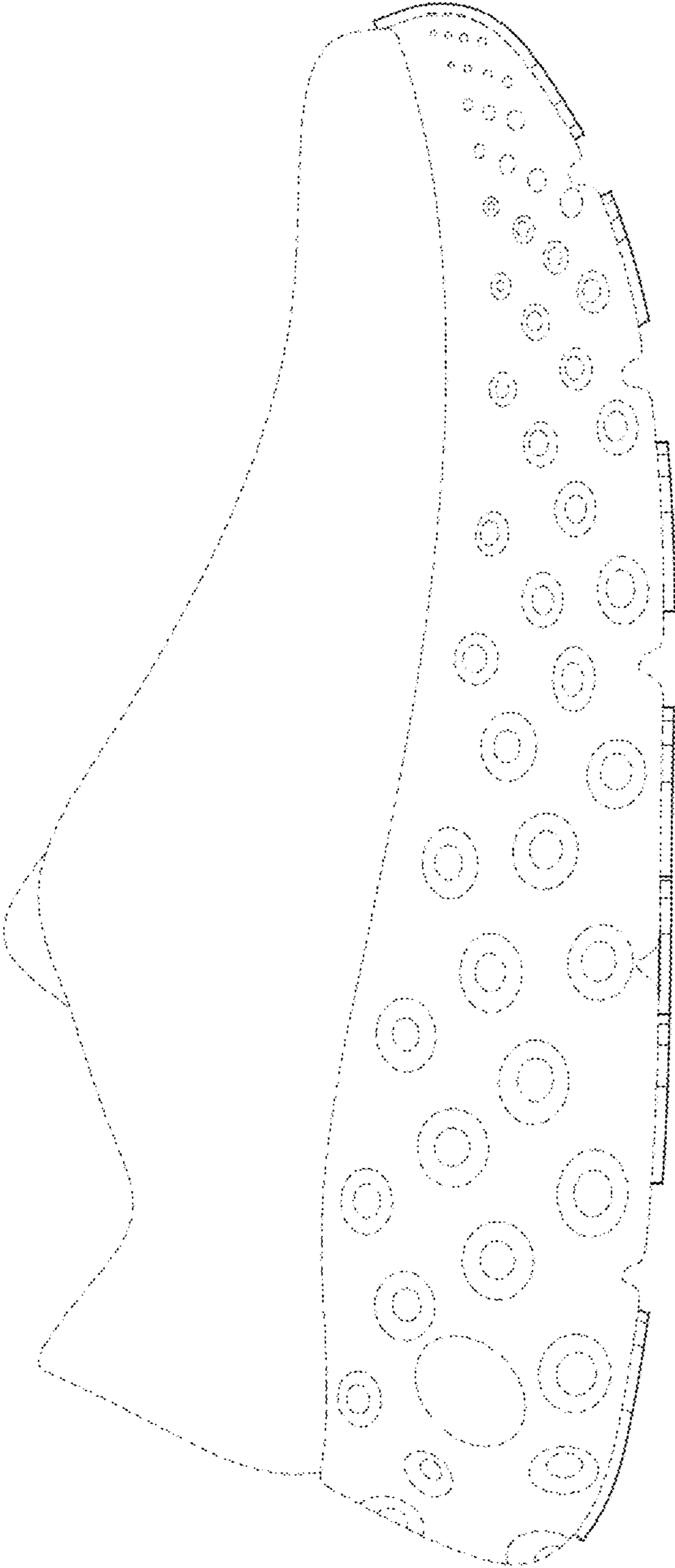

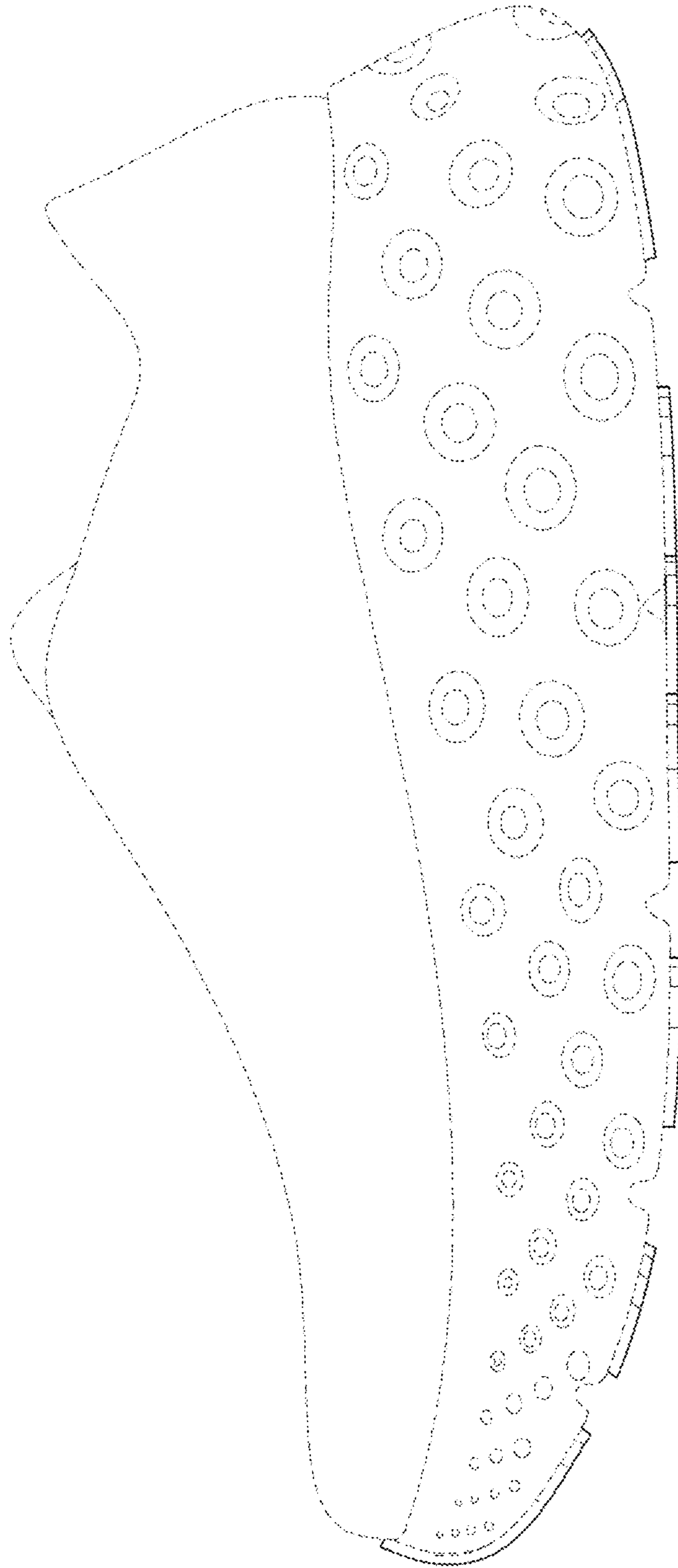

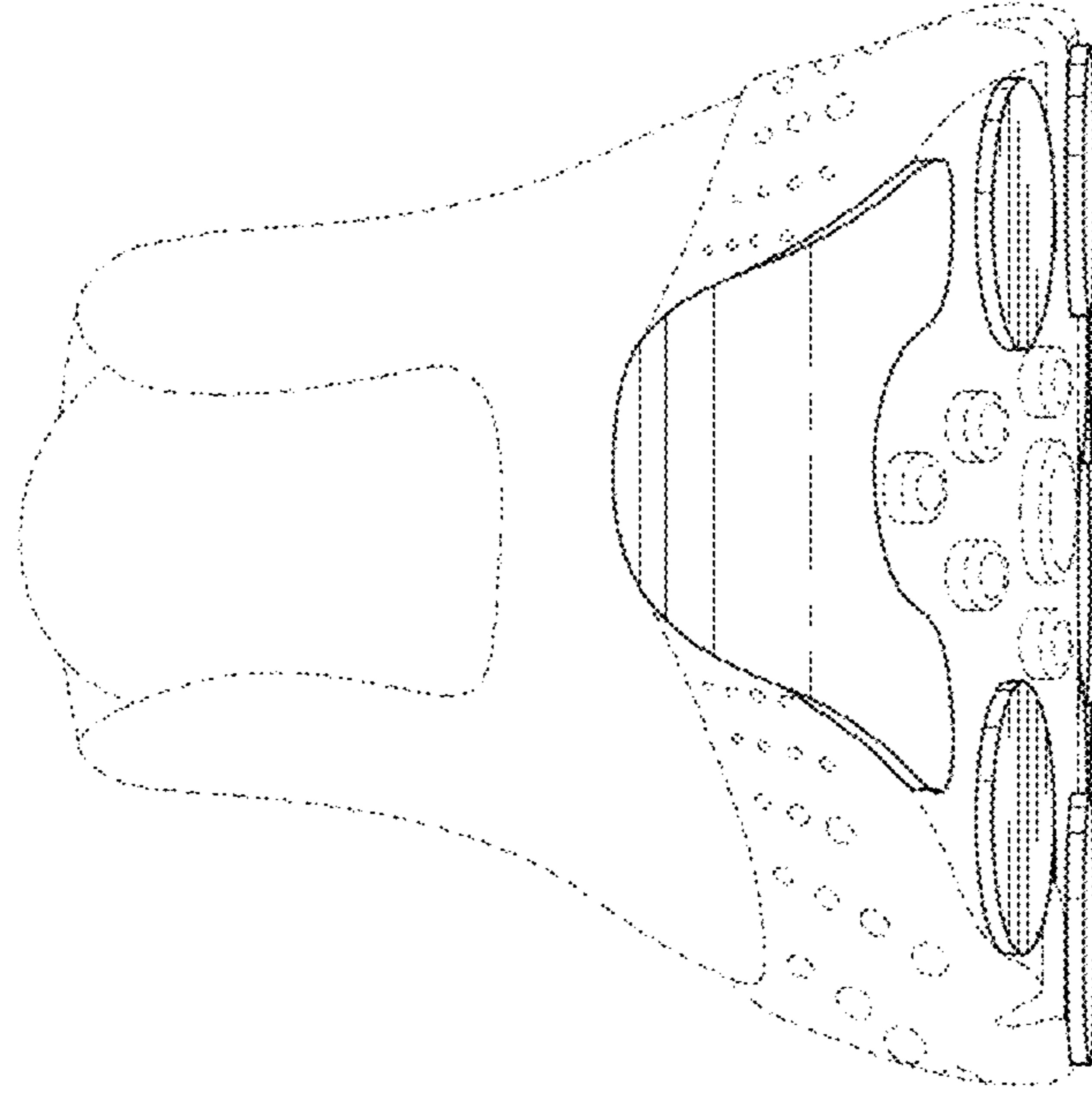

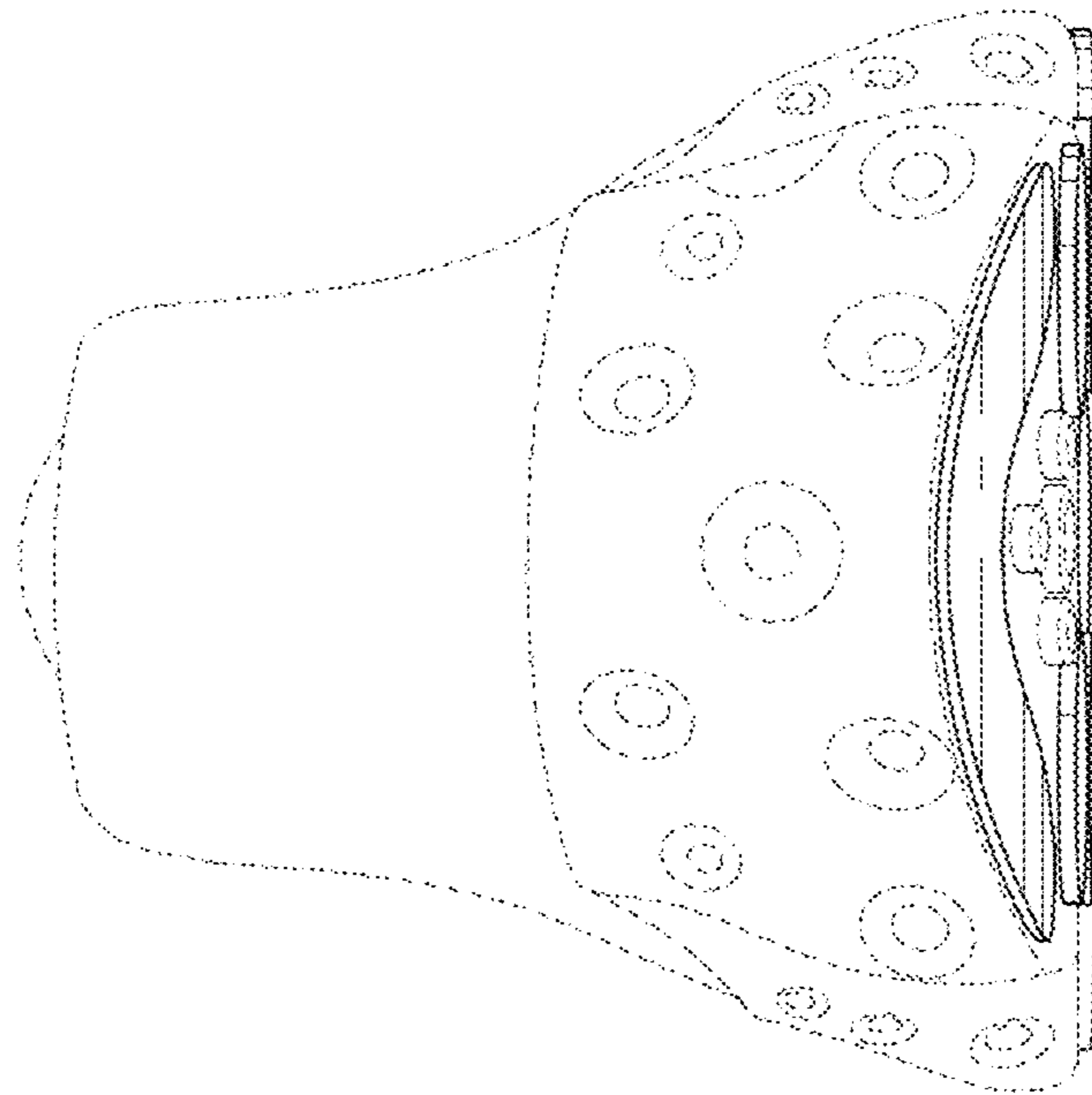

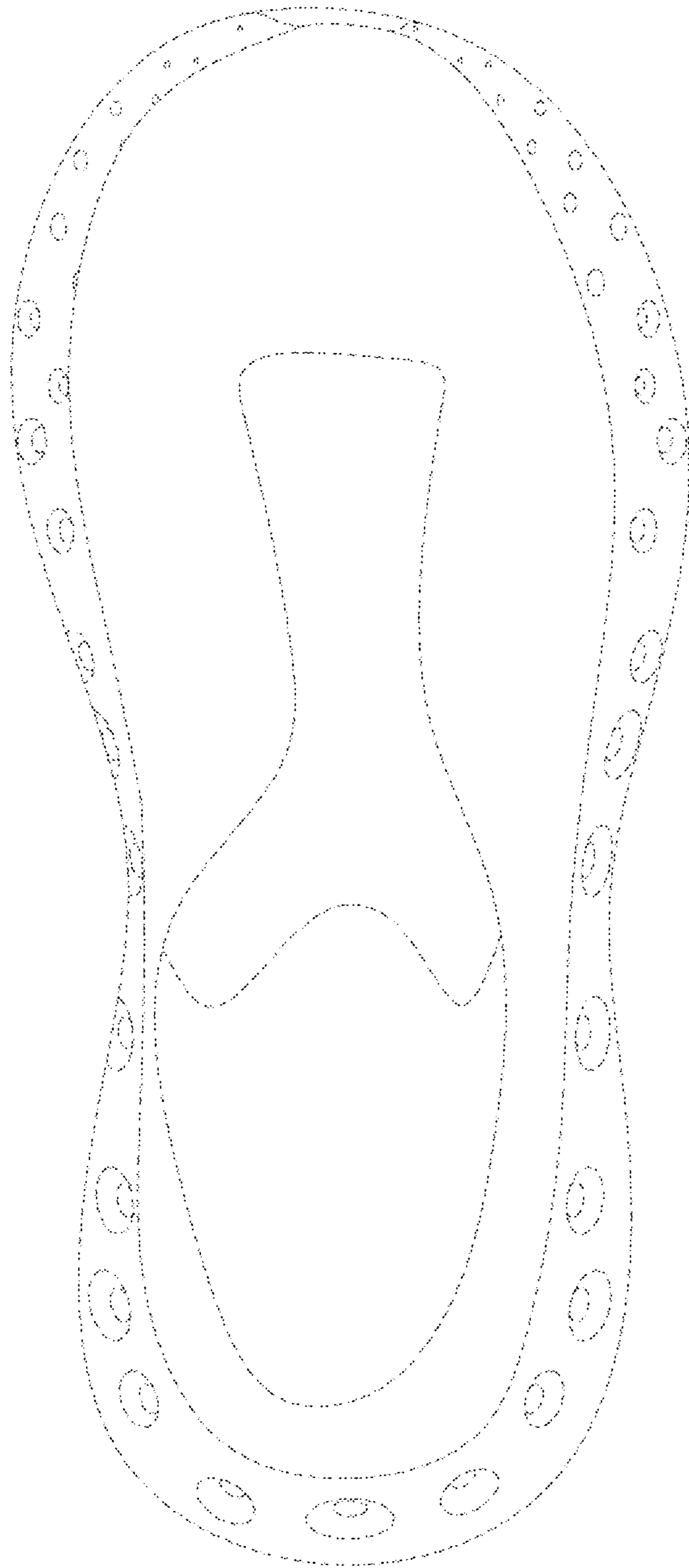

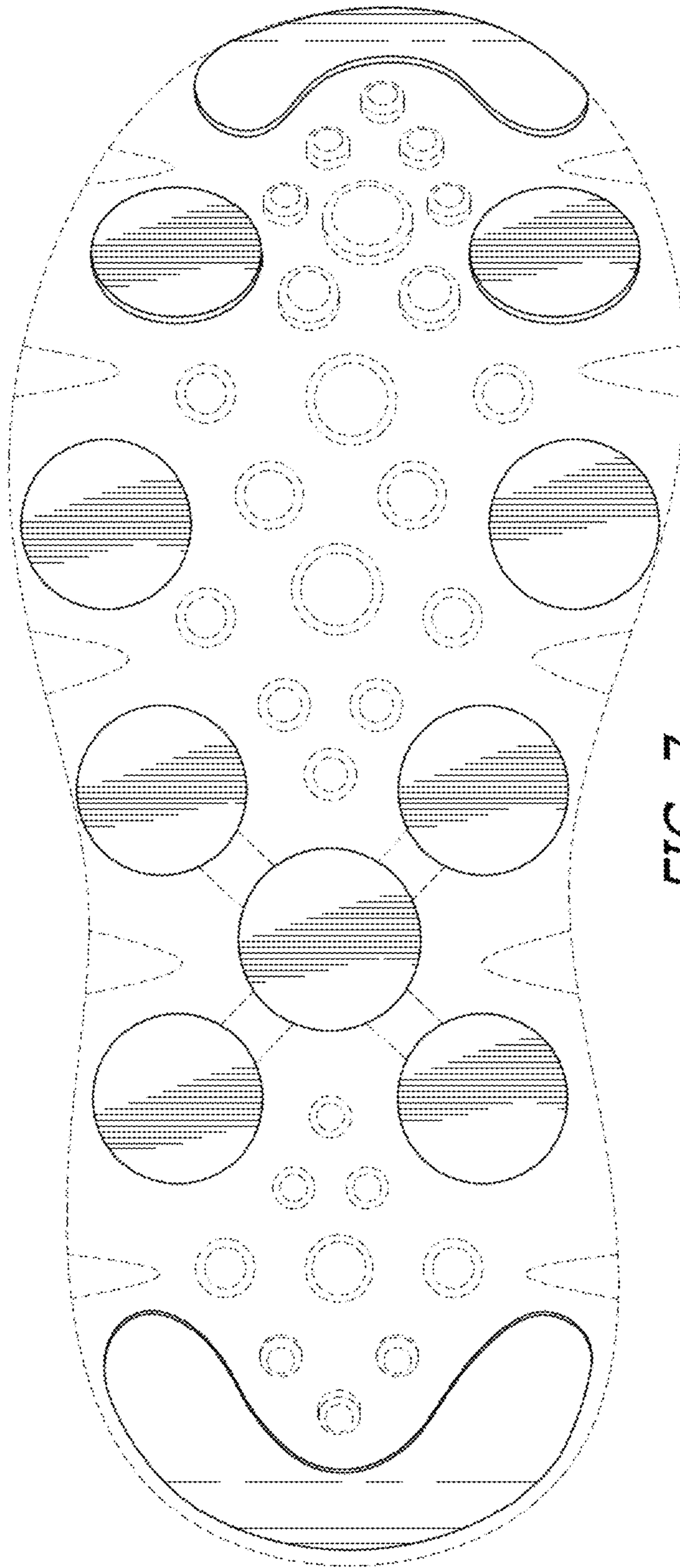
