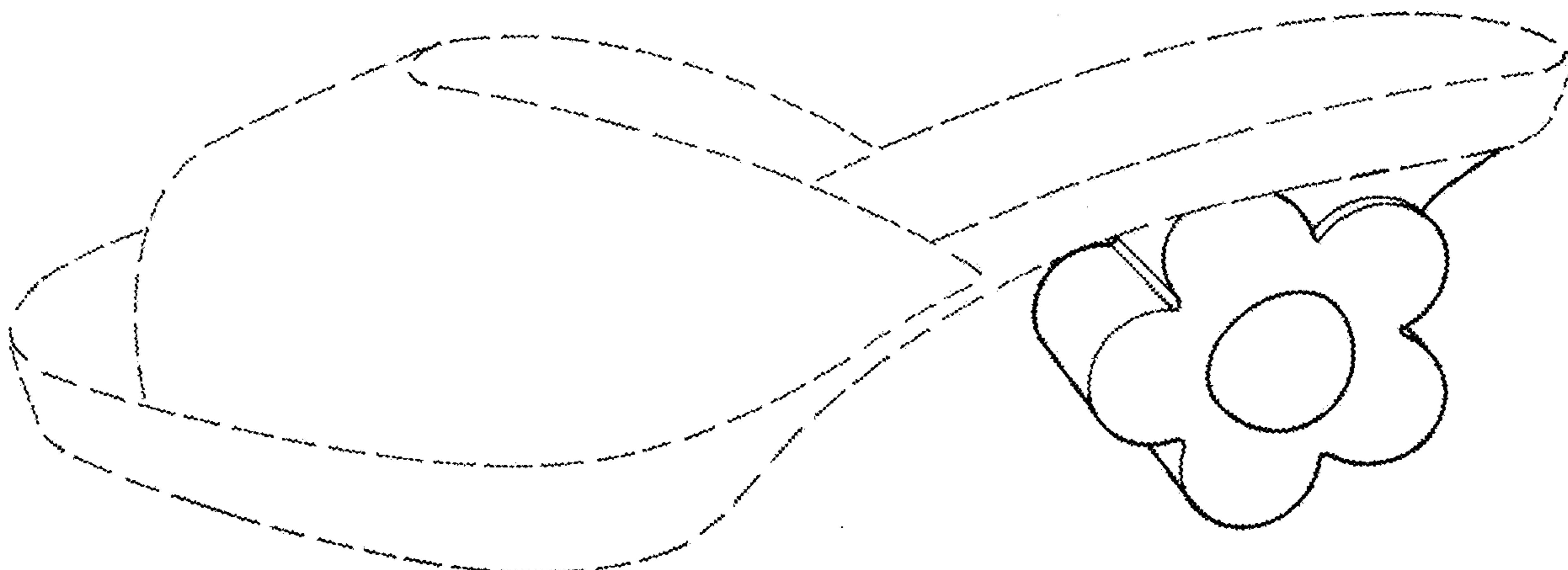
(57) **CLAIM**

**1.7** is a rear view thereof.

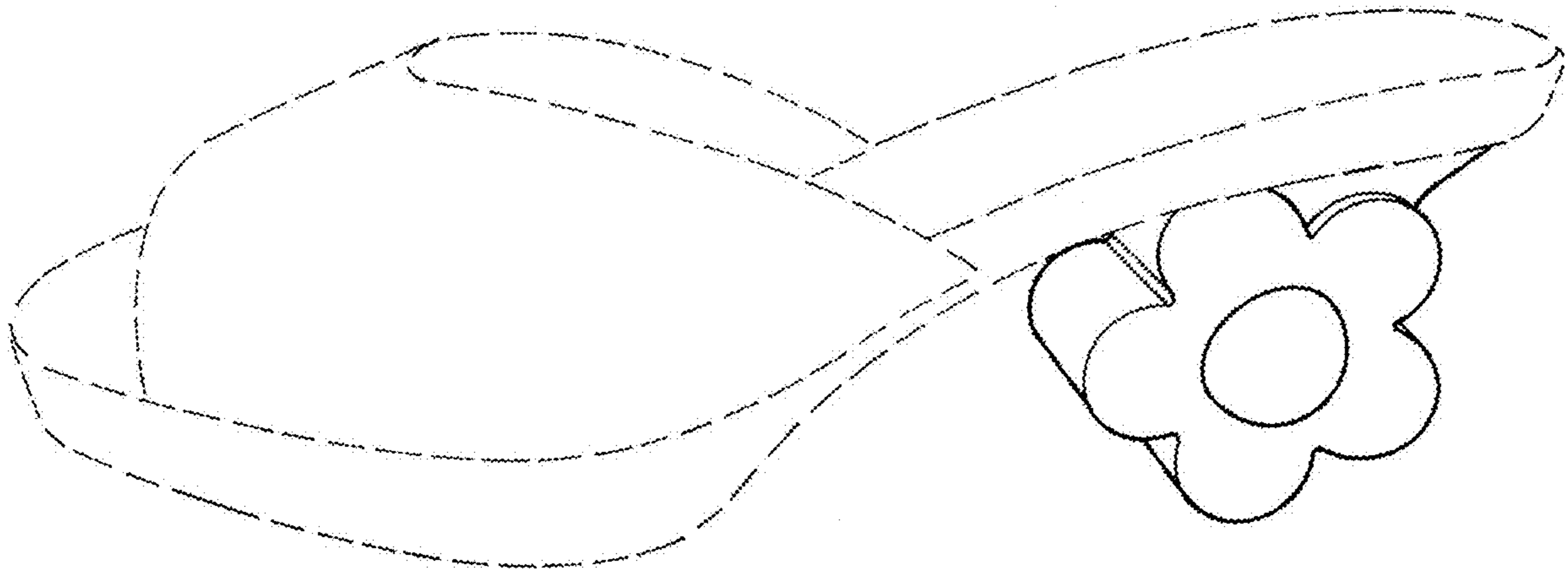

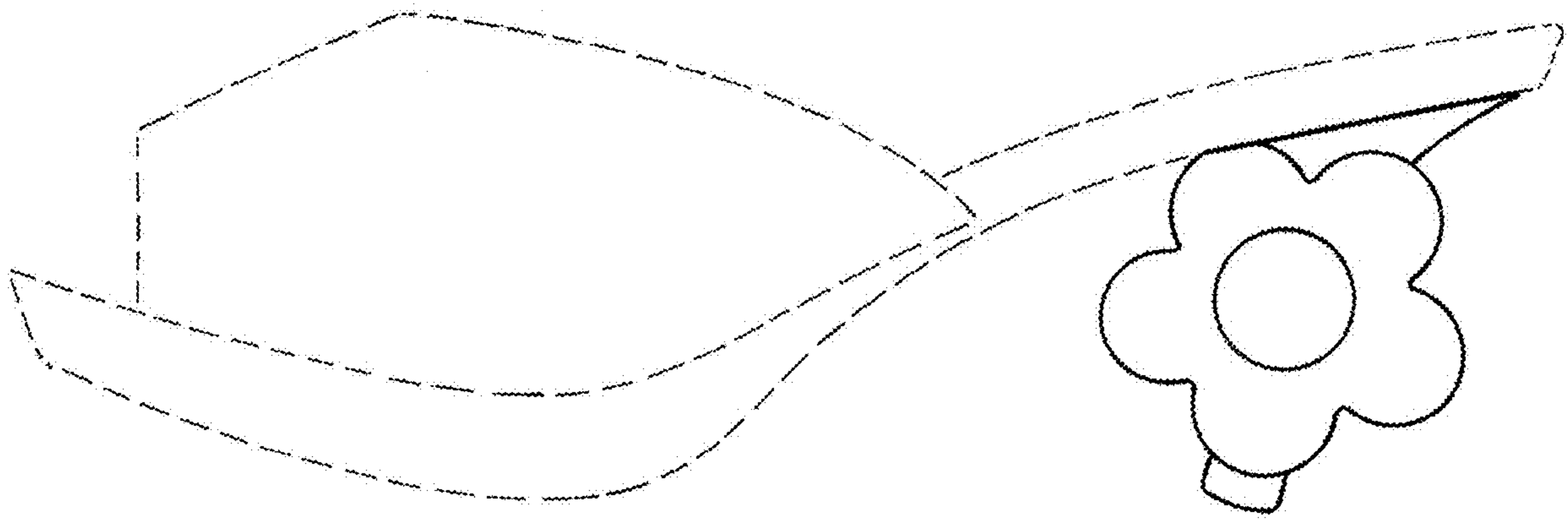
The broken lines shown are for the purpose of illustrating the environmental structure and forms no part of the claimed design.

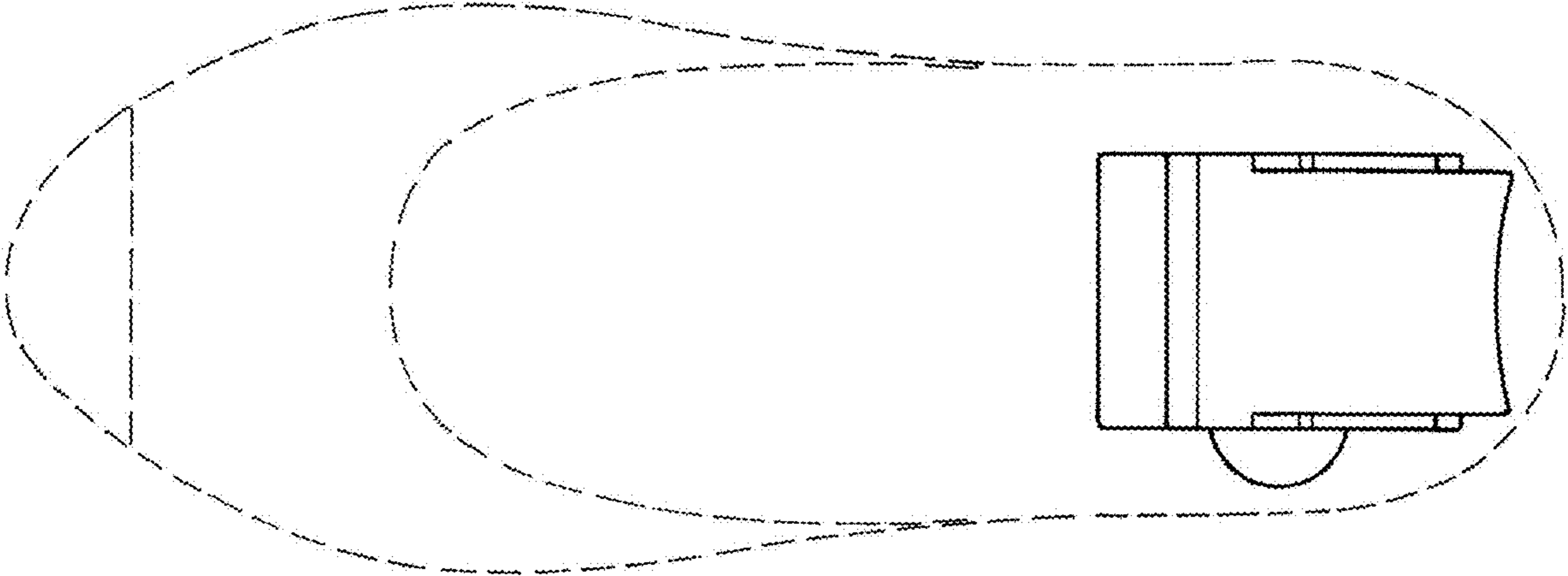

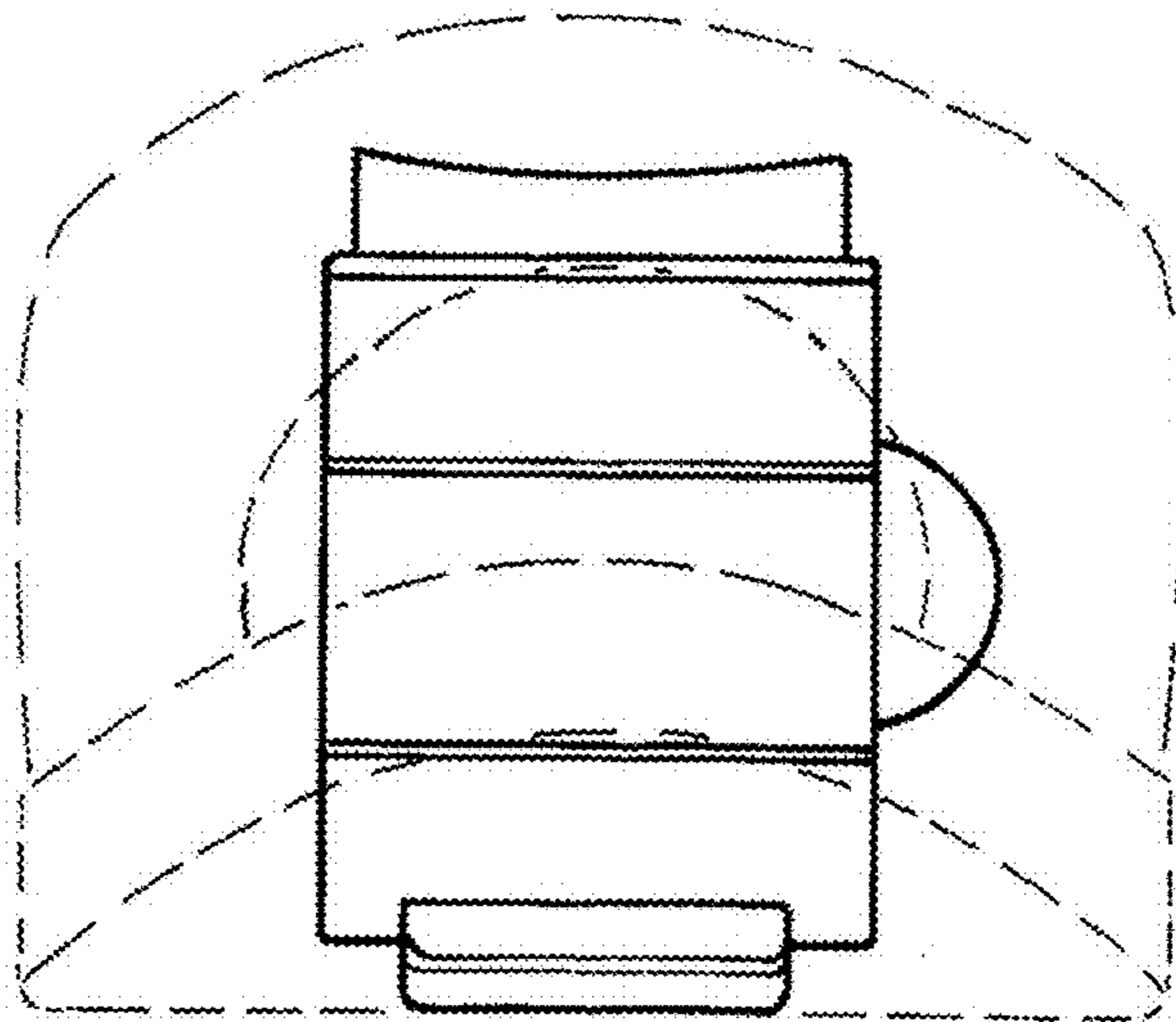

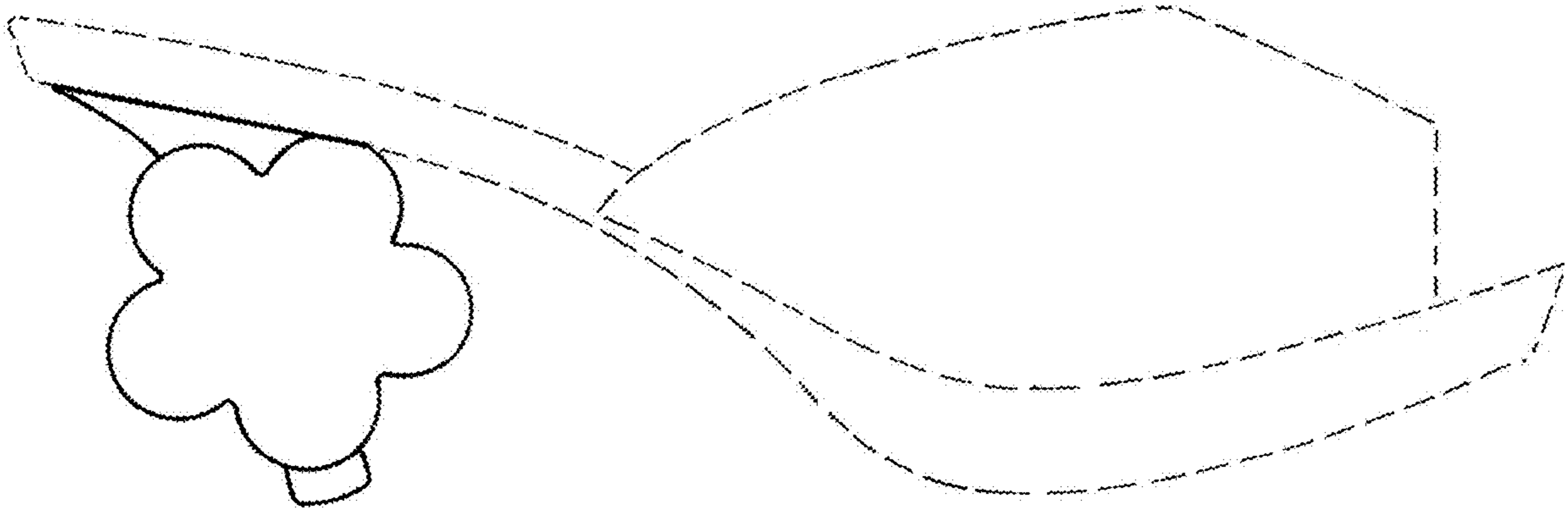

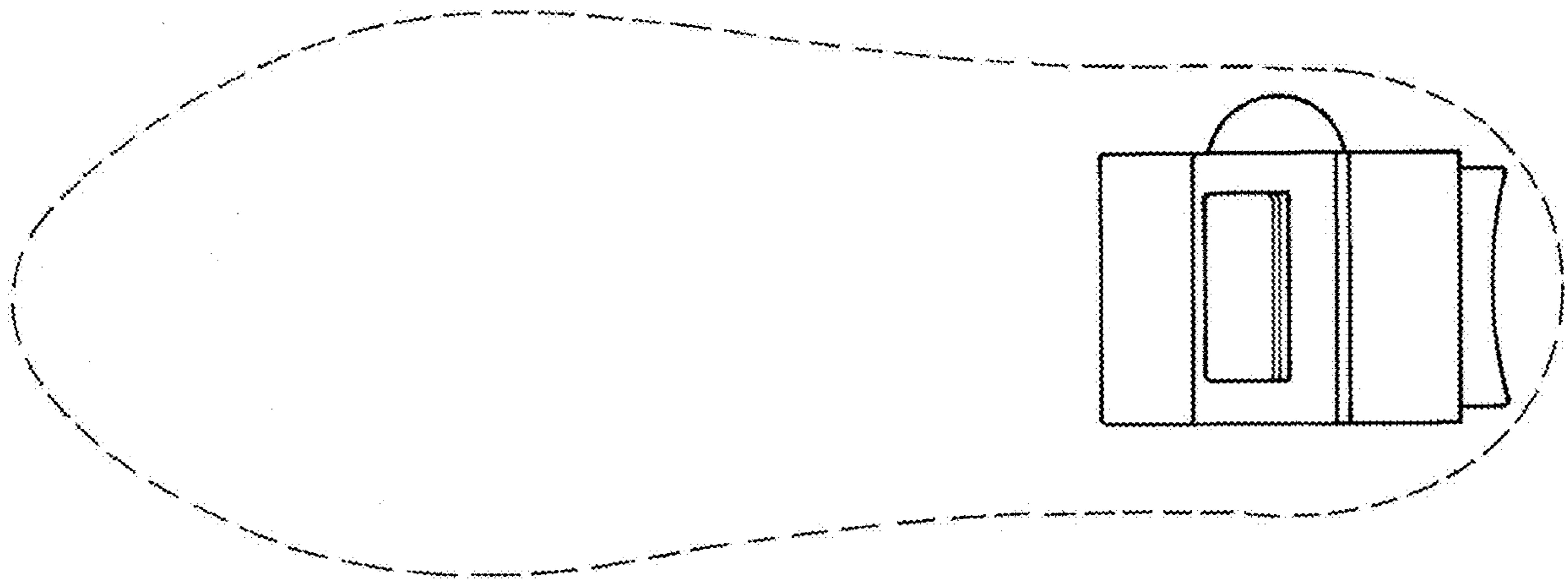
