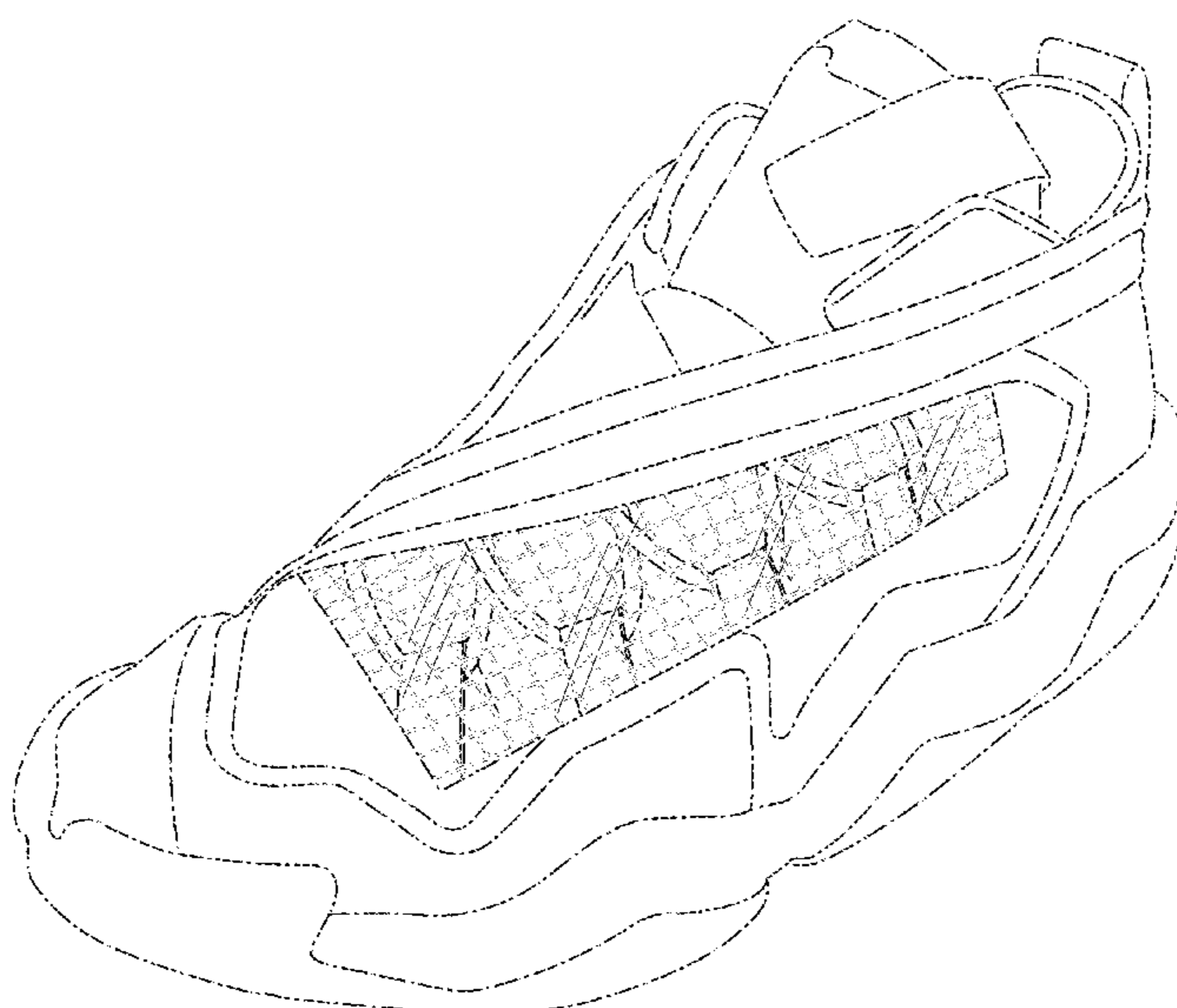
(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe showing my new design with an overlapping mesh panel;
FIG. 2 is a side view thereof;
FIG. 3 is a rear perspective view thereof;
FIG. 4 is a front perspective view of the shoe shown in FIGS. 1-3 showing my new design with surface shading and omitting the disclaimed mesh grid appearance for clarity purposes;
FIG. 5 is a side view thereof; and,
FIG. 6 is a rear perspective view thereof.
In FIGS. 1-3 the grid pattern on the mesh overlay shown in broken lines forms no part of the claimed design. The broken lines immediately adjacent to the shaded area define the bounds of the claimed design and form no part thereof. The broken lines depicting the remainder of the shoe form no part of the claimed design.

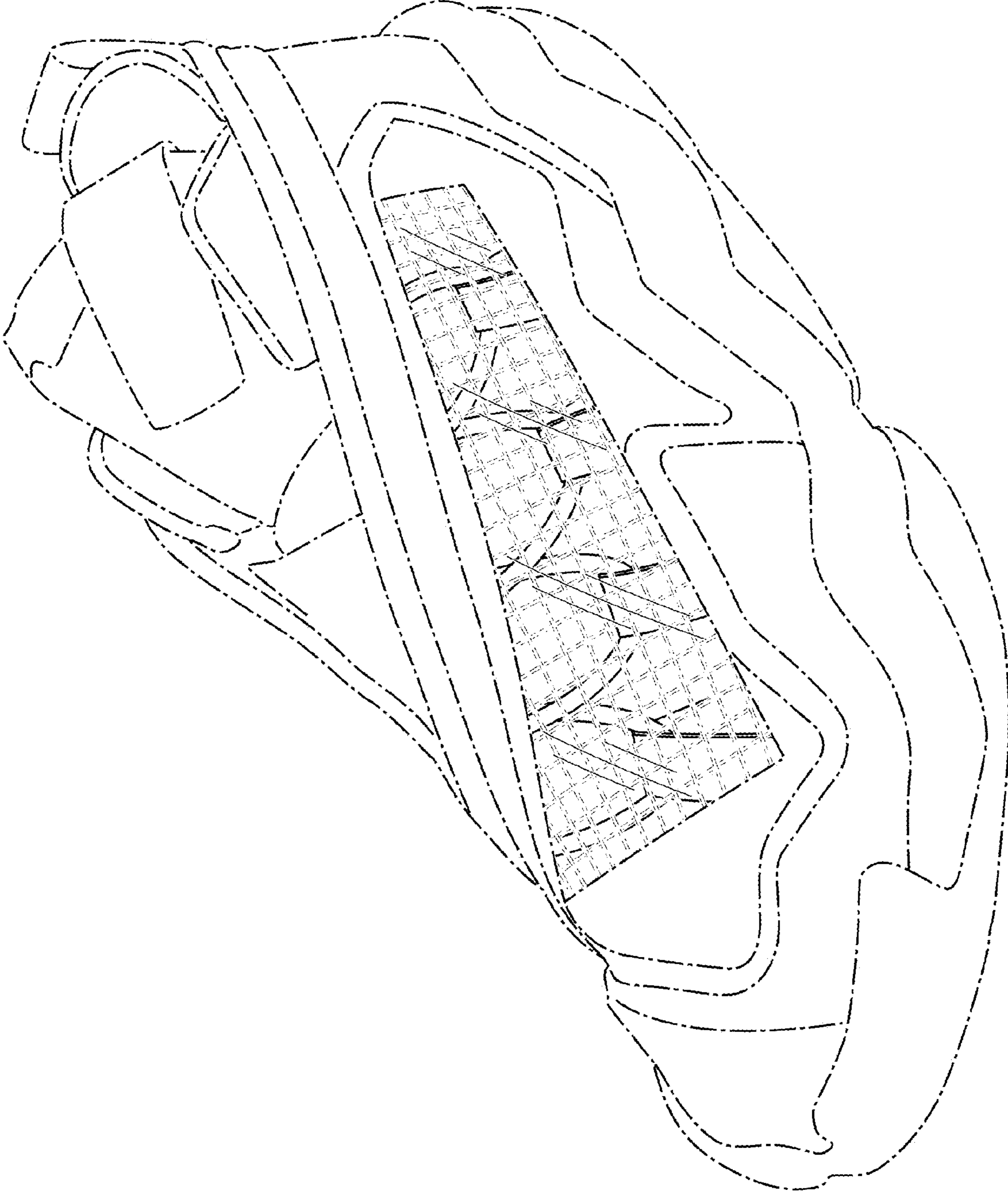

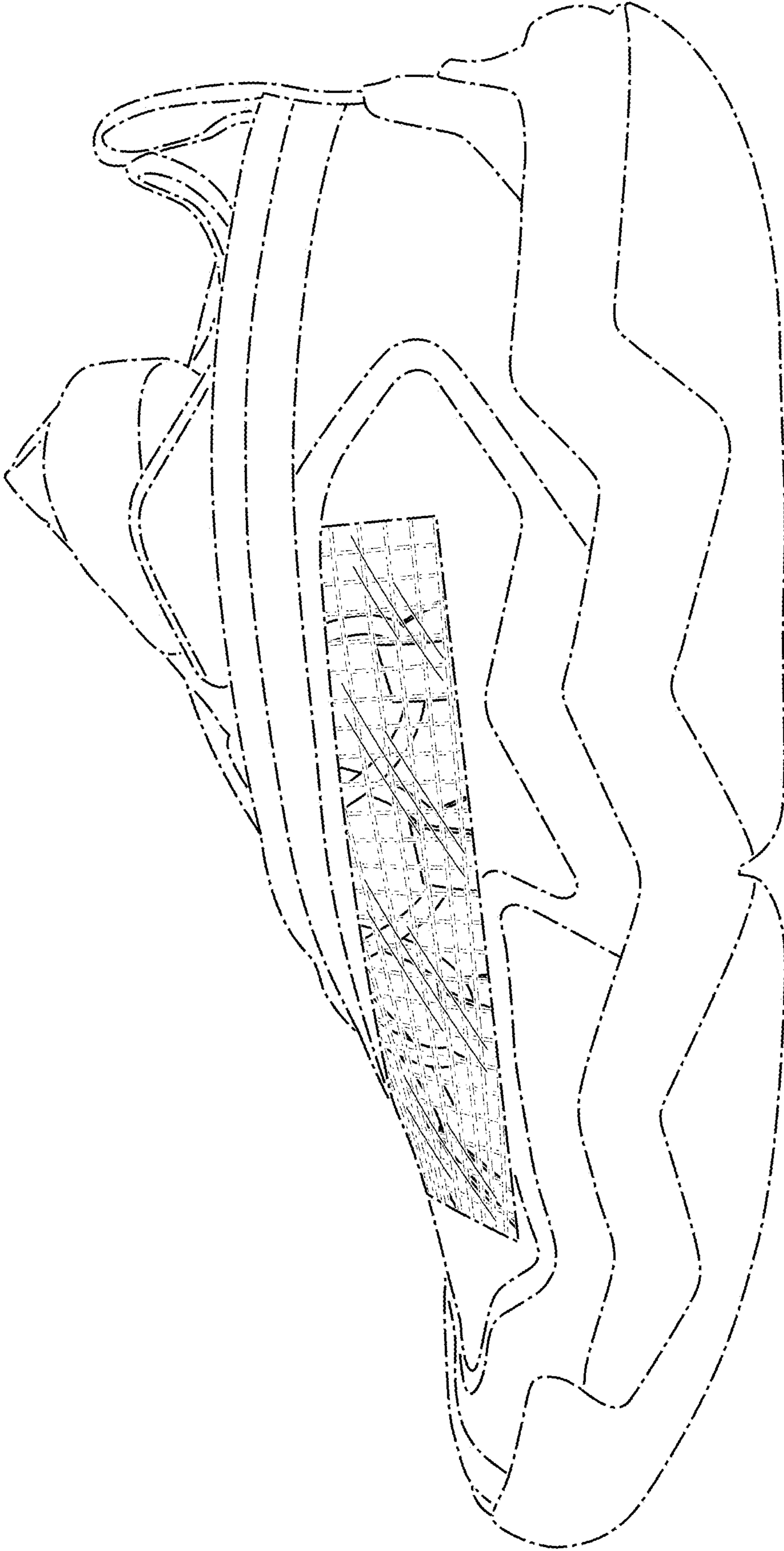

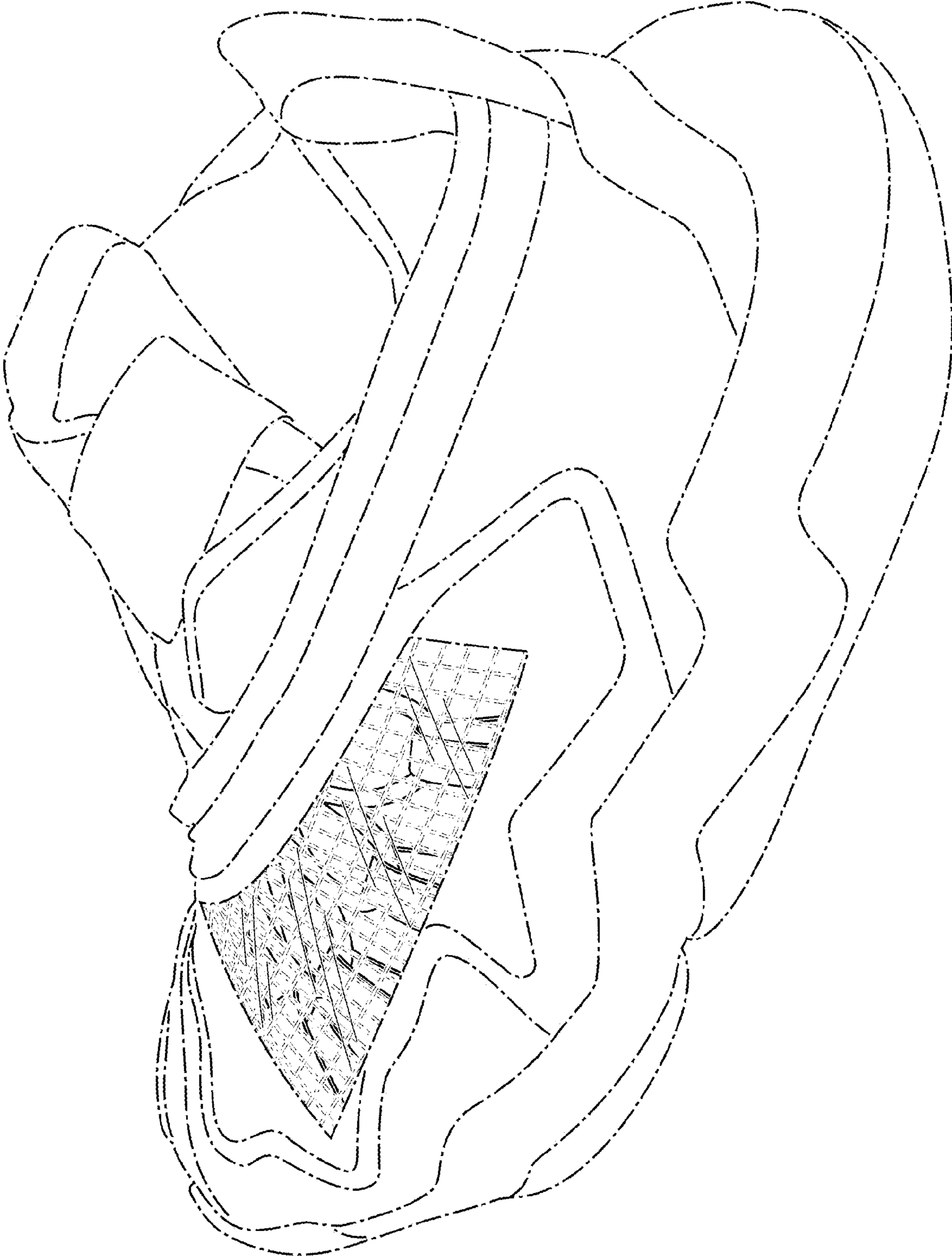

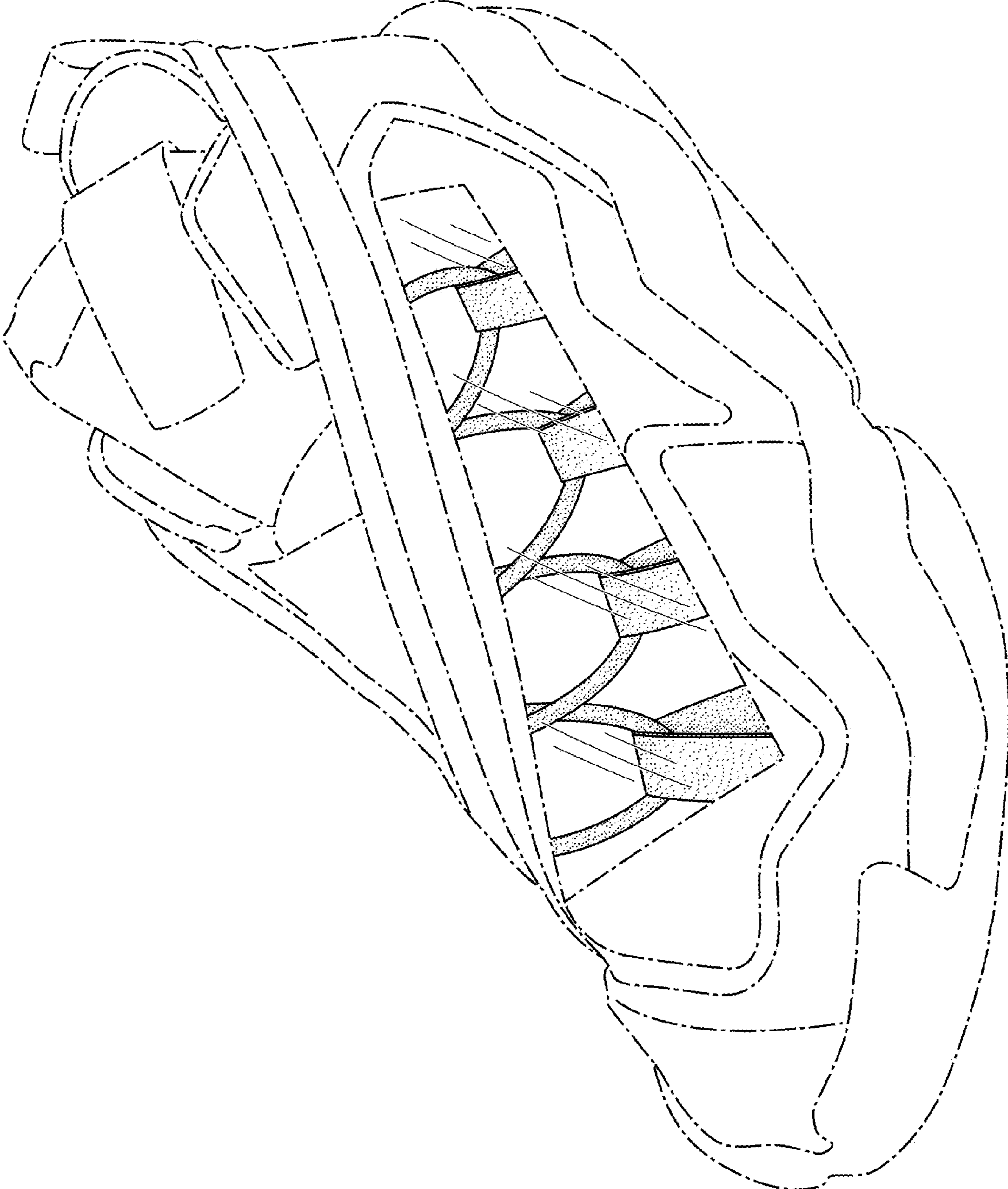

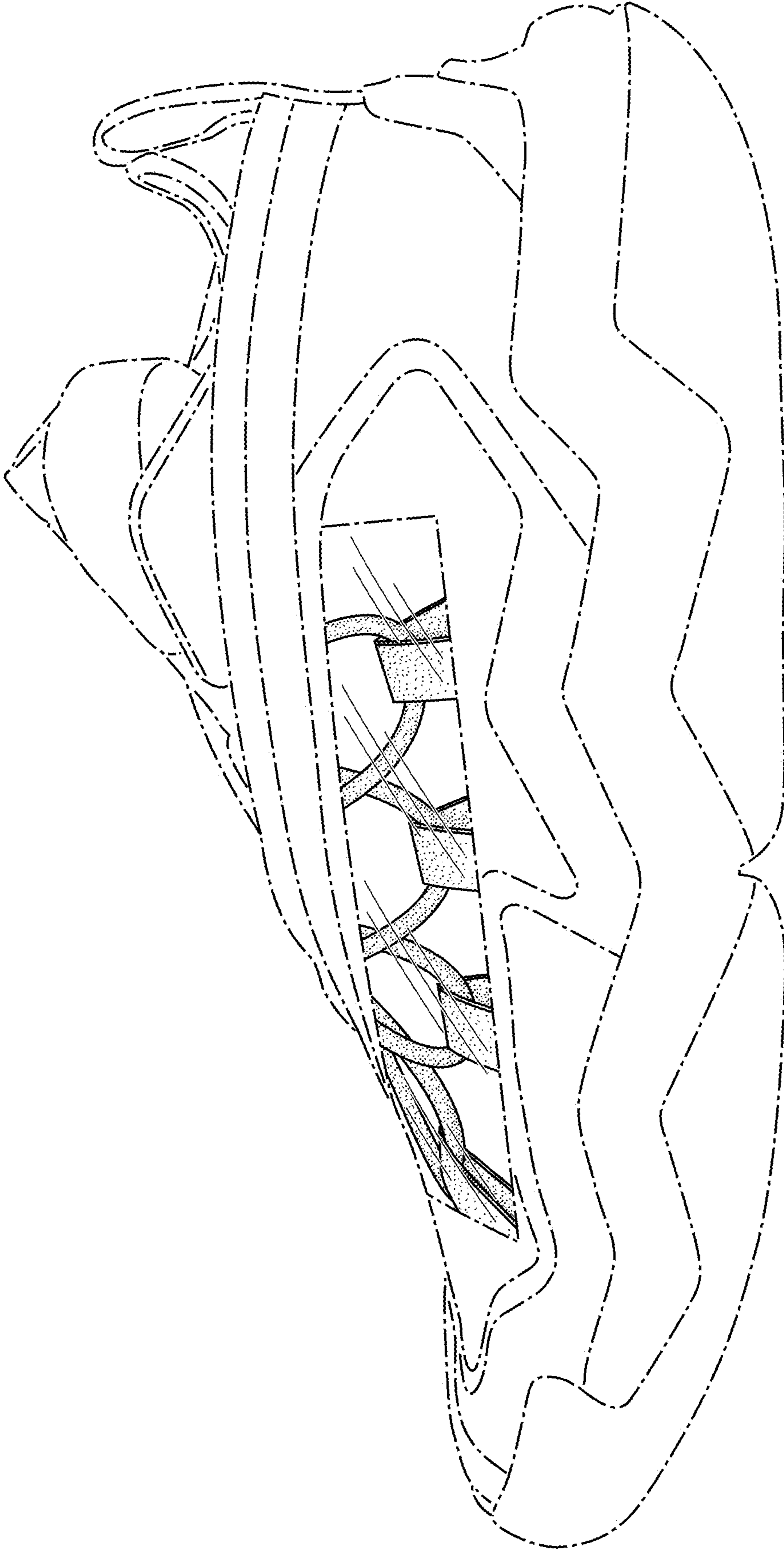

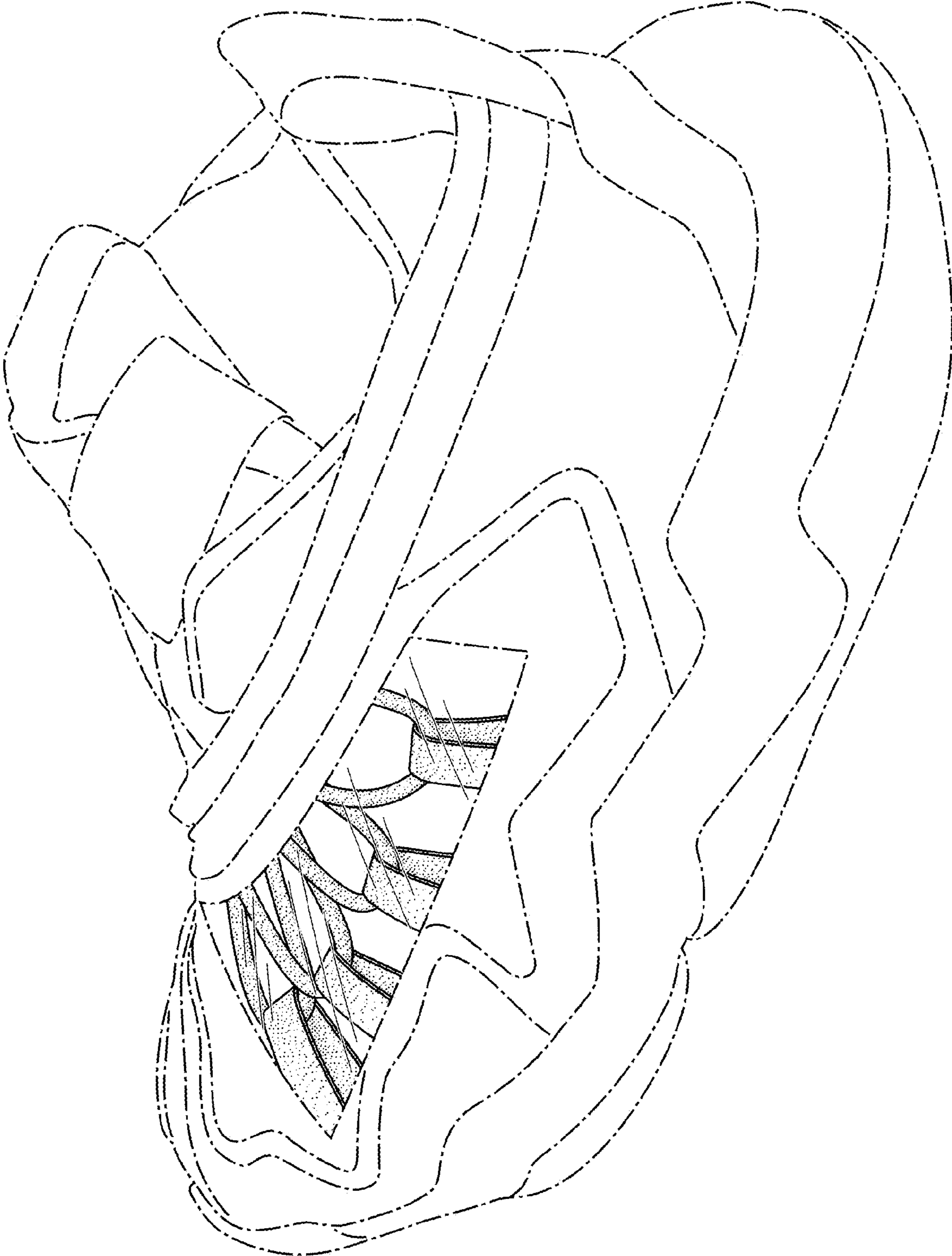
