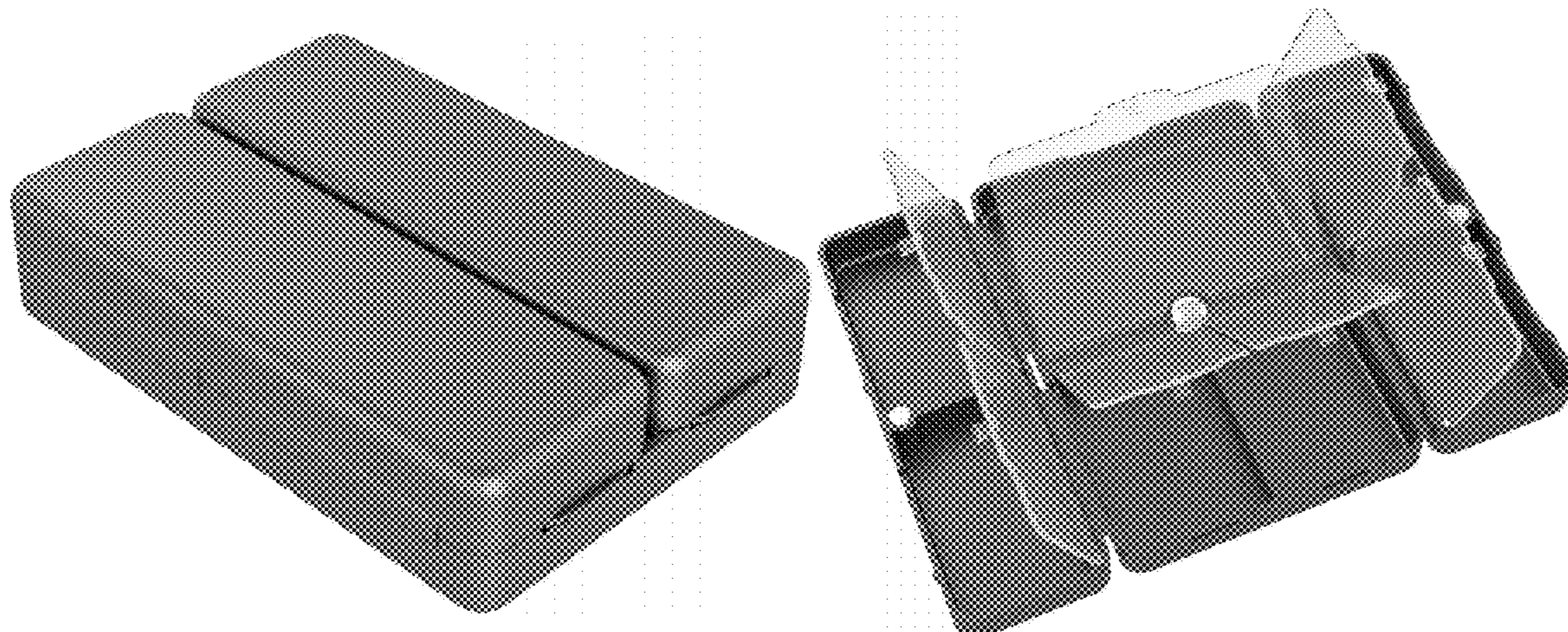
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front elevation view of a pill case, showing my new design;

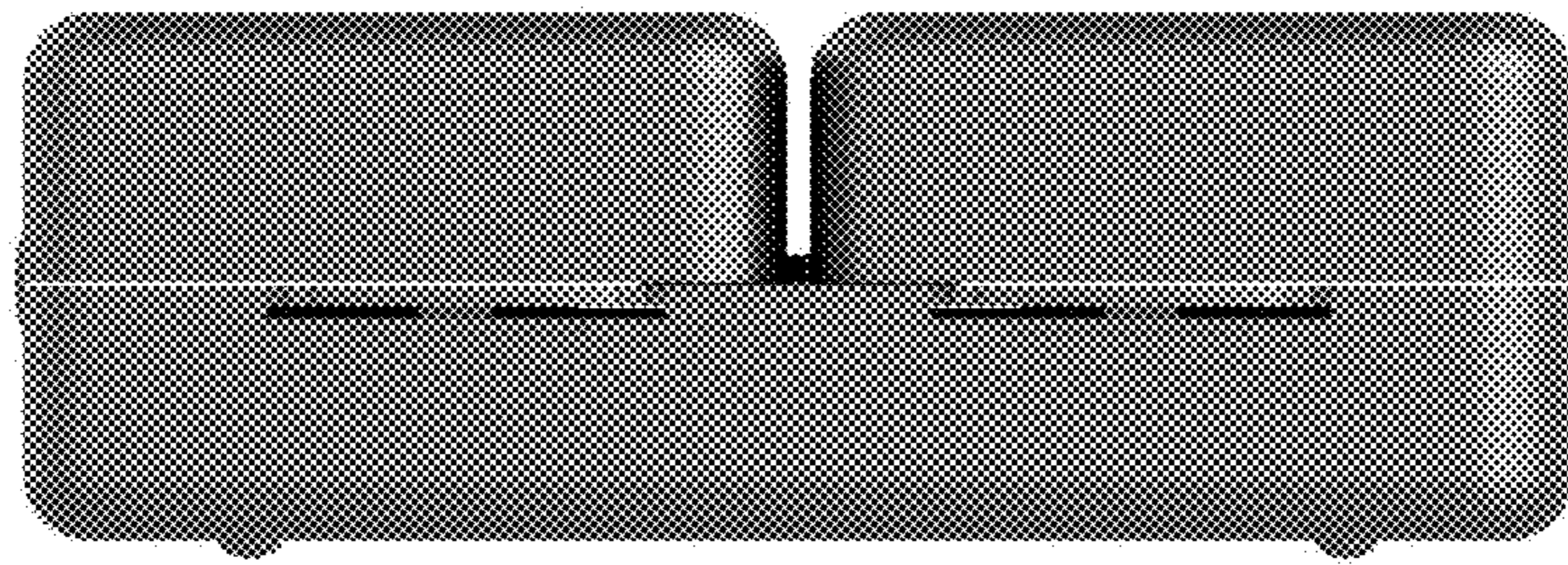

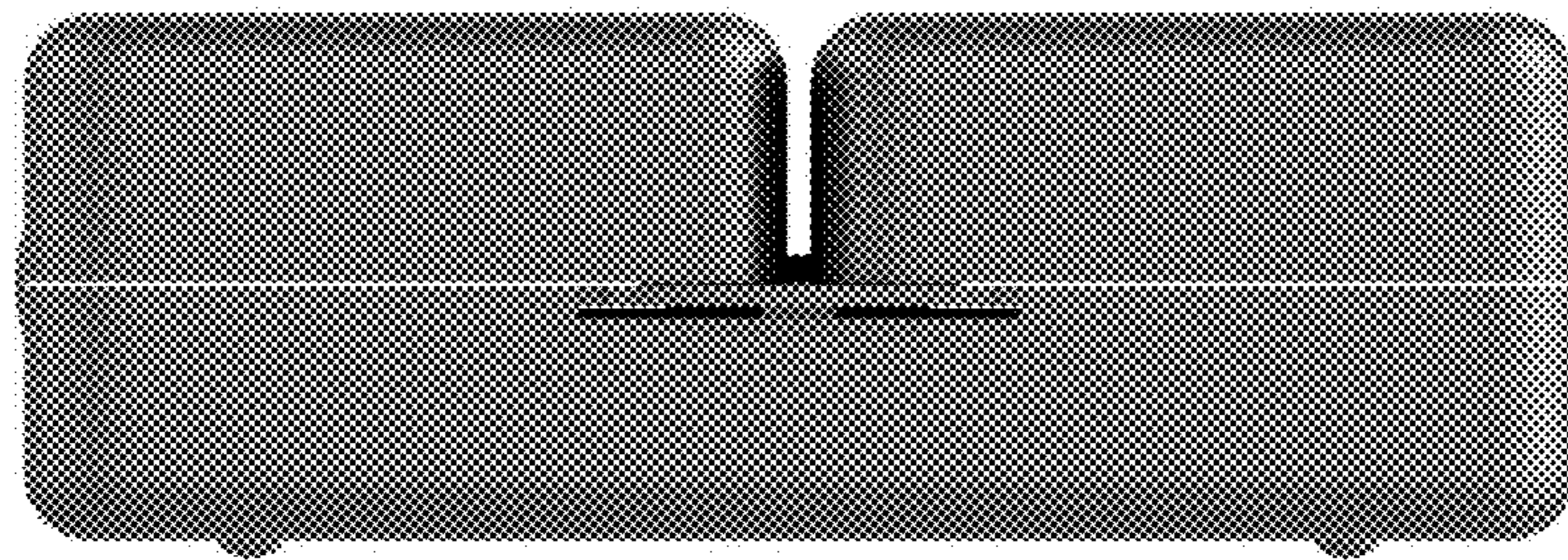

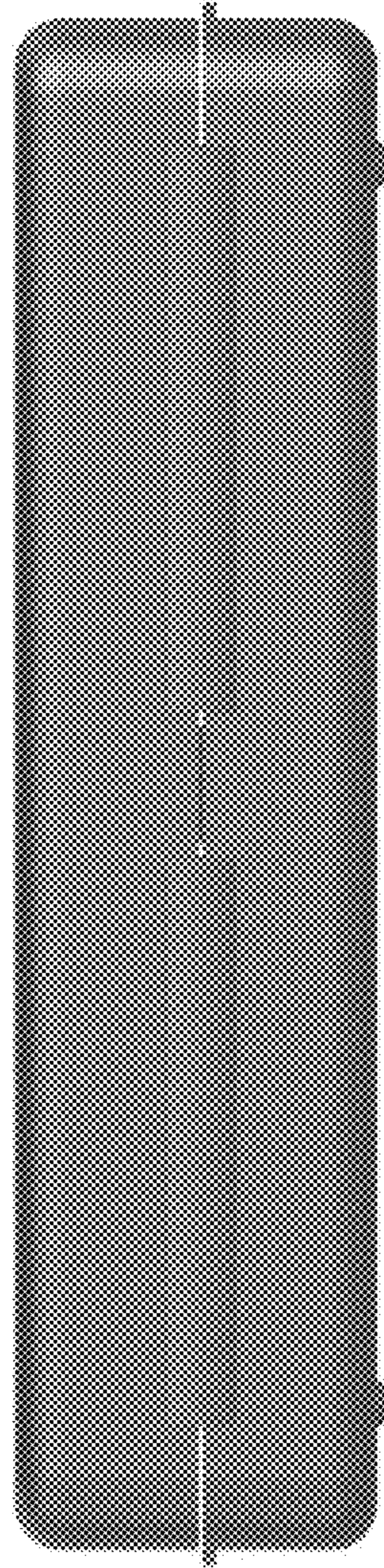

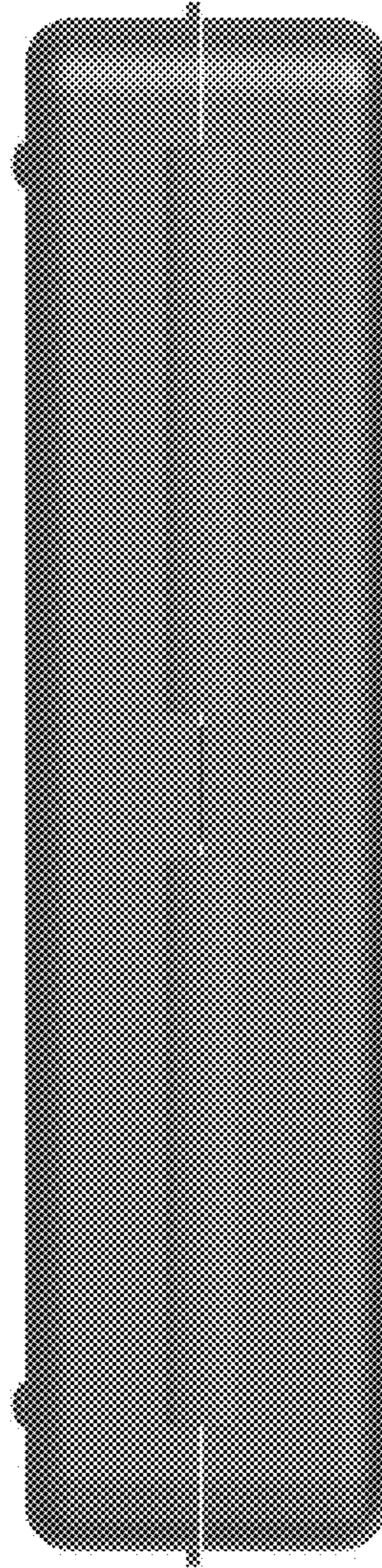

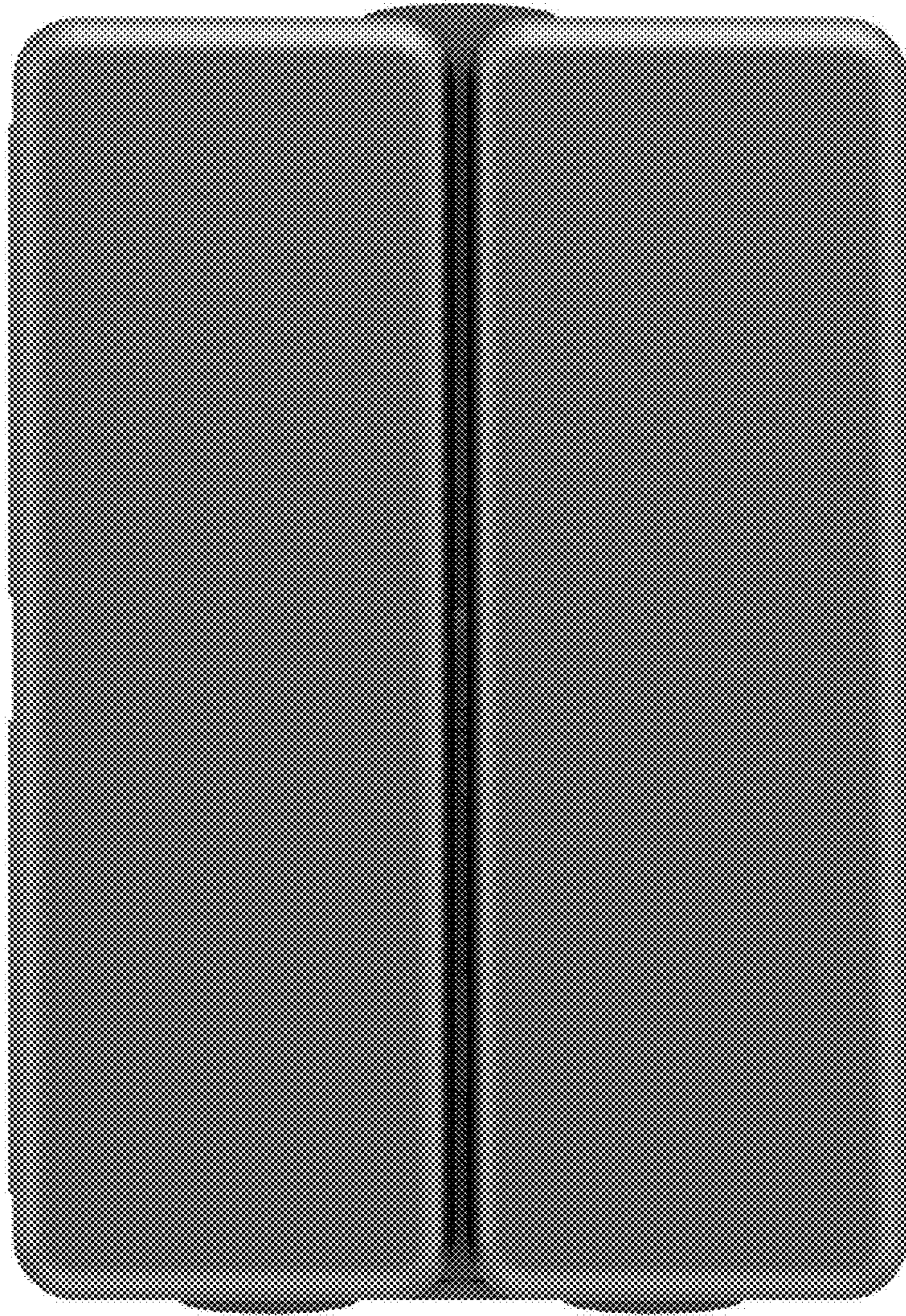

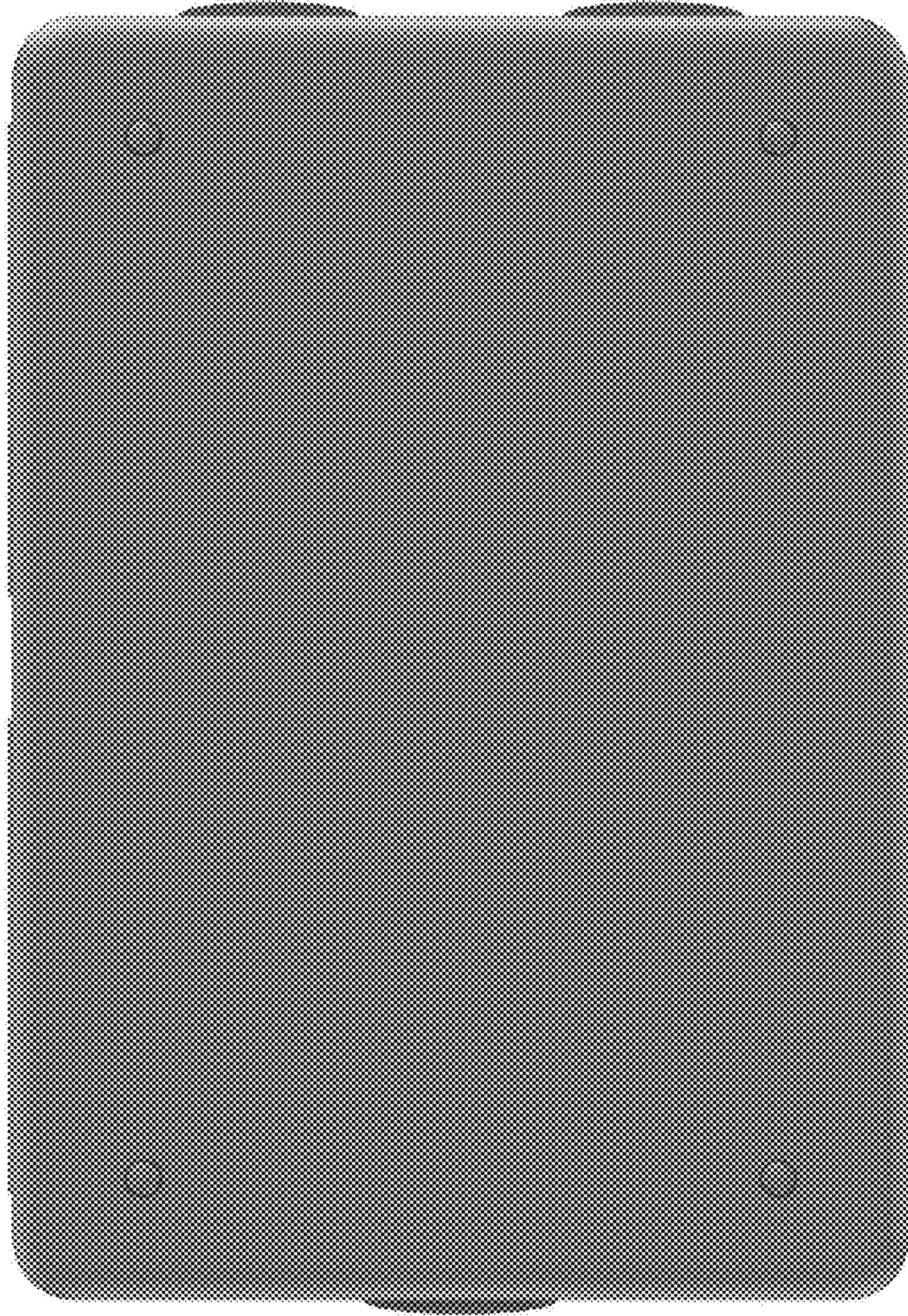

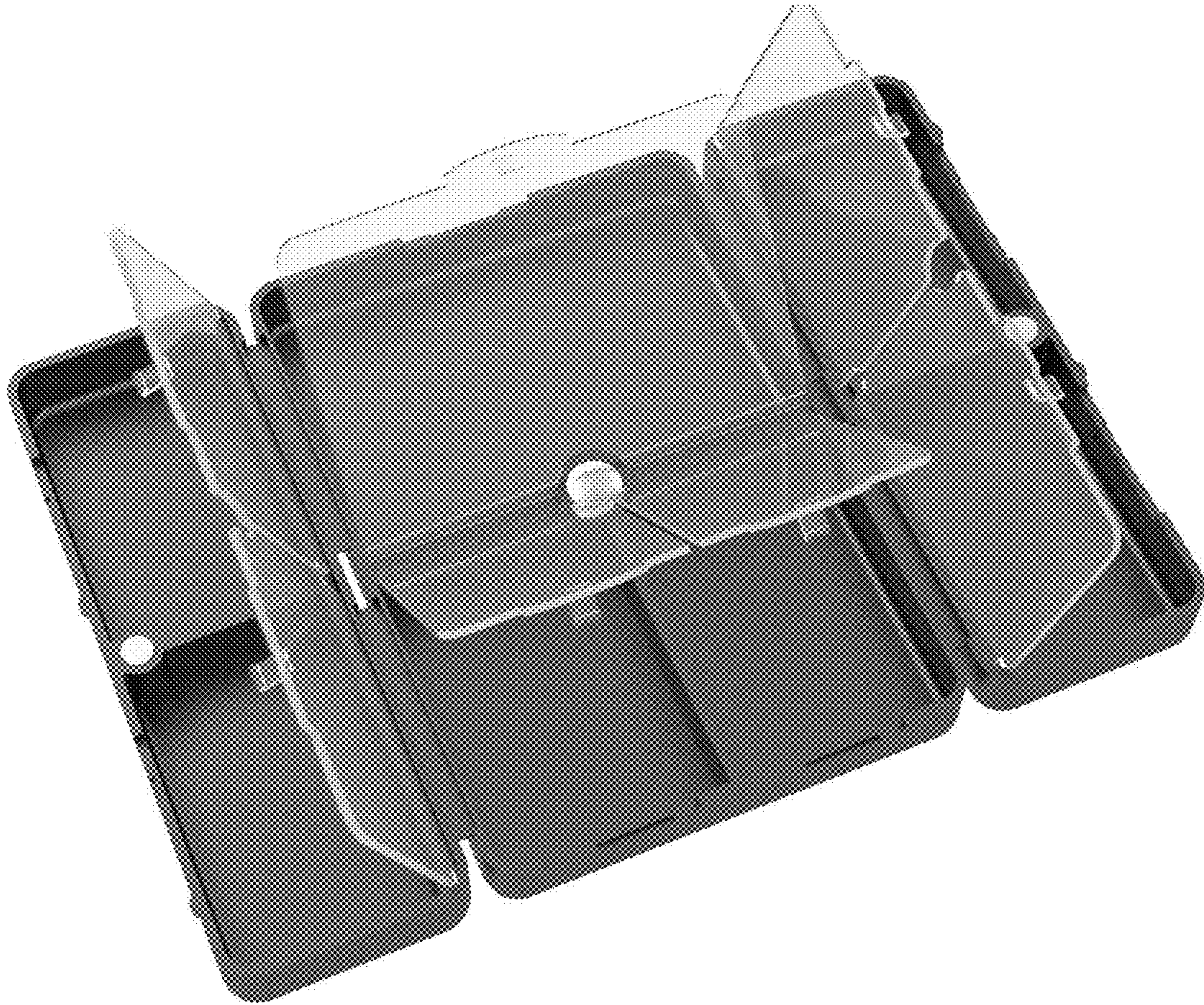
