FIG. 3 is a right side view thereof. The left side view is the same as the right side view.

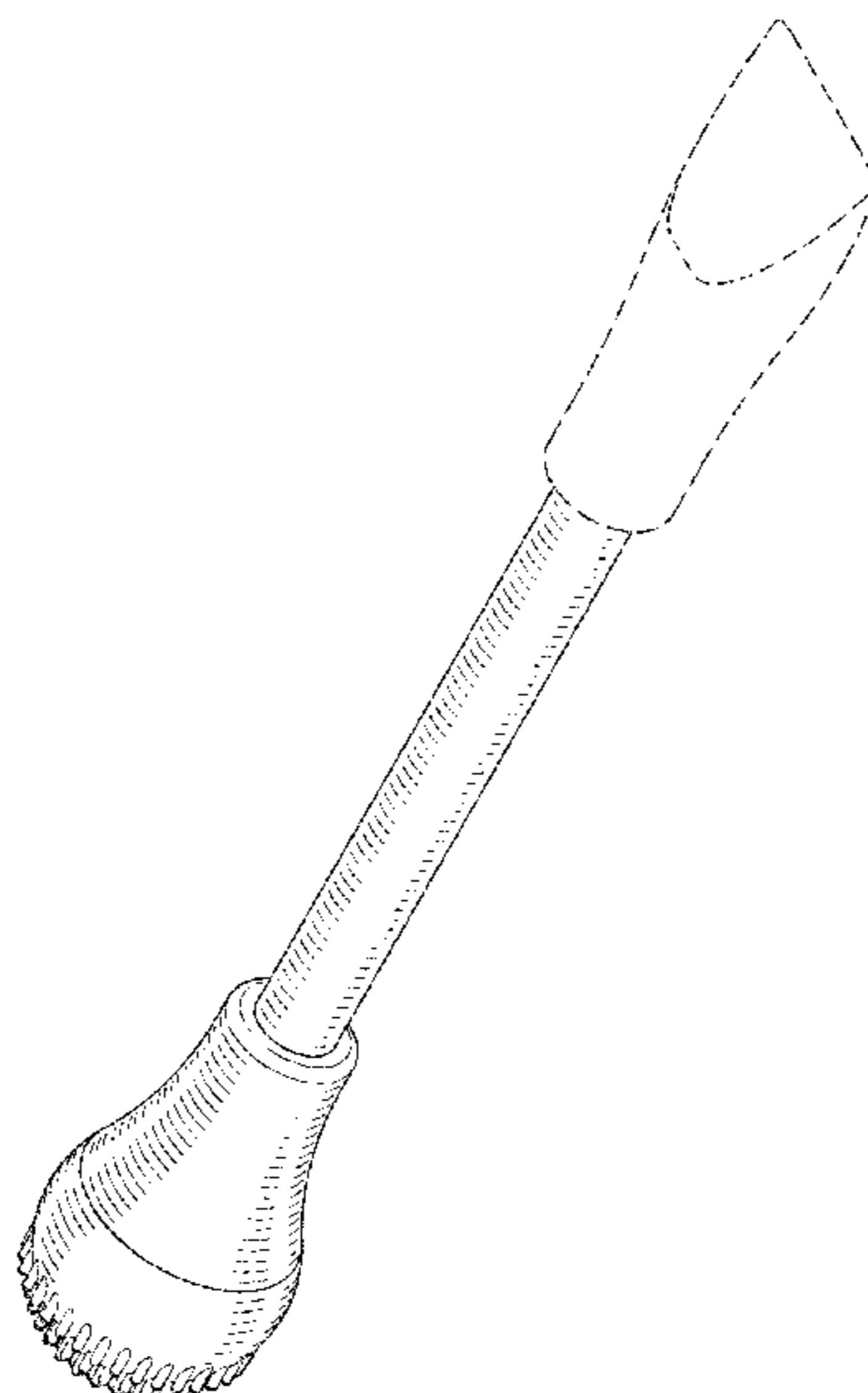
FIG. 4 is a front view thereof. The rear view is the same as the front view.

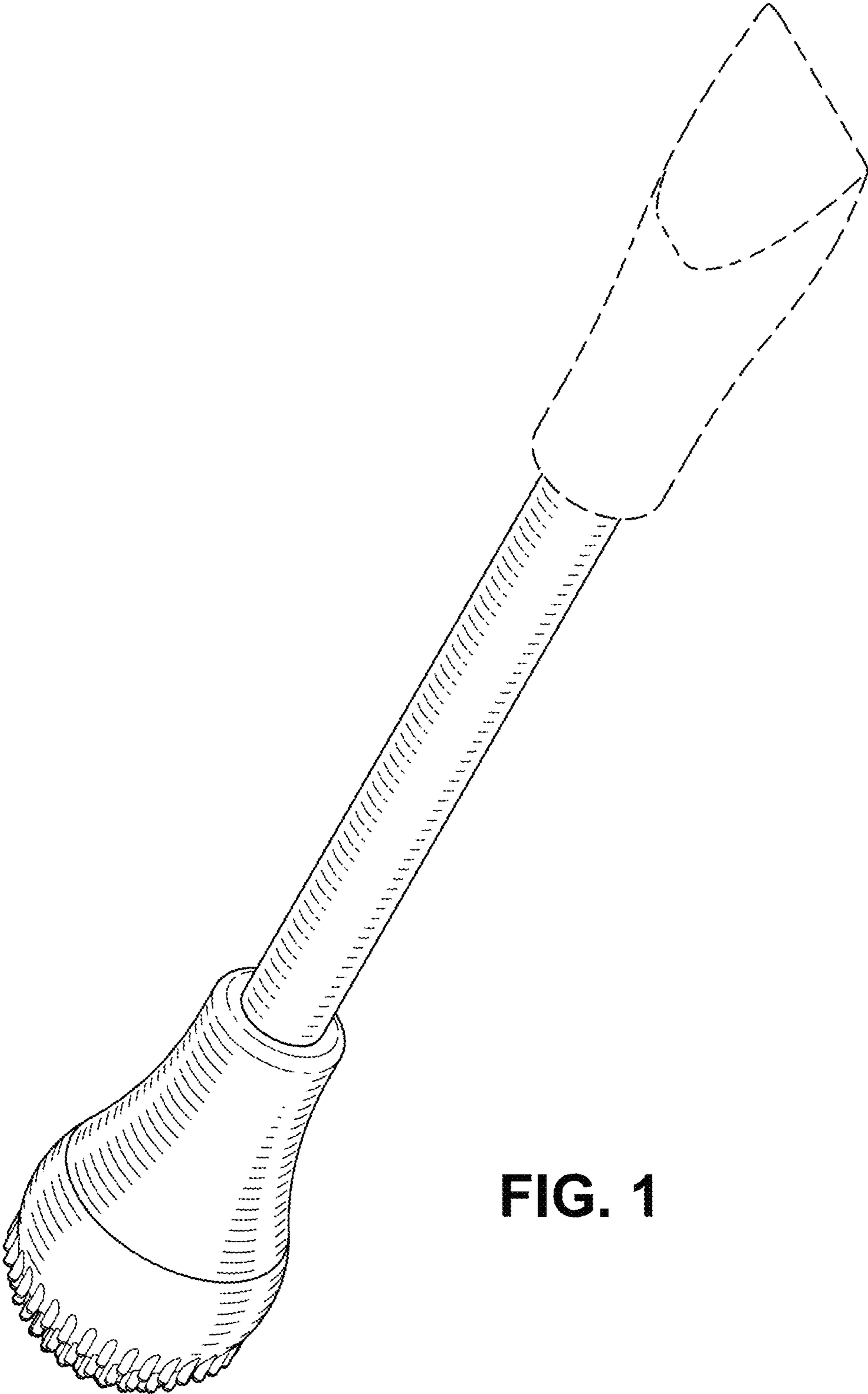

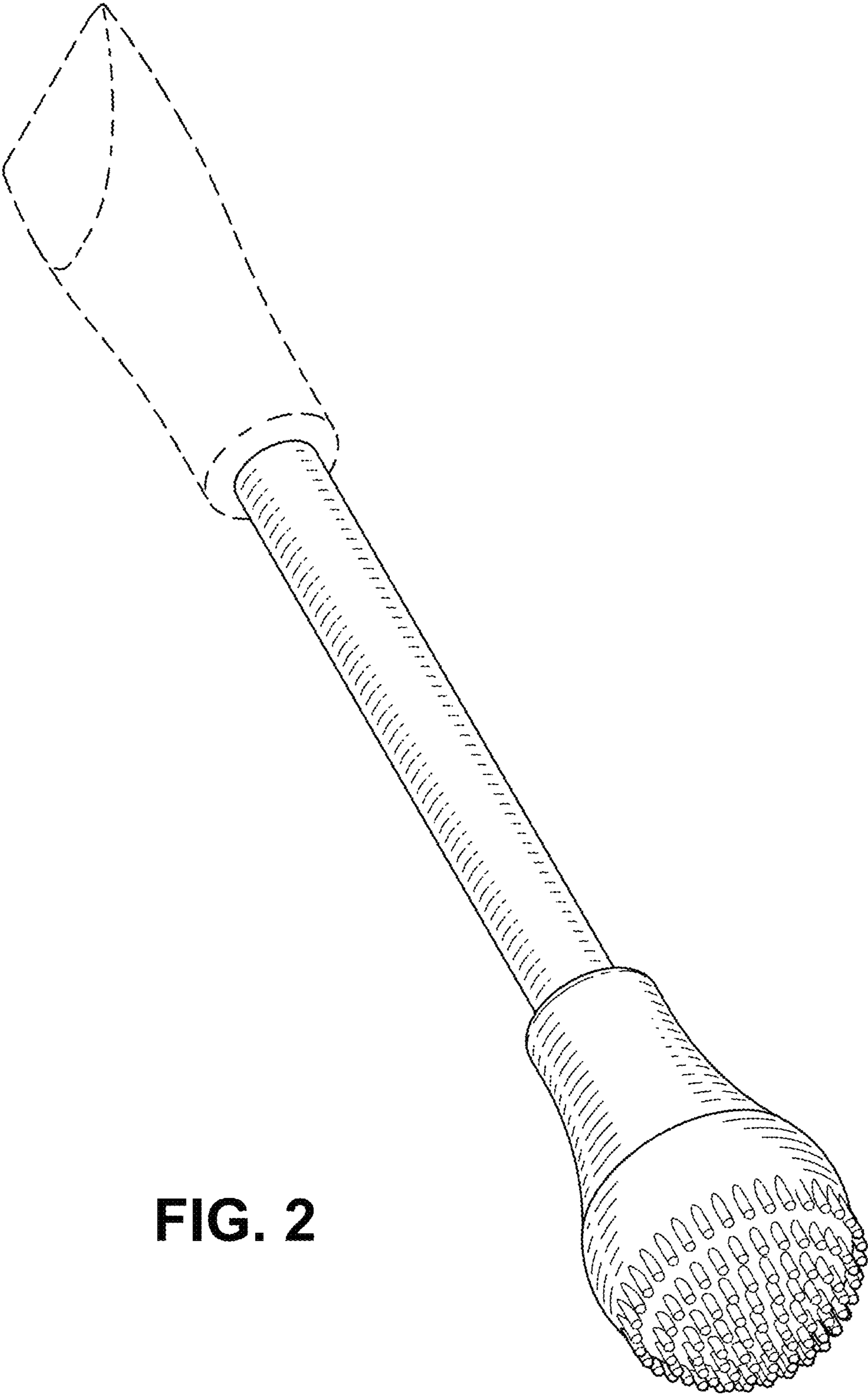

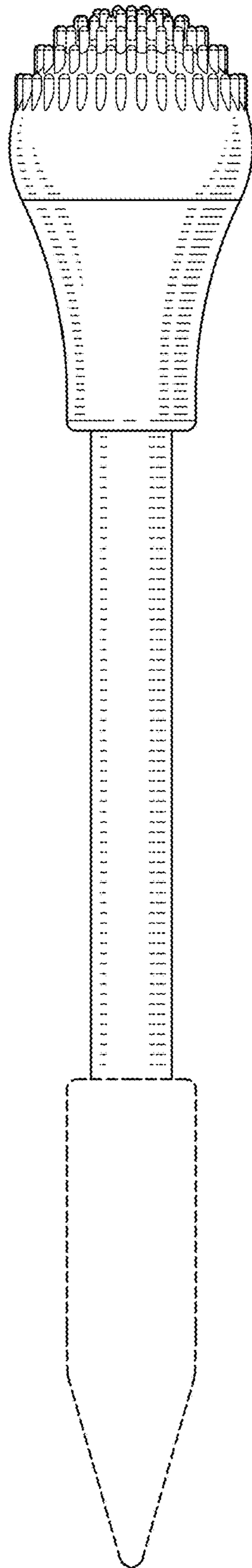

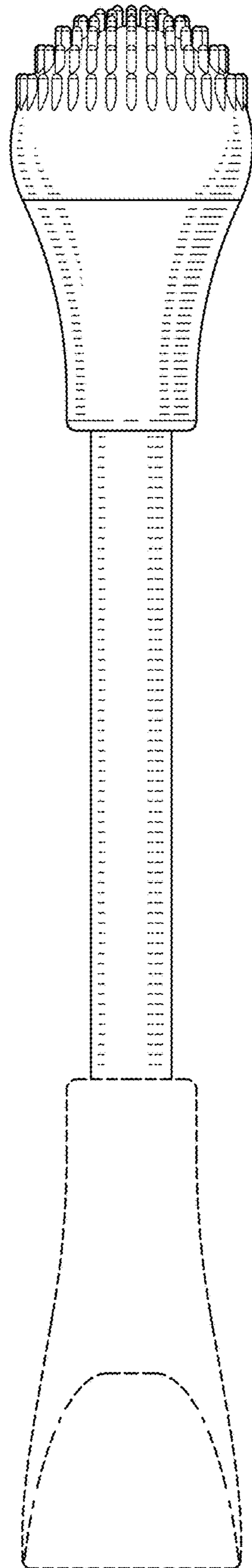

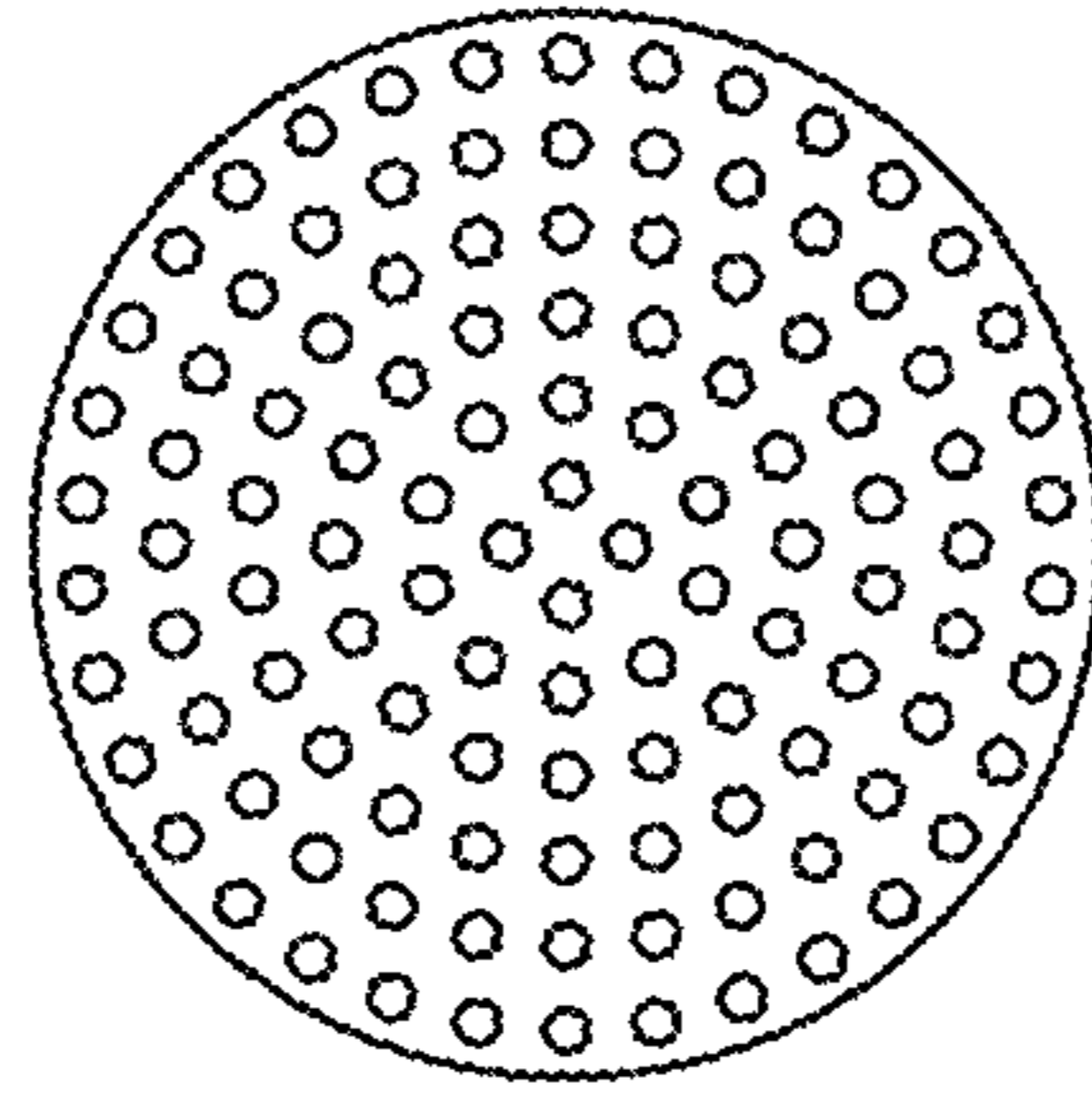

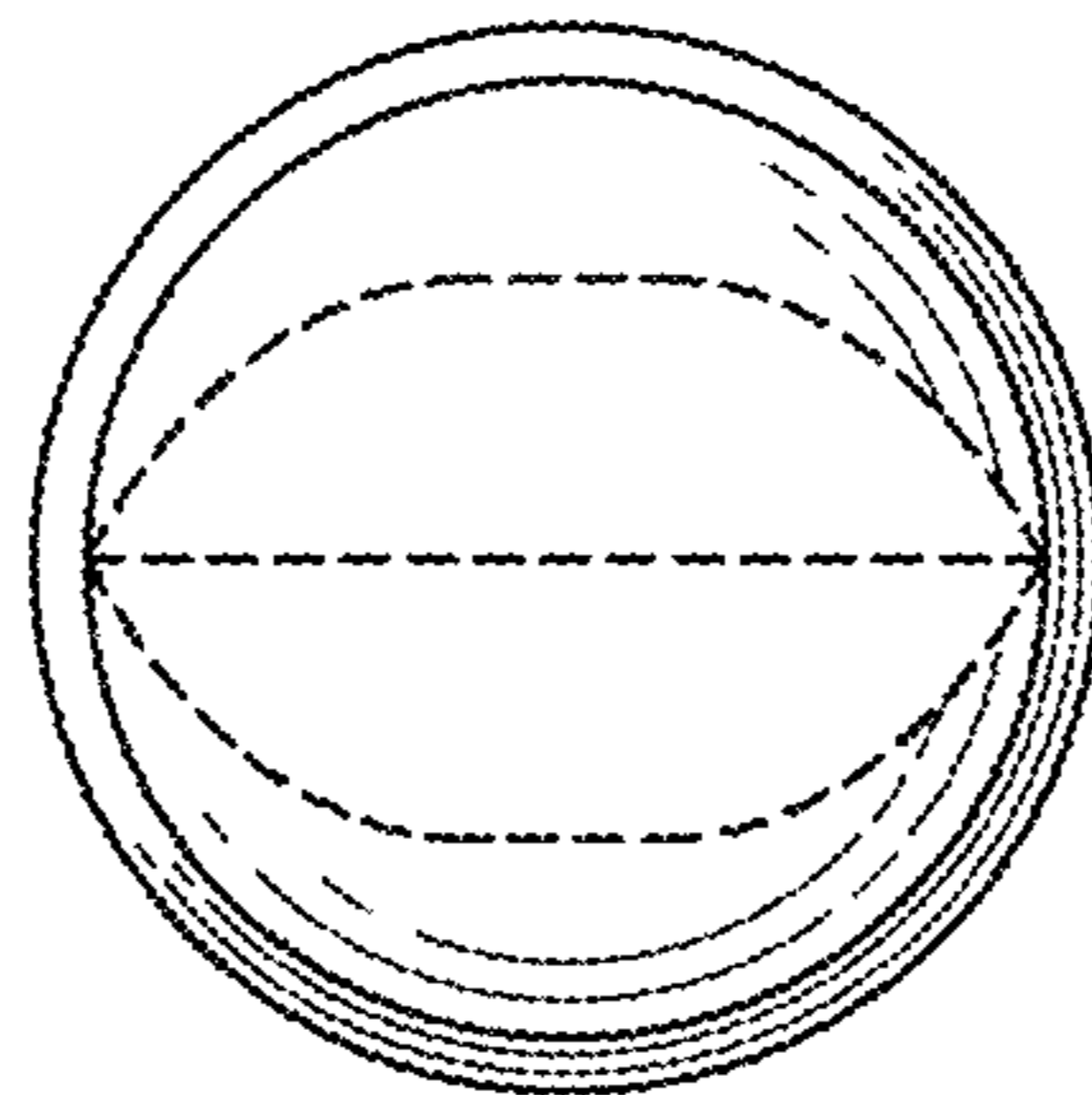
