(57) **CLAIM**

The ornamental design for a waste bag dispenser, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a first embodiment of a waste bag dispenser;

FIG. 2 is a front view thereof;

FIG. 3 is a rear view thereof;

FIG. 4 is a right side view thereof;

FIG. 5 is a left side view thereof;

FIG. 6 is a top view thereof;

FIG. 7 is a bottom view thereof;

FIG. 8 is a top perspective view of an alternate embodiment of the waste bag dispenser shown in FIG. 1;

FIG. 9 is a front view of the refuse receptacle holder shown in FIG. 8;

FIG. 10 is a rear view of the refuse receptacle holder shown in FIG. 8;

FIG. 11 is a right side view of the refuse receptacle holder shown in FIG. 8;

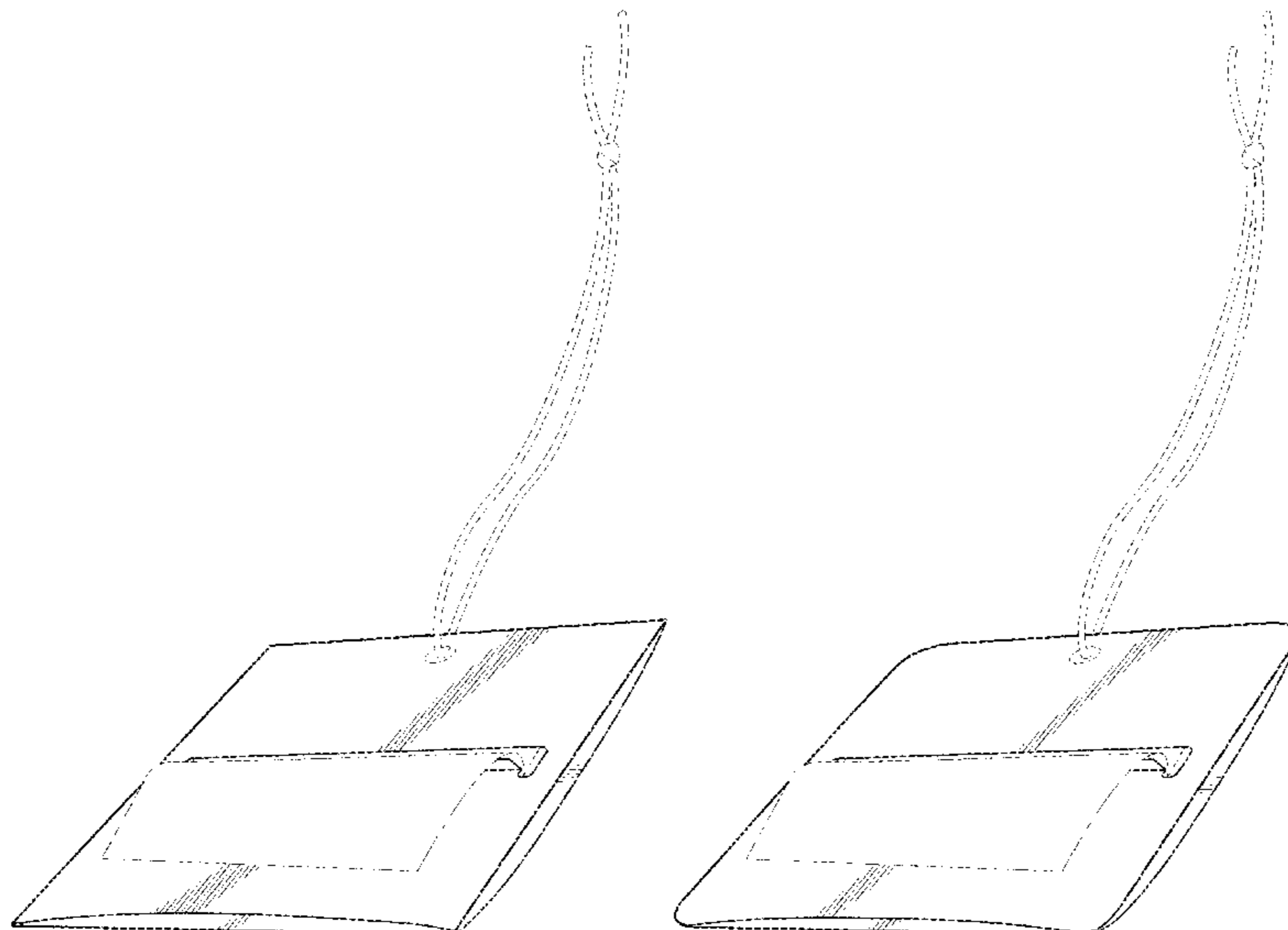
FIG. 12 is a left side view of the refuse receptacle holder shown in FIG. 8;

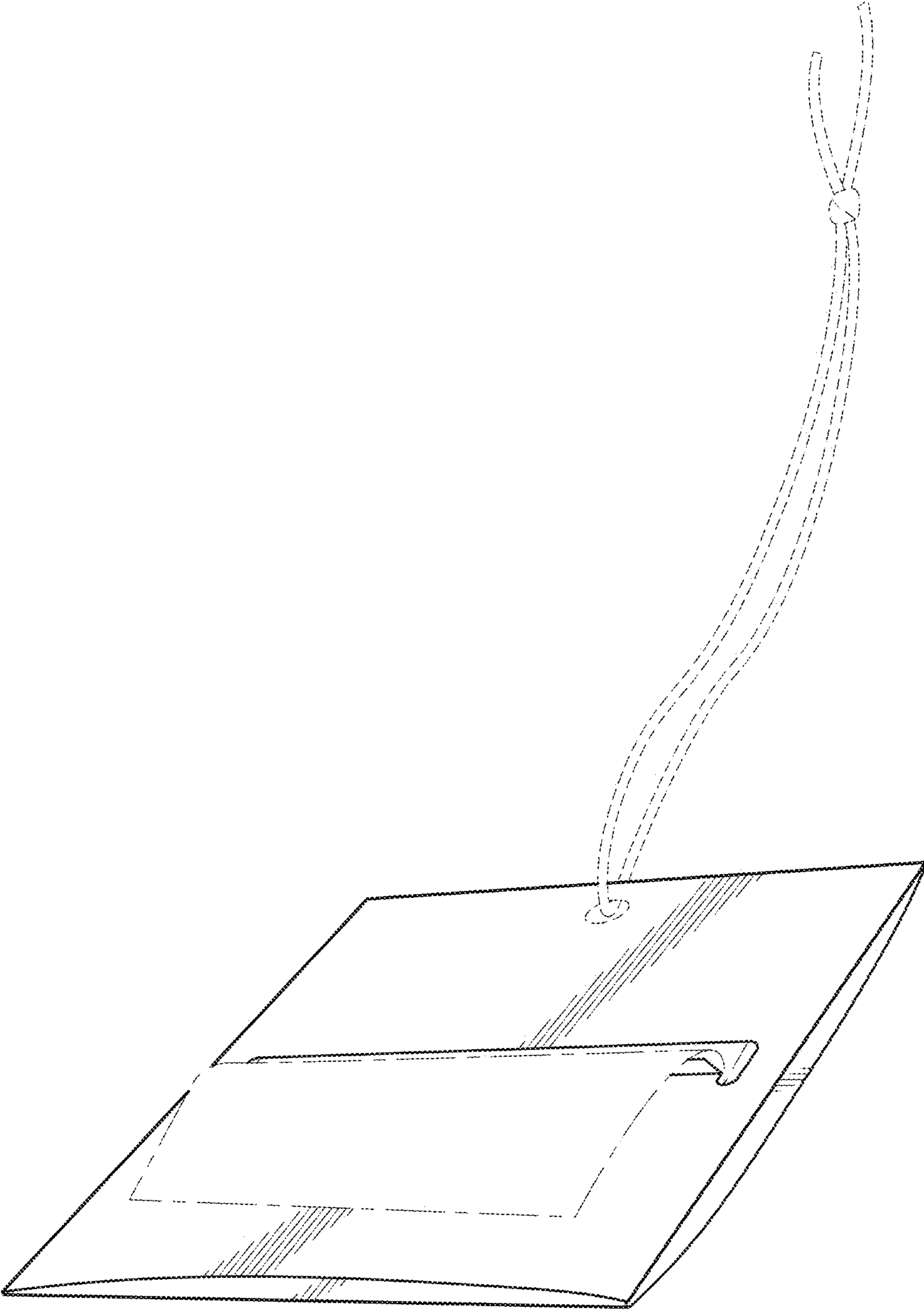

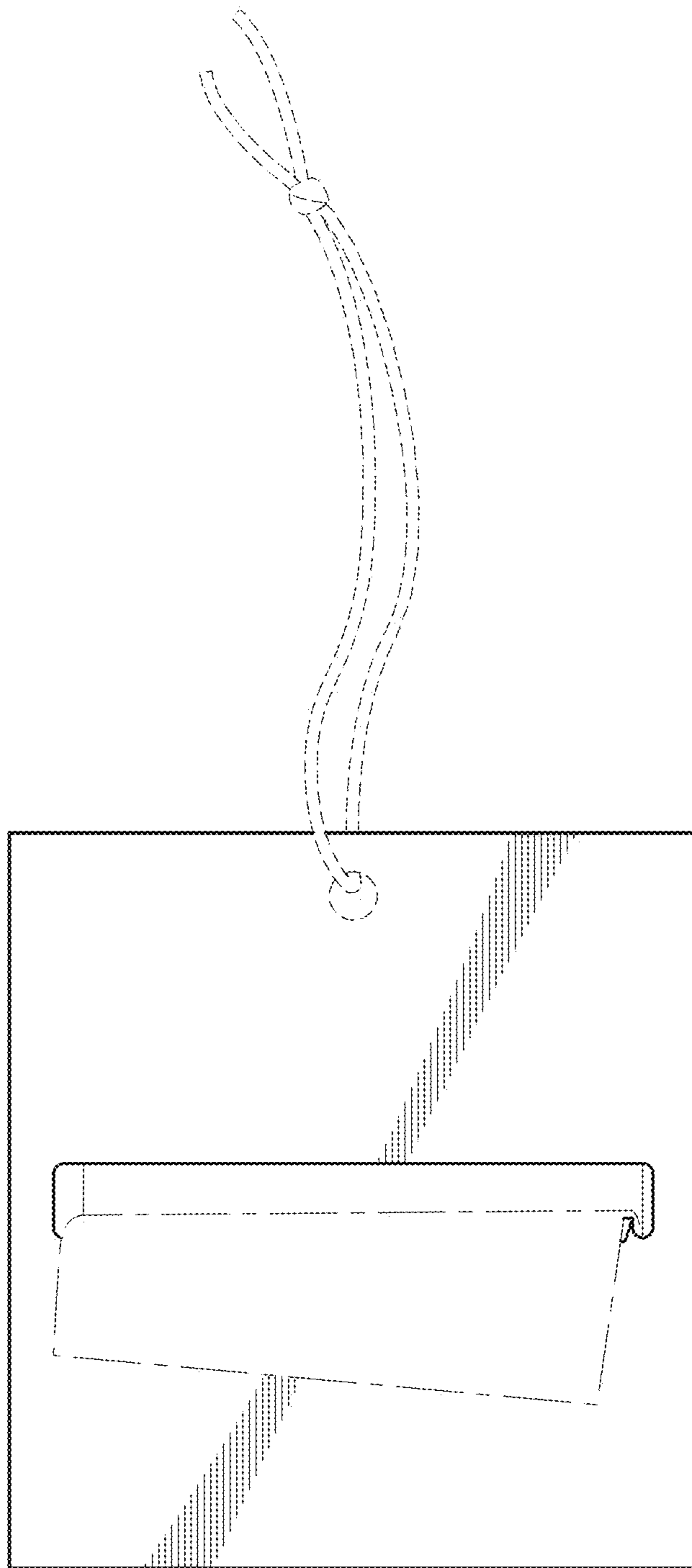

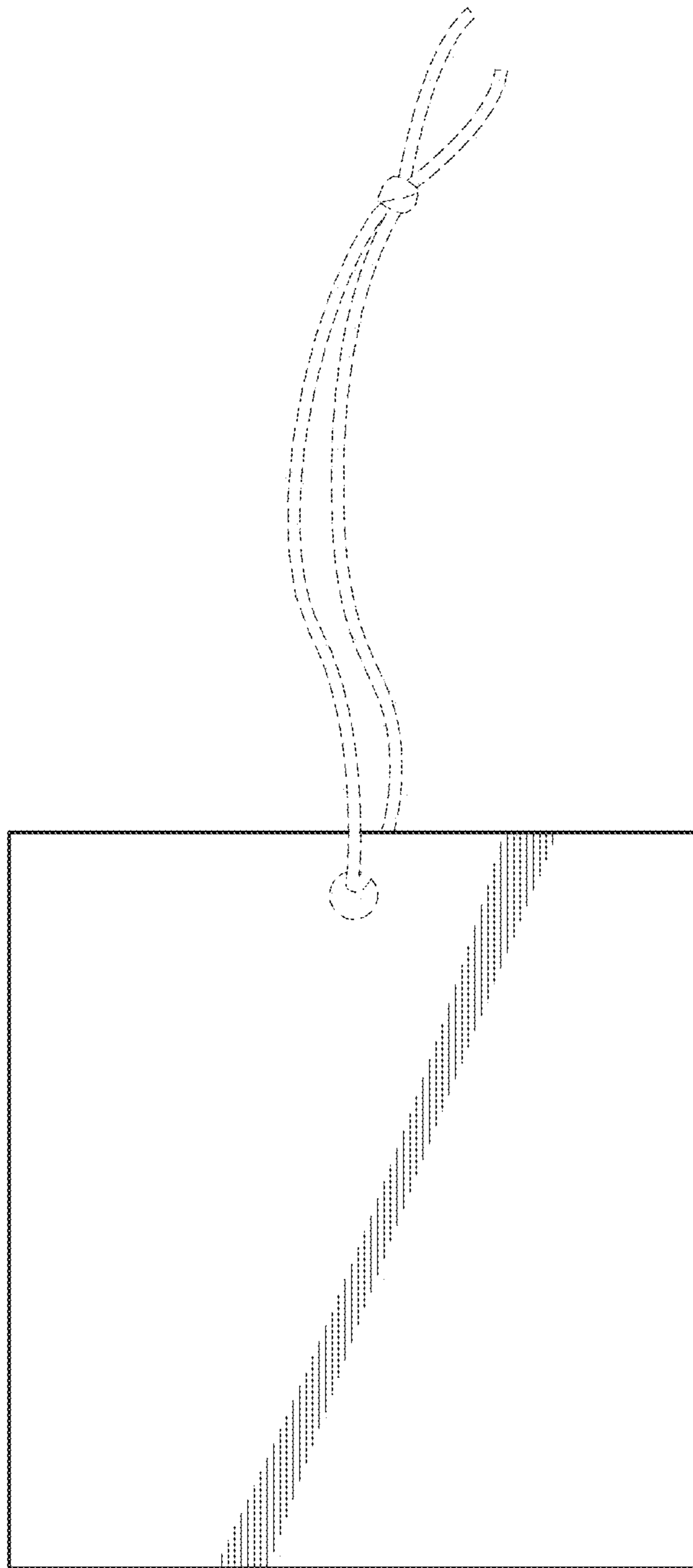

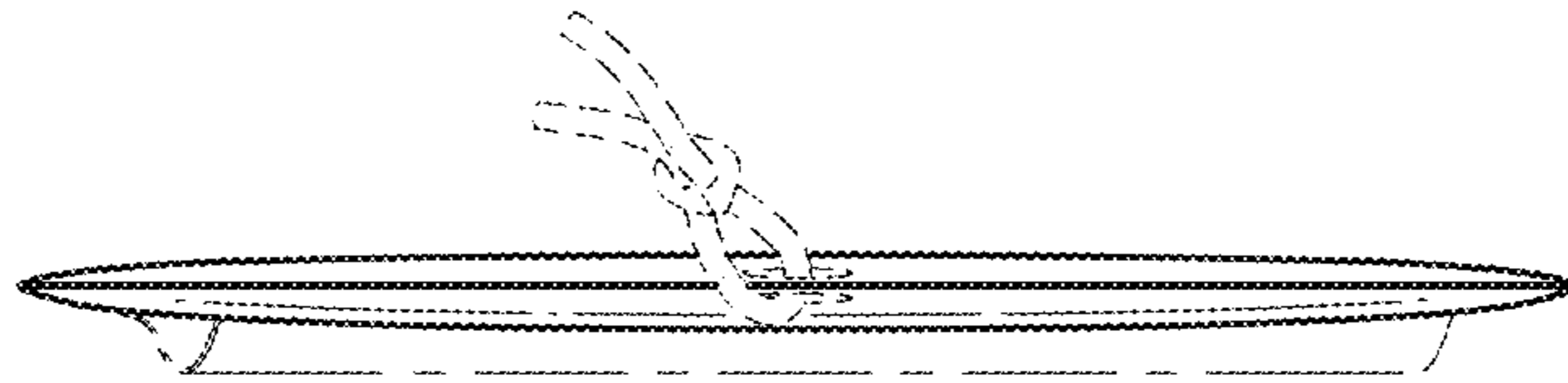

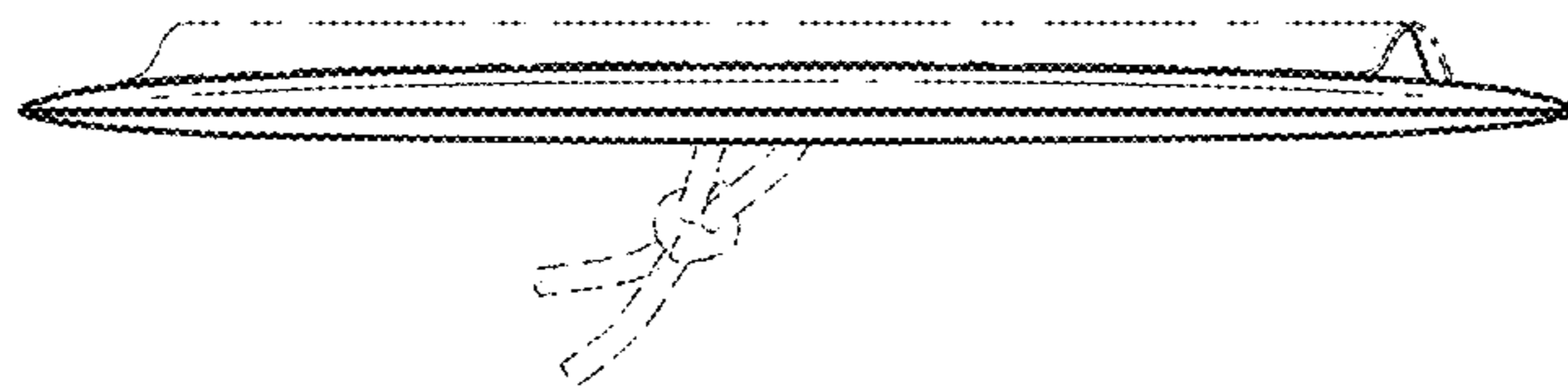

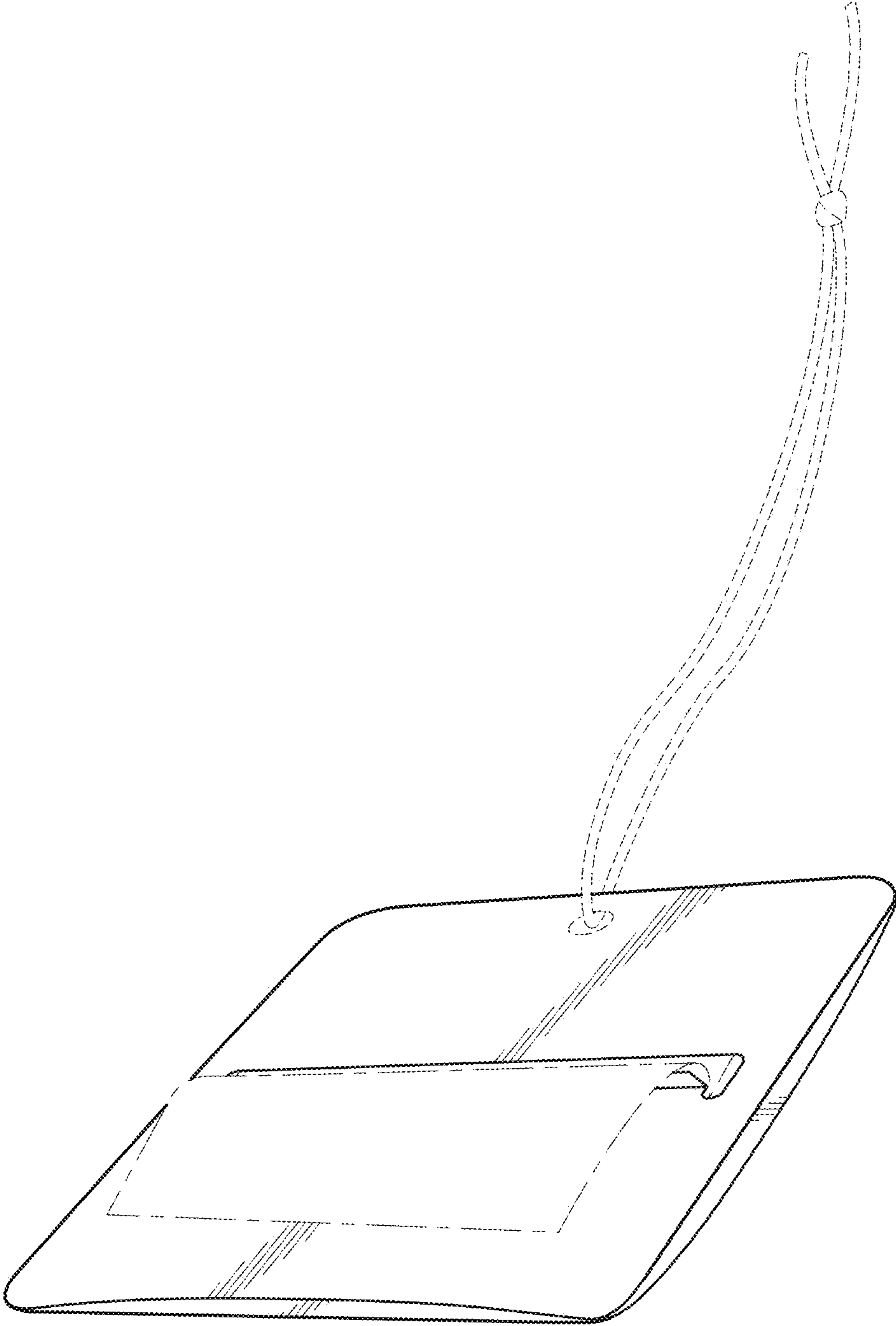

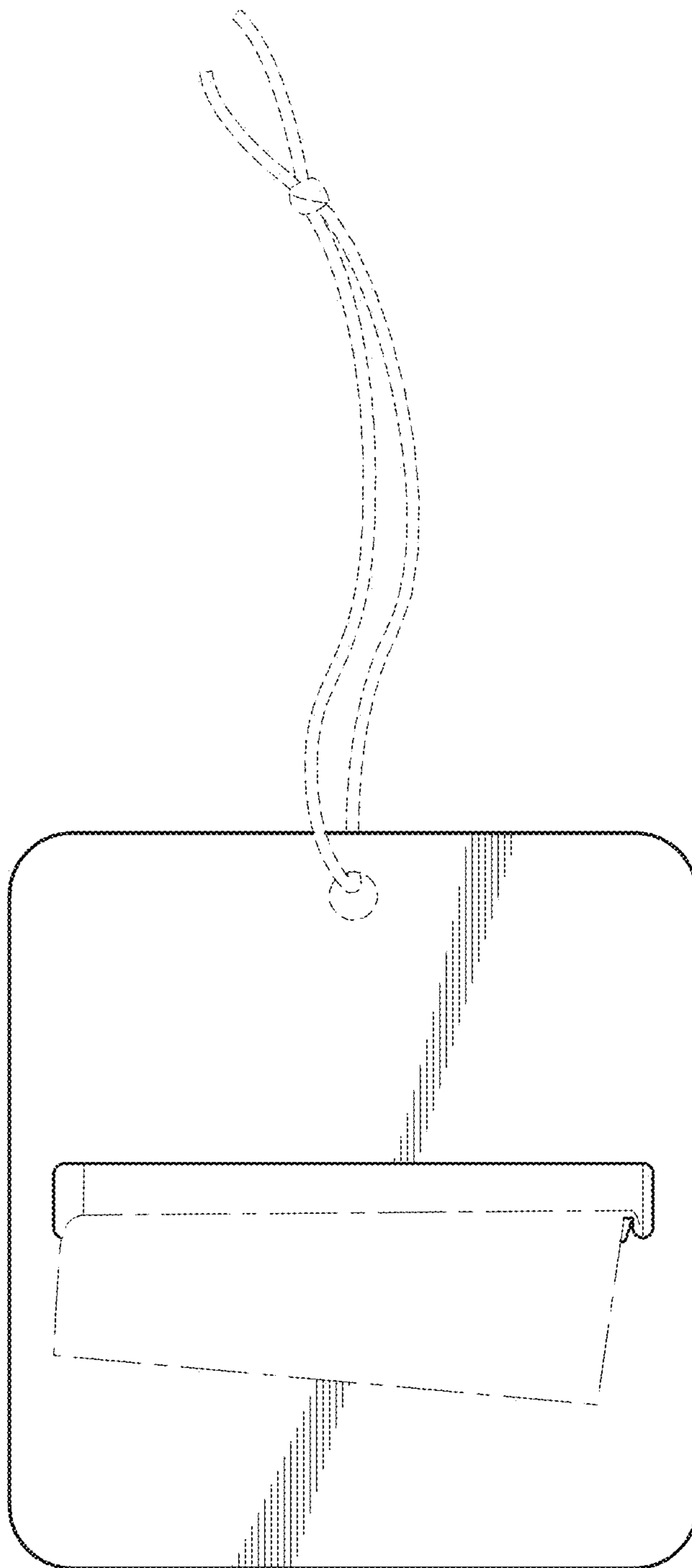

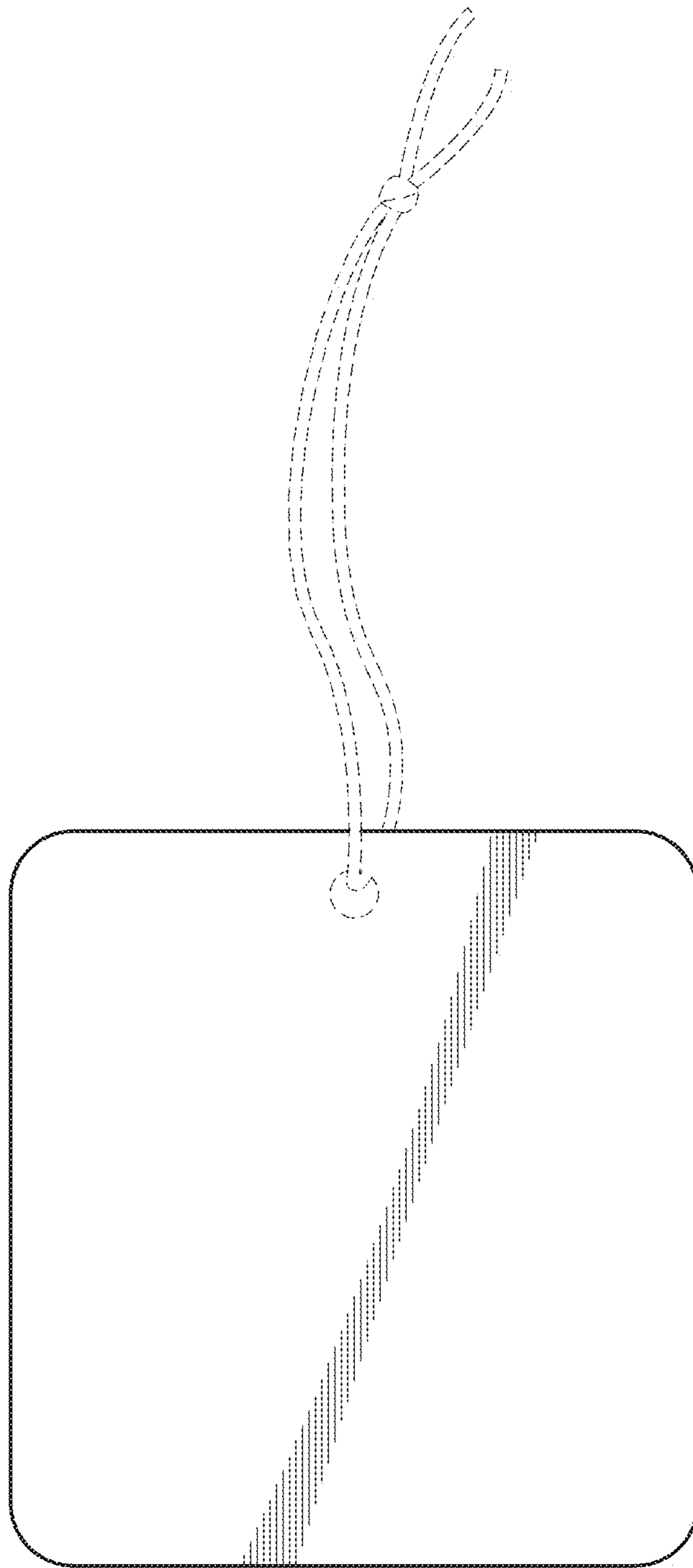

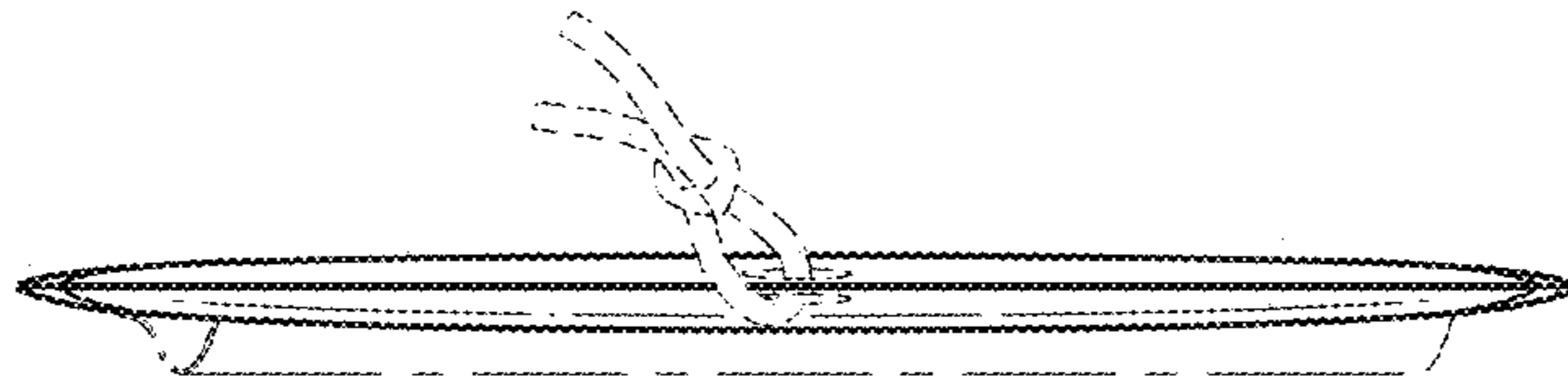

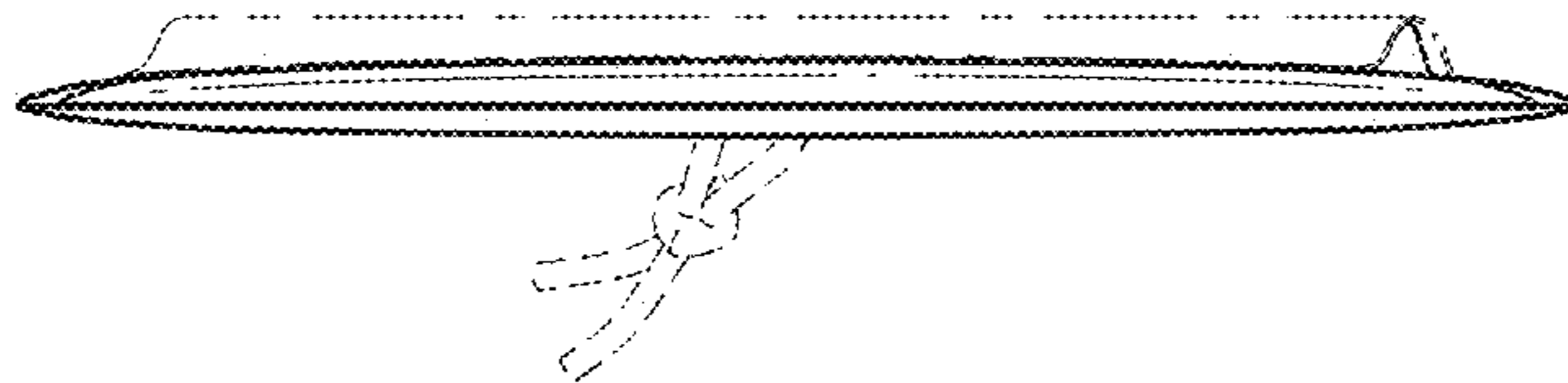
