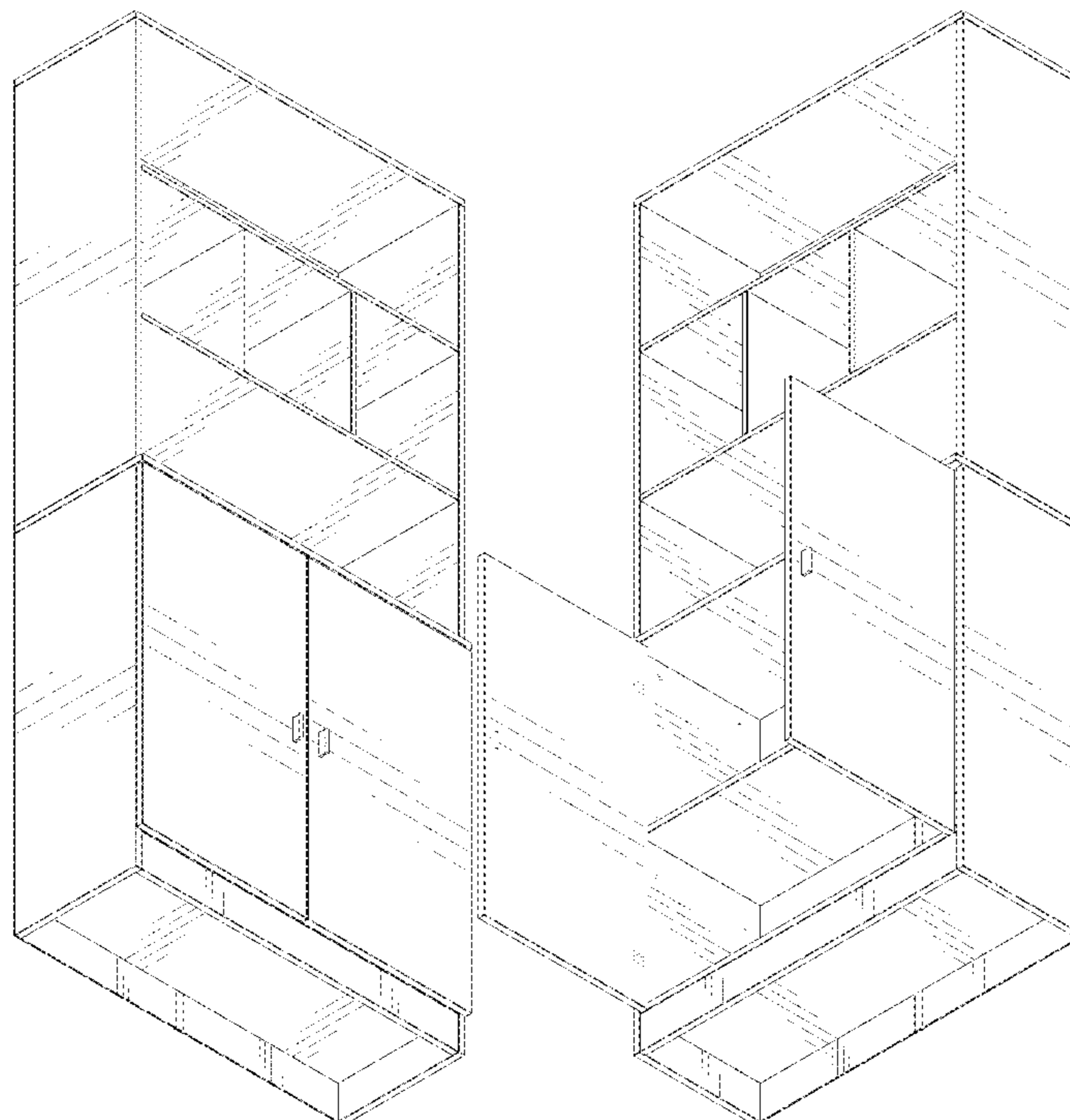
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front, left, bottom perspective view of a cabinet, showing my new design;

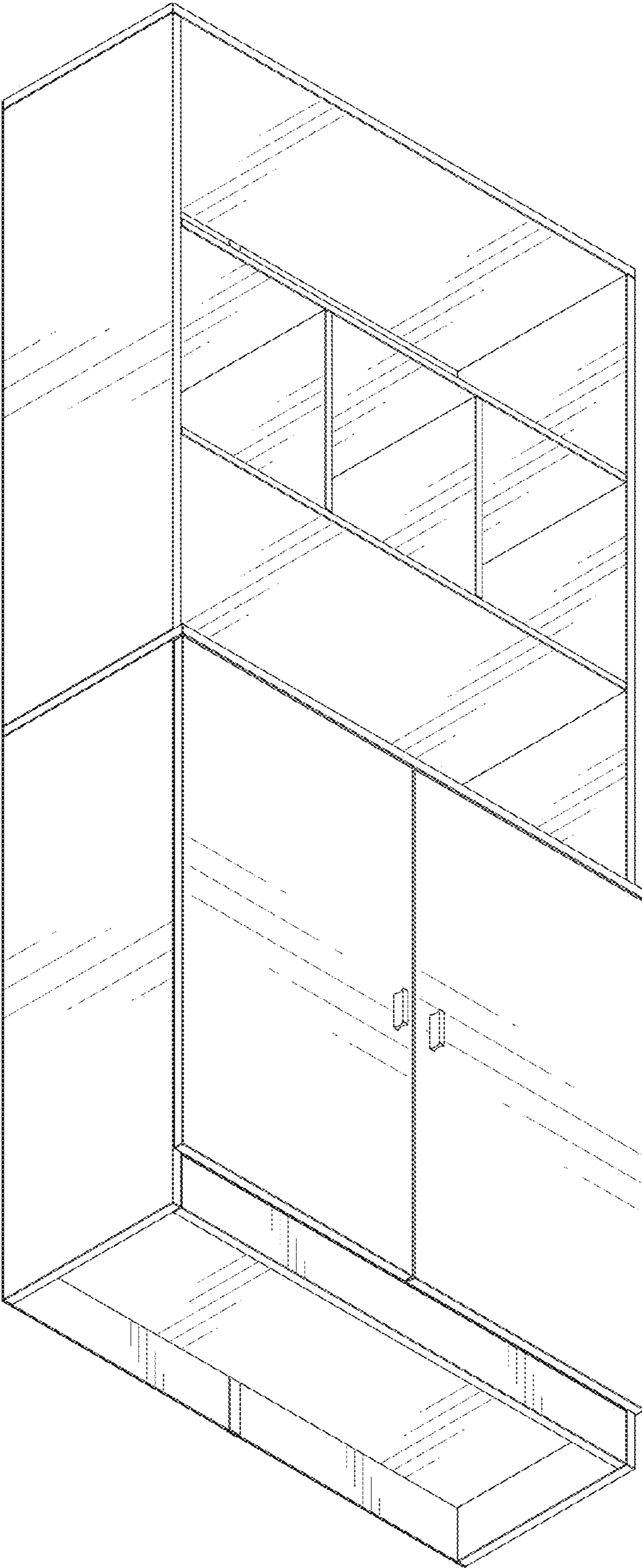

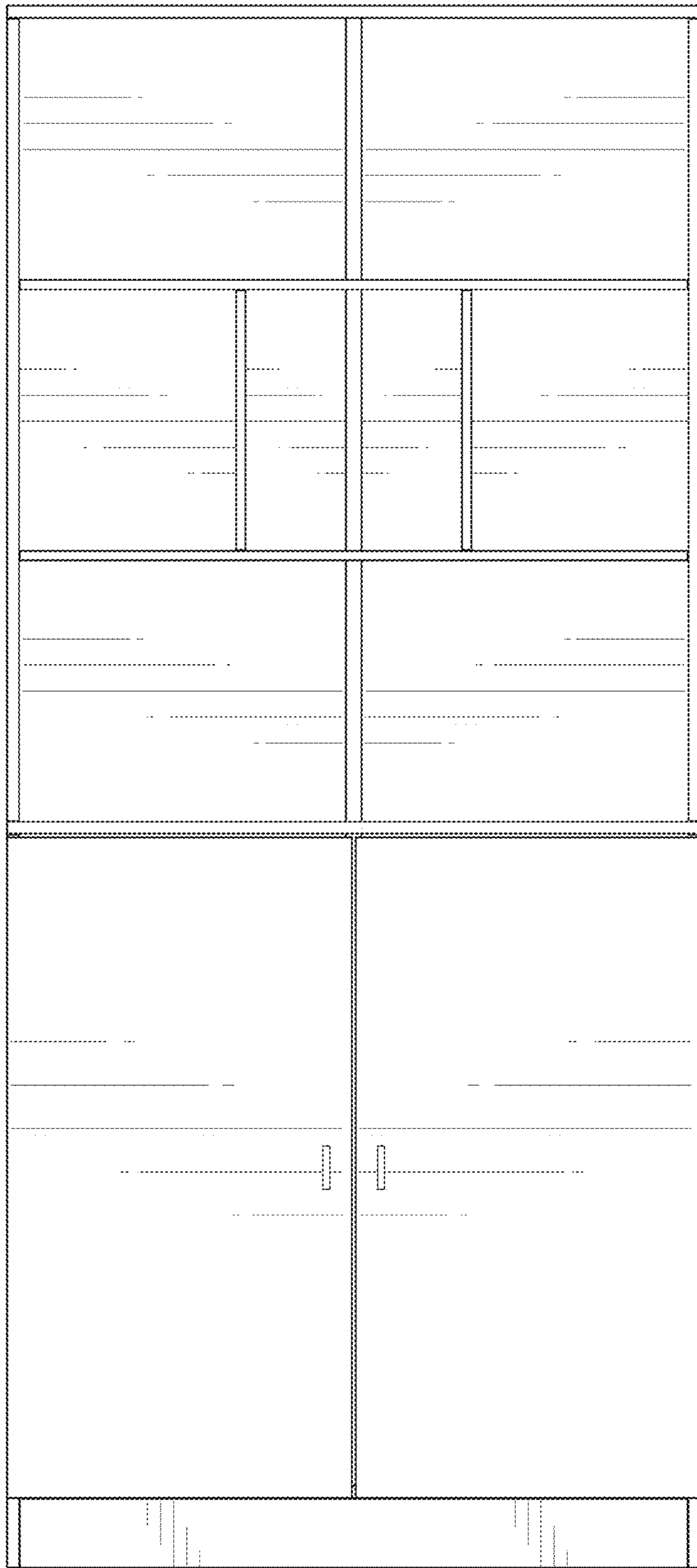

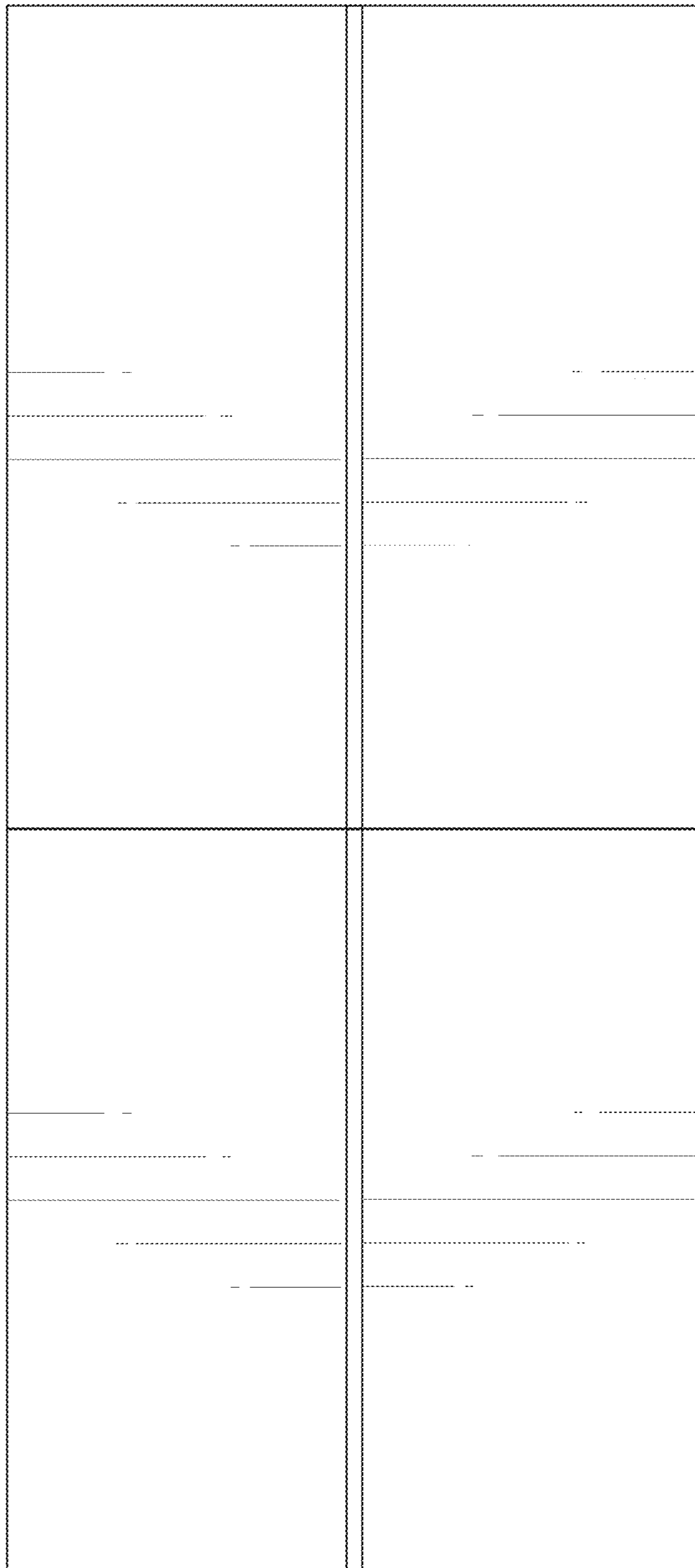

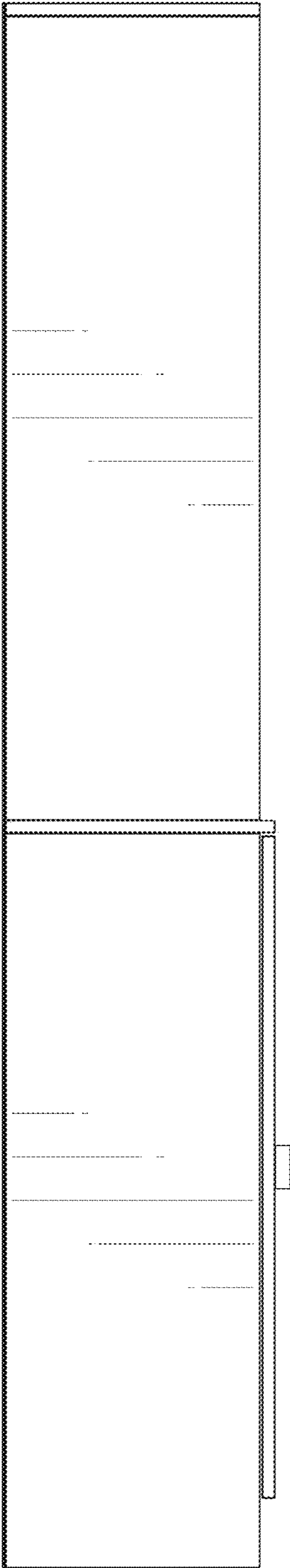

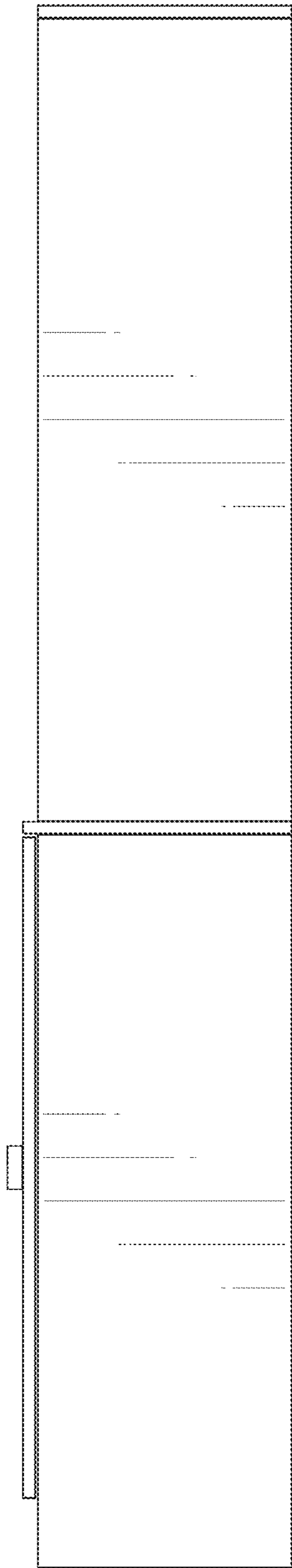

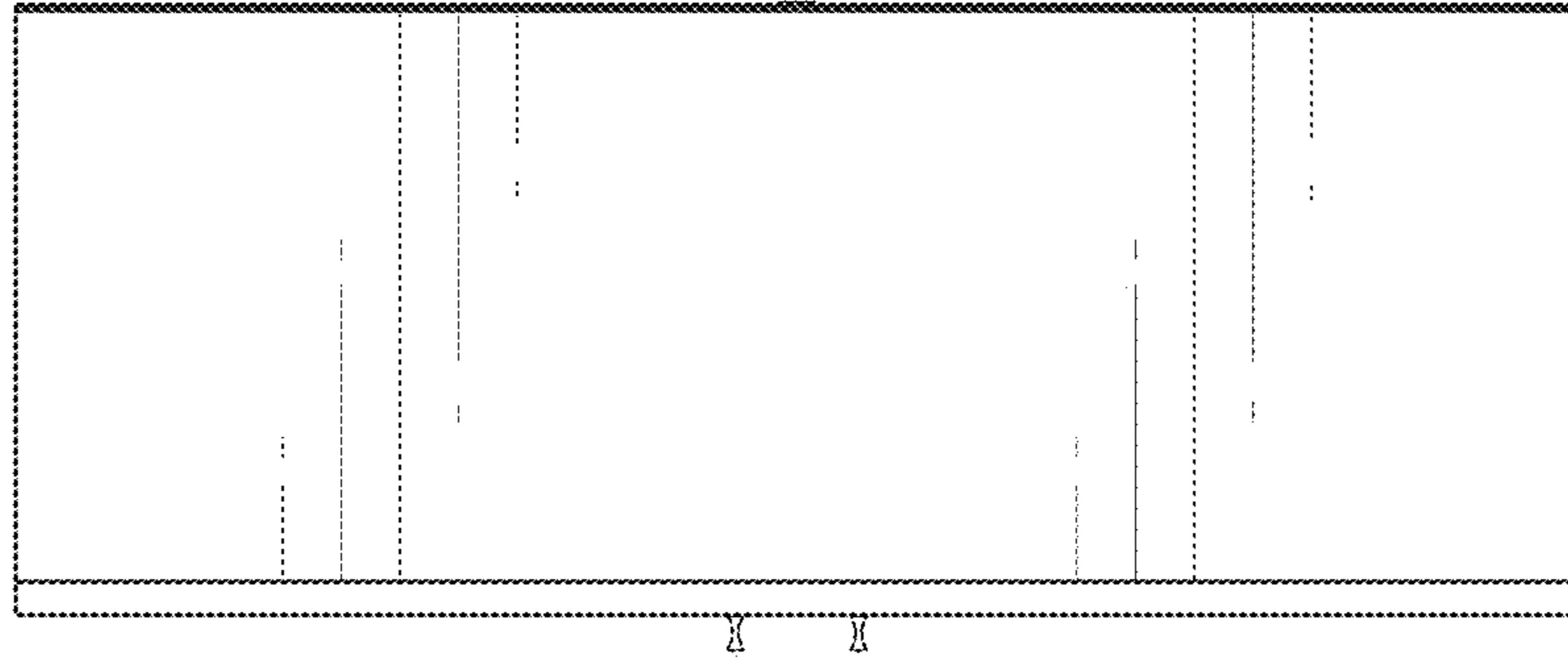

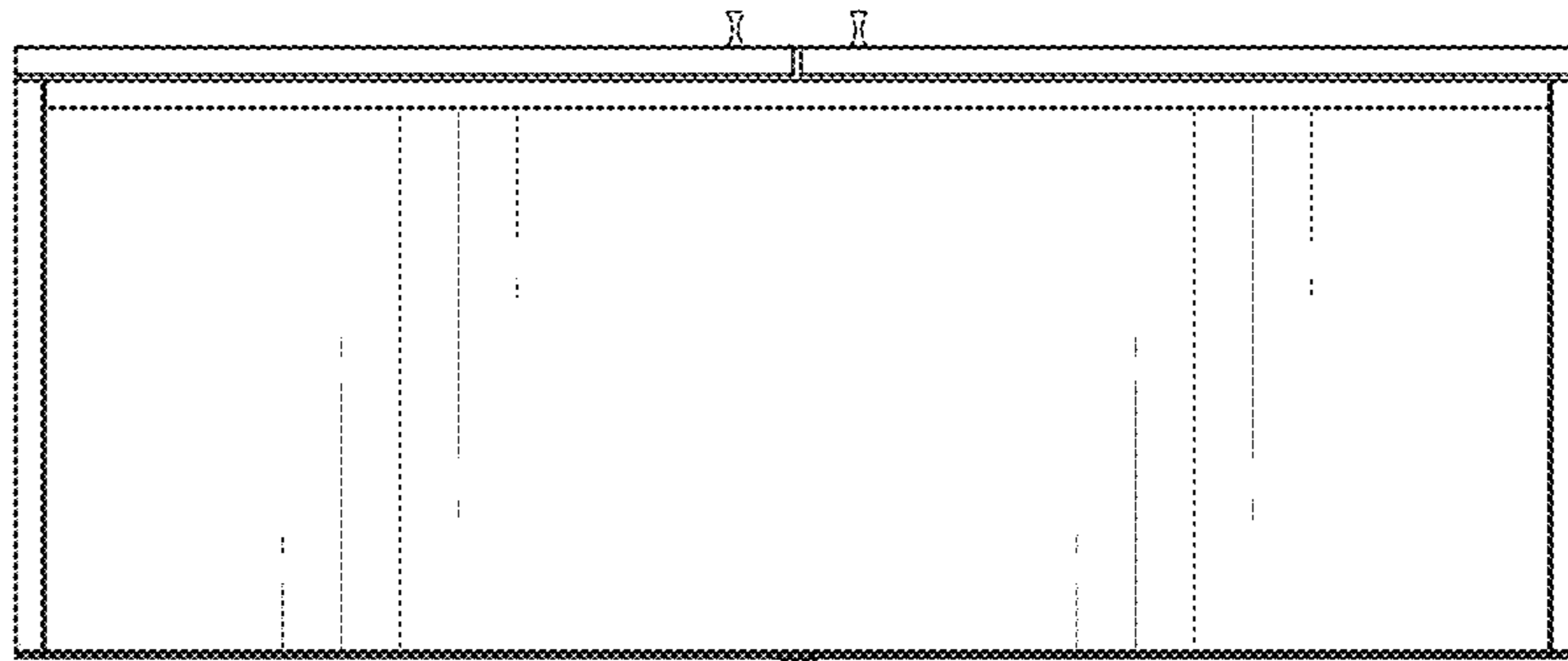

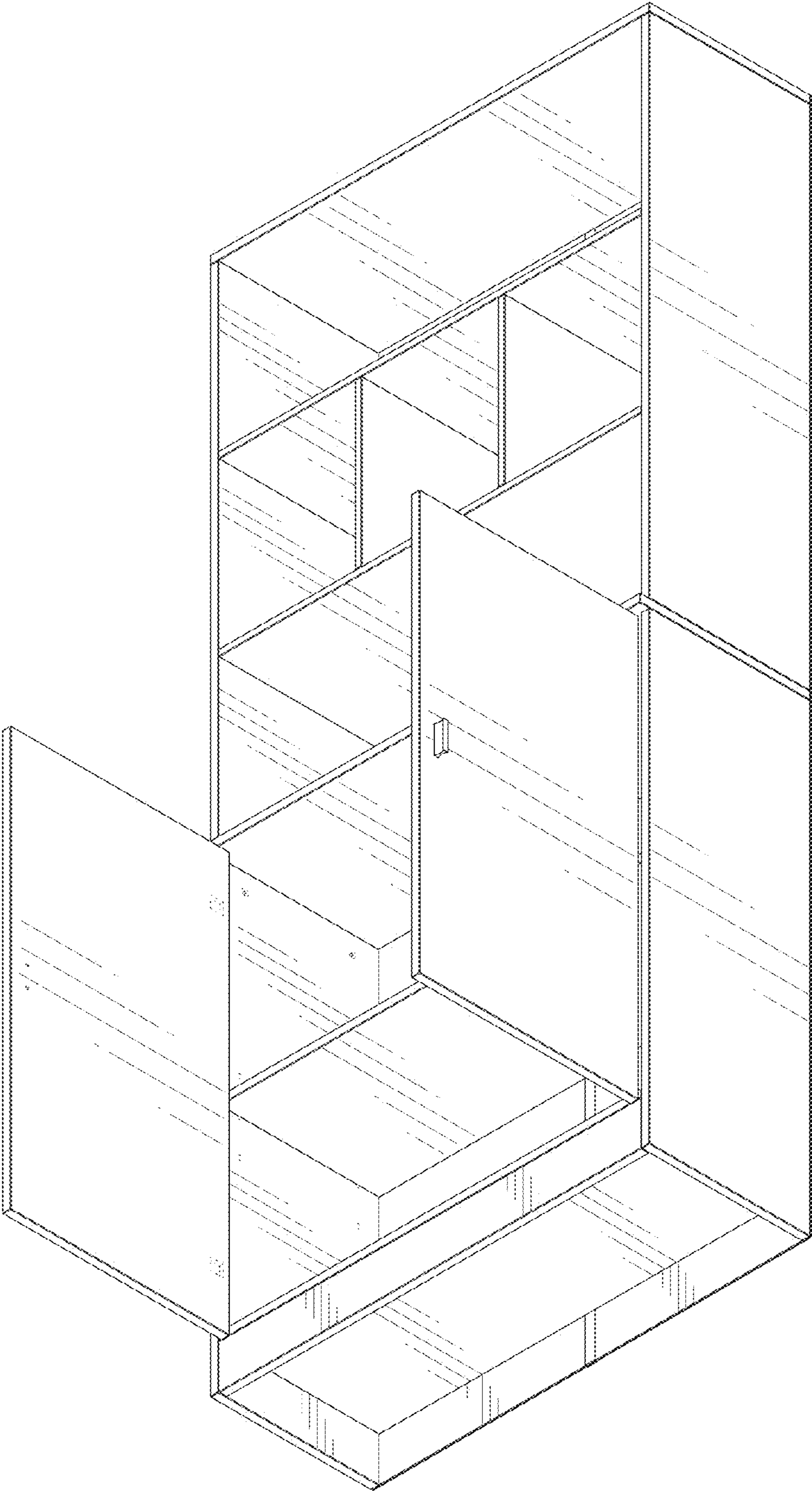
