The broken lines are provided for environmental purposes only and form no part of the claimed design.

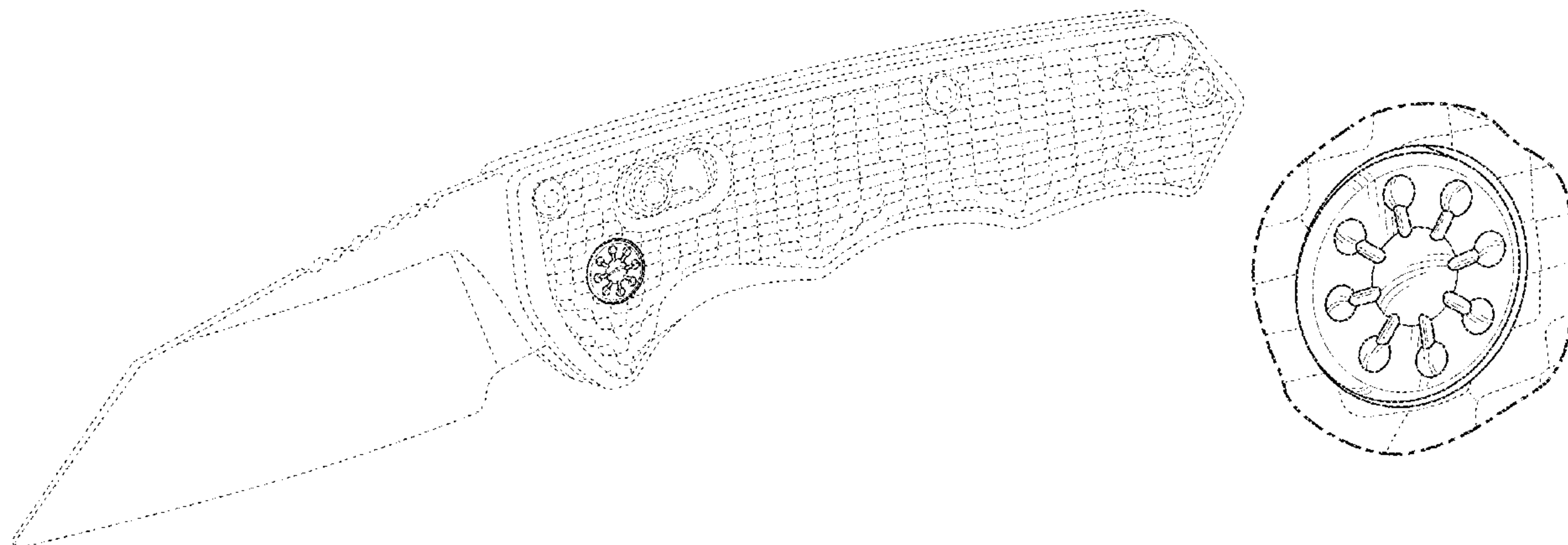

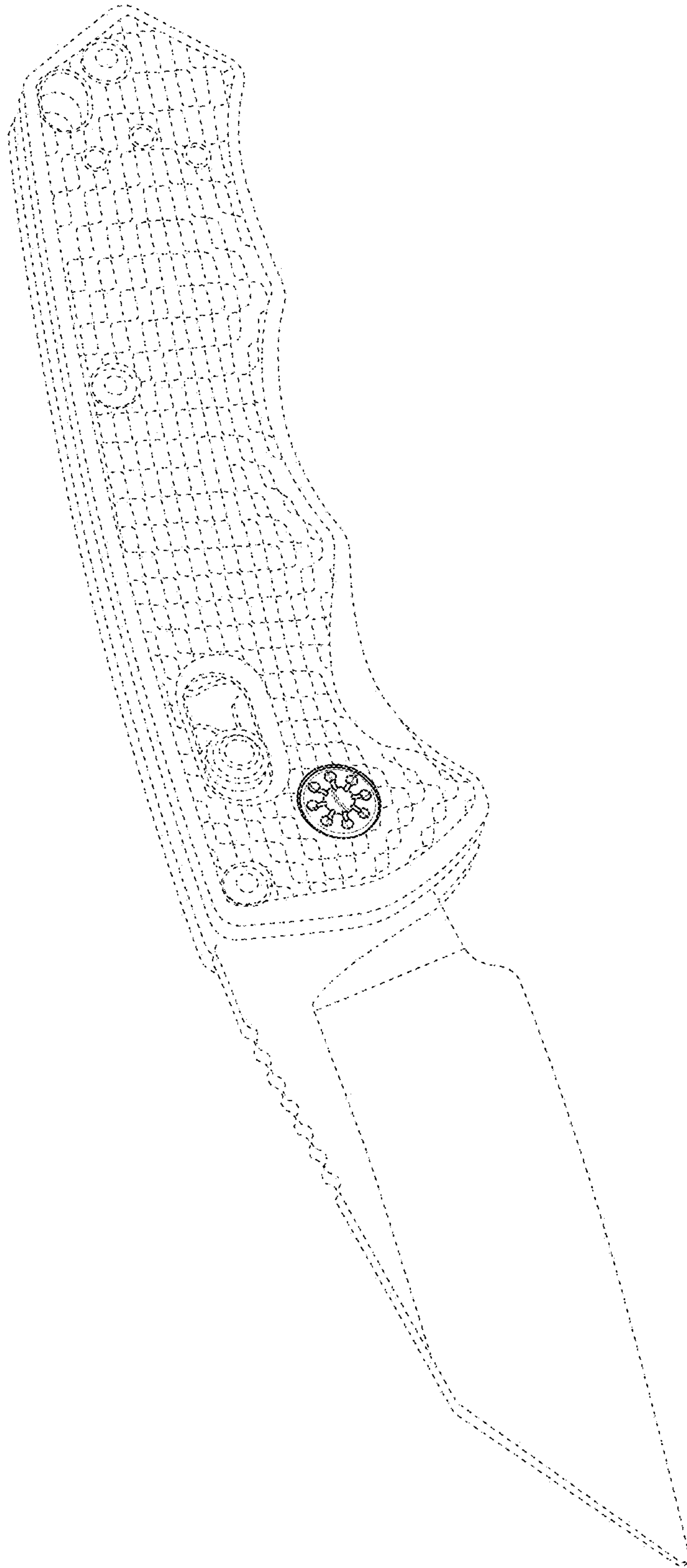

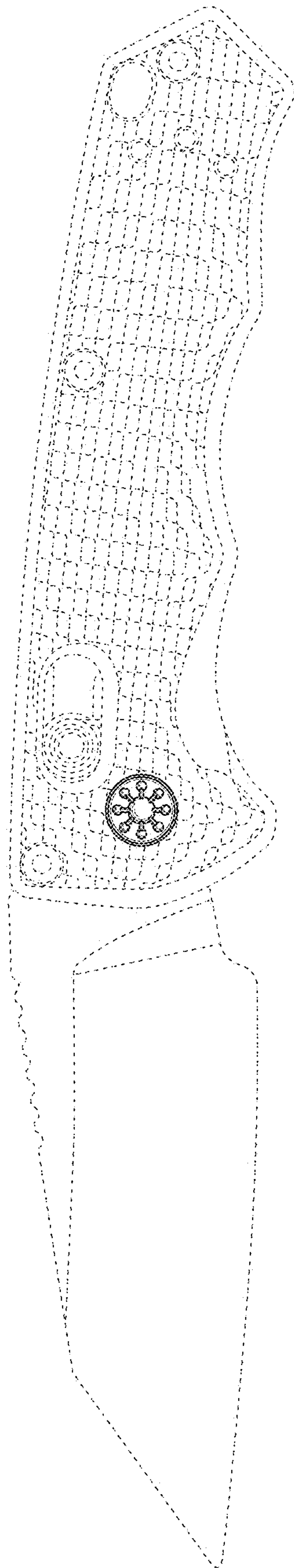

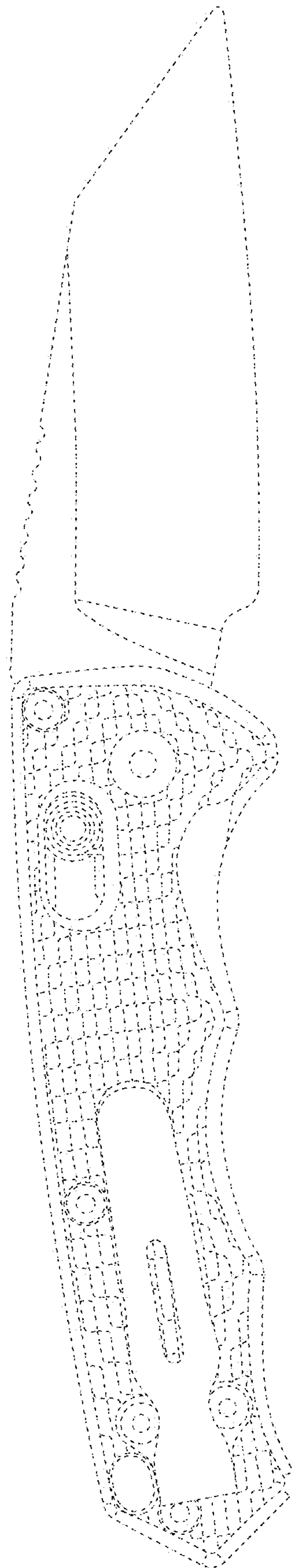

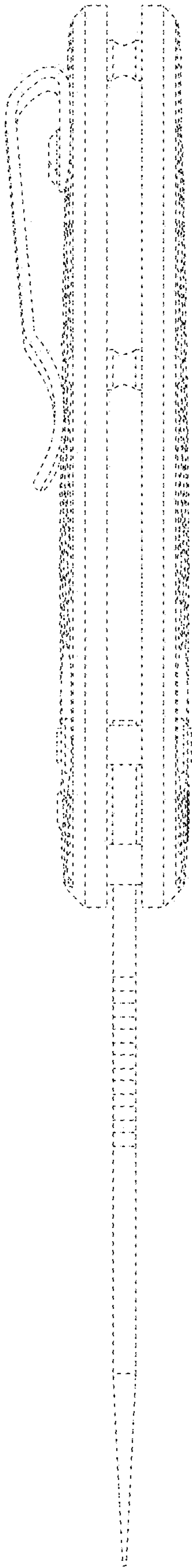

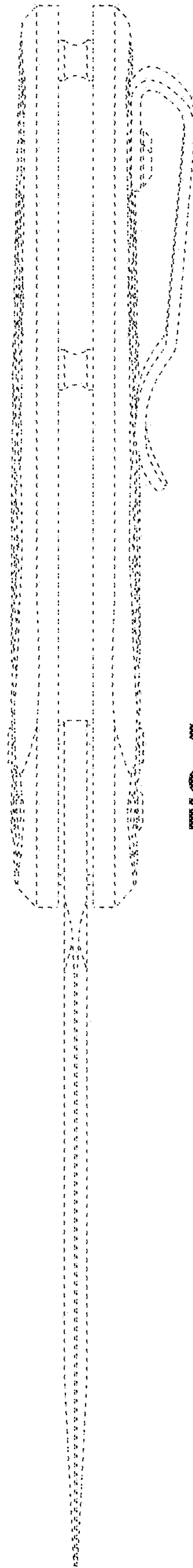

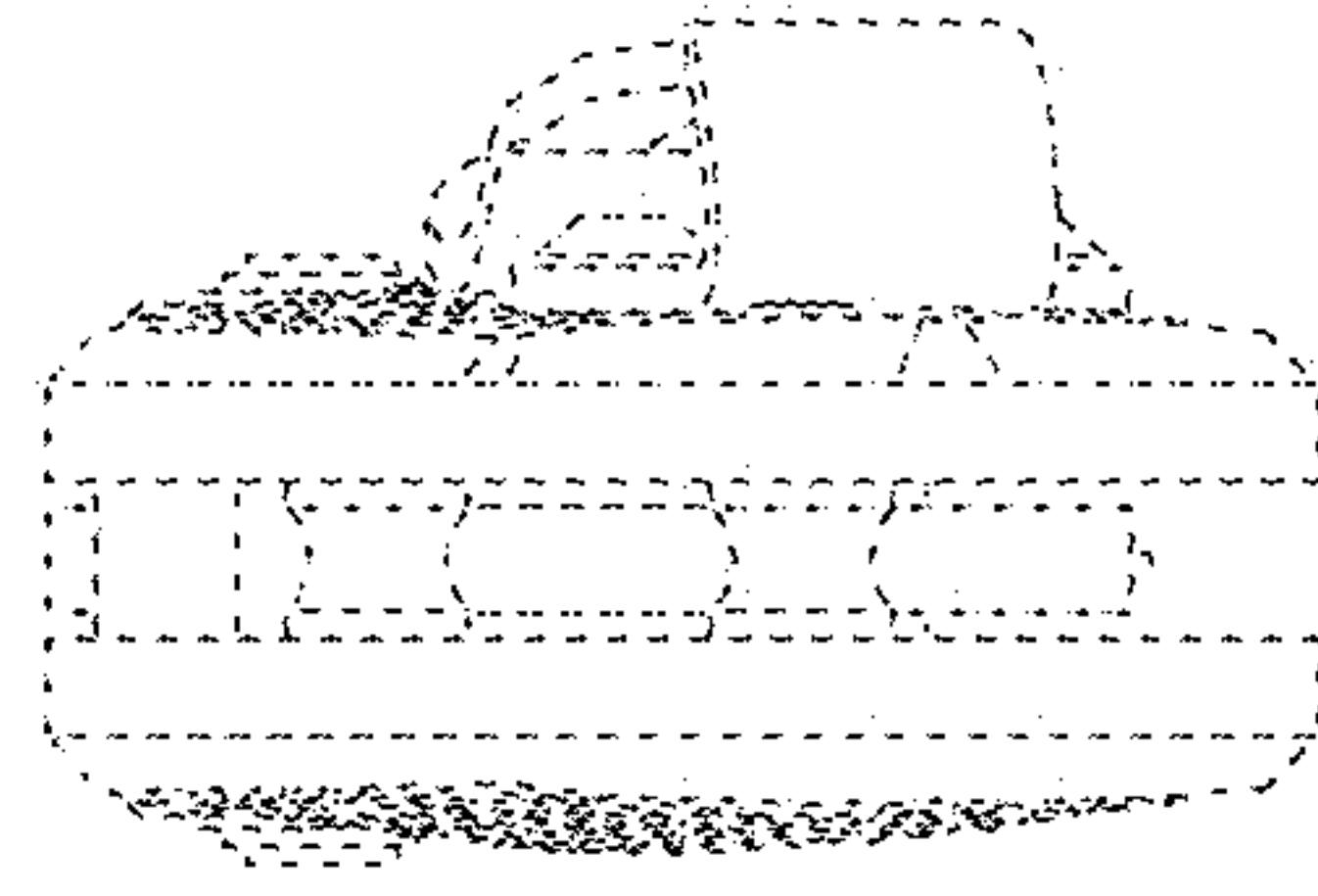

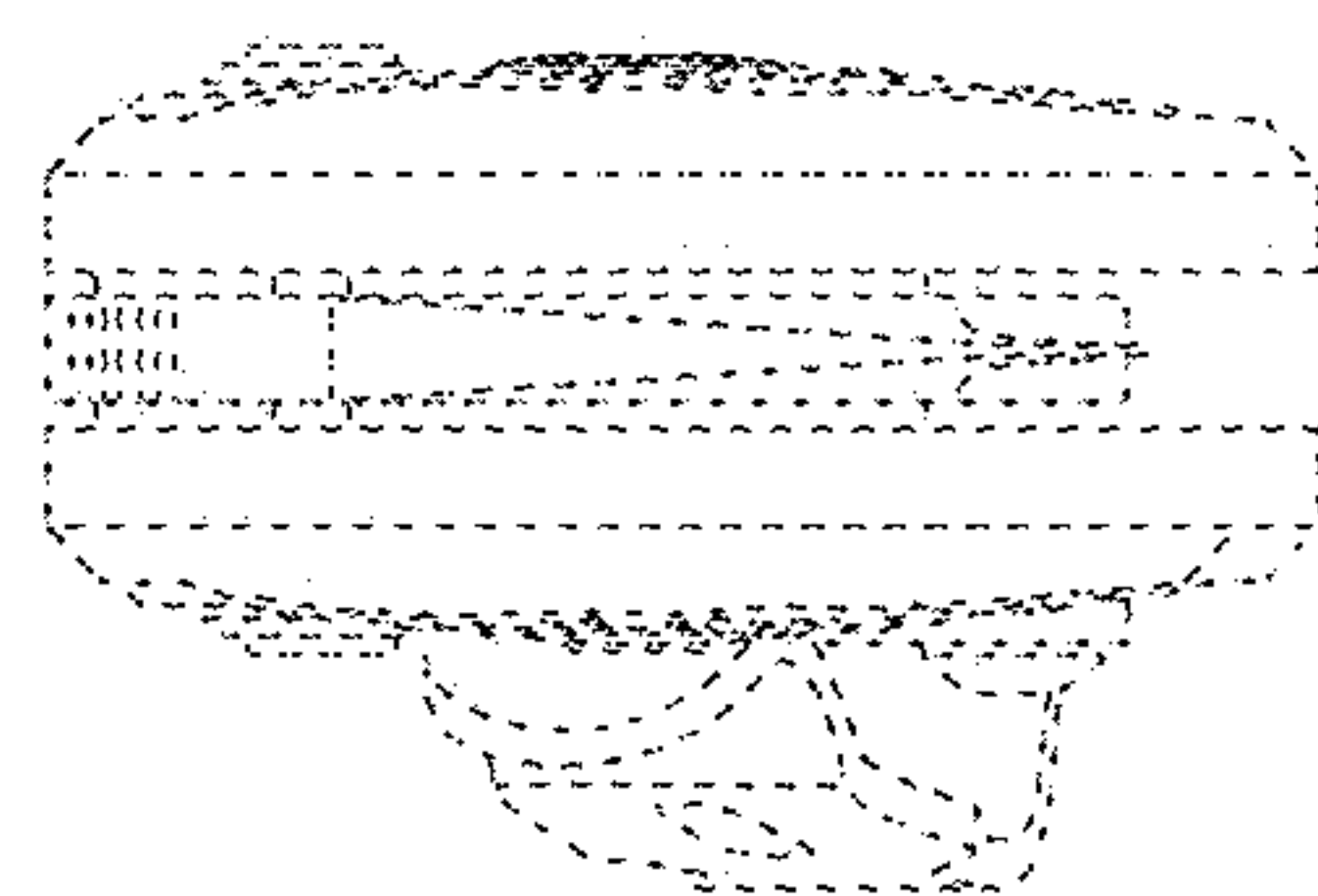

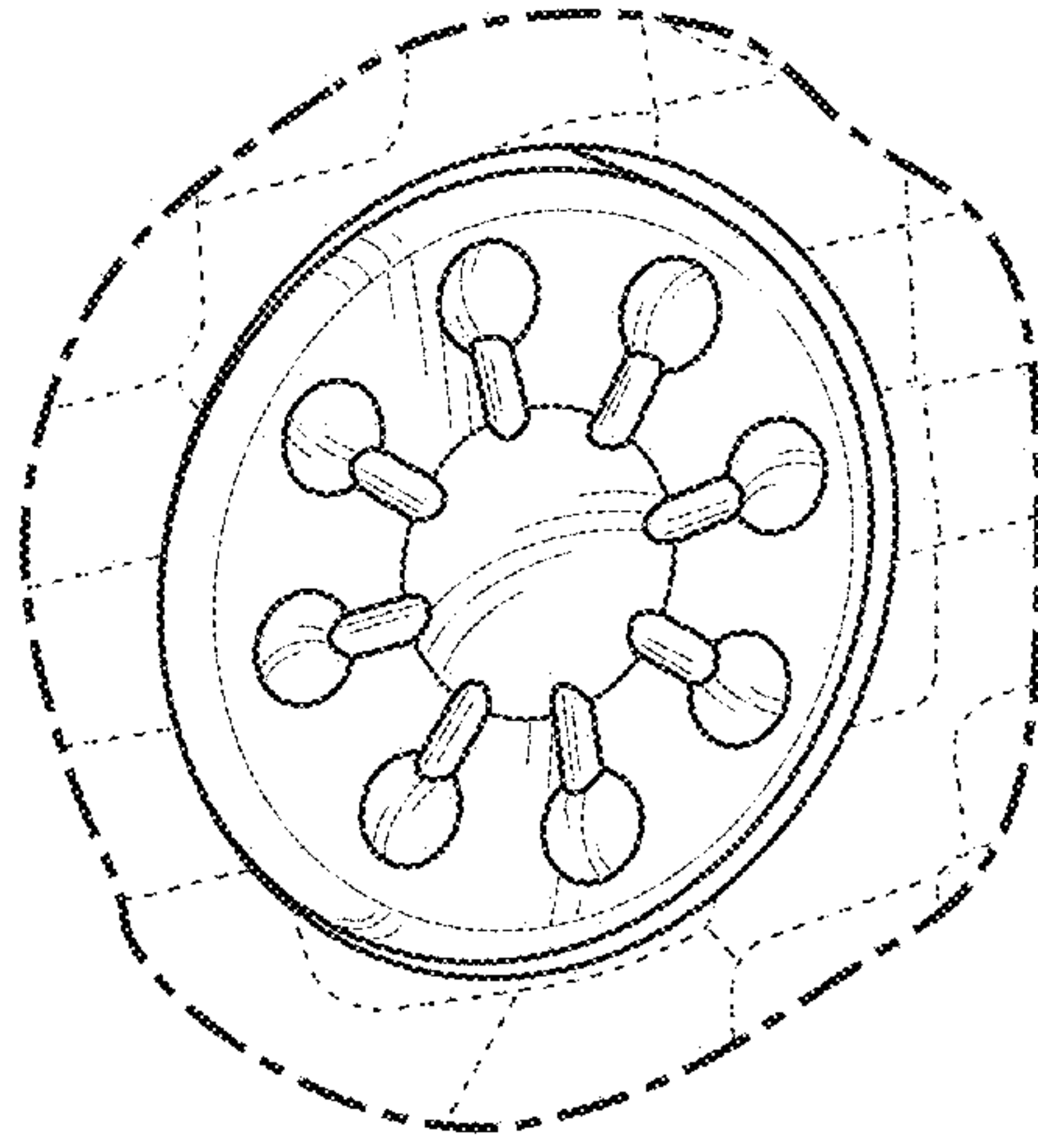

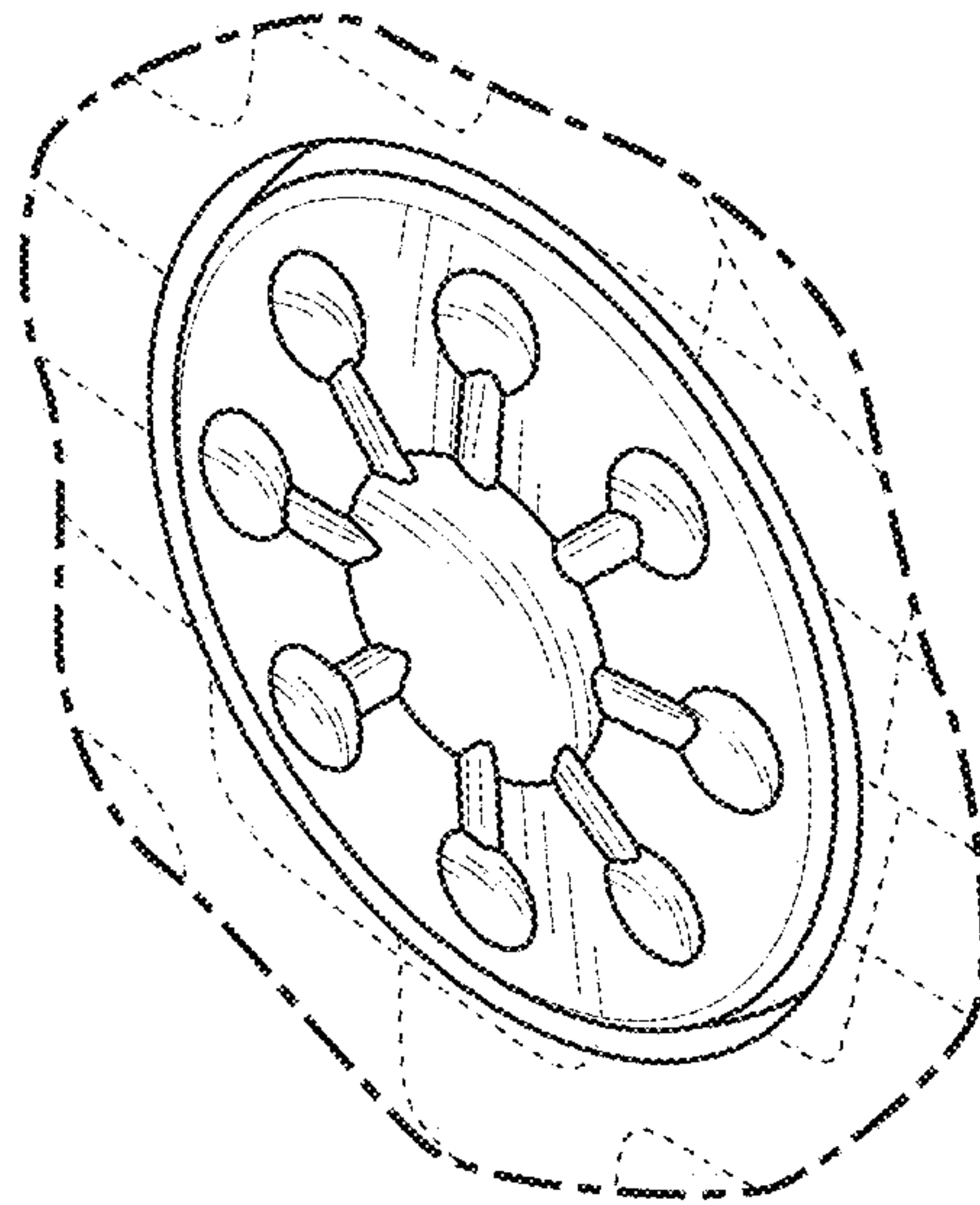
