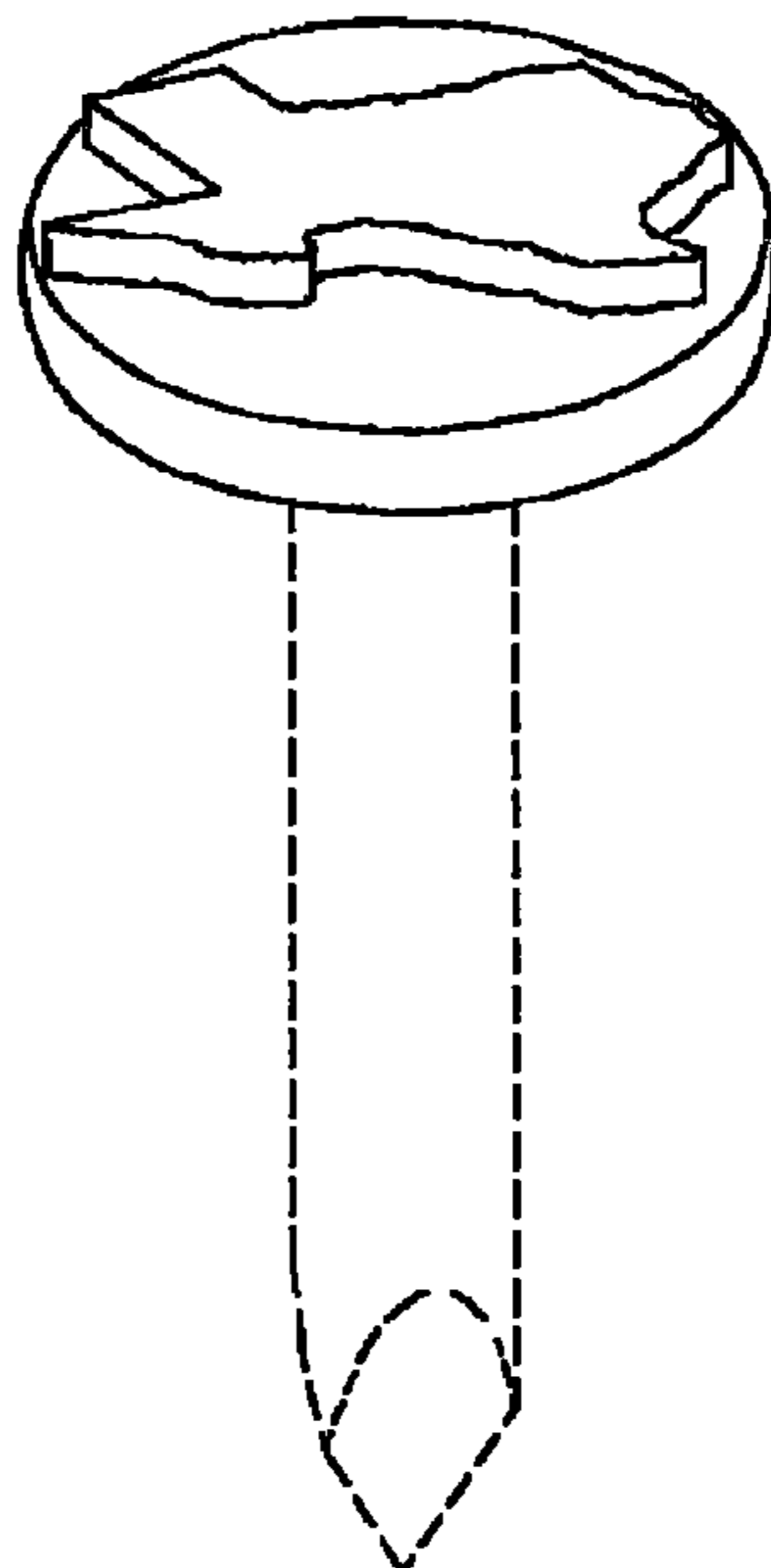
(57) **CLAIM**

DESCRIPTION

FIG. 1 is an isometric view of a nail with texas-shaped head showing my new design.

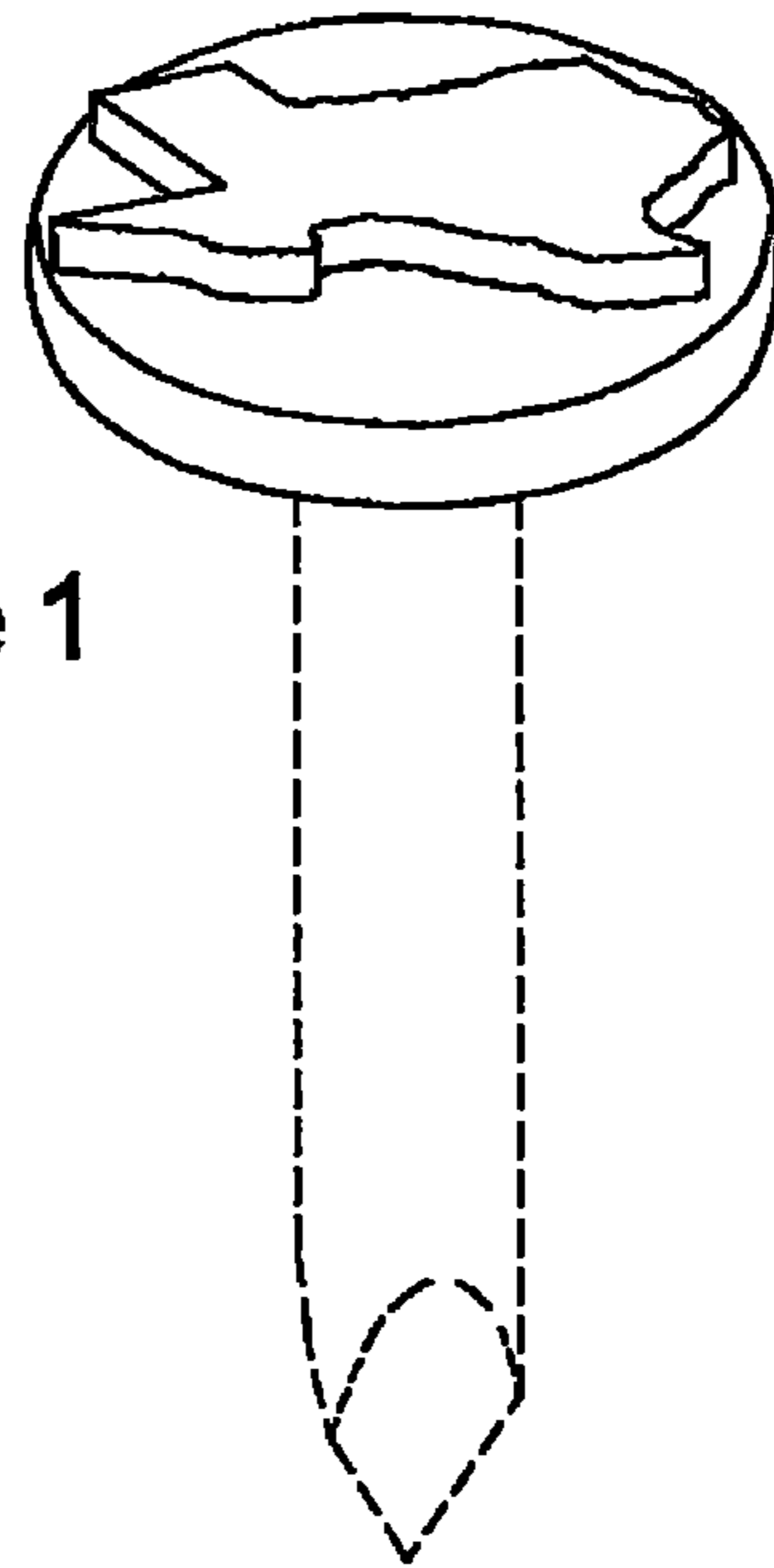

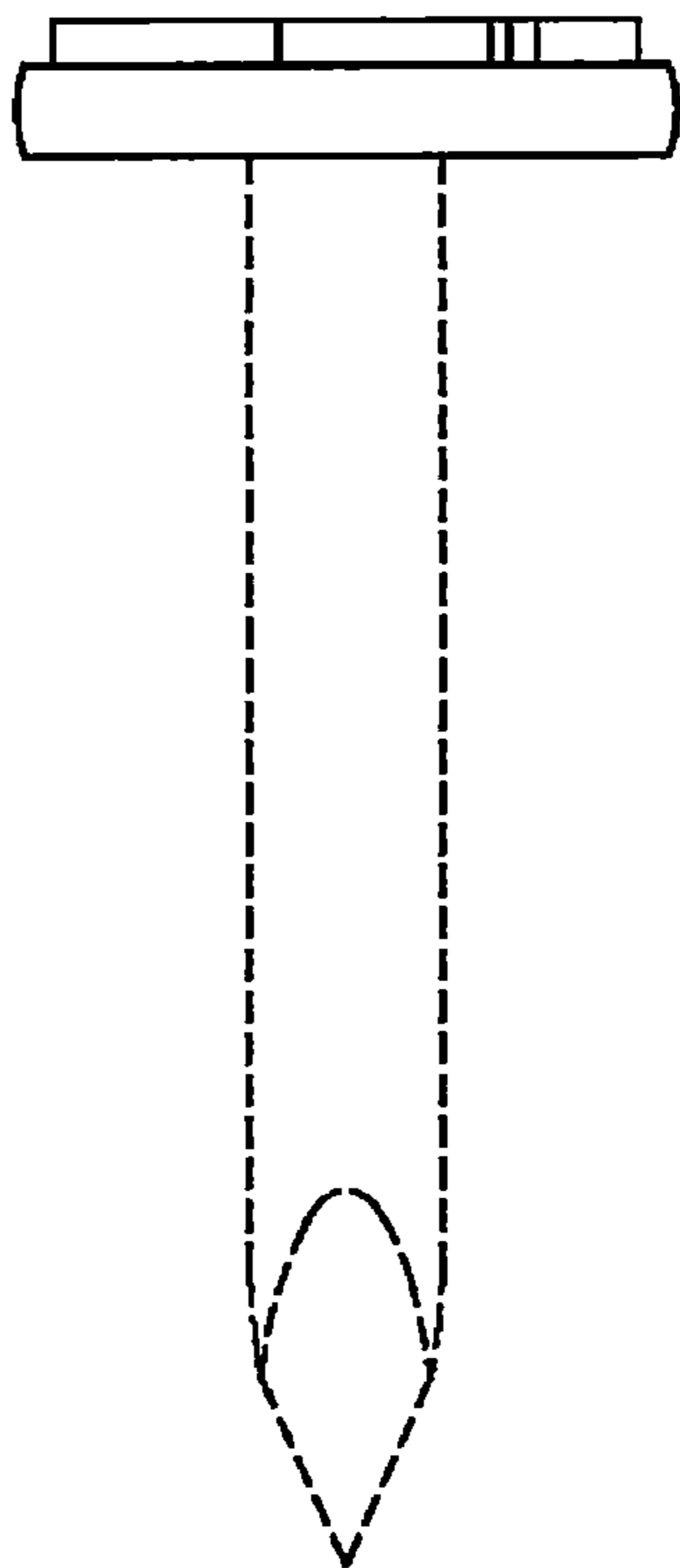

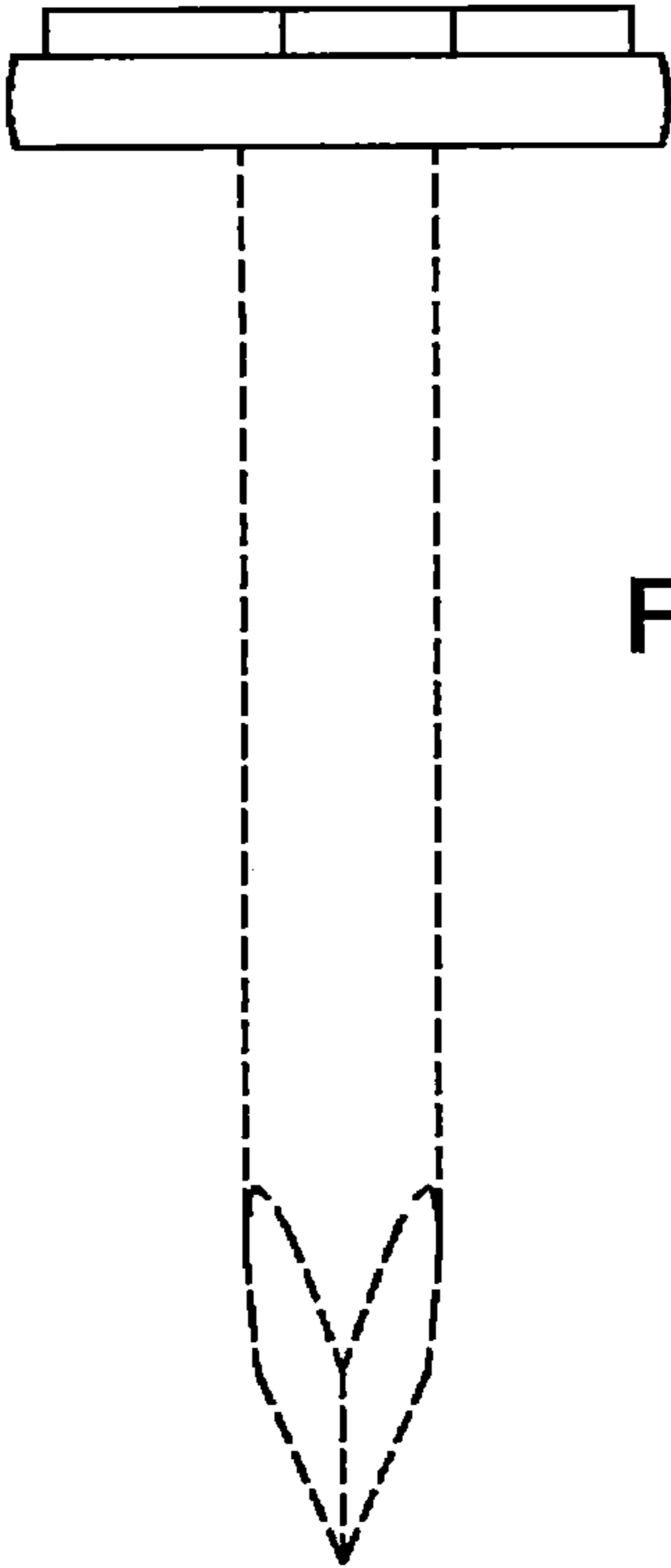

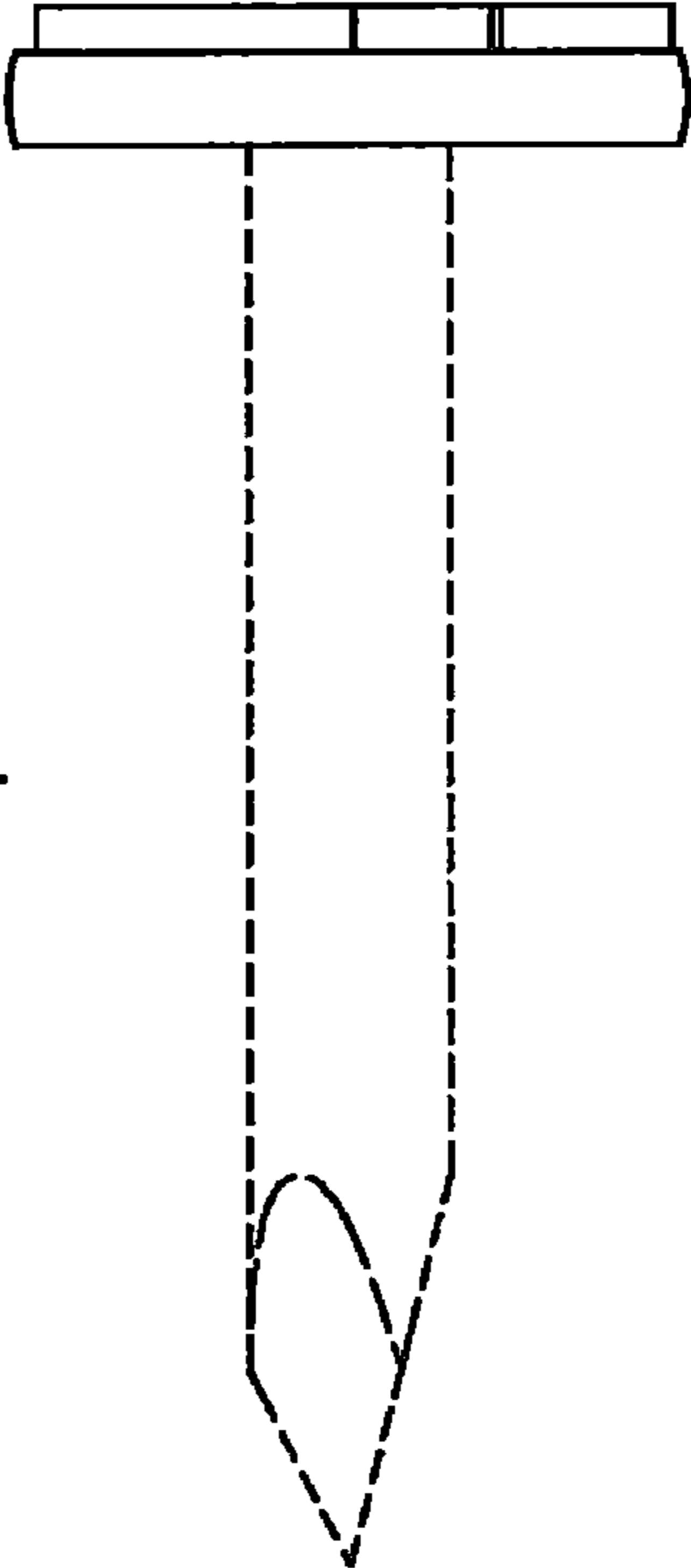

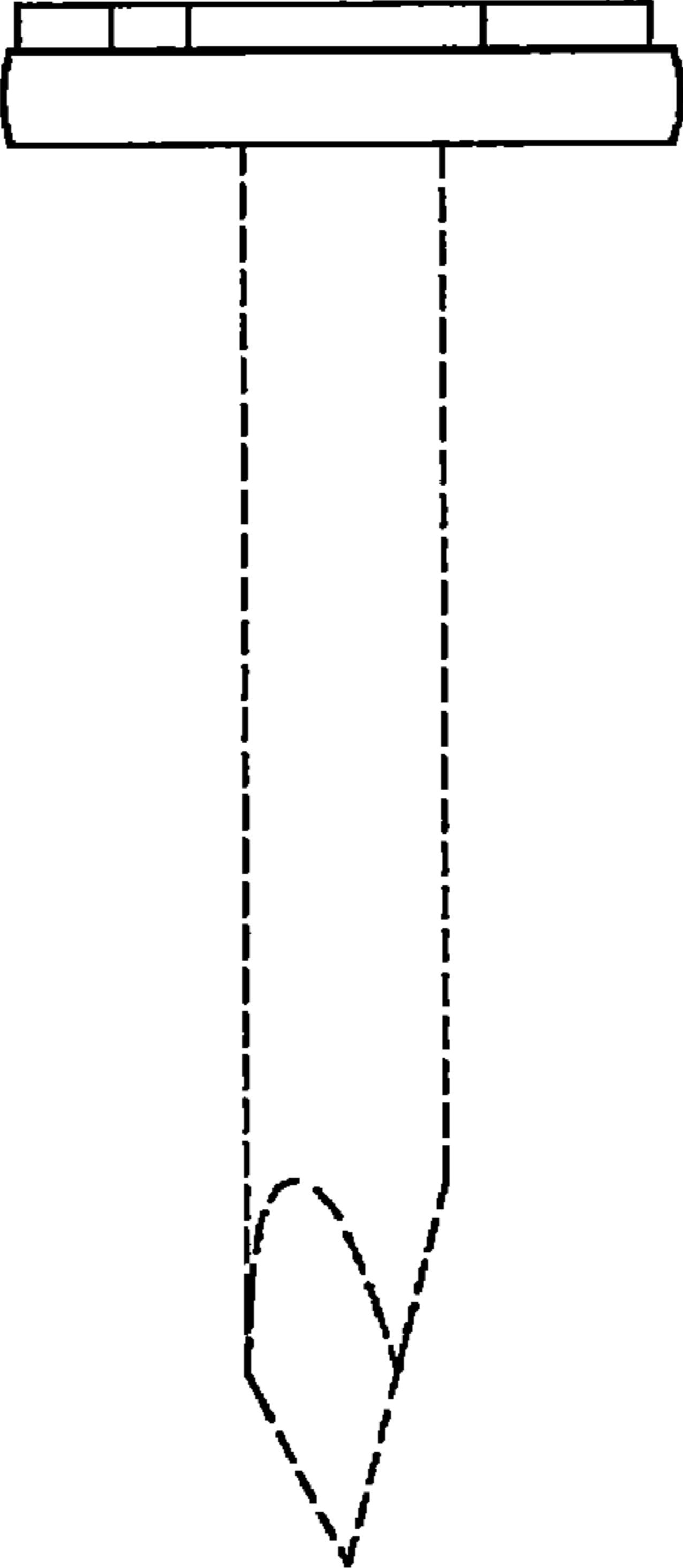

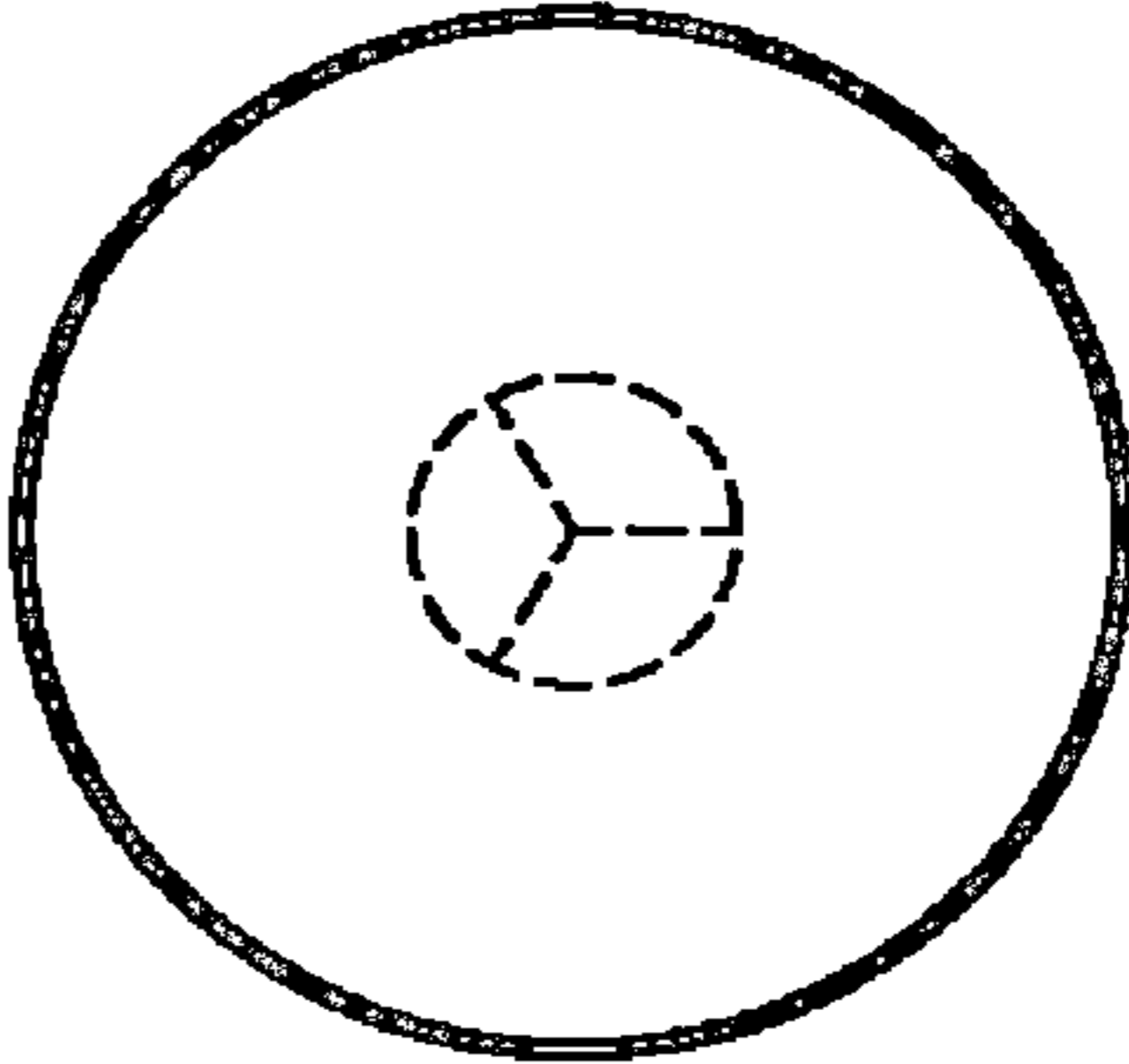
